STALIN WILL GET REPORT OF ACTIVITIES

Soviet Leaves Behind A Path Paved With Amity, Pointing to Mutual Trade Relations; Speedy Solution of Russo-American Debt and Claims Expected to be Outgrowth of Conference With Roosevelt

Washington, D. C., Nov. 23.—(AP)—Maxim Litvinoff heads for Moscow today with personal tidings of America's new friendship for the Soviet union. To Joseph Stalin, Russian political ruler, he carried a new interpretation of this government's attitude on tangled world affairs gained in intimate talks with President Roosevelt which preceded recognition.

CIVIL WORKS PROJECTS ARE OKAYED HERE

\$25,000 to be Spent On Three Jobs in Pitt; Over 100 Men To be Employed

A hundred or more men will be put to work between now and Monday on three projects in Pitt County recently approved under the Federal civil works program. It was announced today by K. T. Futrell, director of the program in this county and head of the Pitt County Department of Welfare.

Mr. Futrell said he had already received notification of approval of projects in Swift Creek, Ayden, Winterville and Greenville Townships.

One of the projects, providing for clearing for drainage in Swift Creek Ayden and Winterville, was approved this morning and the other two received action several days ago. That in Farmville involves a canal and in Greenville improvements to the colored school building on Fifth Street.

Mr. Futrell said about \$25,000 would be paid out for these improvements, and that around a hundred men would be employed. The laborers are already being lined up and will be in readiness for work not later than Monday morning.

Mr. Futrell said work was also being provided for women, and that several would be put to work on various jobs in the near future.

DEAN TALKS ON 'LIFE POWER'

Three Concluding Sermons to be Delivered at College This Week

"Power For Life," through the medium of fellowship, prayer and service, are respectively the subjects for the three concluding talks in Dr. Frank Dean's series of services given this week at East Carolina Teachers College.

The first of these, Fellowship, was discussed on Wednesday evening. Dr. Dean gives it precedence over prayer because the latter can never be truly soul-satisfying unless one first has fellowship with God. Fellowship, in the general sense of the word, means active congeniality. Man is brought into fellowship with God through His Son who showed his congeniality while on earth, tendering mankind a wholly unselfish friendship. If one is to lead the full rich life of power through prayer and service, he must not be led by a false sense of values into missing the life of a friendly fellowship with God.

Takes Crack At Sprague
Columbus, Ohio, Nov. 23.—(AP)—Congressman A. C. Lombeck of Ohio, said here today that the resignation of C. M. Sprague as special adviser to the U. S. Treasury was "a blessing to America."

Sprague, he said, was ignored by President Roosevelt as soon as the President learned it was the interest of England and not those of the United States that Sprague held closest.

"Why did he leave a \$60,000 job as adviser to the Bank of England to take one at \$7,000 annually? The answer to this question would make interesting reading and would embarrass some of the American financiers. I have been informed that Sprague continued to receive his \$60,000 salary from the Bank of England while the United States paid him \$7,000 to advise them of their own monetary policy."

MRS. NOWELL GIVES VIEWS ON DANCE HERE

The Daily Reflector is in receipt of a letter from Mrs. Virginia Nowell, of Raleigh, in which she deals with circumstances surrounding the Royal Court Ball she promoted here last Monday night, and dealing especially with a dinner given at the Yum Yum Inn which resulted in her arrest and imprisonment.

Raleigh Dance Promotor Tells of Dinner Which Resulted in Her Arrest

The letter in its entirety follows: "In justice to me I am asking you to print the following letter in your paper.

"When I ordered, and when we ate the dinner at the Yum Yum, I had the money ready to pay for it. Just before dinner was over, Stuart Carr, Secretary and Treasurer of the Cotillion club, came to me and said the orchestra refused to play unless they had some more money and begged me to let him have what I had. I told him I couldn't at first, then made an arrangement with the head of the Yum Yum for him to get his money from gate receipts later that night. He agreed to do this and the money \$64.00 was turned over to Stuart Carr, who was in charge of ticket sale.

"At the check-up, I was informed by ticket sellers that the government had demanded and taken all the gate receipts, except about \$300 which was paid to the orchestra, leaving no money for anything else. As I was not in ticket box, I do not know anything more about ticket sales. I did not even get my \$64.00 back and I told the Yum Yum man I could not pay him until I could get it elsewhere. He swore out a warrant and served it about 3 o'clock on night of dance. As I was without funds, and knew nowhere to get a bond at that time of night, I went over to jail and sat up there until I could get in touch with friends the next morning. As soon as I phoned, Mayor Flanagan came down and Dr. McGeachy, and they speedily got in touch with others who arranged the matter.

RED CROSS IN ANNUAL DRIVE IN CITY TODAY

Concerted Canvass Made For New Members in All Parts of County

The annual Red Cross Roll Call got under way at full blast today in all parts of Pitt county with indications that the quota of 1,000 would be raised in the whirlwind campaign.

S. G. Wilkerson, roll call chairman, yesterday appealed to the public to join the organization which has done so much to carry relief to those suffering from misfortune in all parts of the country. The chairman was particularly anxious to go over the top this time in view of the fact that the county fell short of the goal last year, in fact, under the general average of the entire nation.

Committees representing the Kiwanis club made a thorough canvass of the business district, and while it was impossible to obtain a complete check of what had been done, it was indicated they were meeting with success.

Young women representing the Junior Woman's club were stationed in banks, the postoffice and court house, and indications were that they also were meeting with success.

In tobacco town the Tobacco Board of Trade had charge of soliciting and Miss Lewis had charge of the college.

In other sections of the county organizations had been perfected and were pushing the campaign as was being done in Greenville.

Part of the money raised in the annual roll call is kept at home and the remainder is sent to the national organization to help relieve distress in other parts of the nation.

The Red Cross, Mr. Wilkerson said, did commendable work in North Carolina during the recent hurricane on the coast, caring for hundreds of people whose property was wiped out by wind and flood. The same attention has been given to other sections hard hit by elemental disturbances, and it is necessary that the organization receive liberal support in its annual drive for members.

TWO WORK PROJECTS IN EAST CAROLINA

Manteo, N. C., Nov. 23.—The planting of 300,000 to 350,000 bushels of oysters to areas in the Roanoke, Croatan and Pamlico Sounds where they will mature and thrive will be the major project for Dare County under the civil works program. It was announced today by T. S. Meekins, local administrator.

Plans for the project has already been submitted by Mr. Meekins to W. T. Morse, State project supervisor.

Another important project which the local administrator thinks will be of great benefit to the county as a whole is one to control mosquito breeding. Projects have been submitted for draining areas on Roanoke Island and at Nag's Head where mosquitoes breed.

SMALL TOWN DOOMED BY THE RED TIDE

Many Residents of Tujunga Abandon Possessions and Flee As Flames Reach Town; Eight Mansions Destroyed; First Aid Stations Kept Busy Rendering Help to Those Injured in Fighting Blaze

Los Angeles, Calif., Nov. 23.—(AP)—One hundred and seventy men cut off by a roaring brush and forest fire in the foothills northwest of Los Angeles were returned safe this morning by a motorcycle officer who ran the gauntlet of flames and found them hurrying to safety.

The men, county welfare workers engaged in unemployment relief work, were making their way over the hills and apparently were in no danger, the officer said.

The fire was completely out of control and was eating its way through the foothills to Tujunga, which was reported doomed by the fire. Scenes of hysterical confusion were enacted at Tujunga as the flames spread in the town. Many residents abandoned their possessions and fled, while others seeking to save their valuables had to be dragged from the scene by firemen.

L. D. Hotchkiss, assistant managing editor of the Los Angeles Times, was among those forced to flee from the flames.

At least eight of the homes destroyed were pretentious and belonged to wealthy residents who had located at Tujunga for the dry, mild climate of the 3,000 feet altitude.

The American Legion hall and several public buildings were thrown open to women and children, but how long the structures would remain outside the danger zone was problematical.

First aid stations were kept busy fixing the injuries of many of the 3,000 fire fighters, the majority of whom were residents who volunteered to stem the red tide.

DENY MOTION FOR VENIRE IN DECATUR CASE

Counsel For Haywood Patterson Loses Appeal Before Judge Callahan

Decatur, Ala., Nov. 23.—(AP)—A motion to quash the venire drawn for the trial of Haywood Patterson, one of the seven negro defendants in the "Scottsboro" case today, was overruled by Judge W. W. Callahan, presiding over the Morgan Circuit Court.

The motion was made by Joseph Broadsky, of New York, member of the counsel retained by the International Labor Defense for the defendants. He alleges that negroes were excluded from the jury boxes because of their race and color.

Patterson and eight other young negroes, two of whom are now in Juvenile Court, are under indictment charged with attacking two Huntsville, Ala., white women on a freight train in Jackson County, Alabama, on March 25, 1931. The present trials are under a change of venue from Jackson County where the eight negroes were convicted and sentenced to death. The United States Supreme Court set aside the death verdict.

NORTH CAROLINA'S SCHOOLS

(New Bern Sun-Journal)
There is, throughout the State of North Carolina, a ready and full appreciation of the fact that the schools are not getting the maximum financial support one might hope on the part of the average citizen that this condition may be improved as rapidly as possible. But despite that present position of the schools, we are reminded in an Associated Press dispatch from Raleigh that this state may be the outstanding bright spot in an otherwise dark year for education in the United States.

North Carolina is the only state in the Union which guarantees an eight-month school term for every child within its borders. Every school teacher in the state draws pay in cash. One-sixth of all of the school children in the nation who are furnished bus transportation to school ride the school buses of North Carolina.

"It is a plain fact," says a current news sheet of the Scottish Rite News Bureau, "that forces generated by the present financial condition of the country and other forces opposed to the American principle of free public education have operated in some areas to bring about a complete collapse of public education. There are many

areas in which the schools are on the verge of collapse."

Supplying the facts from a few states, the news item says that in Alabama 145 schools have closed completely and that 90 per cent of all schools enrolling 600,000 children are maintaining terms less than half their normal length. Eighty per cent of the teachers there, it is said, are being paid salaries below the minimum of the NRA code for unskilled labor. Four hundred schools enrolling 30,000 children have been closed entirely in Arkansas. In Kansas, 700 schools enrolling 35,000 children, were closed completely. Michigan closed 205 schools enrolling 10,250 children. In Oklahoma 50 per cent of the schools are either closed or have greatly reduced terms. In West Virginia 3,250 schools enrolling 162,500 pupils, are operating on less than a six-months term.

"These states," the news sheet continues, "are not isolated examples. Conditions similar to those just cited now exist in the majority of States or our Nation."

Sandino Transforms Jungle Fighters Into Plantation Workers

Managua, Nicaragua—(AP)—General Augustino Sandino, defiant foe of American marines, has become Senior Augusto Cesar Sandino, co-operative planter and peace officer. The man who for several years escaped every net spread for him by Uncle Sam's "devil dogs" and the national guard of his own country, is back in his old stamping ground on the Coco River.

Leads Picked Men
His headquarters are at Wivil, a river town near Bocay. Under him are one hundred men picked from his former followers so as to aid him in patrolling the region.

But the erstwhile jungle fighters seldom shoulder a rifle these days. Their hours are taken up with farm work.

They are banded in a society which Sandino named "El Co-Operativo Rio Coco." It operates on a collective basis for raising crops and exploiting the natural resources of its district.

Gets Government Aid
The enterprise is backed by a monthly government bonus of \$1,000. With this money Sandino buys clothing, medicines, seeds and farm tools for his men.

Products consist of grains, garden truck and cattle. Attempts also are being made to exploit the region's pine and hardwood timber lands, rubber, sisal, gold and silver. The outlet for the district is by river to the Atlantic coast.

Sofonias Salviatierra, Minister of Agriculture, who went to Sandino's lair in northern Nicaragua last January and arranged a truce with the

jungle chieftain, maintains a friendly correspondence with him.

Senior Salviatierra is sure that Sandino is through with politics except as a patriotic individual. He has been assured by the general himself and by relatives and close friends of the latter, that he has no idea of running for the presidency in 1934.

These were all predated checks given and received with the understanding that funds would have to be deposited to take care of them.

"As for the dance itself, it brought many people and much money into Greenville. It helped the merchants, one and all. Greenville's cafe's, eating places, gas stations and everywhere of the kind took in a great deal of money. Mr. Forbes of Heber Forbes Co. and Mr. Perkins of the Perkins Co. both told me it had greatly stimulated their trade. People heard of and came to Greenville from all over North Carolina. The Merchants Association should have appreciated this fact as that is one of its duties of such an association, but its head Mr. Powell fought the dance from the beginning.

"He was the gentleman who issued the warrant for the Yum Yum, he it was who refused to wait until morning to let me get the money, who refused to even let me call over phone. I think the majority of the merchants and people of Greenville agree that the dance was a big thing for Greenville.
