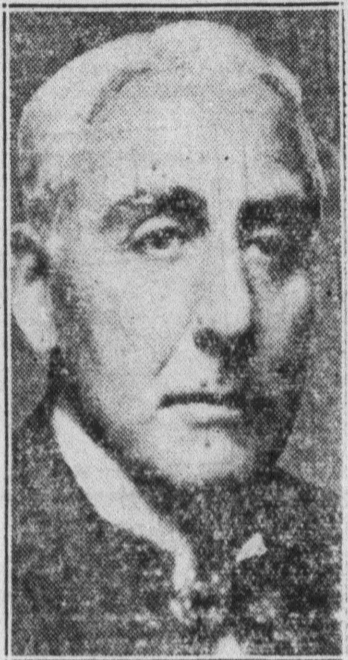

LEAF SIGNUP BEGINS HERE WEDNESDAY

Committeemen Given Final Instructions at Arnold's Office This Morning

The tobacco sign-up campaign will get under way in Pitt county tomorrow morning.

Committeemen will be stationed in all townships of the county to assist farmers in making out contracts and filing applications for benefit payments for tobacco sold prior to October 7th.

The committeemen met in the office of County Agent E. F. Arnold this morning to receive final instructions relative to filling in the contracts.

Public meetings were to be held in several townships tonight at 7:30 for the purpose of imparting information to growers relative to the nature of the contracts and as to plans for having same signed. The meetings were called for schoolhouses in Ayden, Belvoir, Bell, Arthur, Stokes, Bethel, Falkland, Fountain, Farmville and Pactolus. Committeemen have been provided with invitation cards to mail to growers.

American Flier and Wife to Leave Gambia at 7 P. M., E. S. T.

Bathurst, Gambia, Dec. 5—(AP)—Colonel and Mrs. Charles A. Lindbergh planned to take off at midnight 7 p. m. (EST) on a projected flight to South America, 1,900 miles away.

Colonel Lindbergh chose that time for his departure because at that hour the winds are most favorable for a getaway.

A cooling breeze sprang up during the morning giving promise that the flight which had been delayed by a calm since Thursday might proceed.

URGE GROWERS TO SELL LEAF RAPIDLY NOW

Farmers Advised to Market Tobacco Before Bad Weather Sets In

The Greenville tobacco market will close for the Christmas holidays December 15 and re-open for resumption of business on January 2. It was decided at the regular meeting of the Tobacco Board of Trade here yesterday.

In the meantime, farmers were advised to market the remainder of their crop before bad weather sets in and makes this difficult. There is a considerable amount of the crop to be disposed of yet, it was said, and farmers who go ahead and market their tobacco while good weather holds sway will not be subjected to discomforts incurred in such work when winter actually gets under way.

The market re-opened yesterday following observance of the Thanksgiving holidays, and the official report of K. W. Cobb, supervisor of sales, issued this morning, showed that 1,035,808 pounds of tobacco were handled. The market paid a total sum of \$204,169.15 at an average of \$19.71 per hundred pounds.

Sales were expected to be heavy from now on until the Christmas holidays, and with a full corps of buyers on the floors of the various warehouses, the golden leaf will be moved as rapidly as at any other part of the season.

The price situation continued to remain firm yesterday and this condition, it was said, will prevail throughout the remainder of the season.

In view of this fact and the advice of tobaccoists to market the remainder of the crop rapidly before the beginning of bad weather, it was believed offerings would be comparatively heavy until the market suspends operations for the Christmas holidays.

ROTES HEAR TALK ON CRIME

Local Club Members Plan to Attend Inter City Meeting at Farmville

Rotarians gathered in weekly session last night heard an illuminating talk dealing with "Safety and Crime," by O. H. Pate, assistant general traffic manager of the Atlantic Coast Line Railroad.

The speaker discussed the monumental effort being made by transportation companies throughout the nation to make travel safe for the public, declaring that his company alone had been able to reduce accidents at least 99 per cent. He attributed this to an extensive educational program reaching to every walk of life. He also told of what is being accomplished on the highways to reduce accidents and death ways to reduce accidents and death and said the various clubs of the nation could play an important part by aiding in the educational program.

Referring to crime, he pointed to recent statistics showing that most of those arrested and jailed for crime are between 18 to 21-years of age. He ascribed this to lack of training in the home, and not enough interest on the part of those who come in contact with youth.

He also stressed the tremendous influence clubmen could bring to bear on this situation by attempting to place youth on the right track before he had time to go the way of crime.

Herbert ReBarker presided over the session and called attention to the inter-city meeting of Rotary to be held at Farmville tomorrow night. Thirty members of the local club signified their intention to attend.

The program was in charge of Charlie Robinson of the vocational service committee.

Will Veto Liquor Bill. Trenton, N. J., Dec. 5—(AP)—Governor A. Harry Moore said today he would veto the liquor control bill in event the legislature does not act to recall it for amendment.

Ohio Ratifies Repeal. Columbus, Ohio, Dec. 5—(AP)—Ohio today ratified repeal of the

Eighteenth Amendment, becoming the 35th state to approve the return of legal liquor.

The vote of the 52 repeal delegates was unanimous, but in spite of it the state remained legally dry.

Dollar Down. New York, Dec. 5—(AP)—The dollar closed in Paris at the equivalent of 6.08 cents to the franc and later the French rate rose to around 6.17 cents.

Man Wanted Here in Alleged Clothing Theft, to be Returned Tomorrow

B. C. Efrid of Albemarle, who failed to appear for preliminary hearing last Saturday in connection with the alleged theft of wearing apparel from automobiles at the Royal Court Ball here two weeks ago, was arrested in Wake Forest today and will be returned here tomorrow to face preliminary hearing.

When Efrid failed to appear for trial here Saturday, Chief of Police George Clark was instructed to immediately issue a warrant for his arrest. This was done and when Efrid appeared at Wake Forest, where he attends school, he was taken into custody.

In view of the fact that the case is out of the jurisdiction of the lower court here, Chief Clark said, Efrid would be bound over to the next term of Criminal Superior Court. Should he confess to the charge it will not be necessary for four other young men held for questioning in the case to return as witnesses, but should he fail to do so, the police head said at least two of the witnesses would be released this month were white and (Continued on Page Three)

GOVERNMENT PLANS TO ACT DURING NIGHT

Proclamation Will be Made Public Immediately Upon Ratification by Utah Convention; Government Considers Plan for Releasing Medical Liquor for Beverage Purposes

Washington, Dec. 5—(AP)—The government is considering a plan to release all medical liquor stocks for beverage purposes immediately after the proclamation of repeal this evening.

Washington, Dec. 5—(AP)—The effort to prevent the issuance of the proclamation announcing ratification of the prohibition repeal amendment was rejected today by Justice F. Dickinson Letts of the District of Columbia Supreme court.

Hearing the expected news, William Phillips, assistant secretary of state, prepared to go ahead with soon as he hears the Utah convention plans to issue the proclamation as it has acted as the 36th to ratify the 21st Amendment.

The unsuccessful court action was brought by Cannon Williams, Chase of Brooklyn and George Duncan of this city, representatives of the International Reform Federation and other dry organizations. They contended the amendment had been illegally referred in several states.

Washington, Dec. 5—(AP)—Tried almost 14 years and adjudged wanting, constitutional prohibition ends tonight and the American people will face curiously a new period of experimentation on how to handle liquor.

Only formal ratification by conventions in Pennsylvania, Ohio and Utah are necessary to do away with the 18th amendment.

As it stands—the Salt Lake City action as the 36th state—will be over about 7:30 (Mountain Time) or 9:30 (EST).

MAN KILLED WHEN TRUCK HITS BRIDGE

Another Badly Injured in Accident Near Rocky Mount Early Today

Rocky Mount, Dec. 5—(AP)—H. W. Fulton, 26 of Charleston, S. C., was fatally burned and J. B. Lea, 25, also of Charleston, was injured when their fish truck crashed into a bridge near here today.

Lea's injuries were not immediately known and physicians refused to comment until thorough examination had been made.

The cause of the crash was not known but the truck went head on into the bridge, catching fire immediately.

Fulton died in a hospital several hours after the accident and was conscious until death came. He told a nurse he was engaged to be married Christmas Eve in Charleston.

Lea said he could have saved the life of his companion had he been able to sever a leg pinned in the wreckage. He said Fulton begged him to cut off the leg but he said he could find nothing with which to perform the operation.

Fulton's body was burned in its entirety except for part of the head and a place near the heart.

M'LAWHORN IS AGAIN CHOSEN HEAD OF BOARD

Winterville Man Re-elected Chairman County Commissioners Here Yesterday

R. H. McLawhorne was re-elected chairman of the Board of County Commissioners in the regular monthly session of the organization at the court house here yesterday.

J. N. Williams was also re-elected chairman pro-tem.

All other appointive officers of the county were re-elected for the coming year which begins January 1.

In addition to the election of the officers, the commissioners confined attention to preparation of bonds and discussion of general routine business.

The election of officers paved the way to the beginning of the new year: the first Monday in January and work was expected to move along smoothly with this matter definitely out of the way.

Mr. McLawhorne, prominent grower and landowner of the Winterville community, was named head of the board for his second term, as was Mr. Williams, chairman pro-tem.

Many economies in government have been effected during the past year, and have been effected during the term of the Winterville man, this was expected to continue.

PISTOL ENDS LIFE OF ALBEMARLE MAN

Albemarle, Dec. 5—Apparently the victim of his own hand, Creile Milton, 34, one of Albemarle's most prominent young men, was found dead in his garage yesterday morning about 1 o'clock with a bullet hole in his temple and a 32 calibre revolver from which one bullet had been fired clamped in his right hand.

His funeral was conducted yesterday afternoon from the home on North Second Street, with Rev. D. M. Littaker, pastor of Central Methodist Church, officiating. Burial was in Fairview cemetery.

Mr. Milton had eaten a hearty supper about 7 o'clock Sunday night and had gone out, presumably for a walk around the yard. Becoming alarmed at his prolonged absence, his wife called his brother and their search for Mr. Milton ended when his body was found slumped forward in the seat of his automobile in the garage. The bullet had entered his right temple and penetrated almost through the head.

SEEK TO HALT ELECTION OF LONGFAVORITE

Men With Shotguns And Pistols Patrol Highways in Effort To Stall Balloting in Sixth District; Highway Policemen Sent To Districts With Ballot Boxes; Court Issues Injunction Preventing Distribution of Ballots

Baton Rouge, Dec. 5—(AP)—With defiant and heavily armed citizens patrolling major highways and polling places to block administration efforts for a congressional election in the Sixth district today, state highway police in plain clothes were sent from here to set up ballot boxes in parishes which have declined to take part in the election.

The state police were concentrated at a local hotel during the night and today carried the ballot boxes on trucks out of Baton Rouge for unannounced destinations.

The election started haltingly in most voting precincts and quietly here and in other large centers in the district at the scheduled hour in spite of court injunctions issued by the District court yesterday to prevent any distribution of ballots at the polls.

No polls were opened, however, in the parishes of Tangipahoa, Livingston and St. Helena where violent demonstrations occurred during the past few days and Chairman Lee Ponder of the Sixth District Democratic committee said the election had been called off in the parishes in obedience to the injunction issued by Judge Nat Tyler at Hammond late yesterday.

Ponder, the Long leader in the three parishes said in a statement "the vote in those parishes could not affect us one way or the other," and that the balloting had been canceled there because there had been no time to appeal the Tyler injunction to the Supreme court.

Elsewhere and other outlying areas in the district showed no signs of holding the election as men with shotguns on their shoulders and pistols on their hips stood ready to stop the balloting in case Senator Long seeks to have the district ratify the Democratic nomination of Mrs. Bolivar Kemp, the Long candidate, without holding a party primary.

DEFER CASE AT DECATUR

Trial of Remaining Five Defendants in Scottsboro Case Postponed

Decatur, Ala., Dec. 5—(AP)—Trial of the remaining five defendants in the Scottsboro case on charges of attacking a white woman in Jackson county March 25, 1931, today was postponed indefinitely by Judge W. W. Callahan, presiding, at the request of the defense counsel.

A decision in the case of Clarence Norris, second of the seven defendants in the case to be re-tried here, rested today with a Morgan county jury. The jury retired last night after listening an hour and twenty minutes to the charge of Judge Callahan, but received permission from the court to defer deliberations until 8:30 today.

Norris was tried on a charge of attacking Mrs. Victoria Price, the same offense for which another negro named Patterson was convicted the third time last week and sentenced to death.

RUSSIAN TRAVEL BONUS OFFERED SWEDISH REDS

Stockholm.—(AP)—The governing council of Norrbo, a community in northern Sweden, has decided to help Communist sympathizers visit the country whose praises they sing.

A bonus of two hundred Swedish kronor (about \$40) will be paid each Communist sympathizer who will agree to go to Russia and stay there at least two years.

#### SHARP CURVE GETS ITS FIFTH VICTIM

Morganton, Dec. 5.—John C. Cope-  
land, 32, accidentally killed in an  
automobile accident yesterday, was  
buried at Oak Hill Methodist church  
near here, this afternoon. Copeland's  
lifeless body was found beside his  
wrecked automobile early Sunday  
morning. Testimony to the fact  
that he failed to negotiate the sharp  
curve leading to the Catawba bridge-  
Highway No. 181, a mile north of  
Morganton.

The accident occurred between  
four and five o'clock Sunday morn-  
ing, he was unaccompanied.

It was the fifth accident at the  
sharp approach within three months,  
but none of the occupants of other  
cars tumbling over the 15-foot embank-  
ment was injured.

Copeland is survived by his wife  
Bonnie Queen, his parents, Mr.  
and Mrs. A. C. Copeland, three  
brothers and three sisters. He was  
an employee of the State Highway  
Commission.

#### SLAYER'S CASE CONTINUED IN NASHVILLE COURT

Nashville, Dec. 5.—The cases  
against Eddie Barnes, negro, who  
confessed that he killed Sylvester  
Joyner, another negro, on the night  
of October 13 in Cooper's township  
and against Ernest Parker as a  
principal of the crime were con-  
tinued to the January term of  
criminal court, due to the fact that  
Barnes is pleading insanity.

Since Barnes claims that Parker  
paid him five dollars in cash and  
promised him another ten to com-  
mit the crime, both are to be tried  
for first degree murder. However,  
Barnes' plea of insanity prevents  
the immediate trial of Parker be-  
cause the former would not be con-  
sidered a competent witness in the  
case against the latter. Barnes has  
been placed under the observation

of Dr. T. O. Coppedge, county  
health officer, and other physicians  
who will make their report before  
the next term of court.

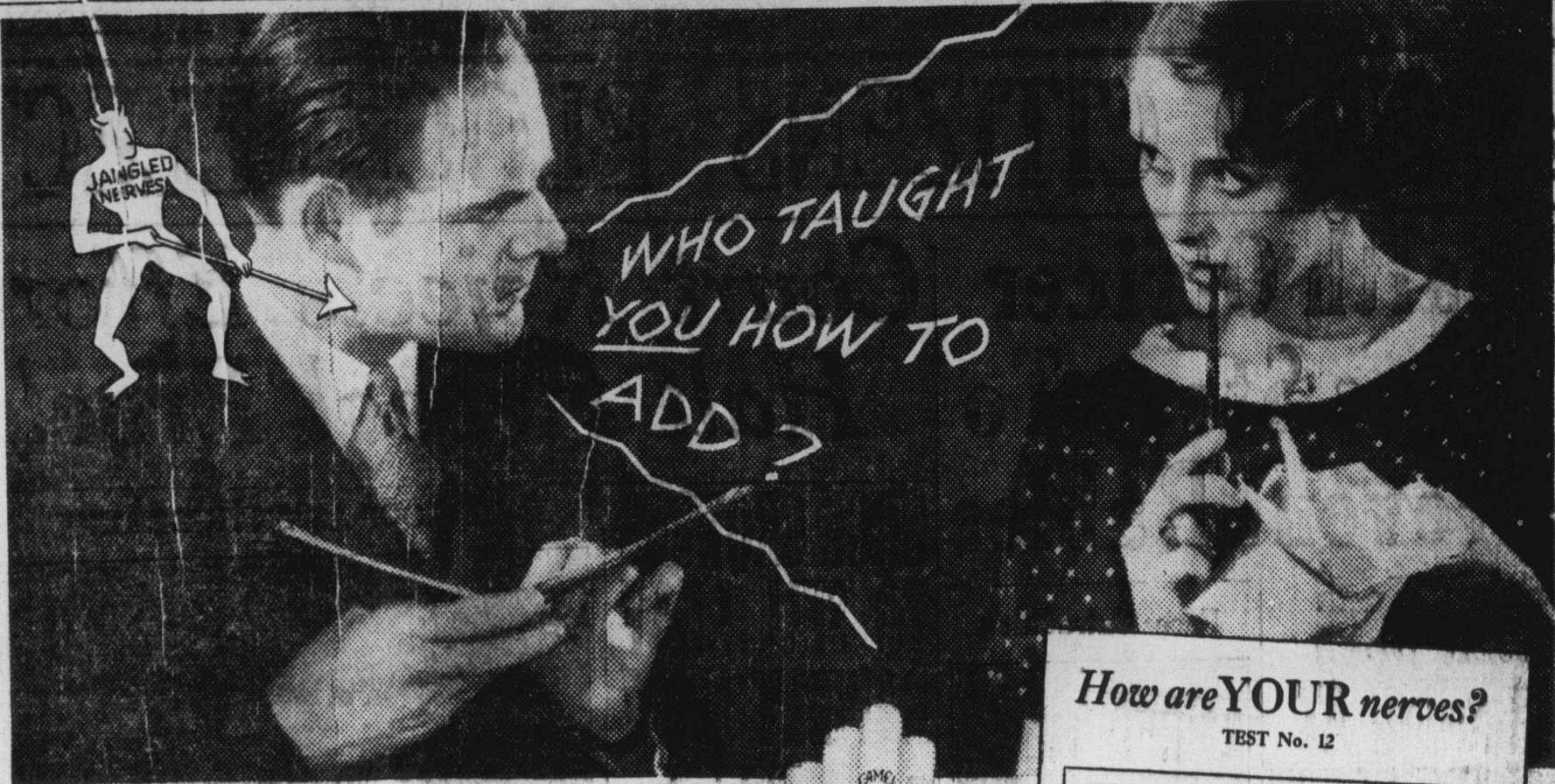

Carthage, Dec. 5.—Another war within four or five years is predicted in a letter to Mrs. L. P. Tyson of Carthage, from her brother, B. P. Parity Price Goal of Corn-Hog Plan

Washington.—(AP)—As the corn-hog reduction program of the Agricultural Adjustment Administration swings into action its administrators aim to correct the disparity in prices which makes eight 100-pound hogs today worth in purchasing power only as much as three in 1914.

To raise the purchasing power of the farmer's hogs to parity, the adjusters say, the farm price should be in the neighborhood of \$8.00 a hundredweight, as compared to present Chicago quotations of around \$4.25 for top hogs.
