

HITLER RUMORED AS SEEKING PEACE WITH FRANCE

Alleged Five Point Program In The Offing

GERMANY WILL ASK FOR MORE PLANES-TANKS

Conscript Army of 300,000 is Also Sought by Nazi Leader; International Prohibition of Use of Gas and Bombing Planes Suggested; Disarmament of Heavily Armed Powers Also Among Proposals

Paris, Dec. 7.—(AP)—Rumors that Chancellor Hitler of Germany has prepared a five-point program for permanent peace with France were given something of an air today by a French foreign office refusal to deny or confirm them. The alleged Hitler program was reported to be as follows: Allowance of a conscript army of 300,000 in Germany. The right of Germany to possess defensive weapons such as airplanes and tanks. The international prohibition of the use of gas and bombing planes. Disarmament of the heavily armed powers. The return of the Saar basin to Germany without a plebiscite. French officials insisted there had been no discussion whatever with Hitler since his talk with Andre Francois-Poncet, French Ambassador to Germany. It was said the French are flatly opposed to surrender the interest in the Saar, granted them by the treaty of Versailles at the end of the World war without a plebiscite and were equally opposed to suggestions that Germany rearm.

LINDBERGH REACH NATAL

Citizens Wish to Fete American Fliers But Can't Reach Them to Do It

Natal, Brazil, Dec. 7.—(AP)—Natal, accustomed, as it is to feting fliers admittedly had a problem on its today in the matter of honoring, or trying to honor, Colonel and Mrs. Charles A. Lindbergh.

The smiling taciturnity with which the American responded to cheers from throngs that hailed them on their arrival yesterday from Bathurst, Gambia, Farica, continued to mask their plans and movements.

The usual rumors flew around; flight into the interior; along the coast or even a grand tour of the continent, but there was neither "yes" or "no" from the flying couple officially.

So Natal had to be content with occasional glimpses of "Lindy" and "Anne" going to and from the British consulate—there is no U. S. consul here—and of speculating upon apparently groundless upon their future movements.

SECOND NEGRO ARRESTED IN ROBBERY HERE

Esau Ross Held For Complicity in Hold-up of Vanceboro Man Last Tuesday

Esau Ross, colored, described by police as an accomplice in the robbery of Hugh Tyson of Vanceboro, in the negro cemetery on First street here Tuesday afternoon, was arrested in Washington last night and was to be returned to Greenville today to face preliminary hearing.

Dave Burroughs, also colored, who was arrested Tuesday night for robbing Tyson of \$40, was given preliminary hearing yesterday afternoon and bound over to the next session of criminal court under bond of \$1,000. He was unable to give bond and was remanded to jail to await trial.

Ross came to Greenville on business Tuesday after procuring a marriage license in New Bern the same day. After he completed his business he decided he wanted to go to the airport on the opposite side of the river to take a spin in the clouds.

He asked two negroes standing on the street to direct him to the airport. They agreed to do so, police said, and instead of going directly to the flying field, led Tyson to the negro graveyard at the end of First street.

Arriving there, Tyson told police that Burroughs pulled a gun from his pocket and hit him over the head with it. The negro then relieved Tyson of his wallet, said to have contained \$40 in cash.

Both negroes fled, Burroughs being picked up by police at a negro house here that night. Ross was traced to Washington where he was taken into custody last night.

Chief of Police George Clark, who went to Washington to return Ross here to face trial, said the negro was wanted for aiding and abetting in the robbery. He said Ross obtained a part of the loot.

LEAF SIGNUP GETS SMOOTH START IN PITT

Over 150 Government Tobacco Contracts Signed Over The County Yesterday

Between 150 and 200 growers signed government contracts when the tobacco signup campaign got underway in Pitt county yesterday according to information released this morning by E. F. Arnold, director of the Pitt County Farm Department, who is in charge of the drive.

It was expected that between 200 and 300 would affix their signatures to contracts today with the same number expected to be added each day during the next ten days. Committeemen who have been stationed in each township to assist growers in making out their contracts and filing applications for benefit payments on all tobacco sold prior to October 7, will remain at their respective posts this week and the remainder of next week, Mr. Arnold said, and growers were asked to co-operate with them in every way possible to speed up the campaign.

Growers must go to the committee before they will be able to sign the contracts, the farm director said, as no contracts will be sent out for signatures.

O. F. Wasmansdorff, auditor for the United States Department of Agriculture, has been stationed in Greenville for the next ten days to assist in the signup campaign and also to obtain first hand information regarding the work in this county. He will later return to Washington to aid government officials in passing on the contracts from this county.

Committeemen are mailing out invitations to growers asking them to appear on certain days for the purpose of signing contracts. This has been done to eliminate congestion and to speed up the work as much as possible. Farmers have been asked to abide by the date on their invitations, and if they do that they will have little trouble reaching the committeemen in comparatively short time after their arrival.

The signup was not as large yesterday as anticipated due to the fact that numbers of growers appeared before committeemen with insufficient information, Mr. Arnold said. They were required to return home and obtain the required facts.

Mr. Arnold asked growers to be careful in this respect and to be sure to obtain all necessary evidence regarding their crops before appearing before the committeemen. This will not only expedite the movement of contracts but also will result in less time being used by the grower himself.

COUNTY COURT CLEARS WORK

Three Cases Disposed Of in Second Day of Two Day Sitting Yesterday

County court completed work yesterday with the disposition of three cases. A dozen-odd cases were completed in a lengthy session the day before and numbers of the defendants were either required to pay fines or found their way to the roads.

Court worked until 7 o'clock Tuesday evening in order to clear the way for completion of work yesterday morning, and only a few actions were left hanging fire for the next session.

Rufus Williams, colored, charged with resisting arrest, was sentenced to 60 days on the roads by Judge Dink James yesterday.

Willie Garris and Ray Dail, colored, were fined \$25 each on a charge of assault with a deadly weapon.

Tom Adams was required to pay a fine of \$100 and cost on a charge of bastardy.

Between fifteen and twenty cases were taken off the docket during the two day sitting. Only a few of the defendants were found not guilty and there was only one appeal to the higher court from judgment. (Continued on Page Four)

Dollar Advances. (By The Associated Press) The dollar in Paris advanced 25 centimes to close to 16.35 francs—equivalent to 6.11 cents to the franc. The franc was quoted later in New York around 6.121-2 cents, off 0.21-2 of one cent from yesterday's close. At the 6.121-2 cents level of the gold franc the dollar was 64 per cent off from parity while the R. F. C. gold price indicated, the dollar at 60.77 per cent of the old parity in terms of gold. OVER 3,000 MEN EMPLOYED ON N. C. ROADS

\$1,411,000 Allotted For Public Construction Projects in this State

Washington, Dec. 7.—(AP)—The Board of Public Roads reported today that 3,071 men had been given work on North Carolina's public work highways through December 2nd.

These men are working on 55 contract projects for which the Public Works Administration has allotted \$1,411,000. The estimated cost of the projects is \$1,935,000.

A total of 95 projects including those to be built by day labor have been advanced for contracts, and allotted a total of \$2,713,000.

This is 28 5-10 per cent of North Carolina's total allotment. The estimated total cost of the projects is \$3,684,000.

Contracts have been awarded for 70 projects but work has not yet been started on all of these. Their estimated total cost is \$2,700,000 of which \$2,144,000 will be paid by the public works administration.

Six public works projects costing \$118,000 have been completed. The public works paid \$68,000 of the total cost of the projects.

VACANCIES FOR DRUMMERS AND TRUMPETERS IN MARINES

Savannah, Ga., Dec. 7.—A limited number of boys between the ages of 17 and 18 will be accepted at the Marine Corps Recruiting Station, Post Office Building, Savannah, Ga., during the month of December to learn the drum and trumpet. It is announced by Lieut. Colonel A. B. Drum, officer in charge.

Applicants for drum and trumpet must have at least an eighth grade education and be not less than 68 inches in height.

In addition to the vacancies for drum and trumpet 35 graduates of high school between the ages of 18 and 30 will be accepted for general service.

Applications will be mailed upon request to young men of this section who have the above requirements.

LEAF MARKET PAYS BIG SUM TO PLANTERS

Local Market Has Paid Out More This Season Than Paid in Entire S. C. Belt

The Greenville tobacco market today had paid out more money to growers of this section than was received by growers in the entire South Carolina belt, it was revealed by comparative figures made public this morning.

The official report of K. W. Cobb, supervisor of sales of the local market, made public this morning, showed the farmers selling on the Greenville market up to yesterday had received a total sum of \$10,439,423.34 for 62,082,924 pounds of leaf.

Reports from South Carolina said that growers of that state had been paid \$10,287,311 this season, of \$6,149,669 more than was received for last year's crop.

Sales on the local market yesterday amounted to 493,586 pounds for which planters received \$99,849.40. The average for the day's sales was given as \$18.20 per hundred pounds.

Tobaccoists today continued to urge growers to bring their tobacco to market as rapidly as possible before bad weather sets in in an view of the suspension of sales December 15 for the Christmas holidays.

With a fairly good rain visiting the section last night, the first since the middle of August, grading of bright leaf was expected to be expedited, and indications pointed to heavy sales the remainder of this week, and in fact, until the market closed for the holiday.

LITTLE BURGAW BOY IS KILLED BY AUTOMOBILE

Wilmington, Dec. 7.—Heywood Byrd, small son of Mr. and Mrs. R. H. Byrd of Burgaw, died at James Walker Memorial hospital shortly after 5 o'clock yesterday afternoon from injuries received about an hour earlier when run over by an automobile in the Pende county town.

The lad was said to have run in the path of an auto an older brother was taken out of the yard at that time. Suffered with a crushed skull the child was rushed to Wilmington but died a few minutes after arriving at the hospital.

FLOYD COX IS SHOT TO DEATH NEAR THE CITY

Robbery Believed to Be Motive For Slaying of Gas Station Employee Last Night

Officers today were seeking a clue in the mysterious slaying of Floyd Cox, 25, employee of the Herbert Cox filling station, on the Greenville-Bethel highway, about a mile from Greenville, who was found shot to death near the old Greenville-Stokes road early today.

Sheriff Sam Whitehurst, who was directing the investigation, said he believed Cox was probably held up and robbed of \$100 he was thought to have had in his possession when he left the filling station last night about 12 o'clock.

The body was found about twenty yards from the road with a bullet wound in the head and heart by a man named Moore who immediately notified officers.

Cox's automobile was standing in the road where he had left it when he entered the woods. Sheriff Whitehurst said about fifty cents in change was found scattered on the ground near the body of the dead man, although nothing was found of the large sum of money he was believed to have had in his possession when he left the filling station.

Cox was last seen when he left the station about midnight, and he was believed to have been slain a short time later judging by the condition of the body when it was discovered this morning.

The body was being held in a local undertaking establishment pending further investigation of the slaying.

Cox, who was unmarried, had been employed for sometime at the filling station of Herbert Cox, his half-brother.

ABSOLVED OF BLAME IN AUTOMOBILE KILLING

Reidsville, Dec. 7.—Frank Henderson, who was driving the car in which W. W. Blackman met his death on Wednesday last, was acquitted after a trial which lasted nearly all of yesterday afternoon. Henderson, a salesman for a drug concern, making his headquarters in Reidsville, was charged with manslaughter and brought before Judge E. Brewer in the local Reidsville court to be given his freedom or bound over to the Superior Court. The decision was freedom. Judge Brewer carrying his answer over until this morning's session of court.

MONEY MART IS OFFERED SECURITIES

Books Opened For Subscriptions of \$950,000,000 One Year Treasury Certificates to Meet December Maturities; Treasury Disposes all Idea that Greenbacks Will be Used in Meeting Obligations

Washington, Dec. 7.—(AP)—Routine methods for raising a billion dollars were chosen by the Treasury today in its first big financing operation since gold buying began.

Dispelling by the action of all talk that greenbacks might be used to meet December maturities, the treasury offered the money market 21-4 per cent for funds to meet immediate needs.

Books were open for subscriptions of \$950,000,000 one year treasury certificates dated December 15 and paying the 21-4 percent rate. The money will be used to retire \$738,000,000 of obligations maturing on the same date—\$473,328,000 of 4-1-4 certificates and \$264,672,000 of bills bearing 3-4 of one percent.

Another portion—\$114,000,000 will go to the interest payment on public debts. The remainder of more than \$100,000,000 will be added to the treasury's cash balance which stands now at about \$1,000,000,444. By exceeding December maturities by \$222,000,000 debt financing will push the public debt much higher. It stands now at more than \$23,500,000,000 after reaching the low or just above \$16,000,000,000 from the war debt peak of \$26,596,000,000 in 1919.

Just what effect the gold buying program had on the form of the refunding issue was not a question between those for and against the gold policy.

The former foresaw no difficulty in disposing of the securities and considered the interest moderate, pointing out that more than half of the maturing obligations are paying 4-1-4 per cent.

Others contended the gold policy had created a condition in the bond market which required the treasury to use short term credit or pay the interest. They said the 4-1-4 maturities were so high only because they were floated at the time of the bank holiday.

SEC. WALLACE SPEAKS TODAY

Sees New Conception of Religion in Address Before Council of Churches

Washington, Dec. 7.—(AP)—A new concept of religion to fit the spiritual needs of men and women in the rapidly changing economic picture was suggested today by Secretary Wallace in a speech before the Federation Council of Churches of Christ of America.

"The problem of statesmanship is to mould a policy leading toward a higher state for humanity and to stick by the policy and make it seem desirable to the people in spite of short time political pressure to the contrary," he said. "True statesmanship and religion have much in common."

COLLEGE HERE GIVEN PUBLIC WORKS GRANT

\$12,445.50 to be Spent in General Improvements of E. C. T. C. Campus

It was announced today that East Carolina Teachers college had received a grant of \$12,445.50 from the Civil Works Administration for improvement to be made on the college campus during the next two months.

The information was given out yesterday afternoon by M. L. Wright, R. C. Deal and A. C. Forbes, who will be in charge of the improvement program.

First work in connection with the college program was to get under way today and will be continued each day over a period of two months, affording employment for forty men, it was said.

The projects include beautification of the campus, driveways, athletic field and tennis courts, and it was expected they would add much to the general appearance of the institution when completed.

The grant is similar to those being made by the federal government in all parts of the country in an effort to relieve unemployment and increase the purchasing power of the people. It is one of many made in this locality, and work in many instances has already started with indications that over a thousand men will be put on relief payrolls during the winter, or before the administration program closes the middle of February.

TAX MEN IN MEETING HERE

Revenue Department Heads Attend Session Held Here Last Night

Commissioner of Revenue A. J. Maxwell, Harry McMullen, director of Sales Tax Division, and J. R. Collier of Revenue Department were in the city last night and met at the Chamber of Commerce rooms for conference. The following deputy commissioners were present: A. J. Maxwell, Raleigh; Harry McMullen, Raleigh; Miles Forbes, Elizabeth City; R. F. Tuttle, Edenton; J. C. Herring, Wilson; A. N. Shaw, Kinston; N. F. Rowe, Morehead City; Tom Hollingsworth, Greenville; L. R. Morris, Wilson; W. A. Baker, Goldsboro; G. McPherson, Rocky Mount; L. Melver; H. B. Briner, Washington; John Langston, Plymouth; Carl Moore, New Bern; Ed James, Robersonville; J. N. Collier, Raleigh.

Mr. Maxwell in addressing the meeting complimented very highly the work done by the field men in Eastern North Carolina. He urged them to make their work as near 100 per cent complete and thorough as possible. He reported that the state revenue was coming in now in increasing volume establishing the claim of state authorities that its budget was now balanced and state finance in good condition notwithstanding the state had by act of the last legislature taken over all the cost of operation of schools, relieving property of the burden of taxes by economies and enactment of the 3 per cent sales tax.

Mr. Maxwell also asked those present to do all they could to get owners of cars to secure their licenses early in December. If this is done he said the state can meet its large debt service payment due on January 1st, without temporary borrowing. No extension of time for securing licenses this year would be allowed he said, and car owners without a license can not operate after last day of December.

Mr. McMullen reviewed briefly the accomplishment of the state in enacting the sales tax. Property has been relieved of taxes in North Carolina to such an extent that counties now find they can collect their levies. In many counties he said, property has been relieved to more than fifty per cent of the burden and from all over the state come most gratifying reports of appreciation of tax payers for this changed situation.

Revenue from the sales tax he said, is necessary each month and it now is indicated that returns will be most satisfactory. Cost of collection is running about 2 per cent.

Reports were made in detail by each of the deputy commissioners present. The increasing prosperity of Eastern North Carolina and co-operation of merchants were shown in these reports. According to the reports less than 1 per cent of the merchants were legally delinquent in making sales tax returns.

New York—The book trade's rush to get books on wine and such into print by the time prohibition is almost equalled by the Ivan Bunin flurry.

Bunin, it will be remembered, was awarded the 1933 Nobel prize for literature the other day—much to everyone's surprise. Bunin is a writer of the old Russian regime, and since the revolution he has lived very quietly indeed in Grasse particularly and other French towns occasionally.

Immediately the award was announced there followed news of Bunin reissues. Two just have been made, and a third is in prospect. Probably there will be a book of new short stories a little later. And equally likely is a book of Bunin stories in various magazines.

The two reissues so far comprise a book of short stories and a novel, the first called by the title of Bunin best known short piece, "The Gentleman From San Francisco." The novel is a study of Russian village life on the edge of the Steppes, and is called very simply "The Village."

The short pieces many modern readers will feel to be a little outmoded. They present Bunin rather in the light of a misanthropic poet a good deal misunderstood by the world in which he finds himself, whereas the novel contains a vigorous and forthright picture of peasant life in Russia.

Paris Again
Very different indeed is Herbert Gorman's "Jonathan Bishop."

"Jonathan Bishop" is theoretically a novel, and actually does carry a story through to a rather illogical but very affecting end.

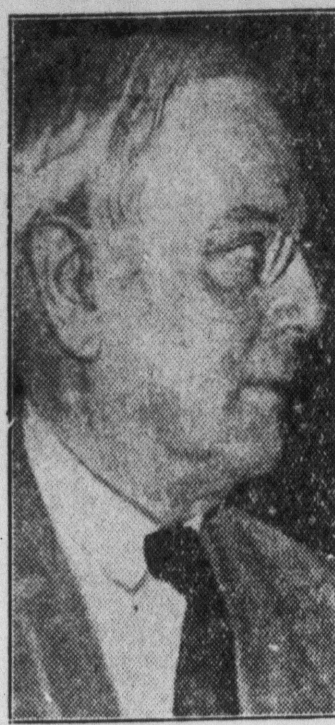

Polo—Cecil Smith, Texan, who played a star role in the West's victory over the East; and Elmer Boeske, Jr., lanky Californian who has not played on a losing team in competition on two continents within the past year.

The team accomplishments that stood out against a brilliant background included the sensational performance of the New York Giants under Bill Terry's leadership, the triumph of the British Davis Cup team, ending France's six-year reign, the victory of Louisiana State's track team over Southern California in the national collegiate, the West's polo conquest of the hitherto invincible East, and the return of Princeton's football team to power in the East.

COLLINS SUMS UP SEASON ON UNC GRIDIRON

Chapel Hill, Dec. 7.—In his weekly column in the Alumni Review football section, which comes from the press tomorrow, Coach Chuck Collins, after bringing out some interesting facts about the inside strategy of the final game with Virginia, sums up the Tar Heel season and indirectly answers some of his critics.

Teams are rated in early season by coaches and sportswriters. Coach Collins points out, "not so much by hopes and desires of their supporters but by where the good football material has been going in the past several years."

"At the start of the season Carolina was rated as runner-up for fifth position in the Conference with Duke, South Carolina, and Duke ahead of us. We finished third. I'm sure by all the critics we were no better than third. We finished third."

"We had ten hard games in a nine-game schedule. These were with Duke and Georgia. We played good close games against Vanderbilt, Georgia Tech, and Florida, and with a more mature ball club we might have reversed the scores in

any of these games. We won from three state opponents and then ended the season with the Virginia victory.

Coach Collins looks for a better team next year. For his reasons he cites the improvement in the varsity after the Georgia game, the fact that only four players completed their eligibility, and the strength of the material coming up from the freshman team.

"Of our playing squad of 28 men" he points out "eight have played two years and 16 were playing their first year. Ten of the later were back-field men, which may explain the inconsistency of the offense during the season."

"The freshman team showed six good linemen who are real college prospects and eight backs with promise but most of whom are too light for regular duty in a varsity lineup."

"With the addition of the freshman material the Carolina varsity squad," he thinks, "should be in better shape to play the array of hard games that have been scheduled for 1934 than it has been at any time since 1930. The reinforcements from the freshman line will be particularly helpful, as it was in this department that injuries took greatest toll this year."

Coach Collins is frank to say that Carolina needs more and better football players to meet the type of teams who make up half the Tar Heel schedule. The difficulty, he points out, is that lack of the University of scholarships and self-help jobs with which to aid god but needy students whether they be football players, Phi Beta Kappa students, or what not.

Peek Ma Be Switched. Washington, Dec. 7.—(AP)—The transfer of George N. Peek now agricultural adjustment administrator, to the National Recovery Administration to take over the agricultural code, newly placed there appeared today likely to be decided upon by President Roosevelt as a solution of disagreements in the agricultural department that have delayed action on these important codes.

This prospect developed as the President conferred with Secretary Wallace and Rexford Tugwell, assistant secretary of agriculture, who had been at odds with Peek on agricultural policies.

Three Killed In Gun Battle. El Paso, Texas, Dec. 7.—(AP)—Three men were killed and another was wounded in a gun fight between U. S. border patrolmen and liquor smugglers at the foot of Park street early today.

Patrolmen said more smugglers may have been killed. They saw two men fall into the Rio Grande during the fight and were looking for the bodies. They may have been the two men who are dead at Liberty Hospital, Jaurez, across the border.

The battle started when E. C. Melton, 31, U. S. border patrolman, one of the victims, and five other inspectors challenged sixteen men who had waded the river with 150 gallons of liquor.

Lenient With Dry Law Breakers.

Washington, Dec. 7.—(AP)—Attorney General Cummings said today the justice department's general attitude toward dry law violators of previously good character would be entirely lenient but he promised vigorous prosecution of the habitual criminal type.

He estimated that of the 2,219 Federal criminal cases pending, 509 were dry law cases and said that 3,764 Federal prohibition offenders were in jail out of a total prison population of 16,557.

The prison population was described by Cummings as 6,809 below the figure for a year ago. He attributed the decrease to a more liberal treatment of prohibition cases because repeal was in sight.

Cummings estimated that within the next year there may be as many as 10,000 cases of violation of liquor violation laws.

Reach Strike Agreement.

Asheboro—C. L. Richardson, U.S. Commissioner of Conviction, announced today an agreement had been reached to end the six week old strike of the Setwick Silk Mills employees.

Richardson said he wasn't ready at present to announce details of the agreement but said it had been approved by the mill management and a committee representing the strikers.

DIES FROM INJURIES IN AUTOMOBILE MISHAP

Hamlet, Dec. 7.—Billy Flaherty, 7-year-old son of Mr. and Mrs. C. M. Flaherty of Hamlet, died at 1:15 yesterday morning in the Hamlet hospital from a crushed skull and internal injuries.

The child was injured in an unusual accident Monday. His brother started the family automobile to get it out of a wet spot where it had been washed. When the machine was started it lunged back against the side of the house, crushing Billy, who was standing behind it.

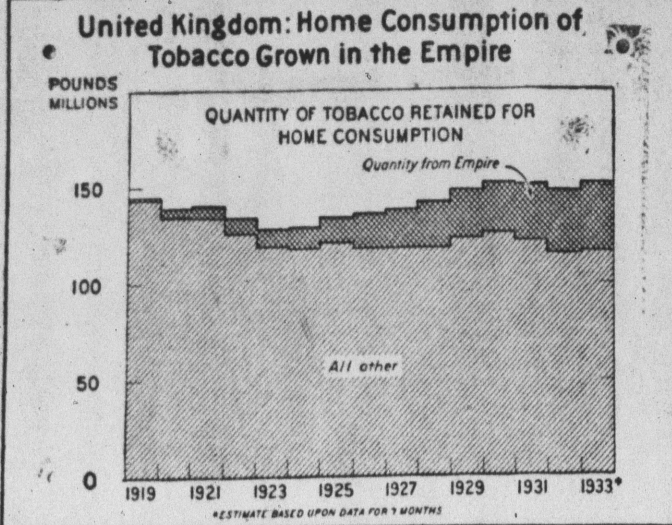

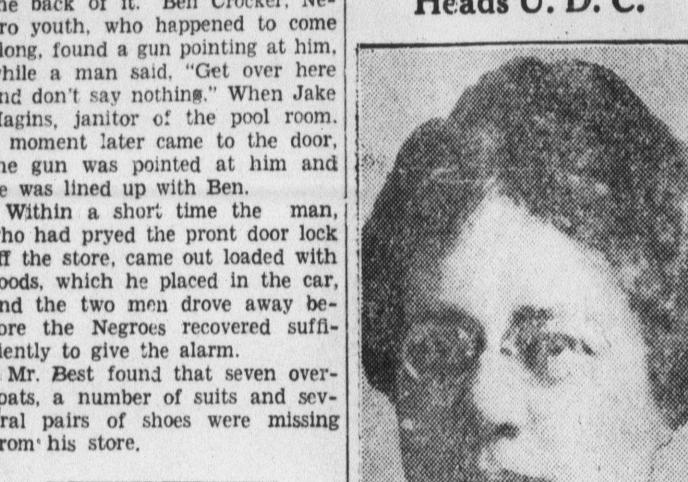
