NEGRO SLAIN AND BURNED ON PYRE BY TEXAS MOB

Charged With Slaying Wife Of a Planter

HUNDREDS OF PERSONS TAKE PART IN CRIME

David Gregory, Shot in Clash With Officers, Taken From Sheriff Dragged Through Streets of Negro Section and Then Burned on Pyre; Heart and Other Organs Cut From Body by Frenzied Mobmen

Kountze, Texas, Dec. 8.—(AP)—David Gregory, negro ex-convict, accused of criminally attack and slaying a white woman, was shot to death, mutilated and burned by a mob which dragged the body to a pyre in the negro section of the city early today.

Officers and incensed citizens who had been searching for the negro since Mrs. Melle Williamson Brockman, 30, wife of a farmer, was found dead on a highway near here last Saturday.

Last night a posse trailed the negro to his hiding place in the belly of a negro church of Voth, a town between Kountze and Beaumont, where he was shot and wounded when officers said he drew a pistol and resisted arrest.

The wounded negro, unconscious, was taken to a hospital to Beaumont, but when officers received word that a mob was forming at Kountze, they started toward Beaumont, they took the negro away in an automobile in an effort to protect him. Without making any statement as to his guilt or innocence, the negro died as the automobile bearing him sped toward Voth, six miles east of Beaumont.

The body was taken to Silsbee, another small town in the vicinity of Sheriff Miles Jordan of Hardin County. On hearing of these developments, the mob increasing in size, trailed the sheriff to Silsbee, took the body from him, tied it behind an automobile with chains and dragged it for 35 minutes through the negro section of the country.

Members of the mob numbering about 200, cut out the negro's heart and other organs before casting it into the flames.

The mob then threatened to raid the Hardin County jail here in an effort to punish upon two other negroes under arrest suspected of having aided Gregory to evade officers after the woman was killed. The mob dispersed after burning the body.

In the face of the threat, twenty deputies, rangers and armed citizens stood guard at the jail until the danger had passed.

Mrs. Brookman started from her home alone in a light truck and was shot to death beside the truck which had been set afire. Flames had seared her body. She had planned to change a pair of baby shoes she had bought.

LEGION LEADS IN MEMBERSHIP

Pitt County Post of the American Legion has received congratulations from State headquarters upon the success of this recent membership drive put on here.

NAB NEGRO IN THEFT OF LEAF

Willie Jackson, Beaufort county negro, was returned to Washington today to face trial on a charge of stealing tobacco from a Mr. Harding, farmer living in the Choctawhatchee community.

The negro was arrested by police here last night after he had allegedly placed 900 pounds of tobacco on sale on one of the warehouse floors. Two other negroes were believed implicated in the theft but they escaped. Police said they hoped to pick them up in a short time.

BOARD PAVES WAY FOR WORK ON POOL HERE

Construction Work on Culvert and Swimming Pool to Begin On Monday

Final action looking to the erection of a municipal swimming pool and culvert here was taken at the regular monthly meeting of the Board of Aldermen last night with the naming of a committee composed of board members and citizens to direct construction work on the two projects.

The committee, composed of Mrs. J. L. Hassell, J. H. Boyd and H. H. Duncan, representing the aldermen and Martin Sharitz, Ralph Garrett, representing the citizens, was the first step looking to actual construction work which will get under way next Monday morning.

The pool and culvert, which will cost \$2,184.95, will be paid for through funds allotted to the city by the Civil Works Administration, and are among several other projects of a similar nature under way in and around Greenville at this time. Of this amount the city will be required to pay only \$7,533.48.

The actual cost of the pool itself will be \$17,956. The total amount to be expended for the culvert is \$11,238.95.

The pool will be located on Fifth street in front of the high school building, and will be one of the finest in this part of the state embracing as it will all of the latest features in this line of recreation.

The culvert will connect with one between Evans and Cotanch street and continue for 895 feet to Fifth street. It is an improvement long needed for that section of the city and is expected to do much toward cutting down the mosquito and malarial menace.

The aldermen decided it would be necessary to complete certain phases of the work on the culvert first, so laborers will be put to work on this project Monday morning. Excavations for the swimming pool, however, were expected to begin in a few days.

In addition to paving the way for creation of the two projects, the board also awarded contract for the city audit to George Scott, Charlotte auditors.

The remainder of the session was confined mainly to consideration of routine business, including reading of reports and paying of bills accumulating during the past month.

LINDBERGH'S OFF FOR MIAMI

Fortaleza, Ceara, Brazil, Dec. 8.—(AP)—The big red monoplane of Colonel and Mrs. Charles A. Lindbergh, passed over here at 10:04 a. m., Brazilian Time, 8:04 (E. S. T.) in a northerly direction.

The Lindberghs had been out of Natal for about two hours. Apparently the Lindberghs were traveling fast, for Fortaleza, or Ceara, the capital of the State of Ceara, lies 300 miles northwest of Natal.

The time given showed they had flown the 300 miles distance in one hour four and forty minutes.

Natal, Brazil, Dec. 8.—(AP)—Colonel and Mrs. Charles Lindbergh hopped off for Miami in the big red monoplane today at 8:15 a. m., local time 6:15 a. m. (E. S. T.).

Their route, it was indicated, lay by the way of Para, Belem, Brazil, and thence north along the American coast. After forty hours in Natal to which they flew from Bathurst, West Parica, the famous American flying couple left Natal indifferently from that of most visiting aviators. The population, although enthusiastic, was unable to understand the Colonel because he was unwilling to pose for photographs submit interviews or attend any of the parties which had been planned for him and his wife.

Late News Flashes From Over World

Dollar Steady. (By Associated Press) The dollar was almost steady in relation to the franc, closing in Paris at about 6.14-2 cents. The franc was later quoted in New York at 6.15 cents which was only one-half cent of a cent from yesterday's final level.

With the franc at 6.15 cents the dollar was at 6.74 per cent off from parity.

Lindberghs At Para. Para, Brazil, Dec. 8.—(AP)—Col. and Mrs. Lindbergh, homeward bound here at 1:30 p. m. E. S. T. today after a flight from Natal, Brazil.

When the Lindberghs landed here at 1:30 p. m. they were 1,904 miles from Natal. More than 3,000 miles still separate them and Miami.

A light shower was falling as the big red plane swooped down on the field. Mrs. Lindbergh was at the wireless reporting to Pan American Airways, for which her husband is an advisor, as the craft ended the long hop.

Lindberghs Call Home. Rio De Janeiro, Dec. 8.—(AP)—The Maritime police said today its radio station has picked up a wireless message addressed to Col. Lindbergh from the United States saying he and his wife must return home at once because of family interests. No further details were made available.

Virginia Declares Tobacco Holiday. Richmond, Dec. 8.—(AP)—Governor Pollard at a conference with tobacco men today agreed to close all dark-fired tobacco markets effective at the close of business today until further notice.

The action was taken by the Governor after the delegation had complained of low prices for the weed and recommended the holiday be declared.

A campaign to induce growers to decrease the acreage for next year will be started.

Recommend High Liquor Tax. Washington, Dec. 8.—(AP)—The President's special inter-departmental alcohol committee has recommended that Congress impose a tax of \$2.60 a gallon on distilled spirits, as compared with the present \$1.10 tax. The committee also recommended that all beers be taxed \$5 a barrel, the same as present \$2.20.

The present tax on beer of alcohol content in excess of 3.2 is \$5 a barrel.

The committee recommended that an additional 16 cents per gallon tax be assessed on blended or rectified spirits over and above the 2.60 gallon levy, bringing the total to \$2.76.

The present law approved an additional 30 cents a gallon on rectified and blended liquors.

LAUDS LEGION FOR SCORING USE OF NAME

Department Commander Congratulates Local Post on its Recent Action

J. H. Rose, commander of the Pitt County Post of the American Legion, was in receipt of a letter today from Tom C. Daniels of New Bern, commander of the North Carolina Department of the Legion congratulating the local post upon its recent action condemning the use of the name of the Legion in schemes looking to private exploitation.

The letter referred to resolutions passed at a recent meeting of the post in which it struck out sharply against those responsible for using the Legion's name in connection with the Royal Court Ball about three weeks ago. The copy of the resolution was carried in Greenville and other papers of the state.

Mr. Daniels' letter follows: "I have a copy taken from the News and Observer of the 24th of the resolution adopted by your post condemning the use of the name of the Legion in schemes looking to private exploitation.

"Let me congratulate you and your post upon the passage of this resolution and furnishing same to the press of North Carolina for publication.

"I note that a copy was to be furnished to the department headquarters and as I have not been at headquarters, I have had no notice of its having been received.

"If all posts would take the same action that your post has taken in schemes of like nature, it would result in a great good to the Legion as a whole and would help to keep the Legion in the good will of the people.

"I was in Indianapolis at the time, and had received no notice of the use of my name as patron of the dance, and only learned of same in the columns of the press upon my return. I certainly would not have permitted the use of my name, and more especially with its official Legion designation for the purpose in which it was used."

Funeral services for A. A. Nichols, 71, were conducted from the home of his son, D. N. Nichols, on Ninth street, this morning at 11:00 o'clock by Rev. W. A. Lillycrop, pastor of St. Paul's Episcopal Church, and Rev. W. A. Ryan, pastor of the Christian Church. Burial was made in Greenwood cemetery.

Mr. Nichols died yesterday morning at 5:17 at the home of his son after an illness of five days.

The final rites were largely attended and a large floral tribute attested the high esteem in which he was held.

He came to Greenville from Beaufort county about a year ago and had made his home here ever since. He was a retired farmer and was prominently identified with the industry in Beaufort county over a period of many years.

He was a member of the Washington Episcopal Church. He is survived by twelve children who reside in various parts of the country.

CITY TO SEEK MORE PUBLIC WORKS JOBS

Meeting Called For The City Hall Tonight to Discuss the Question

Senator A. B. Corey, member of the Civil Works Administration Committee, today issued a call for a meeting at the City Hall tonight at 8 o'clock for the purpose of working out more civil works projects for Greenville.

Members of the Board of Aldermen and heads of various organizations of the city have been invited to attend the meeting and take part in the discussions. Heads of any organizations not reached by telephone today, were asked by Mr. Corey to be present also.

Senator Corey said there are a number of projects needed by the city which might be obtained through Civil Works Administration funds and urged that immediate action be taken on the matter.

Among the projects he had in mind were a sewerage disposal plant, city incinerator for disposal of garbage, street repair and extension of Third and Tenth streets through the highway to relieve congestion in the main part of town.

Mr. Corey went to Raleigh this afternoon to take up the question of labor for such projects with Capus Waynick, state director, and results of his conference will be conveyed to the meeting tonight.

LEAF SALES PICK UP HERE

Around Million Pounds of Tobacco Expected to be Disposed of Today

The movement of tobacco to the Greenville market picked up sharply during the last two days compared with the first of the week and indications this morning were that around a million pounds of bright leaf would be sold here today.

The official report of sales made public this morning by K. W. Cobb, supervisor of sales, indicated the market yesterday sold 716,468 pounds of tobacco for a total sum of \$127,966.69 at an average of \$17.86 per hundred pounds.

With tobaccoists urging farmers to rush the remainder of their crop to market before bad weather sets in, it was expected sales next week would be as heavy if not heavier than this week.

The market will close for the observance of the Christmas holidays December 15 and will reopen for resumption of business on January 2. This decision was reached at the regular meeting of the board of trade the first of the week.

INQUEST IN COX MURDER SET FOR TODAY

Coroner to View Evidence in Mysterious Slaying; Funeral This Afternoon

A coroner's jury this afternoon to view evidence in connection with the mysterious slaying of Floyd Cox, 25-year-old filling station employe, whose bullet-ridden body was found on the old Stokes road, several miles from Greenville, early yesterday morning.

Coroner A. A. Ellwanger called an inquest for 4 o'clock today, and all information obtained in the extensive investigation of the slaying will be placed before the jury. A report was expected to be made during the late afternoon.

Funeral services for young Cox were held from the home of his brother Raymond Cox, on the Cox Mill Road this afternoon at 2 o'clock by Elder W. H. Laughinghouse, Free Will Baptist minister, and burial was made in the Hardy Graveyard near Red Banks.

Surviving are his father, Shade Cox; four brothers, Raymond and Sam Cox of Pitt County, and Herbert and Herman Cox of Beaufort county; two sisters, Mrs. Tom Cox and Mrs. Raymond Paramore of Pitt County.

Sheriff Sam Whitehurst, who took charge of the investigation immediately after the finding of the body of Floyd Cox in the woods, said today he had been unable to obtain any tangible clue in the slaying.

He said he believed, however, that robbery was at the bottom of the crime in view of the fact that Cox was thought to have had \$100 in cash in his pockets when he left the Herbert Cox Filling Station where he was employed, about 12 o'clock Wednesday night. The murder was believed to have been committed shortly afterwards. A small amount of change was found on the ground near the body, which carried bullet wounds in the head and chest.

Young Cox resided on the Cox Mill road five miles from the city. He was well known in an around Greenville, being a member of the local order of Red Men. He was connected with his half-brother, Herbert Cox, in the operation of the filling station about a mile north of Greenville for some time.

SCHOOLS WILL CLOSE DEC. 19

City Schools to Begin Observance of Christmas Holidays On Tuesday

Public schools of Greenville will close for observance of the Christmas holidays Tuesday, December 19, and will re-open for resumption of work on January 3, it was made known today by J. H. Rose, superintendent of schools.

A full session will be held by all schools the day work is suspended for the holidays, Mr. Rose said.

During the intervening time Christmas exercises were expected to be held in the majority of schools. These will be of a varied nature and are expected to be among the most impressive of years.

Already the spirit of the Yuletide has penetrated the school-room and thoughts of what Old Saint Nick will do about filling up stockings this year are racing through the heads of the major part of the student body. With business conditions better than they have been in years, the outlook for the future is decidedly bright and many who were denied full stockings last year may fill them to bursting point this time.

FATALLY INJURED IN AUTOMOBILE CRASH

Concord, Dec. 8.—J. J. McIntyre, former deputy sheriff of Stanly county, received fatal injuries last night when the car in which he was riding as a passenger with Spencer Honeycutt, private detective of Albemarle, collided head-on with a machine driven by Clarence Barrier, Jr. of this city, son of ex-Mayor C. H. Barrier, near Mt. Pleasant on the Concord-Albemarle highway. McIntyre died at 10 o'clock after being brought to the hospital here. His skull was badly fractured at the base.

We desire to express our appreciation to every grower for the patronage given us, and to assure you it will pay you to market the balance of your crop with us. We know that the fine spirit manifested on our market by the tobacco buyers has not been excelled by any other market. This, and the fact that everybody has been pulling together in behalf of the tobacco growers selling on our market, has made Greenville the outstanding tobacco market of the entire flue cured belt.

This joint market report has been sent you through the courtesy of all the Greenville Warehousemen, and before it is discontinued on December 12th, let us urge everyone to promptly sign the government contract for controlled production of flue cured tobacco, which we agreed to do during the marketing holiday. The most constructive accomplishment ever achieved by our tobacco growers was when we persuaded the government to step in and save us from destruction. This 1933 crop, in the opinion of government officials, would not have average 11c, had this crop control program failed, and next years crop would have been lower.

There is a growing decrease in demand for our tobacco in foreign countries, notwithstanding present uncertain favorable exchange, and we must raise less tobacco if we expect to market our crop at a profit. 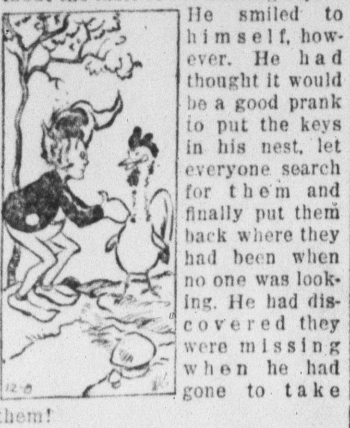

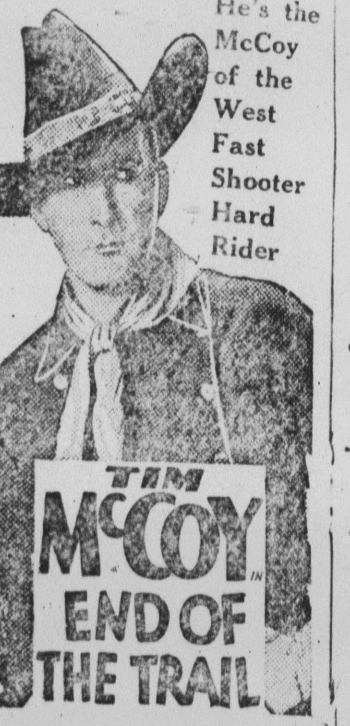

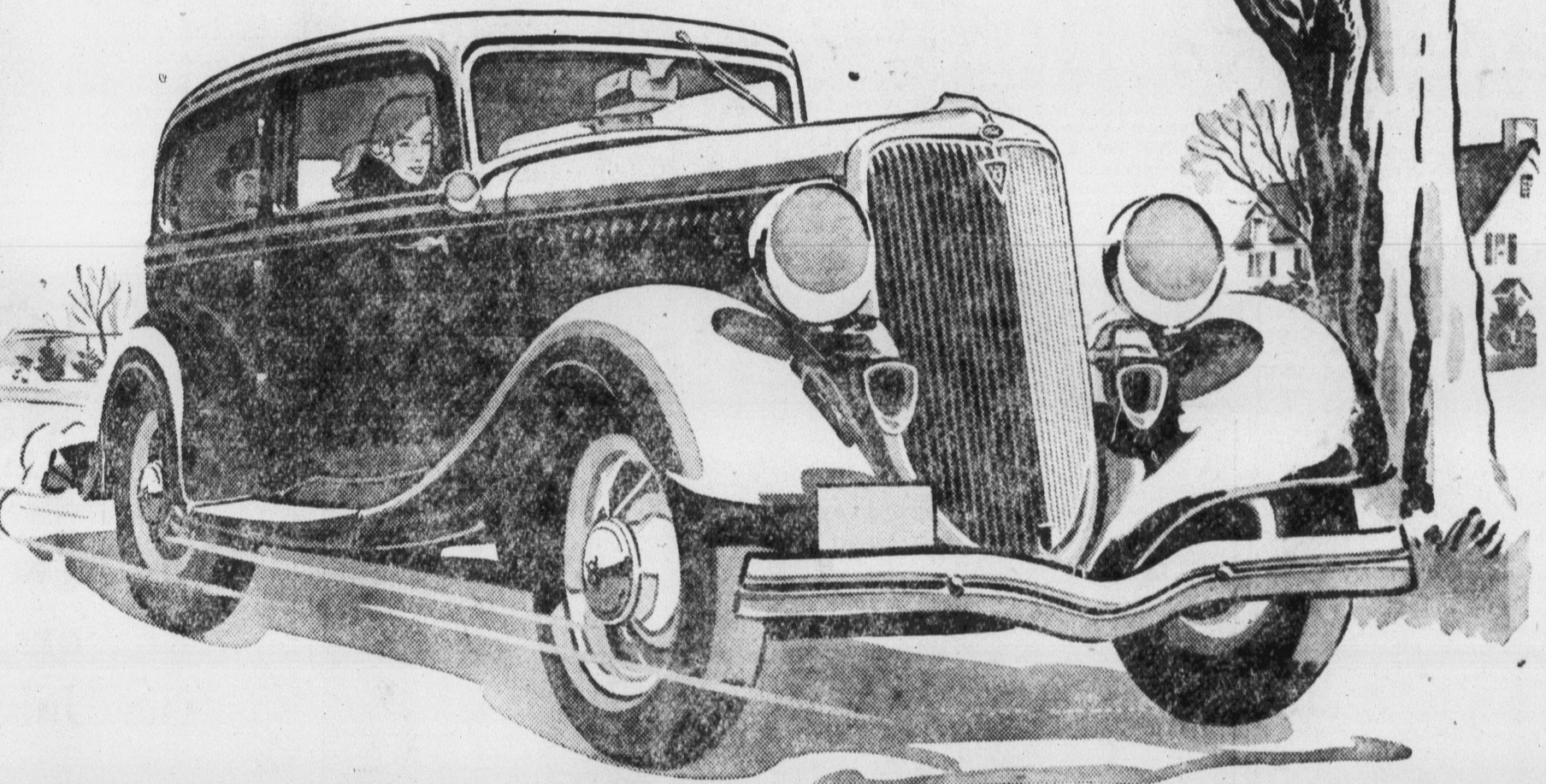
