WOODIN RESIGNS AS SECRETARY OF THE TREASURY

New Bank Code Effective In America Today

INSURANCE ON DEPOSITS IS INCLUDED

More Than 99 Per Cent of All Banks Offering Insurance Feature; Government Help Is Also Offered Banks With Surplus; Roosevelt Monetary Program Continuing to Move Toward its Goal

Washington, D. C., Jan. 1.—(AP)—A new banking era begins today with a new year which opened speculative vistas of new financial moves and closed on epoch stamped indelibly with a nation-wide bank holiday.

Lock-stepped with the new 1934 is a national insurance on deposits in more than 13,000 institutions—99 per cent of all banks, according to Jesse Jones, Reconstruction Finance Corporation chairman and 97 per cent of all bank accounts in the estimate of the Federal Deposit Insurance Corporation.

Outstanding also is a New Year's offering of government help for banks with surplus funds. Simultaneously taxes bringing in \$300,000,000 are listed.

Still closely veiled amidst other developments, President Roosevelt's monetary program moved toward its commodity goal. Gold buying in scheduled to continue and may possibly expand and silver coinage under the international agreement is in its infancy.

LEAF BENEFIT BLANKS SENT TO PLANTERS

Nearly 2 Thousand Blanks Mailed to Growers Who Signed Contracts Here

It was stated today at the office of E. F. Arnold, director of Farm Department, that 1,800 growers who signed the tobacco reduction contracts had been mailed price-equalizing benefit blanks.

These blanks must be signed by committeemen, it was said, carried to warehouses for certification slips and then presented at the farm department where it will be mailed to Washington for payment.

The benefit payments affect only farmers who sold prior to October 7. It was estimated that growers who sold in Greenville will receive \$250,000.

Efforts were being made to complete the sign-up this week, Mr. Arnold said, and growers who have not yet signed were urged to get busy and do so at once and be in line for the benefits which growers will receive next season.

Firemen Called To Grass Fire

FEW CHANGES GREET 1934 IN THIS CITY

Practically Same Forces Used Prior to Holiday to be Employed This Year

Few changes marked the dawn of the new year in Greenville.

A survey of business houses indicated that practically the same forces used prior to the holidays would continue at work during the present year.

Of course scores of extra clerks employed to take care of the holiday rush found themselves looking for new jobs, but outside of this, there were no changes reported, save that of Miss Iva Shelburn, employee of the Home Owners' Corporation who has gone with John Planagan Buggy Company. She succeeds Mrs. R. B. Greene, who resigned.

The new year found the majority of business houses either completing or starting inventories and these were expected to be completed tonight or tomorrow.

Hoping to complete this important work by the first of the year, numbers of firms taking stock last week and today found them ready to start the new year in real style.

After the best fall and winter business of years, especially preceding the holidays, merchants were looking toward with confidence to the remainder of the year. They believe implicitly that attempts of the Federal administration to improve conditions will continue to meet with success and are looking forward to a tremendous improvement over last year.

Then, also, the tremendous amount of money paid out on the local tobacco market this season has been, and will continue to be, a big factor in increasing purchasing power of the general run of people. The home of Ade Whitford at Dave Smith's Crossing, near the Craven County line, was destroyed by fire Sunday afternoon at three o'clock, according to information reaching the city today. The house and entire contents were a complete loss, it was said. The cause of the fire was undetermined and the loss was not covered by insurance.

TWELVE DIE IN FLOODED CAL. STREAMS

More Than Score Injured as Result of Torrential Rains; Hundreds Homeless

Los Angeles, Calif., Jan. 1.—(AP)—A death toll that may reach twelve, more than a score injured and a hundred homeless, were counted in Southern California today as the result of torrential rains, the heaviest on record. Every river and creek bed in the Los Angeles area was overflowing, inundating large areas thickly inhabited. A number of Southern California communities within fifty miles of Los Angeles were isolated.

Highways, electric line and railroad tracks were washed out in numerous places. An undetermined number of young persons were believed drowned last night when the weight of their two cars broke down a wooden bridge over the swollen Los Angeles River. The river, ordinarily a few feet in width and depth, was a roaring torrent more than 25 feet deep and 175 feet wide. Several hours after the accident no accurate list of the missing was available.

CITY'S FIRE LOSS SHOWS GREAT DROP

Annual Report of Fire Chief George Gardner Gives 1933 Toll at \$33,841

Greenville's fire loss which has been showing a rapid gain since 1930, dropped perceptibly during the past year, records in the office of George Gardner, chief of the local fire department, indicated today.

The annual report of the fire chief which will be submitted to the Board of Aldermen at their next meeting gave the 1933 fire loss at \$33,841 as compared with \$236,555 for 1932, \$263,334 for 1931 and \$49,378 for 1930.

The report covered a total of 92 fires for 1933 as compared with between 90 and 100 for the previous year.

There were no large fires here the past year and this was largely responsible for the fine showing made by the city, the fire chief said. The largest of the conflagrations was the wrecking of the home of Col. E. G. Flanagan on Evans street with a loss of approximately \$11,000.

In 1931 and 1932 the city saw the most disastrous fires on record when three tobacco warehouses went up in flames.

These included the Star Warehouse, McGowan and Cannon, and the old Co-operative warehouse. These blazes swelled the loss to the largest figure in years and tested the efficiency of the fire department as it has not been tested before.

In making up his annual report, Chief Gardner impressed upon the public the importance of continued precaution against the fire demon and urged every effort to further reduce the loss during the present year.

Abram Adams Passes Away; Burial Sunday

Abram Adams, 27, died yesterday morning at 5 o'clock in the local hospital after an illness of about eleven days.

Funeral services were conducted yesterday afternoon at the grave side at the family burying ground near Ham's Cross Roads at 4 o'clock by Rev. J. A. McIver, pastor of the Immanuel Baptist Church of Greenville.

He is survived by his widow, Mrs. Mamie Adams, and two children, Hilton and Mildred; father and mother, Mr. and Mrs. Norwood Adams; a brother, Charlie Adams, and two sisters, Mrs. Dorsie Carson and Miss Millie Mae Adams.

Mr. Adams moved to Greenville from the Red Banks community about two weeks ago, and was employed on the Civil Works Administration activities here.

Late News Flashes From Over World

Arrest License Violators.

Raleigh, Jan. 1.—(AP)—With Governor Ehringhaus holding formally to his order that motorists who venture on the highways without 1934 automobile tags be arrested, the big round-up was on today—the first of the year.

Reports to State Highway Patrol headquarters here indicated officers were strictly enforcing the law requiring display of the new plates today. More than 200 motorists had been arrested in Raleigh and the drive was reported to be under way with full force in other localities.

Police in Rocky Mount reported the arrest of 40 license violators before noon, all of whom were ordered to appear in city court Tuesday.

Cumberland county reported 29 arrests for use of old plates.

A highway patrolman in Elizabeth City said he had arrested 12 motorists for not having 1934 tags.

Within ten minutes after the beginning of enforcement of the law at 8 o'clock this morning State Highway Patrolman Wiley Crawford arrested six without tags at Bridgerton, across the river from New Bern.

Members of the Charlotte and Mecklenburg county police forces ignored violation of the law against use of 1933 tags.

SLAYERS OF WILKES GIRL ARE NABBED

High Point, N. C., Jan. 1.—(AP)—Blaine and Tait Norman, alleged slayers of Leota Childress, 18-year-old adopted daughter of a well-to-do Wilkes County family in Elkin, Saturday are under arrest and being held without bond at a place which police would not reveal, it was learned today.

The men, formerly residents of the community where the brutal slaying and robbery occurred, were arrested early today on information furnished by Sheriff W. B. Summers of Wilkes County.

Blaine Norman, 25, employee on a CWA project here, was arrested by local police about midnight, and on information furnished by unknown persons. His brother, about 20 years of age, was revealed as being at Lexington and was captured there. Davidson County officers were notified and the younger brother arrested soon after midnight by Sheriff Bodenhamer of Davidson. He was brought to Thomasville by the Davidson sheriff who was met there by local officers who brought him here.

Where the men are in jail is not being revealed by police here.

PUSH PLANS TO PROVIDE MORE WORK

Washington, D. C., Jan. 1.—(AP)—The NRA today set itself a task of regimenting before the end of January, if possible, the wages and hours of industries employing between 4,000,000 and 6,000,000 workers.

Taking stock as the year ended, the Recovery Administration estimated that 4,000,000 workers had been restored to gainful employment and that basic wages had been raised and the maximum hours reduced in industries employing between 18,000,000 and 20,000,000 people.

Then, said the NRA, the 132 Blue Eagle codes thus far created cover the biggest part of the most important industries while the hundreds of codes remaining to be proposed are centered on less important groups.

The several thousand Blue Eagles continued on display today despite the expiration yesterday of the original President's re-employment agreement under which some 3,000,000 employers won the right to fly the emblems.

Most of those blanketed by the original agreement had just been covered by mandatory codes. President Roosevelt has invited those not so covered to continue the agreement to May, but those desiring may take down the eagle and go back to unregulated wages and hours unless covered by mandatory codes.

CUPID SETS AN ALL TIME RECORD HERE

Love God Causes 744 Persons to March to The Wedding Altar Past Year

Restrained by hard times the last two years from following the dictates of the heart, Pitt county lovers went to the altar last year and piled up one of the greatest records in the memory of the oldest inhabitants.

The annual check of the marriage license book in the office of the register of deeds here this morning showed that a total of 744 licenses were issued in 1933 as compared with approximately 436 for the previous year. The figure was nearly double that of the former year and indicated the extent of Dan Cupid's activity in all sections of the county.

December, always the best month of the year for the issuance of licenses, shattered all previous records with the month's total reaching 168. Ten applications to wed received favorable action last Saturday, the final day of the year for obtaining permission to indulge in matrimonial felicity.

The general increase in marriages got underway last October when 88 persons obtained license to marry. November showed a pronounced increase with the issuance of 134 licenses, and it appeared as if the month might lead all others of the year until the middle of December when indications pointed to the shattering of all previous records for any single month.

The general increase in marriages was attributed by close observers of the wedding trend to improved business conditions, enabling hundreds of persons, hard hit previously by the depression, to bring of the heart to a rapid consummation.

Police Seeking Clue in Robbery of Blades Motor Company Safe Saturday

Officers today were seeking a robber or robbers who entered the Blades Motor Company here, Saturday night and robbed the safe of between \$50 and \$60.

Police said the robbers entered the building through a door with the aid of a crowbar. They had little trouble getting into the safe by reason of the fact that it was not locked. It was stated that employees forgot to throw the combination when they closed the door at the close of business Saturday. The robbery was not discovered until the office opened for business today.

Although State automobile license tags are sold in the same building, it was stated that Saturday's receipts from tag sales were deposited in the bank shortly after the office closed Saturday afternoon and were not affected by the robbery.

Police were investigating the robbery today in the hope of obtaining a clue concerning the identity of the robbers. It was believed they were members of a band who several nights ago blew open a safe at New Bern and escaped with a comparatively large sum of money.

RESIGNATION IS CAUSED BY BAD HEALTH

Acting Secretary Sworn in, in Presence of the President And Members of Family; Oath Administered in the Oval Room; Woodin In Tuscon, Arizona, Attempting to Regain Health

Washington, D. C., Jan. 1.—(AP)—President Roosevelt today accepted the resignation of William H. Woodin as Secretary of the Treasury and appointed Henry Morgenthau, Jr., Acting Secretary, in his place.

The resignation of Mr. Woodin on account of his physical condition was to become effective today. Morgenthau has been acting as Secretary for more than a month. He was sworn in as Secretary at the White House this morning. The oath was administered in the oval room in the presence of the President and members of the Roosevelt family. Mr. Morgenthau and Henry, Sr. The new Secretary is an intimate friend of the President. He is a resident of Dutchess County, New York, the home county of the President.

Morgenthau is a graduate of Cornell University, and for several years has operated a farm in Dutchess County and has run a farm paper.

He came to Washington with the President and served as the first governor of the Farm Credit Administration. When Mr. Woodin was forced last fall by ill health to go West for a complete rest, the President called on Mr. Morgenthau to take the difficult Treasury portfolio. Woodin is in Tuscon, Arizona.

LITTLE NOISE GREET 1934 IN GREENVILLE

City Experiences The Quietest Celebration Of Years Last Night

The arrival of infant 1934 was greeted with little noise in Greenville last night, and only the ringing of a single church bell and exploding firecrackers reminded the populace that the new year was being born.

The celebration was the quietest in years, and celebrants remained indoors to do what celebrating they had planned to get off.

Usually the new year is ushered in by a series of false fire alarms, but history failed to repeat last night and firemen spent probably the quietest and most tranquil new year night in memory of the oldest member of the company.

Police, who usually are kept busy taking care of over-boisterous celebrants, found themselves with little to do, and as a consequence, only a minor number of cases received consideration in mayor's court this morning.

Watch-night services were conducted by some of the churches, and these were largely attended. The services were of an impressive and inspirational nature, and provided a fitting setting for starting the infant new year on his way. A midnight show at State Theater was largely attended.

The celebration in the way of social gathering continued until the wee hours of the morning and firecrackers broke the stillness of the night in various parts of the city as those attending parties gave vent to their welcome in this manner.

The match will mark Vines' debut in the professional racket, and it should pack 'em in. If the spectacle lacks any element of box-office "draw," it doesn't come readily to mind. I'd hate to miss it—the 40-year-old master meeting and attempting to tame the lanky young man who has been compared most frequently to him for the past three years.

And, just because it is Tilden's troupe for whom Vines has contracted to play, don't ever suspect that Bill might feel inclined to do a little "business," to make the opening match look good with an eye to future receipts on the road. Bill just isn't built that way. If he is capable of meeting Vines in straight sets you can wager the old home-stead, mortgages and all, that he will do exactly that.

It's An Obsession

As a matter of fact, I've often suspected that Tilden retained a little too much of the old amateur spirit for his own welfare as a tennis professional. Somehow, when Bill gets a tennis racket in his hand he seems to become possessed with the idea of flicking the socks off some one. I fear he wouldn't last five minutes in, say, the wrestling game. He wouldn't be understood.

I remember his hillybored first pro match against Vincent Richards at the Garden a couple of winters ago. Vinnie had taken the plunge some years before, and in the meantime hadn't hesitated to express the opinion that he or a half-dozen brother money players could make short work of the best of the amateurs, Tilden included.

Big Bill seethed, and by the time he had decided to turn pro and terminate his long-standing debate with the U. S. L. T. A., he was completely fed up with Richards' remarks. When, on the night I mention, he finally got the slightly bulbous Vinnie across the net from him, he was in no mood to worry about dollars and cents.

As you probably recall, he gave the former "boy wonder" such a thorough shelling that there was never again even a little-bitty question about it. They went right on playing each other, here and there, but the customers were under no illusions when they bought their tickets.

Job On His Hands

Whether Bill still has it in him to beat a youngster as good as Vines, I wouldn't know. Experts who watched him play in Europe last summer expressed the opinion that, in a single three or five-set match, he could hold his own or defeat any player in the world.

There were a lot of players who could beat Vines during the last campaign. Even Bryan Grant, Jr., did it. But the Vines who meets Tilden—free of financial worry and the strain of a Davis Cup campaign—is likely to be more like the Vines who battered them all down in 1931 and 1932. In that case, our old friend Bill has a real job on his hands.

A negro, Sam Jones, 55, who lived on a nearby farm, was taken into custody but was released after questioning. Officers said they were seeking another negro.

Examining physicians said the woman had not been attacked.

Brumby told police that on returning home he discovered the back door locked and believed Mrs. Brumby was at one of their neighbors. He waited on the back steps for her.
