CHARGE EFFORT TO ESTABLISH FRENCH DIRECTORY

Japan Charges U. S. Fliers With Spying On Her Islands

STATEMENT PUBLISHED BY ADMIRAL

Head of the Combined Fleet of the Nation Makes Charges In Interview to Magazine; Refers to Lindbergh's Recent Flight Over the Pacific and Bromley's Abortive Flight Effort

Tokyo, Japan, Jan. 12.—(AP)—Japan must prepare, and is preparing, to defend herself against what appears to be America's policy of hostility in circling Japan by every means possible, said a public statement attributed today to Vice-Admiral Nombusa Suetetsu, commander of the navy's combined fleet. The statement was made in a published interview in the widely circulated monthly magazine, Gendai. Instances of encroachment, the interview stated, were Col. Charles Lindbergh's flight along the Kuril Islands in the summer of 1931, and "Lord Bromley's abortive attempt to fly the Pacific in 1930. "I may be mistaken, but I think it is possible they were spying in those islands," the admiral was quoted as saying. "Some time ago an American hoped to go from Japan on an alleged trans-Pacific flight and turned back after flying, we don't know where. I think the failure was purposeful." (This effort obviously was the Bromley attempt September 14, 1930.)

DR. McGEACHY MADE HEAD OF SAFETY BODY

Health Director Selected to Form Committee on Highway Safety Here

Dr. R. S. McGeachy, director of the Pitt County Department of Health, was notified today by C. W. Roberts, president of the Carolina Motor Club, that he had been selected to head a committee on "Highway Safety" in this county as a means of reducing the heavy toll of life and property on State highways. A State committee, headed by Senator Allen H. Owen, has been set up for the same purpose. Mr. Roberts said, and it will work in conjunction with committees to be created in every county of the state. Expenses incurred in such work will be borne by the Carolina Motor Club. Dr. McGeachy said he would send in his acceptance of the appointment today and planned to immediately begin selecting his committee for service in this county. "As long as we are killing more than 33,000 a year and injuring more than 100,000 on our national highway system, and as long as our own State is greater than the national average, we must use every possible means and methods to fight this great evil," a statement accompanying Mr. Roberts letter said. Belief was expressed that committees on highway safety can and will contribute much towards bringing about methods to remedy the existing conditions in the various communities of the State. The following activities were suggested for the committee: "To see that future street and highway building considers the item of safety. "Work with local authorities, re-vamping local traffic plans, with the view of simplifying them and making practical enforcement. "See that signal lights and signs are erected only after careful study. "To take it upon themselves to investigate local traffic accidents, determining the cause, and where possible, take steps to correct the cause. "The maintenance of a spot map by this volunteer committee, indicating location of our accidents, will be very helpful in determining methods to reduce them. "Taking the initiative to see that shrubbery and growths at dangerous curves in local communities are trimmed or moved, to give greater vision, and thereby reduce the hazard. "To co-operate in handling the local activities in connection with a State-wide highway accident prevention week in the spring of 1934 together with supervising a local highway safety exhibition. "Possibly develops a local school of school bus drivers, as well as passenger car drivers, especially for the new drivers. "To co-operate with the local committee on uniform laws in removing ordinances that are impractical of enforcement and adopting others conforming with uniform regulation. "To work in co-operation with the State committee in bringing about the enactment of a State drivers' law, not for revenue purposes, but for the purpose of controlling the driver."

Late News Flashes From Over World

Names Utilities Commissioners. Raleigh, Jan. 12.—(AP)—Governor E. B. Ewing today announced the appointment of Dr. William Louis Poteat, president-emeritus of Wake Forest College, and Professor Frank William Hunt of the University of North Carolina, as associate state utilities commissioners. The selection of the two educators came as a complete surprise in state capital circles here. All expectations had centered around men whose names are linked with politics. Associate commissioners are provided for by the 1933 utilities law to sit in hearing with Stanley Winborne, state commissioner, in cases where the amount involved is more than \$3,000, or when the commissioner desires them to sit with him. They get \$25 a day, and actual expenses not to exceed \$900 each year. (Continued on page six)

CITY PUSHES PLANS FOR BIG BALL JAN. 30

Preparations for the Roosevelt Ball to be given in the Campus building at East Carolina Teachers College on the night of January 30 were being pushed forward rapidly here today and the occasion promises to be one of the most brilliant in the history of the city. The ball is being given in honor of the President's birthday. Similar affairs are being held in various cities of the nation. The object is to create a fund for the Warm Springs Foundation, an institution started by Mr. Roosevelt to minister to the sufferings of those beset by infantile paralysis. Committees to take care of every phase of the ball were named here several days ago, and these were busy today making arrangements to care for a tremendous crowd of local people and those from surrounding towns that are not planning dances of the kind. Mayor Finamore several days ago sent out an appeal to the public calling for support of the ball, making it possible for the city to do its part by the cause which is close to the heart of the President. In order to take care of the big crowd expected to attend, a committee obtained permission to use the Campus building at the college, one of the most ideal places in this section for the holding of such a brilliant affair. There will be plenty of room for dancers and the hundreds of spectators certain to be present to see the community attempt to celebrate the President's birthday anniversary. RECOMMEND REJECTION OF LOWER RATES

Washington, D. C., Jan. 12.—(AP)—Two Interstate Commerce Commissioners today recommended that the Commission reject application of the American Highway Freight Association for an order forbidding the Southeastern Express Company to reduce its rates on less than carload lots. The Southeastern Express which operates over the lines of the Southern Railway System and the Chicago and Ohio took steps a year ago to combat more truck competition. For several years the express company had been losing business to trucks, and it was decided to experiment with lower rates. This resulted in a considerable increase in business. The American Highway Association, an organization of motor truck owners and operators, complained that the express company's action was unlawful.

TROOPS READY TO ADVANCE ON PARIS AT ONCE

Thousands of Soldiers Held in Readiness to Quell Disorders In Captial City; Chamber of Deputies Adjourned Suddenly In Midst of Pandemonium; Deputies Stage Uproar Over Developments

Paris, Jan. 12.—(AP)—Premier Camille Chautemps warned the nation today that the Royalist riot over the Stavisky scandal held the threat of a coup d'etat to establish a directory. "Thousands of troops were ready to march on Paris if necessary to stamp out the disorders which have occurred in a protest against alleged complicity by government officials in the Bayonne Pawnshop collapse which cost the French public more than \$40,000,000. The president of the Chamber of Deputies adjourned the body suddenly this afternoon in the midst of pandemonium which broke out when Deputy Jan Yvanogary charged that "the police assassinated Sarge Stavisky," founder of the bank and hasten the crash to protect those higher up. Premier Chautemps jumped to his feet, waved his arms and protested that Stavisky killed himself when secret service men surrounded him Monday and pledged he would make an investigation of the affair. The chamber previous had been suspended because of the noise in the hall. When adjournment came hundreds of deputies continued to yell, slam their desk tops and rush about. While the disorders continued in the Chamber of Deputies the generalissimo of Paris made an effort to see to it that the bitter Royalists whom they had battled for hours on Tuesday and Thursday were kept away from the chamber.

JONES COUNTY BENEFITS THROUGH CWA PROJECTS

Trenton, N. C., Jan. 12.—The citizens of Jones County are being helped materially by the twenty-two projects on which approximately 225 men are at work, and business has been revived noticeably for the past few weeks. According to a statement from P. B. Pollock, disbursing officer for the county, \$6,613.13 was disbursed in the county last week. It is expected that the disbursements will reach \$3,000 or more weekly during the next few weeks.

LEAF PRICES MOVE UPWARD

Season Sales On the Local Market Drawing Near the 69,000 000 Mark.

The price situation continued favorable on the Greenville tobacco market yesterday with better grades selling as high as 45 cents a pound. Improvement was also noted in medium grades, and this situation was reported as still in evidence today. The official report of K. W. Cobb, supervisor of sales, issued yesterday afternoon, showed the market sold 179,302 pounds of tobacco for \$27,046.21, at an average of \$15.08. The average price was seven cents above the previous day. The advance was attributed to additional buying orders received by the companies here. Yesterday's sales showed the season's poundage up to 68,905,154, for which growers receive \$11,552,741.66. Although no definite date for the closing of the local market has been decided upon, it is believed by many this would take place around the first of February. Farmers were still being urged to re-work their tobacco before marketing and in that way be able to attract more favorable prices for their offerings.

SCORES LOST IN BIG FLOOD

Seventy-eight Lives Reported Claimed By Flood Water In Brazil-Argentina

Rio De Janeiro, Jan. 12.—(AP)—Seventy-eight persons were reported today to have drowned in floods which followed heavy rainstorms in Brazil and Argentina. Eight were known to have drowned in Rio De Janeiro. Unconfirmed reports from Mendoza, Argentina, said seventy lost their lives and that widespread property damage was suffered in the mountain regions. In British Guiana five days of rain caused damage estimated at \$1,000,000.

SEEK DREDGES ON TWO CREEKS

Committee Will Ask Thorough Cleaning of Swift and Grindle Creeks in Pitt

A committee was to go to Raleigh this afternoon to ask the Civil Works Administration for three dredges to be used in mosquito control work on Swift Creek and Grindle Creek. Dr. R. S. McGeachy, who is directing this phase of work, will head the committee. He said the dredges were found necessary in view of the fact that the streams were so cluttered up with rubbish that it would be a matter of impossibility to properly clean them by hand. Dr. McGeachy said it would take three dredges at least a year to complete the work of dredging the two streams. That section of Swift Creek needing dredging is about 30 miles long with three miles of Grindle Creek needing such work. Grindle Creek was dredged about three years ago. Dr. McGeachy said, but there is a three and a half mile (Continued on Page Six)

RESUME HEARING IN BIG MEADOWS SUIT

New Bern, Jan. 12.—(AP)—The hearing in the Meadows company suit, involving \$1,500,000, was resumed here Wednesday morning at the Gaston hotel, after a Christmas recess. The evidence is voluminous and the hearing will probably last into March. E. H. Meadows has been the only main witness to testify so far at the lengthy hearing that opened in November, and it is said that his testimony has not yet been half finished. After the plaintiffs present their side, the defense will have lengthy evidence. J. O. Carr, Wilmington attorney, is referee in the matter. Options have been secured on 3,970 acres surrounding King's Mountain battlefield in South Carolina for inclusion in the National Park the government proposes to establish there.

PITT DOCTORS HEAR REPORTS

Case Reports Mark Monthly Meeting of Organization Here Last Night

The monthly meeting of the Pitt County Medical Society was held at the Episcopal parish house last night with a delightful supper being served by ladies of the church. Dr. T. G. Baslight, of Stokes, who was elected president of the organization at a former meeting presided, and other officers named at the same time also had charge of their new duties. Dr. K. B. Pace, of Greenville, and Dr. Bruce Bestley, of Fountain, were hosts to the physicians. The evening's program was confined largely to case reports, and the doctors heard the greatest number of them in any single meeting in the memory of the oldest member. Usually there is a paucity of such reports, or a disinclination on the part of some of the medicals to talk about cases under their observation, but last night they cut loose, and when they had finished, the various members had many medical theories to take back home for digestion, assimilation, absorption, or something. The making reports were: Drs. Tom Watson, J. L. Winstead, Bruce Bestley, G. G. Dixon, Jenness Morrill, Joe Smith, K. B. Pace, H. M. Bonner, W. I. Wooten, and R. S. McGeachy. NEW WORK IS GIVEN 'OKAY'

Five Projects Providing For \$22,553, Approved For Pitt County

Five new projects, carrying an appropriation of \$22,553, have been approved for Pitt county by the Civil Works Administration, it was made known today at the office of K. T. Futrell, CWA administrator in this county. The most important of the improvement programs call for renovation of county negro schools at a cost of \$10,421. The second largest project calls for beautification, paving and drainage in the town of Fountain at a cost of \$6,585. The others provide for drainage of Mt. Pleasant canal at a cost of \$1,200; engineers for drainage, \$2,148, and rural library work for women, \$1,200. Mr. Futrell said a batch of new projects were expected to be approved probably today or the first of next week and that these, like the rest, would be pushed to completion as rapidly as possible. He said the payroll for work in the county would amount to \$14,000 this week. Pay envelopes will be distributed to workers tomorrow and the money will be spent for things the former unemployed people have been in need of for a long time.

PAPER SEEKS RESIGNATION OF OFFICIALS

Raleigh Times Asks Two City Commissioners to Step Down At Once

Raleigh, N. C., Jan. 12.—(AP)—The Raleigh Times today demanded the resignation of City Commissioners J. H. Brown and Ed. M. Barton. In a front page editorial the paper said: "There is one hope, and one hope only, that the city of Raleigh now in default of its civic obligations can weather the state of bankruptcy growing out of the default upon its debt due to the collapse of the credit of the municipality. "That hope lies in the change of the city administration through the elimination of J. H. Brown, Commissioner of Public Safety, and Ed. M. Barton, Commissioner of Public Works.

YOUTH HELD ON ARSON CHARGE

Paul McKeel Charged With Starting Fire in Basement of Dixie Warehouse

Paul McKeel, 19-year-old Greenville young man, was held in the city jail today on a charge of arson growing out of his alleged attempt to fire the Dixie Warehouse in the southern part of the city. McKeel was taken into custody by officers Wednesday morning after employees of the warehouse told police they caught him at a small fire which had been started in the rear of the basement. McKeel vigorously denied he had anything to do with starting the blaze. He told officers the fire was burning when he went into the basement and that he was merely standing there watching it when warehouse employees saw him. The blaze was quickly extinguished without any damage being done. The young man was given preliminary hearing yesterday morning and bound over to the next sitting of Superior Court. Although no bond was at first allowed it was said today he would be permitted freedom by bail should he be able to provide it. (Chicago, Ill. Jan. 12.—(AP)—Walter Zilkowski, who a coroner's jury yesterday recommended be held for the murder of his wife, committed suicide in his county jail cell today by hanging.

SPONAR TALKS ON MARRIAGE

There were few who had not heard of Graham, F. A. Graham. The newspapers had made much of his exploits when he had returned from Venezuela a year or two after

the Langton mystery. F. A. Force of Arms Graham they called him.

No white man had penetrated so far, or so fearfully for that matter, the upper reaches of the Orinoco. He found Cadwallader's party, or what had been left of it, and returned as victoriously efficient as he went. The dramatic inferences of his feat had been lost upon Graham.

He had guided that party of scientists into the country to stay until the rains forced them out. All of them had been capable men and Graham had left them fully equipped to cope with their few months sojourn in the jungle and to come out as soon as they pleased. But nearly a year had passed when relatives and sponsors, frantic for

Graham grinned. "Sure I met with resistance as you call it. I, well. . . . I handled it."

However the newspapermen discovered that Graham could be articulate when he wanted to be; it was all a matter of tempting him into that mood. He'd been a war-time ace, after which he had flown Uncle Sam's mail for a time. He was known in countries other than the United States.

He was tall, good-looking—perhaps even handsome if one could overlook certain grim lines about his mouth; at any rate his blue eyes, wide shoulders and lean jaws photographed well. Swashbuckling descriptions of him gave romance to staid halftones. He had at the equipment for good news copy.

GERMAN COEDS GETS NEW COURSE OF NAZI STUDIES

By WALTER BROCKMANN. Berlin.—(AP)—The new university woman in Hitler's "third reich" is a kind of feminine storm-trooper. "Kitchen service" and family care are equivalents assigned to her, of field service and "first aid" train-

ing for the young man storm-trooper. Compulsory service in a woman's labor camp is suggested as a prerequisite for university study by Gisela Bretschneider, Nazi head of the woman's branch of the German student association.

Extols Physical Work

Discussing the Nazi educational goal for women in an interview with the Deutsche Allgemeine Zeitung, she said: "This is the best means of determining whether a woman is fit to enter college. Physical labor in a social community is the best prepara-

ration for studies of spirit, boy and soul."

Charter development is wanted for women, said Fraeulein Bretschneider, adding that athletics, family care, and kitchen service are essentials of the future German college woman's training.

"Not a one-sided aesthetic goal must dominate a woman's studies, but the absolute desire to learn a profession," said Fraeulein Bretschneider. "As for fashion studies—those times are past!"

"Creation of womanly and national values is the new goal.

Athletics and Folk Lore "In working towards it we ask ourselves: 'How best can a woman's study serve womanhood and the German nation?'"

Two athletics classes a week, Nazi charity work, family help, community promotion," the letter including hours devoted to national lore, national poetry, national folk-dances and singing, are compulsory for women students, Fraeulein Bretschneider said.

Leaders Hail Revival in Many Aried Lines

(By The Associated Press) Swiftly moving economic changes and a realignment of business factors in the last twelve months turn the United States into a complex picture of recovery. Viewed by sections, the scene presents an overlapping design punctuated by upward trends and downward influences affected by other conditions.

The automobile industry in the Detroit area has reached the stage where leaders are declaring "1933 was the industry's recovery year."

But while Michigan has the major part of the automobile industry, employment in assembly plants and allied industries in other parts of the country is affected favorably.

Cotton in Uplift The South is looking to cotton growing, the naval stores industry and pine lumber trade as leaders in the business upturn.

E. F. Creekmore, general manager of the American Cotton Cooperative Association, says the higher price level, increased yield per acre, and government subsidies of about \$10,000,000 "have caused a materially improved financial condition among the cotton producers."

J. E. Lockwood, naval stores consultant of Savannah, Ga., says: "Naval stores conditions in the United States have materially improved. . . . and the outlook is favorable for continued gradual improvement. . . ."

A summary of business conditions by the Federal Reserve Bank of Atlanta said the Southern Pine Association reports orders received by lumber mills over a given period were 29 per cent greater than production. Department stores in the district reported fall sales increasing.

Mid-West Picture Clouded The Mid-Western picture is clouded. Reports pertaining to it indicate there is no section where business recovery definitely has become apparent.

Government wheat and corn-hog payments have been made over a large area, but these funds are reported going largely to pay off back debts of farmers and into retail channels.

Three industries have been a measure of recovery in the Rocky Mountain section. They are mining, including gold and silver, the sugar beet industry, and the sheep and wool industry.

Gold mining, which affects a relatively small number of persons, has boomed since the government started buying gold above the world price.

The sugar beet trade has had a good year, largely due to increase yields rather than better prices. Wool prices have virtually trebled, but meat prices still are low.

Lumber Gains in Northwest Lumber leads the way in the recovery movement in the Pacific Northwest with many industries reporting advances.

E. Pat Kelly, director of the Washington State Department of Labor and Industries, said an increase of 81 per cent in the pay-roll volume of the State's basic industries was reported for the first ten months of 1932 in addition to Federal compensation for civil works projects and the like.

Col. W. B. Greeley, of Seattle, secretary-manager of the West Coast Lumbermen's Association, said: "Generally speaking, conditions in several hundred Washington and Oregon lumber and logging communities are much better with respect to employment and income to the public than they were in the winter of 1932, and the improvement may be attributed almost entirely to the labor provisions of the NRA lumber code."

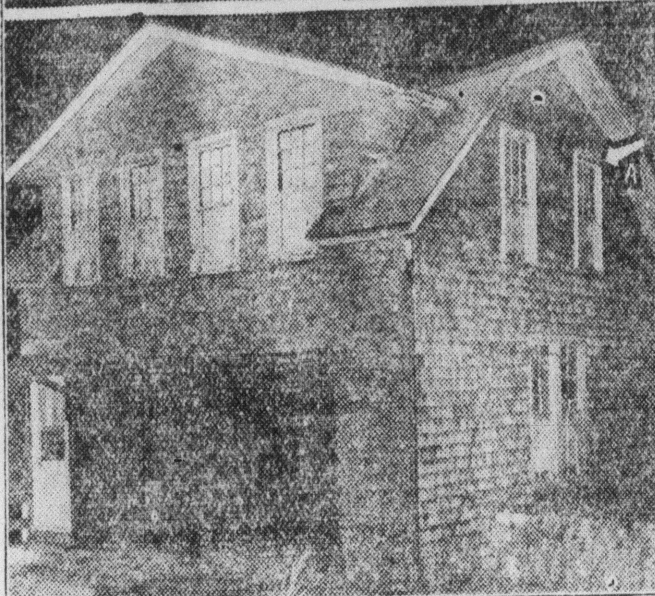
More Money For Less Work To sum up conditions, Colonel Greeley said, more men are getting more money for less work in the lumber industry, and conditions are better, but costs have increased, and lumbermen hope for a larger volume of business, as consumption of lumber has been lagging.

The most pronounced improvement in the West is reported by the research department of the California State Chamber of Commerce to be in Los Angeles, San Diego, Oakland, San Francisco, and Sacramento.

Manufacturing has continued upward since July in many cities, railroad officials report a considerable increase in tourist passenger travel, and crop estimates for California by the agricultural extension service of the University of California show dollar improvement in almost every case.

The WORLD of STAMPS

By JOHN SELBY

New York—January and the new year both start out with a horde of novels, somewhat as if the book stream had been damped by the holidays, and suddenly released.

There is the "important" novel—which distinction might be voted "A Nest of Simple Folk." It is by Sean O'Faolain, it is about Ireland and Irish people, it is vigorous and full of deft characterization—though some readers might find it just a little bit dull.

There is the most amusing novel, perhaps for most readers Anne Parrish's "Level." Miss Parrish's book is amusing in the sense of fun, but in the aptness of its approach and characterization.

It is a "Grand Hotel" sort of novel, in which the "hotel" is a cruising boat. But although the point of it seems to be that one may go around the world and still not escape the things one went to escape, there is no futility in it, nor is there dullness.

And there is the monthly fare, this one a burlesque of certain French characteristics, by Hillel Bernstein, called "L'Affaire Jones."

Mr. Bernstein has, in effect, stretched a short story out to novel length. He has his chief character, a man named Jones who has gone to Paris for a purpose no more sedulous than to write a cook book, suddenly accused of stealing a coat.

And then he permits the French to accuse Mr. Jones of being a spy, and from that the book goes off into a froth of charges and counter-charges, each more absurd than the preceding.

Needless to say, Jones did not steal the coat. But his innocence in that small matter is quite lost sight of; the honor of La Belle France has been impugned, and Jones must pay.

The Serious Novel

Vardis Fisher has written the most serious novel of the week—"Passions Spin the Plot." The title sounds rather like literature for subway reading, but it gives an entirely

PRICE SEES ROOSEVELT TALK AS SIGN HE'LL STAY CLEAR OF CONGRESSIONAL RACES

By BRYON PRICE (Chief of Bureau, The Associated Press, Washington)

Politicians of both parties think they have found, hidden in the soft phrases of President Roosevelt's address to Congress, a pretty clear sign that he means to take no direct part in the Democratic Congressional campaign of 1934.

It is true he said nothing whatever about that campaign, yet when everything is considered, the deduction that he has made his decision does not appear so far-fetched as a first glance might indicate.

Mr. Roosevelt did appeal directly, and repeated, in his speech, for non-partisan support. In the well understood language of politics, such an appeal usually implies a promise. And no one denies that the President knows his political vocabulary.

Furthermore, no one supposes he has forgotten what happened to President Wilson in 1918 when, after many similar requests for non-partisan co-operation, he issued a Democratic Congress.

Wilson's action is rated one of the prize blunders of recent political history, and is credited by many with actually electing a Republican Congress because of the resentment it aroused.

Dissecting the Address Now that Washington has had time to study the Roosevelt address under the microscope, it has found also that it was politically revealing in several other ways.

The opening day of Congress saw the Republican organization hesitant whether to go along or boldly attack. After much private consultation, it was decided to wait and see exactly what program the President would offer. The address itself

took the wind out of that plan, for it offered no specific plan at all, and contained little that anyone could attack.

When the later specific recommendations began to come in, starting with the budget, the attacks began. But they were not so much against the Roosevelt program as a whole, as against isolated portions of it.

Clearly, Mr. Roosevelt acted with a delicate method. By presenting his program piecemeal he has minimized the likelihood that the early weeks of the session will develop anything like a concerted, unified assault on the whole group of new projects he has in mind.

In large degree he has kept to himself the privilege of dictating how and when and on what terms the coming controversy—whatever it may amount to—shall be waged.

All In One Charge On Capitol Hill it was accounted an evidence of his confidence that he chose to take at once the full shock of the budget revelations—conceded by almost everyone to be one of the most severe strains the administration will have to withstand during the session.

Some administration officials would have preferred to conceal some of the expected deficit, sending in only a part of the estimates at first, and then asking for additional emergency appropriations later on.

There was plenty of precedent for that, but the White House rejected the proposal flatly. Mr. Roosevelt had been told—that he was at the peak of his political power, and his closest advisers felt it was the proper moment to get the worst of his troubles out into the open.

It will take weeks to tell whether he decided wisely.

New York Cotton

New York, Jan. 12.—(AP)—Cotton futures opened firm, two to seven points lower in response to disappointing Liverpool cables and under-realizing and foreign selling.

March dropped off to 10.78 and May to 10.95, or about 10 to 15 points lower on more active positions.

Prices steadied a few points from the lowest on the demand. Further marked liquidation was absorbed by the trade against selling of later months, and the market held steady in the morning. At midday the market was steady, one point lower to two points higher.

Signs Liquor Tax Bill. Washington, Jan. 12.—(AP)—President Roosevelt announced today he had signed the \$500,000,000 liquor tax bill before midnight, thus making the major provision of the measure applicable on today's sales.

The measure raised the levy on whiskey from \$1.10 to \$2.00 a gallon. This was the first bill passed this session and Mr. Roosevelt lost no time in making it a law.

The bill is expected by treasury and congressional leaders to provide for \$400,000,000 to more than \$600,000,000 a year.

Announces New Appointments. Washington, Jan. 12.—(AP)—President Roosevelt today nominated General Blanton Winship, former judge advocate general of the army, as governor of Porto Rico, succeeding Robert Gore of Florida, who resigned this morning.

The President also appointed Wright Matthews of Texas, to be assistant commissioner of internal revenue.

A new weather man for the nation was likewise selected, the President naming Willis R. Gregg as chief of the weather bureau to succeed Dr. Charles F. Marvin, retired.

General Winship is a veteran in insular affairs, having served in Cuba and the Philippines as advisor to the ranking American officers in these islands.

He was also military aide to President Coolidge and recently retired as judge advocate general. He fore, whose administration was a native of Georgia.

Describes Glaring Bank Loans . . . Washington, D. C., Jan. 12.—(AP)—A loan of more than \$100,000 from Frank McKay, former State Treasurer of Michigan, was described to Senate investigators today by Chas. A. Johnson Bill Passes Senate. Washington, Jan. 12.—(AP)—The Senate today passed unanimously the Johnson bill to prohibit financial transactions, private or public, with any foreign government in default on its obligations to the United States.

The action followed closely a reversal of the Senate position in approving an amendment to the liquor tax bill placing a heavy excise tax on liquors from nations behind in debts to this country.

The bill was introduced last session by Senator Johnson, Republican, California, fixing a fine of \$10,000 or imprisonment of five years for anyone purchasing or selling bonds or securities or other obligations of any foreign government issued hereafter or to make any loans to such foreign governments or subdivision thereof while such government is in default of payment of debts either in whole or part to the United States.

Johnson Bill Passes Senate. Washington, Jan. 12.—(AP)—The Senate today passed unanimously the Johnson bill to prohibit financial transactions, private or public, with any foreign government in default on its obligations to the United States.

The action followed closely a reversal of the Senate position in approving an amendment to the liquor tax bill placing a heavy excise tax on liquors from nations behind in debts to this country.

The bill was introduced last session by Senator Johnson, Republican, California, fixing a fine of \$10,000 or imprisonment of five years for anyone purchasing or selling bonds or securities or other obligations of any foreign government issued hereafter or to make any loans to such foreign governments or subdivision thereof while such government is in default of payment of debts either in whole or part to the United States.
