SEEK TAX ON NON-SIGNERS IN LEAF DRIVE

Farm Board Urges Congressman to Provide Legislation For Signers Protection

Federal legislation seeking taxation of non-signers of tobacco reduction contracts at warehouses is being pressed by agricultural leaders of this county as a means of protecting those who have agreed to take part in the government campaign to cut next year's crop and relieve the glutted condition of the American market, it became known today.

E. F. Arnold, director of the Department of Agriculture of this county, made public a telegram which J. E. Winslow, chairman of the Pitt County Department of Agriculture, recently dispatched to Congressman Lindsay Warren at Washington, urging that the Congressman take immediate action looking to the question of such legislation.

The telegram said that 2,500 tobacco growers who signed the tobacco reduction contracts urged the government to start action for acreage control through taxation at tobacco warehouses on all non-signers. It stated that growers would be sorely disappointed if such action was not taken.

In explanation of the message, Mr. Arnold said, the request applied to new farmers planting after the tobacco campaign has closed. It also would affect farmers whose production is above what they signed for.

The farm director said practically all growers of the county had signed the government contract, but that acquisition of farm lands by interests which did not sign would sorely affect the reduction campaign if something is not done to improve the situation.

Although no reply has yet been received from Congressman Warren, this was expected in the next few years. The board members felt that the Congressman fully appreciated the situation and would take immediate steps to remedy same.

CLUBMEN HERE ATTEND MEET AT NEW BERN

Highway Safety Is Stressed at Inter-City Kiwanis Meeting Last Night.

Several members of the Kiwanis Club went to New Bern last night where they attended the Inter-City rally given under auspices of the New Bern organization. Approximately ten clubs of this district were represented.

Men high in the life of the organization, in addition to representatives of the State Highway Department and Rotary Club, were present and participated in a program confined exclusively to "highway safety."

Dr. R. S. McGeachy, president of the Greenville Kiwanis Club, and one of the leaders in the highway safety program, presented a motion that the meeting go on record to ask the Governor of North Carolina to issue a proclamation setting aside an entire week for observance of highway safety. No specific date was set for the observance.

Dr. McGeachy incorporated in his motion provisions that at least five minutes be set aside in all schools of the State for impressing upon the necessity of careful operation of automobiles at all times.

The resolutions came after one speaker had stated the death toll in this State was higher than any State in the Union in spite of the splendid highway patrol system doing everything in its power to reduce the total of life from accidents.

COTTON DRIVE NEARS CLOSE

Fifteen Hundred Contracts Expected to be In the Office Here By Tomorrow

The cotton production campaign which has been in progress in the county the last several weeks will be brought to a close tomorrow night, E. F. Arnold, director of the Pitt County Farm Demonstration, stated today.

Farmers who have not signed the contract calling for acreage reduction during the next planting season were urged to do so at once and be in position to take advantage of the splendid government benefits to be derived from such action.

Mr. Arnold said 1,200 contracts had been received at his office so far, but he expected 1,500 would be on hand by the end of the campaign.

Committeemen were at their places in various parts of the county assisting growers in putting their signatures on the dotted line and they were expected to be quite busy today helping those who put off signing until the last minutes.

Mr. Arnold when the campaign comes to a close and urged committeemen to do everything in their power to bring the recalcitrant ones into the fold.

Battle Side By Side With Men In Bloody Area

ONE THOUSAND BELIEVED DEAD IN CONFLICT

Women Help Carry Munitions and Reload Rifles as Husbands and Brothers Battle with Government Forces: State of Civil Warfare Continues Serious Throughout Nation; Dollfuss Declares Socialist Fight Mad.

Vienna, Feb. 14.—(AP)—Socialist women fought grimly through the night, beside their men against an overwhelming wave of government troops. It was estimated that at least one thousand have been killed.

The women fought like old soldiers of the American prairies. The government commander said they helped carry munitions and reload rifles of their embattled husbands, and brothers who fought from the window of houses. Their resistance was smashed by artillery.

There were plenty of innocent non-combatants, said one officer, "who had no choice but go through the shelling."

The state of civil war between the rebels and the government continued serious throughout the nation, but in outlying regions the government rapidly appeared to be gaining the upper hand.

Chancellor Engelbert Dollfuss determined to retain control of the government, declared the Socialist fight was "madness."

"One may say already," said Dollfuss, "that this undertaking has entirely failed and that the position of the federal government is stronger than ever."

At St.urz one of the bloodiest spots in the rebellion the government has control. The government carried out its threat of death sentences against the rebels when a court-martial sentence a 43-year-old shoe-maker to hang.

The government summoning all able-bodied man-power to its side poured reserve troops into the capital.

Elsewhere the national situation was believed to be coming under government control. However, spokesmen for both the government and the Socialist confidently predicted victory.

Rome, Italy, in the opinion of well-informed persons, will consider intervention in Austria's civil war—as suggested in Paris—only as a last resort. Many Italians fear the Nazis may seize upon the Austria crisis as an opportune time to drive political power. It is this factor which causes chief concern.

There was no official comment on the unofficial proposal in Paris by Henry Berenger, Senate Foreign Affairs Committee chairman that Austrian independence be protected by France, Britain and Italy.

WINGATE HALL RAZED BY FIRE

Historic Wake Forest College Building Is Wrecked by Flames Early Today.

Wake Forest, Feb. 14.—(AP)—Fire early this morning completely gutted historic Wingate Hall, second building to be erected on the campus at Wake Forest College, some four score years ago.

The blaze was the second disastrous conflagration here in a year, an early morning fire last winter having destroyed the college's first building, Waite Hall.

Dr. Thurman Kitchin, president, said Wingate Hall was an absolute total loss. "Nothing remained but the bases of the walls," the president said after a survey of the damage.

The historic structure housed the chapel, physics, psychology and Greek departments and every student who has attended the college since it was built had attended meetings there.

COTTON USE SHOWS GAIN

Consumption in U. S. Over the Previous Month Reflects An Improvement.

Washington, D. C., Feb. 14.—(AP)—Cotton consumed during January was reported today by the Census Bureau to have totaled 508,034 bales of lint and 57,769 bales of linters.

Imports for January totalled 739,352 bales of lint and 18,117 of linters compared with 820,099 and 17,655 for December and 793,676 and 12,944 for January last year.

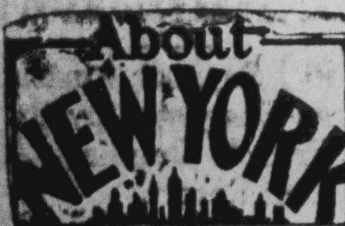

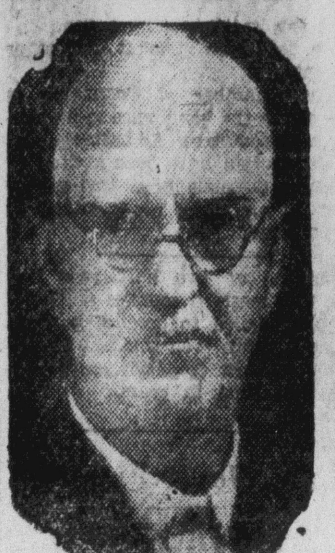
Anti-Rat Campaign Organized

Don't Stop Farm Research - Wallace

By F. B. COLTON

Washington, D. C.—(AP)—Science may make farms of the future twice as productive as now, but this will not conflict with efforts to end agricultural over-production, in the opinion of the Secretary of Agriculture Henry A. Wallace.

Continuing scientific research to make human labor more productive and increase yields of the best land is the only sound course to pursue, for any other will lead to "barbarism and chaos," the Secretary said.

"Larger yield from smaller fields" is his answer to the question of how the government with one hand encourage scientists to keep on seeking new aids to the growing of larger crop per acre and with the other can carry out a program of crop reduction, restriction of acreage and the rearing of marginal lands out of production.

Sees No Incongruity

The Secretary himself a scientist, has gained fame for his breeding experiments leading to improved types of corn. He finds nothing incongruous in such a program.

It is true, he said, that a policy of encouraging increase of production indefinitely without supplementary planning to insure consumption would lead to disaster. As long as the government failed to face the results of increased productivity it was almost "criminally negligent." But it is perfectly sound, he believed.

leaves, to strive to make human labor increasingly more productive. In the public eye the emphasis of the new deal seems to be upon economic matters," said the Secretary. "but it is important as we perfect better social machinery not to forget that so far we have merely scratched the surface of scientific understanding.

Equable Distribution "Science can readily enable human labor to be twice as productive, but it is important the increasing productivity resulting from the application of science be equally distributed so there is a decent adjustment between productive power and consumptive power.

"The ability of science to increase productivity, however, is no reason why we should not strive for continuous understanding and application of natural laws."

To turn back or stop the wheel of time by ceasing research, the secretary went on, would be nothing short of a calamity. On the contrary, there is every incentive for continuing research, for the lowest possible costs of production, he believes, can be attained best by tak-

ing the poor lands out of production or crops and putting the best scientific effort into improving high grade land and livestock.

Industry An Example Continuing scientific efforts to improve agriculture also are justified by the example of industry, the Secretary said.

Progress of industry is made possible largely by the research carried on in private laboratories and plants, aiming at better products.

In agriculture, however, there is little or no possibility for private research on a large scale, and therefore new knowledge must be gained by Federal and State research agencies if progress is to be made.

SPORT SLANTS By ALAN GOULD

Some of the old Yale grads who have been running a fever over the football coaching situation at New Haven, both before and since the selection of Ducky Pond as the new head, may be interested in knowing that most of the men whose names rank high in the coaching profession think the Elis have, under the circumstances, done pretty well for themselves.

The Yale situation, a live topic when some two dozen of the college when coaches gathered in New York for their mid-winter powwow on gridiron rules, shapes up favorably to these keen observers for the following main reasons:

- (1) The presence of Earl (Greasy) Neale as Pond's first assistant assures Yale the benefit of one of the keenest strategists and most aggressive, resourceful men in the coaching game. At the same time Pond's ability as an organizer is recognized.

Watch That Neale Touch! Well informed football men, in short, believe Malcolm Farmer, director of Eli athletics, has taken a definite step forward and for the better in naming the 1934 coaching staff, even though it is quite obvious that many old grads, unimpressed by Pond's record, still feel the only thoroughly satisfactory solution is for Yale to install and experienced outsider as head coach.

Coaches frankly consider "Greasy" Neale, the old ball player and veteran gridiron campaigner, as the key to the whole situation. His reputation for football sagacity is already well established. He has been a head coach in fast company for years. What he doesn't know about Yale he will quickly find out, either from Pond or his young brother, "Widdy," who played in the same backfield with Ducky and now is a director in intro-mural sports at New Haven.

"Greasy won't be in charge, but he will have plenty to say about Yale's general program of action on the field this year," commented one of his coaching friends. "He's a fast worker, too. I seem to recall he got his nickname because he was so slippery on the bases as a big league ball player."

Another thing: Greasy believes in giving a football offense the whole works. He knows how to build up a passing attack and made it click. They are liable to see more chances taken and more footballs flying around in the Yale bowl this fall, on any one afternoon, than those old grads have been accustomed to seeing in a whole season.

Grid Methods Ever-Changing Elmer Layden, another young man who has moved up in the coaching profession this year, has no illusions about the job he is tackling as the combined athletic director and head coach at Notre Dame.

The Star said reports to the effect were current in government circles.

"The resignation," it added, "is looked for regardless of the outcome of probes being made of Woodring's handling of War Department contracts."

"Woodring recently incurred criticism for his article in a magazine referring to the civil conservation camps as potential military assets and was asked for explanation of the matter at the White House. "A wide breach also has developed between Woodring and members of the staff of the army over policies in connection with drawing up specifications and awarding of contracts for army equipment."

Hitler Abolishes Reichsrat. Berlin, Feb. 14.—(AP)—Chancellor Hitler's government today abolished the Reichsrat, the federal council—thereby abrogating section four of the Republican constitution of Germany.

The abrogation section provides for the organization of the Reichsrat as follows: The Reichsrat represented the state and consists of 66 members. Each member has one vote for every 700,000 inhabitants.
