GERMANY WARNED TO KEEP HANDS OFF AUSTRIA

Britain, France And Italy Take Part In Warning

MANIFESTO TO BE GIVEN OUT IN 24 HOURS

Premier Mussolini Is Understood to Have Espoused Movement To Keep Nazi Control Out of Austria; Plan Also Designed to Preserve Austrian Independence

Paris, Feb. 17—(AP)—Three great powers of Europe, England, France and Italy, drafted today, reliable reports said, a warning to Germany to keep her hands off Austria.

The joint declaration will be addressed to the world at large the understanding said.

It is a movement on the part of the three powers intended to preserve Austrian independence.

The manifesto is expected to be released in 48 hours.

Premier Mussolini in espousing the effort to keep Nazi control away from Austria proposed the three power pact.

CWA WORKERS STAY ON JOB IN THIS AREA

Disbanding Order Issued Yesterday Does Not Affect Workmen Here

As far as known the order calling for the dropping of 400,000 Civil Administration employees next week will not affect Pitt county. K. T. Futrell, local administrator said today.

In case the order did affect the county, the administrator said only 16 men would be involved. He stated the county had been operating within its quota ever since the grant program was started and hence will hardly come under the disbanding order unless further instructions are issued.

Workers in all sections of the county were able to put in full time this week, Mr. Futrell said, and this means that approximately \$100,000 will be paid out to the workers today. No orders regarding the making up of lost time caused by the cold wave two weeks ago have yet been received and those affected will have to mark time until some action is taken.

The administrator called attention to completion of a first aid class conducted among CWA foremen by Lieut. Lester Jones of the State highway patrol. The CWA requires that all foremen must have a working knowledge of first aid and the school was conducted the past week to meet this demand.

Mr. Futrell said no new projects were being approved at this time and that work was being pushed forward as rapidly as possible on old projects. Some of the projects have been completed, some are in the course of construction and others have not been touched. However with the coming of spring weather, it was hoped to rush all work to completion in a short time.

FOREIGN MAIL CONTRACTS TO BE PRIED INTO ONE KILLED BY FAST TRAIN

Administration Begins Looking Into Other Phase of Government Business

Washington, Feb. 17—(AP)—Victorious against the first legal challenge of its fight to annul domestic air mail contracts, the administration today pried into foreign air mail agreements.

There were indications that disputes over the government contract abolition might continue week longer.

Following dismissal by the New York federal court on the ground of no jurisdiction of an action by Trans-continental and Western Air to restrain the cancellation, counsel for the company said he would appeal.

"This is something that may go on and on," said the attorney John Thomas Smith.

Another major chapter in the controversy was looked for on Monday. Walter F. Brown, former assistant postmaster general will appear before the Senate committee.

Chairman Black of the committee last night stated the 1930 meeting of air mail representatives here which Brown contends conclusion, resulted in contract allocations that were contrary to law.

PAVE WAY TO IMPROVEMENT OF SCHOOLS

Committee Named At Raleigh Meeting To Work On Reconstruction Program

Raleigh, Feb. 17—North Carolina yesterday laid the groundwork for a reconstruction of its public school curriculum.

More than 300 representatives of 70 organizations of state-wide character and of 20 institutions of higher learning met here to form preliminary plans for a two-year study of the curriculum. Each organization will name a committee to recommend definite changes and within six months another general meeting will be held to receive and consider the various recommendations.

Governor Ehringhaus, President Frank Graham of the University of North Carolina and Dr. A. T. Allen, State Superintendent of Public Instruction, sounded the keynote of the meeting, which was called by the State Department of Public Instruction.

The governor called for constructive criticism. "We must have no patience with criticism which is otherwise," he said.

"We must canvass the entire field of public education. This is not a matter to be carried out in hurried or desultory fashion. We must refuse to recognize education as a static thing, but must allow changes to suit every fancy and whim.

"We must give the best to secure the best for North Carolina." The fact that so many interests were represented yesterday was proof that reconsideration of the school curriculum is needed. Dr. Graham declared in summarizing the day's developments.

"In this era of the New Deal it is only fitting that we should look at our curriculum," the University president said. "If we can erip the real problem, we might see that economic depression is not inevitable, but perhaps result from lack of grasp on our part.

"Social drift brings on economic breakdown and part of that drift goes back to our schools and colleges and their curricula. Revisions of our curricula are but steps in our progress."

TWO HIT-RUN DRIVERS ARE SENT TO ROADS

Smithfield, Feb. 17—Willie Hayes and J. B. Webb, young white men of Ingrams township were tried on an indictment in Johnson superior court Thursday, were charged with being hit-and-run operators of an automobile on Saturday night, October 16th. The result being that one of the legs of a child was broken. The evidence disclosed that both had been drinking and both had been driving the automobile, but that Webb was at the wheel at the time of the accident. Webb received a minimum sentence of twelve months upon the county roads and Hayes received a minimum sentence of eight months upon the roads.

N. C. To Drop 26,000

Raleigh, Feb. 17—(AP)—Twenty thousand persons now on CWA jobs in North Carolina will be dropped next Friday.

Mrs. Thomas O'Berry, state administrator, was advised by telegraph from Washington today to cut 26,000 workers from the payroll next week and to have a maximum of not more than 55,000 CWA workers in the state.

The administrator said she was seeking to scale down the number immediately.

There were 75,930 persons on the payroll for the week ending Feb. 10. The new policy of keeping the most needy on the roll of workers will go into effect in North Carolina next week.

SOCIALISTS BATTLE WITH COMMUNISTS

Bitter Fight Takes Place in New York City Over Austrian Trouble

New York, Feb. 17—(AP)—Socialists and communists meeting at Madison Square garden to protest against "atrocities" of Austrian fascism engaged in one of the bitterest battles that the home of pugilism has ever seen.

The meeting, sponsored by trade unions and socialist organizations late yesterday afternoon became a bedlam after it was called to order when about 5,000 communists among the crowd of 20,000 which jammed the building attempted to take charge.

Three women and nine men were beaten or struck with chairs and one man was stabbed in the back. Seven of the injured were taken to a hospital for treatment.

FINAL LEAF REPORT MADE

Supervisor Cobb Says Total Sales Here This Season Was 72,162,884 Pounds

The official report of sales of the Greenville tobacco market at the closing of the season January 30 was said today by E. W. Cobb, supervisor of sales, to be 70,218,890 pounds for which farmers were paid a total sum of \$11,743,950.33.

The report of the supervisor made public this morning said the figure did not include a small amount of tobacco sold here after the closing period.

It also did not include 1,944,194 pounds of scrap sold by farmers direct to the factories, and which was not included in the general market report. This brought total sales of the season to 72,162,884 pounds. The scrap tobacco, the supervisor said, brought an average of 2 1/2 cents a pound.

In the February issue of the Southern Tobacco Journal, the following official reports from Wilson and Rocky Mount were printed:

The Wilson N. C. tobacco market has sold 70,028,500 pounds this season for \$11,977,579.07, an average of \$16.94 as compared to 37,709,530 pounds for \$4,654,830.35, and average of \$12.34 in 1932. Supervisor George L. Wainwright reports.

The Rocky Mount, N. C., market closed February 5, for the season, with total sales of 49,664,564 pounds which brought \$8,258,360.73 an average of \$16.67. Secretary H. J. Browder reports. Last season the market sold 25,605,220 pounds for \$3,435,944.93, an average of \$13.42.

GAINS SCORED BY FASCISTS IN AUSTRIA

Another Leader Elevated to the Cabinet; Thousands of Socialists Ousted

Vienna, Feb. 17—(AP)—Austria fascists scored big gains in their drive to dominate the government today with the elevation of another leader to a cabinet post and the ousting of thousands of socialists from public office.

They won, too, on Chancellor Engelbert Dollfus' failure to heed the demand of his own party that parliament be reconvened at once. Emphasizing the ascendancy of the fascists influence under Secretary Kniesedepfer-Sturmmer, member of the fascists' Heimwehr, or home guards, who has been named minister of social welfare.

The cabinet accelerated its general anti-socialist campaign by declaring null and void the position of the prerogatives of every official elected on that party's ticket.

Five more socialists were condemned for insurrectionary activities were hanged in Vienna. Six others were sentenced to death but their sentences were commuted to prison terms a few hours before they were to have died.

Not even the hanging courts could halt the guerrilla warfare waged against the Heimwehr by ragged bands of socialists. Several Heimwehr sentries have been wounded in the streets by gunfire from speeding cars.

Unconfirmed reports said today that too of the sentries were dying. Police immediately called for extraordinary precautions—cars were searched and even pedestrians were watched closely. A taxi in which an AP correspondent was riding today was halted twice during a short run. Even the cushions were removed in the search.

Bushman purchased a week ago for himself and Carmela Ponselle of the opera, is just a scrap of paper now, the great lover of the silent movies said today. The wedding is off, by agreement. Miss Ponselle has gone back East. And his next ceremony said the erstwhile matinee idol, may be a retake of his first scene at the altar 32 years ago.

MAKES KNOWN HIS VIEWS IN LETTER TODAY

Pres. Writes Chairman Bankhead He Is In Accord With Bankhead Bills, Seeking Control of Cotton Crop; Believes the Bankhead Bills Cover the Cotton Situation

Washington, Feb. 17—(AP)—President Roosevelt, today endorsed the principle of the Bankhead bills for compulsory control of cotton.

In a letter to chairman Jones (D) of Texas of the house agriculture committee the President said his study of the various methods of dealing with the cotton situation lead him to "believe that the Bankhead bills in principle best cover the situation."

"I hope" the President wrote "that in the continuing emergency your committee can take action."

The Bankhead bills introduced by the Senator from Alabama and his brother in the house would limit this year's cotton crop to 5,900,000 bales and place a heavy tax on all cotton sold in excess of that limit.

The letter from the President said:

"My dear Mr. Chairman: "As you know I have watched the cotton problem with the deepest attention during all these months. I believe that the gains which have been made, and they are very substantial, must be consolidated and, insofar as possible, made permanent. To do this, however, reasonable assurance of crop limitation must be obtained.

"In this objective, the great majority of cotton farmers are in agreement. I am told that the recent poll by the department of agriculture shows that at least 50 per cent of the replies are in favor of some form of control.

"My study of the various methods suggested lead me to believe the Bankhead bills in principle best serve the situation.

I hope that in the continuing emergency your committee can take action.

"Very sincerely yours, Franklin D. Roosevelt."

FRED TURNER CLUB SPEAKER

Assistant Rector Of St. Paul's Church, Addresses Kiwanis Club Here

Regardless of what other nations may do, England and America will always hang together. Fred Turner, assistant rector of St. Paul's Episcopal Church, told members of the Kiwanis Club in regular weekly meeting at the Woman's Club last night.

Speaking on the subject "Some Comparisons of English and American Customs," Mr. Turner, an Englishman, who recently was awarded a three-year scholarship in a college in Virginia, said there was a lot of difference between the way the English and Americans do things, but they are more solidly united than any other nations on earth.

In case of another world war, he added by way of comment, Great Britain and America will be found fighting on the same side, despite what the rest of the world does. These two powerful nations are truly of the Anglo-Saxon type, with more things in common than other nations, and they can be counted upon to stick to one another at all times, he stated.

He thought people of England really get more out of life than Americans by reason of the fact (Continued on Page Four)

AUTOMOBILE THIEF IS ESCAPED CONVICT

Tarboro, Feb. 17—News was received here today that the Roy Evans arrested and held in Tallahassee, Fla., charged with entering the garage of the Tarboro Motor Company recently and stealing a new Ford automobile, is an escaped convict from the Alabama State Prison, and that his name is S. C. Cameron, and he was sentenced to serve in the prison for ten years.

The robbery of the motor company was one of the boldest ever perpetrated in this city. The building from which the automobile was stolen is situated within 60 yards of the City Hall.

ARREST MILL WORKER WHO SHOT TWO WOMEN

Shelby, Feb. 17—(AP)—Louis Sentell, mill worker, was jailed today in connection with the shooting yesterday of two young women who refused an offer of an automobile ride.

Sentell was captured in Polk county near Mill Springs by county and city officers after officials from the counties of Cherokee, Rutherford, Henderson and Polk had spread a dragnet for him.

Miss Florence Jones, 23-year-old mill worker, was seriously wounded and her condition today was said to be unchanged. Miss Emily Drake, the other young woman was slightly wounded by shotgun charges.

TIPS ON CONTRACT TIP-OFF DOUBLE
By Tom O'Neill
When opponents have reached a little slam contract a player with a sure trump trick and an outside ace has good reason to believe he can set the contract.

Yet often in such circumstances it is unwise to double. The contracting side, because of the double, may shift to another contract which will succeed.

Alphonse Moysse was doubled at six spades in a rubber game at Bridge House, New York. Then he bid six no trump and was doubled again. He took 12 tricks through a squeeze which the doubled remarked. Six spades could not be made.

Here was the hand:

Moysse, who sat South, does not recommend his initial bid of one no trump, believing the diamond preferable. Opposite the one no trump offer North, with a major two-suiter naturally had slam ambitions from the start. He forced on the first round and then offered six spades as soon as he got indications as to which major South preferred.

The five of clubs was led by West, and East took the trick with the ace. East's hand was based on the club ace and a sure trick in spades, probably all three missing honors.

East had the protected queen.

West forthwith saw a way to make his trump little slam, and in this method the singleton diamond knave in the North hand was a mighty good card.

East on the second trick led the club queen, which went to South's king. The North hand was entered via the diamond knave, and a low heart to the queen put Moysse back in his own hand to run the rest of the diamonds.

With two clubs and one heart already played from his hand East had to find two discards. One was the club knave, the other had to be a heart or a spade, and either would enable Moysse to make his contract.

In actual play on the diamond eight from the South hand East shed the eight of hearts, and the declarer then ran off three more hearts tricks, which, with the one club trick and one heart trick previously taken, five diamond tricks plus the ace and king of spades at the end, gave him little slam. On South's diamonds three spades and one heart were discarded North.

Father Beshel who has specialized on the question of social justice at the Catholic university of America under the well known author and lecturer, Father Ryan, will explain in a simple style the meaning of social justice. He will likewise explain the application of these laws of justice to the everyday life of our people in North Carolina as elsewhere. The question is of importance to all citizens and a general invitation is extended to all the adult men and women of Greenville to hear the talks on the vital question of our day.

Father Beshel's first sermon will be given out Sunday morning at the Parochial Mass at 8:30 A. M. The second and concluding sermon will be given at the evening service at 7:30 P. M. Invitations are extended to the members of the entire community.

POLITICS at random

By BRYON PRICE

Chief of Bureau, The Associated Press, Washington)
No one has summarized and characterized the first year of the Roosevelt administration more succinctly than the President, himself. In these words: "We are on our way."

By that Mr. Roosevelt means we and millions of his fellow-citizens agree with him. The ordinary indices of trade activity show a pretty consistent upturn for the year. Public confidence is unquestionably stronger than it was on that dark inauguration day last year.

The agreement is not universal. Some are disposed to paraphrase the old popular song and say: "We are on our way, but where?" They doubt the soundness of the Roosevelt experiments, and the enduring quality of the results.

But at any date, everyone agrees things are moving. To the detached observer at Washington that is the outstanding development of the year, whatever it may mean. In February, 1933, dead-end stagnation, weariness. In February, 1934, action, motion, momentum. That tells the story.

A Livelier Tempo
It would take many columns to detail the varying aspects of the change as they affect individual fields of action. Government buildings which a year ago drooped with the dreary routine of long-established governmental procedure echo to day to the noisy tread of hurrying desks, flying messengers, mile-a-minute governmental action.

Washington hotels are crowded. The streets, even in mid-winter, are like the streets of a metropolis. A new air of gaiety presides over glittering an extravaganza social gatherings at the White House and at many a humbler residence.

Centress drives ahead, under the iron hand of strict administration control. Politics is in an uproar, and the party lines of a year ago waver and totter as new ideas, new projects, new visions of breath-taking scope pour from the administration fountain.

It is true today's idea may be forgotten by tomorrow, but no matter; Washington is in motion, and, after a year of it, Washington begins to think it may be perpetual.

The New Nationalism
Not the least strange of these new phenomena is the manner in which Mr. Roosevelt has been able to fasten national attention on the problems at home and divorce national thought from the distractions abroad.

You could listen to the table-talk of present-day official Washington for a week and never suspect that an earthquake is rocking Europe, or that there is a rumble of war in the Far East.

The French disturbances caused hardly a ripple of conversation. Always excepting the State Department and the diplomatic corps—and they are very much on the sidelines—these who showed any interest were as likely as not to ask: Do you suppose this Paris rumpus will help us in the end by driving France off the gold standard?

Significant words about America, spoken in Tokyo a little earlier, simply failed to register.

The new monetary program has become the absorbing topic, just as NRA was six months ago. What will be next?

Washington does not know, but it is sure there will be something. If the farm experiment, for instance, fails—and some think it always has—a new one will be tried.

We are on our way.

Community Art Sponsored by CWA

By SIGRID ARNE
Washington, D. C. (AP)—That typical American family in the small town is about to learn the traditional picture of a street in Venice is no more "arty" than its own sweeping prairies and gaunt oak trees.

Some two thousand artists put to work by the Civil Works Administration are producing a flood of new art, built around American life, which artists hope may prove a renaissance.

A high school in Dallas is being decorated with panels depicting the dramatic history of Texas.

A dozen young artists are working in a swimming-pool studio at the University of Iowa to depict the aesthetic virtues of agriculture and the sciences.

So the famous "San Francisco school"—the city's art colony and the style in which it works—will be recorded permanently on the walls of the Coit Memorial tower atop historic Telegraph Hill overlooking the city. These artists are so serious about doing a fine job that they have organized under a leader who assigns various subjects for different walls—all of them showing American life, industries and history.

Capital Efforts, Too
In Washington, a unique attempt is being made to find rich but inexpensive decorations for schools by making batik wall hangings. A master-design has been drawn and two women technicians are running it off. They expect to make six "editions," such as an ether world school.

In Pittsburgh, the art committee has assigned lithographers to produce richly designed panels recording life. These, too, will be run off in editions and will be allocated to the city's schools.

The act of giving jobs to artists under CWA grants is an unusual departure for this country's government, but the machinery was easy to set up. The country was divided into sixteen districts with central art committees in the large cities.

They decide on the public buildings to be decorated—and to an art lover such buildings are not hard to find. Ideas for decorating them usually have been talked of for years.

Artists Unhampered
"But in any case the artists is given absolute freedom," says Forbes Watson, technical director of the Public Works of Art project.

"We have tried to see that our committees are well-balanced. There always is the heated argument in the art world over classicism and modern art. Both will find a place.

"We are amazed at the excellence of the designs submitted and the type of men and women asking for work. Many of them are famous, but penniless. To the project is giving a chance to the new and unknown artists to prove himself.

"They are paid \$25.50 a week in the second class, and \$42.50 in the first class. They work a full week."

SPORT SLANTS

Probably one of the other reasons why the United States is finding difficulty getting international polo opposition lined up this year—both the Argentine and England having declined on economic grounds to send team here—is that this country has a discouraging number of high-goal players.

Any visitor who happened to get an eyeful of the East West matches at Chicago last year might well have been justified in proceeding post-haste to the nearest cable office and wiring back home to Yondon or Buenos Aires that it was not only quite useless, but positively risky to challenge these wild Americans at the present time. Our latest ranking list, with notable increases, is also a warning.

Not since 1928 has the U. S. A. so dominated world polo rankings as this year, with Tommy Hitchcock, Elmer Boeseke, Jr., and Cecil Smith a majestic triumvirate, all in the ten-goal class. Only one other player of international reputation, the Nawab, of Bhopal, is ranked as high as nine goals and there is no indication that the Nawab contemplates taking polo issue with our lads under any circumstances.

This leaves the Argentine and England with a group of eight and seven goal players from which to pick for championship competition. Probably neither country, under the existing circumstances, feel like spending a lot of money to risk the chance of being outclassed on the emerald turf to Meadow Brook, were only one invading team—Santa Paula of Argentina—has ridden off victorious since the war.

Another East-West Forecast
The result of this situation on horseback seems likely to be the promotion of another East-West series, bringing all the high-goal Americans together again, at Meadow Brook this summer.

The Western quartet, or rather quintet—since Eric Pedley rushed in after Rube Williams had fallen at Chicago to join Aidan Fork, Elmer Boeseke and Cecil Smith in the final match—will be more than anxious to prove their triumph at Onwentsia was no fluke.

Naturally the Eastern forces, under young Mr. Hitchcock's leadership, feel they might reverse the outcome if afforded fresh opportunity. A number of factors, altogether aside from the skill and aggressiveness of the Westerners, contributed somewhat to the downfall of the Eastern favorites at Chicago. They were, to put it quite bluntly, out-smarted in the critical phases of strategy and horsemanship.

Harry Hopkins, administrator, and will leave about 3,104,000 persons on the payroll.
Hopkins made public the text of instructions sent to state adminis-

trators and the quota reduction to be in effect the week beginning February 26.

The instructions are: "To accomplish necessary reduction you should lay off those needing employment least, dropping first all workers in whose immediate family another member is working, leaving no one than one (painfully employed in the family, and then workers who have other resources, making sure that needy women receive equal consideration with needy men."

"Make major reductions in those communities in which seasonal opportunities for employment and in which there is least unemployment. "Reductions to be made in the educational program and any other federal projects will be ordered through the Federal department and you will be notified."

"Any new employment or replacement for any other purpose shall be on the basis of need effective not later than March 2. Wages paid will be prevailing rate of wage for the kind of work performed in each community, but in no case less than 30 cents an hour."

Dolluss Warned.

Prague, Czechoslovakia, Feb. 17.—(AP)—A telegram of denunciation warning Chancellor Dolluss that his war against the Socialists is endangering the place of the Fatherland as well as that of other parts of Europe, was sent to Vienna this afternoon by the Czechoslovakian Social Democratic party, the second largest in this country and represented in the cabinet by three ministers.

"We cannot endure any longer the torture which news of the catastrophe in Austria causes us," said the message, which was signed by the president and secretary of the party and approved by the committee.

"Our whole population is paralyzed with horror over the events to which your regime has led. The hanging of wounded persons has awakened in us and our people a feeling of abhorrence unprecedented in the history of civilization. That is not justice nor is it politics, but revenge."

Bank Bandit Jailed.

Taylorsville, Feb. 17.—(AP)—Bascom Green, 47, and his son Lester, 24, alleged bank bandits were lodged in jail here today and arraignment was made to try them next week on a charge of murder and attempt robbery.

The two men declared outlaws and hunted since last July when an attempt was made to hold up the Merchants and Farmers bank here and a bank official was fatally wounded were arrested Thursday in Morristown, Tenn., and were carried to Asheville yesterday after they waved extradition.

Sheriff H. L. Mays of Alexander county and sheriff W. B. Somers of Wilkes county brought the father and son on here today.

Solicitor John Jones came here this morning to arrange for the trial and said they would be arraigned Monday when superior court here opens and would go on trial Wednesday.

FACTORY AT SPINDALE HAS REDUCED SHIFT

Spindale, Feb. 15.—(AP)—The Stonecutter Weaving Mills yesterday went on reduced shift as the result of a strike by employees. Deputy sheriffs still guarded the mill against threat of active picketing by the strikers, but no disorders had been reported last night.

K. S. Tanner, president of the mill, said the mill would continue in operation, with the workers who refused to join the strike. It was necessary to halt one shift, he said, because of the number of looms left idle by the 75 striking workers. Theodore Johnson of Raleigh, chairman of the state cotton textiles industrial relations board, was expected here in the near future to act as mediator in the strike.
