COMPANION OF JOHN DILLINGER IS SHOT DOWN

Samuel Insull Is Located On Boat

FOUND ABOARD BIG FREIGHTER EARLY TODAY

Chicago Utilities Magnet to be Returned to Greek Jurisdiction Immediately; Paid \$10,000 to Charter Boat; Martin Insull To be Returned to U. S.

Athens, March 16.—(AP)—Samuel Insull who was located aboard the Greek freighter Maiotis early today will be expelled directly to the United States, the Greek government let it be known.

Athens, Greece, March 16.—(AP)—Samuel Insull, Sr., Chicago fugitive, was definitely located today aboard the Greek freighter Maiotis and will be returned to Greek jurisdiction, the ministry of marines has announced.

It was said that Insull paid \$10,000 to charter the Maiotis and that he sailed at 4 p. m., Wednesday. Previously authorities indicated they believed Insull fled from his home and Greek jurisdiction Thursday morning.

The ministry of marines announcement was believed to have marked the close of one of the most widespread police searches in the history of the nation.

Toronto, March 16.—(AP)—Martin J. Insull, former Chicago utilities operator, and brother of Samuel Insull, today was ordered extradited to the United States.

TRUCK DRIVER KILLED WHEN CARS COLLIDE

Wadesboro, March 16.—Ed Adams, of Morven, driver of a bread truck was instantly killed today shortly before noon when his truck collided with a car driven by W. C. Hardison well known Wadesboro citizen. The accident occurred on a straight stretch of highway 80 about six miles south of Wadesboro.

Adams' truck apparently had gotten out of control while coming around a curve several hundred yards north of the scene of the accident and he was over the middle of the road, according to Coroner W. D. Moore who investigated. Hardison's car was on his side and he was held blameless by the coroner.

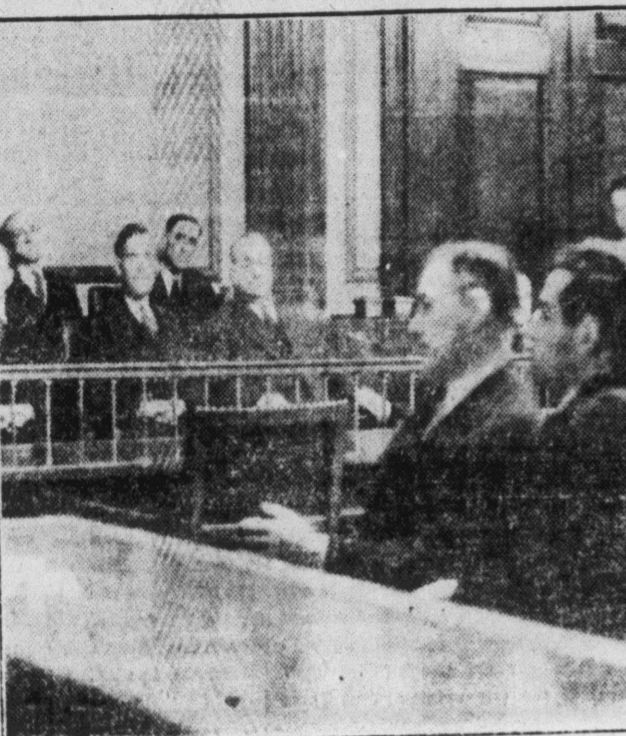
Organization Called To Explain Legislation For Wider Power of Body

Washington, March 16.—(AP)—Unprecedented power to engage in a general banking business heretofore confined to private banks was sought today by the Reconstruction Finance Corporation.

Jesse Jones, chairman of the corporation, will be called before the Senate bank committee tomorrow to explain the necessity for the legislation just submitted on behalf of the Reconstruction board. Under it the corporation could loan direct to industry. Long acquitted of the lending policy of private banks, Jones is expected to urge the measure as a means of providing sufficient credit to industrial recovery.

The proposed measure would be founded upon the broad terms of a bill drafted by the R. F. C. which would grant authority for financing foreign trade and extend the corporation's functions in other directions. Whether the bill had the approval of President Roosevelt was not disclosed but many argued the chief executive must at least have known of the proposal.

Lindy Testifies Air Mail - Washington, March 16.—(AP)—In police but firm tones, Colonel Chas. A. Lindbergh told a senate committee today that the bill to return air mail transportation to private hands was "unjust"; that the private contracts should be cancelled without trial of the operators and that the army had not been so efficient as private concerns in flying the mail.

TWO MEN ARE EXECUTED AT STATE PRISON

Jesse Brooks and James Johnson Pay Supreme Penalty During Morning

Raleigh, March 16.—(AP)—Two men were electrocuted at State prison today. Jesse Brooks, 46-year-old negro, a native of Abbeville, S. C. went to the chair first.

He died for the murder of Detective Rowland A. Gill of Durham. James Johnson, negro, 32-year-old and a native of Blunham was executed for the murder of his ex-girl friend, Virginia Leach in Hoke county.

The prison's new executor, A. H. Sessions, handled the switch for both electrocutions.

THREE BLACKS ARE EXECUTED

Mississippi Claims Lives of Three Men Charged With Attacking White Girl

Hernando, Miss., March 16.—(AP)—Three young negroes died on the gallows here today for criminal assault on a 17-year-old Holly Springs, Mississippi school girl.

Two hundred steel helmeted national guardsmen who rushed the negroes from the Hinds county jail at Jackson, surrounded the jail as Johnny Jones, Ernest McGeachey and Isaac Howard were executed. But few citizens were in evidence.

Howard and McGeachey were the first to die. They went to their deaths singing religious songs, but Jones did not utter a word.

The hanging was witnessed by Clyde Colling of Holly Springs, the father of the attack victim. A bill which would have permitted him to spring the trap was killed by a House committee after being passed by the Senate.

SAFETY MEET HERE MONDAY

Much Interest Manifested in Movement To Reduce Automobile Death Toll

Considerable interest was being manifested today in the safety meeting to be conducted in the office of Dr. R. S. McGeachey, director of the Pitt County Department of Health, next Monday afternoon at 4 o'clock.

The meeting was called by the health director the first of the week for the purpose of naming safety committees in each township of the county. At a recent public meeting held in connection with the movement, selection of the committees were put out to a previous meeting.

Dr. McGeachey mailed out letters to representative citizens in all sections of the county asking them to be present Monday to take part in the conference.

The safety movement is being pushed in all parts of the state with the view of reducing the number of deaths and injuries occurring each year from automobile accidents. The plan was inaugurated by the Carolina Motor Club and committee heads have been named in each of the counties.

NEW FIRM TO RUN GORMAN'S

Tobacco Warehouse This Season to be Operated by Gorman Bros. and Lassiter

Announcement was made today that Gorman Brothers and R. W. Lassiter would operate Gorman's New Warehouse, on Eleventh, Greene and Washington streets next season.

The warehouse is one of the largest in the city for the auction sale of bright leaf tobacco and was erected several years ago by the late J. N. Gorman, whose sons will be engaged in its operation next season.

Included in the force are the following: Claude L. Brown and R. W. Gorman, sales managers; M. D. Lassiter, office manager; L. C. Powell, auctioneer; Ernest L. Clark, Coy L. Smith, Clarence Taylor and Lonnie Lewis, floor and leaf force.

R. W. Gorman, one of the sales managers, has been connected with the warehouse business here for a number of years, and is well known by the thousands of farmers of this great bright leaf district.

Mr. Lassiter has been associated with the industry for a number of years and is considered a very capable and experienced office man.

Other members of the force have seen considerable experience in the tobacco business and are capable of rendering fine service in their respective fields.

BEER BARON ASKS FREEDOM

Perry Druggan, of Chicago, Makes Effort to End Term in Atlanta Pen

Atlanta, March 16.—(AP)—Immediate release of Perry Druggan, former Chicago beer baron from the federal penitentiary here where he is completing his 36-month term for income tax violations is sought in a habeas corpus petition filed in the United States District court.

It was learned today that Federal Judge E. Marvin Underwood had signed the order yesterday setting the hearing on the petition for 10 a. m. Saturday.

South African Miners Get Bonus Capelton.—(AP)—Workers in South Africa gold mines are to get \$2,500,000, equivalent to a 5 per cent wage bonus, as their share in the increased prosperity of the industry. The money comes from the government's share in excess mining profits.

EXPECT SEED LOAN BLANKS HERE DAILY

Application Blanks For Loans to Growers Should Arrive Any Time Now

Application blanks for seed loans to farmers of this community are expected to arrive any time now, it was stated today by T. O. Edens, in charge of the seed production loan office here.

Under provisions of the \$40,000,000 appropriation recently made available by congress individual farmers may obtain as high as \$250 and land up to \$500.

A farmer may obtain the seed loans if he cannot get credit elsewhere and if he is cooperating with the production control program of the Agricultural Adjustment Administration.

Offices of the seed loan department are located in the court house and growers wishing to obtain loans should apply there after obtaining a statement from the county crop production council that they do not intend to increase acreage in opposition to the administration program.

The following information regarding the program was recently made public by the Farm Credit Administration in charge of distribution of loans:

The maximum amount which will be made available to any one farmer this year is \$250 and the minimum is \$25 according to the regulations. The interest rate will be 5-1-2 per cent per annum. Provisions for taking crop liens have been worked out under Mr. Garwood's direction and detailed regulations will be placed in the hands of local emergency crop loan committees within the near future. The time and place where these committees will receive applications will be made known locally within a short time.

Before any farmer may secure a loan, however, he must first obtain a statement from the County Production Council where one exists, that he does not intend to increase his acreage or production in opposition to the Agricultural Adjustment Administration program. Where a county production council has not been set up, the applicant will have to give satisfactory evidence that he is cooperating with the production control program of the Agricultural Adjustment Administration, before his application for a loan will be considered.

Applications for loans from \$25 to \$150 may be made directly to the emergency crop loan offices provided the applicants do not have sufficient security to obtain loans elsewhere.

A farmer applying for a loan of \$150 or more must first make application for a loan to the Production Credit Association serving his county. Rejection of his application by the Production Credit Association will be considered sufficient evidence that other credit is not available and the farmer may then make application to the emergency crop loan office.

The emergency crop loans are entirely separate from, and are not to be confused with production credit association loans. The Emergency Crop Loan Fund is an emergency relief measure for this year only, to make available funds to those who cannot qualify for credit through the regular channels of a production credit association.

In announcing the regulations Mr. Garwood said he could not emphasize too strongly that the emergency crop loans are to provide a means of temporary relief for this year only and that this year's loans probably will be the last of their kind. Farmers who have a source of income other than farming are not eligible for emergency crop loans.

The fund will be used to make loans not exceeding the cash cost of growing crops during the year 1934, for summer fallowing, and for winter wheat to be planted in 1934 and harvested in 1935. An amount from the fund, not to exceed \$1,000,000, may be used to make loans to purchase feed for livestock in areas designated by the Governor of the Farm Credit Administration as drought and storm-stricken. The funds may not be used to make loans to replace work-stock.

Herbert Youngblood Wounded When he Fires on Officers at Port Huron, Mich.; Negro Says he Had Been With Dillinger; All Available Officers Begin Hunt to Capture Desperado Who Escaped From Crown Point Penitentiary.

Port Huron, Mich., March 16.—(AP)—A negro who said he was Herbert Youngblood, a companion of John Dillinger, desperado, in his escape from the Crown Point, Ind., jail two weeks ago, was shot down in a battle with sheriff's officers, and officers armed with machine guns were combing the vicinity for Dillinger, who he said had been with him.

The negro is about 35 years old and is believed to be near death. He was nearly unconscious when he gasped out the information that sent all available officers into the manhunt for the desperado who had been the object of a nation-wide search since he cowed his Indiana jail guard with an imitation pistol carved from a broom handle and fled.

The officers were attempting to get from Crown Point definite information to clinch their identification of Youngblood.

Four officers led by Sheriff William Van Antwerp went to a store in the negro settlement of South Port Huron on a tip that a negro carrying a gun and boasting of a jail escape was there.

The negro suspect met them at the door, gave another name and when the officers sought to enter opened fire.

The officers returned the fire and the suspect fell with a wound in the heart and three bullets in the abdomen.

SEEKS PACT FOR WORKERS

Johnson Makes Effort To Avert Impending Strike of Automobile Employes

Washington, March 16.—(AP)—General Hugh S. Johnson, standing in the breach ruffed by the National Labor Board that conceded itself powerless, sought a pact between labor and automobile executives today to ward off a threatened strike in motion.

He tentatively outlined two plans: Elections to determine the strength of the American Federation of Labor unions and work councils or company unions in each plant without disclosing to the employers the affiliation of each worker. An impartial board to hear complaints of men who say they were fired.

A fear that a great strike at this time might hamstring the Roosevelt recovery drive drove negotiators on. A hundred leaders of labor stood by and waited. They warned the deadline was 4:15 today, the hour previously set for their departure from Washington.

Portuguese Ships Reds To Africa Lisbon.—(AP)—Portuguese authorities are planning a colony in Angola, West Africa, for hundreds of communists and their families, rounded up after a recent rising. The colony at the mouth of the Cunene river, will have modern sanitation, fish and fruit canneries and schools.

TWO NEGROES ARE JAILED FOR ROBBERY

Men Charged With Robbing Bonner's Lane Store Nabbed Last Night

Two negroes charged with robbing a store here Wednesday night were taken into custody by police here early this morning and will face preliminary hearing in police court tomorrow morning.

Bill Clark and Charlie Harris, who police said confessed robbing Ike McCoy's store on Bonner's lane were arrested about 4 o'clock this morning after officers had been on their trail since early yesterday.

George Clark, chief of police, said the arrests followed the sale of some of the stolen goods during yesterday. They were traced through this source and by other information provided officers investigating the case.

Some of the stolen property consisting of cigarettes, candy and other articles was recovered. A clear box partly filled with sales tax money was also recovered but, it was said, most of the fund had been spent.

The thieves gained entrance to the building by forcing their way through the front door. Police at first attributed the robbery to colored youths.

Chief Clark said both men readily admitted the crime shortly after being taken into custody. They were confined in the city jail to await hearing in police court.

FINLAND'S BOOTLEG SQUAD SETS WORLD POLICE PACE

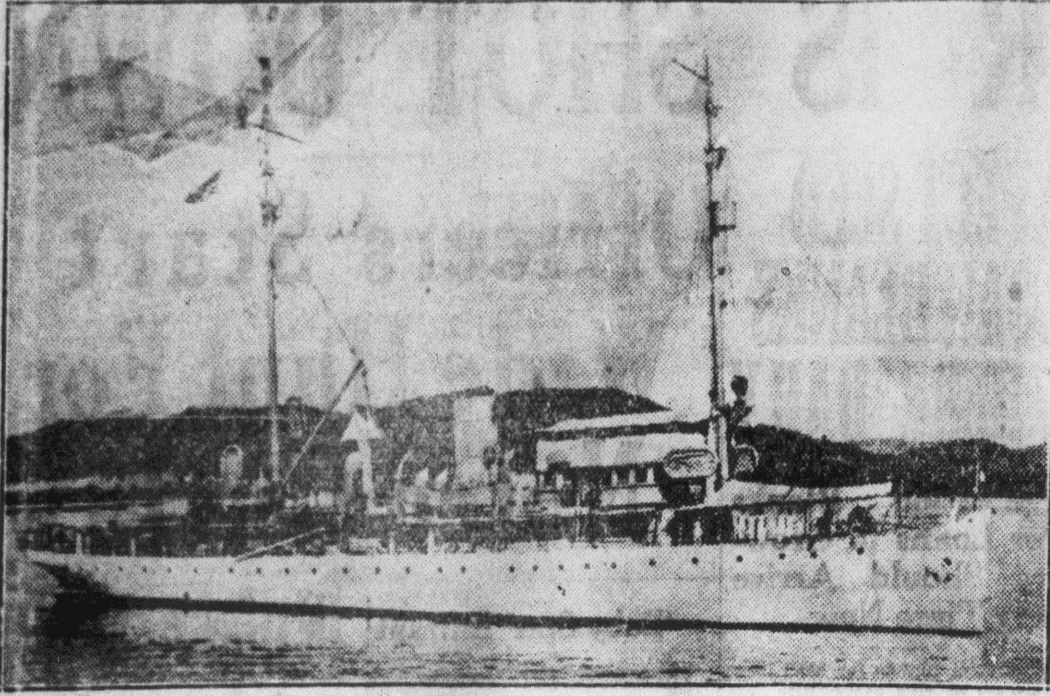
Helsinki.—(AP)—Finland's "flying squad," formed in 1932 to exterminate bootlegging, is reputed to be the busiest police force in the world.

In its first year the squad seized 7,000 gallons of contraband liquor, 581 firearms, 1,113 draggers and sheath-knives, 14 motorcycles, 17 motorcycles, 10 rowboats and six horses. It also arrested 8,361 suspected liquor smugglers.

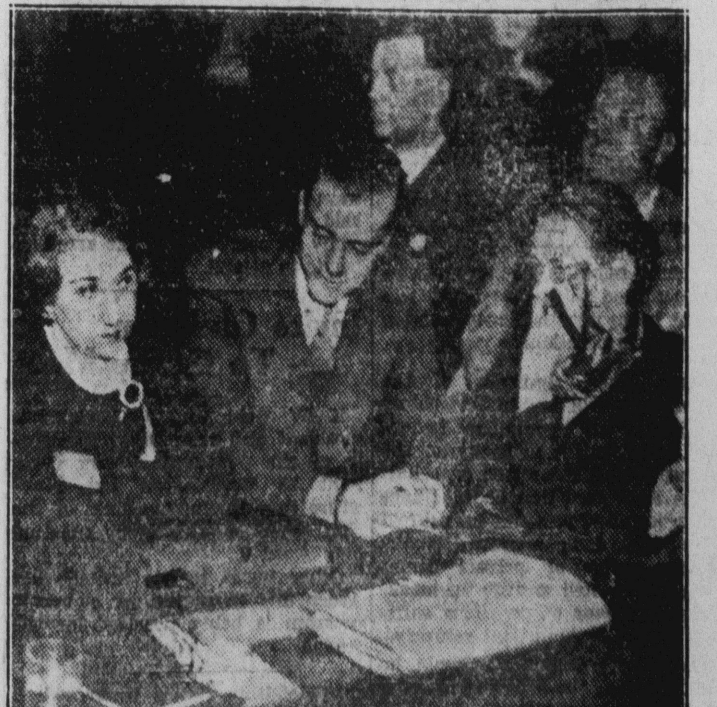

Select Cast For The Passion Play

Selection of the cast of local people for minor parts supporting the 16 professionals in the production of the great European Passion play at two performances here today was started yesterday. At the first assembly of extras to-morrow night additional parts will be awarded. The parts already awarded, include Miss Mary G. Parker as Rachel, Miss Mary Lynn Pupkin as Veronica and Miss Elizabeth Madrin as Salome, dancer to King Herod.

The Passion Play is being brought here under the joint sponsorship of the Junior Woman's club and the Carolina Teachers College. It will be presented in the local auditorium, Monday and Tuesday nights, commencing at 8:00 p.m.

Interest in the Passion Play presented is increasing rapidly, both in the city and among the towns and communities within a forty mile radius. Advance requests for tickets are coming in at an increased rate. Programs of the production, listing 21 scenes from the life of Christ to be enacted at the three hour performance, are being printed today and will be distributed by users at each performance. The synopsis of the scenes of the Passion Play will add much to the understanding of the spectators, who will also be aided considerably by the use of English by players.

The production here will be of the same grand scale which has made the plays at Freiburg and the dramatic productions at Oberammergau, Germany, world famous for centuries.

The Greenville Choral club will furnish the musical background for the production and they have been rehearsing nightly.

Vatican Endorses Dollfuss Policies On German Union

Vatican City (AP)—The independence of Austria is as much a cornerstone of the foreign policy of the Vatican as of Italy, France and England.

Although Vatican Authorities have not said it in so many words, their feeling is known to be that Austria must not be merged into Germany.

"Anschluss," they believe, might produce another European war, a terrible disaster for humanity.

Wary Of Hitler Policies

Besides, Austria, as it now stands, is a Catholic nation, with a Catholic government. If it merged with Germany it would become a province of Protestant Berlin and Hitler's policy toward the church already has produced difficulties between the Vatican and Germany.

The relations between the Vatican and Austria are very friendly. Last summer the two powers signed a concordat. Later the pope conferred the Order of Christ on President Miklas, and the Order of Pius IX on Chancellor Dollfuss. He received the chancellor in a long, cordial audience.

The pontiff sent a personal legate, Cardinal La Fontaine, of Venice, to represent him at Vienna's observance of the 250th anniversary of her deliverance from the Turks in 1683. Newspaper Lauds Dollfuss Highly laudatory articles on the work of Chancellor Dollfuss have appeared in the Vatican newspaper, Osservatore Romano. Dollfuss's declaration that his country would follow the social teaching of the popes as contained in the papal encyclicals caused a profound reaction here.

BIG BARBECUE CELEBRATES CULVERT HERE

Workmen on CWA Project Tendered Dinner By Property Owners

A barbecue dinner today celebrated the pouring of concrete on Greenville's new \$11,200 culvert now under construction in the vicinity of the municipal swimming pool.

Property owners affected by the building of the culvert gave the barbecue for workmen and others engaged in the construction of the project, which is being built through funds provided by the CWA and the city.

The culvert is 600 feet long and extends from Evans street to Fifth, involving some of the most valuable property in the city. Property owners have long felt the need of proper drainage for the district and announcement that a concrete culvert would be built was received with general rejoicing.

The job of constructing the culvert was directed by Henry Rivers, civil engineer, with Jim Clark as superintendent.

The local committee which had charge of obtaining the project and which also has directed construction activities is composed of Mrs. J. L. Hassell, J. H. Boyd, Herman Duncan, members of the Board of Aldermen, and Martin Swartz, Ralph Garrett and Mayor R. C. Flanagan, representing the citizenship. This committee is also in charge of the building of the swimming pool in the ravine in front of the high school building. Both the pool and culvert will cost above \$29,000.

The engineer, superintendent and committee members have been highly praised for the fine job they are doing in behalf of the city and the barbecue today was in appreciation of their fine efforts as well as those of the laborers.

To Consider Strike Issue Washington, March 16.—(AP)—Proposals made by Hugh S. Johnson for settlement of the threatened automobile strike will be considered by the executive committee of the National Automobile Chamber of Commerce at a special meeting in New York on Monday.

The announcement was made today by William Knudsen, executive vice-president of General Motors, after concluding a series of conferences in which Johnson, NRA chief, outlined proposals for thwarting the strike.

Near Vote On Vets Bill. Washington, March 16.—(AP)—Nearing another vote on the controversial veterans allowances, the House today insisted that government employees be given back only ten per cent of the fifteen per cent pay cut instead of the full amount proposed by the Senate.

A proposal that the House receded from its position was made by Rep. Connery, Democrat of Massachusetts—was rejected 225 to 161. A decision now will be sought by committee representatives of the two ranches of Congress.

The House wants five per cent of the pay cut restored as of February 1, and five per cent on July 1. The Senate voted for five per cent as of February 1 and ten per cent on July 1.

The House proposition was estimated to cost the treasury about \$28,000,000 to July; and about \$125,000,000 in the next fiscal as compared with \$190,000,000 under the Senate amendment.
