WIRT INQUIRY TO BE SHORT AND SNAPPY

Republicans Charge Investigation Will Result in a Gagged Hearing

Washington, March 31.—(AP)—Democratic managers planned today to make the House inquiry into the charges of Dr. William Wirt as short and snappy as possible. Several Republican members hoped to extend the investigation a bit. They have objected to limiting the inquiry strictly to the anti-brain trust accusation by the Gary, Indiana, school superintendent. Representative McGugin, Republican, Kansas, contended last night that the appropriation of only \$500 for the investigation and its limited scope would result in a gagged hearing.

Gary, Ind., March 31.—(AP)—Dr. William A. Wirt, educator, struck again today at unnamed brain-trusters accused of planning a governmental revolution with a new statement in which he declared: "We haven't seen anything yet." Quoting from recent books by Secretary of Agriculture Henry A. Wallace and his assistant, Dr. Rexford Tugwell the Gary school superintendent said it was evident one step was leading to another in the revolution.

HOWARD EDWARDS HELD GUILTY OF ATTEMPT

Sanford, March 31.—After being out 15 hours, the jury in the case against Howard Edwards, young white man, charged with criminally assaulting Agnes White, his eight-year-old sister-in-law, returned a verdict shortly after noon today, of guilty of assault on a female, with an attempt to commit rape. Judge R. Hunt Parker overruled a motion for a new trial made by K. F. Hoyte, counsel for the defense and then sentenced Edwards to not more than 15 years, nor less than 14 years, in the State penitentiary. Mr. Hoyte gave notice of appeal to the Supreme Court, and bond was fixed at \$10,000. This has not been given and Edwards is still in jail. The assault is alleged to have taken place at the home of Mr. and Mrs. John White, parents of the little girl, near Tramway, on the afternoon of Saturday, February 17, while Mr. and Mrs. White were in Sanford.

CLAIM IS SETTLED IN BEE-CAUSED ACCIDENT

Fayetteville, March 31.—In the midst of the trial yesterday afternoon a settlement was announced in the damage suit brought by H. L. Melvin, administrator, against Louis Lerkowitz for the death of the plaintiff's 10-year-old son, Neill C. Melvin, in an automobile accident. The terms of the settlement were not revealed. The argument to the jury was ready to commence when the compromise was announced by counsel. This is the case in which the claimant is said to have been caused by bee flying into the automobile. Young Melvin and other boys were sitting on a concrete curbing bordering the Atlantic Coast Line Railroad track on Winslow Street when Lerkowitz's car ran onto the embankment, killing the Melvin lad and injuring another. The administrator brought suit for \$20,000. Downing and Downing were attorneys for the plaintiff and Dye and Clark for the defendant.

QUITS TO GIVE ANOTHER OPPORTUNITY TO WORK

Fayetteville, March 31.—D. M. Stringfield, well known lawyer of this city, who last week qualified as assistant district attorney for the Federal district of Eastern North Carolina, announced his resignation from the chairmanship of the Cumberland County Executive Committee of the Democratic party yesterday afternoon. Mr. Stringfield has been Democratic county chairman for several years. "I am quitting just to let somebody else work awhile," said Mr. Stringfield in making the announcement. He stated that he was mailing notices of his resignation to members of the county executive committee and calling a meeting of the committee for April 7 at noon.

Flemming Case Is Bound Over

At a hearing in police court this morning I. Sugg Flemming was bound over to county court on a charge of operating a gambling house. The warrant was issued following a raid upon Flemming's residence on Second Street last Sunday morning about 2:30 o'clock.

ASK REPORT ON CLINIC WORK HERE

Health Department Checking up on Benefits of Clinic Work In County

Pitt County Department of Health is beginning a check of clinics held in this county last year to ascertain the benefits that have been derived therefrom. At the series of tonsil and adenoid clinics held in the county around 450 operations were performed upon the school children and it is now desired to know of what benefit this work has been. Throughout the county school teachers are being requested to make reports on these children since operations and the department is likewise anxious to have reports from the parents. In the short time allotted for the survey it is impossible to see each of these parents. Dr. R. S. McGeachy, stated yesterday and urged that all parents of the children who received the operations write or visit the health department and make reports as to what benefit, if any, the children have shown. He stated that the department would likewise appreciate any criticism of this phase of its work as only in this way could the attitude of the parents and the desirability of carrying on this kind of work in the county be determined. Another survey getting under way by the health department is in connection with the Rosenwald clinic work carried on here for some time among the negro population. Six field workers will begin this survey next week and they will try to visit each and every person who received treatment and also get a statement from landlords or employers of these persons as to what reaction or benefits had resulted from this work. If the work has shown definite benefits the health department officials hope that provisions will be made to continue this work in the county for another year. All landlords and employers are being urged to cooperate in this survey by reports and also aiding in contacting the person who received the treatment. San Jose, Calif., State Teachers' College awarded teaching credentials to 48 students last year, covering 12 weeks of practice teaching in city and rural schools at a cost to the state of \$38 each. North Carolina faces losses from damage done wheat, oat and barley crops by the cold last winter.

Late News Flashes From Over World

Fair and Warmer. Washington, March 31.—(AP)—The bureau looked for fair weather at least for part of Easter day throughout the east. Rain and wind-storm swept up the country from the south today but forecasters say it will leave in its wake fair skies and warmer weather. New Englanders may have to go to church in the rain but by afternoon they will probably have some of the same sunshine that is predicted for the south Atlantic states this afternoon.

No Reduction This Year Raleigh, March 31.—(AP)—Senator J. W. Bailey expressed an opinion here today that there is no chance for a reduction in federal taxes on tobacco this year. Senator Bailey said evidence at the hearing on the proposed reduction in the taxes had shown that the manufacturers of the so called 10 cents cigarettes had paid the growers an average of around 13 cents a pound for tobacco last year while manufacturers of the so-called 15 cents brands had paid the growers an average of 20 to 24 cents. "That evidence yesterday ended that controversy," the Senator said, when asked if there was any chance of a differential being placed in the tobacco tax. COURT STILL IN SESSION

Sutton Case Will Not Be Completed Before Late Monday or Tuesday

Presentation of evidence by the defense in the J. W. Sutton case continued in court here today with indications that the defense counsel would not complete its work today necessitating a continuation of court over into next week. Hope was expressed this morning that the case would be completed by Monday night but this was dependent upon the progress made today and Monday. The case in which Sutton is seeking recovery of property alleged to have been disposed of through collusion and fraud during the time he was mentally incapacitated and under guardianship was begun in court here last Tuesday morning. Judge J. Paul Frizzelle is presiding over the term.

MEAT STOLEN IN WAKE RECOVERED IN DURHAM

Durham, March 31.—Approximately 1,000 pounds of meat stolen from a Wake county storeroom a few nights ago was recovered here today by local police on information furnished by Joe Page, Durham negro, who was arrested in Raleigh yesterday for the theft.

FIRST LADY INVITED TO PALMETTO STATE

Columbia, S. C., March 31.—(AP)—Mrs. Franklin D. Roosevelt was invited to visit South Carolina, greet adult pupils of night schools here and inspect Magnolia and Middleton Place Gardens near Charleston. Senator James F. Byrnes extended the invitation at the request of James H. Pope, superintendent of education and Governor Blackwood. The University of Iowa arts department offers advice to communities about monuments, fountains or sculptural relief for building.

CONGRESS TO FINISH WORK ABOUT MAY 15

With Most of Major Legislation Out Of Way Members More Hopeful Now

Washington, March 31.—(AP)—Congressional leaders for the first time spoke with real confidence today of May 15 as the date for the adjournment of the 73 Congress. There are only about half dozen vital measures now awaiting action. Since congress convened in January administration leaders have talked of winding up the session in mid May but a new legislative demand continued to pour out from the White house their tone was obviously heavier with hope rather than confidence. They were more assured today as a result of settlement during the past week of the long deadlock over the veterans appropriations, House approval of the tariff bill and Senate passage of the Bankhead cotton legislation. One Representative close to the administration said privately today that the only bills looked upon as absolutely necessary now were the final appropriations measure, tax, tariff and stock market regulation bill and a measure yet to be introduced to provide new public works funds. He said President Roosevelt had no further legislative program in mind with the possible exception of a new tax bill to cover veterans and federal employees expenditures necessitated by the overriding of his veto of the independent office bill. When the chief executive left for his southern trip he was determined if necessary to demand sufficient new revenue to cover these expenditures.

TWO BANKERS DRAW THIRTY YEARS IN PEN

President and Director of Defunct Ohio Bank Convicted on Nine Counts

Cleveland, Ohio, March 31.—(AP)—Alvaney Johnston grand chief of the Brotherhood of Locomotive Engineers and C. Sterling Smith, were sentenced today to serve 30 years in Ohio state penitentiary for misappropriation of funds and false entries in connection with the failure of the closed Standard Trust Bank of Cleveland. Johnston was a director and Smith president of the Brotherhood Engineers Bank which closed in 1931, two years before the banking crisis last March. The two were convicted in common pleas court a month ago. Judge Virgil Terrell overruled a motion for a new trial and sentenced the two to 30 years terms on each of the nine counts, the sentences to run concurrently. A stay of execution was granted and bond continued pending further legal technicalities.

Many Have Filed Applications For Government Loans

More than 200 applications for government seed loans have been completed here this week and already placed on the waiting list for several days have been given out according to announcement by T. O. Edens in charge of the work here. The work of filing applications was begun here last Monday and about 50 applications each day are being completed. In order to be eligible for a loan from this \$40,000,000 government fund a grower must be unable to get financed from any other source and the amount of work in checking up on the applications prevents the handling of a larger number each day. Last year around 1,400 growers in Pitt county received these loans but in view of the fact that many growers are in better financial condition this year and due to the fact that other sources have been provided for growers who are able to furnish security for their loans it is expected that only around 700 such loans will be necessary in this county this year. More than a dozen colleges and universities entered the 1934 Texas intercollegiate dramatic tournament.

GERMANY TO MAKE TOKEN PAYMENT DEBT

Will Pay Million and Quarter on Fifty Million Payment Due Today

Washington, March 31.—(AP)—Of \$50,000,000 due this country today from Germany from mixed claims and army of occupation costs the State Department received notice that \$1,250,000 would be paid April 3. Actual deposit had to be deferred as today and April 2 are bank holidays in Germany. The German government informed the United States sometime ago that it would be unable to make full payment on the due date.

New Government Chart Available

A graphic view of the organization of the major agencies of the United States Federal government, including all of the emergency activities, is provided in a master chart just completed by the National Emergency Council. Representatives of three officials most significantly concerned with government administration—the Attorney General, the Director of the Budget and the Comptroller General of the United States—participated in its preparation. The chart may be obtained at the office of the State Director of the National Emergency Council for North Carolina at 408-410 U. S. Post Office Building, Greensboro, North Carolina. In easily comprehensible form, the chart depicts the inter-relationship of the various divisions of the Executive, Legislative and Judicial branches of the Government, and shows the position of the emergency recovery agencies in comparison with the executive departments and independent establishments. The various divisions are charted under that branch of the Government of which their functions are most representative. As all agencies of current or emergency importance are included, the chart will enable the citizen to identify the recovery organizations in particular and thus be able to take greater advantage of the facilities offered. In view of the rapid developments and changes in the government organization, the chart is especially valuable because of its authoritative character.

Fayetteville Plant Dynamited Last Night

Fayetteville, March 31.—(AP)—The Fayetteville Laundry, 118 Donaldson street, was dynamited last night police revealed today as they launched an investigation of a threatening letter received by one of the laundry owners February 19. Little damage was done. Residents heard the explosion at 10:39 last night but the nature of it was not revealed until today. A portion of one of the rear walls of the laundry was blown out and bricks were scattered about. Some machinery was slightly damaged but the company was operating today. D. K. Bell an American citizen of Chinese descent and who has lived here 15 years and operated the laundry which was formerly run by his father, is owned by D. J. Holloman. Both men were in the building at the time of the explosion but neither was injured. Bell said he received a letter February 19 signed only with a skull and cross bone, advising him to close the laundry and leave town within 10 days. He said he had no idea why the letter should have been sent to him. Police, meanwhile were investigating but would not reveal their line of inquiry.

TURKO-GREEK DIFFICULTIES OVER INSULL

Utilities Magnate Refuses to Leave Greek Ship, Greek Government Takes Hand

Instanbul, Turkey, March 31.—(AP)—Turkey today ordered the arrest of Samuel Insull but the 74 year old Chicago fugitive flatly refused the police request that he quit his chartered tramp steamer, the Malotis flying the flag of Greece. It was Greece that gave him a year and a half asylum from United States authorities who sought to try him on a charge of grand larceny and embezzlement growing out of the collapse of his mid-western utilities company. The Turkish order followed requests of the United States government that Insull be arrested, but Insull apparently clung to the hope that the Greek flag would continue to give him protection. Complications in Turko-Greek relations as a result of the incident were feared in some quarters for the master of the Malotis protested to the Greek consul here against detention of his vessel at the Straits of Bosphorus a free passage similar according to law to the Danube.

ATHENS, GREECE, MARCH 31.—(AP)—The Greek government today asked its legation at Ankara to demand of the Turkish government what justification it had for holding the Greek steamer Malotis, Samul Insull's haven.

This threatened international difficulties between Greece and Turkey key comes at a time when the two nations have been particularly friendly. They recently signed the Balkan pact and a Turkish aviation mission visited Greece, March 25 in honor of Greek Independence Day. Nevertheless strong feeling was in evidence here today and the Turkish action in holding the Malotis was described as unwarranted and subject to much criticism.

NEEDHAM W. OUTLAW IN SOLICITORSHIP RACE

Goldboro, March 31.—Needham Whitfield Outlaw, prominent Goldboro attorney, has announced his candidacy for solicitor of the Fourth District to succeed Clawson L. Williams, who is campaigning for the judgeship to succeed Judge F. A. Daniels. Mr. Outlaw was born near Outlaw's Bridge in Duplin county, and is a son of the late Needham Bryan Outlaw and Annie Whitefield Outlaw. Mr. Outlaw practiced law in Greenville for ten years and represented Pitt county in the State Senate. He is recognized as an outstanding lawyer and has been a loyal Democrat all his life. Friends state he has campaigned over eastern North Carolina for every cause that his party thought was for the best interest of the State.

CHILD FATALLY HURT WHEN STRUCK BY CAR

Albemarle, March 31.—Jimmie Helms, four year old son of Mr. and Mrs. J. Paul Helms, died at a local hospital this morning as the result of injuries received Thursday afternoon when struck by a car driven by Frank Patterson, Jr., Lenoir-Rhyne student. The accident occurred in front of the Helms' home. The child's skull was fractured and he received other injuries. Patterson is being held under bond pending an inquest tomorrow. Funeral services were held at Friendship M. E. church today at 2:30 with Rev. J. S. Anderson officiating.

BOY KILLER IS SENT TO TRAINING SCHOOL

Durham, March 31.—James McLean, 16, white boy held for manslaughter in connection with the fatal shooting of Walter Ashley, 23, on March 3, plead guilty in Superior Court this afternoon to assault and battery with a deadly weapon and was given a suspended bond sentence of two years provided he entered Eastern Carolina Training School. McLean is alleged to have shot Ashley in a scuffle over the possession of a revolver while Ashley is alleged to have provoked an argument over the youth's sister. Ashley died two weeks following the shooting of what hospital physicians termed a spontaneous hemorrhage.

EASTER

(By Harold Glenn Cutrell)

Easter brings to us a sense of victory over fear, the triumph of omnipotent love over material forces, the conquest of doubt, darkness, and death by spiritual truth and beauty, and the consolation that God is in His Heaven and guides the destiny of man to a wonderful fulfillment.

Easter brings to us the comfort and inspiration of Christ and His love for the human race, the majesty and sovereignty of the Son of God over the kingdom of death, and His beautiful and powerful message to the hearts of men:

"Let not your heart be troubled: ye believe in God, believe also in me... I am the way, the truth, and the life: no man cometh unto the Father, but by me... Peace I leave with you, my peace I give unto you... He that heareth my word, and believeth on him that sent me, hath everlasting life, and shall not come into condemnation; but is passed from death unto life... I am the bread of life: he that cometh to me shall never hunger and he that believeth on me shall never thirst... I am the resurrection and the life: he that believeth in me, though he were dead, yet shall he live; and whosoever liveth and believeth in me shall never die... In the world ye shall have tribulation: but be of good cheer; I have overcome the world... I am with you always, even unto the end of the world."

Christ is the Conqueror of fear and mortality, the Giver of hope, joy and abundant life. Fear is the valley of gloom in which dwell the dragons, furies, and harpies, that prey upon the thoughts, hopes and dreams of men. Fear is paralysis. Fear is the destroyer of life. Fear is the pernicious anemia of the soul destroying spiritual beauty and vitality. Fear is spiritual debility. Through Christ we conquer fear, and live the abundant and victorious life, the life of love, joy, and beauty.

Through Christ we conquer the principalities of darkness and the world, and enter into the immortal life, the life of greater usefulness and service. Easter is a time of rejoicing and praise because of the great eternal Fact of the Resurrection of Christ and the Immortality of the Soul. In Him we are immortal and indestructible vanquishers of time, space,

mystery, and physical and spiritual disintegration.

In his great oration, "The Prince of Peace," William Jennings Bryan speaks eloquently on the theme of Immortality:

"Christ gave us proof of immortality, and yet it would hardly seem necessary that one should rise from the dead to convince us that the grave is not the end. To every created thing God has given a tongue that proclaims a resurrection.

"If the Father deigns to touch with divine power the cold and pulseless heart of the buried acorn and to make it burst forth from its prison walls, will He leave neglected in the earth the soul of man, made in the image of his Creator? If He stoops to give to the rose bush, whose withered blossoms float upon the autumn breezes, the sweet assurance of another springtime, will He refuse the words of hope to the sons of men when the frosts of winter come? If matter, mute and inanimate, though changed by the forces of nature into the multitude of forms, can never die, will the spirit of man suffer annihilation when it has paid a brief visit like a royal guest to this tenement of clay? No, I am as sure that there is another life as I am that I live today."

Men and nations must realize that Christ is the solution to the problems and perplexities that vex the world.

"Christ or Chaos," said David Lloyd George. In Him is the way to peace and brotherhood. Without Him all is confusion, waste, strife, and futility. Men and nations must perish in their follies and fears and stupidities if they will not live in harmony with the Golden Rule of Christ.

Easter is a splendid time for meditation upon the truths taught by Christ, and a rededication and a consecration of the Will to His Kingdom of Love.

"O soul, faint soul, disquieted how long! Lift up thine eyes, for lo, thy Lord is near. Lord of all loveliness and strength and song. The Lord who brings heart-sadness better cheer. Scattering those midnight dreams that dote on wrong. Purgings with heaven's pure rays love's atmosphere."

Ballard's X Road

Past and Present

One hundred years ago there may have been no cross roads here, but where the Ballard house now stands there was an unpretentious dwelling occupied by Samuel Forrest, who later sold this land to his son-in-law Benjamin Briley. The latter lived one mile north of the cross roads on the farm now owned by the heirs of Mrs. Mary A. Joyner. Mr. Briley was a man of sterling worth who accumulated a large property. He sold his lands in this community, moved to Greenville, engaged in the mercantile business and kept a tavern, where we would now call a hotel. Subsequently he moved into the country on the plantation later owned by Mr. Charles Rountree, now owned by the heirs of Mr. Robert Allen. Mr. Briley is buried on this farm—his only monument a substantial iron fence erected.

Prosperity For U. S. Milk Farmers Aim Of New AAA Plan

Washington—(AP)—Regulation of a \$1,800,000,000 industry with restoration of prosperity to 4,000,000 cow-owning farmers is sought in the agricultural adjustment administration's \$185,000,000 plan of many

parts for milk and milk products. Largest single division of American agriculture, the milk cow in 1932 returned to the farmer about one-fourth of his total income, and even in the four depression years of 1929-32 yielded an average income of \$1,800,000,000 a year.

But the industry has come upon evil days. Without an exportable surplus the industry has been protected by a tariff. After the war farmers could not shift their surplus agricultural plant into dairy production as easily or quickly as they could into wheat, cotton or tobacco production. Feed costs were favorable. As a result, the position of the dairy farmer before the depression was better relatively than that of other farmers.

There was, however, a gradual shift into dairy production. Dairy men helped this process by advertising the profits to be made from cows. The number of milk cows in 1933 was about 26,000,000 an all-time high, 18 per cent greater than in 1928. Milk production climbed from 87 billion pounds in 1924 to nearly 107 billion in 1932. Manufactured milk products also increased, but consumer expenditures for these products decreased 5 per cent in 1933. Cash income of the industry fell off to \$985,000,000 in 1932.

The administration set up a milk marketing agreement in Chicago last August 1. By December 1, 13 others had been put into effect. But they did not work so well and new agreements were substituted. In parts of the country milk riots and strikes broke out.

A senate investigation of the Washington, D. C. milk problem led to charges of "milk trust" and demands in congress for a nation-wide investigation by congress or by the federal trade commission.

Divergent views within the industry have made a plan difficult, with many elements opposing an attempt at production control. A group of cooperatives, some of whom Secretary Wallace has criticized as "distributors in overalls," are opposing the new milkshed agreements and the proposed new national plan.

The new plan calls for a processing tax of one cent a pound on butterfat content, gradually to be increased to five cents.

No reduction of output below present low winter month levels is planned, but cooperating farmers are to be asked to cut their sales from 10 to 20 per cent below their 1932-33 averages.

For each pound of butterfat, reduced the farmer would get a benefit payment of 40 cents; for each 100 pounds of surplus fluid milk reduced the payment would be about \$150. About \$225,000 is to be set aside to advise the farmer on the best methods of reducing his production.

At least \$5,000,000 is to be used in buying healthy, good-producing cows in surplus dairy regions to be distributed on easy credit terms to cowless farms. The 1930 census showed that about 1,500,000 of the nation's 6,000,000 farms have no cows. About 68 per cent of the cowless farms are in the south, where milk consumption, even in rural regions, is sub-normal.

Another \$5,000,000 is to be used to speed up eradication of bovine tuberculosis. There are about 600,000 tubercular cows in the country, it is estimated, and it would cost about \$40,000,000 to eliminate all of them. States already have set aside about \$9,000,000 for the purpose.

Because a processing tax may increase the price of butter five cents a pound and the price of milk one-half a cent a quart, \$5,000,000 is to be used in distributing milk to needy children in cities to offset a possible decline in production.

Chicago, March 31.—(AP)—Cotton was more active today at Chicago the only cotton exchange open. Final prices on the board of trade were four to nine points net higher.

SPORT SLANTS

By ALAN GOULD

Undoubtedly there has been some sly snickering, here and there as the sport fans have read in the papers that neither Glenn Cunningham nor his coach Bill Hargiss was "satisfied" with that epochal 4:08.4 indoor mile the Kansas flier ran in the Knights of Columbus games in New York.

After all, the lay fan might reasonably philosophize, it must have seemed just a bit thick for Glenn to walk into his dressing room after that performance—second fastest mile ever run by man and by far the fastest indoors—only to encounter something like this:

"Very good, Glenn, only you should have done 4:06."

And when it is further reported that the Elkhart flier nodded his complete agreement with that view, it's likely to seem a bit thick to the reader, too. In other words, a few soft "Oh, yeahs?" probably split the atmosphere.

However, with the accumulation of post-mortem material on the great event there seems to be plenty of sound reasoning back of the "disappointment" of both coach and athlete that a still greater mark was not achieved.

Hargiss, after pointing out Cunningham's revolutionary self-developed system of running faster second halves on his miles that first halves, explains why it wasn't unreasonable to vision two seconds lopped off the 4:08.4 effort.

"I believe, along with many other coaches, that rhythm is the secret of record races," he said. "Glenn, who has always defied tradition by running his second halves faster than the first halves, runs the first 880 as fast as he can without straining the rhythm of his stride—then he has his body prepared for the big drive."

"In the Columbian mile he could have clipped two seconds off his time for the second quarter without affecting it in the least his final two quarters of 61.2 and 59.8."

"I am sure of this because when Frank Nordell of Manhattan, after pacing the field perfectly through a 62-second first quarter, slowed down to 65 seconds for the second, Glenn actually had to chop his stride to avoid treading on Nordell's heels. Keeping to the stride and rhythm he had already established would have taken no more energy from him than this adjustment effort."

Faster, Faster, Faster
Cunningham insists that the "faster second half" scheme is the natural one for him, though it is contrary to virtually all foot-racing teachings.

He's a student of physical education and has gone into the mechanics of running with usual avidity, yet he admits it is impossible to chart a runner's capabilities scientifically and accurately.

"I don't know what goes on inside of me in the matter of burning up and rebuilding of tissue during the running of a fast mile," he said. "But from my running experience I know that I need a good warm-up run faster and better in a second race, and still better in a third race on those afternoons when I run in three events."

Which explains another thing for fans inclined to scoff. That is, the usual routine of neck-jerking, body-bending—exercises Glenn always indulges in for an hour or so before his big indoor appearances. Many though it was grandstanding, but it's just Cunningham's way of running a few preliminary miles!
