LABOR BOARD ANNOUNCES END OF AUTO STRIKES

Firm Boosts Stocks with Billion Dollars Obtained from Investors

SENATE BODY REVEALS BIG 'BOOM' DEAL

Cities Service Company Spent Tremendous Sum Obtained From Public Investors to Maintain Price of its Stock; Counsel of Federal Trade Commission Tells of High Pressure Sales Methods

Washington, April 5.—(AP)—Evidence that Cities Service Company obtained more than a billion dollars from American investors during the boom days and used most of it to maintain the price of its stock was before the senate banking committee today.

As it began a drastic revision of the stock market bill in executive session, the committee made public testimony given it in private by Robert Healy, chief counsel of the Federal Trade Commission.

Healy said the utility company had \$1,146,518,000 from investors from 1927 to 1930 and \$965,000,000 of it to keep up the price of the stock.

He told a vivid story of a high pressure sales campaign conducted by the company while it maintained the market price by market operations. The market regulations bill would end such practice, he said.

TO ENFORCE TRAFFIC LAWS

Police Department Declares War on Various Types of Violation Here

A drastic campaign to eliminate violations of traffic regulations in Greenville was inaugurated by the police department today.

Chief of Police George Clark called attention to the various types of violations which have been taking place in the city the last few months, and declared emphatically that the law would be strictly enforced in the future with violators being carried into court and fined.

He directed attention specifically to the parking of trucks in the center of streets for the purpose of delivering merchandise. This has caused considerable congestion and complaints in the crowded business districts as well as residential sections.

The police head said that trucks making deliveries in the future would be required to go to back doors.

Youth Drowns Near Morganton

Morganton, April 6.—Earl McGimsey, 16-year-old son of Horace McGimsey, of Morganton, was drowned late Wednesday afternoon in Hunting Creek, near the point where the creek empties into Catawba River, about three miles from Morganton. With a group of boys he was fishing for catfish when the bank caved in and he was thrown into the creek, probably 15 feet deep where they were fishing. The body was recovered within an hour and a punitor used ineffectively in an effort to revive him.

HEARING ON RIVER SET FOR THUR. APR. 26

Government Engineers Order Public Hearing On Opening Tar to Navigation

A public hearing has been ordered by government engineers to be held in Greenville Thursday April 26, at 10:30 o'clock for the purpose of reviewing data relative to the opening of Tar river to navigation. The meeting will be held in the Library building.

A bulletin received today from the office of Eugene Reynolds, district government engineer, said oral statements would be heard at the hearing but that for the purpose of accuracy all important facts and arguments should be submitted in writing.

Re-examination of data on the river was ordered recently by Congress at the suggestion of Congressman Lindsay Warren. The matter was brought to the attention of the Congressman by the Eastern North Carolina Association, Inc., local organization, which at this time is collecting data required by the engineers.

It is estimated by the association that deeping the river from here to Washington would save the shippers. (Continued on Page Four)

BANDITS SACK KINGYU, CHINA

Torch Applied to Walled City After Looting and Ravaging of Populace

Shanghai, April 6.—(AP)—Laying siege to the walled city of Kingyu, 300 miles north of here, 2,000 Chinese bandits scaled the walls looted and ravaged the populace and applied the torch to the town, reports reaching here today said.

The renegade mongolian general Li-Kwei Tang, known as China's most sensational bandit leader, commanded the tattered outlaw horde which scaled the walls with ladders carrying flaming brands.

Like medieval armies which once sacked Europe's "embattled" towns with catapults and fiery arrows, Liu's forces went out of the mountain fastnesses of Shantung province to within easy traveling distance of Shanghai, one of the world's most modern cities.

FUNERAL FOR WINTERVILLE CITIZEN HELD

Charles McLawhorn Laid to Rest at Home Place Near Winterville Today

Funeral services for Charles McLawhorn, 71, prominent Winterville citizen, were held today at 1:30 o'clock and interment was made in the family burying ground near his home place. The final rites were conducted by Rev. R. P. Pittman, Free Will Baptist minister of Ayden, assisted by Rev. J. B. Mye, pastor of the Rev. Branch church, and Rev. E. H. Canaday, pastor of the Ayden Baptist church.

Mr. McLawhorn, who spent all of his life in the community where he died, succumbed to a heart attack yesterday morning. He had been sick about ten days but was out Sunday and again dressed and went out into the yard yesterday morning. He died shortly thereafter.

The funeral was largely attended and a profusion of flowers told in mute way of the love and esteem of countless friends in this and other parts of the state.

He spent all of his life in the agricultural development of the Winterville area. He was a large landowner and confined his attention mainly to development of this property.

His sudden death was received with pronounced shock throughout the community where he was greatly beloved for his generosity nature.

DEATH STALKS PUBLIC ROADS

Nine Persons Killed in Series of Accidents In This Patrol Division in March

Death stalked the highways of this highway patrol district during the month of March and claimed the largest toll of life in the history of the patrol, it was made known today in the monthly report of Lieut. Lester Jones, head of the division.

The death list was given as nine with forty-one listed as injured. Not only the death toll, but the number injured was the most staggering in department records and indicated the lack of proper observance of traffic regulations.

The report showed the arrest of twenty-eight drunken drivers, by far the largest number taken into custody in recent months and indicating that drivers are not only failing to take precautions for their own safety but endangering the lives of thousands of others along the highway.

The report showed a total of 121 arrests with 109 being found guilty. They received total sentences of 92 months either in jail or on the roads.

The number of violations handled by the department was listed at 1,034 with 77 persons being warned for parking on the highways. Seven reckless drivers were taken into custody by patrolmen along with 9 drunken persons for being drunk on the public highways.

CHILD SLOWLY IS TURNING TO STONE IN WAYNE

Goldsboro, April 6.—(AP)—The name of two-year-old Levi Thompson of Wayne county was added today to the rolls of those medical science is attempting to save from unnatural death, for Levi is slowly turning to stone.

EDUCATION CONFERENCE HERE APR. 13

Statewide Conference Scheduled For Teachers College Two Days This Month

The theme for the State-wide Educational Conference to be held at East Carolina Teachers College next week, April 13 and 14, is "Education for the New Social, Political and Economic Order." The object of this year's program is to solve in some measure the vital problems which confront the public schools in their effort to prepare the children of North Carolina to meet the demands of the new order.

A representative group of people actively engaged in school work and others interested in the educational problems of the state will gather to discuss these problems.

An excellent program has been prepared with two general sessions and with round table discussion group meetings, each under able leaders. There will be two groups one composed of those most interested in administrative problems, county and city superintendents, and the other of those interested chiefly in internal school problems, principals, supervisors and classroom teachers.

The conference will open at 3:30 Friday afternoon, April 13, with a brief general meeting in the Austin Auditorium, when M. K. Fort will preside and give the announcements. The round table conference groups will meet at 3:45 and again the next morning at 9 o'clock.

In the evening at 7:30 a general meeting will be held in the Austin Auditorium which will open with special music and addresses by President R. H. Wright and Dr. W. O. Hampton, principal of the New Hanover high school. The public is especially invited to this meeting. The final meeting on Saturday morning will be a general meeting when there will be summaries of the work done in conferences. A large attendance is anticipated.

Late News Flashes From Over World

Unemployed Riot. Minneapolis, April 6.—(AP)—Three thousand unemployed milled about blood spattered sidewalks today after authorities had repulsed onslaughts against the city hall and court house. Eighteen were injured. Twenty-five others were in jail. Machine guns were mounted near the entrance of the city hall and courthouse as authorities strove to restore order among 3,000 unemployed who rioted there about 10 o'clock.

Four police and a woman were injured, none seriously. Chief of police Michael Jones earlier had said he would accept the request of a group of judges and ask for aid of the national guard in restoring order.

With establishment of machine gun positions and the advance of a detachment of police into the streets the temper of the crowd died down. Traffic was paralyzed on all four sides of the building started moving slowly with traces of tear gas from bombs flung back and forth between police and rioters still hovering in the air.

TWO MORE HATS FALL IN 'RING'

He was elected in 1918 and has served continuously since that time. Several times he has led the county ticket and the only time he has had opposition was in 1924 and 1926. He is opposed by Vance Perkins of Greenville, who announced the first of the week he would seek the office.

The first candidate to fling his hat into the ring for a seat on the Board of County Commissioners is Frank Kilpatrick of Ayden, who announced this morning he would try for a place on this powerful body.

With several candidates in the ring for other offices, it was expected the political pot would put on so much steam during the next month or so that it will be difficult for the kettle to stay on the fire. At least the public is assured of plenty of material to choose from.

MRS. MASSIE ATTEMPTS TO KILL HERSELF

Principal Figure in Honolulu Murder Case Jumps From S. S. Roma

Genoa, Italy, April 6.—(AP)—Ship's officers of the S. S. Roma said today that Mrs. Thalia Portecue Massey, principal figure in the sensational Honolulu assault case of 1932 attempted suicide by lashing both wrists and throwing herself from the liner's top deck on the voyage from New York.

Professor Dario Borello, director of the nervous ailment clinic in Genoa, where Mrs. Massey has been taken, since the ship's arrival yesterday, confirmed the officers report.

The director said that Mrs. Massey told him she attempted suicide when the steamer was three days out of Genoa because "I wanted to die I regretted having to get a divorce from my husband."

Mrs. Massey and Lt. Thomas Massey U. S. N., were divorced at Reno February 21. Dr. Borello told the AP she would have to remain in the clinic from 2 to 4 days before she could recover completely.

Ship's officers said Mrs. Massey threw herself from the top deck but that they did not know whether she intended throwing herself into the sea or only on a lower deck.

Order Records In Cannon Case

Washington, April 6.—(AP)—The House today adopted a resolution authorizing South Trimble, clerk to submit records in the trial of Bishop James Cannon, Jr., April 10 here on charges of violating the federal corrupt practice act.

Trimble was subpoenaed to appear at the trial with the records showing how much Cannon and anti-S. Burroughs, treasurer, of the anti-Smith organization in Virginia, reported they received and disbursed in 1928.

Cannon and Miss Burroughs, his secretary, are charged with reporting only \$19,000 of \$60,000 received from E. C. Jameson, New York financier.

House action was necessary to let Trimble take the records to the District of Columbia supreme court.

Senators Will Attempt To Increase Estate Taxes Sharply For The Future

Washington, April 6.—(AP)—Senators who want to redistribute wealth concentrated today on a drive to increase the estate taxes sharply.

Beaten back in their move to hoist income taxes to war time levels liberals from both political parties turned their "heavy-levies" on the rich" campaign to the support of the LaFollette's estate transfer amendment.

The plan for which Senator LaFollette sought approval today called for rates from 27 to 60 per cent on estates valued from \$1,000,000 to more than \$10,000,000.

The senate finance committee of which Senator Harrison of Mississippi is chairman favored rates of 30 to 50 per cent. Under existing law the rates are 19 to 45 per cent.

Harrison told the senate in his report that even under the committee plans the new levies would tend to prevent undue accumulation of wealth.

Harrison's committee has yet to be defeated on the floor in any of the scores of revisions it made in the \$330,000,000 tax bill after the house sent it to the upper chamber. Harrison has indicated he would probably accept a compromise on the LaFollette amendment and let it go to conference with the house.

TWO WHISKEY STILL TAKEN

Eight Gallons of Liquor and Considerable Beer Captured in Fountain Area

Sheriff's officers today reported the capture of two whiskey stills, eight gallons of whiskey and a thousand gallons of beer.

One of the plants, a copper affair was in operation but the stills spotted the officers in time to make their escape. It was there the liquor and beer was located.

The other plant, a steam still, was not in operation. Officers destroyed both stills along with the beer and liquor.

It was stated that the copper plant was located in a fairly open place where the distillers had a good view of the land for a mile or more and this accounted for their ability to make their getaway in such a quick manner.

Although numbers of similar captures have been made in recent months this is probably one of the most important lately in view of the size of the plants and amount of paraphernalia seized.

Sun Kissed Chorus Girls Taboo. Melbourne.—(AP)—Chorus girls have been warned that sunbathing on this city's beaches is taboo because star lights make their skins look even darker than the sun actually has burned them.

THOUSAND ON RELIEF ROLL

New Burn, April 6.—Nine hundred and forty-five applicants have applied for work on the Federal government's rural rehabilitation program in Craven county according to a survey of rural relief cases and gardens made by H. D. McLawhorn, of this city.

Seven hundred and twelve of the applicants are white. Of the whites 85 per cent are tenants in the rural areas, whereas only 45 per cent of the colored applicants are tenants.

Although 99 per cent of the 945 applicants are on direct relief, the number is considered small, because during 1933 the case load of the welfare department was approximately 1,900.

Of the applicants, 295 ask for cows, 469 for hogs, and 536 for chickens. They already possess 863 gardens, the average size of which is three-eighths of an acre.

FRENCH SOCKS HOLD ONE THIRD OF NATIONS COIN

By JOHN EVANS Paris (AP)—Half enough money to run the whole government of France for a year is hidden away in the good old "woolen sock" of the thrifty Frenchman. There can be no statistics on hoarding, but the Bank of France and the government calculated fairly closely how much money is in the banks, in circulation, and how much is abroad. The remainder is what the French have put away for "safe keeping" in tin boxes, bottles and jars, hidden in every conceivable way. Close to one-third of France's money is estimated to be in hiding. The last official statement on the subject was by George Bonnet, then Minister of Finance, December 9, in the chamber of deputies. He said \$25,000,000,000 francs or \$1,650,000,000 were hoarded then when the circulation was \$1,000,000,000. Bank of France officials thought the figure high, and since then they have asserted part of the money has come out of hiding because big hoarders were tired of getting no interest. Robberies of these hoards seem to be few. French peasants, secretive by nature, have learned to guard their fortunes.
