## DR. WIRT NAMES PERSONS AT 'BRAIN TRUST' FEAST

### Heard Talk Of Communists At Dinner In Va.

#### TESTIFIES AT INQUIRY BY HOUSE BODY

Witness Tells Committee He Heard Talk of Revolution While Attending Dinner Near Washington; Says Roosevelt "Brain Trusters" Plotting to Bring Communism to America

Washington, April 10.—(AP)—Dr. William A. Wirt testified today in the house investigation into his "brain trust" charges that five persons were present at a dinner when he first heard assertions of a plot under way to bring communism.

He gave the names of Robert Bruce Lawrence, Fred Hildebrand, and Mary Taylor, Alice Barton and David Cushman Coyle. Chairman Bulwinkle of North Carolina, asked Dr. Wirt where he first heard "brain trusters" talking about a revolution.

"From a group of individuals at a dinner in Virginia, near Washington," Wirt answered referring to cards on which he had closely written notes.

"When was that?" Bulwinkle pursued.

As a hush settled over the more than six hundred persons in the committee room, Wirt replied.

"As I remember, it was Friday evening September 1."

"Who was present?" the chairman asked.

The names followed.

Dr. Wirt previously testified in the investigation of his allegation that some Roosevelt brain trusters are plotting to bring communism.

He was represented by former Senator James Reid, of Missouri as counsel. The committee voted to let him appear after ruling to the contrary.

#### CRAZED MAN SLAYS WIFE AND MOTHER

Joe Barry of South Carolina Taken Into Custody at Bamberg Early Today.

Bamberg, S. C., April 10.—(AP)—Joe Barry, 45 year old farmer, was arrested here today after an extensive hunt since late yesterday by officers who charged him with killing his wife and mother-in-law at their home near Batesburg.

Officers said Barry had shot the women to death in a fit of anger reporting they could learn nothing that precipitated the affair except there had been a quarrel.

Sheriff T. J. Hadwin and policeman J. W. Price said Barry was drunk when they arrested him.

#### SYKES SPEAKS AT INTER-CITY ROTE MEETING

District Governor Says Danger to America is From Inside not Outside

The politicians and diplomats have created a world which has got out of hand. The danger for America is not from outside but inside," said Tom Sykes last night in his address "The Future of Rotary" before the over one hundred Rotarians and their guests gathered in an inter-city meeting in the Greenville Rotary Club building. A one hundred per cent attendance from the Farmville club and large delegations from Washington and Ayden, besides the one hundred per cent attendance of the Greenville club were present.

"Bernard Shaw, Bertrand Russell and H. L. Mencken of the school of 'cock-sureness' would have been days without column material if they had not had Rotary ethics to poke 'fun at. But now that this group has been completely deflated, and all of us have come down to earth, Rotary ethics and principles will come in and contribute to the world's salvation collective sanity, decency and cooperation.

"There must be a change of hearts along the line of Rotary ideals before we can have a changed social scene. Secretary of Agriculture Wallace and Roosevelt are sounding the need of an ethical code first suggested by Rotary," Mr. Sykes declared. "America has more resources than our ancestors who returned to a ruined country after the Civil war. They had nothing left but faith in God and faith in each which was manifested in old fashioned neighborliness. Yet people think this country is at the bottom.

"We have been giving a spineless presentation. We are the posterity our fathers worried about—and they should have from the mess we have made. Our spirit is wrong. We have forsaken God. He has not forsaken us, as people are saying.

"Think of the problems of life. We are going to come down to earth before we can 'come through.' There are still a few who must be deflated. The crowd has come down to their real place now. We are humble in High Point. Come to see us sometime. We will not high-tail you. We are down to earth."

The inter-city meet was opened by the singing of a few of the old familiar songs, led by Bill Lee and accompanied by Mrs. Ray Tison, the club pianist, as they gathered about the festive board. (Continued on page Three.)

#### HEALTH DRIVE HALTED HERE

Only 451 of 4,000 Contemplated Sanitary Privies Constructed in County.

The termination of CWA activities in Pitt County on March 23 brought to a close one of the most worthwhile public health programs ever undertaken on a county-wide basis, for with the passage of the Civil Works Administration into history there was brought to a standstill the pit privy construction work that has been underway for the past several months.

The pit privy construction activity has done much to advance the cause of public health, not because of the actual number of privies constructed to date for many more of them are needed, but because the people have become conscious of a need for greater cleanliness of the premises of individual households and for improved community sanitation as well.

In becoming conscious of a need for a better sanitary environment, the individual or the community is taking the first step in the great war against disease.

Since the inauguration of CWA activities in De-ember, there have been built throughout the length and breadth of North Carolina something over 35,000 pit privies. Truly a remarkable achievement. However, only one-tenth of the job of sanitizing rural homes has been done since conservative estimates place the number of rural homes in the state (Continued on page Two.)

#### Late News Flashes From Over World

Washington, April 10.—(AP)—Naming "brain trusters" and their satellites in his informant, Dr. William A. Wirt indicated today that he traced back to Dr. Rexford Guy Tugwell, assistant secretary of agriculture, his conviction that a plot exists to overthrow the social order.

For two sensation-studded hours he recounted his fears to the House probe committee while massed crowd followed his words.

The story ended with the Indiana educator unable to complete his testimony today, suggesting that the committee summon Lewis Douglas, budget director, and W. I. Westervelt, Chicago business man, formerly with the Farm Administration.

They, Wirt asserted, could throw more light on the alleged plot to bring communism.

#### COMPROMISE NEARING ON COTTON BILL

Conferees Hope to Speed Control Measure Back to Congress For Action

Washington, April 10.—(AP)—With one of the major Senate amendments to the Bankhead cotton control bill already tossed into the discard conferees today hoped for an easy compromise to speed the measure back to the House and Senate for final action.

Little bickering was required to discard the Senate amendment that would exempt from tax provision fixed bales of cotton for every farmer. Advocates have contended this would destroy the usefulness of the control measure.

#### WILL RESUME PUBLIC WORKS IN TWO WEEKS

CWA Projects Abandoned Here 2 Weeks ago to be Completed under New Program

Work on CWA projects suspended in this county about two weeks ago will probably be resumed within the next two weeks, it was made known today from the office of K. T. Futrell, who has been directing these activities here.

The work will be completed under rural rehabilitation and urban work programs which will supplant the CWA. Mr. Futrell said people in various communities where uncompleted projects exist should not be worried over suspension of activities, that they would be completed in due time.

E. L. Winslow, federal engineer of Washington, was here yesterday conferring with Mr. Futrell regarding completion of Pitt County projects. A complete survey must be made of all projects to determine what will be needed to complete them, Mr. Futrell stated.

The county director stated that every effort would be put forward to push rural rehabilitation activities, and that while not as many men probably would be used in either program as employed by the CWA a sufficient number would be placed on the jobs to complete them as early as possible.

The swimming pool and several school projects were involved when the CWA disbanded, but Mr. Futrell said he felt sure sufficient funds would be provided the county to complete the work in Greenville, as well as projects in all parts of the county.

#### BAKER HEADS AIR INQUIRY

Former Secretary of War Will Direct Investigation Into Army Tragedies

Washington, April 10.—(AP)—Newton D. Baker, war time secretary of war, today accepted appointment as chairman of the army air corps investigating committee on which Col. Charles A. Lindbergh declined to serve.

Secretary Dern announcing the acceptance of five other civilians to assist army generals in making the military aviation inquiry, said the first meeting would be held here the later part of this week or the first of next.

The investigation, planned by the war department itself, stepped into national focus following a list of tragedies suffered by the army air flyers flying the mail.

#### U. S. CRIMINAL DOCKET SHRINKS

New Bern, April 10.—"If there happened to be anyone in Craven county who did not know that the prohibition amendment had been repealed, he would certainly have found it out yesterday from a look at the opening of the April term of Federal Court." Judge I. M. Meekins of Elizabeth City, told the grand jury in informal remarks that took place of a formal charge.

There were fewer persons at the court opening than had been reported for years, and the criminal docket has shrunk so much in size that civil suits were started Monday afternoon for the rest of the week's term. The grand jury returned three true bills, then was dismissed after two hours service.

#### SAYS CANNON FUND SPENT 'PROPERLY'

Attorney For Bishop Declares Campaign Fund Spent Under Board Management

Washington, April 10.—(AP)—Robert H. McNeill, attorney for Bishop Cannon, Jr., told criminal court jury today "that every dollar of the unreported part of a 1923 presidential contribution to the churchman was spent under management of the Virginia state anti-Smith committee.

He referred to a \$65,000 contribution made by Edward Jameson, N. Y. insurance executive for the Southern Methodist churchman's use in his effort to defeat Smith for the presidency.

Bishop Cannon and Miss Ada Burroughs, who was treasurer of the Virginia committee are on trial charged with failure to report the entire contribution.

The government contends only \$17,300 of the amount was reported to the clerk of the House under the Federal Corrupt Practice act.

The remainder was spent in Virginia, McNeill said, and Jameson was so advised.

He told the jury that the question before it was not whether the money was misused which the government counsel said yesterday will be shown. "The only thing you have to consider," McNeill said "is was there a conspiracy to hide it?"

#### SLIM CHANCE OF FINISHING MEASURE NOW

Democratic Leaders Believe Controversial Measure Will Have to Wait Until Next Session of Congress; Wagner Pleas-ed With Commendation From Hugh Johnson

Washington, April 10.—(AP)—Democratic leaders held privately today that the chances for completing the controversial Wagner labor board bill at this session were slim.

Senator Wagner of New York, author of the measure which would outlaw employer dominated company unions held to the view that the legislation had a fine chance of enactment.

The New York Senator was particularly pleased by what he said was the okay placed on the bill by Hugh Johnson, NRA administrator before his departure for the south yesterday to confer with President Roosevelt.

In a letter saying "a series of misadventures" had prevented his appearance at the hearings on the bill Johnson said he wished Wagner "every success with your bill."

The blue eagle chief made the flat declaration that he favored continuance of the national labor board which the bill would make permanent saying "we must have a supreme court of industrial relations."

#### MANY SEEKING JOBS IN CAMPS

New Bern, April 10.—Coming from a wide radius, 247 applicants for CCC jobs during the third period were examined and enrolled here yesterday.

After preliminary training at Fort Bragg, they will be assigned to different CCC camps, including the new one at Fort Macon. In charge of the enrollment was Staff Sergeant Herman E. Rader, of Fort Bragg, with five assistants.

#### WHITEHURST FOR SHERIFF

Present Incumbent Announces His Candidacy for Re-Election to Office

Another hat dropped with a resounding smack in the political ring today. It was the new spring hat of Sheriff Sam Whitehurst, who announced his candidacy for re-election to the office he now holds.

If elected, the sheriff said, he would continue to render the high type of service that has marked his administration the last four terms. Sheriff Whitehurst will be opposed by Richard (Dick) King who several days ago announced that he would be a candidate for the office.

The sheriff has a long record of service behind him as a law enforcement officer. He served as a deputy sheriff three and a half years before being elected sheriff and as chief of police of Ayden for a year. Later he was a member of the police force in Greenville. He served with the army for six years and saw 18 months of service in the World War. He returned home shortly after being discharged from the army and entered the law enforcement game which resulted in his election to the high office he now holds.

Sheriff Whitehurst said he would seek his fifth term on the basis of his achievements the last four years and asked support of his constituents on the strength of this.

by privy projects. The average number of workers for the period would probably be around 2,300 or only 17 1-2 per cent of the number authorized by the privy projects. With so few workers, 35,000 privies have been constructed.

In Pitt county a CWA project providing for the construction of 4,000 privies was approved, but of that number only 451 were completed. Much, therefore, remains to be done.

Typhoid fever, dysentery, "summer complaint," and other intestinal diseases could be largely eliminated by safely and adequately disposing of human excrement, which is the source of these diseases. Pitt county should see to it that the privy construction work is continued until every home in the county is provided with a safe means of human excreta disposal.

The construction of sanitary privies as a function of the CWA has been under the direct supervision of the North Carolina State Board of Health. This state agency was entrusted the task of organizing and training crews of workers in the many counties, and the fact that 35,000 privies have been completed is splendid testimony as to the efficiency of this state department.

The work in Pitt county has been under the direct supervision of Mr. C. C. Martin and L. H. Johnson.

Junior 'Gold Rush' Oroville, Cal. — (AP) — School boys have turned their attention to constructing portable "rockers" and "sluice boxes" to earn spending money by washing gold from creek beds. Working after school, boys of 10 and 12 years have reclaimed gold enough to start a juvenile stampede.

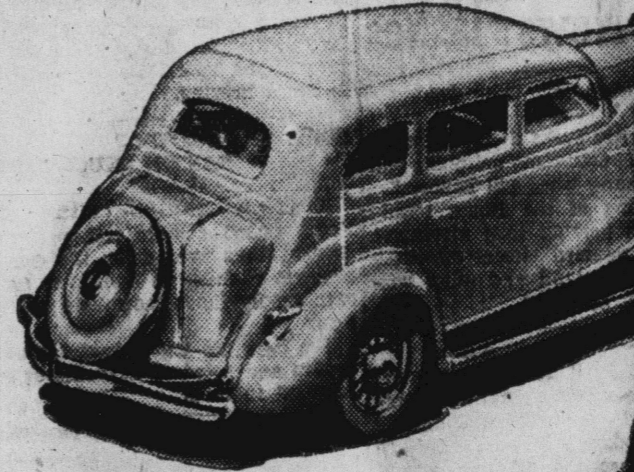

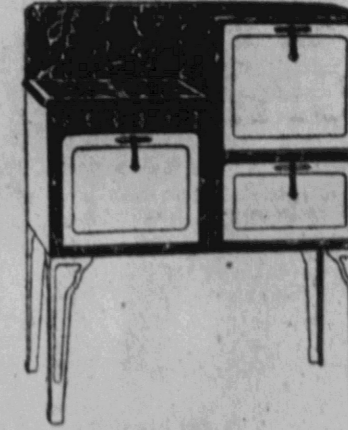

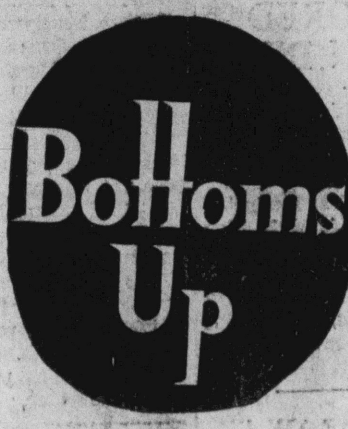
