RIVER HERE NEARS CREST

Tar Expected To Reach 17-Foot Stage Here Tomorrow; Near 15 Feet Today

The angry waters of Tar river were rampaging through lowgrounds north of Greenville today, sending livestock of all description scampering to higher ground.

The stream, according to a warning sent out by the State Weather department the middle of last week, will rise 17 feet before reaching its crest. The highest point is expected to be reached by Tuesday.

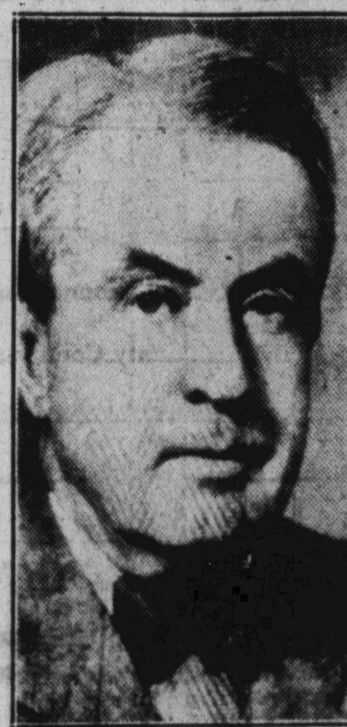
B. T. Clark, local government weather observer, said this morning that the flood water stood at 14 feet 7 inches and was still rising.

He expressed belief, however, that the 17-foot mark would not be reached in view of the fact that the stream was rising much less rapidly than yesterday.

Heading the warning last week, farmers having livestock in the low-grounds drove it to safety in lane to escape the flood waters and no loss of life of any consequence had been reported here today.

Hundreds of people crossing the river yesterday were surprised at the rapid rise of the stream, which for the last several months had been the lowest in years. In fact, during most of the winter the water was so low that the river bottom could be seen in numbers of places.

CLUBMEN TO CANVASS FOR BOOKS FRIDAY

Kiwanians Make Effort To Increase Stock of Sheppard Memorial Library

A canvass of the city for books for Sheppard Memorial Library will be made by members of the Greenville Kiwanis Club next Friday afternoon from 4 to 6 o'clock. It was stated today by Dr. R. S. McGeachy, president of the organization.

The movement to raise more books for the library was inaugurated at the regular meeting of the club last Friday night with contributions of a number of volumes by members of the club themselves.

The Kiwanians will canvass both the business and residential districts during the two hours and groups were to be assigned to certain districts during the next day or so.

Dr. McGeachy said the need of more books at the library was imperative, especially for the children's department and persons desiring to contribute to the cause, either with books or money, are asked to have their contributions ready when members of the committee call upon them.

The canvass will be one of the most intensive probably ever staged here and virtually every member of the club that can will be placed in service, the club president said.

During the observance of "Library Night" by the Kiwanians last Friday, Dr. G. R. Combs, pastor of Jarvis Memorial Methodist Church, called attention to the fact that although the library has a capacity of 20,000 volumes only 5,000 books were on the shelves.

He stressed the necessity of more books for children, if the various reading clubs conducted during the summer months to improve the cultural and intellectual standards of the children are to continue to be improved.

Because of the shortage of books in the children's department, Dr. Combs stated that the circulation of the library will be cut sharply during the present year.

Anybody desiring to give to the cause before the date of canvass are urged by Dr. McGeachy to get in touch with Charlie Parsons, chairman of the Objectives committee, who will send for contributions.

This is the first time that a concerted movement to increase the stock of the library has been conducted in recent years and hope was expressed by members of the club that everybody able to do so would give freely. Members of other organizations desiring to aid in the canvass are asked to confer with Dr. McGeachy or Dink James, president and vice-president, respectively, of the club.

NEGRO HELD IN CAR WRECK

Cleveland Little Jailed Here For Driving Drunk after Running Into Car

Cleveland Little, Greenville negro, was held in jail here today charged with driving drunk and running into an automobile last night driven by W. O. Crisp, who resides near Greenville.

The negro will face hearing at the next sitting of County court to convene following the two-week term of criminal Superior court which opened here today.

Both cars were badly damaged when they collided on the Greenville New Bern highway, four miles from Greenville, last night about 9 o'clock. State highway patrolmen, who investigated the wreck, said Little had been drinking heavily and was drunk when they took him into custody shortly after the wreck occurred.

The negro was brought to the county jail and locked up. He would have faced hearing in county court tomorrow but the case will be delayed a couple of weeks by reason of the fact that the regular weekly sitting of the court has been postponed until superior court adjourns.

CONGRESS IS NOW FACING SILVER BILL

Legislation Said by Speaker to be Contained on Administration Program

Washington, April 16—(AP)—Speaker Rainey told reporters today that silver legislation is included in the administration's program for this session of congress.

The speaker recently issued a statement urging representatives to agree on a silver bill. He said then he would see that the house was given a chance to vote on it.

"You can say the president is just as much for silver as I am," speaker Rainey told the reporters today.

But he questions the advisability of going ahead with any legislation now.

He prefers to continue the present power under the London conference agreement.

The speaker said he understood the Treasury was buying all newly mined United States silver and that all silver producing countries, Canada, Peru, Mexico and Spain were doing likewise.

ROOSEVELT NOT THROUGH WITH SOLONS

President Plans Ask Congress for Additional Legislation This Session.

Washington, April 16—(AP)—President Roosevelt has let congress know in a series of week-end conferences what he wants to do, what not to do and when to go home.

He told congressional leaders over Sunday among other things that he shortly would hand them a new request for a billion and a half dollars war relief work.

He told them he wants a stock market regulation measure with teeth and not the kind offered by the Fletcher-Rayburn circle.

He indicated willingness to sidetrack if necessary some of the less important items of the administration in order to obtain adjournment by mid-May but that these things be no sidetracking of those things he regards as vital to his program.

Listed in the immediate class are: Reciprocal tariff revenue and bankruptcy, federal insurance on bank deposits and relief measures.

The \$1,500,000 relief bill which was forecast in the president's budget message in January will include several provisions for housing program and \$600,000,000 for public works to aid employment.

The chief executive was described by House members as only opposed to the Connery compulsory 30 hour week bill, the Lomke-Frazier farm mortgage refinancing and inflation measures and the proposition for the federal government to pay off depositors in closed banks.

JACK EDWARDS IN RACE AGAIN

Representative In Last Legislature Will Seek Re-Election Here in June

Hats, which have been flying thick and fast into the political ring the last few days, continued to swish through the air today with indications that the number would be greatly increased during the week.

The latest hat-toss was no other than Jack Edwards, who announced that he would again seek his post in the House of Representatives of the State Legislature. He is the second to file for the House post, John Hill Paylor, of Farmville, stating Saturday that he would also be in the race.

Mr. Edwards served Pitt in the last session of the General Assembly and promised if returned to the post he would uphold the fine record he set in the previous term.

His record of service has been marked by pronounced opposition to the sales tax imposed upon the public by the last Legislature. He battled against the measure, he said, because he did not believe it was for the best interest of the people, and would continue to use his influence in this direction, if sent back to Raleigh.

Aside from this, Mr. Edwards used his influence for other measures he thought for the welfare of the people at large and declared he would enter the race this time fully prepared to live up to his former record of service.

R. T. FOUNTAIN FIRES OPENING POLITICAL GUN

Rocky Mount Man Voices Opposition to Sales Tax and New Constitution Here

Former Lieutenant Governor, R. T. Fountain, addressed the Pitt County Tax Relief Association in the courthouse at twelve o'clock noon today. A large and enthusiastic audience was present. Mr. Fountain discussed the proposed change of our constitution and also voiced his opposition to the efforts now being made to make the general sales tax which was put on us during the last general assembly, permanent. He further stated that the main argument which was being offered by proponents of the change is that the constitution is old and out of date; that this was a false argument. While our constitution was adopted in 1868, it was amended in 1875, amended with the suffrage amendment in 1900, and the six months school term since adopted and many other amendments have changed the old part of the original constitution as the times have demanded. Those seeking to change this constitution, while they talk about a new constitution, are only interested in one section, and that is the section of taxation. The old constitution, which we are living under now, provides that taxation shall be uniform upon ad valorem value, the new constitution takes the bridge absolutely off and says that taxation shall be just and equitable, which leaves it in the power of the legislature to do as it pleases without constitutional restraint. The Greensboro News yesterday carried a statement from Dr. Poe, in which he urged the adoption of the new constitution on the ground of the ability and standing of the Commission, through in this same article he states that eight men of them were lawyers, and that he was put on to represent the farmers and liberal elements of the state. He asked the question who had ever heard of Chief Justice Stacy, Mr. J. O. Carr, Commissioner of Revenue Maxwell, Federal Judge John J. Parker, Lindsay Warren, or Mr. Burton Craig, ever being accused of being liberal. COURT OPENS HERE TODAY

Important Cases Faces Two Week Term of Criminal Superior Court Here

A two week term of criminal Superior court convened here this morning with Judge Frank A. Daniels, of Goldsboro, presiding.

The grand jury immediately got down to work and among the first true bills returned was one against Elwood Gwaltney, charged with stealing an automobile containing tobacco products, from C. E. Oakley, of this city. He pleaded guilty to the offense. Two other theft charges also face Gwaltney.

In opening court Judge Daniels told members of the six months grand jury that a charge would not be necessary at this term in view of the fact that full instructions were given at the last session when the grand jury took over its duties.

The docket contains scores of cases of more or less interest to the people of this section and the courtroom as customary was crowded to overflowing.

Two murder cases and an arson charge are among the highlights scheduled for the term. Matthew Harrington, Greenville young man is charged with slaying of his step-father John Gurganus, and the Carson murder charge from Bethel, Claude Clemmons, colored is charged with firing a house in Stokes, resulting in the death of three negro children.

SEED LOANS MOVE RAPIDLY

Applications For Loans Under \$150 Can Be Made Direct To Seed Loan Office

Under a new ruling just made public persons applying for loans under \$150 will not have to apply to the Greenville Production Credit Association before filing their application with the local office of the Federal Seed Loan administration; it was made known today by T. O. Edens, manager of the department here.

Prior to the ruling, all persons who desired to obtain seed loans for this season were required to have their applications approved by the Production Association before filing with the Seed Loan office. This was done to determine if they were co-operating with the government's effort to reduce tobacco and cotton, principal crops of this section, and were deserving of such aid.

Mr. Edens also announced that offices of his department had been moved to the office building back of the court house. Offices heretofore have been in the grand jury room of the court house.

Five hundred applications for seed loans had been filed up to the end of the past week, Mr. Edens said, and quite a number of them, have been approved. In fact, he stated, checks for virtually all of the approved loans have been received with others expected to roll in daily.

Under a recent ruling of the Seed Loan department, farm owners are able to obtain as high as \$750 and individual growers \$250.

The time limit for the filing of loan applications will close April 30 and persons desiring to obtain funds from this source are urged to act immediately.

SEEK REVIVAL COUNTRY CLUB

Reorganization Plans To Be Discussed At Meeting At Library Tuesday Night

A movement was on foot here today to reorganize the Greenville Country Club.

A special meeting of persons interested in reorganization plans has been called for Sheppard Memorial Library Tuesday night at 8 o'clock.

The club was disbanded following the destroying of the club house by fire last year, but those who enjoyed the benefits of the many diversions offered by the club are not satisfied without such an organization and want it revived.

The old club was organized many years ago and for a number of years enjoyed large membership. Its golf course was considered to be among the finest in this immediate part of the state and numbers of tournaments, bringing representatives in this part of the state, were staged.

KNOW YOUR CANDIDATE

We agree heartily with former Lieutenant Governor R. T. Fountain in his declaration here today that "there are ample sources in North Carolina from which to derive the necessary revenues for operation of the schools and all state departments without resorting to the sales tax or increasing taxes on land."

It has been our contention from the start that the only fair basis of taxation was upon ability to pay but the last General Assembly instead of following such a course resorted to the road of least opposition by enacting the general sales tax thereby shifting the burden of taxation to the backs of those least able to pay. Based upon figures made public by the State Revenue Department for the first six months Pitt county will pay more taxes this year under the sales tax plan than was paid under the old plan while the counties with the greatest concentration of wealth are showing great savings, one of them running close to half a million dollars.

Mr. Fountain urged that the people of this county vote for no candidate for a seat in the House or Senate who is not willing to consistently vote his or her opposition to the general sales tax and we urge our people to follow this advice.

The candidates now in the field and any others who might enter the race for seats in either branch of the coming General Assembly should be required by voters to make clear their stand on this and other important questions that must come up before that session. This is a time that every voter should know where the candidates stand.

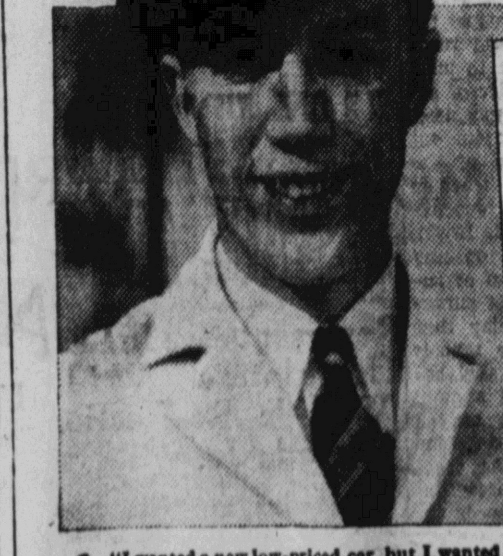

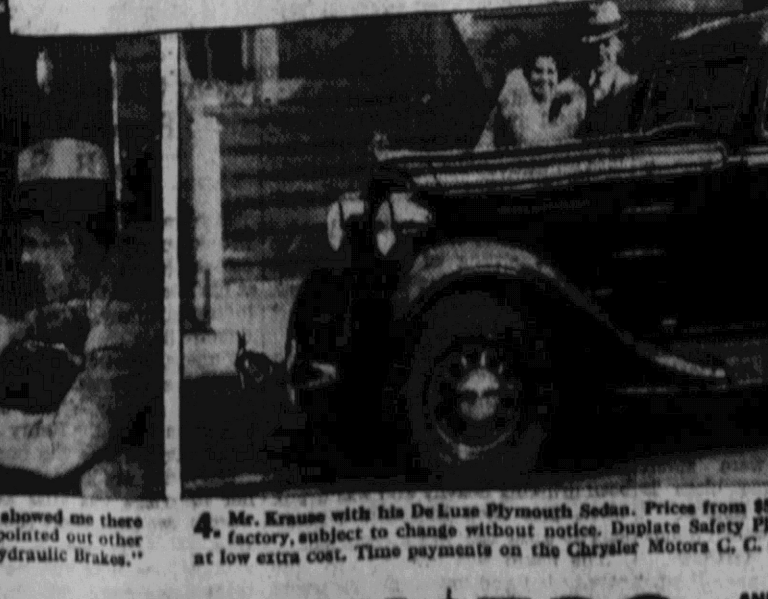

Veteran Benefit Now Restored

All laws in effect March 19, 1933, which granted monetary benefits to veterans of the Spanish-American war, have been re-enacted entirely by congress.

All such veterans who were on the pension rolls on March 19, 1933, and whose pensions were reduced or discontinued under the Economy Act of March 20, 1933, are automatically restored to the rolls as of March 28, 1934, at 75 per cent of the rate of pension they were receiving prior to the act of March, 1933. It was stated today.

Those not included in the benefits are:

Those whose pension was for a disability the result of their own misconduct.

Those not exempt from payment of Federal income tax for the year 1933.

Federal employes with salaries in excess of \$1,000 if single, and \$2,500 if married.

Those being furnished hospital treatment, institutional, or domiciliary care. Federal employes, and pensioners being furnished hospital treatment, institutional or domiciliary care, will continue to draw their pensions at the rate now being paid them under the act of March 20, 1933.

Those who enlisted after August 12, 1898, and who did not serve in either the Boxer Rebellion or Philippine Insurrection.

Widows who married subsequent to the death of the veteran upon whose services the title to pension is based.

EDUCATIONAL CONFERENCE CLOSES HERE

(Continued from Page One.) lations and whether more emphasis shall be put on social or on cultural values. While the complaint has been that there are too many subjects, the problem is perhaps more largely organization than it is that of numbers. In the Raleigh meeting, when one expected, frills and fads to be taken out, every one wanted something added, so as to fit one for leisure. The type of training a teacher needs to fit into the new program and era was a topic that stirred up a great deal of discussion, for all realized that the teacher is the crux of the whole problem. The kind of administration set up in order to meet the emergency was another topic discussed.

The discussion in the group of principals, supervisors and classroom teachers was along the same general lines. They throw the responsibility largely upon the classroom teacher. All realized the need for changes in the curriculum that would make it function in society. Great emphasis was placed upon character education, in both groups. Another topic upon which emphasis was placed in every meeting was the necessity of training that will enable people not merely to make a living but to live happily, and use to advantage their leisure time.

At the morning meetings, Reid Ross, principal of the Moss Hill High School, Lenoir county, talked on the possibilities of a Modified Platoon System for meeting the Educational Needs of the New Order, and gave a report on an experiment in his own school, which proved to be successful.

Miss Evelyn D. Anderson, of the New Hanover High School, Wilmington, in her talk on the place and function of mathematics in the new program of secondary education said: "The development of a functional program of mathematics instruction will, then, involve the necessity of a supervisory program based upon four steps in reorganization and teaching of the mathematics courses. She said: "This involves a restatement of the aims of mathematics in terms of the social, industrial, economic, and political problems of our present civilization; Three things are necessary: The selection of materials on the basis of relative values to realize these aims; The determination of appropriate teaching procedures and techniques to achieve the desired results; and the selection of tests that measure success in achieving these aims set forth."

Miss Mildred English, assistant superintendent of the Raleigh City schools, presented "A Modern Supervisory Program." She said the teachers, supervisors, and principals must become cause and effect in this program of change and all must work in cooperation in order to help determine aims and standards. She believes other than economy, one reason supervision was put aside in North Carolina was that the spirit of democracy caused people to rebel against the dictatorial.

Some supervisors considered themselves dictators, she said, and in the new program they must be consulted and divest themselves of their former authority. R. S. Proctor, superintendent of

(Continued From Page One) chief legal adviser of the state, was rendering public service to the people of North Carolina in pointing out to the lay mind the dangers in the proposed new constitution. He further stated that the governor of North Carolina already had more power than any governor in the American Union, and that there was no necessity granting the veto power to him. Governor Bickett having stated on one occasion that the prestige of the office of governor was sufficient power for any governor to have if he conducted it right, without the veto power. Governor Ehringhaus has more than a hundred times more power than Governor Bickett had. Since Governor Bickett's day, the highway system has been set up within the same neighborhood of six to eight thousand appointive employees. The state school system has been adopted with the central control of superintendents and principals. The conservation act has been enacted with hundred appointive game wardens; the highway patrol has been set up with a large number of officers; the executive budget act has been inaugurated giving him the control of the salaries of every appointive officer in the state. Does he need

the veto power? In conclusion, he stated that there was an effort well organized permeating this state even before the members of the legislature were elected, to make the general sales tax a permanent policy, notwithstanding the governor had spoken against it in his campaign and had urged during the legislative session that it would be temporary. He further stated that the revenue commissioner and the sales tax collector had been sent to Indiana and were spending much time in Washington, seeking to get Congress to enact a tariff wall around the state of North Carolina, which was against the best interest in this state and in violation of the very cardinal purpose of the Democratic party; that there were ample resources to support the state government and its institution without resorting to a general sales tax; that the argument that we either had to put the tax on land or close the schools or have a general sales tax, was pernicious propaganda; that there was never any necessity for the general sales tax. That there is now in the highway fund from six to eight million dollars unexpended.
