LEAGUE OF NATIONS DAZED BY JAPAN'S WARNING

ARMED POSSE HUNTS WOODS FOR DILLINGER

CAPTURE OF GUNMAN NOT FAR AWAY

Officers Believe They Will Round Up Indiana Desperado in the Country North Wisconsin; Department of Justice Agents to Shoot to Kill; Planes Bring Re-inforcements.

Merced, Wis., April 24.—(AP)—Throughout wooded wilds of the north country, freshly white with snow, an army of determined men hunted John Dillinger today.

Crafty as a fox and rough as the wolves that sometimes prowled the fresh timberlands of the north west, the gunman from Indiana continued to elude one of the most determined man hunts the full country has ever known.

"Dillinger's luck was holding," but the feeling was strong among the hunters that John Dillinger, cop killer, bank robber, highwayman and jail fugitive was very close to his last stand. The government had nearly 100 picked men on the job. Some of them were drafted from as far a distance as Philadelphia and Washington. Many airplanes swooped down from the skies bringing reinforcements.

The department of justice men were under orders to shoot to kill. The sentiment was openly expressed that Dillinger dead would be more desirable to the forces of the law than Dillinger alive.

The memory of the outlaw's latest victim, a government agent slain as Dillinger blasted his way from a tavern Sunday night, was not calculated to encourage the officers to take any chance with the heavily armed desperado and his gang of criminals.

Dillinger was believed hiding today either in this north woods country or to have taken refuge in one of the several hideouts he is believed to have prepared in the two cities of Minneapolis and St. Paul. The casualty list in the gunfight Sunday night remains two dead, four wounded with the condition of one of the wounded men critical.

WRITER DIES IN ACCIDENT

Sylvester Dorain, Lecturer and critic, Killed in Wreck Near Fort Bragg.

Payetteville, April 24.—(AP)—Sylvester Dorain, 32, lecturer, author and critic, and Private James A. Richards, 27, of Fort Bragg, were found dead behind Dorain's wrecked car near Manchester early today.

Both men had been dead several hours. Dorain's watch had stopped at 10:15 and officers presumed the accident occurred at that hour last night.

Clearance Stone, who operates a filling station at Manchester, a little community near Fort Bragg, discovered the wrecked car and the bodies. The automobile evidently had left the road, run over an embankment and overturned.

Dorain, a native of North Carolina, was the author of several successful books, biographies and plays. Among his best known works were "Sarah Bernhardt as I Knew Her," "The Life of Lily Langtry," "Biography of Isadore Duncan," and the plays "La Trahison," and "L'Adat Juor."

Born in Gastonia, he was educated in the schools of his native state and at the University of Oxford, England.

For the last few years Dorain had lived in Paris and lately completed in collaboration with Professor August Piccard a book entitled, "Adventures in the Stratosphere."

STATION OPERATOR HELD UP AND ROBBED

Hickory, April 24.—(AP)—Three unidentified bandits held up Harion Tuttle, 19, filling station operator, here early today and robbed him of \$25 and a gold watch later escaping toward Lenoir in an automobile. Tuttle said the men first came to the station at 2 o'clock this morning and bought gasoline. They returned an hour later, he said, and covered him with pistols as they gathered up their loot.

ARSON CASE BEFORE JURY

Judge Daniels Refuses To Grant Motion for Dismissal of Clemmons Charges

The case against Claude Clemmons, 50-year-old Stokes community negro, charged with murder and arson, went to the jury this afternoon.

Argument was completed shortly after 3 o'clock after which Judge Daniels charged the jury selected yesterday morning from the regular panel and a venire of 50.

After the state finished presentation of evidence this morning the defense made a motion that the charge be dismissed on account of insufficient evidence, but Judge Daniels ruled to the contrary and ordered the case continued.

Following the decision defense attorneys decided not to present any evidence and immediately announced they were ready for the beginning of argument.

Clemmons is charged with firing the home of Cora Robinson, a short distance from Stokes on the night of last January 18, causing the deaths of three of her children and the narrow escape of others sleeping in the building.

The state contends that Clemmons fired the house as result of malice against the negro because she had given shelter to his estranged wife. He was also charged with attempting to "get even with his wife," who was said to have been sleeping in the Robinson house at the time of the fire.

Two children of Clemmons testified he was away from home at the time of the fire, returning while flames could be seen from their windows. Evidence was also introduced showing the negro had written his children asking them to testify he was away from home about ten minutes instead of the hour claimed by the accusers.

Clemmons, who has been in jail here since his arrest has constantly denied setting fire to the building. If found guilty of arson he automatically becomes guilty of the three separate indictments of murder.

PITT COUNTY FINANCES IN FINE SHAPE

Report of Auditor J. H. Coward Shows Receipts are Ahead of Expenditures.

The monthly report covering the ninth month of the current fiscal year, of County Auditor, J. H. Coward, to members of the Board of Commissioners, shows the county to be in excellent financial condition as to the current year's operations. Much has been accomplished in effecting economy in operations, and indications are that some savings will be effected in all appropriations except those made for Debt service.

For the first time in several years receipts are in excess of expenditures. General fund expenditures are 66 per cent of appropriations; County Home and Poor, 85 per cent of appropriations; Health Department, 72 per cent of appropriations; and Debt Service 42 per cent of appropriations. Receipts for all funds average better than 90 per cent of estimated revenue.

Collections on the 1933 tax levy amount to 62 per cent of the levy and collections on prior year's taxes are in excess of estimates.

RIVER HEARING ON THURSDAY

Government Engineer To Receive Facts On Opening Local Stream to Navigation

A public hearing is scheduled for Thursday next, Thursday morning at 10:30 o'clock to consider data regarding the opening of Tar river to navigation.

This hearing was ordered several days ago by Lieut.-Colonel Eugene Reynolds, District government engineer of Wilmington, for the purpose of receiving data relative to the deepening of Tar river to permit the operation of boats from here to Washington.

The data has been compiled by the East Carolina Association, Inc., local organization, and will be presented by representatives when the hearing gets under way.

Improvement of the river will cost around \$800,000 it has been estimated and will result in saving over \$350,000 annually to shippers of this territory with greater benefits to be realized in years to come.

If the proposal receives favorable action a steamship line has assured boats in operation between this area and Washington.

The re-survey of information was prepared by engineers employed at the suggestion of Congressman H. H. Cantwell who had the matter called to his attention by the association.

All business and professional men of the section are urged to attend the hearing and use their influence in making the improvement possible.

DR. R. H. WRIGHT SLIGHTLY BETTER

Senators Bailey and Abernethy joined the delegation from the state in arguing that the proposed project would give a region rich in agriculture, livestock and forestry products a waterway to the sea that would result in cheaper freight rates.

TRIES TO MURDER FARMER IN BED

Raleigh, April 24.—Wake county officers yesterday reported no clue had been found to the identity of the murder-bent assailant who fired a lead of shot into the bedroom of Clarence Medlin, 35-year-old prominent New Light township farmer. LEAF CHECKS ARRIVE HERE

Tobacco Growers To Receive \$82,488.27 From Government During The Week

Pitt county tobacco growers who took part in the government acreage reduction campaign will receive checks for \$82,488.27 during the present week, it was made known today from the office of E. F. Arnold, farm director.

Mr. Arnold said six hundred checks have been received at his office and that they would be distributed among the growers and they would have to bring the notices to his office to get the checks.

The checks cover rental and benefit payments of those farmers who agreed to reduce tobacco acreage and help relieve the congested condition of the world market. Rental payment checks amounted to \$58,480 and benefit payments \$24,008.27.

Mr. Arnold said two thousand other checks were to be paid growers of this county and they will be distributed as rapidly as they arrive. He warned growers not to apply for payments until they received notices from his office.

Speaking of the cotton reduction campaign the farm head said it was going to be necessary to review contracts in this county and that committees would be at the usual places the latter part of the week to assist growers in filling out their revised contracts. Contracts were carried to Raleigh this week and it was discovered in the checking there that the acreage for the county was too high.

JAPAN WAITS FOR U. S. TO TAKE ACTION

Nippon Government Marks Time While Waiting To See What U. S. Will Do Toward Britain's Demand for Solidarity Japanese Foreign Minister seeks to Appease Britain's Suspicions.

Geneva, April 24.—(AP)—League of Nations circle were dazed today by Japan's warning to the world that she will oppose foreign aid to China under whatever guise which she deems may disturb the peace of eastern Asia.

The warning was issued yesterday in a prepared statement by the Tokyo government through Consul General Uchiro Tokemura, which is regarded as far from reassuring in the present situation in the far east.

These representatives say Japan is reaching out to the Asiatic people and seeking to inculcate in them Japanese ideas and leadership. Japan was pictured as defying the league's home where she was publicly criticized for her aggression in the Manchurian campaign.

Tokyo, April 24.—(AP)—Confronted by Great Britain's demand for clarification of Japan's statement of March 17 concerning the Empire's China policy, official Tokyo today awaited indications as to whether the United States would follow suit in the signing of an Anglo-American solidarity.

NO PLACE FOR BABIES

Of course it's everyone's right to attend court when it is open but it seems to us that some people let their curiosity get the best of them when they will go to court just as spectators and carry with them little babies in their arms. During the murder trial the latter part of last week when the court room was crowded almost to the point of suffocation Judge Daniels was forced to halt court a couple of times until women there with crying babies in their arms could remove them from court. While yesterday and today during the trial of a negro on a first degree arson charge the court room has not been as crowded as it was last week, women with babies in their arms have been noted in the audience and in one instance a local negro nurse with a small white child in her arms made her way to the court room to listen to the trial. In almost every instance of these babies in court the parties who brought them were not connected with the cases on trial but were there merely as spectators.

Any mother who will push her way into a crowded court room with her baby in her arms to listen to a trial, apparently does not think much of her baby and certainly no parent should permit a nurse who takes a baby out for an airing to take it into a court room and spend a portion of the day there.

If parents don't think enough of their children to keep them out of such places the judges would do well to order babies barred from the court rooms except in such cases as the mothers are connected with the cases on trial and it is absolutely necessary for them to bring their babies with them.

Rep. Doughton of North Carolina, Cooper of Tennessee and West of Ohio, all democrats, went to the White house and declined to comment after their talk.

Mr. Roosevelt made it clear that he thought the government needed revenue too badly to sanction the proposed horizontal cut in the tobacco levy, although he did express some sympathy for the proposed reduction asked by independents on lower prices of cigarettes.

Democrats Outline Program

Washington, April 24.—(AP)—The Senate Democratic leadership in a conference today with 25 others of their party outlined an ambitious legislative program for the remainder of the session, which may postpone adjournment until well in June.

A conference of all Senate leaders was called for Monday evening to consider action on the reciprocal tariff bill.

The House meanwhile accepted a

conference report with the Senate on the sugar bill but the latter branch has yet to act on this measure before it goes to the President.
