POLICE OF WORLD PREPARE FOR MAY DAY TROUBLE

Dr. Wirt Takes New Crack At Government New York Lays

SAYS EFFORT BEING MADE TO CONCEAL AIMS

Indiana Educator Says He Met Stubborn Official Resistance And Intimidation In Recent Investigation Of Revolution Charges; Singles Out Senator Brookhart And Henry T. Rainey

Chicago, April 30.—(AP)—Dr. William A. Wirt, Gary, Ind., educator, charged today there was "frantic struggling to conceal the aims of official Washington."

When he went to Washington to accuse minor and major "new dealers" of slipping a revolution on the country he met, Wirt declared, "not only stubborn official resistance but actual slander, intimidation and other hindrances that do not rest well with free citizens."

In a speech today before an American Legion group, his first public statement since the congressional committee declared his revolution charges were "unfounded," Dr. Wirt singled out former Senator Smith Brookhart, Assistant Secretary of Agriculture Rexford G. Digwell and Speaker Henry T. Rainey as having made disturbing statements.

Dr. Wirt implied that government officials have blocked rather than aided recovery.

"We actually had recovery in 1933," he declared, "and desisted in 1933."

LILLYCROP TO FLORIDA

Former Rector Of Episcopal Church Here Leaves Today For Post In Sarasota

Rev. W. A. Lillycrop, who resigned as rector of St. Paul's Episcopal church here several days ago, left today for Sarasota, Fla., where he has accepted the rectorship of the Church of the Redeemer.

Mr. Lillycrop planned to stop over in Charlotte until Wednesday to visit Mrs. Lillycrop and children before proceeding to his new post in Florida. He is scheduled to preach his initial sermon next Sunday morning.

Mr. Lillycrop served the local church for six years during which time splendid growth was recorded. During his rectorship the congregation moved from the old church building on Pitt street to the beautiful new structure on Fourth street.

In addition to his work with the local church, Mr. Lillycrop took an important part in activities of the diocese, being director of Young People's activities.

He delivered his final sermon to the local congregation yesterday morning and was heard by a crowd that packed the chapel to overflowing. Using his subject the Navajo song of separation, "Beauty, it is Ended," Mr. Lillycrop spoke impressively of God's love and the response of the people.

Taking his text, "Now abideth faith, hope and love, but the greatest of these is love," he told of the unsearchable riches of God's love, the response of the people, devotion to the church in friendship and kindness and in consecration to ourselves.

WANT IDLE WEEK FOR SILK WEAVING MILLS

High Point, April 30.—A complete shutdown for one week of all weaving mills coming under the Silk Textile Code Authority, which embraces silk and rayon plants, has been asked of the Recovery Administration. According to the plan which officials here believe will be acceptable to Washington, the shutdown would be for the week of May 7.

Late News Flashes

Leas Denied Review. Washington, April 30.—(AP)—Col. Luke Lea, former senator from Tennessee, and his son, Luke, Jr., today were denied a review by the Supreme Court of the United States on the action of the Tennessee court ordering their extradition to North Carolina to serve sentences impending on them in that state.

Lea, former publisher of the Nashville Tennessean and for many years a dominant power in Tennessee politics, was convicted in North Carolina in August, 1931, along with his son on charges growing out of the failure of the Central Bank and Trust Company of Asheville, a \$17,000,000 concern. Lea was sentenced to imprisonment of from 6 to 10 years and his son was fined \$25,000 or sentenced to from 2 to 6 years. They appealed their conviction to the United States Supreme Court but were denied a review.

In opposing extradition they asserted their conviction was illegal because it was based on acts which were alleged to have committed in North Carolina when they were not in that state.

The Tennessee court refused to release them from extradition, the state supreme court declaring it could not pass on the validity of the conviction in North Carolina.

HIGH WINS MUSIC CUPS

Young Musicians Capture Four Loving Cups At Music Contest At Greensboro

The Greenville High School Music Department again distinguished itself at the State Music Contest in Greensboro last week by winning four silver cups, six second places and three third places, out of the thirteen events which the school entered. The four first places, each one carrying the grade of 1, which means excellent are as follows: Trombone solo, Ben Herring; Tenor solo, Edward Conway; Alto solo, Helen Phelps; and the Boy's quartette, composed of Ben Herring, Edward Conway, Fred Slem and D. T. Beaman. Second places were won by the following: Baritone solo, James Savage; Bass solo, Fred Slem; Girls' Trio, Julia Foley; Eoline Sawyer, and Helen Foley; Mixed Quartette, composed of D. T. Beaman, Ben Herring, Julia Foley and Eoline Sawyer; Mixed Chorus composed of 40 students. Third places were won by the following: Soprano solo, Julia Foley; Boy's Glee Club, and the Girls' Glee Club.

The Greenville High music club was also honored again this year in being asked to take part in the "Ole Miss" Festival Concert which is the climax of the week. This concert is both instrumental and vocal. The Greenville singers were asked along with Durham, Charlotte, Lenoir, and Roanoke Bands to make the Chorus for this grand concert. This chorus was under the direction of Dr. Hollis Dunn, and the results achieved under his direction will never be forgotten by the audience who heard the music, or the singers who produced the music.

The schools which were awarded the largest number of places during the contest were Charlotte and Lenoir, which schools entered bands and orchestras in the contest, and also a soloist entrant for each band and orchestra musical instrument. The Greenville High School made a better record than any other school in the events, considering the fact that she did not enter either band or orchestra, and entered only one instrumental soloist.

Each year the State Music contest is growing despite the fact that music is being placed at such a disadvantage in the school curriculum. There were more entrants this year in the contests than there have ever been before. Competition is getting keener each year, particularly on the vocal side, and it has become increasingly hard to take the first place. That is why the Greenville High School feels such pride in that she was able to bring back four silver cups in the number of events entered. The work was under the direction of Miss Oma Shindler, and to her goes the credit for the results achieved. Mrs. Luther Herring and a group of teachers from the City Schools, and several mothers went to Greensboro with the boys and girls.

ARREST NEGRO FOR SHOOTING MD. OFFICER

Harry Fleming Nabbed By Sheriff As Mob Hunts Him In Woods And Swamps

Crissfield, Md., April 30.—(AP)—Sheriff Luther Daugherty early today captured Harry Fleming, negro, for whom hundreds of men and boys had searched woods and swamps since last night.

Fleming, wanted for seriously wounding policeman Harry Daugherty with a chisel, was in the hands of a guard of state police and being rushed to Baltimore before the sheriff let the searching crowd know their man was gone.

The sheriff who said he had been working alone, made the arrest unaided when he found Fleming at the home of Joe Spence, near Westover Cross Roads several miles from where the crowd believed they had him surrounded in a swamp.

The negro was alleged to have attacked Patrolman Daugherty, distant kinsman of the sheriff, when the officer went to arrest him last night. At the hospital today it was said the officer had only a fighting chance to live.

Tax listing in Pitt county will continue through the remainder of this week, it was made known today by J. H. Coward, county auditor and head of the tax department. The tax listing period was to have expired today but owing to the fact that the first Monday in May does not come until the 7th, Mr. Coward stated that listers would remain at their post at the court house this week to continue the listing of property.

Listers set away to a slow start in Greenville township by reason of the congested condition of the court house and inability to find a suitable place for the listers, and it was discovered today that numbers of people had been unable to list their property.

Concord, April 30.—(AP)—Carl, Jr., two-year-old son of Mr. and Mrs. Carl L. Presley of near Midland, died at a local hospital Saturday from burns suffered a few days ago when he fell backward in a tub of boiling water. The child accidentally fell into the tub while his mother was washing clothes.

MANY CASES DISPOSED OF IN TWO WEEKS

Approximately 75 Actions Handled In Two-Weeks Term of Criminal Court

Approximately seventy-five cases were disposed of in the two-week term of criminal Superior court which came to a conclusion here the latter part of last week, records in the office of the Clerk of Court indicated today.

The final cases disposed of was the second degree murder charge against Claude Clemmons, Stokes negro, who was sentenced to 30 years at hard labor in State Prison. He was charged with starting a fire that resulted in the death of a negro girl in the Stokes community the first of the year.

The case that attracted probably the most attention during the term was that against Matthew Harrington, Greenville young man, who was sentenced to the penitentiary from 25 to 30 years on a second degree murder charge growing out of the death of his stepfather, John Gurganus, whose body was found in the Tar river bridge fill during February.

After submitting to the second degree charge, Harrington admitted killing Gurganus in self-defense in a fight which took place as the two were riding in an automobile in Greenville.

Numbers of persons convicted of charges of robbery were sentenced to the roads. These included members of a ring of store and freight car thieves who had been operating in this community for several months and were rounded up in a dragnet thrown out by city and county officers.

The term was described as one of the most successful in months and from the standpoint of interest it was unquestionably far ahead of previous sessions.

PACE HEADS PHYSICIANS

Local Physician Elected President Of Second District Medical Society

Dr. K. B. Pace, of Greenville, was elected president of the Second District Medical Society, which met in Kingston the latter part of last week. Dr. J. Paul Fitzgerald, also of Greenville, was elected secretary of the organization.

Dr. Pace, one of the best known physicians here, will succeed Dr. Ira M. Hardy of Kingston and Dr. Fitzgerald takes the post formerly held by Dr. Leslie Lee also of Kingston.

Dr. Fitzgerald is a Greenville dentist and like Dr. Pace has been prominent in his profession here for a number of years.

The society is composed of doctors from Beaufort, Carteret, Craven, Hyde, Jones, Lenoir, Martin, Pitt, Washington and Tyrrell counties.

In addition to the election of officers, always one of the highlights of annual meetings, the society heard interesting papers read by leading members of the profession from various parts of the district.

MEMORIAL SERVICE FOR DR. WRIGHT

Late President Of E. C. T. C. Honored At Vesper Service Last Night

A beautiful, impressive memorial service, simple and informal, was held by the college Y. W. C. A. last night at the vesper hour.

The Austin Auditorium, dimly lighted by candles on the stage, decorated with white flowers, the girls dressed in white, the original members of the faculty seated on the stage, with the hymns sung softly, with a talk appropriate to the occasion by one closest to him, all seemed to fit perfectly the character and personality of the great and beloved leader whom they were honoring. President Wright's very spirit seemed to be present.

The six people seated on the stage were Mrs. Beckwith, who was lady principal for the first seventeen years, and the five members of the faculty who have been in the school since the first year, Misses Davis, Graham, Lewis and Jenkins, and Dr. L. R. Meadows, Miss Melba O'Brien, president of the Y. W. C. A., had charge of the service.

Dr. Meadows made a talk that will doubtless stay in the minds of those who heard it as long as they live. Instead of giving a direct eulogy, he presented the life of Moses and the life of Dr. Wright as parallel in their main features. "The Two Leaders" was his theme. He chose as the Scripture lesson the first two verses of the first chapter of Joshua which includes these words: "Moses my servant is dead; now, therefore arise, go over this Jordan."

The main points he brought out in the life of Moses, one of the greatest leaders of all time, were these: Born in bondage; saved from the evils of his environment by his mother who developed in him the highest type of character; educated in the University of Egypt, the best of his time; leaving his people and going into another land for a time; recalled to become the leader of his people, leading them out of the land of bondage; their leader still throughout the years in the wilderness; finally passing on, and leaving the order for them to "go forward."

Our leader, he said, was born in the days of Reconstruction when the state was going through the worst bondage in its history; his great mother saved him from the bondage of ignorance and superstition, great dangers in his environment; she planted in him high ideals and standards and developed in him the finest type of character; he was educated at the State University, the school that perhaps offered the finest opportunity within his reach; after studying with his people a short time, he left the state and labored elsewhere for a few years; he was called back to lead his people out of the bondage of ignorance; for almost a quarter of a century he gave his life to his people, becoming a great leader; now he has passed on, leaving his people to go forward.

Dr. Meadows spoke of the great influence that President Wright had on his state and on the educational thought of the day, becoming recognized not only nationally but internationally. He showed how the influence of that first great leader, Moses, had gone on and on, growing greater as time passes by, and how the influence of our great leader, through the lives of those he has influenced, can never die.

Mrs. Ginn Dies At Goldsboro

Mrs. Mehetable Ginn, aged 76, much-loved Goldsboro woman, died at her home on Pou street, Tuesday morning, April 24, after a lingering illness of several months with pneumonia and complications incident to old age. Mrs. Ginn, the widow of the late Owen Ginn, was a native of North Carolina, and had lived in Goldsboro since 1919. She was widely known and loved for her sincere and beautiful Christian character, and for her hospitality and unbounded charitableness. Her generosity was further emphasized by the fact that in addition to thirteen children of her own, she gave a home to and reared four of her grandchildren.

Funeral services were conducted at the home by Elder John W. Gardner of Goldsboro, assisted by Rev. Matt Ransome Gardner, Methodist minister. Interment was made in Willow Dale cemetery, Goldsboro. Her ten children who survive her were all at her bedside except her youngest son, W. M. Ginn, who is a member of the State College faculty at Las Cruces, New Mexico, and could not reach home in time. The deceased was the mother of B. W. Ginn, member of the staff at East Carolina Teachers College. Floral tributes were beautiful and profuse.

STREET WORK DELAYED HERE

Resurfacing Of Dickinson Avenue Held Up By Improvement Of Railway Crossing

Work of resurfacing Dickinson Avenue, which was to have started today, will be delayed until the latter part of this week or probably the first of next week, it was made known today.

The delay, it was said, is caused by improvement of the Coast Line railroad crossing on the upper end of Dickinson avenue. Several days will be required to complete this work but it will be believed the last of the week will see it finished.

Reinforcing weakened sections of Dickinson Avenue was completed last week along with the laying of numbers of pipes by the Water and Light Department and everything was in shape for resurfacing when the railroad company announced it desired to improve the crossing before resurfacing work was started.

Laborers started to work widening Fifth street from Library street to the city limits this morning and this work is expected to be completed in a comparatively short time. The highway which begins at Library street will be made as wide as the pavement on Fifth street.

Both improvements are being done by the State through funds made available by the federal government and were approved several weeks ago.

BLOUNT SEEKS SEAT IN HOUSE

Prominent Bethel Business Man Announces Candidacy For Representative

M. O. Blount of Bethel, has announced that he will be a candidate for the House of Representatives. Mr. Blount is a native of Pitt county, having operated a mercantile business in Bethel since 1887. He farms extensively, and is president of the Blount-Harvey Company of this city. For more than twenty-five years he has served as a member of the County Board of Education without opposition. With his knowledge of the condition of the county and of the farmers, he is well qualified to protect the interest of the taxpayers in these crucial times.

C. T. Grandy's Body Cremated. Elizabeth City, April 30.—Judge and Mrs. Walter L. Small returned Thursday from Washington where they had on Tuesday accompanied the body of Charles Taylor Grandy. The body, as had been requested by Mr. Grandy during his lifetime, was cremated and the ashes brought back to Elizabeth City and taken to the family plot in Hollywood cemetery. There was no public ceremony.

Lone Bandit Gets \$350 At Charlotte

Charlotte, April 30.—(AP)—Brandishing an automatic pistol, a lone bandit last night entered the Allied Brothers Candy Company here forced employes to lie on the floor while he scooped up \$350 in currency and escaped in an automobile belonging to J. W. Allred, one of the owners of the store.

STABILIZATION FUND NOTED AS 'EXPENDITURE'

Government Officials Decline To Explain Transaction Of Big Fund

Washington, April 30.—(AP)—Use of the government two billion dollar exchange stabilization fund was indicated today by a Treasury statement which described the entire sum as an expenditure. Officials declined to explain the transaction but it was generally understood the entire sum had not been spent but instead was being set up as a separate fund in the Treasury books. In the past the fund has been lumped with the cash balance along with \$810,000,000 of additional profits on devaluation.

Under the heading of liabilities the exchange stabilization fund was carried today at \$1,800,000,000. Officials would not say whether this meant the expenditure of \$200,000,000.

The stabilization fund may be employed in buying and selling currencies and in buying bonds. It represents part of the profit from gold devaluation.

W. G. CHAPMAN DIES AT AYDEN

Ayden, April 29.—W. G. Chapman, 62, prominent Pitt County farmer who died at Memorial General hospital Saturday afternoon at 4 o'clock, was buried today at 3:30.

The funeral service was conducted from St. John's church near Griffith by Rev. I. S. Richmond, his pastor, and Rev. A. C. D. Noe, rector of St. John's Church. Interment was in the Church cemetery.

He is survived by his wife, who was Lula Kilpatrick of the same neighborhood; two children, Miss Fannie Rhem of New York, and Alton, who lived with his father; two sisters, Mrs. L. L. Stokes and Mrs. Will Tucker both of Greenville; two brothers, P. C. Chapman of Fort Barnwell and C. E. Chapman, Ayden; one daughter in law, Mrs. Alton Chapman, and an adopted daughter, Lucille.

For a number of years Mr. Chapman has been a faithful member of the Methodist Church in the community in which he lived, and his honesty, integrity and friendly manner made him a great asset in the neighborhood.

The large number of people attending the service, and the beautiful floral offering attested to the high esteem in which he was held in his own, as well as other communities.

HIGH POINT REPORTS ADVANCE IN INDUSTRY

High Point, April 30.—Manufacturing operations in the furniture industry during March showed substantial improvement according to figures for the industry as compiled and released here.

Orders for March, 1934, exceeded those of February, 1934, by approximately 20 per cent and March, 1933, by 44 per cent. For the first quarter of 1934, the industry was 30 per cent ahead in orders and 19 per cent in shipments compared with the first quarter of 1933. Shipments in March this year alone exceeded the same month a year ago by 37 per cent, and February of this year by ten per cent. Unfilled orders at the end of March were 84 per cent greater than at the end of March 1933.

OTHER CITIES PREPARE FOR COMMUNISTS

Paris Places Thousands Of Police On Duty To Handle Mobs Expected To Take Action Against Economy Decrees; Rumors Of Strikes Circulated In Havana; Austria Declares State Of Alarm

(By Associated Press) Police and soldiers in many lands were marshaled for extraordinary duty today as authorities braced for battle in outbreaks feared on May Day.

New York laid the most extensive plans in history to guard against violence as parades were announced in which 25,000 marchers were expected to appear. All police leaves were suspended for a period of special duty from last midnight until noon Wednesday.

Communists and their sympathizers will form one parade while socialists and affiliated groups have planned another. Other American cities made similar precautionary preparations today while French mobilization gave the country a war time aspect. In Paris alone 18,000 police, 10,000 mobile guards and 3,000 mounted guards will be ready for action if mobs take to the streets during May Day general strike against recent economy decrees. Military units in Paris and other cities will be held in readiness. Red flags flew and red signs popped out in many parts of Havana calling on all classes to join in the communist May Day demonstration in which 40,000 are expected to take part.

There are rumors of radical and anti-government strikes. Soldiers filled sand bag barricades at all bridges around the capital and made ready with gas bombs and bullets to meet any uprising.

Austria began its precautionary moves by rounding up known agitators and confining them to jail. A state of alarm already had been declared in Spain.

TO TALK BASE BALL TONIGHT

Street Dance To Be Given Tomorrow Night To Boost Local Club's Standing

A meeting of directors of the Greenville baseball club of the Coastal Plain league will be held at the Chamber of Commerce tonight at 8 o'clock for the purpose of discussing matters pertaining to the operation of the club this season.

Funds with which to finance the club are still to be raised and it was expected this matter would also be taken up by the directors.

Tomorrow night a street dance will be given on one of the streets opposite the court house for the purpose of raising additional funds for the club. The dance will be of the square variety and good music is assured, the committee on arrangements said today. One of the features will be Ballard's Jub Band. The dance will begin at 9 o'clock and last until the wee small hours. Members of the committee said they hoped people would turn out in large numbers and in this way do their bit toward financing baseball during the hot summer months.

Talk By Tugwell and
Snell Held 'Keynotes'
For Year's Voting

Two addresses delivered at Wash-
ington within the space of a few
days are widely heralded as "key-
notes" to the coming congressional
campaign.
For more than one reason, they
will bear the most painstaking ex-
amination by the curious.
Said Rexford G. Tugwell, premier
idea-man of the administration:
"It is my conception of the new
deal that it shall restore to men
the freedoms they have earned."
Said Bertrand Snell, Republican
leader of the north:
"The political philosophy of this
administration is that nothing must
be left to the individual citizen."
Certainly, if words could be relied
upon to express exact meanings,
there would be as clear-cut an issue
as anyone might desire.

Both Dr. Tugwell and Mr. Snell
want liberty, and every voter sim-
ply can balance up his affairs and
decide for himself whether he has
more or less liberty now than he
had before March 4, 1933.
Unfortunately there is a catch in
it. It lies in the age-old disagree-
ment as to what liberty really is.
Both also are against regimenta-
tion. But the administration spokes-
man means the regimenting of men
under the old industrial system; the
anti-administration spokesman has
in mind the regimenting of men
under government.
So there you are. It is that kind

a clear head."

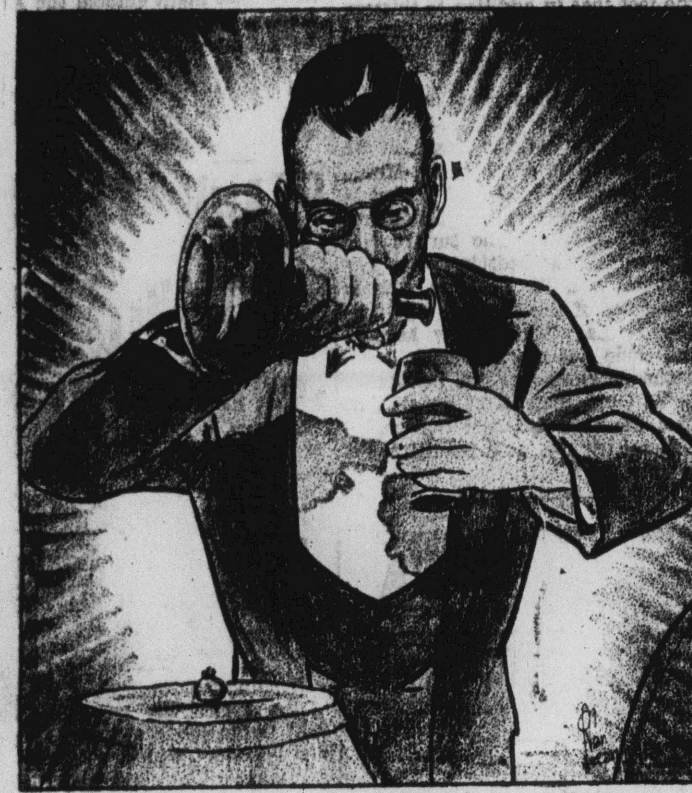
Dufresne smiled scornfully.

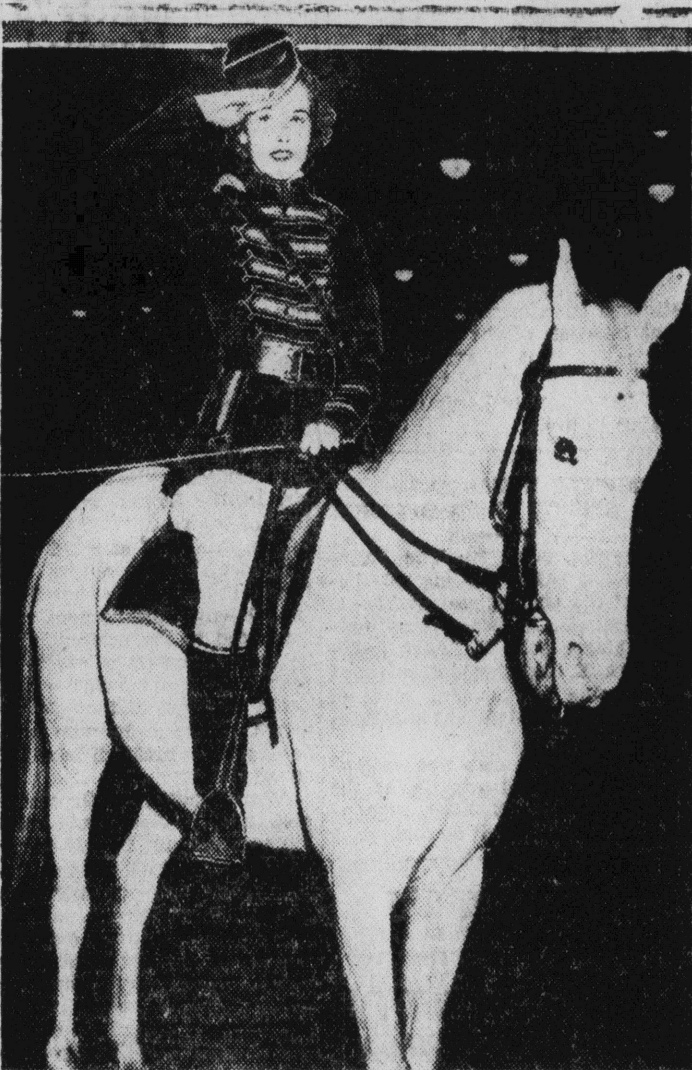

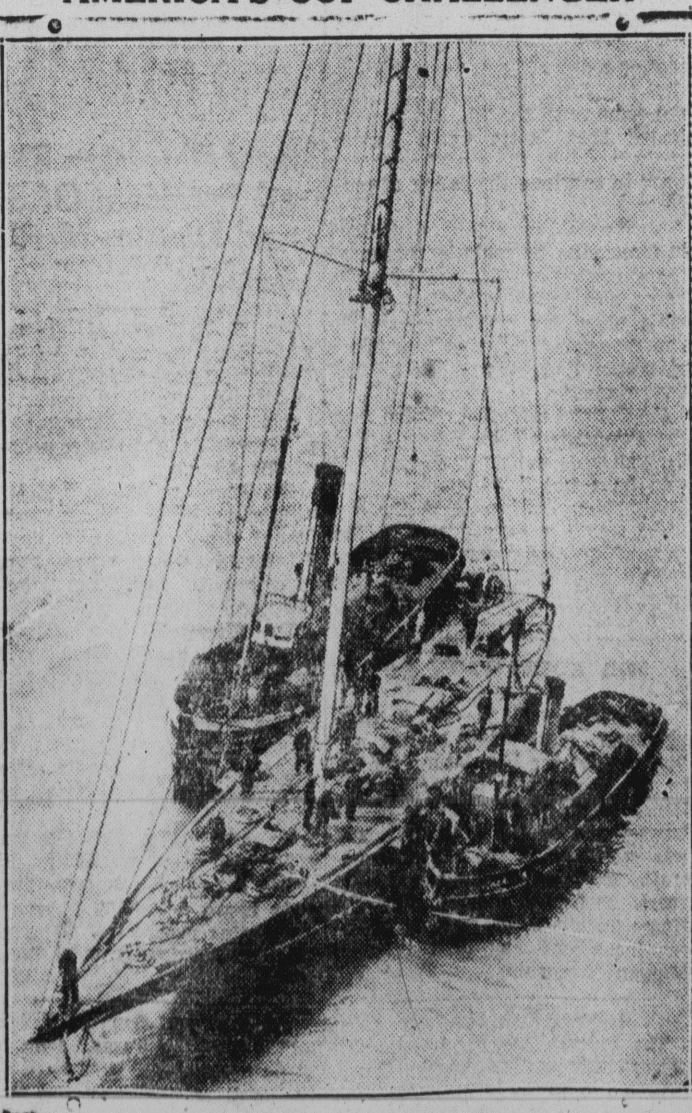

## CATHOLICS OPPOSE INDECENT MOVIES

The program outlined by the Bishop's committee of the Catholic Church for the combating of suggestive and immoral cinema pictures was inaugurated at the local Catholic Church yesterday. During the parish mass the pastor, Rev. Charles J. Gable, read a letter from His Excellency the Most Rev. Wm. J. Haley, which asked that every adult and child old enough to visit a theatre sign a pledge to avoid showings that were known to be indecent, and to promote as far as was in their power, clean and wholesome entertainment.

**Pledge of the Legion of Decency** (Sign and give to your Pastor) I wish to join the Legion of Decency, which condemns vile and unwholesome moving pictures. I unite with all who protest against them as a grave menace to youth, to home life, to country and to religion.

I condemn absolutely those salacious motion pictures which, without other degrading agencies, are corrupting public morals and promoting a sex mania in our land.

I shall do all that I can to arouse public opinion against the portrayal of vice as a normal condition of affairs, and against depicting criminals of any class as heroes and heroines, presenting their filthy philosophy of life as something acceptable to decent men and women.

I unite with all who condemn the display of suggestive advertisements on bill-boards, at theatre entrances and in newspapers, and the favorable reviews often given to immoral motion pictures in the daily press.

Considering these evils, I hereby promise to remain away from all motion pictures except those which do not offend decency and Christian morality. I promise further to secure as many members as possible for the Legion of Decency.

I make this protest in a spirit of self-respect, and with the conviction that the American public does not demand filthy pictures, but clean entertainment and educational features.

## INTERESTING ARTICLES BY PUPILS OF THE BELL ARTHUR HIGH SCHOOL

The article on the "University of North Carolina," by Nan Lucas Nichols, carried in our issue of April 26, and the one on "Our Trip To Chapel Hill," by Verna Joyner, in the issue of April 27, were written by pupils of the Bell Arthur school.

These articles and two others, one on "Duke University" in today's paper and another on "Duke Hospital" which will appear at an early date, were written on their impressions of Chapel Hill and Durham, on the recent visit of the Bell Arthur debating team when they took part in the state finals at Chapel Hill.

## Duke University

Duke University was built around the center of Trinity College, through the gifts of James B. Duke, tobacco king and a leader in the development of water power. He was born in 1857 and died in 1925. The University is named in honor of James Duke's father, Washington Duke.

Davidson College, Furman University, the Baptist College of South Carolina, were included among the beneficiaries of the endowment, as were also Johnson C. Smith University, the Negro College at Charlotte, N. C., and numerous other orphanages in the south.

In addition to the endowment for the University and other objects, he created a current building fund of twenty million dollars, the largest amount ever given an American university for this purpose. Of the twenty million dollars he left two million of it to be used in the study of the cause of pernicious anemia, the disease that caused his death.

When a person goes to the Duke Hospital he is charged according to what he has. If he is able to pay \$10.00 a day, he pays it. If he is able to pay \$2.00, he pays that, and so on.

The University covers about 100 acres of land in all.

The grizzled former cattle baron's sudden reappearance after his unexplained Mexican trip of a night and a half day was almost simultaneous with first public overtures to deal with the abductors.

**Talk Soviet Debt Problems.**  
Washington, April 30.—(AP)—Soviet-American debt problems and a 30-hour week agitation occupied President Roosevelt today while Congress dealt with stock market and municipal bankruptcy bills.
