SEVERAL KILLED IN COMMUNIST PARADE IN HAVANA

Disorders Also Mark May Day In Other Countries

MANY INJURED DURING RIOT THRU FRANCE

Precautions Taken to Guard Against Disorders in New York And Chicago; General Shutdown in Spain After Government Declares State Of Alarm; Disorder Feared Between Communists in Panama

Havana, May 1.—(AP)—Shooting started at noon today in the midst of a communist parade. Several were seen to fall dead or wounded. A dozen rifle shots were fired at 10:45 a. m. in the middle of the town. The shooting apparently was directed by civilians on house tops against the communists. The demonstrators were marching down Reina street when the shots rang out. Observers saw groups of civilians standing on the house tops. A first check of the casualties showed three civilians and one soldier had been wounded. Some of the civilians were in a serious condition.

(By The Associated Press) Police and soldiers threw a ring of steel today around demonstrations called in many parts of the world in observance of May Day. Paris, Madrid, Havana, New York, and Chicago were the chief centers of activity.

The French capital assembled a military camp as 30,000 police backed by 10,000 troops with machine guns and armored cars were called to cope with disorders. A policeman died at Anger in French Provincial rioting in which nearly 100 persons were estimated injured.

More than 1,500 police were assigned to special duty in connection with rallies and parades of communists and socialists in New York.

Precautions were taken to guard against bombing in Chicago where another heavy mobilization of police strength was ready for any eventuality.

Citizens of Spain laid in supplies for the day because of a general strike and government decreed state of alarm which brought a general shutdown.

Thousands of Cuban soldiers took special precautions against bombing of foreign property in Havana after requests for protection were made by United States, and German officials.

"A state of siege" similar to martial law was decreed throughout Argentina.

Disorders were feared between opposing communists and socialists factions in Panama.

Demonstrations scheduled were canceled at Santiago Chile, after three hours of fighting between workers and police which resulted in four fatalities.

An extra guard watched over the Presidential Palace in Mexico.

REAL ESTATE STILL SLOW

HIGHWAY FUND ABOVE FISCAL YEAR TOTALS

General Fund Revenues Reported Doing "Fairly Good" at Raleigh

Raleigh, May 1.—(AP)—Highway fund receipts of the State of North Carolina today passed the total amount they were estimated to reach for the entire current fiscal year and general fund revenues were "doing fairly good" though behind estimates, revenue commissioner A. J. Maxwell reported.

Payments of various kinds into the coffers of the highway fund reached \$19,330,694.44 yesterday and two more months of the fiscal year remain.

Mr. Maxwell said his recollection was the legislature was given an estimate of \$19,000,000 for the year.

Highway receipts last year for ten months were \$17,267,721.21. General fund revenues aggregated \$18,985,988.31 up to yesterday increase of \$5,373,465.81 over the same period a year ago with the three per cent general sales tax accounting for \$4,877,951.15 of the increase.

With two more months to go the sales tax collections must run close to a million dollars a month if the generally accepted estimate of what it would yield is to be reached. Though it was admittedly almost impossible to estimate the amount it would bring it was generally thought it would yield about \$7,000,000.

In order to provide a close check on all tax collections the entire field force of the department has been called in this week and each field man is making an office check on delinquencies in his district. He will then go back to his area and "go after them" Mr. Maxwell said.

Two Negroes Held On Murder Charge

Fayetteville, May 1.—Two young negroes, Vander Glover and Houston McMillan, are in jail here charged with the murder of Robert H. Williams, respected colored storekeeper who was found dead in his shop on Person street Sunday morning. Both have confessed, according to the police, though each blames the other for the actual slaying.

Apparently there was no clue to the solution of the mystery when Williams was found with his throat cut and his body soaked with kerosene, but within 24 hours two accused men were under arrest and the police had partial confessions from each.

Cost Of Gathering Taxes Decreasing

Washington, May 1.—(AP)—It cost the government about \$1,750,000 less to collect \$750,000,000 more in taxes during the first nine months of this fiscal year than it did in the corresponding period last year.

Guy T. Helvering, commissioner of internal revenue, reported today that it cost \$21,279,864 to collect \$1,962,339,156 for the nine months period against \$23,052,663 expended to collect \$1,164,421,906 last year. This year's collection includes such new items as the liquor and processing taxes.

Part of the decrease in costs was credited to statutory reduction of salaries. Other factors included failure to fill vacancies and the filling of vacancies at lower pay grades.

CONTRACT IS GAMBLING BY BRITISH POLICE RULE

Harrogate, England.—(AP)—A ruling by police here that bridge is a game of chance has thrown card-players into a turmoil.

Its immediate effect was the cancellation of a bridge congress, but it also has cast a shadow over proposed tournaments throughout the country.

The bridge congress was to have been held in a hotel which is licensed to sell liquor, and gambling is not allowed on licensed premises.

The police ruled that, even though the only stakes in the congress were trophies, the latter were equivalent of money. Lawyers have endorsed the decision.

Evidence Shows Huge Sums Made On N. Y. Stock Market

PECORA GIVES INVESTIGATORS NEW EVIDENCE

Exchange Members Made Nearly Billion Dollars in Past Six Years In Spite Of Depression; During High Times Income Of Various Members Went Beyond \$1,000,000 Mark

Washington, May 1.—(AP)—Evidence that New York stock exchange member firms have made nearly a billion dollars in the past six years despite the depression was presented today to a senate committee.

Ferdinand Pecora, counsel for the senate stock market committee placed before its reassembled members data showing that exchange firms average almost \$2,000,000 apiece in net profits during the boom and four depression years.

Gathered from member firms themselves the statistics showed they have had a total gross income of more than \$2,000,000,000 during the six year period.

During the high-time years of 1928 and 1929 their gross annual revenue averaged more than \$1,000,000 apiece.

These and a mass of other hitherto undisclosed statistics relating to market operations were presented to the committee as stock exchange control legislation approached the test in both houses of congress. Concededly the disclosure of this data was timed to put the bill "over the top."

The move followed close after charges in the house yesterday of a "vicious" campaign of misrepresentation against the legislation by the New York stock exchange.

SEARCH CONTINUED FOR MAN'S ASSAILANTS

Wilmington, May 1.—(AP)—New Hanover county officers continued their search today for the assailants of Karl Hayduck, 26, who was found unconscious Saturday night 6 miles north of Wilmington on a road near his home.

Hayduck's pants pockets had been turned inside out. Sheriff C. David Jones said Hayduck had been slugged and robbed of \$70. Two negroes were held for questioning in connection with the case.

Resists Payment Of Stock Assessment

High Point, May 1.—(A)—Dr. C. D. Thompson of this city, appealing from a \$2,500 assessment levied by Commissioner of Banks Gurney P. Hood on relation of the High Point Morris Plan Bank, alleged in a paper filed in superior court that the bank is not insolvent and that by proper liquidation can pay all its depositors in full.

He asserts that his stock in the corporation was acquired long before enactment of a state law in 1925 which provides for bank stock assessments and it is alleged that the law cannot be construed as retroactive without violating constitutional rights. The appellant asks the court to cancel the levy docketed by the commissioner.

Martin Farmer Takes Own Life

Williamston, May 1.—Jesse B. Griffin, prominent farmer of Martin county, killed himself at 8:30 Sunday night by shooting himself through the head with a shot gun. Members of the family say they cannot account for his act.

Griffin, complaining of a toothache, left his wife and son indoors and went out on the porch of his home. The report of a gun followed shortly. He had attached a string to the trigger.

Late News Flashes

Amendments To Kerr Bill. Washington, May 1.—(AP)—Four important amendments, one of which would in effect reopen the voluntary reduction program to tobacco farmers, were adopted by the House agricultural subcommittee today in favorably reporting the Kerr bill for tobacco reduction control.

The committee changed the flat tax rate of 25 per cent of the market value which would be levied on all tobacco sold outside of the voluntary reduction allotment to a flexible rate of 25 to 33-1/3 per cent. The exact rate would be fixed by Secretary Wallace.

Two amendments are designed to take care of small farmers and those ineligible for the reduction plan.

One of these would give Secretary Wallace authority to apportion five per cent of the total production covered in the contract to "persons engaged in production of tobacco as to whom the secretary determined that no equitable allotment" of production is accessible under the voluntary plan. The other provides that the secretary "may make regulations protecting the interest of share-croppers and tenants in the issuance of tax payment warrants under this act."

A Cuban youth, Joseph Lombillo 30, and Nicholas Bruno, 20, of West Chester, both seniors at the preparatory school in nearby Malvern, were charged with manslaughter and held in \$800 bail each.

The material witnesses are Frank Midgette, 19, of Manteo, N. C.; John Ruda, 20, of Milford, Conn.; and Thomas Welham, 18, of Philadelphia.

Italy Plans To Increase Her Military

Rome, Italy, May 1.—(AP)—Italy has determined to increase the power of her military while at the same time seeking an arms agreement under which Germany would be permitted moderate rearmament, the Associated Press learned today.

Henceforth it was disclosed the Italian government will proceed in military matters along two lines.

First: To plead the cause of limitations of armaments at present levels—with threatened rearmament of Germany.

Second: To add the greatest possible amount of efficiency to Italian military forces.

The policy was enunciated by high officials in commenting on King Victor Emmanuel's declaration Saturday for a strengthening of military arms.

17 Cars Jump Track Blocking Railroad

Gatesville, May 1.—The Atlantic Coast Line Railroad at Eure was open today after being blocked since late Saturday night when 17 cars jumped the track as a through freight, southbound, was passing the Eure station.

One of the cars, a tanker filled with tar, went through the south end of the station almost completely wrecking the structure.

W. H. Cowan, a flagman, received minor injuries. He was the only person hurt.

Of the 17 cars which left the track, all but three were loaded. Some of them had new cars and other merchandise. Officials estimated the damage between \$10,000 and \$15,000. The cars which left the track were in the middle of the train. The freight operates between Norfolk and Rocky Mount.

COUNTY COURT BACK AT WORK

Comparatively Light Docket Heard Today After Inactivity Of Two Weeks

County court, which has been inactive here for the last two weeks owing to the two-week term of Superior court which was concluded last week, resumed its regular Tuesday sitting today with Judge Dink James on the bench.

The docket was comparatively light considering the long time between sittings, only about fifteen-odd cases being docketed up to today.

As customary, the majority of cases consisted of violations of prohibition and traffic laws and a few minor cases of larceny.

Barring eventualities, work was expected to be completed during the late afternoon or possibly tomorrow morning.

Violations have been at a minimum in Greenville and other parts of the county the last several days and this accounted for the slowness of the docket.

Police here over the week-end reported only a few arrests for minor violations and the majority of these actions were directly disposed of in police court. A similar situation was reported in other parts of the county.

Denied Review In His \$100,000 Damage Suit

Washington, May 1.—(AP)—C. W. Upton, police officer at High Point, N. C., was denied a review by the Supreme Court yesterday on a \$100,000 damage suit against J. Frank Harrison.

Upton asserted Harrison while trading as the Greensboro Coca-Cola Bottling Company had sold him a bottle of Coca-Cola which contained glass and which seriously injured him. The suit, begun in October, 1932, in the state courts, was removed to the Federal district court for middle North Carolina which dismissed it. The Fourth Circuit Court of Appeals affirmed its action.

Upton contended he had not been granted a fair trial and asserted there had been tampering with witnesses.

THERE ARE OTHER SOURCES

In his address here last Saturday afternoon Attorney General Dennis G. Brummitt made it clear that the sales tax is not essential to the operation of the school system in North Carolina and that there are other and sufficient sources from which all needed revenue could and should be procured. Proper revision of the corporation franchise taxes basing same upon the actual value of the outstanding stock or the net earnings rather than on the par value of the stocks will add millions to the revenue and be far more equitable than the present system according to Mr. Brummitt, and this is one source to which the legislature should turn.

Repeal of the statute that exempts stocks in foreign corporations from taxes in this state would likewise swell the state revenues probably two millions of dollars or more, and a recapture of some of the present great savings enjoyed by the power companies and similar corporations would add still more millions to the state treasury. And mind you, each of the above mentioned suggestions would not be taxing to destruction for certainly ability to pay should be the first consideration in levying taxes and the concerns showing the greatest net profits are certainly most able to bear the greatest amount of taxes. There is no reason why a holder of dividend paying foreign stocks should have his property exempted from ad valorem taxes while a farmer with a farm upon which he is unable to make a profit is forced to pay his yearly tax toll regardless.

These are just some of the sources from which the necessary state revenues can be derived if the legislature is of a mind to deal out justice and certainly in view of this the sales tax is not only a non-essential but in equivalent to taking from those who have not in order that those who have might continue to accumulate more without bearing their just part of the tax burden.

The Duke Chapel is made of bluish gray stones, it has very pretty green grass and shrubbery around it. We went in some large doors, where we saw a large book and pencil. Miss Dilda told us it was for visitors to write their names, the date and their addresses. We walked up to the pulpit where the pipe organ was and then into one of the Sunday school rooms. New Books

By JOHN SELBY

It must be some sort of celebration when two books on the same infrequently treated subject arrive. Such as Gilbert Seldes' "Iron, Blood and Profits," and "Merchants of Death," by H. C. Engelbrecht and F. C. Hanighen. These three gentlemen are out to expose and sometimes castigate the international armament "racket"—but they do it in quite different ways.

Messrs. Hanighen and Engelbrecht use the historical approach. They begin circumspcctly with the importation of gun powder from China in the Middle Ages and trace the development of the munitions business, its scandals and its ramifications, from that point.

Whereas Mr. Seldes is much more dramatic. He goes in for what might be called hysterical exaggeration, declaims a good deal and offers largely the same facts in the end.

Those facts are rather horrible—men of one nation being killed by men of another nation, but with arms sold to Nation two by Nation one; graft high and low, and propaganda that tends, according to Mr. Seldes, to create war where "war might not otherwise be had.

Those who want their facts not too highly tinted may choose "Merchants of Death." For those who enjoy a little lusty shouting there is Mr. Seldes' book.

"Journey to the End of the Night" by Louis-Ferdinand Celine (Little Brown): Part of the life story of a man who is an expert at looking upon the seamy side; everything, to M. Celine's Bardamu, is horrible, perverted, bitter—in Bardamu's own argot, "pretty damn lousy."

"Two Loves Have I" by Clara Longworth de Chambré (Lippincott): The novelized love life of one William Shakespeare, including the countless own solution of the "Dark Lady" mystery.

"The Dreamer," by Julian Green (Harpers): What the fantasy-life of a French youth does for him, for a girl, and for the girl's mother; an often beautiful study of three small frogs in a very small pond.

A Washington Day Book

Washington — The latest addition to that vaguely-defined but much discussed governmental group known as the "brain trust" has made its appearance at the treasury.

At last the group of treasury officials who gather with Secretary Morgenthau every morning of the week for a conference which usually lasts from 30 minutes to an hour have been so designated.

Newsmen assigned to cover the treasury haven't been able to find out what transpires at these regular morning conferences. Their best guess is that current and future policies are threshed out.

Certainly the "brains" of the department are present. A roll call would disclose such names as the following:

Secretary Morgenthau, Herman Oliphant, general counsel to the secretary; Herbert Gaston, in charge of press relations; William H. McReynolds, administrative assistant to the secretary, and T. Jefferson Coolidge, recently appointed under-secretary.

Treasury Revamped
There was a time when the treasury was probably the most decentralized department of government in Washington. Since Morgenthau took control, however, it has become just the reverse.

Where in former days the secretary remained aloof, almost apart from personal contact with his various bureaus and their chiefs, Morgenthau has a fairly good idea of everything going on in the department.

Once a week he holds a regular staff meeting of all his bureau chiefs, from the collector of the bureau of internal revenue to the chief of the secret service.

The problems of each bureau are canvassed and talked over. These weekly meetings are much the same as the executive of a big business concern would have with his subordinates.

Roosevelt Hand Seen
An excellent example of how Morgenthau goes in for this sort of thing is the recent meeting he had here with collectors of internal revenue from all over the country. There plans were made to launch an intensive campaign to collect back taxes owed the government.

Many profess to see the hand of President Roosevelt in this newly-organized treasury efficiency. It wouldn't be far wrong, perhaps, to say that Mr. Roosevelt is his won secretary of the treasury. Certainly his hand has been clearly evident in all policies pursued by that department thus far in his administration.

Communists Riot In Paris.
Paris, May 1.—(AP)—Fifteen hundred communists after an afternoon long demonstration at the Porte de Vincennes, attempted shortly after dusk to march into the heart of Paris but were smashed back by the police who injured ten with their clubs.

The 1,500 were part of a mass meeting of 15,000 communists who gathered during the day in the Vincennes woods.

The smaller number started for the city despite police warnings. When they reached Vincennes the demonstrators charged into the crowd, the manifestants were scattered into side streets and their hand-to-hand battling continued in small groups. The resistance was quickly snuffed, however.

Elsewhere in the country radical attempts to celebrate May Day with general strikes appeared a failure.

Socialists Active In Vienna.
Vienna, May 1.—(AP)—Airmen roared over the romantic woods of Vienna while demonstrators raced into the concealed spot to raid May Day mass meetings of Socialists defying an order of Chancellor Dollfuss today. Several persons were captured.

One communist was reported killed near Nuervuschaing, Styria, by a member of a motorcycle troop of 170 fascists from Italy who were riding to Vienna to participate in the celebration.
