ROOSEVELT INSPECTS U. S. FLEET

Annual Review of American Fighting Craft Staged Off Ambrose Lightship

U. S. Indianapolis, May 31.—(AP)—The cruiser Indianapolis for a review of the fleet got under way at 10:45 a. m. (Eastern Standard Time) today after coming to anchor because of fog.

New York, May 31.—(AP)—Concerning the Presidential salute of 21 guns and flying the pennant of the Secretary of the United States Navy, the heavy cruiser Indianapolis with President Roosevelt aboard started down the Hudson River shortly after 8:30 a. m. today for its annual rendezvous with the United States fleet at sea.

The mighty fighting vessel carrying the nation's high command of the naval fighting forces was a stirring spectacle as she pointed her long gray nose seaward for Ambrose light.

Following in the wake of the Indianapolis was the heavy cruiser Louisville flying the pennant of the Assistant Secretary of the Navy Henry L. Roosevelt. Aboard the Louisville was the bulk of the representatives of the official party, invited guests, newsmen and naval officials.

SPEND RECESS IN EFFORT TO STOP CLOSING

While Leaders Attempt to Settle Rift Between France and Britain, Leading Nations of World Look After Implements of War; U. S. Stages Fleet Review, Japs Launch Cruiser; Germany Celebrates Jutland Victory

(By The Associated Press) Following a rift between French and British representatives, the Disarmament Conference was in recess today in Geneva.

The biggest display of naval power in the history of the United States—ninety-six warships at sea in review before President Roosevelt.

NEGRO STILL ALIVE IN SPITE OF RUMOR HERE

Lee Knight Interviewed in Jail Says he Has Not Been Object of Mistreatment

Lee Knight, colored, arrested by sheriff's officers about two weeks ago following a gun battle and fist fight in which two officers were injured, is not dead but is very much alive, in spite of rumors circulated throughout the community the last few days that the negro had died from mistreatment at the county jail and his body secretly removed and buried.

On basis of the rumors which spread considerably yesterday and last night, a representative of the Daily Reflector visited the jail this morning and found that Knight was not only well but had not been subjected to mistreatment during his jail confinement.

Knight said that in the last two days several people had been to the jail fence to see if he was still there and told him it was reported on the streets he had died.

When the rumors first gained circulation, the Reflector representative inquired of Sheriff Whitehurst if there was anything to the reports of Knight's death, and upon being assured by the officers the negro was still alive and all right, no further action was taken.

HOOD LOSES SUIT AGAINST OIL COMPANY

Gurney P. Hood, state bank commissioner, lost his suit in civil superior court here yesterday to recover on a stock assessment for \$3,000 in the defunct Citizens Bank of Farmville against the Farmville Oil and Fertilizer Company.

The jury held the shares of stock involved in the suit were not the property of the fertilizer concern, and the burden now falls back upon R. E. Fields of Farmville, original owner of the shares, against whom a verdict for the amount was returned by a jury in a former session of court.

R. E. Fields, original owner of the stock, had placed it as collateral on a note to the Farmville Oil and Fertilizer Company.

Hood first brought suit against Fields and obtained judgment for the full amount. Fields, however, contended the stock was owned by the Fertilizer company and that he was not the right person to pay.

The jury found that the fertilizer concern was not the owner of the shares and this left Fields subject to provisions of the original judgment.

The case was begun yesterday morning and completed during the afternoon. Court immediately adjourned when the jury answered the issues.

Around a dozen cases were disposed of during the week, bringing the total for the two week term to approximately 35. The remainder of the cases on the calendar for this week were continued.

HUTTON WILL BRING BARBARA BACK TO N. Y.

ASKS CONFAB WITH STRIKE MOVE LEADER

Hugh Johnson Orders Thomas McMahon, To Confer With Him Next Monday

Washington, May 31.—(AP)—Thomas McMahon, president of the United Textile Workers of America, which called a general strike in the cotton textile industry for Monday, was summoned today for a conference with Hugh S. Johnson, NRA administrator.

Johnson's request for the conference today was unexpected. Johnson—the cotton textile code authority, Robert Bruere, chairman of the cotton textile industrial relations board and union officials are to meet tomorrow in an effort to avert the walkout.

The possibility that President Johnson might take a hand personally in the negotiations if his NRA lieutenants are unable to avert the walkout, was seen today in some quarters.

SUFFRAGE DOUBLES COST OF ELECTIONS IN CUBA Havana.—(AP)—The Cuban government expects that women's new privilege of voting will cost it about \$50,000 in the presidential elections next fall.

BIG CROP OF CANDIDATES IN THE FIELD

Interest Centers Around Fight For State Senate, House And Several Other County Posts; Balloting to be Conducted From Two Entrances of Court House Here

Political candidates in Pitt County were making their final round-up of constituents today in preparation for the State-wide primary to be held Saturday.

Some of them were confident of victory and some not so confident, but all were putting forward a bold front hoping to impress the public with their ability to face everything with a smile—even the disapproval of their opponents.

The political pot has been putting on additional steam constantly for the last two weeks, and tomorrow will find it almost ready to explode as the candidates make their last canvass before their fate rests in the hands of the voters.

Although a large vote is expected in all sections of the county, it is not expected to be as large as in the last general election when Pitt countyans went to the polls in unprecedented numbers to help place Franklin D. Roosevelt at the helm of government at Washington.

In an effort to prevent some of the congestion always manifest at the polls in Greenville, the Board of Elections has made arrangements for votes to be cast at both entrances of the courthouse. This was tried out in the former election, and to some extent, helped to reduce the jam experienced other days when there was only one place to vote.

The candidate crop is large this time, one of the largest in years, and while some are going to be left in the lurch, others are going to ride into office on a wave of popular acclaim. Because of the reported closeness in the contest of some fields it is generally conceded that a second primary will have to be held to determine the winner.

How- ever this is purely problematical, as politics is fickle as the weather, and there is no telling the way ballots are going to drift.

Navy To Stage Sea Pageant for The President

By ALEXANDER R. GEORGE

Washington, D. C., (AP)—The national spotlight will shift from Washington to New York on May 31 when President Roosevelt reviews the massed naval power of the United States moving in majestic procession from the blue waters of the Atlantic to anchorage in the Hudson River.

This year's review, the first since 1910, is expected to be unusually spectacular because it will include scores of naval planes in new breath-taking maneuvers against the background on Manhattan's skyline. Some ninety ships, ranging from sloop, sloop destroyers to massive battleships, will come up over the eastern horizon in a long column led by the flagship, the Pennsylvania, flying the 16-star blue flag of the fleet's commander, Admiral David F. Sellers.

Salute the President

As the war vessels come abreast of the President's flagship, the new treaty cruiser, Indianapolis, their crews in full dress will give the band salute, the guards will present arms, the band will play the national anthem with ruffles and flourishes and the guns of each ship in succession will thunder the Presidential salute of 21 salvos fired at five second intervals.

After the aircraft carriers Saratoga and Lexington pass in review, they will swing out of the column and proceed to positions advantageous for launching the planes massed on their decks.

While the surface ships churn great lanes of white in the blue seas as they move toward New York, the airplanes will fly in echelon, soar and dive and lay down thick smoke screens to obscure the fleet.

Flying Presidential Flag

President Roosevelt will be on the bridge of the Indianapolis anchored near Ambrose lightship and flying the Presidential flag which has the United States seal in colors surrounded by four white stars on a dark blue field. On board with him will be Secretary Swanson of the Navy Department, Admiral William H. Standley, chief of naval operations, and members of the President's Cabinet.

The heavy cruiser Louisville, anchored near the Indianapolis, will fly the flag of Colonel Harry L. Roosevelt, Assistant Secretary of the Navy. It, also, will carry distinguished guests.

After the flagship Pennsylvania, slated to pass the Presidential ship at 11 a. m., will come the huge air-

Whit House Gets Painting of T. R.'s Ancestral Home

Rosewell, Ga.—(AP)—A CWA artist's painting of Bulloch Hall, antebellum home of President Theodore Roosevelt's mother, Martha Bulloch, has gone from here to hang in another great white house in the nation's capital.

Mrs. Frances Lee Turner, of Decatur, Ga., mother of seven children, did the work and sent it to Washington for exhibition.

President Roosevelt, whose wife is a niece of Martha Bulloch, recognized the old mansion immediately and requested that the picture be transferred to the White House.

All of that has served to freshen the many traditions of the time Theodore Roosevelt, Sr., the former President's father, came here from New York by slow train and slower stage coach to woo and wed Rosewell's beautiful belle.

Bulloch Hall was built in 1840, at the peak of the Old South's agricultural prosperity. Time has dealt gently with it, leaving nothing but the style of architecture to indicate its age.

Vass, N. C., May 31.—Plans for marketing this season's dewberry crop are going on apace. The auction shed is being enlarged, trucks are busy distributing crates, and buyers are expected to arrive in town the latter part of this week.

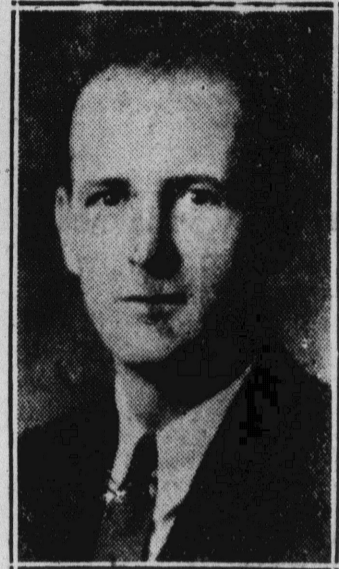

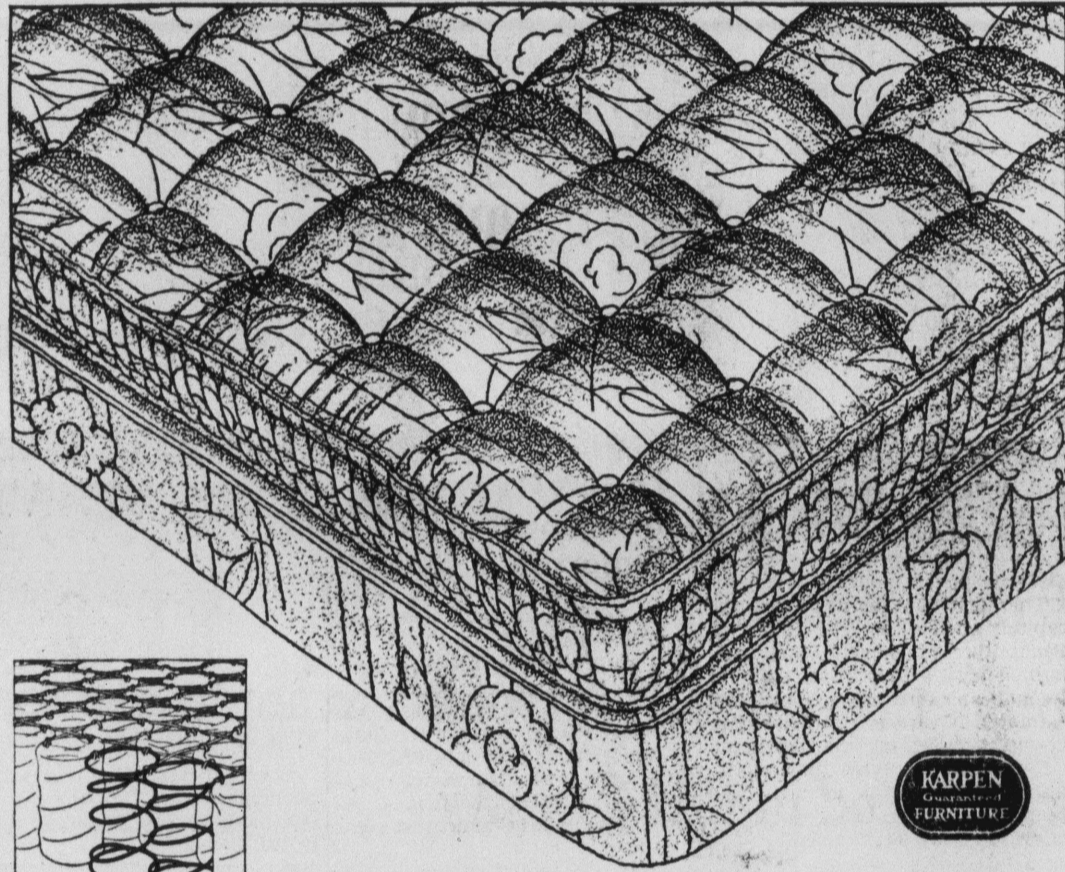
