PERKINS WILL ASK FOR SECOND PRIMARY HERE

Abernethy Loses Out In Fight For Seat In Congress

COOLEY WINS IN BALLOTING IN THE 4TH

Three Incumbents In Other Districts have Fairly Easy Sailing; Stanley Winborne is Renominated for the Utilities Commission on Basis of Returns from Half of State.

Charlotte, N. C., June 4.—(AP)—There will be two new faces in North Carolina's congressional delegation as result of Saturday's Democratic primaries.

The veteran, Charles L. Abernethy, rounding out his seventh term from the Third District, was eliminated from a second primary June 30 on the face of fairly complete unofficial returns.

Harold C. Cooley, Nash County attorney, will be the Fourth District's new representative succeeding the late Edward Poul, who was dead of the House at the time of his death, April 1.

The Democratic nomination is equivalent to election.

With only seven precincts missing, Abernethy was trailing the two leaders by 1,300 votes. Graham Barden, of New Bern, was in the lead with 7,908 votes, and Luther Hamilton of Morehead City, was second with 7,214. Abernethy's vote was 5,900.

Cooley was nominated by a majority of about 1,000 votes over four opponents, including George Ross Poul, former State Prison superintendent, and the son of the man who represented the Fourth District in Congress for 33 years.

The three other incumbents had easy sailing except Representative A. L. Bulwinkle of the Tenth District, chairman of the Congressional Committee which investigated the Work case. Representative Bulwinkle fairly nosed out Hamilton Jones, Charlotte attorney.

Fairly complete returns gave the incumbent a narrow margin of about 2,500 votes.

Stanley Winborne was renominated as Utilities Commissioner by a 3 to 1 margin on the basis of returns from half of the State's 1,832 precincts in the only contest involving a State-wide office.

E. C. Macon, of Asheville, was his only contestant.

Representative John H. Kerr apparently won the nomination in the Second District, 64 of the 115 precincts giving the veteran Kerr 10,180 and A. O. Dickens, of Wilson, 6,965.

BIBLE SCHOOL TO OPEN HERE ON JUNE 18TH

Study and Recreation to be Provided For Children Over Period of Month.

The Vacation Bible School sponsored here by the churches co-operating with the city school system will open June 18 and continue through July 13. The school will be held at Third Street School and is expected to play an important part in providing study and recreation for children during the summer months.

The school will hold its session daily from 8:30 to 11:30, from Monday to Friday. Both the school buildings and grounds will be used in the extensive program outlined for the month.

Miss Louise Galphin, member of the faculty of city schools, has been selected as principal of the Bible School and will be assisted by the following staff of teachers:

Beginners' Department, Misses Jane Hadley and Louise Curran, for children four to five years old.

Primary Department, Misses Lois Herring and Mary Wise Davenport, for children six, seven and eight years old.

Junior Department, Miss Ruth Hillhouse and Mrs. W. E. Brewer, for children nine, ten and twelve years of age.

The Intermediate Department will be taken care of by Miss Galphin and Miss Hillhouse. Miss Mosele Jones will have charge of children thirteen to fourteen years old. She will also direct all music work of the school.

The program of work is an extended one, consisting of morning worship, Bible stories and studies, character and habit studies. Hand-work will supplement the studies along with guided play periods. There will be several types of hand-work, including basket-making. Manual training will also be a part of the program.

The school is being conducted by the various churches of the city in conjunction with the public school system in an effort to meet the juvenile situation here.

During the week announcements concerning the costs and funds necessary to the operation of the school will be made. Several organizations of the city are backing the movement, which it is believed will be instrumental in improving the spiritual and moral life of children during the summer.

J. R. WHICHARD PASSED AWAY EARLY TODAY

Funeral Services to Be Conducted From Baptist Church Tomorrow Afternoon

Julian R. Whichard, 75, native of Greenville, and one of the founders of The Reflector, died early today following a period of ill health of several years.

Funeral services will be conducted by Rev. A. W. Fleischmann, at Memorial Baptist Church at 4:30 tomorrow afternoon followed by interment in Cherry Hill Cemetery.

He is survived by a daughter, Mrs. Thomas Barney, of Atlanta, Ga., and two sons, Robert D. Whichard, of this city, and W. B. Whichard, of Silver Springs, Md., and a sister, Mrs. Ora Whichard Kennedy of Bertie County.

Mr. Whichard was born in Greenville, January 11, 1859, the son of the late David Fleming and Violet Jordan Whichard. While in their teens he and his brother, the late David J. Whichard, were connected with the Greenville Express, Pitt County's first newspaper. The Express was discontinued the first of January 1882, and on the 13th of the same month the brothers published the first issue of The Reflector. After a few years on The Reflector J. R. Whichard disposed of his interests in the paper to his brother and went to Salisbury where he was engaged in the newspaper business for several years. He continued active in the newspaper field until about 1905. His years of newspaper work covered several fields, including Greenville, Snow Hill, Hickory and Albany, Ga.

After retirement from the newspaper field Mr. Whichard returned to this city to engage in other business, and during the latter years of his business activity was wamer and operator of the Protor News Stand here. Ill health forced his retirement from business about four years ago.

WILL SEEK MORE VOTING PLACES HERE

Dr. Fitzgerald Will Ask Elections Board for Four Balloting Places in Greenville.

Additional voting places to take care of the tremendous vote cast in Greenville township, the most populous of the county, will be sought at the next meeting of the County Board of Elections, it was revealed today.

Dr. Paul Fitzgerald, member of the board, said he would propose that four voting places be provided in Greenville for the next election in an effort to speed the compilation of ballots. Ballots were cast at two places at the court house on Saturday's primary and two sets of counters were used in compiling the returns. Due to lack of counters the final tally was not completed until yesterday afternoon about 3 o'clock.

Dr. Fitzgerald, who proposed that balloting places be increased several months ago, but failed to get support, said the need of greater speed in the handling of the ballot was imperative. He stated that the population in this township had increased to such extent that it was practically impossible to care for the vote with balloting places only at the court house and two sets of

YOUTH HELD FOR SLAYING HIS MOTHER

Los Angeles Man Also Confesses Hatchet Slaying of Brother.

Los Angeles, Calif., June 4.—(AP)—Louis Rudd Payne, 21, crushed under the strain of an all-night grilling by police had confessed early today of the hatchet slaying of his mother and brother in their Westwood mansion here.

"I killed them last Tuesday night," detectives quoted him as saying. "Many things my mother and brother had done to be finally multiplied in my mind, and at last something set off the spark and I couldn't stand it any longer, so I killed them."

Mrs. Carrie L. Payne, 45, and her son, Robert, 14, were found hacked to death in the bedrooms of the luxurious Spanish type Payne residence near the University of California, at Los Angeles, campus yesterday.

Several hours later an alarm was broadcast for Los Angeles, but before the extensive police net had been spread he nonchalantly walked into the Hunting Beach police station, thirty miles south of here, with the announcement that he was wanted for murder at Los Angeles.

COLLEGE HERE HOLDS FINALS

Gov. Ehringhaus and Dr. Idleman of New York Speakers At Commencement.

Governor J. C. B. Ehringhaus made a splendid impression in his commencement address at East Carolina Teachers College on Saturday night. He was most happy in his opening remarks.

The theme of his address, Character Building, was peculiarly appropriate at this time and place, and tributes to Dr. Wright made his audience feel that this "great and good man" was a supreme example of one whose life was built on the laws the Governor laid down as fundamental.

"Everything is controlled by law," was the guiding principle he laid down, and he firmly believed the laws that lead to sound character and success are based on three essentials, those of work, of ideas, and of ideals.

His tributes to Dr. Wright showed a sympathetic understanding of the character of that great builder of the institution and builder of character of girls and boys who attend it. The college, he said, in a very real sense is his lengthened shadow, and he put into it as much consecrated effort, as much devotion as it is possible for one to contribute to any cause. "Hereabout somewhere rests a very gallant gentleman," he quoted in referring to the abiding presence of the "great and good man," and his spirit will always be present as a blessing, whenever a group of interested souls gather here, now or in other times.

Late News Flashes

Arming For Strikes Washington, D. C., June 4.—(AP)—President Roosevelt was informed today by Governor Pinchot, of Pennsylvania, that steel companies are arming in preparation of threatened strike of workers. Their talk was at a time when the President was depending on Hugh Johnson to find means to avoid the strike.

The NRA chief, which his aides would not admit it, was believed to be in conference at a hotel with A. E. Erwin of U. S. Steel.

On leaving the White House Pinchot told newsmen he had called simply to report the situation as bad.

"The steel companies are arming," he said; "I am ready to meet whatever situation arises."

He had not asked for Federal intervention, but said he was interested mainly in making a report. (Continued on Page Four)

EDWARDS NOT DECIDED IF HE WILL RUN OVER

Former Member Of House Says He Will Know In Few Days If He Will Ask for Run-Off with John Hill Paylor; Another Race in this Township Possible; Second Balloting Three Weeks from Date of First Primary.

A second primary will be called to settle the race for Treasurer of Pitt County between A. T. Moore and J. Vance Perkins, it was revealed today.

Perkins, who ran second to Moore in Saturday's State-wide primary, said this morning he would ask for a run-off primary to settle the race. Moore is the present incumbent.

The race for County Treasurer was a six-cornered affair with Moore polling a plurality vote of 2,649; Perkins, 1,691; G. L. Rouse, 1,260; C. C. Martin, 950; W. E. Warren, 907; and C. W. Willard, 801.

The race was one of the tightest of the primary which brought out the greatest vote in the history of the county.

Jack Edwards, former member of the House of Representatives, who ran third in a four-cornered race for his old seat, said today he had not made up his mind whether to ask for a run-off vote with John Hill Paylor, of Farmville. He said, however, he would make up his mind within the next few days. M. O. Blount, of Bethel, obtained sufficient votes to assure his nomination.

The vote for Blount was 5,185; Paylor, 3,525; Edwards, 3,371, and Eure, 2,844.

There is a possibility of a run-off race between "Snoc" Smith and Gus Stokes for township constable, but Smith had not announced today whether he would enter the second race. Stokes lacked about eight votes having a majority over the several candidates entered for the post. F. C. Harding, chairman of the Board of Elections, said this morning it would be necessary for candidates to file application within five days after the date of the election. He stated the second primary would be held three weeks after the date of the first primary if it should be asked for.

Although Perkins had not formally filed application with the Elections Board this morning, he said he would do so in proper time.

On basis of the complete but unofficial returns, the following were nominated for the Board of County Commissioners eliminating the possibility of a second primary in the nine-cornered race: Roy T. Cox, B. M. Lewis, G. S. Porter, Walter Cherry, and J. N. Williams. Only two of the old members were returned, Cox and Williams.

Miss Hardee Passes Away; Burial Today

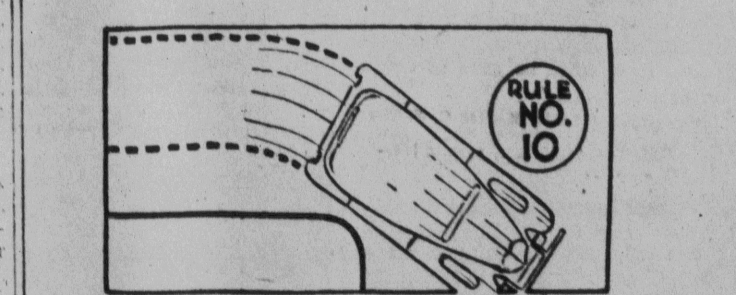
Miss Louisa Hardee, 70, died suddenly from a heart attack last night at the home of her sister, Mrs. William Braxton, of the Smith Mill community.

The fact that it took until

morning to complete the

count of the votes in the

Chicod township box, and

until about three o'clock in

the afternoon to complete

the count here, should be

sufficient to convince all that

it is necessary to split these

boxes in order to provide

better facilities for voting

and easier tasks for those

whose duty it is to remain on

the job from the time the

polls open until the count is

completed.

The method used in voting

and counting here Saturday

was the same as if it were

two polling places and yet

the election workers had to

remain on continuous duty

for about 36 hours. When

the election officials take up

the matter of providing more

voting places in the Green-

ville and Chicod precincts it

is our opinion that there

should be four voting places

in the Greenville precinct

and three, or at least two, in

Chicod. By splitting these

boxes in this manner it

would cut the number of vot-

body, with mind and spirit in

control.

"when his spirit is unbound,"

the speaker inquired what

College Here Holds Finals
(Continued From Page One) South, whereas now it is a distinction, a badge of honor, idealized by the poets.

Thought, the product of ideas, he gave as one of the most potent factors in individual success.

"Thought is the one road on which one may ride to progress." He made an earnest plea for honesty, of thought, thinking for themselves.

He said he would like to preach a sermon on the text, "Thou shalt not steal," and gave dishonesty in thinking as the most reprehensible of all things. His definition of education is "a process of finding out how very little we know."

The only time the Governor reminded the graduates of their obligation to the State, as students in a State institution, was when he begged them to show their gratitude to the State by thinking honestly on the problems that concern the welfare of the State.

Consecration and devotion to ideals, those that lead up instead of down, he gave as the climax of character training. He contrasted Lee with Napoleon, and the disciple who preached the gospel of law with Judas, as examples of those who chose differently.

Dr. L. R. Meadows, acting president of East Carolina Teachers College, in introducing the Governor, called attention to the fact that he was one of the founders of the college, one who worked hard for the establishment of the school. He gave four achievements that stand out in his two years' record as Governor. He has materially reduced taxes on land; he has helped the farmer get higher prices for his produce; he has given the people an eight months' school term; and he has made more friends than any other Governor ever made in his short period of time.

A great sermon, beautiful music, the dignified, impressive procession—all giving a note of formality—all made the services of the commencement Sunday, June 3, at East Carolina Teachers College a most inspiring occasion.

Dr. Idleman, the distinguished New York preacher who delivered the message of the day, voiced the feelings of the congregation when he said a man must have a heart of stone if he were not inspired by the sight. He spoke of the day as one of consecration for the graduates before him, who, through the discipline of the mind and college experiences, were preparing for the morrow. He compared them to the knights of old who came with their unsheathed swords and, laying them on the altar, consecrated themselves to the service of humanity.

Life and its experiences, especially through suffering, as God's way of educating man so that he can "live steadily and live it whole," was the theme of Dr. Idleman's sermon. That the world as it is today is the kind of world man needs, was the answer he gave to the question as to what kind of world would enable man to live such a life. He needs a world in which he must struggle and fight, one that will lead out the best in him and from which he will come out the conqueror.

He took his text from Hebrew 2:10: "It became Him in bringing many sons to glory to make the captain of their salvation perfect through suffering."

Dr. Idleman gave as the three things essential to one who lives life fully: intelligence, kindness and goodness, but showed how the first two are inadequate without the third.

He cited examples of those who had found the best answer to life and with these he contrasted a living philosopher of real parts, of keen intellectual judgment, who missed it—Clarence Darrow, the scintillating Chicago lawyer. When asked by a student what he would do with such a world as we now have, Darrow said: "I'd chuck it."

Man's intelligence is needed in conquering his environment, and if he fails to do this, he drops out, as did the Indians who merely accepted what came their way by chance.

Man, in discovering, through his intelligence the secrets of nature, has overcome darkness, dug into the earth for coal and brought to his uses its riches. Man who sees Niagara Falls as power to be used, rather than a god to be sacrificed to as the Indians saw it.

Kindness should be added to intelligence. This is brought out by the obligations of social life, the relationship of parents to children, and of neighbor to neighbor. This mutual dependence caused by the sort of world we live in produces "sons of glory," and does it through pain and suffering.

Goodness he gave as the crowning glory as a result of educating or educating process through which man is led to the fullest life. He gave as an illustration one who discovered that cleverness, brilliance and scholarship wear us enough, that only goodness was perpetually satisfying. "Suffering" was his answer to the question: "What makes a man good?" This suffering, however, he made it clear, is not the kind brought on by one's self-indulgence or breaking laws.

Dr. Idleman richly illustrated his idea of life as a discipline educating man to intelligence, kindness and goodness.

Rev. W. A. Ryan, pastor of the Eighth Street Christian Church, Greenville, led in prayer and read the Scripture lesson, which was the first eight verses from the third Epistle of St. John.

# NRA STUDIES MILL ISSUE

## Textile Strike Averted During Protracted Conference With Gen Johnson.

Washington, D. C., June 4.—(AP)—Instead of a threatened strike, an NRA study of whether cotton textile workers should get more pay got under way today.

Union leaders Saturday afternoon called off the strike schedule to start this morning after a protracted conference with Hugh S. Johnson, NRA chief and representative of the mill owners.

The workers withdrew demands for withdrawal of an order effective today reducing working time by a quarter for the next three months or as an alternative increased pay to compensate for the loss of time. In return for that concession NRA and the owners agreed:

That NRA make a detailed study of production, wages and hours.

That cotton textile labor be given a voice in the labor advisory board and cotton textile code authority.

That the production wage hour study include the question of what production machine hours are necessary to meet normal demand, what increase in wages would be possible, whether wage differentials above the minimum have been maintained, what changes have taken place in man-hour productivity.

That NRA make a detailed study of production, wages and hours.

That cotton textile labor be given a voice in the labor advisory board and cotton textile code authority.

That the production wage hour study include the question of what production machine hours are necessary to meet normal demand, what increase in wages would be possible, whether wage differentials above the minimum have been maintained, what changes have taken place in man-hour productivity.

That NRA make a detailed study of production, wages and hours.

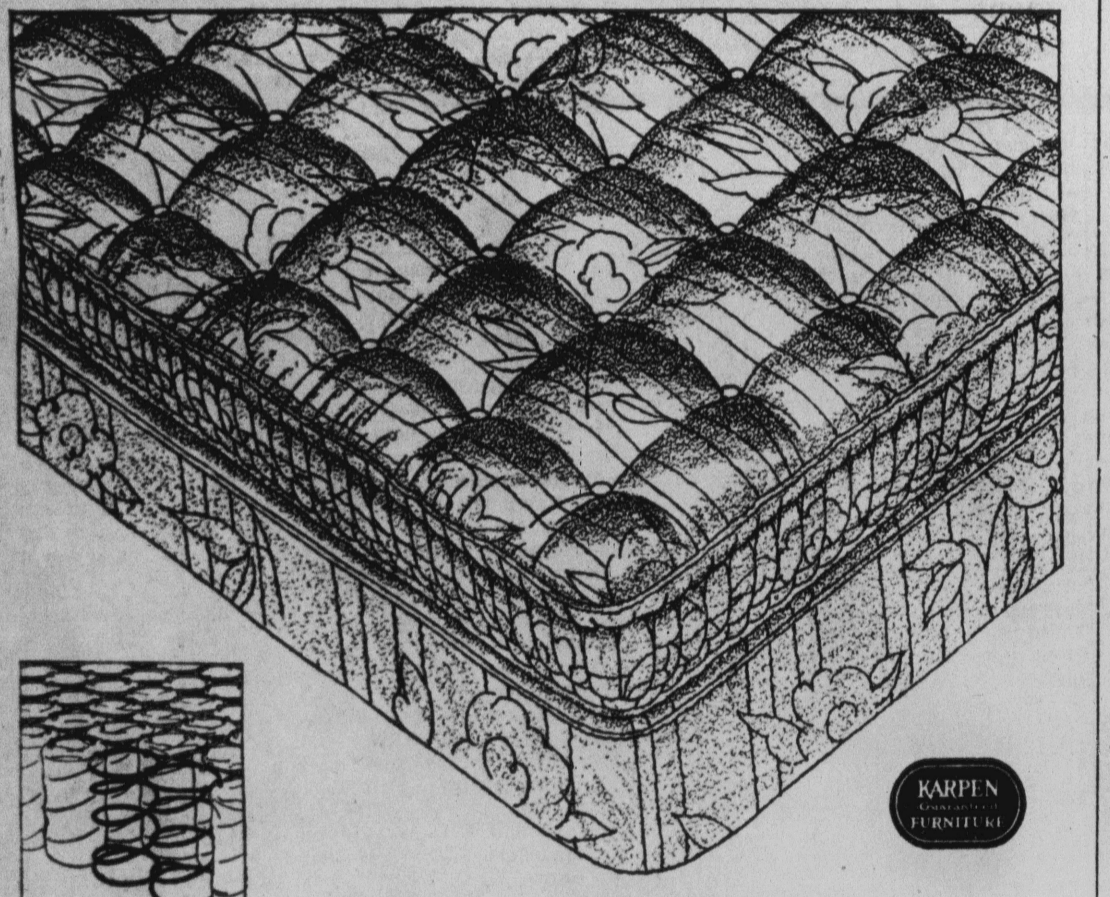
