FRANCE SEEKS COMPROMISE ARMS CONFERENCE

Capitals of Europe Line Up For War Debt Battle With America

BRITISH STEP CHEERED OVER CONTINENT

Conference for Full and Final Settlement for the Question of Debts is England's Final Goal; Italy Expected Follow Britain's Lead.

(By Associated Press) The capitals of Europe were lined up solidly against America on the war debt situation for the first time today.

"It is up to Washington," was the consensus of opinion. As cheering broke out everywhere except in the United States for Britain's decision to default—the sentiment was general that the complicated issue had been brought to a head and that America's hand was forced.

A conference for full and final settlement of the questions was England's goal. France, happy to find Britain a bed-fellow in default, and a logical leader in the move for settlement, turned its attention to borrowing nearly \$200,000,000 for paying military preparedness program.

Italy, it was indicated, will follow in the footsteps of Britain. The move encouraged Germany to hope for credit.

World recovery and international amity would be greatly forwarded if an end to the question should be reached. It was stated in foreign circles.

The House of Commons and English public gave its endorsement to the government's steps.

HALF HOLIDAY BEGINS TODAY

Business Houses Will Close on Wednesday Afternoons During Summer

Observance of Wednesday half holiday began here today and will continue for a period of 90 days, ending August 22.

Many business houses of the city will close at the noon hour in keeping with a petition circulated by the Chamber of Commerce sometime ago and employers and employees will be given an opportunity to follow their chosen fields of diversion during the half days.

The main entertainment of half holiday crowds today will be the opening game of the Coastal Plain League to be played here this afternoon between Kinston and Greenville. Kinston was rained out in the opener scheduled on her home grounds yesterday, but Greenville played at Ayden and lost.

Tremendous crowds were expected to be on hand this afternoon when the curtain is raised on the home diamond and both employers and employees will be glad they had the half day off to see what everybody always wants to see—the opening game of the season.

When the weather begins to hit the summertime strid many of the half holiday observers will lie off to beaches to take cooling plunges in the surf. Others will stay at home and rest and take part in whatever diversion they are able to find in the community.

The Daily Reflector is cooperating in the half holiday movement this year. The paper will be issued this afternoon about 1 o'clock instead of 4 as customary, and several of the force probably will be found at the Kinston-Greenville ball game with the rest of the community, attempting to cheer the home town boys on to victory.

Americans Win Big Stakes On English Derby

Dublin, Ireland, June 6.—(AP)—Nearly \$2,000,000 went to the United States from the Irish hospital sweepstakes as a result of the running of the derby at Epsom Downs today. The amount of prize money to be distributed to American ticket holders totaled \$1,901,853, distributed as \$957,600 to holders of tickets on Windsor Lad; winner over Eastern, second; Colombo, third, and \$944,250 went to holders on horses which did not place any winners of residual and cancellation prizes.

COUNTY COURT IN THE MIDST OF HEAVY DOCKET

Over Dozen Cases are Disposed of in Opening Session Here Yesterday

Sitting for the first time in two weeks, County Court disposed of part of its heavy docket yesterday and continued in session today in an effort to clear its decks for next week. A dozen-odd cases were completed in the session yesterday and as many if not more awaited action today. The majority consisted of charges of larceny and violation of traffic and prohibition laws, and defendants either were released on payment of fines or found their way to the roads.

Judge Dink James presided. Heber and Rufus Stepp, arrested by city officers here the latter part of last week on a charge of stealing gas from the car of Willie Owens, were found guilty. Heber was sentenced to eight months on the roads and Rufus was turned over for disposition by Juvenile Court authorities.

Court approved an agreement for the payment of \$200 to the wife of Sam Adams for support of a minor child. Adams immediately paid the sum and was released of possessing liquor for sale; Lomas Moyer, colored, was sent to the County Home for 90 days.

W. H. Carrow was fined \$50 and J. D. Vick \$25 on a charge of possession of liquor for sale. Cost of action was deducted from the fine. James Armfield, colored, was sentenced to the roads for ninety days on a charge of larceny.

John Henderson was ordered to pay \$25 and cost after being convicted of operating a car in a reckless manner. Convicted of a charge of larceny, Raymond Tyson, colored, was given six months on the roads.

Six months in jail was the judgment dealt out in the case of Curtis Willis, colored, appearing on a charge of carrying a concealed weapon.

Payment of \$50 and costs and his driver's license revoked for twelve months was the judgment in the case of Roy Mills, charged with driving drunk. Jesse Smith, charged with driving drunk, was ordered to pay \$50 and cost and not to drive a car for 90 days.

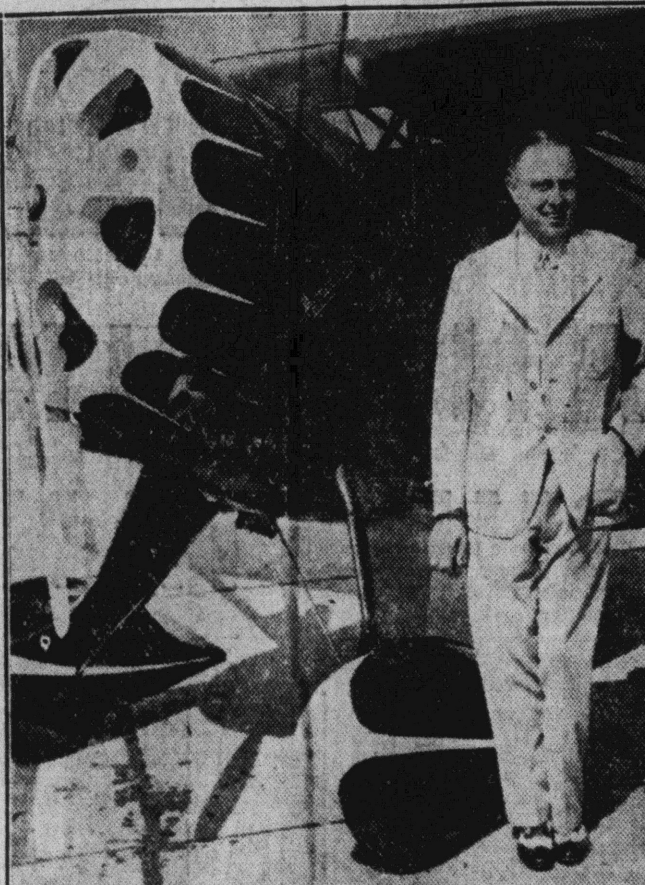

TWO WOMEN DIE IN FIRE

Perish in Fire That Damages Home of C. W. Carter at Winston-Salem

Winston-Salem, N. C., June 6.—(AP)—Trapped in their rooms as they slept and overcome by smoke, two women perished early this morning when fire badly damaged the home of Mr. and Mrs. C. W. Carter. The dead are:

Miss Ethel Massengill, 23, formerly of Raleigh; Miss Audrey Ellen Angel, 28, native of North Sidney, Nova Scotia, a resident of the city for the past several years.

Mr. and Mrs. Carter were sleeping on the first floor of the residence and were the first ones out of the structure. Two other occupants of the house, H. G. Moore and Miss Mary Carter Noce, escaped also.

The fire was discovered about 12:45 a. m. Mr. Moore, who was sleeping on the second floor, was awakened when the curtain to the window of his room caught fire and gave the alarm. He broke the glass out of the window, and with Miss Noce, the fire was discovered about 12:45 to the ground.

As the glass was broken a draft was created, and flames spread through the upper floor, making it impossible to rescue the two women. As Moore left the flaming building he said he heard one of them cry out: "The chimney, I'm coming!"

Miss Noce's body was found about the center of her second-story room. She had apparently made a desperate effort to reach the door.

Hospital attaches said she had probably suffered, and there was a possibility she had swallowed some of the flames. The position of the body of Miss Massengill led to the belief that she also tried to escape.

ASKS FOR \$25,000 IN ALIENATION SUIT

Albemarle, N. C., June 6.—C. C. Howell, sheriff of Montgomery County, was made defendant here this week in a suit for \$15,000 damages instituted by R. D. Biles, native of this county, but who for the past several years has resided at Troy. Biles alleges that Howell alienated the love and affection of his wife, was guilty of unlawful acts with his wife, and was responsible for Biles losing the love and affection of his children, being humiliated and embarrassed, and having to leave his own home. The complaint asks \$15,000 actual damages and \$10,000 punitive damages.

PRINTING CODE EXPLAINED AT MEETING HERE

Job Printers of Eastern Carolina Hear Regional Secretary At Dinner Here

Job printers from all sections of Eastern Carolina were advised last night that the government code for printers was no laughing matter and that any printer violating the wage and hour provision of the code or selling printing under prices prescribed as fair prices was in for trouble with the government.

Representatives from printing plants in Rocky Mount, Wilson, Kinston, New Bern, Ayden, Farmville, Greenville and other points gathered in the meeting here to hear the explanation of the code by W. C. Hardison, of Greensboro, field secretary of the Regional Code Enforcement Division.

Prior to the meeting guests enjoyed a delightful dinner at the Proctor Hotel and continued with the meeting here.

After explaining the code, Mr. Hardison answered numbers of questions pertaining to its enforcement. This was followed by a round-table discussion in which many of the representative took an active part.

Mr. Hardison made it clear that in every instance printers must not only live up to the wage and hour schedule, but must also live up to the code provisions pertaining to the selling end of the business as well.

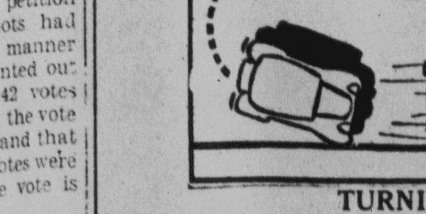
Mr. Morgan is one of the most prominent business men and active leaders of Farmville, and his election to the high post in the national organizations was received with interest here today by his many friends.

WINDSOR LAD WINS OUT AT EPSOM DOWNS

Eastern, Second in Wagering, Takes Second Place in English Derby

Epsom Downs, England, June 6.—(AP)—Windsor Lad, and outsider in the betting today, won the 156th running of the English derby.

Eastern, second in the wagering, was second, and Colombo, the favorite, third.

Windsor Lad was quoted at 100 to 5 and carried the silks of the Maharaja of Rhapsia, while Eastern represented Lord Woolzington.

Colombo, unbeaten in several races, carried the silks of Lord Granley. Colombo, who led by a length in the two thousand guineas, went to the post, the choice at 6 to 4 of the crowd of 25,000, including the king and queen.

Eastern was sold after the two thousand guineas by Ralph Strassburger, of Philadelphia, to Lord Woolzington for \$75,000.

CANVASS OF PRIMARY MADE

No Changes of Any Consequence Found By Elections Board Here Yesterday

The Pitt County Board of Elections met here yesterday and canvassed the vote in Saturday's primary.

P. C. Harding, chairman of the board, said this morning that no changes of any consequence were found in the standing of the various candidates and that the unofficial figures compiled by The Daily Reflector Saturday night and Sunday were virtually correct, with exception of a few minor changes that did not affect the standing of the candidates.

The canvass was completed late yesterday afternoon.

Mr. Harding said that several candidates whose names were not on the ballots because they were without contest had been nominated and a list of their names would be submitted for publication tomorrow. The list was being prepared today. Among the number is J. F. Harrington, clerk of Superior Court.

The question of providing new polling places in Greenville and Chicod Townships to speed up the handling of votes and complication of figures was not taken up during the session yesterday, but it was understood it would be considered sometime this week.

Lack of polling places in the two townships, the two most populous of the county, caused much delay in compiling returns Saturday night and Sunday. The Chicod vote was not completed until about 5 o'clock Sunday morning and in Greenville until about 3 o'clock Sunday afternoon.

Security Of His Nation Sought by Minister Barthou

OPPOSITION IS EXPECTED FROM POWERS

Barthou's Resolution Also Seeks to Settle Minor Questions Of Conference; Compromise Plan Described as Only Alternative to Complete Collapse.

Geneva, June 6.—(AP)—Convinced that no other nation would make a concrete move to save the stalled Disarmament Conference, Louis Barthou, Foreign Foreign Minister, presented a resolution today in a last-minute effort to effect a compromise.

It was understood that Barthou's plan would give primacy to France's thesis of security.

The resolution refers to methods of getting Germany to return to the conference as well as settling minor work of the conference.

The resolution was described as a "small olive branch." Others anticipated that the French move would incur considerable opposition. Nations of the world, many of them bitter, came to a showdown today on whether to disarm.

A composite plans calculated to save the face of the disarmament negotiations was the only apparent alternative to the complete collapse of the conference.

Peering behind personal squabbles found one hope in all providing the conviction that the world goal of peace is at stake.

As suggested by Arthur Henderson, president of the world Disarmament Conference, millions of youths' lives might be the price of failure. For this reason it was felt that renewed efforts might find a patch across the obstacle.

STEEL STRIKE NOW SET FOR 16TH OF JUNE

Workers Refuse to Accept Johnson's Plan for Settling Steel Strike

(By Associated Press) Steel strikers saying Hugh S. Johnson's plan for a separate labor board for the industry is not acceptable, renewed threats of a general strike June 16th.

John Knudsen, 51, is the second man to die from injuries suffered in rioting May 15 in strikes of Los Angeles longshoremen.

NEGRO FREED IN SLAYING

Ben Sam Moore Exonerated in Death of Bert Hazleton Near Ayden

Ben Sam Moore, negro of the Ayden community, was exonerated by a coroner's jury Monday night in connection with the slaying of Bert Hazleton, 25-year-old negro, at Moore's house Sunday night.

Shot in the chest by Moore with a shotgun, Hazleton died in the local hospital Monday night, with the jury declaring that Hazleton's death was "justifiable homicide" in view of the fact that Moore fired in defense of his home.

Evidence revealed that Hazleton while drinking, went to Moore's home while Moore was away, raised a fuss with Moore's wife and daughters. When Moore appeared Hazleton asked him if he wanted to take it up. He immediately went to his home about a half mile away, obtained a shotgun, returned and fired at Moore and family through a window.

Moore then fired through a window, the shotgun load taking effect in Hazleton's chest. The negro was immediately rushed to the hospital where it was said his injury was so serious that no hope was held out for his recovery.

SPEED IS THE DANGER

The world's record for throwing the 16-pound shot, one of the regular events at all track and field meets, is 53 feet.

The amount of energy possessed by an average-sized automobile traveling at 60 miles an hour would be sufficient to throw that shot 52,800 feet—nearly ten miles.

To use another illustration, a car traveling at 60 has the same capacity for inflicting damage as if it were driven off a twelve-story building.

Those facts, brought out in a recent report, give some idea of the potential menace of speed on the highway. During recent years the death and injury rate per accident has been rising—and the increase was especially marked in 1933. The chance of a person being hurt or killed in an accident is substantially greater now than it would have been five or ten years ago in a similar accident.

Today's cars have better brakes, better steering, better lights and stronger bodies than those of the past. By all engineering standards, they are safer. What has happened is that the public has exaggerated the increased safety factors—and actually turned these improvements into dangers.

Watch your speed—adapt it to local conditions at all times—and you'll have taken a long step toward becoming a safe driver.

ABSOLVED OF BLAME IN KILLING OF ROBBER

Lumberton, June 6.—Ed Martin, Pembroke night watchman, was absolved of blame at an inquest held yesterday in the killing of Troy Smith, Indian, on the early morning of May 31. The jury found Smith was killed while robbing the store of the Pate Supply Co., by the officer while in the discharge of duty. In a voluntary statement, Martin told how he found the store doors open, entered and was fired on by a group of four or five rob-

bers. He said he returned the fire with gun and pistol. Smith's body bearing two gunshot and three pistol wounds was found 180 yards from the store in a field.

EARLY POSTOFFICE, FOUNDED IN 1817, CLOSED BY U. S.

Stuttgart, Ark.—(AP)—The post-office at Arkansas Post, earliest settlement in the State, which once served territory between St. Louis and Monroe, La., with monthly mail delivery, has been closed by orders from Washington.

Established 117 years ago, the office was reputed to have been one of the first west of the Mississippi River. Two years after its opening, William E. Woodruff landed a canoe load of printing equipment and founded the Arkansas Gazette. That newspaper, which some say is the oldest west of the Mississippi, is now published at Little Rock.

For several years the population of the Arkansas Post community has been growing smaller. After the recent death of Lewis Cornell, postmaster for thirty-six years, the office was ordered discontinued.

Announcement that the order had been received brought a last-minute boom in postal receipts. Stamp collectors hurried there, bent on obtaining cancellations.

WORD 'TREASURE' ON TOMB BLAMED FOR OPEN GRAVE

Miami, Fla.—(AP)—The lonely grave of William S. Milliken has just been invaded by ghouls—the second time in eight years—and the countryfolk nearby blame it on the word "treasure" in his epitaph. It reads:

"Yet, all its well:
God's good design I see,
That where our treasure is,
Our hearts may be."

Tradition has it that Milliken, a surveyor from Scarborough, Me., was killed by Seminole Indians in 1876 and was buried where he fell.

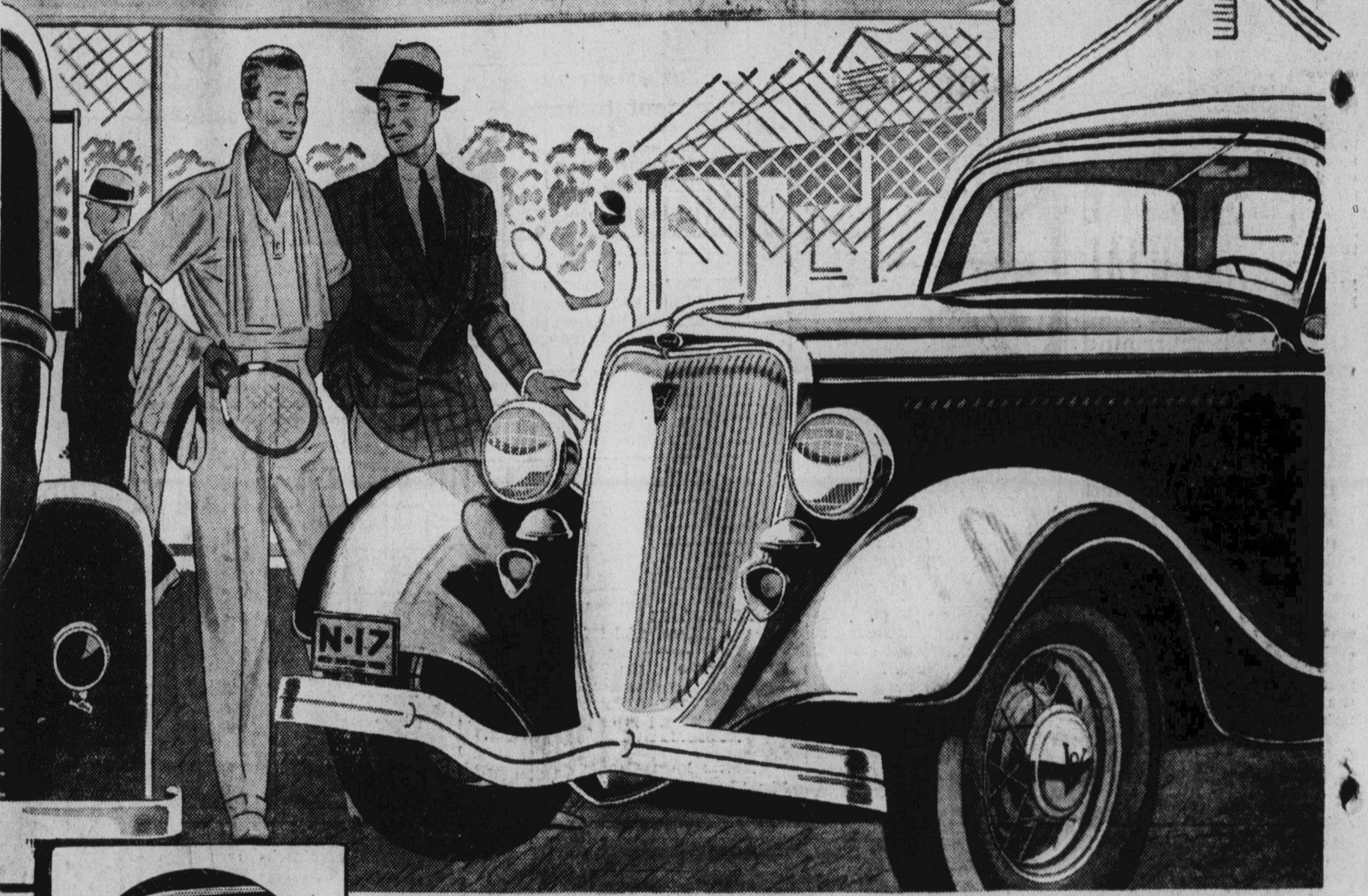
