TWO BANDITS SHOOT UP THE BANK OF MAGNOLIA

Board Orders More Voting Precincts In Greenville And Chicod

ENTIRELY NEW REGISTRATION AT FARMVILLE

Elections Board Sets Up Four Separate Voting Precincts in Greenville Township And Three in Chicod; Greenville Boundaries Completed; Chicod to be Determined; New Registrations Are Also Required

Greenville Township is to be divided into four separate and distinct voting precincts and Chicod Township will be divided into three as result of action taken this week by the Pitt County Board of Elections.

The board also authorized an entirely new registration in Farmville because of the fact that the registration book used two years ago has been misplaced and cannot be found and it was necessary to use one of the older registration books in the recent primary.

Greenville Township is to be divided as follows: All voters residing in Greenville Township north of Fifth Street and the Falkland highway and west of Greene Street and the Greenville-Bethel highway will vote at the Third Street School known as Greenville Precinct No. 1.

Voters north of Fifth Street and the Greenville-Washington highway and east of Greene Street and Highway No. 11 will vote at the courthouse, known as Greenville Precinct No. 2.

Those residing in the territory south of Fifth Street and the Falkland highway and west of Greene Street, Dickinson Avenue and Highway No. 11 will vote at some point in the southwestern section of the city yet to be designated by the board and known as Greenville Precinct No. 3.

The voters south of Fifth Street and the Washington highway and east of Greene Street, Dickinson Avenue and Highway No. 11 will vote at the City Hall in Greenville Precinct No. 4.

While Chicod Township will be divided into three voting precincts the definite line of division and designation of polling places is still under consideration by the Elections Board and definite announcement will be made at a later date.

The splitting up of the divisions of these larger precincts will necessitate an entirely new registration and specifies that there must be new registration books in typewritten form and properly indexed.

HORSE KILLED BY LIGHTNING

A horse was killed by lightning on the farm of Clarence Summerell, several miles from Ayden, during the thunderstorm which passed over the section Thursday night, according to reports reaching Greenville today.

The stables in which the animal was housed suffered slight damage from the bolt, it was said.

DRAWS THREE YEARS FOR OBSCENE LETTERS

Lexington, N. C., June 9.—While Paul Mahaley, young man of this city, was being tried in Federal Court at Greensboro this week on a charge of sending obscene letters through the mail, a letter similar to those of which he was accused was dropped into a local collection box by an unknown person. It is reported to have been strikingly similar to others which Mahaley admitted in a signed confession he had sent. These letters have been addressed to several prominent young women, all living in a section of the city more than a mile from Mahaley's home. Mahaley drew three years in Chatham County prison.

JAPAN SEES FAILURE AT NAVAL MEET

London, June 9.—(AP)—Informed Japanese quarters in London predicted today the flat failure of preliminary naval conversations which opened here shortly by world powers.

The same sources expressed belief also that the 1935 naval conference would be a failure. "Nothing much can be accomplished at the discussions," the authority said, "and the world can be sure the conference of 1935 will be documented unless they are willing to consider Japanese needs."

Japan is expected to seek naval equality with Great Britain and the United States next year, rejecting the 5-5-3 ratio. On the other hand, it is understood here that Great Britain and the United States, or both probably, will resist Tokyo's claims.

Asked what subject would be considered in the conversations, the Japanese sources replied: "Naturalistic diplomatic questions which apparently are generally known already. We all know the conversations first will be to decide where to hold the conference." This is only a formality since London has already been selected.

SCHOOL BOND ISSUE NOT YET ASSURED

Sanford, June 9.—Although the board of county commissioners have authorized the issuance of \$46,000 bonds in order to receive a grant of \$58,000 from the Public Works Administration for the improvement and repairs to school buildings in Lee county, the matter is not definitely settled.

Petitions against the issuance of bonds were presented to the commissioners at the monthly meeting Thursday but as comparatively few citizens—approximately 180—had signed the petitions, the order for issuing the bonds was passed.

Under the law, if 15 per cent of the registered voters object, the bond issue will have to be submitted to voters for adoption or rejection. The opponents of the bonds are circulating additional petitions which have to be presented to the board for consideration, not later than June 23, in order to secure an election on the question.

PLAN TO END STEEL STRIKE IS REJECTED

Insurgents Exchange Bitter Words With Recovery Leader At Conference

Washington, D. C., June 9.—(AP)—Amid a roars of bitterness, steel union insurgents revolted today against a peace plan approved by Hugh S. Johnson and employers.

They were to see President Roosevelt today to present him a plan of their own and then return home to fight.

The threat of the steel strike which many officials fear would hog-tie the recovery drive seemed still imminent.

About the plan for a peace board to settle capital-labor fights—a plan which Johnson said he practically prescribed and which the steel unions accepted last night—the international president of the steel unions, Michael Tighe, remained firmly silent.

Johnson and the insurgents whaled away at each other—using such phrases as "hell," "bluff," and "damnable."

"We are done with you and your iron and steel institute board," a score of leaders said in a statement.

Recently a group of leaders of local unions—declared by President Tighe to be without authority to speak for the institute—suggested that Johnson could learn something by walking up to an open heart and getting his summer pants scorched.

Johnson in a radio speech last night answered what he called "these immature leaders."

Precinct Meetings Held In All Parts of County; Convention Here Monday

Democratic precinct meetings were being held throughout Pitt county this afternoon for the purpose of selecting delegates to the county convention scheduled for the courthouse here Monday morning at 11 o'clock.

In addition to the naming of delegates the precinct meetings will also name five executive committee members for each township.

At the county convention Monday delegates to the state convention set for Raleigh Thursday, June 21, will be chosen along with other matters that may be presented for consideration.

The call for the conventions was issued several days ago by W. E. Hooks of Ayden, chairman of the executive committee, who urged that as many party members as possible be on hand to take part in the deliberations. Precinct meetings are important, Mr. Hooks said, in view of the fact that they afford party members opportunity to select the men or women they desire to represent them at the county convention. He said the county convention is also important because of the delegates to be selected to go to the Raleigh meeting.

GENEVA MEET CHEERED BY DEVELOPMENT

Mussolini And Hitler To Confer On Germany's Return To Arms Conference

Geneva, June 9.—(AP)—Harmony succeeded dissension in Geneva today as cheered supporters of disarmament looked to the expected meeting between Europe's most powerful dictators, Premier Mussolini of Italy and Hitler of Germany.

After a general exchange of compliments, leading figures of the Arms Conference left. Work on actual disarmament is not anticipated until Germany accepts or rejects the latching held out to her re-entry to the conference.

Italian delegates met it known that Mussolini would confer personally with Hitler. Official confirmation was lacking in Rome.

It is expected that the Asiatic Coast soon ostensibly for a vacation but Rome dispatches said it was likely he would meet Hitler in Venice and urge that Berlin come back to Geneva.

DRY FORCES ORGANIZE HERE

County-Wide Unit Formed at Meeting At Sheppard Memorial Library Last Nite

A county-wide dry organization was formed at a meeting at Sheppard Memorial Library here last night attended by representative citizens from virtually all sections of the county.

Wyatt Brown, of Greenville, was elected chairman of the organization; J. T. Martin, of Bethel, vice-chairman, and Sam Underwood, of Greenville, secretary. Two trustees, John T. Thorne, of Farmville, and Mrs. William Quinerly, of Ayden, were also elected.

J. D. Page, of Raleigh, field worker of the State Dry organization, was present and told of the program being pushed in all parts of the country in an effort to bring about greater enforcement of dry laws. He also enumerated educational features of the program, urging that school children as well as the general public be informed of the danger of intemperance and the value of strict law-enforcement.

Similar organizations, he said, are being formed in all parts of the State as a means of forwarding the general program, and hope was expressed that everybody interested in the movement to improve conditions brought about through laxity of moral codes and law-enforcement would give all aid possible.

Although the crowd was not as large as had been hoped, it was stated the county as a whole was fairly well represented and that those in attendance went home to attempt to carry out the program as far as they were able to do so.

Late News Flashes

Congress Talks Drought and Strike Washington, June 9.—(AP)—The government strove today to ease a costly disaster of nature—the drought—and to obviate a potentially costly man made order—a steel strike.

Before going down the Potomac to rest from a hard week, President Roosevelt requested Congress to appropriate \$525,000,000 to protect people in the stricken region from suffering, to move feed to livestock and livestock to feed and to acquire a price for surplus cattle to provide meat for relief distribution. He wanted the spending of the money which is certain to be made available left to the administration's discretion.

NEW STORM ROARING IN C. AMERICA

Second Disastrous Hurricane Not Expected To Reach North America

San Salvador, June 9.—(AP)—(By American Airways Wireless)—A new tropical disturbance roared toward the coast of Central America, battered the last two days by a destructive hurricane.

A wireless dispatch from the weather station at Merida, Yucatan, Mexico, said the storm center had formed in the Gulf of Mexico and was moving toward Central American east coast.

The North American continent apparently will not suffer the storm which has lashed Central America.

Communication service was badly damaged by winds and heavy rains which accompanied the hurricane. Preliminary reports indicated eight lives were lost in Salvador and property damage reached as high as \$2,000,000.

DELEGATES GO TO CANADA

B. W. Moseley And W. A. Darden Represent Local Club At Toronto Convention

B. W. Moseley and W. A. Darden left yesterday for Toronto, Canada, where they will attend the International Convention of Kiwanis Clubs. They are delegates from the Greenville Club and will remain in Toronto during the four days the convention is in progress.

Thousands of visitors from the United States and Canada are expected to attend the sessions which will be marked by discussions dealing with civic betterment, child welfare, urban-rural relations, maintenance of adequate educational facilities and public affairs. The question will be taken up at several daily conferences.

Joshua L. Adams, president of Kiwanis International from Appleton, Wisconsin, will deliver the keynote address at the opening session.

The two Greenville delegates were named at a meeting of the club two weeks ago, and arrangements were made immediately for their attendance. Alternates were named to take their places in case they were unable to attend, but such was not the case, and everything went off as originally planned.

At the regular meeting of the club last night, Dr. R. S. McGeachy, president, told of the departure of the two delegates, and declared the club is looking forward to the interesting reports they are expected to bring back from the Canada meeting.

SUCCESS IN ARRESTING VERY ACTIVE BURGLAR

Ayden, June 9.—Success crowned the efforts of officers of the town of Ayden Wednesday afternoon in rounding up a persistent burglar who has committed a number of robberies here. The thief, William Hooks, colored, has been almost captured a number of times, but succeeded in making his getaway up to the present time.

In the attempt to escape, Hooks received a bullet wound in the shoulder. His injury, though painful, is not considered serious.

In searching the home of the burglar, a number of stolen articles were found, some of which were identified as clothing and jewelry stolen from time to time in town.

MACHINE GUNS ARE USED ON BANK EMPLOYE

Police Guard In Bank Cuts Loose With Shotgun As Two Men Secreted Atop Vault Leap Down And Open Fire With Machine Guns; One Bandit Believed Wounded; Undetermined Amount Of Loot Obtained

Magnolia, N. C., June 9.—(AP)—Two bandits shot up the Bank of Magnolia at opening time this morning leaving two men wounded as they blazed their way to waiting cars with an undetermined amount of loot. The bandits met a hail of lead from hastily assembled residents as they sought to join their confederates and two of them were believed wounded.

They fled toward Wilmington, using a dove-colored sedan bearing Virginia license No. 90786 and a black-red trimmed coupe stolen at the time of the robbery from John Croom, Magnolia business man.

The wounded men are J. N. Horne, assistant cashier of the bank, who received a scalp wound, and T. H. Rogers, local business man, who received a serious leg wound.

E. E. Pope, policeman, who was on guard at the bank following two similar hold-ups in less than eighteen months, said he turned his shotgun on the bandits and that one of them fell and then got up. Some one of the score of citizens who joined the attack on the bandits was believed to have inflicted a wound on another.

Two of the bandits had concealed themselves on top of the bank vault during the night. Pope said he and Horne were discussing an investigation of the mysterious Virginia sedan when the bandits leaped down, firing what appeared to be machine guns. Pope said he ducked out of the door and started firing back into the bank and his shots quickly aroused the town.

The number of injured men in the bandit band was not determined, but a confederate was believed to have stolen the Croom car and brought it to the bank for the escape.

One of the bandits within the bank was described as short and dark with a hatchet face and appeared to be in his middle thirties. Description of the others was not obtained. L. D. Dale, cashier of the bank, said the bank lost only what money was in the open tills.

CLOTHING FACTORIES AT NEW BERN REOPEN New Bern, N. C., June 9.—After having been closed for several weeks, the coat shop of Cohen, Goldman and Company was re-opened Wednesday. The parts shop was started in operation a week previously. Manager F. M. Girton is anticipating a good season of continued activity. He expects to increase the work force gradually.

DECIDE NOT TO CALL FOR A SECOND PRIMARY Albemarle, N. C., June 9.—R. Lane Brown, candidate for solicitor in the Thirteenth Judicial District, and Robert L. Furr, candidate for sheriff, announced yesterday that they would not call for a second primary to decide between them and their opponents. The withdrawal of these men leaves no vestige of a contest in the county, since all candidates were nominated on the first ballot with these exceptions. Both candidates give as reason for withdrawing that they do not wish to put the county to this added expense.

OUR CONGRATULATIONS

No doubt the voters of our county will welcome the news that the County Board of Elections has taken definite steps to help the voting situation in this county by arranging to split Greenville Township into four voting districts and Chicod Township into three. This division has been needed for a long time and talked almost as long without result but it is gratifying now to know that the job is to be really put across. Of course there is not sufficient time to make the change before the second primary, if there is one, but after then the voters of the county will find themselves in position to go to the polls and cast their ballots without congestion, confusion and interference.

We congratulate the election board on taking this step in the interest of better voting facilities in this county.

UP TO THE PEOPLE

On several occasions we have referred to the matter of slot machines in this county, and recently we carried articles from the State Magazine and Literary Digest showing clearly that the slot machine business was a racket of the worst sort and one that should be dealt with severely.

Judging from this week's issue of the State carrying comments from newspapers all over the state, it is the general consensus of opinion with the press that the people of the state should get behind the movement to rid our state of the slot machines. Usually the people get just what they want and when the people of our state come to realize the great menace of the slot machines and demand that they be put out of commission we will be rid of them, and not before. If the people of our county want to rid our county of the slot machines they can, we believe, do so by bringing sufficient pressure to have the grand jury to investigate their operation in this county, for it is our belief that the great majority if not all the machines in the county, are operated illegally. If there are loopholes in the present law whereby these machines are permitted to operate, then the next step would be to place the matter before the next legislature and urge the passage of laws that would prohibit slot machines in this state.

Certain amendments to it were pending which the steel men didn't like at all. Senator Wagner was using the steel situation as a talking point for these amendments.

Automobile men and others opposed to such drastic legislation privately talked to the steel people about that.

The steel people talked to General Johnson. Those who knew the trend of the conversation got the impression that steel was frightened, and willing to make concessions it never would have made except in an effort to head off the more sweeping of the Wagner proposals.

Previously, hints of administration favor for the Connery bill prescribing a thirty-hour week caused much thought among big industrialists at a time when NRA was asking for a voluntary forty-hour week.

It is strange but true that some legislative proposals which never are intended to pass have a greater effect than others which get on the statute books.

Congressmen Revise

Anyone who thinks the Congressional Record is dry and unilluminating should look over the issue for June 1. One page of it focuses a brilliant light on life among the Congressmen.

Representative Cannon arose. He complained that the official stenographic transcript of his remarks of the previous day actually had been shown to newspaper reporters before he had a chance to "look them over."

Speaker Rainey held the objection based on "excellent" grounds. He ordered the official stenographers not to do it again.

Cannon did not complain he had been misquoted, or that there was anything confidential about what he had said in public session. On the contrary, he paid tribute to the accuracy of the official reporters.

That all would be a very mysterious passage if the reader did not know how common it is for members to revise, edit, blue-pencil and re-write their remarks before they go into the printed record. It is necessary to listen to a debate, and then read the official version of it, to understand how often the Congressional Record is a record of second or third, not first, Congressional thoughts.

UTAH MAY BUILD TEMPLE TO HOLD DINOSAUR RELICS

Salt Lake City. — (AP) — Utah, stamping ground of the prehistoric dinosaur, is giving serious thought to the building of an imposing monument to the past, in the form of a huge Maya temple to house archaeological and paleontological specimens.

The Utah State Museum Association, Inc., has been chartered by the State and it has prepared preliminary plans for a building 276 by 297 feet on the State Capitol grounds.

Unless a project of this nature is undertaken, the association, of which Governor Henry H. Blood is honorary chairman, believes, the State faces the prospect of being stripped of its ancient treasures by other museums.

The association describes Utah as the most fertile field now known in America for the uncovering of relics of past ages, and a membership of 5,000 Utahans, is sought to join in the movement to preserve the prehistoric collections under one roof.

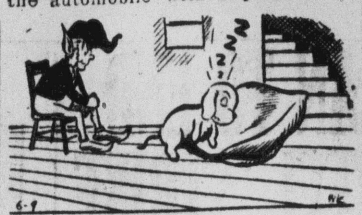

Washington Daybook

By CARL C. CRANNER. Washington, O. C.—(AP)—The ruin or partial saving of many of the country's principal crops is held to depend upon what kind of weather the agricultural sections have until mid-June.

Already the drought has surpassed in area covered and is moisture deficiency any other recorded in United States history.

J. B. Kincaid, chief of the climate and crops section of the weather bureau, says that both winter and spring wheat are entering the most critical stages of growth in areas which thus far have had just enough rainfall to prevent a complete or almost complete loss.

Pastures and hay crops, already reduced to dust in the driest areas, may yet come back in most sections with rain later in the season. There already was a shortage of hay in the country due to recent small crops.

Corn still has a chance, as the chief harm thus far has been in delay of planting and germination. Given a season of normal length corn can mature if it germinates by mid-June, but after that date it encounters increasing danger from early frosts. The critical period for corn that has germinated comes in the last half of June and in July.

So far most of the cotton belt has enjoyed more than normal rainfall, without enough rain to encourage boll weevil development. But the drought area has been gradually extending south and east, weather maps show.

The 1934 drought, in area and moisture deficiency, surpasses that of 1894, which wrecked a land boom in the West, Kincaid says.

In twelve States the emergency drought relief service, set up by the Agricultural Department, AAA, Farm Credit Administration and Federal Emergency Relief Administration, has designated 134 counties as "emergency drought counties" and 79 "secondary drought counties."

U. S. Buys Cotton. In the "emergency" counties the government has launched a cattle buying program, of unestimated cost, to take starving and thirsting cattle off farmers' hands. The meat is to be distributed to families on relief rolls.

In the "secondary" counties the Farm Credit Administration is extending feed loans, and efforts are being made to obtain low freight rates on shipments of feed into the territory and shipments of cattle out of the dry sections.

Wheat, corn-hog and tobacco contracts throughout the country have been modified to permit increased planting and harvest of all forage crops, including fodder corn and grain sorghums, on non-rented acres. On government rented acres all forage crops except corn and sorghums may be planted and harvested. Planting date restrictions on corn apply, however, in all States except the Dakotas, Minnesota, Wisconsin, Michigan, Montana and Wyoming.

CO-EDS PREFER CAREER SUCCESS TO ROLE OF WIFE. Minneapolis.—(AP)—Betty Coed in the arts college at the University of Minneapolis holds professional success as the key to her happiness, but her sister on the farm campus believes marriage and friendship the best things in life.

Answering a special survey into social conditions at Minneapolis, the girls studying art, literature and science said they believed success in the world of business would open the door to happy lives.

Just as certain, however, were the girls studying domestic science that they could find the most happiness in wedlock and companionship.

Support for the attitude of girls in the academic school came from the majority in both colleges. The majority said they believed professional success had more to do with providing happiness than marriage or friendship.

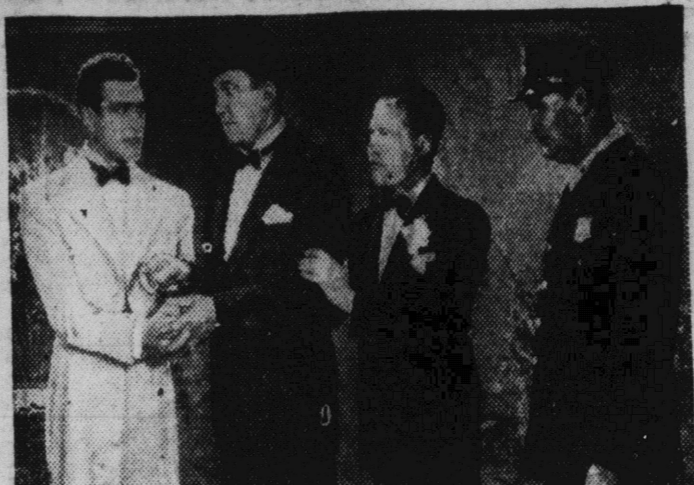

Pickles Are O. K. With Ice Cream Doctor Declares

Rochester, Minn.—(AP)—If you like pickles with your ice cream, eat them, and don't expect to increase your brain power by a diet of celery and fish, says Dr. Dwight L. Wilbur of the Mayo clinic here.

"There is no scientific evidence," says Dr. Wilbur, "that in the healthy individual any combination of foods is deleterious."

"The old thought that cherries and cream or sea food and cream produced poisons or generally caused indigestion when eaten together has been disproved many times and lacks proof in scientific evidence."

"Similarly, combination of cereals and acid fruits, proteins and starch, cranberries and milk, lemonade and ice cream, are not harmful."

Phosphorus 'Misleading'. On the contrary, the indigestion which seems to come after eating of such foods is the result of eating excessive amounts of them, says Dr. Wilbur, who is a son of Dr. Ray Lyman Wilbur, former Secretary of the Interior.

Celery and fish, says the doctor, which contain relatively large quantities of phosphorus, are often spoken of as brain foods because the nervous system also contains a certain amount of phosphorus.

But the idea that one can supply added strength to one's brain of wisdom by eating regularly of these substances is quite far-fetched, he believes.

The average healthy individual who eats the usual American diet of meat, potatoes, bread and butter, eggs, milk, vegetables and fruit to satisfy his appetite need have no worries about getting enough vitamins or minerals, says Dr. Wilbur.

Open Cans O. K. "One no" frequently hears of individuals refusing to eat berries or grapes for fear that the seeds will lodge in the appendix and produce acute appendicitis," the doctor says. "While it cannot be denied that this never occurs, it is so infrequent in actual experience as to be absolutely negligible."

Dr. Wilbur takes one last blast at some time-honored theories. "Cooking acid foods in aluminum vessels is not harmful," he says. "And leaving food in opened tin cans is not any more dangerous than it is to leave them in china or glass dishes."

Jimmy McLarnin and a flock of other Irishmen went away from the ring in Madison Square Garden's Long Island bowl thoroughly downhearted, but only one of them, apparently, doubted that the one-time "baby-faced kid" from Vancouver had experienced anything but an artistic beating at the hands of fiery, hard-hitting little Barney Ross, the sensational Jewish boxer.

The line dissenting figure was that of white-haired Tom O'Rourke, a veteran of the fight since the days of John L. Sullivan. It may always remain a mystery of everyone but O'Rourke as to just how he reached his personal conclusions, sitting in one of the two judges' chairs at the ringside, but the fact was that Old Tom startled the entire assemblage with a score-card conceding only one round out of fifteen to Ross!

No one can challenge O'Rourke's experience. He managed some of the ring's foremost fighters and was a promoter before New York ever heard of Tex Rickard, but his judgment struck a weird note in the acclaim that otherwise was accorded the clean-cut triumph of Ross over the clouting Irishman.

If there was anyone else around the ring who did not give at least eight rounds, a majority, to the black-haired Chicago youth, I failed to locate him. The other two officials, fortunately, scored so decisively for Ross as to leave no question about the ultimate verdict. Together, the other judge, Harold Barnes, and Referee Eddie Forbes gave McLarnin only three rounds.

No Rival in Sight

The precedent-shattering victory of the Jewish boy gives him absolute domination of the ring over the range of 135 to 147 pounds. There is no outstanding rival for him in sight at either extreme in weight.

Ross won the world's lightweight championship by whipping Tony Canzoneri, until then considered the best little man in the ring. To make it stick, Barney came to New York and repeated in a return bout.

The county securities were reported issued by Dyer and Henderson county by District Attorney David Murray, of Jackson, who said he had been informed the securities were issued fraudulently though some were almost an exact duplicate.

The Life and Casualty Co. of Nashville reported that when Lea floated a \$25,000 loan from it last March he posted collateral that included \$40,000 par value of Henderson county bonds.

Hold Man For Incendiarism
Raleigh, N. C., June 9.—(AP)—At a preliminary hearing this morning Charlie Lassiter, 22-year-old illiterate cotton mill worker, was bound over to face trial in Superior Court on charges of incendiarism by Magistrate J. B. Daniels.

Lassiter was held under \$2,500 bond in connection with a series of fires in the fall of the Neuse community near here.

State insurance officials planned to try to connect Lassiter with a series of unexplained fires in Wake Forest, but Lassiter claimed he had nothing to do with the blaze.
