ROOSEVELT IN RUSH BEFORE HIS VACATION

President to Clear His Desk of Business Before Leaving Saturday For Hawaii

White House, N. Y., June 25.—(AP)—President Roosevelt began today an intensive week to arrange affairs of State prior to his departure Saturday for his long planned cruise to Hawaii and the West coast.

Before leaving tonight for the capital he took up the last of the bills passed by the recent Congress and went over the list of recommendations for the two new important commissions to be selected—the stock exchange and communications agencies.

The President took advantage of his brief stay here at the family home to talk with State political leaders, Governor Lehman and Edward J. Flynn, Secretary of State, and Bronx leader, were dinner guests yesterday. While none of the participants in this meeting would talk, it was assumed Governor Lehman would run for re-election this fall on the Democratic ticket with the full support of President Roosevelt.

Administration to Buy Potatoes Washington, D. C., June 24.—(AP)—The Relief Administration agreed tentatively today to take 2,000 carloads of early potatoes from Virginia, North Carolina and Maryland off the market immediately.

William A. Neelander, commodities distribution director of the Administration, said the proposal must be confirmed by Harry L. Hopkins, the relief administrator.

However, Hopkins said earlier in the day that the administration is prepared to buy more potatoes "and buy them quickly" for distribution to the needy.

The tentative proposal of the administration to buy 2,000 cars of the commodity followed two conferences attended by officials growers and shippers from the three States.

Senator Byrd, Democrat, who arranged the conferences and was chairman of the large delegation which called on Hopkins this morning, described the agreement as "very satisfactory."

Relief officials said the price to be paid for the administration-purchased potatoes would be determined by consultations with the Agricultural Department.

SETTLEMENT EXPECTED ON DEBT RATES

Unofficial Circles Expect Germany Will Make Some Concessions and Call Off The Moratorium; Not Officially Indicated How Far Great Britain Will go With Concessions

London, June 25.—(AP)—Negotiations between Germany and Great Britain are to begin Wednesday at the British treasury through representatives of both nations.

Germany is sending a delegation of three experts who will arrive tomorrow for the conference.

The parley will be concerned with the German moratorium on debt payments and some unofficial quarters anticipated that a settlement—if one is reached—may provide lower interest rates on German debts owed in Great Britain.

The same circles likewise anticipated that to reach such a result the Germans would make certain concessions and call off the moratorium. There was, however, no official indication of how far Great Britain might be willing to go in the concessions. It is known that the government desires to avoid a trade war with Germany.

TEXTILE ASSOCIATION TO HOLD CONVENTION

Charlotte, N. C., June 25.—More than 300 members and guests are expected to attend the 26th annual meeting of the Southern Textile Association at Ocean Forest Hotel, Myrtle Beach, S. C., June 29 and 30, it was announced from headquarters here. Membership in the organization is drawn from operating executives in Southern mills.

The first session will convene the morning of the 29th, with President H. H. Eler, of Greenville, S. C., presiding. Mr. Eler's address as president and an address by Luther H. Hodges, vice-president and general manager of the Carolina Cotton and Woolen Mills, will feature this session.

The annual banquet will be held the evening of the 29th, with addresses by W. M. McLaurine, secretary of the American Cotton Manufacturers' Association, and H. S. Reeves, of Charleston, S. C.

BEGIN PAYING COTTON FUND

Rental Payments Being Distributed From The Farm Department Here Today

Pitt county cotton growers who took part in the government reduction campaign were trekking toward the local farm office today to receive checks for half of their rental payments.

The checks, amounting to \$30,000 were received at the farm office on Saturday, and notices were immediately mailed out to the various growers to apply on certain days to receive their share.

E. F. Arnold, farm agent, in making announcement of receipt of the checks Saturday morning, said about 350 additional checks for the first half of the rental payments were yet due this county and they are expected at any time.

Mr. Arnold said that the other half of the rental payments probably would be made in August after a complete check of the crop has been made. The farm director especially called attention of the growers to the fact that they should apply for checks only on the date designated on the notices.

AIR MISHAPS PROVE FATAL

Jimmy Weddell, Speed Flier, One of Five Persons Killed In Accidents Sunday

(By The Associated Press) Five men—among them Jimmy Weddell, famous speed flier—died Sunday in airplane crashes.

Weddell, 34, was killed when the ship in which he was instructing a student pilot crashed near Patterson, La. The student was injured seriously.

As thousands stared aloft before the dedication of the new Rutland, Vermont, municipal airport two ships collided in mid-air. A pilot and his photographer, W. J. McMullen, 32, and R. L. Oakes, 30, of Roosevelt Field, New York, died. The pilot of the other ship bailed out safely.

James Carl Ryan, 28, of Yates City, Ill., and Dr. Robert Thomas Plummer, 29, of Praville, Ill., were killed when their plane went into a spin near Praville and crashed in flames. Dr. Plummer, a student pilot, was at the controls.

Mrs. Harris was a member of the Oak Grove Christian Church of near Stokes. She was a splendid Christian character and news of her death was received with sorrow. The family lives a few miles from Greenville.

She is survived by her husband and three children, Paul W. David, Jr., and James Ray Harris, her mother, Mrs. R. L. Woolard, Windsor, Va.; two brothers, Ralph and Russell Woolard, Windsor, Va.; three sisters, Mrs. Edward Howard of Panama; Mrs. Selma Tate Richmond, Va., and Mrs. Sally Belle Auderton, Portsmouth, Va.

OAKLEY HELD FOR ROBBERY

Bridegroom of Three Weeks Charged With Stealing \$50 and Automobile

Willie Oakley, 26-year-old Greenville young man, described by police as a bridegroom of about three weeks, was held in the county jail here today on a charge of stealing \$50 and an automobile from Gus Haddock Saturday night.

A POWERFUL RACKET

(News and Observer)

All over North Carolina, save in the few cities which have outlawed them, are slot machine gambling devices which undertake to sneak through the law by giving a mint or a stick of chewing gum to every gambler.

Anybody who has an idea that the slot machine is a trifling thing of penny and nickel gambling is looking at this problem from the standpoint of one machine and falling to see that it is a huge gambling racket which is taking more money out of the pockets of the people of the State than any wide-open, honestly operated race track with frankly published and permitted gambling odds could ever do.

The racket in North Carolina is apparently as wisely managed as its big profits justify. Nowhere in the State have the real racketeers, the owners of the machines, appeared to protest against the public demand that the machines be outlawed.

Those who are interested in riding the State of slot machines have been making a mistake in spreading their fire against a multitude of individual machines and not seeking at all to determine who are the true racketeers who are making the rich profit from the ownership and control of the machines.

These are questions which should interest North Carolinians today unless the State is willing to continue to delude itself in the attitude that an organized racket which collects thousands of dollars every week in North Carolina is of no more significance than a nickel and dime crap game.

Miss Moore had told him of her brother, Admiral Moore, and of the loans-to-industry act, which proposes that the government and the reserve banks go fifty-fifty in extending credit to private enterprises. The idea is to get the idle capital out and to work.

union bill and the railway bill hold possibilities which may conceivably have a material bearing on the direction of future banking and social legislation.

The former permits the incorporation of small groups of persons to borrow jointly and relend to members without security. It is an experimental thrust at the loan sharks.

The latter set up a compulsory system of employee retirement for railway workers, to be paid for one-third by employees, two-thirds by employer. What more interesting experimental prudence could be devised to the program of industrial insurance to be proposed next session by Mr. Roosevelt?
