BRITAIN WISHES TO SETTLE WAR DEBTS WITH U. S.

New York Banker Sentenced To Prison New Note Sent To Embassy At Washington, D.C.

JOE HARRIMAN MUST SERVE FOUR YEARS

Federal Court Judge Orders Former President Of The Harriman National Bank Confined in Jail 4 1/2 Years; Convicted By Federal Court Jury Last Thursday On 16 Counts

New York, June 27.—(AP)—Joseph W. Harriman, former president of the Harriman National Bank and Trust Co., was sentenced to four and a half years in prison today on a conviction of causing false entries in the books of the bank.

Federal Judge John C. Knox directed that Harriman be turned over to the custody of the attorney general of the United States for confinement in the penitentiary for a period of four and one-half years on each count on which he stands convicted.

The court inadvertently neglected to state that the sentences be concurrent but said later that that phrase was inserted in the records.

Harriman was convicted by a federal jury last Tuesday on 16 counts of an indictment charging falsification of the bank's records and misapplication of funds of the bank.

Execution of his sentence was stayed until next Tuesday to permit him to apply to the U. S. Circuit Court of Appeals for further stay.

J. H. Robinson Dies Following 4-Months Illness

James Henry Robinson, 65, died last night at 9 o'clock at his home near the Briar Swamp Church after an illness of four months.

Funeral services were conducted from his late home this afternoon at 4 o'clock by Rev. J. M. Perry, pastor of the Robersonville Christian Church, and burial was made in the Worrell Moore burial ground near the home.

Mr. Robinson was a member of the Stokes Christian Church and was active in work of the congregation. He had lived in Stokes County all his life.

He was a member of the Robersonville Masonic lodge and was highly esteemed by a wide circle of friends.

He is survived by his wife, who before her marriage was Miss Sarah Bullock. He had no other living relatives.

Defers Talk With N. C. Delegation

Washington, June 27.—(AP)—Plans for a North Carolina delegation to talk with Secretary Ickes about the route for the proposed Phoenix highway through the Great Smokies and Shenandoah National Park have been cancelled.

Cancellation of the conference was announced last night from the office of Senator Bailey who had made arrangements for the meeting tomorrow. The announcement said the cancellation was made at the request of Secretary Ickes. It added that while there is no assurance of a later meeting, one may be arranged if considered desirable by the secretary.

THREE CASES POTTER HURT IN COURT HERE IN ACCIDENT

John Bass, colored, fined for stealing highly prized pistol Sunday

County Court, which has been enjoying abbreviated sessions for the last month or so tried one of the lightest dockets of the year yesterday and adjourned before noon. It is the first time in months probably that only three or four cases have faced the court, and officials were probably glad of the break in view of the blistering temperatures holding sway throughout the day.

Jess Bass, negro, charged with stealing a pistol from James Smith, also colored, Sunday, was found guilty and fined \$25 and cost.

The negro was taken into custody by city officers shortly after the pistol was reported stolen and found it in Bass' house here. Bass at first denied implication, but admitted he stole the firearm after police found it.

Smith probably wouldn't have raised so much sand about the matter anyway had it not been for the fact that the pistol was given him by a former employer and was highly prized. The gun was highly ornamented and is of such value to the owner that he would readily defend it with his life.

James Edward, colored, charged with assaulting a colored girl, was sentenced to ninety days on the grounds that he is a good road to turn on nearby. David Applewhite, colored, with found not guilty on assault.

The usual summer vacation of the court was not considered yesterday, but if the present heat wave continues, it may be said with certainty that officials will not be able to restrain themselves much longer. Good fishermen in the circle are probably ready for the summer holidays, but Judge Dink James doesn't give a darn about wearing himself out on a river bank, and had as soon listen to evidence despite hot weather.

MILLS REJECT PEACE OFFER

Laurinburg, N. C., June 27.—(AP)—Negotiations between employers and striking employees at the Waverly Mills were apparently at a standstill today after the management was said to have rejected a union overture on procedure looking to arbitration.

The agents said they stopped, explained their business, "cussed out the pickets," and drove on.

When they returned, the trio said, six or eight shots were fired as they drove along but the three men said they believed the firing merely was an act of intimidation rather than an effort to wound anyone.

NOTED BRIDGE EXPERT DEAD

Milton C. Work Succumbs To Intestinal Disorder At Hospital In Philadelphia

Philadelphia, June 27.—(AP)—Milton C. Work, instructor and advisor to millions in the international realm of auction and contract bridge, died early today in a Philadelphia hospital. He was 69.

The Philadelphia card expert who gave up a promising law career to find a fortune in the popular interpretation of the laws of bridge, fell victim to intestinal disorder that plagued him for months.

His first book, issued in 1893, was "Waist of Today." With the advent of bridge he became a fan of this game and soon learned he could win consistently by following certain laws he found in the game.

FARLEY LAUDS MR. ROOSEVELT

Says President's Program Is Beginning To Bear Fruit For The Nation

Washington, June 27.—(AP)—Postmaster General James A. Farley assured delegates to the convention of Rotary International today that "there is no danger of any college professor leading President Roosevelt off on any haphazard adventure."

He told them that the President's departure from the old practice of rugged individualism was long planned and is now beginning to pay dividends.

"I know of no man with a more definite mind than his," said Farley. "I know of no executive less likely to be swayed by impractical theories regardless of sources, than the President."

"To listen to our critics one would think that the various elements of the recovery program were haphazard adventures made by the President because some professor whispered to him. This program was worked out in Mr. Roosevelt's mind before he was even nominated for the presidency."

"There is nothing impulsive about him except the impulse to serve the country and you may be sure his head is cool and his feet are on the ground all of the time."

MILLER HURT IN BALL GAME

Former Greenville Player Now Umpiring Hit In Neck By Foul Ball at Kinston

"Bing" Miller, former Wake Forest College third baseman, who was released by Greenville several days ago, and who umpired the game between Greenville and Kinston at Kinston yesterday afternoon, was reported as painfully injured when he was hit in the neck by a foul ball.

The game was delayed for some time while physicians on the field rendered emergency aid. Although Miller umpired the remainder of the game, he was reported as unable to speak, and fear was expressed that the injury may prove serious.

Miller was a member of the Greenville championship team last season and went through the season with only a few errors to his credit.

He had only two bobbles chalked up against him up to the middle of the season.

HEAT WAVE GRIPS AREA

Community Today Expected To Experience Hotter Weather Than Yesterday

The citizenship mopped its brow and fanned diligently today as it peered anxiously into the heavens for indications of relief from the heat wave which has held sway the last several days.

B. T. Clark, local weather observer, said the mercury climbed to 99 degrees yesterday afternoon with indications today it would be still higher. At 11 o'clock he said the government records showed a temperature of 97 degrees.

Although the mercury climbed beyond 101 degrees here last year, old weather observers here, going entirely by feeling, declared it felt just as hot today as any day last year. Humidity added greatly to the uncomfortable temperatures today.

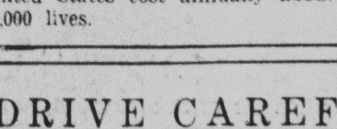
Cooling breezes came to the rescue of the locality last night and thousands of persons who had developed a dizzy feeling form the high temperatures during the day, were at last able to crawl in bed and snooze peacefully until the morning.

While the heat was tough for individuals, it was said to be the thing needed for the crops, and taking that as an index to the general situation, the community might be able to stand a little more pressure.

Meridan, Miss., June 27.—(AP)—A broken cylinder last night ended the attempt of the Key Brothers to set a new endurance flight record after they had spent 123 hours in the air.

Official time of the landing was given at 10:45 last night. One of the cylinders of the motor of the plane worked loose but was temporarily repaired. It soon gave away again, and fear that the cylinder would be hurled into the pilot's seat brought the decision to come down.

The brothers, Al and Fred Key, said they had not given up hope of breaking the recent record, and announced they would make another attempt as soon as the necessary arrangements can be made.

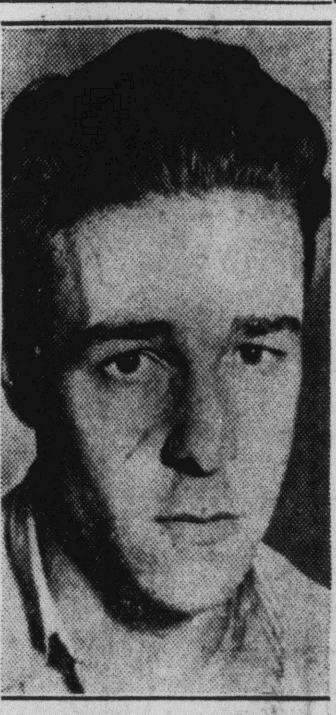

SCHOOL FUND SLOWS DOWN

No New Contributions Reported To Vacation Bible School During Morning

No additional contributions had been reported to the Daily Vacation Bible School today, but members of the finance and soliciting committees were continuing their efforts to raise the \$100 yet required for the institution.

Reports yesterday swelled the total to \$304.30. The amount required for the four weeks' operation of the school is \$400.

Although committees of some of the churches have reported, others were scheduled to go out sometime during the week and it was hoped the remainder of the fund would be raised through these efforts.

The school is sponsored by the churches of the city in co-operation with the public school system. Over two hundred students were enrolled when the school was thrown open last week.

Dr. G. R. Combs, pastor of Jarvis Memorial Methodist Church, chairman of the school finance committee, renewed his appeal today that the public give liberally to this cause, launched in behalf of improvement of the moral life of the juvenile element of the city.

Proctor reported today that all machines in the city limits had been moved.

DECLINE TO MAKE KNOWN ITS CONTENTS

Desire For Discussion Of Full Payment Of The Debt Understood To Be Re-stated in the Communications; Experts Say Note Is Short, But Remain Silent

London, June 27.—(AP)—A new British note was cabled to the British embassy in Washington today in which the British government emphasized its desire to negotiate a permanent war debt settlement with the United States.

Foreign office officials declined to reveal the exact nature of the note except to say "it is quite short."

The British policy of the past in reference to the desire for a discussion of the full settlement of the debt question was understood to have been restated as part of the communications.

He was the son of the late Edward Thorne Clark and Margaret Lillington Clark, and a nephew of the late Justice Walter Clark of the North Carolina Supreme Court.

COUNTY HOME INMATE KILLED BY AUTOMOBILE

Sylva, N. C., June 27.—Louis Frady, 32, an inmate of the Jackson County Home, died in C. L. Harris Community Hospital at 3:40 o'clock Monday morning of injuries he suffered Sunday night when struck by an automobile at Webster junction on State Highway No. 106.

The automobile was driven by Frank Crawford, of Cullowhee, operator of a book store at Western Carolina Teachers' College. After an investigation, Police Chief J. A. Turpin said the accident was unavoidable and announced Crawford would not be held.

A number of witnesses said Frady walked in front of Crawford's automobile. Frady's skull, thigh, collar bone and jaw were fractured, and he also suffered internal injuries.

SOMEBODY BLUNDERED

Study of the statistics reveals that a majority of the 756,500 automobile accidents in the United States in 1933 occurred on straight, dry roads in clear weather, and involved cars in good condition driven by persons with a year or more of experience.

A recent analysis shows what the blunders were. There are eight in all.

- 1. Drove too fast for conditions—this accounted for approximately three-fourths of all mishaps in 1933 assigned to driving blunders. 2. Failed to slow down at intersections. 3. Failed to keep to the right. 4. Tried to pass another car going in the same direction when view was obstructed.

If drivers will obey the eight common rules suggested by these violations, the annual accident record can be reduced to a negligible figure.

By HERBERT PLUMMER Washington.—The House of Representatives never will quite forgive the Senate for refusing to adjourn the Seventy-third Congress on Saturday night, June 16.

ASHEVILLE BOY DIES, VICTIM LEUKEMIA

Asheville, N. C., June 27.—Suffering from what is believed to have been the first case of leukemia ever reported in Asheville, Thomas Edwin Weis, 11, died at 6 o'clock Sunday afternoon at his home, No. 3 Warwick Road, Kenilworth. The immediate cause of death was a cerebral hemorrhage, the boy being stricken a few hours before death.

Physicians were unable to say whether there was any connection between the disease and the hemorrhage. The lad apparently had been suffering from lymphatic leukemia for several months, it was said, but the disease was not discovered until he was stricken. Leukemia is a comparatively rare disease in which the red blood cells are destroyed.

The boy is survived by his mother, Mrs. H. A. Wells; a sister, Sara Lou Wells, and three brothers, E. Edward, Harry B. and Richard Alonzo Wells.

SEVERELY INJURED IN AUTOMOBILE MISHAP

Smithfield, N. C., June 27.—Hubert Creech is reported in a serious condition by officials of the Johnston County Hospital resulting from severe injuries received in an automobile accident Saturday night. Creech, who lives in Benson, is suffering a broken hip and severe head injuries.

Creech was an occupant of a coupe driven by Garland Johnson when the wreck occurred on Farrish in Benson. Johnson, who was blinded by the lights of an approaching car, collided with the car and a truck parked on the street. Neither Johnson nor the occupants of the car were injured in the accident.

RECORDED WARNS OF BEACH INDECENCIES

Elizabeth City, N. C., June 27.—Recorder W. C. Morse, Jr., today gave a judicial expose of the indecency of Pasquotank River beaches. With characteristic eloquence he described the nocturnal drinking parties which infest the otherwise beautiful waters of the river, the nudist swimming ventures and worse revelries which are becoming a menace.

The subject was brought up by the arrest of five colored bathers, charged with participating in an affray, but the recorder was emphatic in stating that the river revelries are not confined to the colored race. He warned of serious tragedies likely to result from the beach indecencies.

The WORLD of STAMPS

By QUINTON JAMES
Antonio Oscar De Gragasa Carmona, president of Portugal, assumed office in November, 1926, and in honor of the eighth year of his presidency a special stamp has come from that country.

It bears the president's portrait, in dress uniform, and is slightly larger in size than the recent issues of Portugal. The color is deep violet, with the inscription, Portuguese republic, placed vertically on either side of the head.

The value is 40 centimos.

From Africa
Part of a new issue of the British protectorate of Nyasaland in South Africa shows a definite change in design for the stamps of this section of the world. They are oblong, about the size of a U. S. special delivery, and have a small head of King George looking to the right instead of to the left.

The principal part of the design consists of a leopard standing upon a rocky pinnacle with the setting sun in the background. To date the 1-2, 1, 1-2, 2, 3, and 6 penny stamps have been received with a 1 shilling to come out later.

U. S. Activities
A new 6-cent airmail stamp, now that the 8-cent plane postage rate has been reduced to 6 cents, will be the next to embellish the U. S. postage list. It will appear ahead of the Wisconsin tercentenary, now postponed until July 7.

The 6-cent, the first of that denomination to be printed since the original airmail issue of 1916, will be the same design as the present 5- and 8-cent, with the color orange.

The Wisconsin commemorative, a 3-cent, will go on sale the first day at Green Bay, Wis., where Jean Nicolet, French explorer, landed in 1634 in his search for India.

There also has been a change in the date for the new stamps to commemorate the national park system. The first of the series, the 1-cent green, will go on sale July 16 at the philatelic agency in Washington and at the postoffice in Yosemite Park, California, as has a picture of Mt. El Capitan in that park.

Sale of the others will start later in the parks which they commemorate and at the philatelic agency. Because two California parks were pictured in the original series, the design of the 8-cent has been changed to show a view of Crater Lake National Park in Oregon instead of Sequoia Park in California.

The remainder of the stamps represent these national parks: Grand Canyon, Arizona, 2-cent; Mt. Rainier Park, Washington, 3-cent; Mesa Verde Park, Colorado, 4-cent; Yellowstone, Wyoming, 5-cent; Zion Park, Utah, 6-cent; Acadia Park, Maine, 7-cent; Klacifer National, Montana, 8-cent, and Great Smoky Mountains Park, North Carolina and Tennessee, 10-cent.

The new Presidential issue, intended as a replacement for the current regular postage, has been put off until the fall, the date for which still is indefinite.

of Italy to commemorate the world championship soccer baseball games did not comprise the entire issue. Altogether there are 30, 11 of which are for use in the Italian colonial possessions. Of these, the five regular postage range from 10 centesimi to 10 lire and the six airmail from 50 centesimi to 25 lire. They show football activity of one sort or another coupled with Roman columns or desert scenes as well as airplanes flying over athletic fields.

MAKING SANDWICHES FOR SUMMER AFTERNOONS

Now is the time to think of novelties in the way of sandwiches to serve with cool beverages on hot summer afternoons. First, prepare some mayonnaise. Then mix with anchovy paste. Season with a dash of red pepper or paprika. If you want still more flavor, chop up stuffed olives or ripe olives and add to the mixture.

Then spread on very thin slices of toast. Or use your ingenuity in making odd-shaped sandwiches. A new way of cutting the bread may give the sandwiches a new appeal, and a tiny sprig of parsley or watercress stuck in the top will give it a pleasing flourish.

Another way of making toast is to spread bread with olive oil, and

toast until the bread is light brown. Then spread with anchovy paste or smoked salmon or minced ham and another delectable what-not is ready for your guests.

Tomato sandwiches are always good—particularly when very cool and fresh. After peeling the tomatoes chill in the ice-box before making the sandwiches. A dash of cream cheese spread over the slice of tomato is a nice touch, and watercress always adds to the appearance. Mayonnaise should be used sparingly, to avoid making the sandwich awkward to eat.

Washing Suggestions
Lemon and salt, mixed, will help to remove the rust color from a garment which has been pressed with too hot an iron. Hold the material over steam while this mixture is on it.

Keeping Fat Usable
It is best to drain fat through cheese cloth before putting it away for future use. Thus all food particles are removed and the fat may be used over and over.

Hard-cooked eggs, the yolks removed and mixed with pickle relish, sardines and dressing and replaced in the egg white cases, make tempt-

ing appetizers to serve with cocktails.

Dry Clothes With Fan
If you have an electric fan you can dry your clothes much more readily on a damp day by hanging them up and placing the fan within range so that it blows on the clothes.

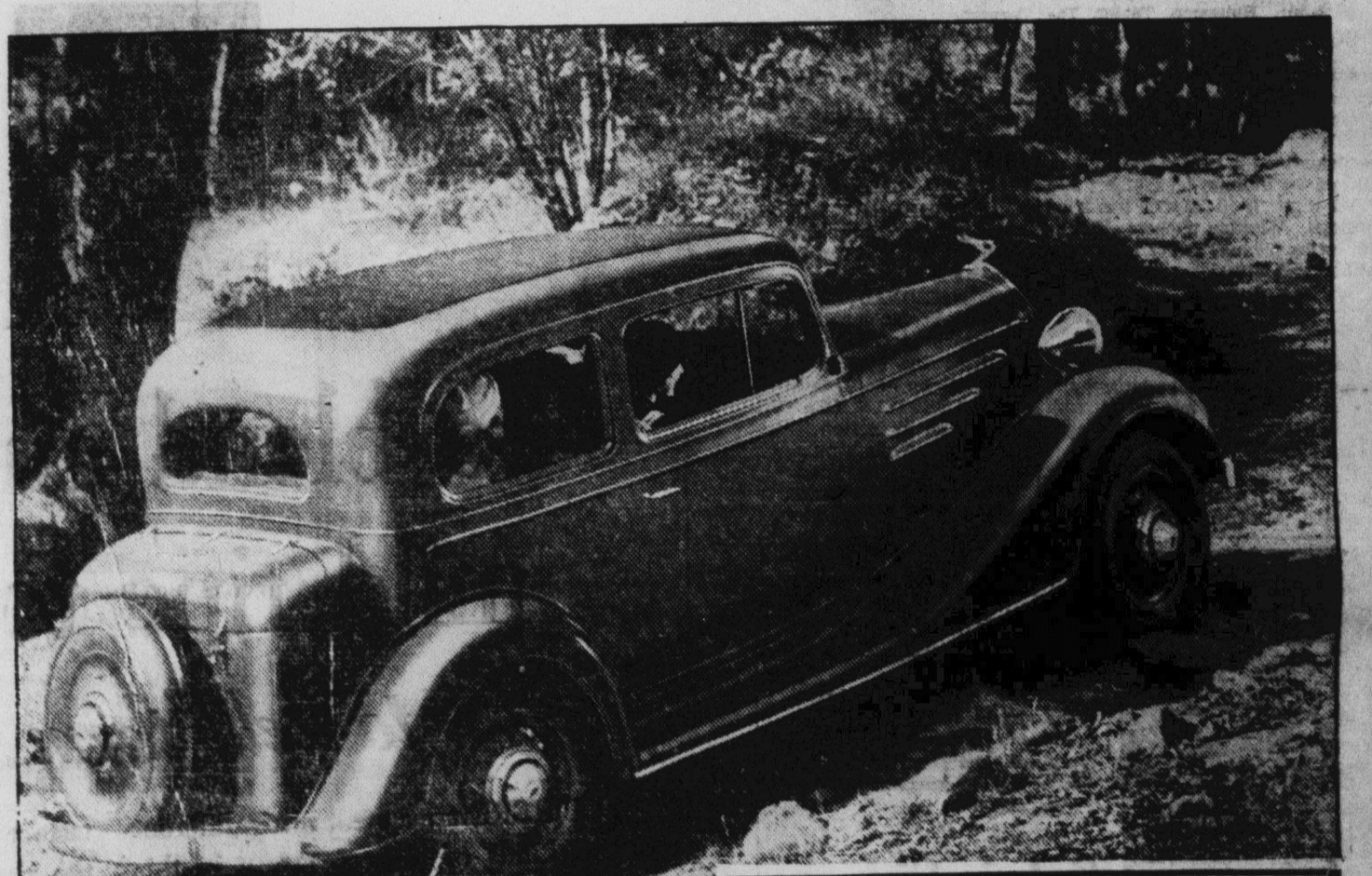
