PAYLOR DEFEATS EDWARDS FOR SEAT IN HOUSE

Scores Of German Leaders Arrested In Hitler Drive

HINDENBURG ORDERS ARMY TO SAVE PAPAN

Numbers Believed Killed in Chancellor's Ruthless Effort To Clean House; Rumors That Crown Prince Wilhelm Was Arrested Proved Groundless; Merciless Campaign to Continue

Berlin, July 2.—(AP)—President Paul von Hindenburg today made the Reichwehr German army personally responsible for the safety of Vice-Chancellor Franz von Papen, threatening a stage of siege if he were victimized for his recent stand in criticizing Nazi policies.

Berlin, July 2.—(AP)—Scores of Nazi storm troops sub-leaders, possibly hundreds, have been arrested throughout Germany in Chancellor Adolf Hitler's ruthless house-cleaning, it was learned today.

The leaders were arrested in wholesale fashion after a week-end of violence which saw a number of their superiors summarily executed. Estimates of arrests ranged from one hundred to several hundred with official figures withheld. Men accused of plotting against Hitler were arrested in storm troop groups in Berlin, Brandenburg, Bavaria, Silesia and Pomerania.

A statement issued last night said the "cleaning in finished" but at the same time Hermann Wilhelm Goering, German Minister without portfolio and Premier of Prussia, said he would be a tailor again if the leader must be called to account.

A special storm troops law punished treason with the death penalty, and Goering plainly indicated he intended to proceed mercilessly against mutineers and reactionaries. No deaths had been issued but it was expected this would number eighteen.

Rumors that Crown Prince Friedrich Wilhelm had been arrested were proved groundless. The propaganda ministry announced the final list of all executions in the abortive revolt would be published during the day.

American Girl Released After Russian Arrest

Moscow, U. S. S. R., July 2.—(AP)—Miss Avis Thayer, of Philadelphia, Pa., who is visiting her brother, Charles Thayer, private secretary to Ambassador William C. Bullitt, was arrested today and held in police court for an hour and a half for taking a photograph of one of the Kremlin gates.

N. C. ARTILLERYMEN AT FORT MOULTRIE

Charleston, S. C., July 2.—(AP)—The 32nd Coast Artillery Regiment of the North Carolina National Guard, comprising sixty-three officers and about 650 men, was encamped last night at Fort Moultrie and today will begin the annual two-weeks training schedule. The troops will fire mobile 155-millimeter coast defense artillery.

Colonel Royce S. McClelland arrived in command of the main body of troops. Colonel McClelland is from Wilmington. A service battery had preceded them and made ready the camp in the tent city at the Military Reservation on Sullivan's Island. Units of the 252nd Regiment, Raeford, Lumberton, High Point and Whiteville.

On the staff of Colonel McClelland are Lieutenant-Colonel Robert B. Laws, of Raeford; Captain Andrew H. Harris and First Lieutenant H. M. Symme, both of Wilmington.

BARDEN WINS HOUSE SEAT

Luther Hamilton Concedes His Defeat to New Bern Man in Third District

Charlotte, N. C., July 2.—(AP)—Graham Barden, of New Bern, former member of the State House of Representatives, will represent the Third North Carolina District in Congress.

Virtually complete unofficial returns from the Second District primary showed Barden leading his opponent, Luther Hamilton of Morehead City, by around 2,500 votes.

Returns from 152 of the 165 precincts in the district gave Barden 15,335 votes and Hamilton 13,000.

New Bern, N. C., July 2.—(AP)—With full official returns in from Carteret County, Luther Hamilton today conceded his defeat to Graham Barden for the Democratic nomination for Congress from the Third District.

Hamilton's Carteret vote was 1,430 to 508 for Barden.

NEGRO JAILED IN THEFT CASE

Galving Hyman Stea's Chickens and Lands Behind Jail Bars Soon Afterward

Stealing chickens may look easy, and it was easy for Galving Hyman, Jr., 18-year-old negro, but he couldn't get away with it and was landed in jail shortly after the crime was committed.

Elias Taft, of the Grimesland community, came to the city Saturday morning to dispose of some chickens. Arriving in town, he placed five chickens on the sidewalk at Blount-Harvey Co., and went into the building to see if the firm wished to buy his offerings.

Seeing the chickens on the street and nobody guarding them, Hyman immediately took possession of them, police said, and went to Herring's grocery and told them for \$1.00.

Taft came out of the store and couldn't find his chickens, so he notified police. Hyman was trailed to Herring's store, the chickens were identified by Taft and police shortly afterward took Hyman into custody along with part of the money.

Hyman was scheduled to receive preliminary hearing here today and was expected to be bound over to the next sitting of county court.

TWO GIFTS TO BIBLE SCHOOL

Recreation Corporation Contributes \$24 And Ollie Clark \$2 Today

The Greenville Recreation Corporation, through its secretary, Junius H. Rose, announced today that the corporation had donated \$24 to the Bible School Fund.

This swelled the total to \$332.30 with a contribution of \$2.00 from Ollie Clark. The amount needed for the school is \$100, and it was hoped that committees would get busy this week and obtain the remaining amount.

Dr. G. R. Combs, pastor of Jarvis Memorial Methodist Church, and chairman of the school finance committee, made a final appeal in behalf of the school fund last Saturday, and expressed the hope contributions would be liberal enough during this week to enable the committee to end its work.

The school starts this morning. Over two hundred children from a neighborhood of the city are receiving instruction under the supervision of the committee.

The school is the outgrowth of a desire to improve the social situation, described by these children as alarming and needing immediate attention. The children are receiving instruction in mental, physical and social development, and that their guidance as a result of the school will be an important part in the future life of the city cannot be doubted.

Persons who have contributed to the cause are asked to do so immediately and help the committee close its work with success written at the end of the report.

STORM CAUSES MUCH DAMAGE AT SALISBURY

Two Children Injured As Lightning Strikes Park Avenue Methodist Church

Salisbury, N. C., July 2.—(AP)—Lightning, high wind and torrential rainfall did large damage to Salisbury and vicinity last night at a heat wave which had been prevailing for a week, was broken. Rainfall was 2.10 inches, or more than the entire amount for the past month and fell in about an hour.

Lightning struck the Park Avenue Methodist Church while a group of young people were holding a meeting and knocked unconscious Helen Hall and Maxine Doby. Neither was seriously hurt. Several homes were struck and a barn belonging to C. A. Goodman in the country were burned, but the stock was saved. Trees were blown down, buildings unroofed and crops damaged to some extent.

More than 600 telephones were put out of commission and utilities companies had plenty of trouble from poles being shattered and high wires being blown down.

Lightning ran in on a switch at the Kluma Cotton Mills, sparks jumped and ignited some cotton, the sprinkler system started functioning and rayon stored in the basement was damaged by water to an estimated extent of \$8,000.

Over Two Inches Of Rain Sunday

B. T. Clark, local weather observer, stated today that the city and community had 2.74 inches of rainfall yesterday afternoon and last night. It was the heaviest precipitation for a similar period recorded here in sometime. Mr. Clark said, and nearly as much as we usually have in a month. The average monthly rainfall in this county is about four inches, Mr. Clark said.

No damage was reported from the heavy rain and accompanying electrical storm, although sections of Martin County were reported to have suffered considerable damage.

Hollingsworth Assumes Duties As Postmaster

T. T. Hollingsworth today entered upon his duties as postmaster of Greenville.

He was named to the post about two months ago, but delayed taking over the office until he completed work in connection with his duties as sales tax collector for Pitt County of the State Revenue Department.

M. T. Hollingsworth is a former hotel operator here. He accepted the position with the Revenue Department shortly after the sales tax legislation became effective. He is a former member of the Board of Aldermen and was Pitt County campaign manager for Senator Bob Reynolds in the last campaign.

He succeeds H. R. Mumford, who has served for the past twelve years.

ROOSEVELT IS OFF ON JAUNT ON HIGH SEAS

President to Visit American Possessions Before Returning to Washington

Aboard U. S. Gilmer, Accompanying President Roosevelt, July 2.—(AP)—President Roosevelt turned to the open sea today striking out on the historic journey to American possessions of the Atlantic and Pacific. The cruiser Houston, carrying the President was near Hampton Roads at dawn for a final exchange of official papers after a cheering send-off as darkness fell last night at Annapolis, Md.

From Hampton Roads the President goes to high seas, stopping briefly at Haiti Thursday before landing at Porto Rica Friday to travel across the island.

A gay flotilla of small craft surrounding the Houston in midstream at Annapolis shouted farewell to the President, bent eagerly on his sea vacation.

A band on the deck of the Gilmer hailed the commander-in-chief on the Houston with the "Star Spangled Banner."

Mr. Roosevelt stood at attention and sailors manned the rails. Franklin, Jr., and John, sons of the President, were aboard with him. Mrs. Roosevelt and James, the oldest son, waved farewell from the docks with the crowd that gave the President a rousing send-off.

Late News Flashes

Adopt Arms Embargo Pact. Geneva, July 2.—(AP)—The American project to curb the manufacture and profit of arms, urged by President Roosevelt as imperative, was adopted today at a plenary session of the disarmament conference steering committee.

The plan provides for international registration and publicity and strictest inspection and supervision of all armaments.

Representatives of Britain, France, Venezuela, Sweden, Czechoslovakia, Switzerland and Spain supported and paid tribute to the United States for its constructive proposal.

A Venezuelan representative said it would go down in history as a great success.

A draft of the proposal will be sent to all governments with the idea that it will be incorporated in (Continued on Page Four)

RAIN SETBACK TO OPENING OF UNION SERVICE

Small Crowd Takes Part in Brief Devotional Service in Courtroom

Rain, which came down in torrents yesterday afternoon and last night prevented the opening service of the union services of city churches in the courtroom lawn last night, but a short devotional service was held in the courtroom for the 25 or 30 people who braved the inclement weather to be present.

Rev. W. A. Ryan, pastor of the E. 10th Street Christian Church, scheduled to deliver the opening sermon, spoke briefly on the subject of "Reconciliation," ushering in local and world events to illustrate his subject.

Ample seating accommodations had been provided on the lawn for several hundred persons, but the lawn was virtually flooded by the torrential rainfall, and this made the holding of the services on the outside inadvisable.

Next Sunday evening, weather permitting, the service will be held on the lawn, and the sermon will be delivered by Rev. A. W. Fleischmann, pastor of Memorial Baptist Church. Special music will be provided by the Memorial Baptist church choir.

Ministers representing the other churches of the city will preach each Sunday evening during July and August and members of the Ministerial Association, which is sponsoring the services, expressed hope attendance would be large.

WILL MEASURE FARM ACREAGE

Committee to Receive Instructions on Cotton and Tobacco at Williamston

The county tobacco and cotton acreage measuring committee went to Williamston today to receive instructions relative to acreage measurements scheduled to get under way immediately in all tobacco and cotton-producing counties of the county.

The county committee is composed of J. E. Winslow, R. L. Little and Haywood Dail. They were accompanied by Williamston by County Agent E. P. Arnold, who is in charge of the production campaign in this county.

A representative of the State Tobacco Administration will be at Williamston to acquaint committee members of several surrounding counties with details of the measurement program. The committee will return to their respective localities and call a meeting of all committee members to inform them of their findings.

Mr. Arnold said before leaving that notices of the meeting would be sent out immediately upon his return, and that the measurement of tobacco and cotton acreage will be gotten under way immediately.

The measurements are being taken to determine if growers lived up to provision of their contract calling for reduction of both tobacco and cotton crops.

FARMVILLE GOES SOLID FOR PAYLOR

Paylor Captures Legislative Seat From Edwards by a Majority of 2,171 and Moore Again Wins His Post as County Treasurer by a Majority of 501; Edwards Loses in Every Township Except Greenville; Moore Given Big Boost in Greenville and Farmville

Piling up a smashing majority in every township except one, John Hill Paylor of Farmville, defeated Jack Edwards of Greenville, for a seat in the House of Representatives of the North Carolina Legislature in the run-off primary held throughout the county last Saturday. Paylor's vote was 3,757 and Edwards' 1,586. The majority was 2,171.

While Paylor was administering this drubbing to the former House member, Thurman Moore retained his post as County Treasurer by ridding Vance Perkins to the tune of 2,932 to 2,431. Moore's majority was 501.

Paylor showed his greatest strength in his home town of Farmville, which went solidly for him. His vote there was 793 to Edwards' 16.

Edwards led in only one township Greenville, where the largest vote in the county was cast. His vote was 338 against Paylor's 579.

Moore showed his greatest strength in Greenville and Farmville townships. Greenville gave him a vote of 917 and Farmville 529. Perkins received 618 in Greenville and 233 in Farmville.

The vote for each of the contestants in the first primary was: Paylor, 3,757; Edwards, 3,371; Moore 2,649; Perkins 1,691.

Neither Paylor nor Moore obtained sufficient votes in the first primary to assure nomination and their opponents were eligible to enter a second primary, which they did on the final day of registration period.

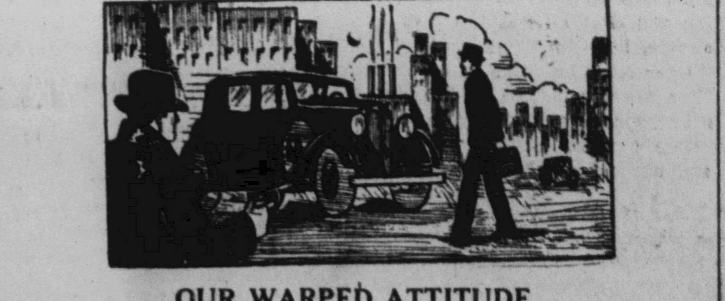
The total vote cast throughout the county was 5,333. The total vote in the first primary was around 8,000.

Voting throughout the county was conducted in an orderly manner and no special rush was reported in any particular precinct.

The Farmville vote of 809 was the same as cast in the previous primary, showing that the people of that area were interested in their candidate for the House seat; and rallied to help put him across.

M. O. Blount of Bethel, who obtained a majority in the first primary, will go to the next sitting of the Legislature with Paylor. Blount obtained the greatest vote in the four-cornered race for the House. The count was completed by 10 o'clock in all precincts. It was a striking contrast to the first balloting when all night and the major part of the next day were required to complete the tabulation. Unofficial but complete returns from all precincts follow: Ayden—Edwards 79; Paylor, 284; Moore 177; Perkins 188. Beaver Dam—Edwards 51; Paylor 94; Moore 81; Perkins 61. Belvoir—Edwards 28; Paylor 180; Moore 81; Perkins 103. Bethel—Edwards 38; Paylor 183; Moore 110; Perkins 111. Carolina—Edwards 54; Paylor 111; Moore 12; Perkins 170. 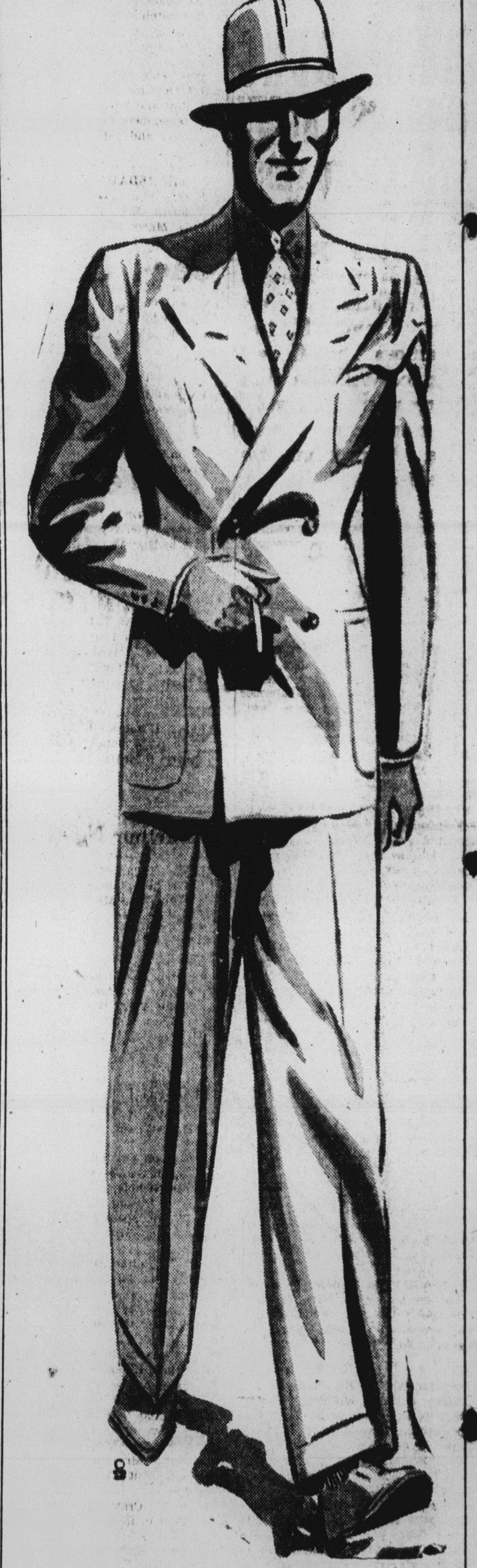

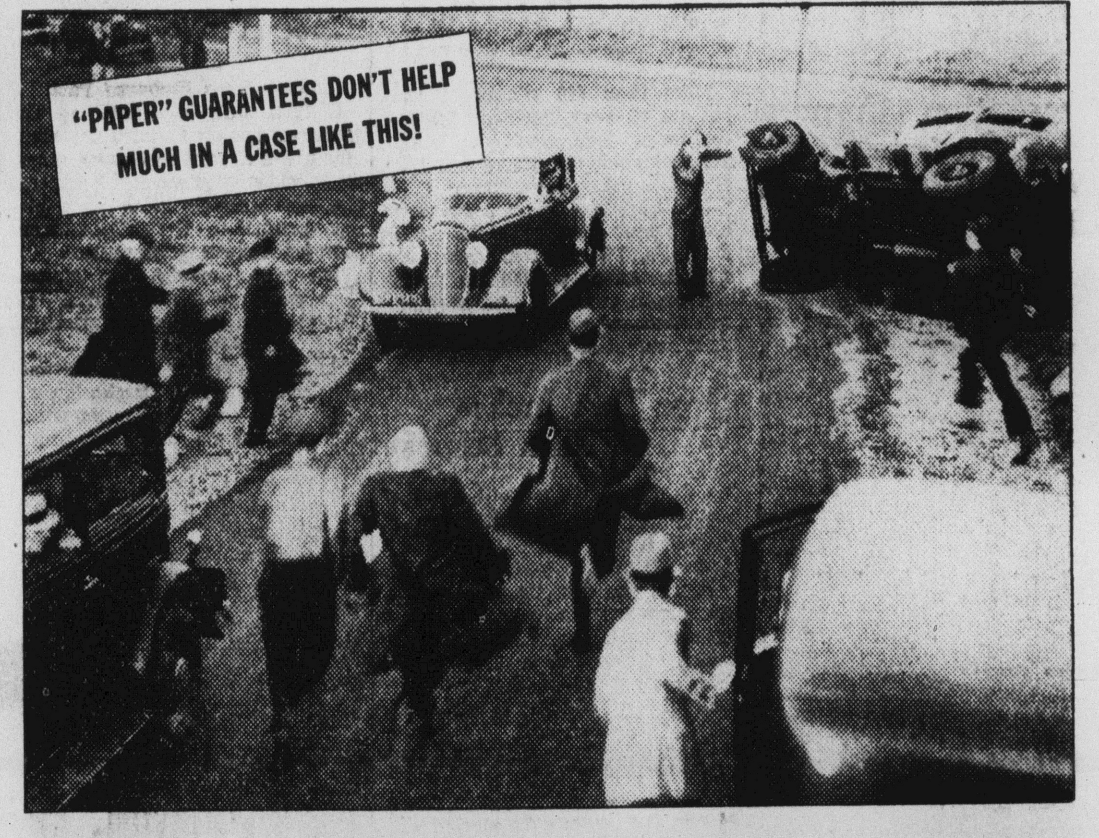

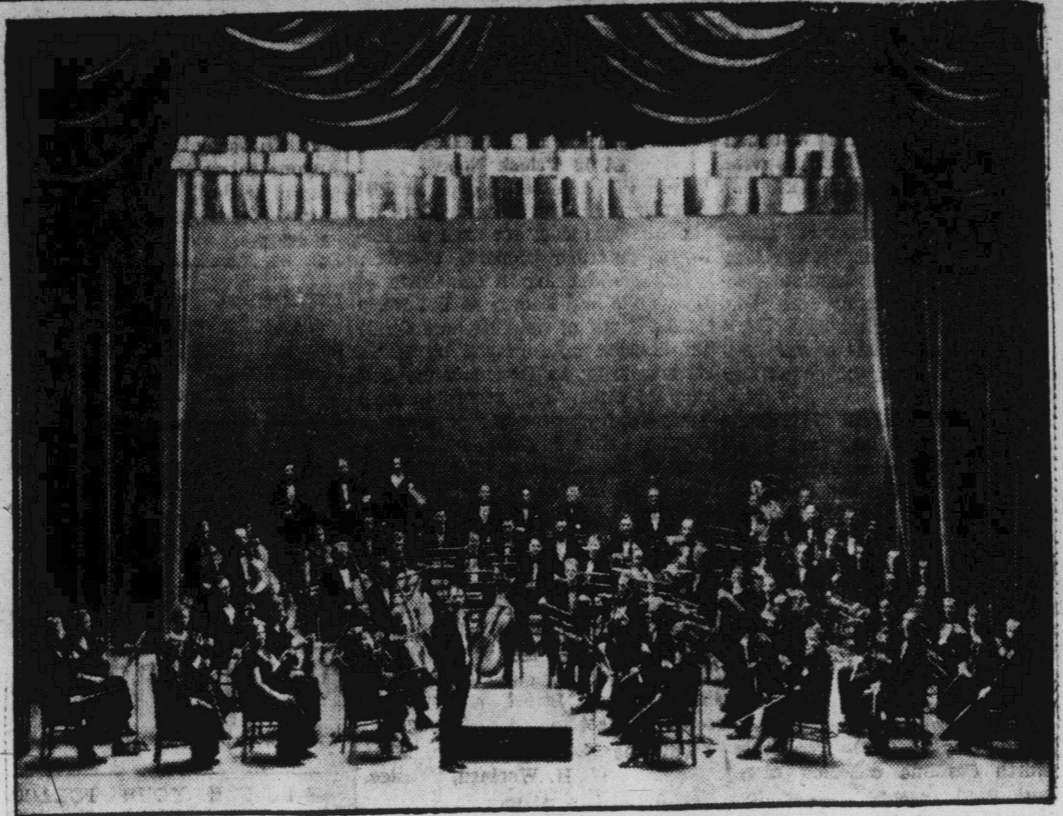

Rumor has it that Tugwell all but wept. His disappointment was so keen that President Roosevelt felt moved to dispatch him a note advising that he "keep his shirt on."

He feels better about it now and is determined to fight.

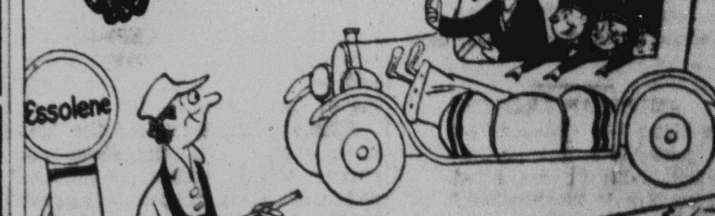

New York, July 2.—(AP)—Clouds hovered the financial markets today, and both traders pending the clearing of speculative skies.

Extreme dullness marked the first day's operation of the stock exchange under Federal regulation and more shares grouped by the rails exhibited a rather heavy tone.

Some of the nervousness was attributed to exciting developments in Germany as well as to doubts concerning the effect of various new laws in industrial profits generally.

The softness of grains did not tend to brighten the picture. Wheat and corn dropped a cent or more a bushel and the other cereals lagged.

Stock prices sagged under dull selling. Rails led the decline. Later quotations were around the low for the day.

Sales approximated only 365,000 shares. Union Pacific got down around three points, while U. S. Steel, American Telephone, Case, Dupont and Santa Fe rallied fractions to a point or two.

 Berlin, July 2.—(AP)—The list of executions mounted swiftly tonight. It was reported that 60 have been put to death in Berlin alone.

Revenue Collections Larger.
 Raleigh, July 2.—(AP)—The State of North Carolina collected more general fund revenue during the fiscal year which closed Saturday, than it ever received before.

Receipts for the general fund aggregated \$21,569,818, an increase of more than \$7,000,000 over the total of \$14,301,819 which was collected in 1932-33. A. J. Maxwell, commissioner of revenue, said today.

Highway fund receipts for the 12 fiscal months aggregated \$22,552,478, an increase of \$2,383,000 over the 1932-33 total of \$20,168,650.

To close the state books with all possible 1933-34 revenue included the highway patrol, came into Raleigh all through Saturday night with last minute collections of all kinds and the books were not finally totalled until yesterday morning, after the force had worked all night.

As a result receipts Saturday totaled \$300,885 and the money received on schedule license taxes reached \$1,018,000 for June, nearly a million ahead of some receipts. Last June only \$94,286 in all taxes was collected on June 30, 1933, the last day of the previous fiscal year.

The increase of \$7,000,000 in the general fund was allegedly accounted for by collection of \$6,015,900 from the three per cent general sales tax which was in effect for the first time.
