SELF-GOVERNMENT FOR INDUSTRY PLANNED IN U. S.

Political Truce Is Declared In Germany Will Take Place of NRA Activities Thruout Country

STEPS TAKEN TO BLOT OUT REVOLT TRACE

Special Vigilance to be Maintained on all Fronts Despite Efforts Restore Peace; Hitler Returns to the Bavarian Alps To Complete His Vacation.

Berlin, July 7.—(AP)—A political truce was put into effect today by the Nazi high command in a determined effort to efface all remaining traces of Germany's bloody "second revolution."

Chancellor Adolph Hitler left for his summer home in the Bavarian Alps for inspiration while his trusted sub-leaders are also taking their first rest since the party purging of plotters and traitors.

Two million storm troopers temporarily stripped their uniforms are on a month's vacation. Their future has become Germany's foremost political problem. A powerful political instrument, these peace-time soldiers are being treated as if they might become greater in power than their creator.

Vice-Chancellor Franz Von Papen when seen at his home today seemed in better spirits as if reflecting the prevailing tendency toward political peace.

Despite the political truce, the propaganda ministry indicated that special vigilance on all fronts by the secret police will continue undiminished.

There was intimation that Chancellor Hitler's short respite in the Bavarian hills may be extended to a possible longer vacation. Hitler left exactly one week after he had flown to Munich and accomplished his grim purging of storm troops with firing squads.

MRS. RIGGS PASSES AWAY

Funeral Services to be Held From Home in Chicod Township Sunday Afternoon

Mrs. Sallie Riggs, 75, died at 5:30 o'clock this morning at her home in Chicod Township, between Galloway's Cross Roads and Grimesland, after five weeks of illness from a complication of diseases.

Funeral services will be conducted from her late home tomorrow afternoon at 3 o'clock by her former pastor, Rev. M. C. Prescott, who for years was pastor of the Black Jack Free Will Baptist Church. Burial will be made in the family burying ground near the home.

Mrs. Riggs was born and reared in the community where she died. She had been a member of the Black Jack Free Will Baptist Church for a number of years and was a regular communicant as long as her health permitted.

She was one of the most beloved ladies of the community, and news of her death was received with sorrow.

She is survived by two sons, J. W. and M. L. Riggs, who reside in Chicod Township; two daughters, Mrs. H. H. Proctor and Mrs. Herman Neal, of Greenville; a sister, Miss Bettie Elks; twenty-six grandchildren, two great-grandchildren, three nephews and two nieces.

SAYS TOBACCO CODE WILL AID EMPLOYMENT

Winston-Salem, July 6.—(AP)—The operation of the code for the loose-leaf tobacco and auction warehouse industry will mean increased employment and higher wages. Frank Davis, president of the National Warehouse Association, said here today.

The code, already signed by President Roosevelt, provides increased pay for all workers over their previous schedule, and unless this year's short crop hold back sales, employment in the industry is expected to increase, Davis said.

CHILD DEATH RATE IN PITT LEADS STATE

Startling Facts Laid Before Members of Kiwanis Club Here Last Night

Members of the Greenville Kiwanis Club, assembled in regular session at the Woman's Club last night, heard their president, Dr. R. S. McGeachy, declare that the child death rate in Pitt county exceeds any other county in the state.

Recent figures compiled by the North Carolina Health Department, Dr. McGeachy said, place the Pitt county death rate at 55.0 per cent as against the state average of 19.3 per cent.

Infant mortality was described by Dr. McGeachy as unusually alarming in view of the fact that over half of the deaths recorded were among babies. He said death was caused by common stomach complaints suffered by children.

After startling the club with the staggering death total, Dr. McGeachy called attention to recommendations for increasing the public health budget from about \$5,000 annually to around \$8,000. The budget has been cut each year until it is impossible for the limited number of health workers to cope with the situation, Dr. McGeachy said, and expressed belief that a full time sanitary inspector and extra nurse proposed from the increased budget appropriation would improve the situation materially.

The club unanimously endorsed the increased figure of the recommended budget and members will appear before the Board of County Commissioners at their regular meeting Monday and ask that the health department be given a chance of attempting to reduce the death toll.

NEW RIOTING BREAKS OUT IN HOLLAND

Six Killed in Disorders Among Unemployed Seeking Bigger Dole Payments.

Amsterdam, July 7.—(AP)—Rioting, thought to have been checked with the arrival of additional soldiers and police, broke out anew late today resulting in two more deaths and bringing the total to six for the day.

An undetermined number of persons suffered wounds. Authorities said the situation was grave.

Four men were killed this morning when police and troops cleared the disturbed areas, using tanks to flatten barricades.

The rioters are mostly several taken to a hospital earlier in the day but the condition of six was said to be hopeless.

JOE CARTER DIES TODAY

Heart Attack Claims Pioneer Tobacco Grower in Black Jack Community

Joe Carter, 68, pioneer tobacco grower of this county, died of a heart attack on his way to a doctor's office in Grimesland this morning at 10 o'clock.

Funeral services will be conducted Sunday afternoon at 4 o'clock from the Joss B. Hardee home near Black Jack, by Elder W. H. Laughinghouse and interment will be made in the family burying ground nearby.

Mr. Carter came to Pitt County from Transylvania County, Virginia, 35 years ago to cure tobacco for Jesse Hardee, near Black Jack. He liked the section so well that he decided to make his permanent home here.

He was one of the early instructors in the curing of bright leaf tobacco. The industry was at its infancy when Mr. Carter came to the Black Jack section to cure the leaf for Mr. Hardee, and as a result of his activity in behalf of expansion of the growing of the weed, became one of the best known figures throughout the county.

He was also active and manifested much interest in politics in his section as well as other parts of the country, and his influence played an important part in the life of the community.

He is survived by his daughter, Mrs. Pearl Faulkner of near Ormondsville, Greene County.

PARIS READY FOR TROUBLE

Rioting Is Expected Around Tomb Of Unknown Soldier in Celebration Sunday.

Paris, July 7.—(AP)—The cabinet today ordered mobilization of thousands of police for riot duty to prevent clashes tomorrow between patriotic groups around the tomb of the Unknown Soldier where thousands of members of the Croix de Feu "crosses of the fire" are to march tomorrow.

Scarred and limping from wounds of battle, these veterans annually march to Paris' world-famous memorial there to rekindle an eternal flame. This year the ceremony had been suddenly lifted to political significance with dangerous possibilities.

Troops and large numbers of reserves of mobile guards are to be held in barracks and hidden in courtyards for emergency.

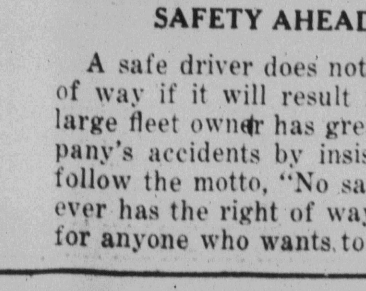
DURHAM YOUTH DIES, RESULT OF COLLISION

ORDERS ONE SIDE PARKING ON D. AVENUE

Mayor Complies With Request From Government For Change In Traffic

One side parking on Dickinson Avenue was ordered today by Mayor R. C. Flanagan in an effort to relieve congestion on what is generally considered the busiest street in the city, especially during tobacco season when thousands of vehicles from every direction for hundreds of miles, pass along the thoroughfare.

The action of the mayor followed a request from the government that all cities where improvements have been made with Federal funds take action to effect parking only on one side of streets whose width is 30 feet or under.

The mayor said Dickinson Avenue was the only street in the city to come under the regulations, and immediately issued orders to the street department to see that the government requirements are complied with.

The request was contained in a letter received today by the mayor from John Waldrop, State Highway Engineer, who set forth the government's wishes.

"The Bureau of Public Roads at Washington has requested that certain traffic regulations be instituted on streets in all municipalities where improvements have been made with Federal funds which have clear roadway with a width of thirty feet or under.

"The Bureau takes the position that streets with a width of thirty feet or under do not provide sufficient space for two lanes of traffic if parking is permitted on both sides.

"We find that the point brought out by the Bureau is well taken and urgently request that you arrange for the establishment of parking on one side of the street only, and we will thank you very much. Advise us if it is agreeable to comply with the request made by the Bureau."

HOT WEATHER STILL SWEEPS OVER NATION

No Let-Up Seen in Intensive Heat Reported in all Parts of Country.

(By The Associated Press) Summer continued its riotous course today over a nation which knew not what to expect next.

The East hoped for early relief from a heat wave which has smashed the sixteen-day record set in 1901, but warmer weather was again the forecast for the week-end over almost the entire country west of the Appalachians.

Cracking down on southern Michigan with winds and rain yesterday, the erratic season took seven lives in the metropolitan area and caused unestimated damage. Three persons lost their lives as boats were swamped, two were electrocuted by dangling wires, and two were struck by crashing trees.

Showers, some of them torrential, were general throughout the Middle West. Farmers rejoiced at the salvation of the crops despite damage from winds and hail.

U. S. SAILORS FIGHT FRENCH

Two U. S. Battleships Cancel Shore Leave Because of Rioting in Cafe.

Nice, France, July 7.—(AP)—Shore leave for sailors for the United States warships Arkansas and Wyoming was cancelled today because of a riotous evening ashore, resulting in the injury a twenty-eight men.

The two battleships had been scheduled to remain at Villefranches harbor until July 12, but it is likely they will leave earlier.

The condition of Joseph Kline, 22, a wireless operator aboard the Arkansas, was improved today, although surgeons have not yet been able to extract a bullet from his neck. He was shot by Leon Curpey, chief of the suet.

ROAD DEATH TOLL DROPS

Six Persons Killed in This Patrol District Last Month Against 9 in May

Highway fatalities in this highway patrol division showed a slight drop the past month, but the list of injured was higher, the monthly report of Lester Jones, patrol lieutenant, revealed today.

Six persons met death in various parts of the division in automobile mishaps, as compared with nine in the previous month, and 45 were injured as against 35 for May.

The patrol office also revealed the fact that July got off to a swift start in the race of the dead with two fatalities already having been recorded. One of them was Drury Settle, of Greenville, who was killed when the car in which he was riding crashed into a freight train at Marsden.

Drunk drivers, the report also revealed, are becoming bolder in this section with 32 arrested the past month. The total number of arrested reported by the department was 131. Of this number, 25 were found guilty.

The patrol issued 2,237 warnings to motorists in minor infractions of the law and saw that 1,957 lights were corrected.

Although no mention was made of it in the report, improperly focused lights are causing autoists no little trouble at this time. The danger of lights glaring in a driver's face cannot be stressed too strongly, and the number of corrections of this fault made by the patrol was received with interest by the thousands who frequent the roads from day to day.

POLITICS at random

By BRYON PRICE (Chief of Bureau, The Associated Press, Washington) Even with the President, Congress and the Supreme Court away, old and new aspects of the recovery program are keeping Washington stirring. Here are a few:

NRA: July and August are critical months. General Johnson, Senator Borah and others will be talking to "the little fellows" from varying viewpoints, and the returns will be laid before President Roosevelt, for his decision, when he comes home from Hawaii.

AAA: The whole tendency is to fortify and expand the crop control experiment. There is no sign of retreat; the main effort now is to ride down the opposition. Unless the situation changes radically, at least another year of the experiment seems certain in prospect.

FWA: Officials are convinced too many projects are being unduly delayed. Greater speed will be insisted on during the summer, culminating in a big push coincident with the normal seasonal business upturn this fall.

STOCK MARKET CONTROL: The personnel of the new control commission is so preponderantly liberal in its views that Washington expects some real regulation of Wall Street. It is agreed the President has chosen a commission with teeth.

Housing, Labor, Farm HOUSING PROGRAM: Important industrial interests are encouraged at the selection of James A. Moffett, an experienced business executive, as administrator.

LABOR BOARD: There is no conviction in Washington that this problem has been solved. The new board's operations will be experimental, an dthe lessons learned will provide a basis for further legislation next session.

Foreign Doctors Hit By Language Decree In China

Nanking—(AP)—Influx into China of German-Jewish physicians has become so marked that the nationalist government has limited the number of them admitted to practice.

The new decrees apply to all foreign medical men. Hereafter licenses will be issued only upon presentation of diplomas from medical schools and permits to practice in their own countries.

As the latter must be certified by the applicants' consulates here, the emigrants from Germany may find it difficult to meet this requirement.

Another high hurdle in the way of alien practitioners is a requirement that they must be able to speak and understand Chinese.

In explanation of these measures the government says that large cities like Shanghai, Tientsin and Canton overrun with physicians, both foreign and Chinese.

Washington Daybook

By HERBERT PLUMMER Washington, D. C.—(AP)—President Roosevelt's signature of the Frazier-Lemke bill—granting a moratorium on farm mortgages—upset the calculations of almost everyone in Washington.

Few believed the White House would give its approval. Even those who worked hardest to obtain passage of the bill in the closing hours of the Seventy-third Congress were none too optimistic.

Three things must be taken into consideration in any effort to understand why Congress passed the Frazier-Lemke bill.

In the first place, the administration was anxious to have Congress adjourn. Huey Long, of Louisiana, threatened to filibuster the bill was brought up for consideration.

"I would rather never see Congress adjourn if it had to sit here until Gabriel blows his horn," shouted Long, "than to see us go back to the farmers without giving them relief at this session."

Bill's Legality Doubted Because the administration knew the Louisiana "Kingfish" would do all in his power to make good his word, the way was paved for consideration of the bill.

Then, too, tremendous political pressure was brought to bear on members of Congress. The argument was made that Congress had come to the rescue of everyone but the farmer by similar legislation. Why should he be left out?

And third, there were serious

doubts in the minds of many as to whether the bill was constitutional. Undoubtedly there were votes cast in favor of the bill with this in mind. Many thought the President would throw it out on these grounds and even if he didn't the Supreme Court would.

This last still remains an important factor. Sooner or later a test case will be brought before the Supreme Court and a decision made.

Approval Eliminated Issue

While the President made no reference to it in his message announcing he had signed the bill, the rumor was current in Washington that he had submitted the legislation to the Department of Justice for a study of its constitutionality. It also was rumored the department was doubtful whether the bill could weather the test of the courts.

"Nevertheless," said the President, in announcing he had given his approval, "the reasons for signing it far outweigh the arguments on the other side."

From a political standpoint, many believed the President couldn't have done anything but sign the bill. His disapproval would have immediately made it an issue in the election—the battleground of future election campaigns.

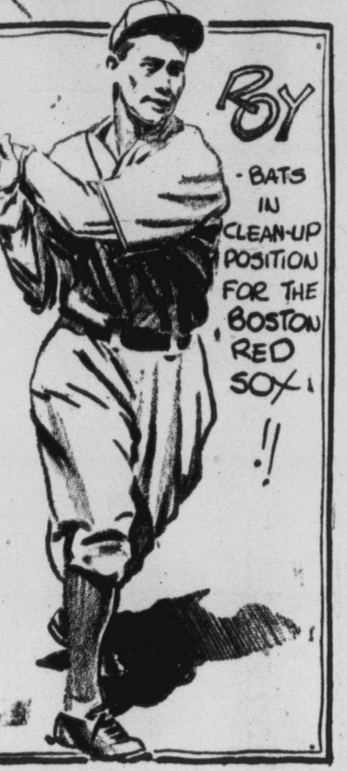

"Show Ears" Sets Vogue in Coiffures

Paris—(AP)—"Show your ears and forehead" is the rule for chic heads this summer.

Shorter hair is "in" again. Coiffures for young heads are swept gently back from the face and often curled close to the back of the head in a manner reminiscent of a shingling cap.

Ears are definitely in the picture. Though they may not show out fully, most of the smart coiffures leave in view at least the lower half, often ornamented with an earring.

Forehead can be seen, too. "Skinned back" effects are by no means smart, but semi-windswept effects, curled softly back from the forehead as though blown by the breeze, are "the thing." They sound a note of serenity in keeping with the oriental clothes, so much in vogue this summer.

Free and Easy' Curls
The newer closer coiffures are done in many ways. The favorite is one waved softly back from the forehead and cupped up in a series of crisp but "free and easy" little curls in the back. Another is brushed back from the forehead and curled high across the top somewhat like a panish headdress, while a third is parted on the side from forehead to the nape of the neck and curled in a high sculptured effect.

One smart Parisian, whose hair is gray but who has the figure of a debutante, has her hair tinted a soft mauve, swept back from her face and curled closely to her head like a cap. A chic blond brushes her hair back from the forehead and curls it around behind her ears.

Greek' Coiffures
A closely curled coiffure recalling the heads of Greek statues is new for evening wear. Antoine does them in big swirls casually placed all over the head and "glued" in place by a thinning lacquer. Even his coiffures for a summer daytime wear have the same sculptured effect. They are brushed back from the forehead with a series of flat curls on the side of the head.

Diadems and tiaras are less often worn in the evening than they were this winter. Though some Parisians favor a slender gold fillet, others prefer a gold or diamond studded arrow or wind poised on the side of the head. Many smart evening coiffures are unadorned.

Filling for Sugar Cookies

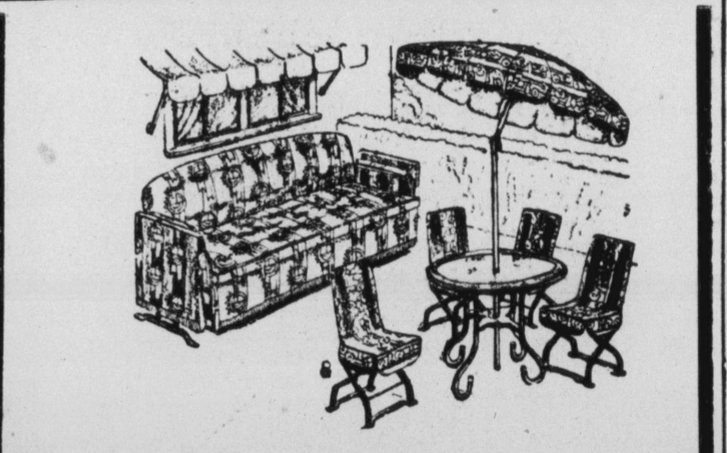
