Admiral Byrd Lost At South Pole

JOHN DILLINGER IS SHOT TO DEATH AT CHICAGO

Noted Explorer Is Missing From Little America

TRAIL TO HIS LONELY POST LOST IN SNOW
CHIEF FAILS TO 'GET' HIS MAN
Chief of Police George Clark, who has been keeping his eyes "peeled" for John Dillinger ever since the Indiana desperado hit the trail of blood and crime, returned last night from Morehead City where he spent last week "dipping in the surf" and hoping that Dillinger would show up as a member of the summer colony.
After he heard last night that the gangster had been shot to death in a little West Side theatre in Chicago, the chief packed his "valise" and hit the trail for Greenville to take care of the criminal element back home.
Chief Clark is one of the several thousand law enforcement officers who for the last several months have been hoping that Dillinger would come their way so they might send him back to Indiana in a casket and collect the tremendous sum offered for his capture, dead or alive.
Last night when the news was flashed over every telegraph and telephone line in the country that the most famous criminal since the day of Jesse James had been captured, Chief Clark saw his dreams of conquest go a-flickering, packed his kit and made a bee-line back home.
Speaking of his vacation over the telephone this morning, the police head said he had a delightful time on the North Carolina beach and never saw so many pretty girls in his life. Although fifty years of age and bald-headed as a watermelon, the chief still is able to take his mind off official business when necessary and likes the "girls"—particularly the bathing beauties—as well as anybody when they reach life's meridian and turn their faces toward the setting sun.
Little America, Antarctica, July 28. (AP)—Give concern for the safety of Rear Admiral Richard E. Byrd was felt today. The trail leading to his lonely weather observation outpost was lost.
A tractor party which set out Friday to bring him back to the main base reported it could not pick up the trail.
The group was fifty miles out on the 123-mile run. Orange flags with which the trail had been marked could not be found past that point, the relief party reported. Byrd followed the trail four months ago to take up his lonely sentinel duty.
Dr. Thomas C. Paulter, in charge of the group, said it had battled in bitter weather to reach the fifty miles Dr. Paulter reported zigzagging from 50 to 71 degrees below zero.
The expedition traveled 130 nautical miles to attain the 50 nautical mile station. Temperatures ranged from 50 to 71 degrees below zero. A nest of deep crevices lie ahead.

GEN. MITCHELL RAPS REPORT ON AVIATION

Retired Leader of Air Corps During World War Says Baker Report Puerile

Middleburg, Va., July 23.—(AP)—Brigadier-General William Mitchell, retired, denounced the Baker board report on aviation as "just another whitewash."
Such words as "puerile" and "disgraceful" studded Mitchell's comment on the report of the War Department's special aviation committee headed by Newton D. Baker, former Secretary of War, under whom Mitchell served as commander of the A. E. F. Air Corps.
The Baker report published today turned thumbs down a separate air force unifying Army and Navy ski fighters—an idea for which Mitchell conducted a spectacular fight before resigning from the Army in 1926. It also urged building up the Army Air Force to 2,300 planes to provide a defense second to none.
"This report is about what you could expect of a board with Army men who knowing nothing of and want to know nothing of aviation, Mitchell said.
"It's just a whitewash of former investigating boards. The Baker board just rewrote the old report."
"The United States is about fifteen years behind the world now in aviation and as long as the air force is saddled with Army generals who do not want to understand what airplanes can do in war, and aviation spectators hungering for profit, little can be done to improve our position."

DR. COMBS IS SPEAKER HERE

Delivers Sermon To Large Crowd on the Court House Lawn Last Evening

Dr. G. R. Combs, pastor of Jarvis Memorial Methodist Church, last night delivered the sermon at the fourth of the series of union services held at the courthouse during the summer months.
He was heard by a crowd representing virtually every denomination in the city and delivered an inspirational message.
The first two services were rained out—at least they could not be held on the lawn—but were carried to the courthouse where brief devotionals were held.
It was decided at the time that rainy night services in the future would be held in Memorial Baptist Church and the public was notified to govern itself accordingly.
The past two Sunday evenings, however, have been fair and hundreds of worshippers assembled on the lawn and enjoyed the impressive and inspirational program.
One of the features of the service last night was the singing by the choir of the Methodist Church. The program was marked by a solo by Mrs. John Karsnack. Congregational singing was also ably par, and those who could sign lifted their voices in praise along with those more experienced in the art of vocal expression.
The services are sponsored by the members of the Ministerial Association who urged that all those interested in the effort to bring all denominations together in one service during the summer months give their support to the cause.
Ample seating accommodations for several hundred had been provided on the lawn, and those desiring to listen to the special sermons and musical program prepared for each Sunday are urged to attend and take part.

Notorious Bank Robber Falls In Rain Of Bullets

TRAP SET FOR HIM BY POLICE ON WEST SIDE

Chicago, Ill., July 23.—(AP)—Dillinger's dead.
He swaggered from a neighborhood theater last night into the rain, late he saw the gleaming steel of the trap set for him.
His hand went on his gun. Too late. Three bullets tore into his body—one in the neck, two in the body. He staggered and fell.
It was the end of Dillinger. The hour was 11:40 p. m., Central Time.
The place was just outside the Biograph Theater, a neighborhood movie at Fullerton and Lincoln Avenues, in the territory where the blood of many a Chicago gangster has flowed before.
Had the climax of this bank-desperado killer's career been prearranged it could not have been any more sensational. There was even an audience loitering about the vicinity of the theater drawn by the presence of so many department of justice agents that for a time some believed a hold-up was planned.
Dillinger—his hair dyed a darker hue, tell-tale scars on his cheeks lifted by plastic surgery, gold-rimmed spectacles framing his shifty eyes, his nose straightened, a carefully formed black mustache adorning his leering lip and the whorls of his fingertips obliterated by acid—strode through the lobby and sauntered down the street.
He passed apparently without recognizing Melvin H. Purvis, chief of the Chicago Bureau of the Department of Justice. Purvis seated in a parked car moved his right arm in a casual signal. Several agents leaped forward, their pistols glinting in the garish light.
Suddenly the mask of insolence dropped from the phantom free booter's countenance. He darted into an alley reaching for a pistol for a duel to the death. As he did so a five-shot fusillade cut him down. Three of the bullets struck him. Two missed their mark and whizzed into the terrified throng gathered near the theater, striking the leg of two women spectators.
The infamous fugitive sprawled on the pavement in a double heap.
There was a tense silence, then the scores of horrified witnesses, the agents, two-score of Chicago detectives and five officers from East Chicago, Indiana, rushed forward.
A cordon was thrown about the body.
Automobilists and pedestrians, attracted by the furor, swarmed up by the hundreds. Burly policemen opened narrow avenues through the throng and the snarled traffic to get the injured to the nearest infirmaries.
The vehicle transporting the wounded Dillinger made for a hospital. He died without word or motion before medical aid could be administered at a street crossing en route to the hospital.

FORGER HELD UNDER BOND

Alleged 'Check Flasher' Released For Appearance Here Again Saturday

Marvin Hudson, alias Roy Stocks, 19-year-old young man of the Shermerside community, who was arrested Friday while allegedly attempting to pass a forged check at Greenville Banking and Trust Company, was released under bond in police court this morning with the understanding that he return next Saturday to undergo trial.
The trial was postponed on account of the prosecuting witness, W. L. Smith, farmer of the Shermerside community, being unable to attend.
Hudson, police said, gave the wrong name when taken into custody Friday, but admitted under examination that his real name was Marvin Hudson. He was said to have been a tenant on the Smith farm.
Walking into the bank Friday, Hudson went to the teller's window and attempted to pass what bank officials said was a check for \$20. It bore Mr. Smith's name.
Glancing at the check, the teller saw at once that the signature was not Mr. Smith's, and after comparing it with other checks in the bank, called up police and had the young man taken into custody.
Hudson was confined in the city jail to await hearing this morning, but when the prosecuting witness was unable to appear, the hearing was set for Saturday morning and the alleged forger released under bond of \$200.

Late News Flashes

Seek Higher Tobacco Prices.
Raleigh, July 23.—(AP)—Governor Ehringhaus today telegraphed Chester C. Davis, Agricultural Adjustment Administrator in Washington, urging that farmers be guaranteed a price for tobacco that will make the income from this year's curtailed crop at least equal to total returns from last year's crop.
The governor suggested to Davis that this year's parity price be set at not less than 22 cents a pound.
Representatives of the AAA and domestic tobacco buyers will confer in Washington tomorrow about a marketing agreement for this year's crop.
Last year the parity price was agreed upon after Gov. Ehringhaus called a tobacco holiday which was broadened to include South Carolina, was 17 cents.

Found Beaten To Death.
Rocky Mount, July 23.—(AP)—George E. Spruill, 59-year-old Rocky Mount grocerman, was found beaten to death in a store here today, apparently the victim of robbery.
The body of the elderly grocerman was found in front of his safe which was standing open. The head had been battered in with some heavy instrument, possibly an axe, police said.
A coroner's jury returned a verdict at the hands of parties unknown.
While officers were of the opinion that the safe had been robbed, they had no information as to what it had contained or what was secured by the robber or robbers.

SHOPLIFTER JAILED HERE

James Sawyer Jailed Saturday Night After Stealing Articles At Store

SHOP LIFTER James Sawyer, colored, alleged shoplifter, failed to get away with the "lifting" business at Grant's store Saturday night, and today was behind the bars.
Given preliminary hearing in city court this morning, he was bound over to the next term of county court.
Sawyer was spied by a clerk as the negro "snatched" some hosiery and other articles, and police took him into custody as he started out of the front door.
This is the first case of actual shoplifting here in several days although usually a number of such cases take place in the various stores.

Lumber Prices Are Reduced

Raleigh, N. C., July 23.—In order that home owners may take full advantage of the loans offered by the Home Owners' Loan Corporation for the renovation and modernization of homes, lumber dealers and manufacturers have agreed to reduce their prices drastically.
The agreement was reached between the Lumber Code Authority in Washington, the Southern Pine Association in New Orleans and the National Recovery Administration. Dealers in Raleigh have been notified of reductions of 50 cents a thousand feet for various types of lumber, effective July 20.
Reductions are to be made by the pine lumber industry all over the country.
The modernization program of the Home Owners' Loan Corporation will be functioning within ten days, the lumbermen have been notified.
It is expected that the program will aid materially in improving the lumber business. Northern buyers already are placing orders in anticipation of reconditioning and home-building programs.
The reconditioning division of the HOLC, which has a branch office here is prepared to take applications for loans for repairs or improvements of any kind.

J. A. HUDSON PASSES AWAY

Prominent Hudson's Cross Roads Man Succumbs to Long Illness Today

John Allen Hudson, 84, prominent resident of the Hudson's Cross Roads community, died at the home of his son, Louis Hudson, this afternoon at 1 o'clock. He had been in declining health for a number of years, but succumbed to a serious illness of only one week.
Although funeral arrangements had not been completed this afternoon, it was stated that final rites would be held probably tomorrow afternoon with burial taking place in the family burying ground near the home.
Mr. Hudson was one of the pioneer tobacco producers of the community in which he spent virtually all of his life. While not actively engaged in farming the last several years because of declining health, he continued to manifest much interest in agricultural development of the community and the county generally.

Much-feared Indiana Jail-breaker and Killer Felled By Federal Agents In Front of Biograph Theatre; Disguised, Dillinger Attempts To Pull His Gun But Is Shot to Death Before He Is Able to Do So; Identified by Department of Justice Chief

BOLD PRISONERS STILL AT LARGE

Philadelphia, Pa., July 23.—(AP)—Two of five desperate convicts who made a daring break from eastern penitentiary through a half-mile of rat-infested sewer remained at large today despite an intensive police search throughout the city.
Screened by a crowd of fellow-convicts from the eyes of guards, the men during exercise period in the prison yard yesterday broke open a padlock on a large iron door covering the top of a sewer running through the penitentiary grounds.
They dropped twenty-five feet into the swirling, dirty waters of the sewer. Sometimes they were able to touch bottom and struggle along. At other times they swam through the thick stream of muck. Their bodies were bruised and cut as they were shot against walls at bends by the fast current.
One of the men finally grasped an iron ladder dangling from a manhole. Holding on with one hand, he grabbed the other four as they came along downstream.

FARM FIRES CAUSE LOSS

Garage Destroyed When Hit by Lightning; Tobacco Barn Goes up in Flames

Fire over the week-end destroyed a garage in the Red Oak community and a tobacco barn on the farm of Frank Wilson, near the city, entailing loss estimated at \$2,000.
When lightning struck the garage on the farm of N. W. Tyson at Red Oak last night the building was destroyed by fire along with six bales of cotton. Mr. Tyson estimated his loss in the process of curing were devalued for \$300.
When a tenant on the Wilson farm left his tobacco to go to his house a short distance away, he saw the building burst into flames and the barn and entire amount of tobacco into the process of curing were destroyed. Mr. Wilson said this morning his loss was approximately \$500 and was not covered by insurance.
The fire was believed to have been caused by running the heat too high, resulting in a bursted fuse. The dry tobacco immediately caught fire and was destroyed within a few minutes along with the barn.
A couple from New York recently arrived in the Ozark Mountains in an old-time covered wagon after traveling about 1,300 miles.

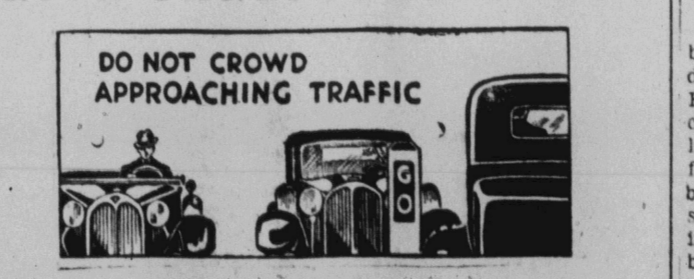
APPROVES BILLION IN NEW SECURITIES

Washington, D. C., July 23.—(AP)—Nearly a billion dollars in securities issues were found eligible for sale by the Trade Commission in the year ended June 30, 1934.
There were 713 issues, valued at \$962,856,438.
Three hundred and eleven issues were industrials amounting to \$225,285,592.
Financial issues numbered 186, and were valued at \$609,028,666.
Other issues totalled 216, valued at \$128,542,179.
The commission gave no interpretation of the statistics.

The marriage may take place at Conneaut Lake, Pa., this week, Violet said today, or it may be postponed a week.

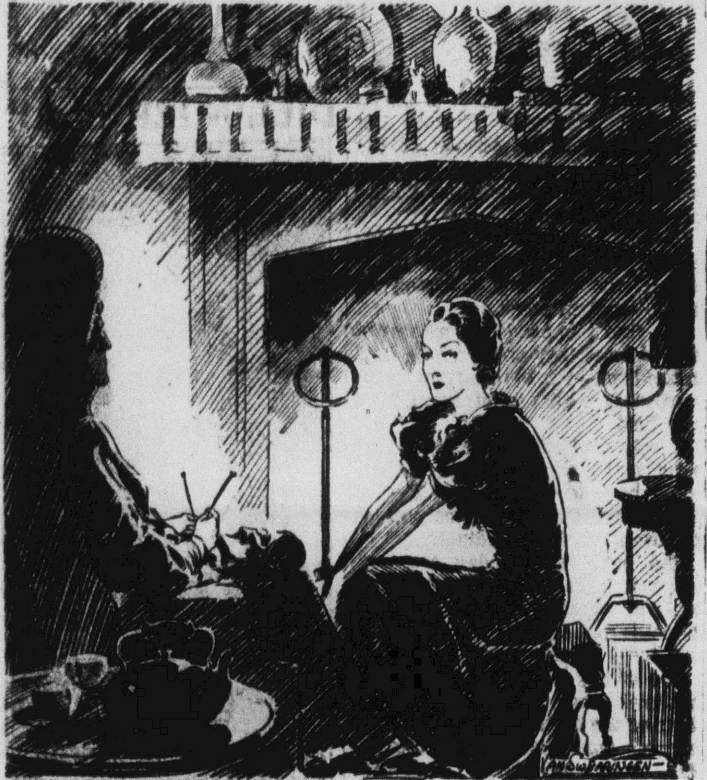

IT SHOULD GO

The investigation into the election irregularities in Carteret county revealed that in one instance 50 absentee ballots were delivered to one applicant without receipt or record and no doubt they were voted as the applicant or his associates saw fit. This is just one incident of the abuse of the absentee voting provision of our election laws. There is probably not a county in the state in which there have not been irregularities in the voting of absentee ballots and as we have stated in this column before, the next legislature would do well to repeal this section of the election laws.

Of course there will be objection on the part of the politicians to making this change and they will talk long and loud about depriving a citizen of his or her right to vote because it is necessary for them to be absent from the polls on election day but as we see it, it is better to deprive a few people of their privilege of voting than to permit a form of voting that leaves room for crooked business and the casting of a large number of illegal votes to every one legitimate absentee vote.

The legislature should put the skids under absentee voting and those who have been profiting by the manipulation of these votes.

RECENT BOND SALES

(Winston-Salem Journal)

Advocates of the present tax system in North Carolina boast that as a result of it the State is able to sell its bonds at the low interest rate of 3.75 per cent.

But on June 29, according to The New York Times, the State of New York sold \$30,000,000 worth of bonds at an interest rate of 1.83 per cent. The issue was bid for by small groups. It was the lowest interest rate at which New York bonds were ever sold. They were sold at a premium, bringing 100.911. It will be observed that the interest rate was less than one-half of that at which North Carolina recently sold its bonds.

A few days ago we made reference to a recent bond sale by the State of Missouri which sold \$5,000,000 worth of bonds at an interest rate of 3 per cent, and at a premium, the bonds being sold for 101.169. It was the lowest rate in the history of the state.

On June 28 the city of Boston sold \$3,000,000 of bonds, bearing interest of 1.32 per cent. On the same date, Sioux City, Iowa, sold \$467,500 of bonds, carrying interest rate of 3 and 3/4 per cent.

At about the same time the city of Cambridge, Mass., sold \$200,000 of bonds at 2-1/2 per cent.

Apparently something besides a sales tax is affecting the interest rate on bonds. New York did have a sales tax but repealed it sometime ago.

ONE-FAMILY HOUSES LEAD IN DELINQUENCY

Washington, July 23.—(AP)—An analysis of tax delinquency in Greensboro, N. C., one of the cities selected throughout the United States for such surveys, revealed one family house to be responsible for the major part of unpaid taxes, the Census Bureau reported today.

Single family dwellings led all other classes of real property in the amount of unpaid taxes in the North Carolina city among parcels analyzed for the tax year beginning April 1, 1932, the report, released by Director William L. Austin showed.

Stores were in second place, owning 24.3 per cent of the total amount of delinquency. One family houses

and stores combined were responsible for 64.7 per cent of the total amount of \$223,957 shown delinquent on 1,132 properties of the 3,470 total parcels analyzed in Greensboro.

New Books

Harold Nicholson has written three books on diplomacy, the latest being "Curzon; The Last Phase, 1919-25." One of "Curzon's" predecessors had to do with Lord Carnock, and the other with the Paris Peace Conference.

The book is extremely curious. Mr. Nicholson knows a great deal about diplomacy, it is evident. He also knows a great deal about Lord Curzon. But somehow Lord Curzon (who was, as the rhyme goes, a "very superior person") doesn't seem quite the peg to hang the book on. For it is evident that although Curzon offers Mr. Nicholson hundreds of opportunities to make clever remarks, all of which are taken advantage of, the author really doesn't respect his lordship too much. And on the other hand it is equally evident that the book could have been written without more than cursory mention of Curzon, who once in a while seems dragged into the picture rather summarily.

Nevertheless, as reading, the book is fascinating. One may not agree with the author, nor quite see what it's all about, but one can be sure Mr. Nicholson knows how to be amusing. Many authors don't.

Thumbnail Reviews
"A Conquest of Tibet," by Sven Hedin (Dutton): The doughty explorer goes back into his past and assembles what he knows about Tibet, draws pictures of everything, and then publishes the book by luck just at the time he has an encounter with bandits in faraway Tukeystan; and Dr. Hedin knows a lot about Tibet.

"Four Generations," by Naomi Jacob (Macmillan): The absorbing story of an international Jewish family interested in antiques and life.

"Design For a Staircase," by Guy Poccock (Dutton): A clever novel about what happened to the people living on the same staircase of a London flat when a fire threw them all together for the first time.

"Amusement Park," by Roger Garis (Appleton-Century): More or less the same things that usually happen in middleweight novels happen in this, excepting that the background is quite fresh.

"Via Panama," by Margaret Jepson (Harpers): One of those novels set on ships, in which some quite curious people do some quite curious things en route from dear old England to New Zealand.

In Memphis
"Beale Street," by George Washington Lee (Ballou): A sometimes rather madly written book packed with obviously authentic "dope" on the street from which the "blues" hail; the blues are one chapter only of Beale Street's history.

"Night Shift," by Richard Blaker (Appleton-Century): A love tangle against the background of a big garage, in which the leading charac-

ter is the night foreman, and in which there also is a very beautiful lady.

"A Storm Is Rising," by George Dyer (Houghton Mifflin): An extremely ingenious mystery-adventure tale in which the technique of insurrection is employed with cleverness, and the writing is considerably above average.

"London Bridge Is Falling," by Philip Lindsay (Little Brown): Mr. Lindsay uses the old London Bridge, upon which odd people once lived, and Cade's Rebellion as means to lay before us the color of fifteen century London; much more than "summer reading."

League To Study Calendar Change At 1935 Meeting

New York.—(AP)—Two widely advocated plans for calendar reform will hold the attention of the 1935 session of the commission on communications and transit of the League of Nations in Geneva.

They are the 13-month and the 12-month-equal-quarter devices forwarded to replace the present calendar which dates to 46 B. C. when Julius Caesar substituted the solar calendar for the lunar calendar.

West opened the king of spades, which was permitted to hold the trick. West led the king of clubs, which also won. Noting that the declarer was trying for a Bath coup, a lead up to an ace-jack, West sought to put East in for a spade lead and tried a heart. The queen in dummy took the trick.

A low diamond was led from the North hand, and East played the ten spot in order to make the queen. South took the trick with the king and led the nine. In with the queen, East of course, led a spade, and South came up with the ace.

Now all depended on West's length in spades. A diamond was led from the South hand, and three diamond tricks were run from the North hand. The diamonds forced a total of four discards from West. With one diamond left to play from the North hand, West held the spade queen, the king-nine of hearts and the queen-nine of clubs. South had the spade jack, the ace-ten of hearts and the ace jack of clubs.

On the lead of the last diamond from North the spade jack went by the board South. West was in a quandry, but let go a heart. South took three tricks with the ace-jack of hearts and the ace of clubs, then gave up a club at the end.

West and East made two club tricks, one spade and one diamond. Had West shed his last spade on the last diamond South would have taken a trick with the ace of hearts and then led the jack to West's king, so that West would have to lead from the queen of clubs into the ace-jack.

From the World Over
Inspection of the Wisconsin Tercentenary 3-cent violet leads many collectors to place it in the classification of ideal stamp art. They say it rivals in execution any of the stamps of previous United States issues, or the world for that matter. Detail, they claim, is excellent and shading is superb. This issue escaped anything like the flood of criticism that followed the recent Mother's Day 3-center.

Collectors also are having their first glance at the new National Parks issue, which starts with the 1-cent and goes up to the 10-cent, paralleling the Washington bi-centennial issue.

A special issue has been announced by Italy to commemorate the international electro-radio-biology congress to be held in Venice, beginning September 10. The stamps will picture Dr. Luigi Galvani, Italian pioneer in electrical research.

Yugoslav Sokol
Translation of the inscription on three of the newest semi-postal stamps of Yugoslavia reads: "Kingdom of Yugoslavia, Congress of the Sokols, Sarajevo." This set of three was issued in conjunction with another group of three stamps for the city of Zagreb, both being commemorative of the 1934 sokol congress, an athletic contest of the Slavic peoples.

The Sarajevo stamps also bear the dates, 1914-1934, without notation. While 1914 was the year in which Archduke Ferdinand of Austria was assassinated on his visit to Sarajevo, just before the World War, there is nothing thereon to indicate that the use of the date is significant of that event. However, students of the history of this section of the world express the belief that 1914 was placed on the stamps to point out that, while in 1914 the Sokols were held in territory under Austro-Hungarian domination, today they take place with the south Slavic groups (Yugoslavia).

A reunited people. Another significance of the date is that the assassination in 1914, which led to the World War, also resulted in the establishment of the independent kingdom of Yugoslavia.

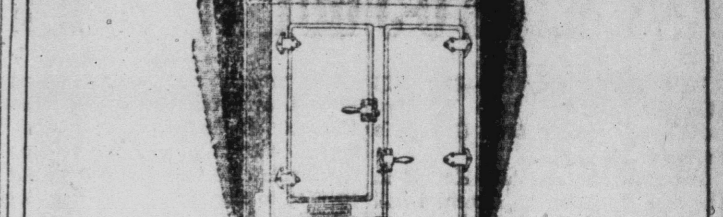

'BUGS' SEEK TO PUT OUT GUY FLETCHER

The pennant race in the Coastal Plain League will be changed considerably if league directors decide to sustain a protest of the Greenville club that Kinston is not entitled to any of the nine victories scored while Guy Fletcher, University of North Carolina athlete, was pitching for the Lenoir club.

The Greenville club has filed a formal protest, charging that Fletcher participated in professional baseball early in the 1933 season as a member of the Winston-Salem club of the Piedmont League.

Under league rules, each club is entitled to one player who has engaged in professional ball within the past three years but he can not pitch. Kinston's pro is Manager Bunn Horn, who also is baseball coach at Carolina. Fletcher pitched for the freshman team at the Hill last spring.

The Greenville club's contention is that Fletcher is ineligible to pitch in the league and that therefore the games he pitched and won should be forfeited to the teams defeated. Kinston is now leading the league.

One meeting of the league directors on the runner-up Ayden club.

One meeting of the league directors has already been held in consideration of the protest. The meeting was held Friday night but directors decided to hold another meeting on Tuesday evening, the postponement being decided on in order to give the Kinston club opportunity to present any data it might be able to produce to prove the protest unfounded.

From Kinston there came yesterday a report that the charge against Fletcher was that he had pitched for Winston-Salem in an exhibition game against the House of David team. From other sources it was indicated that Greenville's contention was that he had pitched part of one game in the Piedmont League in April of last year. The Kinston report said that Fletcher was not under contract to the Twins.

The Greenville protest not only involves games won by Kinston with Fletcher on the mound but threatens the college baseball career of the young right-hander from East Bend. If the Greenville club submits data to support the contention that he pitched in organized ball, the youngster's days as college athlete will be over.

The dispatch of last night from Kinston concluded with this paragraph: "Heads of the local club said they could not recall when a Kinston club in organized or semi-pro ball 'protested anything.' They appealed to the other clubs in the league to sustain them in the contention that young Fletcher is not a professional." (News & Observer)

To Make War On Gangsters.
Chicago, July 23.—(AP)—A vigorous drive to exterminate all the hoodlum henchmen of John Dillinger was launched by the government today as Chicago police and federal agents issued conflicting statements on whether the public arch enemy was lured to his death by a woman in a red dress.

Chicago officialdom took the stand that a girl had figured in the dramatic case that ended in the slaying of the phantom fugitive, but Melvin Pervis, chief of the Chicago bureau of the investigating branch of the Department of Justice, denied that a "finger woman" had led the notorious outlaw into the fusillade of slugs that cut him down last night.

Father Goes For Dillinger's Body.
Mooreville, Ind., July 23.—(AP)—John Dillinger, Sr., left today for Chicago to claim the body of his slain son.

Although ill from indigestion and sick at heart, the father insisted on riding in an undertaker's ambulance which he engaged to bring back his son's body.

Before departing the father made tentative arrangements for holding funeral services Wednesday at the Maywood home of Mrs. Aubrey Hancock, John's sister, who cared for him many years after the death of his mother.

Two British Firemen Killed.
Toronto, July 23.—(AP)—Two British firemen were believed dead and four more were believed trapped in the hold of the oil barge Norca, blazing furiously this afternoon on Ash Bridge's Bay in the Cities Oil Refinery district.

Heat Deaths Reach 275.
(By Associated Press)
While the heat wave gripping the country brought the toll of the dead to higher levels today the northeastern states were given a welcome respite.

The temperature in New York City was only 75 at noon compared to 83 at the same time yesterday. Pennsylvania and the New England States reported generally more moderate temperatures.

The death list now stands at approximately 275 with the heaviest casualties being reported from the center of the Mississippi Valley.

A survey of drought damage from the Mississippi Valley to the Rocky Mountains showed thousands of cattle lost, thousands more driven up at forced sales and crop losses placed at hundreds of millions of dollars.

More than 8,200 homesteads were filed in California during the last fiscal year, leaving 9,298,275 acres of public lands available for entry.

DIES OF INJURIES FROM AUTO WRECK

Wilson, N. C., July 23.—Waylan Williams, 28, of Simms, died here at a local hospital late this afternoon from injuries received from an automobile accident early this morning. Williams and another man were driving along the highway in the direction of Wilson at a fast pace when the car they were in struck a telephone pole and was catapulted seventy-five yards further along the road into another pole. Both telephone poles were knocked over and the car completely demolished. Williams' legs were torn from his body and his companion received serious injuries also. Williams was brought directly to Wilson to a hospital by a passing motorist, but the other man was taken into custody and sent to Nashville jail. It has not been learned whether charges will be preferred against Williams' companion.

The car in which the two were driving was a borrowed car, the owner's name has not been learned. Williams is the son of N. K. Williams who was murdered by Becker Watson, a negro, near the same spot where the accident occurred last Sunday.
