

RECORD HEAT WAVE STILL GRIPS MID-CONTINENT

Record-Smashing Prices Being Paid For Tobacco

BORDER MARTS JOYFUL OVER GOOD SALES

Prices Described as Hundred Per Cent Higher in Some Places; Average Yesterday Around \$23 Against \$12 For Last Year; Both Planters and Business Men Happy

(By The Associated Press) Record-breaking prices for tobacco—in some places the highest in history—today spread a blanket of comfort and well-being throughout the Carolinas.

Light opening day breaks, consisting as usual of the poorer grades which the farmers always like to test the buyers with before offering the cream of the crop, brought joy to business men and grower alike as hundreds of thousands of dollars poured in above last year's figure.

Where top averages at the various markets last year ranged about \$12 and \$13 per hundred pounds, the average yesterday was about \$23, judging from unofficial figures from thirteen of the sixteen markets in the South Carolina and North Carolina border belt.

Many received less. Many received more, but throughout the belt prices ranged approximately 200 per cent higher for the various grades than in 1933. Some lots sold for \$67 a hundred, some for only \$5, but nowhere was there any dissatisfaction.

The farmers' unofficial figures indicated, too, that they received about \$800,000 from the buyers for about 3,000,000 pounds of weed, and fair weather following recent rains was expected to bring larger breaks as the season wore on.

LEAF PRICES MUCH HIGHER

Fairmont Reports Prices Seventy-Five Per Cent Higher Than Last Year

K. W. Cobb, supervisor of sales of the local tobacco market, who attended the opening of border belt markets, yesterday, received a telegram this morning from I. A. Barnes, supervisor of sales at Fairmont, saying that prices on that market yesterday were "seventy-five per cent higher than last season."

The figure was some lower than previous reports from some of the other markets which said that prices apparently were double those of last year.

The statement was received with interest by thousands of people in this community who are looking forward to the opening of this great bright leaf tobacco belt August 23 with eager anticipation.

The official average on the Fairmont market was given by Mr. Barnes as \$21.68 per hundred pounds and was established on the sale of 494,214 pounds of fair weed quality which sold a total of \$107,138.28.

Numbers of tobacconists of this city attended the South Carolina and North Carolina "border" opening and returned home highly pleased with demand for the weed and the good prices prevailing on the opening day.

With prices high both in Georgia and on the border it is expected the situation here will be the most favorable in years when the market swings open on the 23rd.

Farmers have housed the major portion of their crop in this county, and today were turning their eyes expectantly toward the opening day when they hope receipts from their leaf will enable them to gain get just about straight with the world and provide their families with some of the necessities of life, which have been missing in recent years.

MILL WORKERS OUT ON STRIKE AT GASTONIA

Three Hundred Silk Mill Employees Involved by Strike Over Wage Cut

Gastonia, Aug. 10.—(AP)—Katterman-Mitchell silk mill employees at Stanley, near here, struck today, protesting a "threatened wage cut." Strikers said approximately 300 workers were idle and that the action came after G. H. Harker, manager, posted notices last week that the plant would be closed unless wage cuts were taken.

A few operatives had been working each day in some Government mills this morning when the few arrived the mill was strongly picketed. The small group of workers was forbidden admittance to the plant. Average wages have been \$17 to \$18, workers said. It was added that the suggested wage cut was to be about 15 per cent. No trouble at the mill, due to a chain owned by a Passaic, N. J. firm, had been experienced and none was expected.

Family of Six Injured in Wreck

Fayetteville, N. C., Aug. 10.—(AP)—A. M. Maness, furniture dealer of Tabernacle Road, Greensboro, and five members of his family, were injured this morning shortly before 7 o'clock when their automobile driven by Mr. Maness failed to take a sharp turn in the approach of a bridge over Little River at Manchester and crashed against the heavily timbered approach.

Mr. Maness and two of his daughters were the most seriously hurt. One daughter was unconscious and her condition was considered critical at the Fayetteville hospital where all of the injured were rushed. The party was en route to Carolina Beach.

SILVER PLAN RAISES HUGE SUM MONEY

Greater Fund Could Be Realized From Using Ratio Provided by Congress

Washington, D. C., Aug. 10.—(AP)—The amount of additional money which could be created as a result of silver nationalization could reach as high as a hundred million dollars.

Silver has not been monetized on any such ratio, and it is not believed a 16 to 1 ratio is likely.

Sixteen to one would be well over \$200 an ounce as compared with the declared 50.1 cents.

The policy also is still far short of that suggested by Congress in legislating a policy for one-fourth silver in the government metal money supply.

The value of the gold now held is about \$7,800,000,000 at \$25 an ounce.

Total holdings of silver are not known, but it is variously estimated that as much as a billion ounces would now be needed to bring the quantity to congressional ratio.

That would mean an expenditure of \$500,000,000 in new silver certificates. Such purchases are not likely. Estimates of silver available indicate there may be 200,000,000 ounces which would cost the government \$100,000,000.

Silver certificates would be issued to that amount and might be issued to more than two as much under the law empowering the government to value its silver at \$12.29 an ounce. That would mean new certificates for about a quarter of a billion dollars.

POOL DRAWS BIG CROWDS

Thousand Two Hundred Persons Take Cooling Plunge The Last Two Days

Greenville people are certainly taking advantage of the municipal swimming pool which opened two days ago, figures for the two days of operation indicated today.

Two hundred and twenty-seven children entered the pool Wednesday, opening day, and two hundred and eighty-one adults. Thursday was even a better day as three hundred and seventy-eight children and three hundred and forty-one grown-ups took cooling plunges, making a total for the two days of 1,220.

Revisions of the hour schedule was announced today by Manager Eric Tucker to meet the demands of swimmers throughout the day.

The pool will be open from six to seven o'clock in the morning to afford an opportunity to swimmers who have to be on the job at an early hour. The schedule for the remainder of the day is from 9 to 12 a. m., 2 to 6 p. m., and from 7 to 11 p. m. The new schedule becomes effective tomorrow morning.

Tucker also announced the beginning of life saving classes Monday at 9 a. m., and persons interested in taking the courses have been requested to apply at the pool.

The pool has attracted hundreds of people both night and day since the christening Wednesday afternoon and hundreds are expected to be on hand each day the remainder of the summer.

Adequate life saving facilities have been provided to throw a safeguard about swimmers at all times and small children may paddle about in the wading pool with utmost safety.

Tobacco Prices Continue Good. (By The Associated Press) Opening day's good prices on the South Carolina and border belt markets were repeated today, with the average standing around 21 cents a pound, despite a preponderance of poor quality.

Deliveries to the market were light as usual on Friday, the last sales day of the week. General satisfaction on the part of growers was evident, many markets reporting there had been no bids rejected since sales started.

Official sales figures from most of the markets showed little deviation from the estimate of prices. Sales for Lumberton for Thursday were 466,622 at an average of \$23.09 per hundred.

Sales Thursday at Timmonsville were 270,690 pounds, averaging \$20.00 per hundred.

Deliveries on the Lumberton market today were estimated at 200,000 pounds, and about the same on the Timmonsville market.

BOARD TO PASS PITT BUDGET

County Commissioners Also Scheduled To Fix Tax Rate at Meeting Tonight

The Board of County Commissioners were scheduled to meet tonight in special session to put their final okay on the budget and set the tax rate for the present year.

The commissioners met the first Monday this month to pass on this business, but decided to wait until tonight to give them more time to consider certain phases of the budget.

There is every indication the tax rate will be increased from \$3 to \$5 cents this year because of increased appropriations for some departments and valuations of about the same at last year.

The commissioners will also be called upon to pass on the health budget calling for a slight increase of appropriations to take care of what has been described as "menacing sanitary conditions in many parts of the county. The health department is seeking an appropriation of \$8,500 compared with \$5,000 for the previous year.

Health officials said that the increased sum would provide a sanitary inspector and additional nurse, enabling the department to give more attention to general health conditions throughout the county, especially as it pertains to the death rate among children. Infant mortality in this county has been described as the greatest in the State, and immediate action has been urged by members of the medical profession.

HITLER FACES OPPOSITION FROM CLERGY

Ministers of Germany Refuse to Swear Fidelity to German Chancellor

Berlin, Aug. 10.—(AP)—Clergymen are rebelling against swearing fidelity to Chancellor Hitler declaring the German ruler seeks to place himself above God and the Church.

A law requiring churches to take oath of fidelity and obedience to Hitler is one of the several enacted yesterday by the National Synod. It is part of the Nazi program of a unified Protestant Church. Representatives of the Bavarian Wuertemberg and Hanover State churches protested passage of the law.

Many of them said flatly today they would not take the oath. Some 800 clergymen are already under suspension for opposition to the Chancellor and his church lieutenant, Reichsbishop Ludwig Mueller. Those who refused to take the oath faced the same fate. Mueller has absolute authority in church matters.

PREPARE NEW PARKING RULE

One Side Parking to Become Effective on Dickinson Avenue in Near Future

The final marking of Dickinson Avenue for the inauguration of one-side parking regulations was in progress today and was expected to be completed in ample time to take care of traffic conditions when the tobacco market opens.

The government recently requested the city to pass one-side parking regulations on all streets 30 feet wide which had been improved with government funds. Dickinson Avenue was said to be the only street affected.

Chief of Police George Clark, who is in charge of street operations, said today one-side parking would be effective from the Norfolk Southern station to Five Points, but that the remainder of the street would be open to two-side parking beyond the designated points.

Dickinson Avenue, running directly through the heart of the tobacco district, is probably the most congested thoroughfare in the city during tobacco season and stringent regulations are required to deal with the traffic situation.

BOARD DEFERS SELECTION OF HEALTH HEAD

Committee Named to Select Temporary Successor to Dr. R. S. McGeachy

The Board of Health met in the Department of Education at the court house yesterday afternoon, received the resignation of Dr. R. S. McGeachy, director of the Pitt County Health Department with regret, and named a committee of three to select a successor until a permanent health officer could be chosen.

Dr. McGeachy presented his resignation in person and the board immediately adopted resolutions expressing regret over the action and appreciation of the splendid service rendered by Dr. McGeachy during his four years of service with the department.

The resignation will become effective August 21, when Dr. McGeachy is scheduled to report for work with the Halifax County Department of Health, and the temporary officer will take over duties here at that time.

The committee named to select the new health director is composed of Drs. W. I. Wooten, Paul Fitzgerald and M. T. Frizzelle.

The board also recommended a tentative budget carrying increased appropriations for the department with a view to increasing facilities of the health department. This provides for an all-time sanitary inspector to cooperate with the city of Greenville as well as other towns of the county, and an additional nurse. It was understood the budget seeks \$8,500 compared with \$5,000 for the previous year.

Dr. McGeachy sometime ago explained to the board the necessity for increasing facilities of the department because of the gradual increase in infant mortality. Pitt county infant mortality was described as the greatest in the State.

The budget will receive final consideration of the Board of County Commissioners which will meet in special session at the courthouse tonight.

INDICATIONS EARLY RELIEF NOT IN SIGHT

Temperatures Skyrocket Beyond The Century Mark in Many Localities; Fifteen Deaths Reported in Texas; Nebraska Counts Seven Dead; Crops Seared By Scorching Winds And Heat

(By The Associated Press) The heat wave held tenaciously today with a steadily mounting toll of victims.

Thirty-six persons are known to have perished during the last few days as result of the record-breaking temperatures that have baked the mid-continent with no immediate general relief in sight. A crop wave reported sweeping down on the stricken area from the far northwest failed to appear yesterday and temperatures skyrocketed far beyond the century mark at a number of places. Several persons were prostrated.

Texas had fifteen deaths, Nebraska counted seven dead since last Saturday, and although scattered rainfall was reported little was left of the rain in pastures and where crops were seared by wind and scorching heat.

It was 103 at Lincoln, the State capital yesterday, the fifth day in which 101 was exceeded the past week.

Attendance was described as among the best of the year with two visitors, Dr. Garrenton and Burroughs, of Bethel, being guests of the organization.

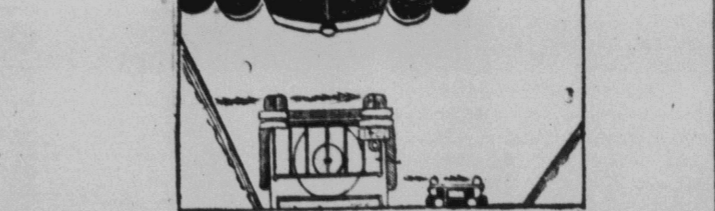
Dr. Tom Watson, baby specialist, read a paper on "Scurvy" and an interesting case report was made by Dr. Jenness Morrill.

## MORE ABSENTEE BALLOT CROOKEDNESS

In past elections in North Carolina the absentee voting privilege has been probably the most violated and abused phase of the election laws until there is rightly a growing demand among the citizens of this state for repeal of this part of the election laws.

Now comes word from Texas of trouble in that state as a result of absentee voting which is another evidence that to control such a form of voting is almost an impossibility, hence the absentee voting should be abolished.

Commenting on the situation the News and Observer says:

At least North Carolina has no monopoly on the evils which accompany absentee balloting.

Some election contests have developed and others are brewing as the result of alleged abuse of the privilege in Texas.

One group of unsuccessful candidates in Hidalgo county claimed 2,500 absentee ballots were counted despite the certification of only 1,800 by the county clerk.

But if evidence brought before a court of inquiry conducted by a justice of the peace in the county is to be credited, Texas has stepped a long way out front in the development of original election devices.

Says the San Antonio Express:

"Juan Cavazos, a deputy sheriff, testified he was at the Cipres voting box Saturday afternoon. An airplane flew over the house where the box was located and dropped a note telling the election judge to pick up some absentee ballots that would be dropped. Cavazos testified the note was signed by O. V. Bridges, chief county clerk and one of two high candidates in the race for county judge of Hidalgo county. The plane dropped a package containing five absentee ballots a few moments later, Cavazos testified.

"Quirino Reyes, an absentee voter testified he was an American citizen and voted on affidavit, but Border Patrolman Ernest Kilborn testified government records showed Reyes to be a Mexican citizen.

"E. F. Blackburn testified 89 absentee votes were counted in the West Edinburg returns where he was an election official. A list of absentee votes furnished newspaper men by County Clerk F. W. Lemburg two days before the election showed only 59 absentee ballots for that box."

And so the testimony went. Whether in Texas or North Carolina, the way toward the integrity of the ballot is through the careful pruning away of all those informalities which beset abuse.

There may be some means of protecting the absentee ballot from improprieties and irregularities, but the sure method has not yet been proposed.

## POLITICS at random

The daily reports of strikes and strike settlements, of violence, martial law, mediation and court action, tell only half the story of the present industrial struggle.

It must occur to any discerning newspaper reader that such an epidemic of labor troubles probably has some special central cause, that things like that do not "just happen." What is the special cause?

standing dislike for the standard union, promoted the organization of "company unions." How far such unions could be controlled by the employer is a matter of dispute; but at any rate, they were not unions under the control of the A. F. of I.

Then the trouble began.

**Company Unions**  
In many cases, the question was raised: "Who shall speak for the employees in the collective bargaining mentioned in Section 7A?" Surprisingly large was the number of industries where the company and standard unions claimed to represent a majority of the workers. And the difficulties of determining which was correct were many.

negotiations with the employers, each union should be represented in proportion to the number of votes it received.

That would have been a tremendous step toward solution, if it had worked for all industry. But it did not.

In later strike situations, standard unions have held out against proportional representation on the ground that it gave a voice to company unions which, it was contended, were entitled to none because they represented the employer, not the employee.

"Since the administration has not yet secured for workers their legal right to organize," said the July business survey of the A. F. of L., "strikes have become necessary in very many localities to enforce the recovery act."

So there you are, from the standpoint of those who are conducting the strikes. On this issue—a vital one—the new labor board has not yet taken a stand. It must sooner or later.

"You see Olin and Rosenbloom have been campaigning hereabouts. **Horse Racing On Coast**

"The Californians certainly are planning to give the South's winter racing circuit something to think about this coming season in the matter of bidding for the services of the best thoroughbreds, with three tracks promising well over \$200,000 in stakes money.

"Bill Kyne open up in October at San Mateo, near San Francisco, with a new track which will spring the barrier on the first real season of racing in California in several decades, thanks to the legalized betting law passed a year ago.

"Immediately thereafter the Los Angeles Jockey Club stages its inaugural Christmas Day and runs for 56 days with the \$50,000 Santa Anita handicap the top prize.

"When it closes down, Agua Caliente in Baja California plans to open with a shorter season than ever before, but with such high spots on the program as the Agua Caliente handicap and derby.

**More California Champs?**

"Racing at Tanforan, near San Francisco, never created much of a stir, since few of the big stables sent thoroughbreds of note West and Agua Caliente seldom could do better than put a handful of top performers on its course.

"But with approximately 150 days of racing coming up, sweetened with some big purses, it appears that California is about to come back into its own as one of the nation's big horse racing States.

"Naturally, the breeding industry has picked up sharply here so that the State may be contributing in a few years thoroughbreds equal to its numerous other champions."

## New York Cotton

New York, Aug. 10.—(AP)—Cotton futures opened easy, five to nine points lower on over-night trading and reports of rain in Texas.

Realizing was active at the opening and became more general after the call with December selling off to 13.72 and May to 13.93, or 22 to 25 points below yesterday's closing.

Prices steadied later on trade or commission house buying, and there were quick rallies of nine or ten points with the market at the end of the first half-hour showing losses of about 1 to 14 points on active positions.

Washington, Aug. 10.—(AP)—General Hugh S. Johnson today notified NRA workers that the Blue Eagle organization has reached the point where personnel reduction must be faced.

A notice in the nature of a personal letter went to all employees. In it Johnson said:

"We are now confronted with the necessity of a slight reduction in personnel because the work that has to be done has declined in volume, but I want you to know I am laying down rules that no person who has been efficient in their organization shall be let go without a period of notice and this organization will endeavor to find other employment for those no longer needed."

Johnson's notice went out as the NRA reached the date officially set for the end of code making and the beginning of new emphasis on code enforcement.
