Leaders Move To Perfect Plans For Textile Strike

STRIKE HEADS ASSEMBLE FOR CONFERENCES

Supreme Court of Labor Disputes Moves To Maintain Peace; Attempt Made to Obtain Views of Strike Leaders; Conference to be Held in Charlotte, Massachusetts and Rhode Island

Washington, Aug. 25.—(AP)—The "supreme court" of labor disputes strove to maintain peace today as chiefs of the United Textile Workers gathered to perfect plans for the national strike which they say will involve 600,000 workers.

Strike leaders were called into three regional conferences at Charlotte, and in Massachusetts and Rhode Island—and they are apparently bent on calling workers out next week unless demands are met. The strike had been set for September 1—or earlier. Local meetings are also called. After spinning the good offices of the Cotton Textile Industrial Board, the leaders headed by Francis J. Gorman, responded to call last night to confer with the national labor board.

W. D. Garrison, chairman of the strike tribunal to forestall labor disputes, indicated he wanted to obtain the strike leaders' viewpoint at first hand.

The Cotton Textile Industrial Relations Board—whose offer of aid the leaders rejected today—is headed by Robert Bruer and was created to settle labor disputes in the industry.

LLOYD GIVEN HEARING HERE

Farmville Community Young Man Bound Over For Reckless Driving

Preston Lloyd, young white man of the Farmville community, was bound over to County court under bond of \$200 on a charge of driving while drunk in the regular Saturday morning session of police court today.

Four other defendants held with Lloyd on charges of drunkenness, were permitted to go free on payment of cost. They were Elias Dunn, Henry Jack and Thurston Lloyd.

All five defendants are scheduled to face trial in magistrate's court here next week on a charge of assaulting Ab Baker, farmer who resides on the Falkland road, several miles from Greenville.

The young men are alleged to have indulged too freely in whiskey started toward Greenville attacked Ab Baker along the road, and then came on to Greenville. Arriving at Five Points the car went out of control and crashed into an iron post in the front of Brown's Drug Store. Neither the car nor the building was damaged to any great extent.

Backing the car off the sidewalk, they headed for the hospital for treatment of slight injuries which one or two of them allegedly suffered in the attack on Baker. Police overtook them and held them in jail for preliminary hearing this morning.

Preston Lloyd's bond was fixed at \$200 which he immediately provided.

POOL CLOSING FOR TWO DAYS

Municipal Swimming Pool Closes Because Of The Death of H. L. Rivers, Jr.

The municipal swimming pool will be closed today and tomorrow because of the death of Henry L. Rivers, Jr., who died last night after a week's illness from pneumonia.

The announcement of suspension of pool activities for the two days was made today by Eric Tucker, manager, who said the regular schedule would be resumed Monday morning.

Young Rivers was assistant manager of the pool and had had wide experience in life saving. He was considered one of the leading experts in swimming in this immediate part of the state, having formerly been connected with the Westbrook swimming pool before the building of the present beautiful project on Fifth street.

The pool has been in operation about three weeks and during the time hundreds of people have taken advantage of its cooling waters, and the expert advice in swimming offered by young Rivers who was always on the job as one of the regular staff of life savers.

Those connected with the pool expressed deep sorrow over his death and paid high tribute to the splendid service which he rendered the community in attempting to put all fields of sports with which he was associated on a higher plane.

Escaped Convict Shot. Watts, Ok., Aug. 25.—(AP)—Dennis Morris, escaped Oklahoma convict, was killed in a gun battle with Adair county officers here today after Morris and two companions had shot and wounded H. V. Waldrop, watch merchant, during a robbery of his store.

State penitentiary guards from McAllister with bloodhounds, and county officers were trailing the confederate of Morris who escaped during the gun fight. One of the men was believed to be wounded. None of the officers were wounded.

Aroused by his watchdog at the store, Waldrop, 46, went to his establishment about 1 a. m., he was confronted by three robbers, one of whom fired at him with a shotgun. Waldrop fell wounded.

The others then fled about carrying bundles of shoes and dry goods.

Following the fleeing trio officers came upon them at a camp two and a half miles west to Watts where the battle ensued.

SERVICES TO CLOSE SUNDAY

Rev. J. R. Potts to Deliver Final Sermon At Union Services Here

The series of union services which have been held on the court house lawn during the summer months will be brought to a close tomorrow evening. The final sermon will be delivered by Rev. J. R. Potts, pastor of the Presbyterian church, and the musical program will be in charge of the Presbyterian choir.

Members of the Ministerial Association, sponsors of the services, said today they hoped to make the concluding service the most inspirational of the summer and urged representatives of all denominations to attend in large numbers.

All ministers of the city have taken an active part in the success of the services by the preparation of special sermons and choirs of the various churches have done their part through special musical programs.

The first two services were interrupted by rain but since that time large crowds have been able to assemble on the lawn each Sunday evening to join in spiritual uplift.

Rev. A. W. Fleischmann, pastor of Memorial Baptist church, and president of the Ministerial Association, said today he thought the services had been of great value to the entire citizenship in that they had brought members of the various denominations in close touch with one another. He expressed appreciation of the interest manifested and the wholehearted effort of the ministers to make the services a success.

Mr. Potts several months ago accepted work as acting pastor of the Presbyterian church, having served many years as an evangelist. He is a speaker of considerable ability and a good crowd, if not the largest of the summer, was expected to be on hand to hear him.

SCHALL SEEKS 'CENSORSHIP' OF U. S. PRESS

Says Administration Plans to "Force" Censorship on American Newspapers

Washington, Aug. 25.—(AP)—Senator Schall, of Minnesota, sent an open letter to President Roosevelt today reiterating that the administration intends to "force a censorship of the press."

It followed a demand by the president for "facts" on which the senator based his recent assertion that plans are under consideration for a national press service to take the place of the Associated Press, the Hearst News Service and the United Press.

This service, Schall said would "have exclusive use of all government news and be in a position to give its service only to those newspapers loyal to the Roosevelt dictatorship."

"Since I should assume the statements were not made without basis in fact," Mr. Roosevelt telegraphed the senator late yesterday, "I request that you give me the benefit of such facts as you have in support of the charges you have caused to be made. When these facts are in my hands they will receive immediate attention in order to make impossible the thing you say will be done because 'I am just as much opposed to them as you are.'"

Schall's 650 word reply was issued a few hours later.

PITT MAKES CATTLE BID

Inspector to Come Here Next Week to Pass on Available Pasture Lands

A federal inspector is expected to arrive here next week to pass on pasture land which Pitt County wishes to set aside for cattle which the government is shipping from the drought regions of the middle west for relief purposes.

R. L. Little, farm director of the FERA in this county, said today the inspector had been expected here the last several days but was unable to reach the community on account of pressing business in other areas. He said, however, he expected him the first of next week.

Mr. Little said a recent survey revealed that there are 3,000 acres of pasture land available in this county for drought cattle.

Sometime ago a survey was made and it was declared at the time that pasture land was insufficient to meet the needs of the government and consequently Pitt county lost out on its request for an allotment of relief cattle.

However, the new survey has placed an entirely new complexion on the situation and the inspector is expected to place his stamp of approval on the county's request. His decision is final.

Mr. Little said with North Carolina's allotment of cattle increased from 75,000 to 175,000 heads, Pitt county should put in a bid for one of the canning plants which the government is erecting in cities close to pasture lands. He declared there is no reason in the world why the county should not have a plant as it had the facilities and an abundance of labor.

TAX RATE IN ANSON IS SET AT 78 CENTS

Wadesboro, Aug. 25.—The Anson county commissioners have just reduced the 1934 tax levy, which was set last week at 87 cents, to 78 cents, which is two cents more than it was last year. Items for which the levy is made are as follows: General county, 15 cents; debt service, 43 cents; public health five cents; charity, five cents; agricultural and home economics teachers for high schools, seven cents; capital outlay for schools, three cents.

H. L. RIVERS, JR. SUCCUMBS TO ILLNESS HERE

Funeral to be Conducted From Late Home Sunday Afternoon at 5 o'Clock

H. L. Rivers, Jr., 20, one of the most promising young men of the community, died last night at 10:10 o'clock following an attack of pneumonia. He was taken sick Sunday, and while physicians held out hope for his recovery, his condition took a sudden turn for the worse late yesterday and death was inevitable.

Funeral services will be conducted from the home of his parents, Mr. and Mrs. Henry L. Rivers, on Tenth Street, Sunday afternoon at 5 o'clock by Dr. G. R. Combs, pastor of Jarvis Memorial Methodist church, assisted by Rev. A. W. Fleischmann, pastor of Memorial Baptist church. Interment will be made in Greenwood cemetery.

The deceased was regarded as one of the most upright young men of the community, always taking part in activities looking to the moral, physical and spiritual improvement of public life.

He attended public schools of Greenville, graduating from high school in June, 1929. He was a student at Clemson college two years, studying civil engineering. He then attended East Carolina Teachers' college one year. While attending high school he was a member of the football team and participated in all forms of student activities.

At the college here he was a member of the football team, student manager of athletics and took an active part in campus activities.

Due to his training in civil engineering he was last year made county supervisor of the federal malaria control project. Prior to his illness he was assistant manager of the municipal swimming pool, and during previous summers had been co-manager with C. W. Porter of the Westbrook pool. His last year at Westbrook was marked by awarding of 22 life saving certificates to 17 juniors and five seniors.

He was a member of Jarvis Memorial Methodist church and was formerly connected with the teaching staff of the Sunday school.

LEAF PRICES MOVE HIGHER IN CAROLINA

Various Markets Report Higher Averages on Last Sales of Week Friday

Raleigh, Aug. 25.—(AP)—Saturday is a holiday on the tobacco auction markets and the dark warehouses were deserted but growers of the new bright belt looked back on the highest opening prices in more than a decade.

An upward trend in prices set the opening of the markets Thursday caused growers to look forward to the next week sales with optimism.

Prices throughout the belt yesterday were generally higher than those on the first day of the season. Although prices Thursday were generally kept down by a preponderance of low grade tobacco, nevertheless the price levels reached the highest point they had touched since the years immediately following the World war.

Official reports of sales yesterday included:

Wilson, 455,390 pounds, average, \$27.11.

Rocky Mount, 124,576 pounds, average, \$25.95.

Ahoskie, 25,228 pounds, average \$26.25.

Goldboro, 116,490 pounds, average \$30.35.

Prices on the South Carolina belt which opened ten days ago before the Eastern North Carolina belt continued to bring joy to growers. Due to the late curing and rainy weather the breaks during the first two days of the new bright belt were not heavy but considerably larger offerings were expected next week.

Mercury Dips To Freezing In The Mid-West

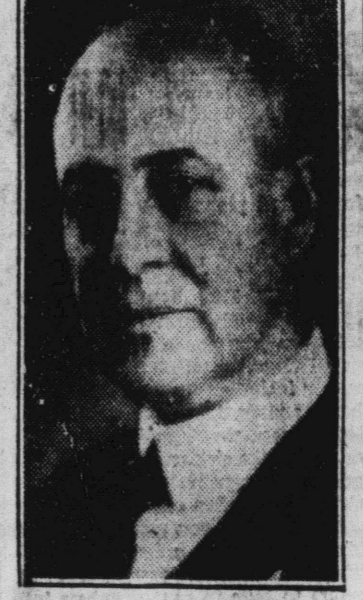
(By Associated Press) With perspiration from record heat hardly dry upon their brows farmers in the Mid-West shivered in frost nipped fields today.

Prophets saw a long and severe winter in the sudden plunge of the temperature but their views were without official confirmation. Meteorologists said their predictions were unscientific. Records fell as the mercury plunged to 28, four degrees below freezing in North Dakota, 34 in Minnesota, 36 in Yellowstone National Park and in Wyoming, 37 in Wisconsin, 39 in South Dakota, 41 in Michigan, Montana and Wyoming, 40, 41 in Nebraska, 44 in Missouri, 46 in Colorado, 52 in Kansas and Oklahoma, and 56 in Illinois.

Only a few days before temperatures rocketed to 110 degrees and over in several of these same states.

PRICES MOVED TO HIGH POINT DURING FRIDAY

With Full Corps of Buyers on The Job Monday, Sales Are Expected to be The Heaviest of The Season; Farmers Advised to Market Tobacco Rapidly and Grade Carefully; Growers Overjoyed By Advance in Prices

Tobacco prices rocketed to greater heights on the Greenville tobacco market yesterday and the hundreds of farmers who sold here were overjoyed with the outcome of the sales.

The official report of sales made public this morning by K. W. Cobb, supervisor of sales, showed the market averaged \$28.26 yesterday. Poundage disposed of was given as 442,606 for which farmers were paid \$125,000.53.

During the two days' sales Mr. Cobb said 880,042 pounds were sold for \$243,907.99 at an average of \$27.71 per hundred pounds.

Five sets of buyers will go on the floors of the various warehouses Monday morning, it was stated by Mr. Cobb, and growers were advised to bring their tobacco to market rapidly. The leading markets of the belt operated the first two days of the season with two sets of buyers because of the inability of buying companies to bring their men from other belts in time for the opening.

However, assurance was received yesterday afternoon from J. C. Eagles, president of the East Carolina Tobacco Warehousemen's Association that five sets of buyers would be on this market Monday morning. This means that the market will be able to handle over 1,750,000 pounds of tobacco daily.

Farmers expressed themselves as highly pleased with the price situation yesterday, and with additional buyers on the floors from now on are expected to market their tobacco rapidly. They have been advised by tobacco men to grade their tobacco carefully, eliminate all strings and market it in the best condition possible. This, it was declared, will play an important part in price because buyers give more attention to tobacco that has been carefully handled.

Some of the warehouses yesterday averaged above \$29.00 a hundred pounds and some others fell slightly below the mark. Common grades of tobacco brought prices probably as high as war days when all time price records were hung up.

Opinion was expressed today that prices during the two opening days were as high as in 1919, and with the season just started it was hoped the average here would reach the 30 cent mark if not exceed that figure.

The price boost not only has put new heart into the farmers but the public generally, and smiles a mile wide may be noted everywhere one goes. It means that additional thousands of dollars will flow into this district daily, enabling growers who have been hard hit in recent years to provide their families with some of the necessities of life, meet old obligations and probably set aside a little nest egg for emergencies next year.

The government and buying companies told the farmers prices would be better if production was reduced. That statement was made last year at the beginning of the reduction campaign. It was made again this year, and mounting prices on the local market yesterday indicated they mean to live up to their word.

Farmers who have been holding back the last several days because of two sets of buyers probably will cut loose with their crop Monday and the market for several weeks probably will have as much as it can do to take care of the offerings.

COURT OPENS HERE MONDAY

Over Hundred Cases Are Docketed For Hearing During One Week Session

With a hundred or more cases on docket, a one week term of criminal court will convene in this city next Monday morning with Judge R. H. Hunt Parker, of Roanoke Rapids, on the bench.

The grand jury will be faced by two score or more cases, the majority of defendants now being held in jail here.

Three murder cases, rape, forgery, and robbery charges are also on the docket and indications are that the session will be one of the busiest in months.

It is the first sitting of criminal court in about three months because of the annual summer recess, and as usual hundreds of people will be on hand to watch the wheel of justice grind out sentences to the hundred or more defendants.

Judge Parker convened a one week team of civil court here Monday, completed the calendar by Wednesday afternoon and adjourned. Around twenty actions were completed, the majority going the compromise route.

ACQUITTED OF MURDER ON DIRECTED VERDICT

Laurinburg, Aug. 25.—John Peter Malloy, 24, Negro, on trial here for his life, was freed late today when Judge H. Hoyle Sink halted the testimony and ordered a directed verdict of not guilty.

The Negro was charged with the first degree murder of Frank Alford, 43, well known white trader. Alford was the victim of a secret assault late at night, and two Negro eye-witnesses identified Malloy as the man who slipped up behind Alford and struck him on the head.

After listening to a long line of testimony, however, Judge Sink said it would be impossible for the jury to render a verdict of guilty that should not be set aside.

DEPARTMENT STORE AT GIBSON ROBBED

Laurinburg, Aug. 25.—Scotland county officers are searching for robbers who last night forced a door of the Reynolds' Department Store, at Gibson, and hauled off goods the sheriff estimated as worth \$700.

Near Gibson robbers broke open the garage of W. N. McKenzie, prominent farmer, stole a wheel of a Ford and one off a Chevrolet automobile, after prowling all thru his barns and outhouses.

Washington Daybook

Washington — One of the most curious facts in the political career of Henry T. Rainey was that at the time of his death he held the very power as speaker against which he had crusaded a great part of his public life.

During his one term in the speakership that office was clothed with such authority that members of the house—democrats and republicans alike—were prevented from exercising little more than a voting membership.

Not Reed, Cannon, Clark or Longworth, in the heyday of their power as speaker, enjoyed such absolute control as did the kindly, white-haired farmer-statesman from Illinois.

Yet it was Rainey who joined heartily with Norris of Nebraska (now in the Senate) back in 1910 in the fight which took away from "Uncle Joe" Cannon the czaristic powers of the speaker.

Made No Apologies

He made no apologies during the seventy-third congress for the ever-increasing authority he exercised. If he ever said anything about it, it was not a matter of record.

He believed firmly that the economic condition of the country and the world during the time he was speaker made it vitally necessary that the recommendations of the administration be applied quickly. Not to do so, he argued, would have invalidated them.

His faith in what he had done was summed up aptly in the closing moments of the congress when, after handing the gavel to Republican Leader Snell, he advanced to the democratic side and declared:

"An historic congress is about to end its second and last session. In this congress we have enacted more legislation, we have done more work and we have talked less than in any other congress in the history of this republic."

Used "Gag" Rule

Rainey and his aids were able to reach the crest of power they did by use of a form of procedure in the house known as the special or so-called "gag rule." By means of this they were able to bring up a measure for immediate consideration, restrict debate and choke off amendments.

They went back to a precedent of 120 years standing for this authority.

Nothing like it had been seen by the oldest of house observers. There were plenty of complaints, even threats of outright revolt on the part of members. But Rainey stuck to his guns, beating down opposition in forceful and at times ruthless fashion.

DURHAM PREPARING FOR TEXTILE STRIKE

Durham, Aug. 25.—More than two thousand Durham textile workers affiliated with the American Federation of Labor, late Friday night formulated plans to be carried out in the event the national strike is not halted by President Roosevelt before September 1.

Albert P. Beck, textile organizer, speaking to the group at the high school auditorium in West Durham, asked them to select fifty ex-Army men, including state militia and home guards, for strike duty. Eighteen women were appointed to serve on the strike sick committee and 24 additional women to make up the strike commissary committee.

Plans are under way to appoint a vigilance committee for the administration of summary justice, a group to take in new members into the organization and an entertainment committee to see that the strikers will be jolly during the strike period.

London —(AP)— British women earn their living in a wide variety of occupations. This is shown by a ponderous book of tables just issued by the government as a result of the 1931 census. Women blacksmiths numbered 848, women "bookies" 422, women police 19, and women chimney-sweeps 27. There were 198 women undertakers.

There was only one woman game-keeper, while the task of minding sheep and caring for lambs attracted only 22 women.

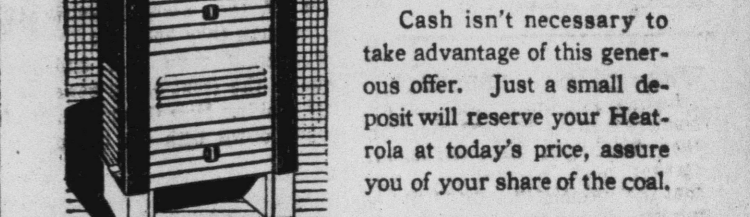

'Boris I' Wants A Free Andorra'

By H. E. KNOBLAUGH Madrid.—(AP)—Andorra, world's tiniest republic has become the battleground of a vestpocket war which, although more theatrical than sanguinary, has both France and Spain considerably upset.

Apparently from nowhere a monocolored young man appeared in the country, nestling among the Pyrenees, bent on making himself king. Until recently, moment of unrest for the Andorrans have been few and short-lived. For ten centuries the people, now numbering 5,500, have tilled the soil and tended sheep, enjoying undisturbed sovereignty and apparently content under the suzerainty of France and the Spanish Bishop of Urgell.

So remarkable were they, in fact, that his view of the scenery has been restricted to that available from the window of a cell in the Madrid jail while the government is debating what it should do with him. These are some of his accomplishments in his brief but active stay in Andorra.

Twice Bonthon chased his two foremost rivals to world records. He trailed Lovelock at Princeton when the New Zealander did 4:07.6 in 1933. On the same track, almost a year later, Bill was beaten away by Cunningham's record mile in 4:06.7. Yet Bonthon came back to turn the tables twice on his Kansas rival, whipping him at Los Angeles in the National Collegiate mile and then racing to a sensational world record of 3:48.8 for the national 1500 meter championship at Milwaukee.

Yanks Supreme

Meanwhile, the United States has served notice in Europe of its potential strength for the next Olympics. Our touring track and field teams have registered a series of spectacular performances. Ben Eastman in the 800 meters, or half

mile, has proved himself the best in the world. Big Jack Torrance has forced a complete revision of standards in shotputting by heaving the 16-pound ball beyond 57 feet and making a joke of existing records. Glenn Hardin, over the low hurdles, and Percy Beard, in the high hurdles, have likewise been battering world records to bits.

With such stars to set the example and the pace, for a wealth of up-and-coming talent at home, there is every reason to expect this country to assemble a formidable team for the trip to Europe two years hence.

The West Coast is a hotbed of track and field development, with California returning to power in the three-cornered tussle with Stanford and Southern California. The South, thanks to Louisiana State's remarkable output, is also contributing heavily to the talent of championship calibre. The East has no "Little Bill" Carr in sight, but likely will contribute its share again while the Middle West turns toward a new galaxy of rising athletic stars, among them the sensational Jesse Owens, of Ohio State University, labelled a "super-Melcafe" in the prints.

ACCUSED OF PURPOSELY RUNNING DOWN YOUTH

Smithfield, Aug. 25.—Chester Pollard and W. H. Crawford, two white men who live here, have been given a hearing in the recorder's court, charged with assault with a deadly weapon and being hit-and-run drivers, and for operating an automobile while intoxicated.

Chester Pollard was driving his Ford Model T, on Market Street, in Smithfield, last Sunday afternoon and his companion, Crawford suggested that they run over a young boy, Ben Pollard, who was riding on a bicycle on the right hand side of the street. Chester Pollard refused to do this, but as the car came close to the boy, Crawford grabbed the wheel and deliberately pulled the car against the young boy. Apparently he is not seriously hurt, but when he was struck neither of the men stopped to look after him, but drove on and they were shortly arrested by Chief of Police E. R. Hales. Pollard was putting a bottle of liquor in his shirt when he was arrested. Probable cause was found and both defendants bound over to the Superior Court under bonds of \$500.

Business Activity Declined In July

New York—(AP)—General business activity as measured by the National Industrial Conference Board declined during July and the first two weeks of August more than is usual for this season.

Production of passenger cars and trucks in United States and Canada in July declined 16 per cent under June, but the total was 15 per cent larger than July of last year.

Building and engineering contract awards showed a greater than seasonal decline in July, reports the board.

Steel production in July was reported at half the June total and the lowest since April, 1933. Steel operations in July were marked at 26.8 per cent of capacity, and pig iron production was reported as sharply declining in July.

Production of electric power in July showed less than the usual seasonal decline from the previous month, the board reported, "production being maintained by unprecedented requirements for refrigeration and irrigation."

Rail shipments of all classes of commodities averaged 53 per cent under June and 48 per cent under July, 1933. "The decline was due to diminished shipments of coal, coke, forest products, ore, merchandise and miscellaneous items," the board report shows.

Department store sales declined in July 28.6 per cent in dollar value of turnover as compared with June. Prices of department store items were reported 9.2 per cent lower in July than in June and 17.7 per cent above July of last year.

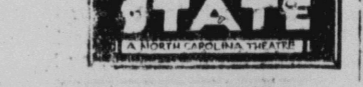
