Nine Persons Killed In Strike

COURT ORDERS SEIZURE OF SLOT MACHINES IN PITT

Seven Men Felled In Clash In Two South Carolina Areas

TWO DEAD IN FIGHTING AT GEORGIA MILL

Thirty Wounded as Flying Squadrons And Strikers Clash At Honea Path and Greenville, S. C.; Pistols and Shotguns Take Six Lives at Honea Path; Deputy Kills Man at Greenville; Troops Ordered Out to Take Care Of Situation

(By The Associated Press) Over 360,000 workers were idle today out of the 700,000 normally employed in the industry, an independent survey of the general textile strike indicated.

Death by shooting marked the efforts today of union leaders to extend the general strike in the textile industry by pickets and flying squadrons movement against plants still open.

At least six persons were killed at Honea Path, S. C., and approximately thirty wounded. One was also killed at Greenville.

Late yesterday two men were killed in fighting at the plant of the Tyron Cotton Mill at Tyron, Ga., in a gun fight between deputies and strike sympathizers. One was a deputy and the other a striker.

Striking workers composed a flying squadron from Fall River, Mass., numbered by police at 2,000 battled officers at King Phillip Mill to free a strike leader after he had been taken into custody by police.

Charlotte, Sept. 6.—(AP)—Seven men died and thirty fell wounded today in mill clashes as flying squadrons continued their forays through the Carolinas despite national guards attempts to restore order in the general textile strike.

Pistols and shotguns took six lives and injured thirty at Honea Path, S. C., in a battle there and a deputy sheriff at the Dunham Mill at Greenville fired six bullets in John Black.

The Honea Path victims were members of squadrons from Belton, S. C., which arrived at the mill just before opening time today and demanded that its gates remain closed. The mill management delayed opening pending final decision but meantime armed workers entered into a dispute with the Belton crowd which numbered approximately 200.

In a moment guns were blazing and the ground was littered with dead and wounded. Identities of the wounded and factions to which they belonged could not be learned immediately.

Bob Putnam, who killed Black at Greenville was arrested. He claimed opening pending final decision when the man who claimed not to a striker struck him with a knife. Putnam surrendered and was jailed pending an investigation.

No arrests had been made at Honea Path.

Governor Ibra C. Blackwood of South Carolina was urged from numerous sides to declare martial law but said he would do so only as a last resort. Honea Path authorities had asked for troops prior to today but they had been advised all troops had already been mobilized at other points.

The governor said it would take three or four thousand troops to enforce the martial law order; that would interfere with civil life of the entire state; that he did not have that number of troops and would not issue such an order unless it could be enforced.

Late News Flashes

Order Guards On Strike Duty. Raleigh, Sept. 6.—(AP)—Six additional national guard companies, making a total of 13 in all, were ordered on strike guard duty this afternoon.

Three of the new units will go to King's Mountain and three to Greensboro. This morning two units of the 120th Infantry Company 2 at Burlington and Company M at Wilson, were ordered on duty at Burlington.

It was indicated still more troops might be mobilized with Spindale, some points in Gaston county, and some points in the Fayetteville section as likely concentration centers.

Probe Disappearance. Lynn, Mass., Sept. 6.—(AP)—Lynn police today started a probe into the tragic disappearance of Claude Kitchin, 32, of Washington, D. C., an attorney connected with the Department of the Interior.

According to John Mills, Jr., of Raleigh, N. C., who had been registered with Kitchin at the Hotel Edison, the latter had been missing for the past two days and Mills feared he might be suffering from a nervous breakdown. He had but little money in his possession when last seen.

Sloan Scores Strike. New York, Sept. 6.—(AP)—George Sloan, president of the Cotton Textile Institute, said today "that all other questions have been replaced by one paramount issue: ten lives have been needlessly sacrificed in a conflict over the inalienable right to work."

Governor Silent On Strike. Columbia, S. C., Sept. 6.—(AP)—The terse announcement was made by Gov. Blackwood of South Carolina that "no more information will be given out concerning the mobilization or movement of troops" in connection with the strike in the state.

The governor also issued an appeal today to all dealers in firearms not to sell weapons to any person except authorized officers of the law. The governor made no comment on the appeal.

Debt Negotiations Collapse. Washington, Sept. 6.—(AP)—Soviet-American negotiations for a settlement of debts and claims totalling more than \$500,000,000 virtually collapsed today as result of another unsatisfactory discussion of settlement terms between Assistant Secretary of State Moore and Alexander Trajavenosky, the Soviet ambassador.

The State Department issued a communique in which it revealed that Moore, Trajavenosky and Robert Kelly, chief of the Eastern European division, held a joint conference last night which "was without satisfactory results."

TRY TO AVERT NEW VIOLENCE IN S. C. STRIKE

Gov. Blackwood and Federation of Strikers Head Confer on Strike Plans

Columbia, S. C., Sept. 6.—(AP)—Governor Ibra C. Blackwood and J. A. Frier, state president of the Federation of Textile workers, reached a tentative agreement at a conference today to take steps seeking to prevent further violence in the strike area.

The governor proposed that the manufacturers willing, a vote be taken of all workers employed on the day the strike opened on whether the mills shutdown or resume operation. The election under the plan would be held only at mills which are attempting to operate while a portion of its workers while the others are out on strike.

The election, the governor suggested, would be conducted by a board consisting of representatives of the manufacturers, one of the operators and a third to be chosen by the two voted.

LEAF SALES FAIRLY HEAVY

Over Million Pounds Of Tobacco Handled on The Local Market Yesterday

The demand for improved grades has been quite noticeable since the opening of the market three weeks ago and farmers presenting this kind of tobacco on sale are obtaining prices binging joy to their hearts.

The official report of sales made public this morning by K. W. Cobb, supervisor of sales, showed that the market yesterday sold 1,003,372 pounds of tobacco for \$256,896.65 at an average of \$25.60 per hundred pounds.

In spite of comparatively heavy offerings each day this week, the market has cleared each afternoon about 4 o'clock enabling the warehouses to get in splendid shape for the reception of offerings the following day. The Greenville market is in better shape to handle the crop this year than ever before and the increased facilities have played an important part in speeding up activities from day to day.

Giant Okra Plant Draws Interest

A giant okra plant, raised on the farm of Dr. J. W. Perkins, near Greenville, was brought to the Reflector office yesterday afternoon by Penrose Perkins, a son of Dr. Perkins.

The plant is twelve feet high, one of the largest ever seen in this immediate section. It is well filled out containing numbers of limbs and several pods of okra.

The tall plant is reminiscent of Jack and the Beanstalk, although it happened to be a boy by the name of Penrose in this case and an okra plant instead of beanstalk.

ACTION COMES AFTER REPORT OF GRAND JURY

Judge Dink James in County Court Orders All Officers to Notify Slot Machine Operators to Suspend Operation of Machines and Other Gambling Devices; Those Refusing Will Be Arrested and Machines Seized

The operation of slot machines must come to an end in Pitt County, Judge Dink James in County Court this morning issued an order to all officers of Pitt county, outside the town of Farmville, to notify owners and operators of slot machines and all other gambling devices that they must cease the operation of such devices by September 12 or they will be arrested and their machines seized.

The action followed closely on the heels of a grand jury report which mentioned the widespread prevalence of slot machine operations in the county and recommended that County court take immediate action to see that the menace was definitely removed.

Hundreds of such machines were said to be in operation in all sections of the county and the grand jury reported that its recommendations to County court followed complaints made by various sources.

"Any person failing, neglecting or refusing to comply with this order after being notified in the manner described above, shall be immediately arrested and any and all machines or devices, with the contents of the machines or devices being operated shall be thereupon seized," the order of Judge James said.

Legal status of any and all machines, punch boards or devices referred to in the order, as to whether legal or illegal, will be determined by the court, Judge James stated.

The court order follows: To The Sheriff And Any Lawful Officer in Pitt County: Greeting. You are hereby commanded forthwith to notify any and all persons or corporations in Pitt County (outside of the Town of Farmville) operating, permitting to operate or any persons or corporations directly connected with the operating, permitting to operate, or having in possession for the purpose of operating, any and all illegal slot machines, vending machines, punch boards, and or all other gambling machines and devices by whatever name called, that shall not produce for or give to the person who places money or coin, or representative of either, the same return in market value each and every time machine is operated by placing money or coin, or the representative of either therein, to immediately stop the operation, permitting to operate, or having in possession for the purpose of operating, any of the aforesaid machines, punch boards or devices, and to immediately, permanently and completely stop and abandon any and all operations permitting to operate and or possession for the purpose of operation of any of the aforesaid machines or devices.

It shall be sufficient notice on and prior to September 12, 1934, if the sheriff or any lawful officer in Pitt County shall personally and verbally notify any owner, operator, or any person or corporation permitting or directly connected with the operation or possession of any of (Continued on page Two.)

CONTRACT FOR SEVERAL SEEK CATTLE OFF HEALTH POST

Two Thousand Five Hundred Acres of Pasturage Available In Pitt County

A contract for 2,500 acres of pasture land was mailed to the federal cattle inspector at Goldsboro today from this county by R. L. Little, emergency farm relief head, who said he was hopeful the government would allot at least 200 heads of cattle to the county.

It was thought the federal inspector would come to Greenville yesterday and when he failed to appear Mr. Little immediately mailed the contract so that it can be immediately forwarded to state relief headquarters at Raleigh.

With the state cattle allotment being increased from 75,000 to 175,000, Mr. Little said he hoped the relief authorities would see fit to send a shipment for pasturage in this county. The cattle is being brought from drought districts and will be used in general relief work.

An effort is also being made to obtain a federal canning plant for this city and this proposal has already been filed with the administration by the farm department head.

STRICKERS TO DO WITHOUT WAGES

Durham, Sept. 6.—An estimate payroll of \$35,000 for the past week's wages of the 5,200 strikers in the local hosiery and textile plants will not be issued here this week, William Gilliam, president of the Bull City Textile Local, said that the strike executive board will not permit the sheriff to accompany local superintendents and paymasters to their mill offices to make out the payrolls.

"We're not interested in the payroll, Gilliam and Organizer Albert Beck said today. "The workers are back of us, we're not striking for money—but for union principles and recognition of labor's place in industry."

H. A. Deal, superintendent of the East Durham Cotton Manufacturing Company, has been in the plant since he entered it early yesterday morning. Though he has been given permission to leave, without permission to reenter, he will not leave the place.

Number of Applicants Reported For Public Health Office of Pitt County

Although several applications have been received, it was announced today that a permanent health officer had not yet been selected to succeed Dr. R. S. McGeachy, who resigned sometime ago to accept the post as health officer of Halifax county.

The statement was made by Dr. Paul Fitzgerald, member of the Board of Health, who said the committee named to look over the field of probable successors had not yet been able to make a selection.

He said the committee was co-operating with the State Board of Health in an effort to obtain the most suitable man possible, and that it would probably be two weeks before the selection is made.

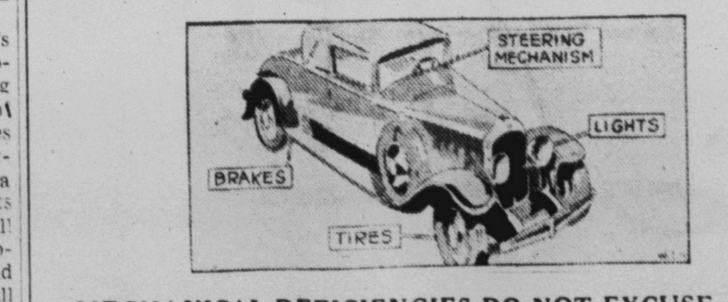
Dr. McGeachy resigned about a month ago and since the time his place has been filled by Dr. Needham E. Ward, who was named temporary health officer pending selection of the permanent health head.

ARRESTED ON TRESPASS CHARGE

High Point, Sept. 6.—High Point's municipal jail built to accommodate only 20 persons, was running over tonight as 38 occupants. 32 of them arrested on trespass charges as the result of efforts of a flying squadron group to close down a local mill, awaiting arrangements for their release on bond. The mill which they sought to close, the local unit of the Carolina Cotton and Woolen Mills owned by Marshall Field and Company which has large plants also at Leaksville, Spray and other places in this state and Virginia continued to operate despite picket lines at its gates throughout the day.

Among those arrested were Alton Lawrence secretary of the State socialist party, and Howard Morgan cotton mill strikers, outspoken leaders and today forced closing of five mills here and two at Thomasville. They were no additional closings here today although a concentrated effort was made all day at the Carolina mill which the management said had "a majority of its workers at their jobs."

Several Cases Disposed of in Second Day Session of County Court Yesterday

Eugenia Spencer, colored, who stabbed Amos Harris, also colored, because she said he told untrue tales about her, was fined \$25 and cost in the second day's session of county court yesterday. The sentence also provided that in case she failed to pay the fine she should be confined to the county home for a period of four months.

Harris, police reported, was badly slashed about the chest and back when he met the negro on a street near their home one day about a week ago. She alleged he had been telling stories about her, pulled out a long-bladed knife and began operating on the negro. She was later taken into custody by police on a charge of assault with a deadly weapon.

County court continued sitting for a short time this morning after which work was suspended until week after next. A one-week session of Superior court here next week will prevent the holding of the usual tribunal. Approximately forty cases have been disposed of in the two days' sitting.

MAN HELD IN HIT-RUN CASE

Willie Braxton Faces Preliminary Hearing Saturday in Auto Collision

Willie Braxton was held under bond by county officers today charged with alleged hit and run driving growing out of an automobile collision on the Greenville-Vanceboro highway Tuesday.

Braxton was alleged to have taken up too much of the highway when he attempted to make a curve, his machine crashing into another car driven by L. R. Hardee, severely damaging both machines.

Braxton, officers said, is alleged to have abandoned the car he was driving and fled from the scene of the wreck. He was later taken into custody by Sheriff's officers and held for preliminary hearing Saturday morning.

SCHOOL TEACHER WINS VERDICT OF NOT GUILTY

Durham, Sept. 6.—Judge Clayton Moore, in superior court last night directed a verdict of not guilty in assault charges against Albert H. Best, Hope Valley school superintendent, in connection with the whipping of a nine-year old boy last December. The State failed to prove malice and permanent injury.

Tyson Markham, the prosecuting witness, son of Mr. and Mrs. W. B. Markham, said on the stand that Best forced him to bend over a chair and struck him 12 times with a rubber hose. The whipping was administered to Tyson because he kicked a girl who allegedly thumbed her nose at him.

ONE KILLED, ONE HURT WHEN CAR LEAVES ROAD

Roanoke Rapids, Sept. 6.—(AP)—Jesse Cassidy, 35, was killed and John Stanley, of Gasburg, Va., was injured today when their automobile left the highway near here and crashed into a tree. Cassidy was a native of Danville, Va., and was a World War veteran.

The wreck was discovered early today by a passer-by. Stanly denied he was the driver of the automobile, but a warrant charging him with manslaughter was sworn out against him by the officers, who said a small bottle of liquor was found in the wrecked car.

Despite the appearance of a large quantity of black and common tips on the local tobacco market to pull the general average down, the price situation remains satisfactory and the growers are pleased with the sales they are making here. AFTER THE SLOT MACHINES

Judge Dink James has accepted the challenge handed him by the grand jury when that body recommended that the County Court look after the slot machine situation in this county, and has issued orders to all slot machine owners and operators in this county that on and after the twelfth of this month the officers will be required to arrest all operators and seize all machines in operation and give the court an opportunity to pass on whether or not the machines are gambling devices and the operators guilty of operating same as such.

This is the first definite step toward ridding the county of the slot machine racket since the grand jury investigation nearly two years ago, after which the papers in the matter disappeared from the clerk's office and nothing more was ever done about the matter. In his efforts to break up the slot machine racket in this county we believe that Judge James has the great majority of the people behind him and certainly it is to be hoped that he will see to it that this job is carried to a successful completion.

adventure by darkness. Flint was thinking solely of Ivy's comfort in the matter.

To be wrecked by daylight in a smooth sea with competent boats at hand, and competent men to man them, and land of continental proportions perhaps distantly in sight, should have no real terrors for anyone.

They did not know that the shroud of blue smoke ahead and on the starboard-bows was the smoke of a little volcano that had once risen out of the sea with volcanic noises that were audible at the distance of a thousand miles and had subsided and through the ages with the help of erosion, climate and sea born seeds, made a little island home for itself.

If they gave the smoke a thought, they thought that it was the smoke of a far-off steamer.

NINE PRESONS KILLED IN STRIKE

(Continued from Page One)
at Greenville today were assigned to trail the flying squadron of 500 men who yesterday created an uproar as they sought to force out mill employees of the Dunean and Jundson mills. The companies were under orders to cover the squadron continuously, dividing as the columns of strikers divided.

Apparently an attempt to dynamite the power plant at the Monogham mill at Greenville, reported by the mill management, failed today and 65 troopers were thrown about the property as strikers threatened to come back to complete the job.

Flying squadrons were reported from various points in both states but apparently they had made little progress in closing mills.

One group of 150 automobiles headed for Marion N. C., where three national guards companies were on duty. More than 2,000 workers entered the two mills, scene of fatal rioting in 1929, without molestation.

Three companies of national guards deployed about mills in Rockingham county near the Virginia line and twenty men were deputized to preserve order. All plants were operating at Leaksville Spray.

Draper and Magadan.

Fifty cars of pickets rode into Haw River near Burlington, closed the Cone Mill and proceeded west toward Gibsonville and Greensboro.

As the strike flying squadrons continued their drive to, extend the strike to less than 200 mills remaining open in the two states where near 30 already were closed, both states moved with militia.

Troops, five crack companies of infantry and cavalry, were mobilized in North Carolina, to be ready at dawn, a few hours after Governor Ehringhaus acceded to numerous appeals for protection in the strike and turned the strike situation over to Adjutant General J. Van Metts.

Adjutant General Metts of North Carolina, who ordered out the troops in the North State in the early hours of the morning, intimated additional troops would be called later in the day.

An Associated Press survey showed today during the past three days that 71,567 of the 111,000 normally employed workers in North Carolina were idle while 41,883 of South Carolina's 60,000 operators had left their jobs. A great number of the idle did not join in the strike but were rendered jobless when mills were closed in the face of threats from strike shock troops.

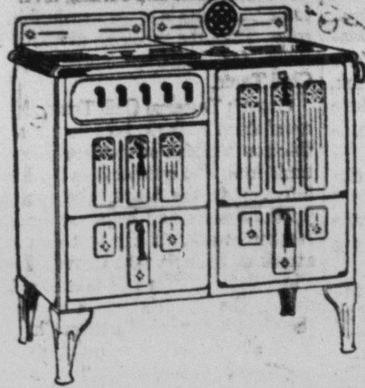

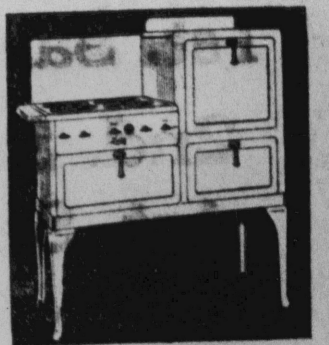
