STRIKE AT STANDSTILL, NEW TROOPS MOVE IN

New Force Of Guardsmen On Duty In State

MORE CALLS FOR TROOPS MADE TODAY

Many Mills Closed in Carolinas Today But Soldiers Continue to Surround Mills For Protection; Score or More Mills Reopen In N. C.; Martial Law Considered in S. C.; 70,000 Men Out in North Carolina

Charlotte, Sept. 8.—(AP)—The south's vast textile industry was at a standstill today as mills were closed for the week-end holiday, but through the strike sectors of the Carolinas troop movements continued.

The early hours of the morning saw the concentration of half a dozen or more units of fresh troops in the Piedmont section of South Carolina, augmenting other companies as Governor Blackford considered proclaiming martial law.

In North Carolina where a score or more mills reopened under the protection of 23 units of national guards a constant stream of reinforcements poured into the office of Governor E. B. Tamm and it was intimated that additional troops probably would be ordered out.

Meanwhile the activity of flying squadrons of pickets which have cruised over the two Carolinas closing mills right and left in the last few days, had diminished considerably. At a few places the presence of squadrons was reported but most of them apparently had disbanded.

Estimates today placed the number of North Carolina idle at 70,000 out of a total of 111,000 normally employed. In South Carolina reopenings were few involving for the most part mills which had never been fully closed.

Overnight developments on the strike battlefield in North Carolina included: Rutherfordton—Two or three men were arrested at Spencer mills on charges of inciting to riot and were held in the county jail while a third was released on \$600 bond.

NEW COTTON REPORT SHOWS LITTLE CHANGE

Washington, Sept. 8.—(AP)—Production of 9,252,000 bales of cotton this year was reported today by the Department of Agriculture as being indicated by the September 1 condition, compared with 9,195,000 bales indicated a month ago and 13,047,000 bales produced last year.

STRIKE SQUAD FAILS TO SHOW UP IN THIS AREA

Highways Being Watched However In Preparation For Any Emergency

The "Flying squadron" of textile strikers reported advancing upon this city yesterday with the avowed intention of closing down the local cotton mill had not appeared today and officers were breathing easier although keeping a keen watch to prevent any disturbance which might result from appearance of the squadron.

Battery A local unit of North Carolina National Guards, which was notified yesterday to be prepared to mobilize for duty on the strike front, marked time today awaiting notification from General J. Van Metts at Raleigh, in command of the several companies of guardsmen on duty at strike fronts.

Captain J. H. Waldrop yesterday morning notified all members of the unit to be in readiness to "march" in case of call, and the battery composed of four officers and 65 men was ready for instant

Nearly \$400,000 Paid Out On Tobacco Mart In Greenville Friday

Nearly \$400,000, the largest sum of money paid out on any single day's sales this season, was recorded on the local tobacco market yesterday, it was revealed today in the daily official report of sales made public this morning by K. W. Cobb, supervisor of sales.

Along with paying out the largest sum of money, the market also sold the greatest amount of tobacco of any day of the season and established one of the highest general averages.

To be exact, the report of the supervisor showed the market sold 1,384,114 pounds of bright leaf for a total sum of \$376,300.27, at an average of \$27.19 per hundred.

PUSH FIGHT ON SLOT MACHINES IN PITT COUNTY

Operators of Gambling Devices Ordered to Close in Face Of Court Order

Operators of slot machines and other gambling devices in Pitt County were notified by officers today that they must close their machines by September 12 or subject themselves to arrest and seizure of all devices.

The action was the outgrowth of an order issued by Judge Dink James in County court Thursday morning, instructing all law enforcement officers of the county to attempt to clear all communities of gambling devices.

The order came after a grand jury recommendation that County court take definite steps to relieve the community of gambling machines. The jury mentioned the fact that numbers of complaints had been made to that body relative to the widespread operation of slot machines in virtually every community and urged County court to take effective steps looking to eradication of the gambling menace.

Although there seemed to be some question in the minds of officers as to the status of "gambling devices" operators of all slot machines were being advised of the court order, and a few machines were being seized in various parts of the county for the purpose of "test" cases.

In issuing the order, Judge James virtually relieved the officers of responsibility of passing on the question of what is a gambling device, declaring that the "status of any and all machines, punch boards or devices referred to in this order, as to whether legal or illegal, shall be determined only by this court."

The town of Farmville was not included in the order in view of the fact that an ordinance is in effect there prohibiting the operation of such machines within the city limits. Farmville is the only town in the county that has taken direct steps to drive out the menace of "legalized gambling" but others were expected to act in the face of the court order, described as one of the most far-reaching and drastic in the annals of slot machine operation.

Judge James said today he was determined to carry out his intention to rid the community of the gambling scourge in view of the fact that thousands of people, including innocent children, are being fleeced of hundreds of dollars daily both in towns and in rural territories.

Late News Flashes

Fire Destroys Liner. Spring Lake, N. J., Sept. 7.—(AP)—A raging inferno ridden hard by death destroyed the luxurious liner Morro Castle at stormy dawn today within 8 miles of the shore of Asbury Park and 251 of the ship's 558 passengers and crew were dead or unaccounted for hours later.

A wireless message at Washington from the Cutter Tampa, said 360 persons out of 503 aboard the vessel were accounted for as alive. It could not be determined here how many were brought to the beach.

The crack Furness line, monarch of Bermuda, which raced at full speed through the dawn to the Morro Castle's side found 70 living and one dead, which were brought to New York, many of them in a dying condition.

"Tropical disturbance central about 60 miles off Cape Henry moving rapidly to the north and northeast attended by shifting gales and wind of whole gale force near the center."

MAN HELD FOR CHILD'S DEATH

Ed Davis Jailed at Lenoir on Charge of Poisoning 4-Year-Old Daughter

Lenoir, Sept. 8.—(AP)—Ed Davis, furniture worker, was jailed here today charged with murdering his four-year-old daughter, Dorothy, who died last night of what physicians said was poisoning.

The pronouncement and arrest was made after an autopsy.

Twin girls aged 6 were critically ill. Authorities expressed belief that the poison was taken in candy or meat sandwiches last night.

64-MILE HOUR WIND BATTERS CAPE HATTERAS

Cape Hatteras, Sept. 8.—(AP)—The wind reached a velocity of 64 miles an hour as the tropical disturbance moving up the coast struck here today but little damage was suffered.

The hard blow lasted about an hour beginning at 7 a. m. By 11 o'clock the wind had dropped to 20 miles and hour and shifted to a direct west wind.

BOARD STRIVES FOR PEACE IN MILL WALKOUT

President's Mediation Continue to Seek Basis For Peaceful Settlement Today

Washington, Sept. 8.—(AP)—President Roosevelt's board of mediation strove today to find some basis for peace in the textile strike as events shaped themselves toward an impasse in the controversy.

While a week-end lull descended on the strike there were indications of renewed activity on both sides on Monday. Some manufacturers are ready to reopen their plants. Strike leaders planned to renew picketing of mills.

Organized labor swung solidly behind the striking textile workers as President William Green of the American Federation of Labor called an international union conference for next week to shape plans for support of the strike. He denied there would be a general walkout.

FACTS ABOUT SPEED

Each year witnesses speedier and more flexible cars. Control devices have been greatly improved, and speeds which may have been dangerous a few years ago are not so now. There are students of these conditions who contend that practically unlimited speeds should be permitted and that speed per se is not dangerous.

Others contend that in no case should cars ever be permitted to exceed 50 miles per hour. A safe car, a safe driver and a safe open highway are conditions under which a fairly high rate of speed may be indulged in with comparative safety, while the congested city streets are obviously places in which speed cannot be tolerated.

STORM DANGER NOT IMMINENT ON N. C. COAST

Wilmington, Sept. 8.—(AP)—Storm warnings flew along the Carolina coast today but danger from the hurricane reported raging in the Atlantic was not believed imminent.

Hurricane warnings were ordered south of the Virginia capes to Morehead City and warnings were also displayed from Wilmington to Sandy Hook.

DRUNK CRAZED NEGRO SHOT BY PITT OFFICER

Galvin Hyman Arrested by Deputy Sheriff Pirece After Going On Rampage

Galvin Hyman, 37, colored, was shot by Deputy Sheriff Preston Pirece and probably seriously wounded when the negro went on a rampage last night near Falkland and refused to be arrested.

With a 45 calibre bullet in his thigh the negro was brought to the local hospital for medical aid. He was reported as getting along all right today and was expected to recover.

Said to have been half crazed by whiskey, Hyman was alleged to have assaulted a member of his race and then forcibly entered a negro house.

Constable Moore of Falkland was notified and went to the home and attempted to arrest the negro. Hyman was said to have cursed the officer and fought him off when an attempt was made to arrest him.

Constable Moore went to a nearby telephone and called the sheriff's office for aid. Deputy Pirece was on duty at the time and went to the scene of the disturbance and tried to arrest the negro.

Hyman allegedly became more violent, cursing both officers, and fighting like a madman when he was seized by Deputy Pirece to be taken into custody.

PASSENGERS ARE TRAPPED WHILE ASLEEP

Five Hundred and Fifty Eight Passengers and Crew Aboard When Flames Ignite Fuel Ship; Vessel on Way From Excursion Trip To Havana; Bodies Visible in Water; Coast Guard Boats Rush to Rescue

Spring Lake, N. J., Sept. 8.—(AP)—A roaring inferno, terror of the seas, swept with showers of death the passenger liner Morro Castle in the storm-clouded dawn near here today and 300 of the 558 passengers and crew were missing five and one half hours later.

The disaster occurred eight miles off shore from Asbury Park. "SOS—Morro Castle afloat off Scotland Light."

The first frantic SOS was picked up at 3:23 (Eastern Standard Time). So swiftly did the surging flames envelop the vessel with its 318 sleeping passengers on their way home to New York after a seven day excursion to Havana, that the ship was ablaze from stem to stern shortly after 10 a. m. (Eastern Standard Time) fewer than 250 survivors had been landed or picked up by nearby steamers racing to their rescue.

Bodies were visible in the water off the beach at Sandy Bay, N. J. Surf boats from coast guard stations along the Jersey coast pushed through heavy seas in search of survivors.

The fire started apparently in the library, according to some of the members of the crew reaching life boats. It spread to the great tanks of fuel oil and enveloped the 11,620 ton liner in a fiery column visible along the Jersey coast.

Dr. Charles Cochrane, of Brooklyn who came ashore in a boatload of survivors gave a graphic description of the tragedy as he escaped from his cabin in the inky pitch blackness.

"The front part of the ship was all aflame," he said. "I do not believe any passengers who got caught in the hold or cabins in any part of the ship beyond the library had a chance of escaping."

M. R. Baker Dies In Piney Grove Church Section

M. R. Baker, 89, died Thursday night at his home in the Pine Grove church community, and funeral services were conducted Friday.

Mr. Baker was vitally interested in religion and confined a goodly part of his time to dissemination of the Gospel in the community where he died.

PETER AND PAUL

(News and Observer)
 The first time that the expression "robbing Peter to pay Paul" was used since the New Deal began to operate, so far as we recall, was when at the meeting of the U. S. Chamber of Commerce in Washington a critic of the Roosevelt policies said they were based upon "robbing Peter to pay Paul." In his Green Bay, Wisconsin, address, President Roosevelt, denied that his policies would "rob Peter to pay Paul." But the expression survives from both angles of the continuous debate.
 A correspondent of the New York Times says that the government is "robbing Peter to pay Paul" and cites that a well known corporation has paid a tax for the first half of 1934 in the sum of \$343,992, an increase of \$187,434 compared with the corresponding period of 1933. Their belatedly Uncle Sam is following the example of Britain in levying heavy taxes on big business. If the Washington government had been wise it would not have reduced the excess profits tax imposed during the war until the war debt, including the so-called soldiers' bonus, had been paid. Instead of doing that under Mellon's leadership the taxes on excess profits were reduced, leaving the soldiers without money promised them, and the war debt not paid. But the profiteers profited!
 It is not robbing Peter to pay Paul when a concern is earning so much money that it can pay taxes of \$343,992. Excess profits tax, or tax on big business, should be high until no man is hungry or no man housed in a shack or slums in the United States. Peter and Paul will agree to such policy, based on the Golden Rule.

Klan Back, To War On Reds

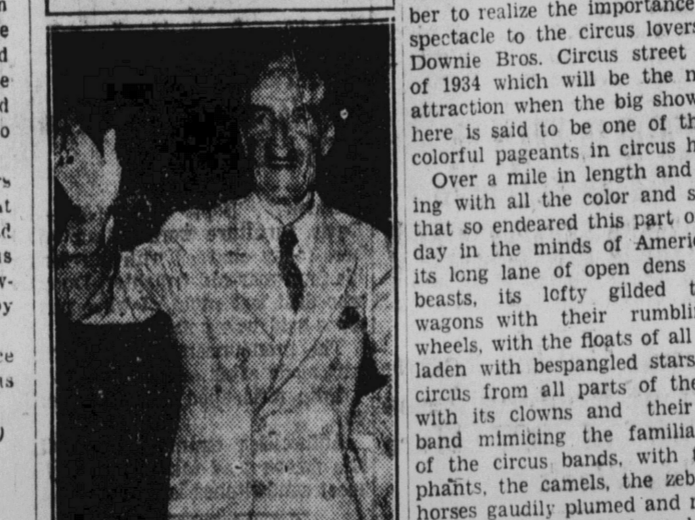

"That'll be easy," Dunning replied. "We'll instruct some of our members in every town and hamlet to join all organizations that look suspicious. They and the 'reds' will sit side by side in communist and radical meetings—but the 'reds' won't know they're Klansmen. And so we'll learn everything we want to know."
 The imperial wizard and his chief of staff are quite perturbed over what they regard as "alarming trends toward communism and radicalism in some colleges and public schools."
 Public opinion which the Klan hopes to create along lines of "strict Americanism" will be used as the "big stick" in carrying out its program, Dunning declared.
Stiff Laws Is Aim
 One major objective of the Klan is the enactment of laws in the various states for the prosecution of alien radicals and agitators. Already, Dunning said, a bill has been drawn up for introduction in the next session of the Georgia legislature to provide the death penalty for agitators in case any disorder at their meetings result in fatalities.
 In cases where the Klan's secret agents find state-supported colleges are teaching radical theories, political treachery will be brought to bear to have the legislature cut off their appropriations until the textbooks are "cleansed," Dunning added.

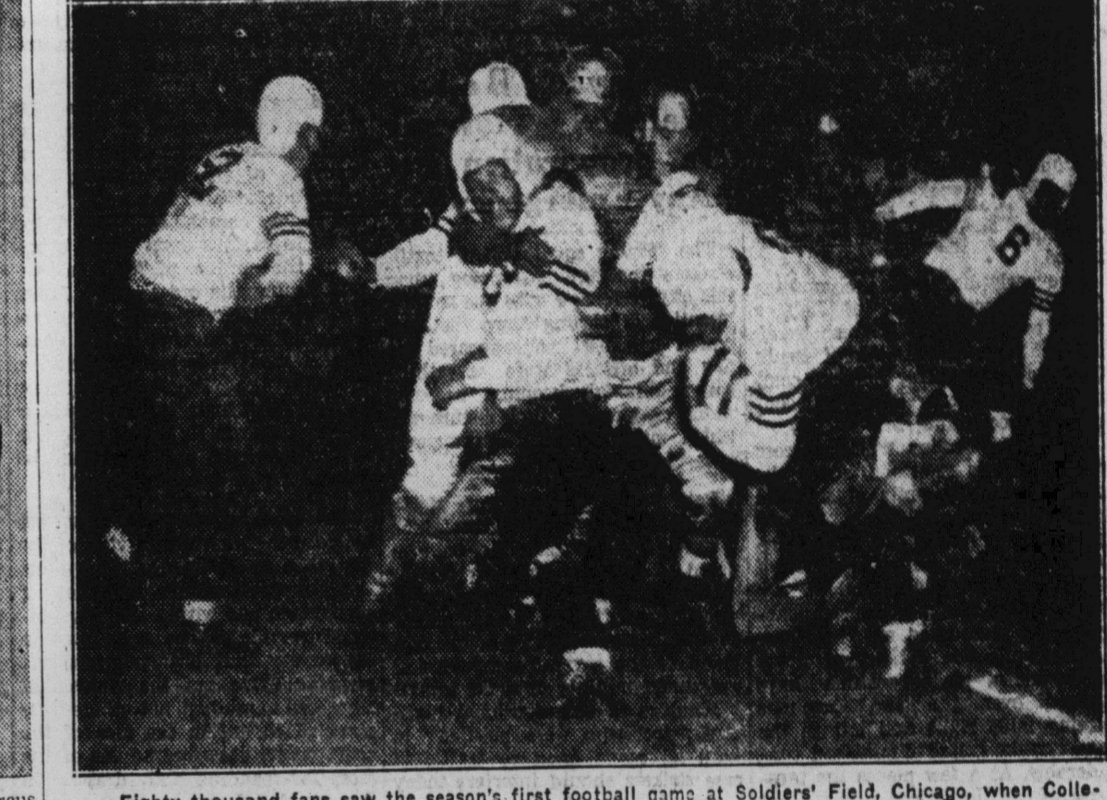

Wounded In Strike Riot That Took Six Lives



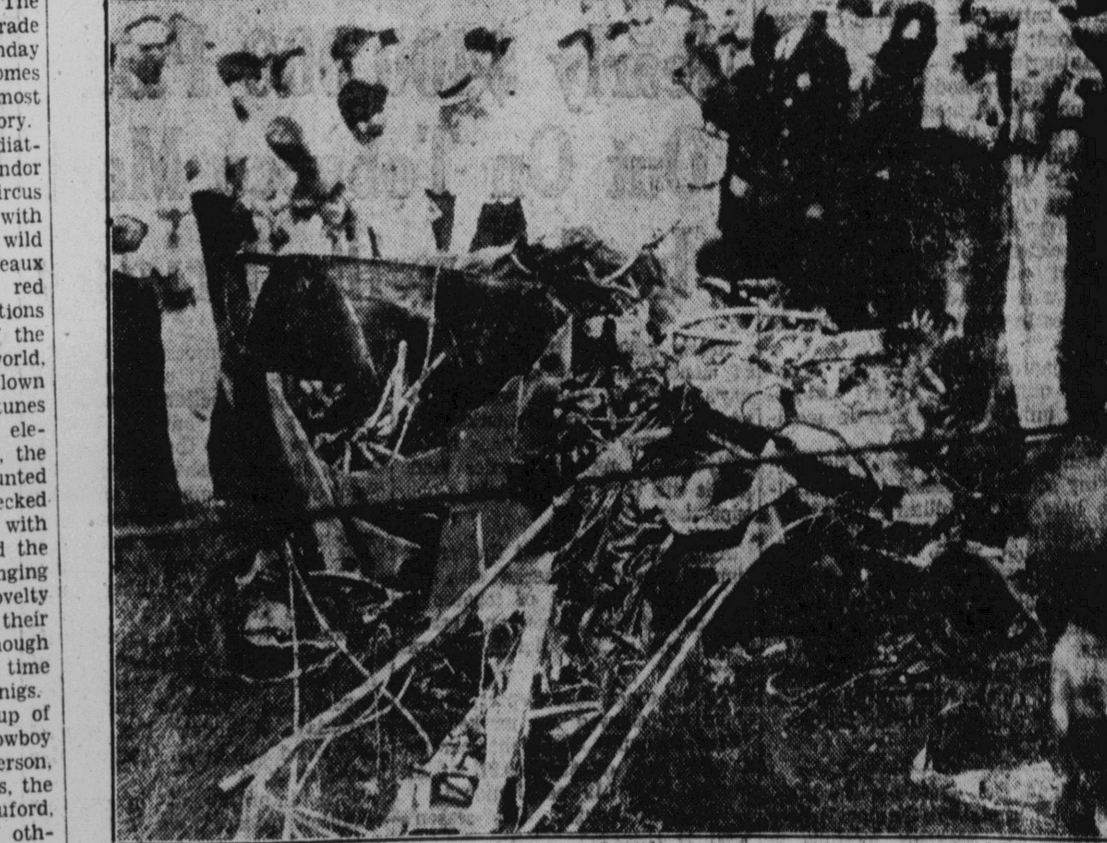

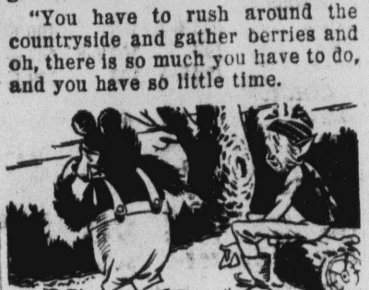

Goldsboro, Sept. 8.—(AP)—The Rev. R. H. Askew, Four Square wasp evangelist, charged with attempted extortion for his alleged kidnaping hoax was ordered held under \$5,000 bond for trial in federal district court at Raleigh Nov. 5, after preliminary hearing here today.

The 29-year-old minister was unable to post bond immediately but it was understood he did so later.

Only two witnesses were heard by U. S. Commissioner L. E. Pearson. They were Sheriff Paul Garrison and C. A. Whitton, agent of bureau of investigation of the Department of Justice, who told of Askew's confession.

The officer told of the investigation of Askew's disappearance on August 13 and the subsequent ransom demand received by his wife and his reported confession made voluntarily after his return.
