

TROOPS BAYONET STRIKERS AT BURLINGTON MILLS

Strike Situation Quiet In Rhode Island Several Injured, Four Arrested In Disorders Today

NOT TO ASK GOVERNMENT FOR TROOPS

Governor Green Declares Situation so Quiet During Night Troops Not Needed; General Assembly to Be Asked for \$200,000 to Carry on protective Work

Providence, R. I., Sept. 14.—(AP)—Governor Green declared after a conference with Adjutant General Herbert R. Dean this morning that the strike situation in the state had been so quiet overnight "there will be no occasion for calling on the federal government for troops."

The General Assembly which was to meet later in the day in special session was to be requested by the governor to pass measures appropriating \$200,000 with which to swell ranks of the state police and to provide national guards with sufficient funds.

He cited the closing of the Sayles finishing and Wonsocket Bayon Co. as developments which have relieved the situation and accepted the vote of the senate yesterday to give him statutory power to force mills to close as the legislator's final word on the subject.

It was the first meeting of the organization held outside Greenville in some months, and members expressed themselves as highly pleased with the fine reception they were accorded in Winterville.

HUGE AMOUNT PAID FOR LEAF ON THIS MART

Nearly Two Million Dollars Received by Growers During The Past Week

Nearly two million dollars was paid out on the Greenville tobacco market during the past week, the largest sum probably ever paid out by any market for such a period in the history of the tobacco industry, it was revealed today in the weekly report of K. W. Cobb, supervisor of sales of the local market.

To be exact, the market paid out \$1,804,274.17 during the week for 6,638,224 pounds of bright leaf at an average of \$27.06 per hundred pounds.

Million pound days have been the order of the day throughout the week, the report showed, with sales yesterday being given as 1,154,944 for \$315,103.03 at a general average of \$27.28 per hundred pounds.

For the season, the report revealed that the market had handled 16,425,892 pounds for which growers received \$4,409,471.63 at an average of \$26.84 a hundred.

The report for the same week last season showed the market closed because of the marketing holiday which resulted in the federal crop reduction campaign.

For the season last year the report said 2,693,686 pounds was sold for \$273,757.46 at an average of \$101.2 a hundred pounds.

The supervisor said prices for good tobacco yesterday were the highest of the season with the demand from the various companies being very pronounced.

He said there was well over a million pounds on the floor of the various warehouses today with indications that the bulk of the offerings would be cleared up during the late afternoon to make way for continued heavy sales the first of the week.

The price average yesterday was the highest of the past two days, and the upturn produced much satisfaction among growers who watched their tobacco bring prices equal to those prevailing during pre-war days.

Durham, Sept. 14.—The seven persons who were admitted yesterday to Watters Hospital with painful but not serious injuries received in a head-on collision on the Durham-Roboro highway, were reported resting well today by attaches of the hospital.

The driver of one of the cars, P. F. Pope, a Coats lumber man, suffered lacerations about the chest and neck, while Floyd, Jr., and Naomi Woods, children of Mrs. B. F. Woods of Coats, riding with Pope received abrasions about the body.

In the other car were Mrs. Jules Johnson of Reidsville, who received head injuries, Mrs. A. H. Gwynn and her daughter, Ann, both of Reidsville, who sustained fractured jaws.

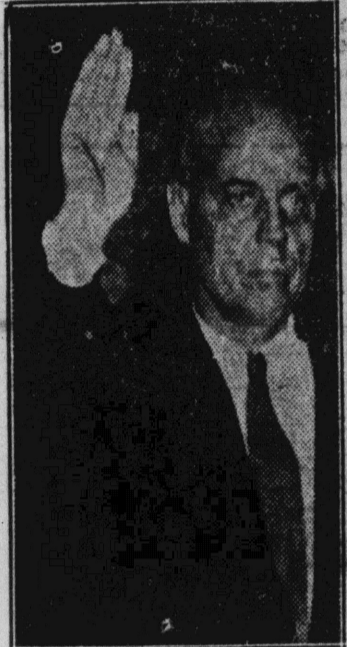

FARMVILLE WINS ACTION

Town Awarded Judgment For \$400 Against J. H. Paylor In Civil Court

The town of Farmville won its suit for a paving assessment against J. H. Paylor, attorney, in the civil term of Superior court here yesterday. The amount involved in the suit was around \$400.

Paylor contended the town could not collect the assessment because the statute of limitation had expired. A point of law was involved here and Judge R. Hunt Parker of Roanoke Rapids took the matter under consideration. He reported to the jury that the statute of limitations had not expired, and the jury after short deliberation returned a decision in favor of the defendant. Paylor appealed to Supreme court.

The case was taken up Monday and was later halted until the presiding jurist could clarify the point of law involved.

Court today was in the midst of hearing in the case of J. F. King against State Bank and Trust Co., and J. F. King and wife against F. C. Harding and others.

Although the two actions were not consolidated they were being heard at the same time as practically the same evidence was involved in each.

The plaintiff contended that the bank used coercion in getting Mrs. King to sign a mortgage securing a \$5,000 debt which King owed the bank. Bank officials and Harding were alleged to have gone to Mrs. King and used their influence in getting her to sign the mortgage.

The bank, on the other hand, contended the transaction was entirely regular and that no coercion was used by any of its officials in obtaining the signature of Mrs. King.

The case was begun yesterday afternoon and was expected to be concluded probably late this afternoon.

A case which probably would have taken two days in clearing from the calendar was compromised yesterday, although terms of the compromise had not been made public today. It involved a suit of S. A. Conleton vs. W. C. Warren and others for repossession of land. The settlement was reached shortly before the case was scheduled to come up for hearing.

SAYS BEER MADE HIM SICK; ASKS DAMAGES

Durham, Sept. 14.—Robert E. Delapp, Rockingham traveling salesman, filed suit yesterday in Superior court here against the Globe Brewing Company of Baltimore, for \$1,500, declaring that insects in a bottle of beer which he drank made him critically ill. Delapp says he bought the beer in a local sandwich shop on October of last year.

N. Y. FIREMAN TESTIFIES AT SHIP INQUIRY

John Kempf Tells Investigators Fire on Morro Castle Started 12:45 A. M.

New York, Sept. 14.—(AP)—A New York City fireman, John Kempf, declared today that as early as 12:45 A. M. (EST) last Saturday morning he smelled smoke on the liner Morro Castle.

Other witnesses have reported discovery of the fire which destroyed the ship shortly before 3 A. M. (EST). Dickinson Hoover, head of the department of commerce board investigating the marine catastrophe commented: "You are the first one to place the time of the fire at 12:35."

The witness said he thought he was correct in giving that time, that he smelt smoke but that the fire was not discovered until later.

Hoover observed that as a fireman Kempf's testimony was "expert" and "extremely valuable."

Kempf said after he went up deck he saw very few ship's officers "I began ordering myself."

The foreman's testimony caused much laughter among his questioners. He was very vague about nautical terms but definite in his ideas concerning technique for extinguishing fire on ship.

PREPARES TO SEND TROOPS TO MILL ZONE

President Roosevelt Watches Situation in Rhode Island as he Boards Yacht

Poughkeepsie, N. Y., Sept. 14.—The possibility that President Roosevelt might take a hand in the strike troubled section of Rhode Island developed today as he boarded the yacht Normahal here for Newport to attend the American cup yacht races.

The president announced he would confer tomorrow at Fort Adams, R. I., with Secretary of War Dorn and Major General Connor, head of the first corps area.

On the outcome of this conference will depend whether the president will witness the first of the international races or go aboard a destroyer for Providence to take direct command of the strike situation.

The president said should the legislature by any chance see fit to ask for federal troops Dorn and Connor are both at Boston and would be ordered to proceed immediately for a survey of the strike area and to report direct to him.

WATCHMAN IS SHOT IN TILT OVER WALKOUT

Gaffney Man Shot by Dance Hall Operator Over Remarks Concerning Strike

Gaffney, S. C., Sept. 14.—(AP)—George McCraw, night watchman at the Limestone and Hamrick mills was shot and killed early today by Dock J. Parrish, operator of a dance hall.

Deputy Sheriff E. E. Lemmons, said the shooting followed a brief exchange of words concerning remarks McCraw is alleged to have made about Parrish in connection with the strike.

Lemmons added he was told McCraw denied having said anything about Parrish before the fatal shot was fired.

Parrish, Arthur Higgins, employees of the Hamrick Mills and Fred Curtis, are being held in the Cherokee county jail, Lemmons said.

Higgins and Curtis, officers said, were present when the shot was fired.

JESSE DUDLEY IN JAIL HERE

Colored Man Wanted For Slashing Deputy Sheriff Returned Here Last Night

Jesse Dudley, colored, who has been the object of widespread hunt the last several weeks for viciously stabbing Deputy Sheriff Herbert Harris on the Farmville road, was in the Pitt county jail today awaiting preliminary hearing on a charge of assault with intent to kill.

The negro, arrested at Fuquay Springs night before last, was returned to Greenville late yesterday afternoon by Sheriff Sam Whitehurst and Chief of Police George Clark.

The officers said the negro admitted he was the man who nearly cut the deputy to death on the night of July 28, declaring he didn't know the officer and thought he was a drunk.

Dudley was also said to have admitted he was the man wanted in Greenville for the stabbing when taken into custody by a constable at Fuquay Springs.

Sheriff Whitehurst said this morning the date for the preliminary hearing had not yet been set but expressed belief it would take place sometime next week.

After cursing Deputy Harris, who was looking for a wreck on the Farmville road, Dudley allegedly drew a long knife and inflicted deep wounds on the officer's neck, back chest and shoulders. The negro then fled and nothing was heard from him until taken into custody at Fuquay Springs.

Cut off from his gun in the car, the officer was unable to defend himself as the negro launched the murderous attack. When the negro fled, Harris jumped in his car and went to Farmville, being later returned to Greenville for medical aid. He was able to return to work about two weeks ago.

NEW COMPANY OF SOLDIERS SENT TO AREA

Troops Sent To Biddeford Strike Sector

August, Me., Sept. 14.—(AP)—A provisional battalion of Maine national guardsmen was ordered to the textile strike area in Biddeford today, "as a precautionary measure against flying squadrons."

Additional Protection Thrown About Mills as Operations Are Increased; Not a Mill Reported Closed by Strikers And Not one Reopened After Being Closed Last Several Hours; 103,000 Workers Idle in Carolinas

Burlington, Sept. 14.—(AP)—Several persons were bayoneted and four arrested in the Holt Weave mills here today as national guardsmen used tear gas and bayonets to disperse a large crowd of pickets. The mills continued operating.

The number of those wounded by bayonets and the names of those arrested was not known.

A company of soldiers under Captain Fountain arrived from Raleigh early today as the mills increased operations to what officials termed 85 per cent normal.

Charlotte, Sept. 14.—(AP)—A clash between soldiers and pickets at Burlington in which five persons received slight bayonet wounds today marked an otherwise quiet strike section in the two Carolinas.

For the first time since the textile strike call was issued September 1 not a mill was reported closed by strikers and not one reopened after having been closed.

The Associated Press tabulation of the strike situation in the Carolinas revealed 296 mills closed, 289 operating and 103,035 workers idle and 100,735 known to be at work. In addition 167 mills in North Carolina and 9 in South Carolina were known to exist but unreported were believed to be operating in the main.

ALLEN HELD IN RUM CASE

Colored Man Taken Into Custody Last Night With Big Supply of Whiskey

Jim Allen, colored, was in jail here today awaiting hearing on a charge of possession of whiskey for the purpose of sale.

Allen, described by police as an old offender of the law, was taken in custody last night at his home in the western part of the city. Seventeen and a half gallons of whiskey were said to have been found in his house, secreted about in different places.

Allen will be given preliminary hearing in the regular session of police court tomorrow morning and probably will be bound over to County court.

Chief of Police George Clark said the negro had served several terms on the roads for violation of the prohibition law. When police walked into his home this morning they were not surprised when they found a large supply of liquor and Allen apparently was not surprised at their visit. He has become used to the law and the law has become used to him, and both probably will know more about each other after the prisoner completes serving the road term awaiting him in this last case.

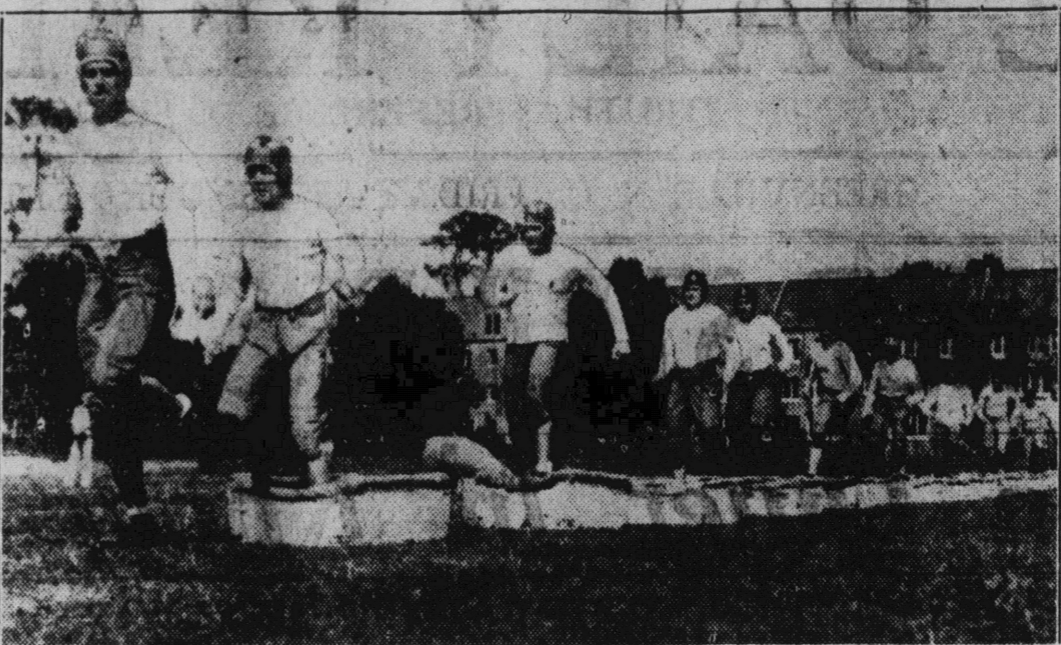
LACK OF ENDS AND TACKLES WORRY WADE

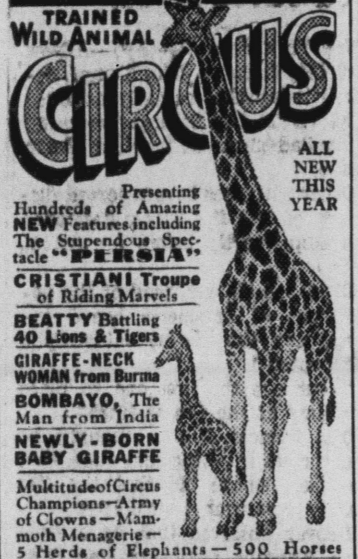

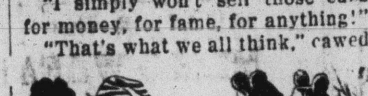

COLLEGE WILL OPEN SEPT. 25

Largest Enrollment in The History of E. C. T. C. Anticipated This Year

East Carolina Teachers College will open its twenty-sixth session on September 25th, this year. September 25, and 26, have been set aside for the registration of Freshmen, and September 27 for the registration of upper classmen. The outlook is for one of the largest enrollments in the history of the college. The applications now in the office are considerably ahead of the number on file at this date a year ago.

For several years the enrollment has been quite uniform throughout the three quarters of the regular school year, at around 900 students. The largest enrollment in the history of the college was during the fall quarter of 1930 when 922 were enrolled.

Dr. L. R. Meadows, Acting President, has been associated with the college since the summer of 1910, and is consequently well acquainted with every phase of the work of the institution, and thoroughly capable of directing its progress. Since the close of the past summer session he has been spending a short vacation in Tennessee and Louisiana.

Very few changes will be made in the faculty personnel next year. Miss Jessie Mack, of Roebling, New Jersey, takes the place of Miss Catherine Cassidy in the Science Department. Miss Cassidy is spending the year in Columbia University, working on her Doctor's degree.

Doc Matthis, of Davidson College has been employed to coach men's athletics, and for some weeks has been getting in touch with the situation on the campus and in the Coastal Plains section. The outlook is that the college will have a good year in athletics. Practically all the members of last year's athletic teams are returning for further work in the college. Among those returning are James Johnson of Raleigh, Jack Humphrey of Beaufort, Francis Jennings of Elizabeth City, Baxter Eidenhour of Cooleemee, Theo Eason of Spring Hope, Bill Puckett of New Bern and Rufin Davis, of Beulaville.

The athletic field was greatly improved last year and bleachers for about a thousand spectators were constructed. This, with the construction of six new tennis courts has spruced up the college excellent facilities for athletic sports, both indoor and outdoor.

Three members of the faculty toured foreign countries during the past summer. Miss Katharine Holstlaw of the Home Economics Department was in Cuba. Dr. Alice Lucile Turner of the English Department and Miss Lois Gorrell of the Music Department spent the summer in Europe.

H. C. Haynes of the Education Department and Beecher Flanagan of the Economics Department completed the work for and were awarded the Ph. D. degree by George Peabody College for Teachers at Nashville, Tennessee, this summer. The college Placement Bureau has placed a surprisingly large number of teachers during the past three months, in spite of the depression and the fact that there has been a tendency for persons having employment to stick closely to their jobs. This is accounted for in part by the fact that many teachers are leaving the profession for other employment where the pay is higher.

The beautification program which has been carried on during the past three years under the direction of Prof. M. L. Wright has given East Carolina Teachers College one of the most attractive campuses in the state. Sidewalks have been rebuilt, driveways improved, much shrubbery placed artistically about the buildings and elsewhere on the campus, and four beautiful gray stone entrances have been built at the entrances on Fifth Street.

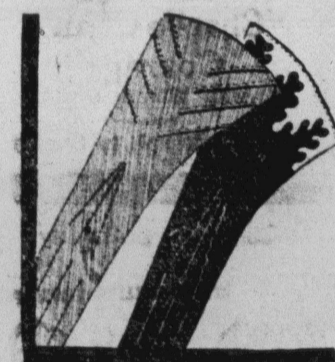

New York, Sept. 14.—(AP)—Cotton futures opened barely steady 3 higher to two lower with steadier Liverpool cables offset by the textile strike situation.

Trading was comparatively quiet later in the morning and attention seemed to center largely on the further narrowing of differences between the new and late months and switching from near to late positions.

Prices held within a comparatively narrow range with December holding around 12.97 and May at 13.07 at midday, or about net unchanged to three lower.

N. Y. Stock Market

New York, Sept. 14.—(AP)—The declining trend in the financial market picked up a little more speed today as stimulus for the recovery appeared to be lacking. Stocks after turning listless in the morning started down around noon and in the subsequent brisk movement prices dropped one to three or more points with a few issues losing much more. A little support appeared later however, and some of the more depressed shares rallied mildly.

Grains suffered a relapse of one to three cents a bushel and rubber was under pressure.

There was no special news to account for the selling flurry in the various markets. Although the textile labor situation was still cloudy President Roosevelt was said to be hopeful. It was announced though he would confer tomorrow with Secretary of War Dern and other regular army officials on the Rhode Island disturbance.

The late tone was heavy. Transfers were 750,000 shares.

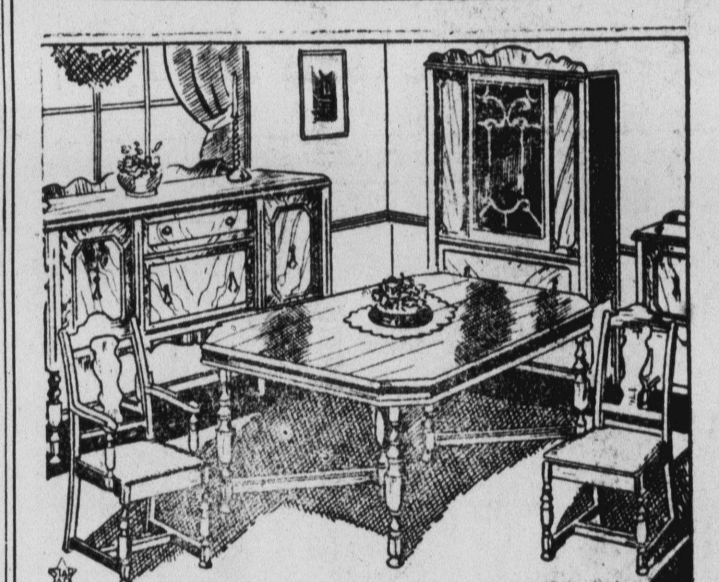
