Textile Strike Is Called Off Today

Hundred Miners Killed In Mine Blast In Wales

RESCUERS ARE HALTED BY GAS AND FLAMES

Fifteen Bodies of Miners Working Near Shaft of Greford Colliery at Wretham Recovered; Three-Fourths of 400 Men Employed Two Miles Under Ground Rescued; Clergymen Assist in Rescue Task

Wretham, Wales, Sept. 22.—(AP)—Hope was abandoned at dusk today for the one hundred coal miners caught in an explosion and fire in the Greford Colliery. Rescuers worked all day to enter the pit but were unable to reach the men.

They were trapped nearly two miles from the mouth of the pit in which they were working. Rescuers, despite the most heroic efforts were unable to penetrate the wall of flame and poisonous gases which barred their task.

Two men of a rescue party were carried out unconscious and died at the surface.

Fifteen bodies of miners who had been overcome close to the pit entrance were recovered.

Nearly three-fourths of the 400 miners below the surface at the time of the explosion escaped.

The blast occurred in the section known as The Dennis Main Deep, ranging from 800 to 1,200 yards below the surface.

Five of the men who escaped from the explosion spent nearly an hour climbing the narrow air shaft three hundred feet to the surface level from where they had been working.

At the pit mouth stood miners' women. It was pouring rain but they paid no attention. Now and then one was seen to faint, collapsing into the pools of water in which they stood.

A number of clergymen assisted in filling the sand bags which were being carried down to fight the fire. One of the clergymen was crying quietly as he worked. Two of his boys were trapped in the mines.

MILLS HELD IN RUM CASE

Shelmerdine Community Man Arrested On Charge of Transporting Whiskey

Simon Mills, of the Shelmerdine community, was scheduled to face preliminary hearing this afternoon on a charge of transporting liquor.

Mills was taken into custody at Galloway's Cross roads by Constable C. W. Evans. Evans said today he found a half gallon of whiskey in Mills' automobile.

Mills gave bond for \$100 pending hearing set before N. A. Clark, Black Jack magistrate.

The defendant probably will be bound over to the next sitting of County Court.

WORKERS TOLD TO GO BACK TO WORK MONDAY

Russellville, Ky., Sept. 22.—(AP)—The South Deposit Bank of Russellville was robbed of \$10,000 in negotiable bonds and \$7,704 in cash today by two shabbily dressed men who tied up four persons and slugged another into unconsciousness.

Columbus, Sept. 22.—(AP)—Harry Pierpont and Charles Makley, Dillinger gangsters, awaiting execution in the Ohio penitentiary, were shot in their cells of the prison today.

DISCONTINUE ERA PROJECTS

Activities in N. C. Abandoned Due to Improvement in Employment Situation

Raleigh, Sept. 22.—Due to the seasonal increase in farm employment in harvesting and marketing cotton, tobacco and other crops all work projects under the NCERA in rural sections of the state will be discontinued immediately.

Mrs. O'Berry, State Relief Administrator, announced today.

Mrs. O'Berry said that hundreds of calls for farm workers have been made at local relief offices by private employers during the past several days indicating the need for work and direct relief to care for unemployed farm workers has declined sharply.

The state administrator said that all farm workers in the state classified as "employables" will be removed from the relief rolls not later than September 26.

"During the height of the harvesting season," Mrs. O'Berry said, "when the need for additional farm workers is so urgent, the need for work projects and direct relief to care for unemployed people is reduced to the minimum."

"With few exceptions, we are suspending all work projects in the rural areas and removing farm laborers from relief rolls in order that farmers and others offering private employment may be assured adequate help during the harvesting season."

Work projects to be expected are those dealing with the handling of the 100,000 cattle brought into the state from the drought-stricken areas of the mid-west and the canning projects.

Mrs. O'Berry said the discontinuance of work projects and the removal of employable people from the relief rolls is in line with the administration's general policy of rehabilitation.

"We make every effort to see that our relief clients return to private employment where they may continue in the work in which they have been trained, or work which they have been accustomed to, when the employment is available. We believe employment now is available to the large majority of farm workers on our rolls."

Mrs. O'Berry said that relief for unemployable people will be continued as usual.

Washington, Sept. 22.—(AP)—The United Textile Workers Union today ordered an end to the most serious strike in the history of the industry and instructed workers to return to mills Monday morning.

In the presence of William Green, president of the American Federation of Labor, and other high ranking officials of the union, Frank Gorman, chairman of the strike committee, announced:

"We have now gained every substantial thing we can gain in this strike. Our strike had torn apart the whole unjust structure of NRA, lifting a load from all labor as well as from ourselves."

By telegram the strike committee sent the following message to all local unions:

"By unanimous vote of the council your heroic strike ends in complete victory as of tonight. Full reports will be mailed at once to all local unions. Our triumph is one of the greatest in all labor history and our officers salute you and congratulate you. Return to work Monday morning as orderly as you walked out. Conscious of having won your rights, determine to maintain the same fair discipline displayed in battle. Now in all efforts everywhere to complete organization of every worker in the industry."

"Washington headquarters will be maintained permanently and from here we shall at once begin work to see that the Winant board recommendations are fulfilled completely."

"Organization campaign will be directed from this office and you will receive instructions at once. New series soon. All strike instructions are hereby cancelled and the strike is declared off."

Surrounded by a group of textile leaders, many of whom had taken part in the strike that raged from Maine to Alabama, Gorman said:

"We have accomplished definite things. And end to the stretchout; a method of determining hours on the basis of fact; a method of determining wages on basis of fact; practical recognition of our union and reforms in the way administration of the labor provisions of the code on a scale so sweeping we must consider ourselves surprised at the character of the victory we have won."

FOUR FLIERS DIE IN CRASH IN ENGLAND

Refuelling Plane Wrecks After Supplying Fuel For India-Bound Plane

Aylesbury, England, Sept. 22.—(AP)—Four fliers were killed today when their airplane with which they had refueled Sir Allen Cobham's plane as he started out on an attempted non-stop flight to India crashed in flames on the main London highway near here.

The plane was equipped as a gas tank twenty miles out from Portsmouth over the English Channel the fliers had poured about one hundred gallons of gas into Sir Allen's ship.

The pilot of the refuelling plane was C. H. Bembridge, a former Royal Air Force man, who was accompanied by three mechanics.

Following the refuelling operation, Bembridge returned to the Histon airfield, landing long enough to permit a press association reporter to disembark. The fatal crash occurred as the plane proceeded toward the airfield at Coventry.

Plans to employ one hundred persons by the SERA near Yuba City, Calif., to dry peaches as a means of providing employment and furnish relief supplies for winter were suspended due to inability to secure labor for the project.

TOLL OF DEATH FROM TYPHOON MOUNTS TODAY

1,650 Lives Lost as Screaming Gale Wrecks Manufacturing Centers

Tokyo, Sept. 22.—(AP)—Shaken by the ravages of typhoon, described as the second worst catastrophe in modern Japan, the Empire today counted at least 1,650 dead and the manufacturing areas laid in ruins.

Ripening fields of rice fell before the screaming gale in the far areas and officials estimated the crop would be reduced twenty per cent.

Early estimates of the property damage ran to more than \$300,000,000, a serious threat to the Empire's ambitious industrial program.

The newspaper Asahi described the typhoon's material damage as second only to that brought by the earthquake of 1923.

Information available at the United States embassy indicated no Americans were injured or suffered serious losses.

Late News Flashes

Note In Kidnap Case. New York, Sept. 22.—(AP)—The dramatic story of a note in code allegedly sent by Brun Richard Kaupmann to an unidentified person and signed, "Will kidnap Lindbergh baby," was injected into the case against Kaupmann today.

Warden Preston Thomas of the Ohio penitentiary disclosed the statement in the Lindbergh case immediately prior to the sensational attempt to break from prison by two convicts. The warden had summoned newspapermen to his office in the penitentiary and the reporters were present when the alarm sounded.

Two prisoners sent to the electric chair attempted the break with the aid of imitation pistols made from soap. One was killed and another seriously wounded.

PRICES STILL BOUND UPWARD ON LEAF MATT

High Price Average of The Season, \$31.25, Recorded Here Yesterday

Skyrocketing tobacco prices continued their upward flight on the Greenville tobacco market yesterday and the highest price average of the season was recorded. K. W. Cobb, supervisor of the local market, made known this morning.

The day's average was given as \$31.25 per hundred pounds as against \$31.23 per hundred, the former high average set by the market last Monday.

The report of the supervisor also revealed that the market handled 1,295,218 pounds of leaf and paid out \$404,794.98.

Between four hundred thousand and a half million dollars has been paid out to growers daily the last two weeks, and yesterday's sale placed the total amount of cash paid out by the market this season very near the seven million dollar mark.

Seven million dollars in figures doesn't sound like so much money, but distributed among the thousands of growers who sell here from day to day it plays a tremendous part in improving the general business condition of the territory.

Farmers, who two years ago were so far in the hole they thought they would never get out are beginning to see the light of day again as result of the splendid prices prevailing on the tobacco market now and the end of the season should see them with a majority of their old debts paid and a comfortable balance in the bank.

In spite of the fact that yesterday's sale was one of the heaviest of the season floors were virtually cleared around 4 o'clock and wrecks and factorymen immediately turned their attention to the reception of continued heavy offerings the first of the week.

Sales held up marvelously the last several days in spite of rain both night and day, and the farmers were fully rewarded for marketing their tobacco by continued mounting prices, especially on the better grades.

W. L. Wall Dies At Hillsboro

News was received here today of the death in Hillsboro last night of W. L. Wall, father of Mrs. H. A. Bost of Greenville.

Mr. Wall, 90 years of age, had been in declining health for a number of years and death followed serious illness of the past several weeks.

Mr. Wall will be remembered by numbers of Greenville people, he having visited here quite a number of times. He was a member of one of the prominent families of Hillsboro and news of his death was received with sadness.

Mr. and Mrs. Bost and Mrs. and Mrs. W. S. Bost left today for Hillsboro to attend the funeral which probably will be held Sunday afternoon.

Scrap Tobacco Sales Procedure Explained

Sale of scrap tobacco by contracting producers must be entered on allotment cards and must be covered by tax-payment warrants, according to information received from the Tobacco Section of the Agricultural Adjustment Administration. Scrap tobacco, if sold from a crop grown under a tobacco contract, becomes a part of the grower's allotment. If the tax is paid on sales of any part of a contracting producer's crop, it will be in violation of the terms of the contract.

A bill of sale should be obtained by the grower if he sells scrap tobacco to dealer in leaf tobacco or a processor of tobacco. The producer must then take the bill of sale and his allotment card to an agent of the Secretary of Agriculture issuing warrants at a warehouse. The agent will make the necessary entry on the allotment card and issue a tax-payment warrant covering the sale. The bill of sale, with the tax-payment warrant attached, is then returned to the purchaser.

Dealers and processors are required to file monthly returns showing all purchases of tobacco, including scrap, at the office of the Collector of Internal Revenue. Dealers in leaf tobacco, including warehouses and re-drying plants, are required to register with the Collector of Internal Revenue of this district in which they are located. Any person or concern manufacturing or otherwise processing tobacco is considered a processor of tobacco.

If a contracting producer sells scrap tobacco to a person who is not a dealer or a processor, he must obtain a bill of sale, have the entry made on his allotment card, obtain the tax-payment warrant covering the sale, and make the report himself to the Collector of Internal Revenue in his district. Forms and information about the filing of returns can be obtained from the office of the Collector of Internal Revenue of the district in which the producer is located.

A grower violating the terms of his contract through improper disposition of his tobacco may have his contract terminated. If a grower's contract is terminated, he may be required to refund any previous payments in addition to being required to pay tax upon the sale of the tobacco covered by the tax-payment warrants issued to him, according to the Agricultural Adjustment Administration.

The additions to the school buildings at the West Greenville and Fifth Street Colored schools, started by the Civil Works Administration, are not yet completed, but will be completed in a couple of months. Work has recently started again on these buildings. The addition to the High School library has been completed. This addition doubles the size of the present high school library, and gives the Greenville High School, one of the most beautiful libraries in the state.

The teaching force of the local schools has not been changed much since last year. There have been some resignations here, as in all other school systems in the state. Miss Horne, of the French department in the high school, has resigned to take further graduate work. Miss McArthur of the English department has resigned to accept a position in the Congressional Library at Washington, D. C. Miss Mary Langston resigned to take a position in the Goldsboro schools. Miss Dorothy Swenson resigned to take a position in the public school of Evanston, Illinois, a suburb of Chicago, and Miss Elizabeth Higgs resigned to take a position in the schools of Lake Forest, Illinois, another suburb of Chicago. Mr. Roberson, teacher of band and orchestra, has resigned on account of ill health. Miss Corinna Mial, who formerly taught in the Greenville high school, and who recently has been Dean of girls and Assistant principal of the Needham-Broughton high school of Raleigh comes to take the department of French in the high school. Miss Mial is an N. C. W. Graduate and also a M. A. graduate of Columbia University. Miss Deanie Boone Haskett of Greenville takes the English work formerly carried on by Miss McArthur. Miss Haskett has recently received her Master's degree from E. C. T. C.

The work of the band and orchestra will be abandoned. At the present time a man for this position is being considered to take this work.

Some of the text-books have been changed this year by the new state adoption, but most of the text-books are the same as they were last year.

Aged limits for beginning children have not been changed since last year. The State School Commission has forbidden the local school authorities to accept people who are six years old after November 15.

On Monday morning, the elementary school children will be only kept for one hour. The high school children will be kept until approximately 12 o'clock. There will be no formal opening of the schools Monday morning. That will take place later. The principals of the buildings will be the same as last year: Miss Eva Keeter, principal of the Third Street school, and Supervisor of elementary grades, Miss Frances Wahl, principal of the Training school, Miss Agnes Fulllove principal of the West Greenville school; C. M. Eppes, principal of the Fleming street colored school, and Sadie Sautler, principal of the Fifth Street colored school. The Williams school will open with only one teacher, namely Miss Ethel Tucker, who taught there last year.

TRUCK DRIVER ARRESTED

D. A. Andrews, of Wilson, Charged With Driving While Drunk Last Night

D. A. Andrews, of Wilson, driver of a bakery wagon, was arrested by local police last night on a charge of driving drunk and reckless and careless driving.

He was arraigned in police court this morning and bound over to the next sitting of county court.

Police said the man was taken into custody last night when he allegedly drove his truck recklessly around a street corner. He was said to have been under the influence of whiskey and was placed in jail to await arraignment this morning.

ONE OF THREE ABDUCTORS IS SLATED DEAD

Dr. John F. Condon Declares He Believes Isador Fisch Murdered in Germany; New York Detective Investigates Hauptmann's Activities in Germany

(By The Associated Press) New York police started searching for a woman as a possible accomplice of Bruno Richard Kaupmann in whose garage ransom money was found.

Dr. John F. Condon, "Jafsie," expressed belief that there were at least three men in the kidnaping plot and that one of them had been murdered.

Records in Leipzig, Germany, tell of the death there March 29, 1934, of Isadore Fisch, fur dealer, with name and occupation corresponding to the man mentioned by "Jafsie" and referred to by police who interrogated Hauptmann.

Anti-Semitic newspapers in Berlin found ammunition in saying Hauptmann had been arrested in the Jewish quarters of New Jersey. A New York police detective was sent from Vienna to investigate angles of the case in Germany. A handwriting expert gave the opinion to New Jersey state police that Hauptmann wrote all the famous notes including the one pinned on the Lindbergh baby's crib by the actual killer.

The State Attorney of New Jersey said no extradition papers seeking Hauptmann's removal from New York to New Jersey to be tried for homicide had yet been signed, the governors office announced.

Night field glasses from Hauptmann's home came into the possession of the district attorney.

CLUBS TO HOLD MEETING HERE

Get-together of Rotary and Kiwanis Clubs and Chamber Planned Next Week

Plans were being worked out today for a get-together meeting of the Rotary and Kiwanis clubs and the Chamber of Commerce next Friday night, it was made known today by R. L. Powell, secretary of the Chamber of Commerce.

The meeting will be held at the Kiwanis club in the Woman's club building and mayors from several surrounding towns will be invited to attend, it was said.

Although the program has not yet been worked out, Mr. Powell said committees of the three organizations would meet early next week to outline definite plans for the gathering.

Talks by leading business men of the community in all probability will be on the program. These will be short and to the point and the remainder of the program probably will be marked by various forms of entertainment.

NEGRO DISAPPEARS, HAD MONEY ON PERSON

Durham, N. C. Sept. 22.—Local police were today on the lookout for a negro farmer who is believed to have fallen into the hands of the "underworld gang" which operates in the warehouse district during this season.

J. S. Atkins, of Kendell, the negro's employer, told the police here that his tenant has been missing in the warehouse section for the past 36 hours, and that he had a large sum of money with him.

The 50-year-old negro, Nat Baker, came here Wednesday morning, Atkins said. After selling his tobacco, he immediately dropped from sight.

SCHOOL AHEAD—SLOW DOWN!

During the summer months those warnings you see on country roads and in city streets, "School Ahead—Slow Down!" or "School Ahead—Watch Out!" mean little to you. You know the buildings are closed and the youngsters scattered to all points of the compass, and you continue your speed without slackening.

Now, however, those signs have a grave significance. Throughout the country, thirty million children are again picking up their textbooks and readers and getting busy at their schoolwork. The signs are a vital warning to all motorists to watch out for the youngsters.

In spite of the efforts of school authorities and safety workers, automobile casualties still account for more child fatalities than any other accidental cause. Last year, 4,100 boys and girls of school age were killed in such mishaps, and many thousands more were injured, according to statistics.

The evidence underlying the statistics appears to place the blame heavily on motorists, for the youngsters have shown a remarkable ability to watch out for themselves by observing safety rules and principles. In five years, for example, while motor vehicle accidents involving adults have increased 34 per cent, those involving children have decreased 20 per cent.

It has been said that the achievement in the schools is the brightest spot in the entire safety movement. Children can be taught to respect and obey the rules of governing their own conduct in traffic, but they are helpless if careless motorists refuse to cooperate.

Motorists, take care for the school children. The sign: "School Ahead—Slow Down!" is a driving commandment.
