

PRESIDENT SEEKS TRUCE BETWEEN CAPITAL-LABOR

RESCUE SHIPS SPEED TO AID TWO CRAFTS

Steamer Ashore off Massachusetts And Another Crippled off Florida Coast

(By The Associated Press) Rescue ships raced today to the aid of a small steamer ashore off the Massachusetts coast and a crippled liner wallowing in the high seas off the Florida coast.

A third vessel, the liner Lonigstein of the Arnold Bernstein line, carried a fire in her hold several hours yesterday off the coast of Nova Scotia, but the blaze was extinguished. The ship is due in New York Tuesday with 120 passengers from Antwerp and Havre.

Sixty-seven passengers were taken safely from the steamer New Bedford last night after she ripped a hole in her side on a log in Vineyard Sound and was beached on Naushon Island, off Woodshale, Massachusetts.

The captain and crew aboard a fishing craft and a coast guard cutter came to the aid and plans were laid for immediate salvaging of the vessel. The 1,116-ton steamer was bound from New Bedford to St. Mark's vineyard.

The salvage tug Willett set out from New York last night to take in tow the red liner Falcon which lost its central propeller about 355 miles off the Florida coast.

Hauptmann To Face Mental Test Probably Wednesday

MANY MENTAL EXPERTS TO PARTICIPATE

Several Psychiatrists And Not Three to Conduct Examination of Alleged Slayer of Lindbergh Child; Short Affidavits on Which Hauptmann Was Held Dismissed by Court Today; Discharged From West Farms Court

New York, Oct. 1.—(AP)—Several psychiatrists and not three as previously announced will conduct the mental test of Bruno Richard Hauptmann, indicted as extortioner in the Lindbergh kidnaping case, District Attorney Samuel F. Kelly announced today.

In the meantime short affidavits on which Hauptmann was held prior to his indictment were dismissed by Magistrate William Klapp in West Farms Court today. Hauptmann was not brought into court for the mental proceedings which required only about half a minute.

On the same facts and law as recited in the short affidavit before this court, Assistant District Attorney Andrew McCarthy told the court, "the defendant Hauptmann was indicted by the Bronx County grand jury and is now awaiting trial. "In view of the fact, I ask that the short affidavit be dismissed and the defendant be discharged from this court."

Magistrate Klapp signed the dismissal without comment. The courtroom, only partly filled, was in sharp contrast with the scene of Hauptmann's arraignment when not a bit of available space was vacant. Foley said the mental examination of Hauptmann probably will take place Wednesday.

COUNTY COURT READY TO SIT

Docket of Thirty or More Cases Scheduled For Hearing Here Tomorrow

The stage was all set today for the regular sitting of County Court here tomorrow morning, the first session of the past two weeks because of the one-week term of Civil Court which was adjourned here last Friday afternoon.

J. F. Harrington, Clerk of Superior Court, said this morning around 20 cases had been docketed for the session, but with police and magistrate courts scheduled to sit in various parts of the county today, it was believed the number would be swelled by at least a dozen cases.

Two weeks ago the court had around fifty cases on docket, the largest number in years, but work was completed in slightly over two days. It was during that time that slot machine test cases were disposed of, the court ordering that all mint vending machines operating in the county be closed. Only this type of machine was declared illegal.

The docket for tomorrow will consist largely of charges of larceny, violation of whiskey legislation and last but not least, the ever present automobile traffic violations.

Some of the purse snatchers who have been troubling the community the last several days are also expected to go before the tribunal. This brand of thievery has been giving the police considerable trouble of late, and it is expected the defendants will receive the full penalty of the law when they go on trial.

There will also be a number of minor cases sent up from police courts in other parts of the county, but it is expected the docket will be virtually cleared during the one-day sitting.

ASSAULT CASE IS DISMISSED

Action of Farmville Men Aired in Magistrate Powell's Court Saturday

D. E. Oglesby, cashier of the Bank of Farmville and Farmville agent for a life insurance company, and Judd Waker, assistant cashier of the same bank, had their case of simple assault, dismissed in a hearing before Magistrate R. L. Powell Saturday afternoon.

The warrant for simple assault against these two men was sworn out by W. L. Smith, Jr., insurance agent of W. S. Smith and former resident of Farmville, on last Saturday following the assault on Friday evening before. The case was at first scheduled to be heard before Magistrate John Ivey Smith but, at the request of Ivey Smith was heard before Magistrate Powell.

In dismissing the case Magistrate Powell said that in his opinion it was a matter for State Insurance Commissioner Boney to handle rather than himself. Only State's witnesses testified and neither of the defendants took the stand. It was brought out at the hearing that the assault was the outcome of an incident occurring some time ago involving a prospective insurance customer to whom the Farmville agency sold a policy. Smith said that he learned Walker, who is not a licensed agent, sold the policy and after securing affidavits to that effect reported both Walker and Oglesby to the insurance commissioner, for an infraction of State insurance laws.

Smith testifying that after transacting some business at the bank last Friday he was approached by Walker regarding the charges. Smith says he was asked into the cashier's office and that while there he was threatened with further trouble by both Oglesby and Walker, unless he dropped the charges. He testified that during the course of the argument he and Walker exchanged blows and Oglesby then jumped into the affair and he'd him while Walker hit him two or three times. Finally, he testified he was allowed to go when he offered to withdraw his charges.

He said today, however, he expected to press the charges.

TWO FARMERS KILLED BY CAR

Sam Stroup and Michael Sellers Run Down in Gastonia Area

Gastonia, N. C., Oct. 1.—(AP)—Sam Stroup, 60, and Michel Sellers, 75, Gaston County farmers, were killed last night by the automobile of Red Kiser, 18, who was placed under bond pending an inquest.

The men were walking from their homes in the Tryon community to St. Mark's Lutheran Church when struck. His neck was broken and he died instantly. Sellers was taken to the Lincoln Hospital but died without regaining consciousness.

The two were walking on the side of the road a short distance behind their wives. Meeting them, Kiser drove around the women and came back to his right just in time to strike the men whom he had not seen. His car left the road and overturned but Kiser was uninjured.

Says Good-bye To NRA. Washington, Oct. 1.—(AP)—Hugh S. Johnson said good-bye to NRA employees today and urged them in an emotional, choked voice to give continued loyal support to those who succeed him.

Two thousand workers jammed the Commerce auditorium and both at the beginning and last of Johnson's speech gave him a thunderous ovation.

"It is now time to say good-bye," he said, "I can—"

Johnson's voice broke, his lips trembled, tears came into his eyes. For a minute Johnson tried to control himself but could not and ended with "God bless you."

In his address Johnson spoke of the criticism and "dead cats" aimed at him. But asserted forcefully the principles of NRA were right and would continue to prevail.

He praised highly the loyalty given him by his workers in the 16 months he has been NRA administrator and likened the employees to an "army that fought so well together."

Johnson disclosed that the barrage of criticism hurled at him last May caused him for the first time to consider a plan of reorganization. (Continued on Page Four)

HOLD TRIO IN MONEY GAME

Colored People Given Preliminary Hearing For Attempt to Fleece Public

Three negroes, two men and a woman, were given preliminary hearing in mayor's court here this morning and bound over to the next sitting of Superior Court under bond of \$500 on a charge of conspiracy to rob and embezzle another negro here the latter part of last week.

They were Eddie Smith, Helen Taylor and B. E. Taylor, who told police they were from Detroit, Mich., and recently came to this section. They obtained their release after posting cash bonds of \$500.

They were charged with attempting to pull a slick pocketbook game on Josephine Price, but got in trouble when Josephine let it leak out she was on the road to prosperity through a deal with the three-handed trio. Police were immediately informed and took the three into custody and held them in jail until this morning.

Police from Durham and Wendell came here yesterday to see if they could identify the negroes as participants in similar pocketbook game pulled off in those two cities, but were unable to do so. Around \$2,000 was said to have been fleeced from unsuspecting people in Durham and around the same amount in Wendell.

Chief of Police Clark said today he believed the defendants seized here were members of a band operating in various parts of the State. This belief was expressed in view of the fact that the Durham robbery happened the same day the plan was tried out here with such little success.

"CRAZY DRUNK" SPREADS TERROR. Nashville, N. C., Oct. 1.—"Crazy drunk" Harry Lee, 41-year-old negro, shot and killed his six-year-old son, hunted down and slew a 70-year-old negro man wounded his wife and terrorized an entire neighborhood two miles north of Castalia last night and this morning.

Arrested at 6 o'clock this morning, Lee was brought to the Nash County jail here by Deputy Sheriff John H. Griffin and Chief of Police Walter Cooke.

Flushed with money from several odd jobs during the week, Lee went home in a murderous state of drunkenness Saturday night, his wife told the officers.

She rebuked him for his rough treatment of their son who had injured his head Lee's wife said. He became enraged.

Going outside the house with his shotgun, Lee fired through the window, striking both his wife and son, the negro woman stated.

TRIAL PERIOD OF PEACE AIM OF NEW MOVE

In Radio Address Last Night, President Called For End of Warfare Between Capital and Labor With Government as Umpire; Attempts To Avert Walkouts; Talks Praised by William Green, Labor Head

Washington, D. C., Oct. 1.—(AP)—President Roosevelt applied himself today to a new experiment—a truce to end warfare between capital and labor with the government as umpire.

Acting on a plan he announced in a "fireside chat" to a nation-wide radio audience last night, Mr. Roosevelt expected to summon leaders of the industry and organized labor within a few days. He will seek to have them forego strikes, lockouts or other methods of economic force in a "specific trial period of industrial peace."

He will ask pledges to settle differences by mutual agreement, and failing in that, by the elaborate mediation machinery the new deal has established. Quick praise for the President's speech came from President William Green of the American Federation of Labor. Calling the address "timely, appropriate and impressive," Green said at San Francisco that the "appeal to industry and labor to use the government for co-operative purposes is pertinent."

He expressed the hope that the National Association of Manufacturers will "take the President's request to heart."

As a remedy for this situation we would say to the merchant: Use your local newspaper as your catalog; it is far cheaper than getting out 1600 to 1800 page books. And to the consumer: See your merchandise before you buy and keep your dollars at home. The further you send them away, the longer they'll be in getting back to you.

BUSINESS SHOWS RECOVERY SIGNS

New York, Oct. 1.—(AP)—Business has drawn to the close of the third quarter with belated but distinct signs of autumn pick-up.

Retail trade, still the brightest part of the picture, has in the aggregate held above the levels of last year by a good margin, although wet or unseasonably warm weather impaired the showing of the past week.

The end of the textile strike contributed largely to further expansion of industrial activity last week, although operations for the most part were resumed on a curtailed basis.

Steel, after dragging through the dullest period since the banking holiday, is showing more signs of life each week now, although the industry does not yet see enough business for return to profitable operations before 1935. "Steel" estimates operations for last week at only cent cent of capacity, up 2 1-2 percentage points.

The automobile industry is expected to be in the market for substantial volumes of steel during October but the railroads, normally one of the leading consumers, are still buying as little as possible, and in view of the reduced state of their net revenues, are not expected to change their policy in the near future.

To Push Bonus Payment. Louisville, Oct. 1.—(AP)—Rep. Dwight Patman, of Texas, told the Veterans of Foreign Wars at their convention here that he had already had filed a bill providing immediate payment of the adjusted service compensation certificates.

The Texan said he planned to push the bill as soon as congress is reopened. Payment would be for \$2,200,000,000 in certificates eligible for banking for currency which will be distributed among the veterans.

"We have," he declared "enough gold in the treasury to serve as a forty per cent backing for the \$15,000,000,000 more money than there is in circulation today."

Posse Search For Gangsters. Richmond, Va., Oct. 1.—(AP)—While 1,000 or more officers in Virginia's greatest manhunt chased to dead end, hundreds of tips of the whereabouts of the escaped gangsters, Robert Mais and Walter Lengua, Judge John Ingram who sentenced them to their doom today said he will ask Governor Perry to appoint another judge to sit in a special grand jury investigation of the jail-break.

"Blanks are all we have drawn," said State Police sergeant Short when he was questioned today on the progress in the man-hunt which has blanketed every city, town and highway for miles around since the two men shot their way out of prison Saturday.
