STORM LEAVES DEVASTATION ON WEST COAST

Sixteen Dead and Property Damage Great In Washington and Oregon

Seattle, Wash., Oct. 22.—(AP)—An October storm lashing the coast of Washington and Oregon left at least 16 dead today and huge shipping and property losses in its wake. The gale which reached a recorded velocity of 83 miles an hour had subsided, but two flooded cities, damaged shipping, wrecked buildings, power and communication lines tangled, debris strewn areas and the death list remained. Striking with fury shortly after daybreak yesterday the storm swept over this region all day, subsiding only after midnight. Waters of the high tide flooded the business section and a large part of the residential section of both Gray's Harbor cities, Aberdeen and Hoquiam.

No Serious Wreck In This County During Week End

Pitt County got by a week-end with no serious automobile accidents according to reports of the highway patrol office here today. The only wrecks on record were that of Walter Cherry who badly damaged his car Saturday night when he ran into the rear end of a stalled car on the highway between the city and the fair grounds. According to available information a car driven by D. W. Hill from Rome, Ga., stalled in a traffic line and Cherry ran into the rear end of the car doing considerable damage to his own car. No one was hurt. Another minor accident occurred at the intersection of the Simpson road and the Washington Highway about five miles east of this city when the cars of Hugh Hardee and Herman Porter collided. Each car suffered a smashed fender, but none of the occupants of the cars were hurt. There were within the city two of three minor accidents in which no one was hurt and no serious damage was done to the cars.

Price Sees Roosevelt Efforts To Reassure 'Right Wingers'

The impressive feature of the Washington picture just now is the manifest effort of the administration to placate the "right-wingers"—to reassure business and convince the doubters there will be no disruption of the basic principles of American government.

A month ago many straws were pointing the other way. The liberal views of Donald Richberg appeared wholly triumphant in NRA. Elsewhere there were other indications of a swing to the left which aroused expressions of alarm in the financial centers. The political opposition rose to a charge that Mr. Roosevelt had gone entirely socialist.

Now important bankers and business men are conspicuous among the President's callers, and most of them go away saying things are getting better. The White House hastens to deny reports that further dollar devaluation has been decided.

"Messages of confidence" fill the speeches of administration spokesmen. The TVA announces it will purchase from private industry certain supplies which it was thought would be manufactured in government plants.

To the observant, the change is as apparent as the autumn turning of the foliage from green to gold. Looking Toward 1936? It is difficult to see how this swing can be attributed to any exigency which may have arisen in connection with the political campaign.

The disposition in Washington is to regard the campaign as over. Even the most stalwart Republicans foresee nothing but overwhelming Democratic majorities in both Senate and House. No one sees any reason why the administration should think it necessary to alter its policies now for political purposes.

There is, of course, the other question of purely economic considerations. The September upturn in business was not what had been hoped for. No reasonable official disguises the fact that, however satisfactory the administration may view the political situation, in view of the economic situation is hardly one of complete commonplace.

News Behind The News.

By GEORGE DURNO Washington, Oct. 22.—(AP)—Here's an angle on the Republican charge that federal relief is a form of political first aid to the New Deal. All signs point to an abnormal increase in use of the franchise next month and again in 1936—a direct result of the federal relief system.

Woman suffrage helped jump the presidential vote from 18,500,000 in 1916 to 39,700,000 in 1932—an increase of over 21,000,000 in a 16-year period during which the total population was increased only about 25,000,000.

Right now a great many people who never thought much about the box'ot box before are being made decidedly vote-conscious by relief authorities. Their number cannot be estimated in advance but it will run into important figures.

Proof of permanent residence is a primary factor in obtaining government aid. The easiest way to provide it in many communities is for the needy one to show he is a registered voter. A number of states and city relief administrations ask first for such evidence. Permanency is a factor to keep any given community from being overloaded with transients, whose welfare the government seeks to protect in other ways.

The Federal Emergency Relief Administration is now in the throes of an exhaustive legal research to determine the conditions governing residence and settlement for persons seeking relief in each state. Laws of 20 states and the District of Columbia have already been analyzed. It will take another month to finish the job.

EVANS STREET HOME GROCERY STORE ROBBED

The change left in the cash register had not been touched.

BRITISH LEAD IN AIR RACE TO AUSTRALIA

Mildenhall Airframe, Eng., Oct. 22.—(AP)—All flight records from England to Australia were shattered today when C. W. A. Scott and the co-pilot, the dapper and slight Campbell Black, hurled into Darwin approximately two days, four hours and 22 minutes out of Mildenhall. While the nearest contestant in the England to Melbourne air derby had just taken off 1,688 miles behind the feet Britain's, badly shattered the best previous record for the long trip. This was the journey by Charles T. P. Ulm of Australia for six days, 17 hours and 45 minutes in 1933.

The British landed in Darwin at dusk (6:08 a. m. E. S. T.) to maintain their commanding lead. The veteran Dutch team of Parmentier and Moll was in second place while the American crew of Col. Roscoe Turner and Clyde Pangborn was in third place, 2,210 miles to the rear.

Captain James McMillon and his wife, Amy, apparently tired and disconsolate at Allahabad, India, saw a faint ray of hope to continue in the race as the resources of the entire city were placed at their disposal to fix two damaged cylinder heads.

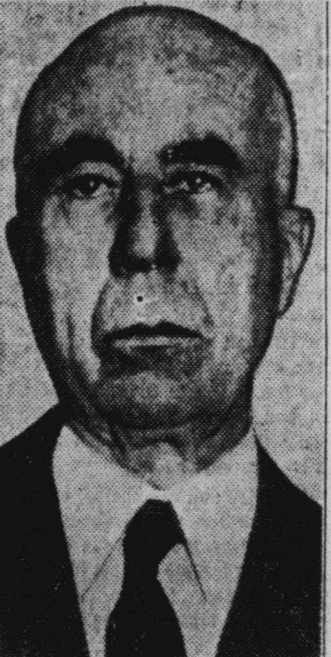

EIGHT KILLED IN ACCIDENTS OVER WEEK END

Airplane Crash, Highway Accidents And Drownings Take Toll in Carolinas

(By The Associated Press) Eight persons were killed in accidents in the two Carolinas during the week-end an Associated Press survey showed today. An airplane crash, drownings took three and three persons were killed in automobile mishaps.

Oscar Womac, 25, of Durham was killed and more than a dozen persons were injured in a series of highway accidents in the vicinity of Raleigh.

Miss Helen Mose and Morris Wilson, of Charlotte, were drowned in Catawba River, near Charlotte, when their motorboat overturned.

The waters of New River, near Verona, were being dragged today for the body of Samuel Cook, Charlotte insurance man, who was drowned in a motorboat accident. Warren Cockersham, 13, of Yacklin, was fatally injured last night when struck by an automobile near Elkin. Mrs. Bertha Bips, 50, was fatally injured near Greenville, S. C., when the automobile in which she was riding left the highway and overturned.

Corpse Remains On Front Porch Day And Night

With nowhere to go and with no one wanting the responsibility of the Hardee, local news, was forced to remain in his box coffin on the porch or the house where he had roomed throughout Saturday night and a part of yesterday before burial was finally made by the county at the County Home.

Hardee died Friday night, and as the story goes, the county did not want the expense of burying him because it was believed his relatives were able to do so. The coffin was procured and Saturday afternoon his body was taken from the house on Clark Street where Hardee had roomed and carried to Cooperfield, negro cemetery, south of this city. Arriving at the cemetery it was found that no arrangement had been made for a plot on which to bury the body and the corpse was returned to the former rooming house. Increased Price Of Cotton Seed More Than Tax

College Station, Raleigh, N. C., Oct. 22.—The increased price of cotton seed this year will more than pay the tax imposed on North Carolina growers this year by the Bankhead act.

The increased income from the sale of cotton seed this year will amount to \$3,946,000, while the Bankhead act will cost North Carolina growers only \$2,179,000, according to Charles A. Sheffield, of State College.

In 1932, before the cotton adjustment program was instituted, North Carolina produced 689,000 bales of cotton. They received a little over \$5 for the seed grown with each bale of lint, or a total of \$3,282,000 for the seed.

This year, Sheffield said, cottonseed is now selling at around 60 cents a bushel, or \$13 for the seed produced with each bale. The forecast of 646,000 bales indicate that seed this year will yield a total income of \$11,628,000.

The Bankhead allotment to North Carolina is 528,000 bales; or 114,000 bales less than will be produced. This means that the tax must be paid on 114,000 bales or else additional tax-exemption certificates purchased to cover them.

Since growers can get all the extra certificates they need at four cents a pound, Sheffield pointed out, the total cost will be \$2,179,000 for certificates instead of the \$3,084,000 which would be needed to pay the tax at 56¢ a pound.

After buying the extra certificates, the growers will have \$6,167,000 more than they had in 1932 from the sale of their seed if they deduct the cost of the certificates from the income from seed sales.

suitable for private investors than for public or private institutions which will be called upon to extend credit in other directions.

But the point is that conservative investment firms—to whom the word Washington was poison not long ago—are willingly bending their efforts to accomplish something the government undoubtedly wanted done.

Financing: That long deferred wave of new corporate security issues may start rolling any time now. Insurance companies and similar institutions are fairly ravenous for fresh investment channels. Their huge load of sterile cash is so much dead weight, and they won't be happy until they can put it to work at a profit.

Then security dealers themselves are at last convinced they can sell securities if they can get them to sell. Three recent trial offerings—Bangor and Gamble and Scoville, Proctor and Gamble and Bangor and Arostook—were snapped up like hot cakes. Of course these don't have to go through the registration mill. The first two were simply a redistribution of securities already outstanding and the last was exempt from registration as a railroad.

The trouble and expense of registration—not the risk any more—is the big stumbling block. But corporate reluctance on this score may be overcome by avid dealers and customers—especially as the Securities and Exchange Commission seems inclined to make things as easy as possible.

Chances for heavy industry come back will be enormously improved once corporations find they can raise money again.

Timing: Governor Lehman has quickly revived his plan to help victims of the guaranteed mortgage collapse by organizing a corporation to loan them money against their defaulted certificates.

He has asked the New York Clearing House banks to cooperate by chipping in jointly with \$2,500,000 of capital for such a corporation. If they do so the RFC stands ready to add \$25,000,000 to the kitty. Formal announcements await the banks' approval. All but two have agreed to go along. The holdouts are stubborn but negotiations are under way to get the others to raise their original ante slightly and fill out the required amount that way.

There are 275,000 certificates holders in the state—infinencing perhaps a million votes. Republicans comment on the beautiful timing of the Governor's move to aid them.

Hedge: Some extremely well-informed New Yorkers are taking an active interest in real estate once more. They view real property as the best hedge against inflation and are firmly convinced that the dollar will be further cheapened—perhaps not immediately but inevitably. The Washington contracts of these sources are such that their views command respect.

GET THEM OFF THE ROAD

North Carolina's all-time record for highway death established last month is not only a record of which the state should be ashamed but is a situation about which something should be done.

For several years we have contended that North Carolina should have a very strict driver's license law that would keep irresponsible and reckless drivers off the road, and to be sure our present rate of highway deaths should convince enough of our people of this to cause the next legislature to take some action along these lines.

No person traveling our highways is safe and then the state permits irresponsible persons to drive automobiles, snuffing out precious lives and doing personal injury and property damage and in the great majority of the cases the drivers are not only reckless and unfit to drive cars but they are likewise financially unable to make any form of retribution to injured persons or for property damage.

Along with a driver's license law the next legislature should make liability insurance compulsory and enough to the cost of the license tag to pay for the insurance. In this way our people would be protected against financial loss at the hands of reckless drivers and the state could gradually get rid of the reckless and irresponsible drivers by revoking their licenses.

It's high time some definite steps were being taken to protect our people.

THE NATIONAL WHIRL... TWO
By JAMES McMULLIN
New York Oct. 22—Money: New York inflationists aren't a bit daunted by sound moneyite rejoicing at the Treasury's call for payment of nearly two billion in liberties next April. Conservatives interpret the move as a virtual guarantee of monetary stability for seven months—but cheap money ad-

vocates confidently hope to turn an apparent defeat into a devastating counter attack.

They figure this way. The object of refunding the Liberties is saving the Treasury money by substituting a new issue paying less interest. That being the case why not save a whole lot more money—and at the same time increase currency in circulation—by invoking the Thomas amendment to retire the entire \$1,870,000,000 in bonds with Treasury notes—greenbacks—which pay no interest at all.

Inflation leaders believe that forceful Congressional thunder early next year could make this proposition sound mighty attractive to the average citizen and perhaps stir up enough clamor for such action to force the administration's hand. Already they're busy offstage organizing the thunder. The situation offers a made-to-order setting for an emphatic demand that Mr. Roosevelt make use of the sweeping monetary powers conferred on him last year by Congress.

Financial insiders expected just such a demand before now—in connection with the payoff of unconverted Liberties on the October 15 call. It's known that some inflationary Congressmen and their backers wanted to make a point of it. Yet nothing happened. Why? mainly because the New York big shots on the inflationary general staff vetoed the idea. They could see no sense in squandering valuable ammunition on the pallid sum of two or three hundred million dollars involved in this payoff when they scented bigger game in the offing. Now the Treasury has set up a target worth shooting at.

Even the staunchest proponents of the idea frankly admit—in private—that the physical effects of adding two billion dollars to the outstanding currency would be negligible. The Treasury notes would probably drive an equivalent amount of other paper money into retirement for no net change in the circulating medium. The inside strategy behind the urge to issue the notes is subtler—to give the dollar a psychological crack on the nose which would scare people into exchanging their dollars for securities and commodities and thereby blow prices through the roof.

Conservatives who have gotten wind of this inflationary pressure plan are worried. They're reasonably sure that FDR won't fall for it but they seriously wonder whether he'll be able to hold the tornado in check. It will be skillfully brewed.

Cooperation: The distribution of \$50,000,000 in Home Owners Loan Corp. 3 per cent bonds this week by a group of investment houses headed by Field, Gore and Co., has a background of Wall Street-Washington cooperation.

The market action of this issue has been somewhat annoying to Washington. Federal agencies have had to step in and buy on occasions to keep the bonds from looking too anemic. It's also reported that New York sources friendly to the administration have purchased H. O. L. C.'s to help out. But both they and the government bodies have too many other uses for their money to want to keep it tied up in a substantial HOLD investment.

The marketing syndicate isn't telling where it got the bonds to distribute. That's guarded as a state

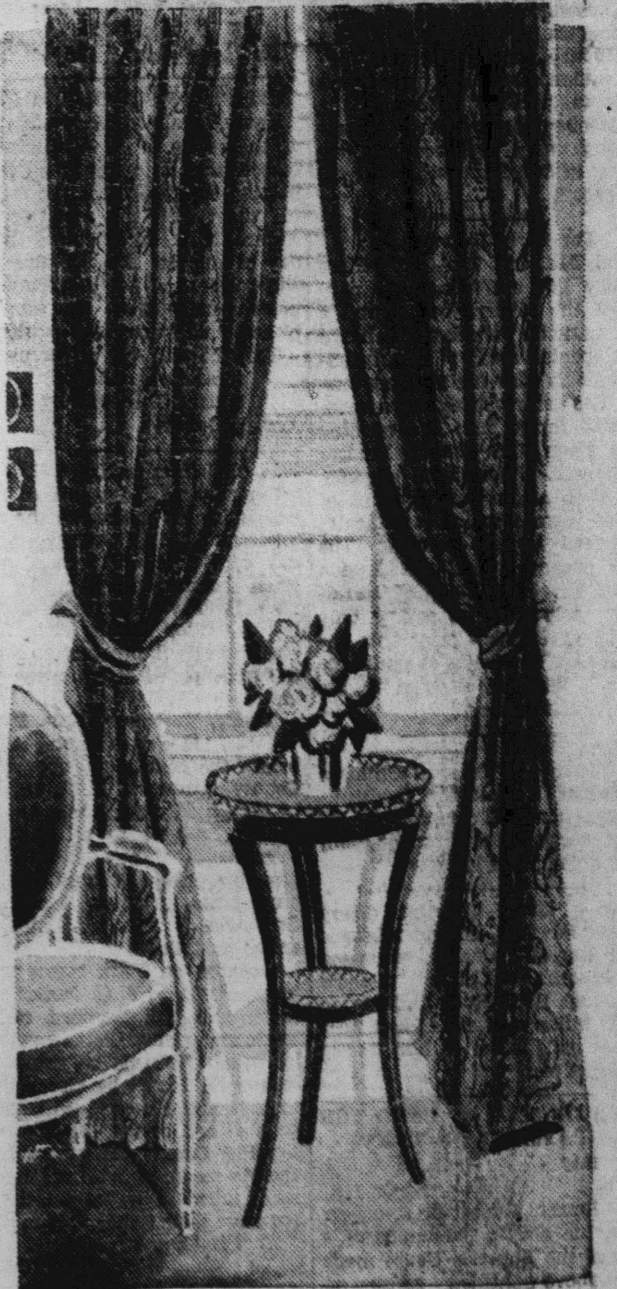

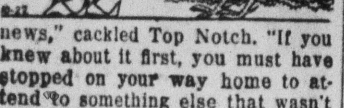
