BRITISH WIN AIR RACE TO AUSTRALIA

Lost Dutch Team Sends Out S. O. S.; American Team in Third Place

Melbourne, Oct. 24. (Wednesday).—(AP)—The flying Dutchmen, K. R. Parmentier and J. J. Moll, with five other persons in their plane were hours ahead of their closest competitors Colonel Roscoe Turner and Clyde Pangborn at midnight and then they became lost in rains sweeping over the high uplands north of the Australian Alps. Anguished Australians on the ground saw clouds dropping from the ship through sodden skies as the pilots wandered in circles trying to locate their bearings. Race headquarters at Melbourne received an S. O. S. wireless message from the ship. No one could go to the rescue but a stream of radio messages were sent up in an effort to help the distressed fliers. Soon afterward came news that Parmentier and Moll had landed safely at Albany about 200 miles from the finish line, only an hour from the home port.

Melbourne, Australia Oct. 23.—(AP)—Two exhausted Englishmen landed their monoplane here this afternoon to end one of the most outstanding flights in history. W. A. Scott, 31, and his partner, Tom Campbell Black, 35, won the \$50,000 speed race to Melbourne, and in doing so set a new record for a long distance flight.

In a drizzling rain their plane crossed the finish line at 3:34 p. m. (3:34 a. m. E. S. T.) seventy hours, 38 minutes and 50 seconds out of Milderhall airbase, England.

Back of them was scattered a field of outstanding pilots, most of them badly beaten in the ambitious 11-

Large Crowd At F. W. B. Revival

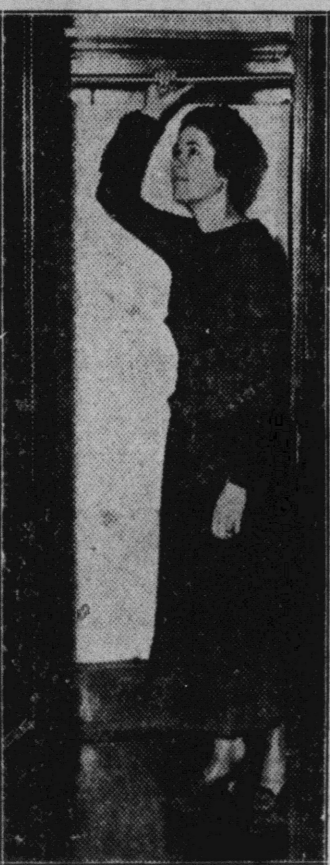

SATTERFIELD HEARING TAKES ON NEW ANGLE

Man Scheduled to Die In Chair Pleads With Alleged Accomplices to talk

Raleigh, Oct. 23.—(AP)—Sensational developments in the case of Rufus Satterfield, Wayne county man scheduled to die Friday for the alleged murder of Herbert Grice, came fast today after Satterfield called Parole Commissioner Edwin Gill to the prison at 2:30 this morning to make a new confession and "tell the truth."

As a result of the new confession Sheriff Paul Garrison of Wayne County, this morning between four and five o'clock again arrested Mrs. Ruth Grice, widow of Herbert Grice and her brother Donald Sasser in connection with the killing. Before the start of the trial the two were indicted in the case but not-prosecuted with leave were taken after Satterfield's conviction.

Sasser and Mrs. Grice were brought to Raleigh by Wayne police and this morning Mrs. Grice was confronted by Satterfield. A newspaper man who entered the room where Mrs. Grice was being questioned was quickly ejected but not before he saw Satterfield sitting directly in front of her with his hands in Mrs. Grice's lap pleading, "Ruth, I am not afraid to die but I want you to tell the truth. I have told the truth of my connection with it." A police officer, thought to be chief of the Goldsboro police addressed Mrs. Grice and told her "If you had seen Rufus when he broke down here at 2:30 this morning, if you could have been here and seen him weeping, you could not withhold your statement a moment longer.

At 11:30 this morning the questioning of Mrs. Grice was still underway with Sasser, who was questioned first, being held in a prison corridor.

Parole Commissioner Gill gave newspapermen excerpts from the new confession which Satterfield made and which directly implicated Mrs. Grice in the slaying and charging Donald Sasser with the actual shooting. Shortly afterward Gill announced that Governor Euringhaus had granted Satterfield a thirty days reprieve.

Portions of the Satterfield statement which Gill released were:

"Donald Sasser and I went there to kill Grice because he had mistreated Mrs. Grice and had threatened her and me and Donald and because Mrs. Grice had asked us to. Mrs. Grice knew all about it. Herbert Grice had mistreated his wife and did not deserve to live. I loved Mrs. Grice and think a lot of her now."

SALES REACH FORTY THREE MILLION MARK

1,261,684 Pounds of Tobacco Sold Here Yesterday For Average of \$35.64

The season's sales on the Greenville tobacco market almost reached the forty three million pounds mark yesterday when the day's sales brought the season's total production to 42,845,144. The money paid out for the season to date is \$13,556,521.96 an average price of \$31.64 per hundred pounds.

Official figures for yesterday's activities show sales of 1,261,684 pounds for \$44,657.83 an average of \$35.64 per hundred.

Despite the fact that sales are falling off somewhat the fact that the market is now at the forty three million pounds mark indicates that the final season's total will reach or pass the fifty million mark.

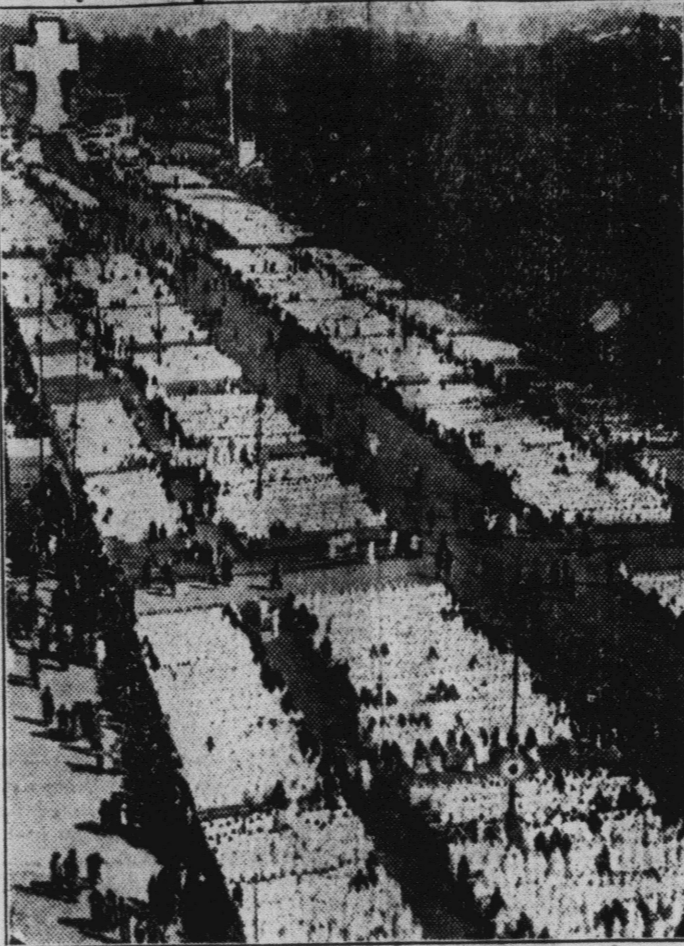
With lighter sales blocks are practically over for the season and growers can get their offerings sold early any day. Warehousemen are urging the growers to lose no time in grading the balance of their crop and getting it to market.

THE NATIONAL WHIRLIGIG News Behind The News.

Washington, Oct. 23.—C. C. C. Practical politicians are beginning to scent gravy in the Civilian Conservation Corps as a juicy patronage outlet. As a result, President Roosevelt may get some unwanted help and advice next January when he moves to have it made a permanent institution.

In addition to the 300,000 young men enrolled in the CCC the Corps maintains about 30,000 civilian employees. This includes 18,000 to 20,000 foresters and 1,200 school teachers. Skilled labor is constantly at work on the many camps. There is a strict rule that enrollees may NOT perform such labor themselves.

About 950,000 enrollees and employees have obtained unemployment relief from the CCC to date. Not less than a million dependents have benefited from the \$120,000,000 in checks sent home by the boys. About \$275,000,000 has also been spent in the purchase of supplies.

FDR is very proud of the CCC. It comes into being as his own special brain child. It succeeded in taking many thousands of boys off the streets and highways who came out of high school to find no jobs open to them. The President has announced his determination to perpetuate the Corps and it seemingly is the one New Deal project which has failed to draw fire of political opponents.

But some of the various gentry within and without his own party have just waked up to all the jobs that are floating around in the organization. This clique thinks patronage could be steered more effectively if the CCC were placed under the wing of one of the established departments of cabinet rank. At present it is a separate emergency setup.

The natural place to put it would be the Interior Department. Secretary Harold Ickes has convincingly demonstrated that he isn't very strong for spoils patronage but the schemers are looking into the future. The Democrats among them figure Ickes may not always be there and the Republicans figure the Democrats won't always be in power.

Resources: When a current survey is completed there will probably be a movement to create a Bureau of National Resources under

the Interior Department which would rule the CCC, the Tennessee Valley Authority, the national park system, oil control etc.

The National Resources Board which is conducting the survey is understood to favor a central authority in Washington. It has very definite ideas about scrapping the old pork barrel system.

Spiesmen are expected to twist this Board's report to their own advantage. It will be up to the President's adroit young brain-trusters to draft a bill for the next Congress that will keep clutching hands out of the cash drawer.

Hours: Organized labor bit off a mouthful when the American Federation of Labor went on record for a universal 30-hour work week at its recent San Francisco convention. It figures to take some time to get the idea nationally massaged but labor big shots might be persuaded to admit privately that the delay won't make them sore.

Back in 1918 the A. F. of L. finally put over the 8-hour day. Years of bitter fighting preceded the victory. Since then they have had no similar

PRETTY BOY FLOYD SLAIN BY OFFICERS

Oklahoma Outlaw Dropped in Tracks As 15 Bullets Tear Through Body

East Liverpool, O., Oct. 23.—(AP)—Charles Arthur "Pretty Boy" Floyd, infamous outlaw whose bullets blazed a crimson path over a dozen States is dead. Armed to the hilt, the braggart, sought as the "trigger man" in the Kansas City union slaying in the slaying of June, 1933, turned tail and ran when the law caught up with him. Fifteen bullets tore into his body, each in the back, as the desperado, listed as public enemy No. 1 since the death of John Dillinger three months ago, was mortally wounded late yesterday at an isolated farm seven miles from here. His nemesis was Melvin Purvis, Department of Justice man who got John Dillinger, aide by three Federal agents and four East Liverpool police.

Hunger driven, Floyd emerged from the Beaver Creek valley in the sparsely settled Brucefield section. He rapped out the backdoor of the house of Mrs. Conkle. He ate. It was a good meal he told the widow, and paid her a dollar. Out in the farmyard he met Stewart Dyke, brother of Mrs. Conkle, who had been husking corn and asked for a ride to Youngsville. Dyke refused, saying he had to go home. I'll take you to Clarkson, though, he told Floyd, and backed up the car. Floyd got into the rear seat and Mrs. Dyke sat beside her husband. At that moment two automobiles loaded with officers appeared. The desperado pulled his gun, jumped from the car and started for a nearby wooded ridge.

"Halt!" yelled Purvis.

Floyd ran.

"Fire!" ordered Purvis, and fifteen bullets tore into the Oklahoma outlaw's body, and he went down fatally wounded.

URGE VOTERS TO REGISTER THIS WEEK

Residents of Seven New Voting Precincts Must Register This Week

Saturday is the last day for voters in the newly-created four precincts in Greenville Township and three in Chicod Township to register in order to be eligible to vote in the election November 6.

Persons living south of Fifth Street and Falkland highway and west of Greene Street, Dickinson Avenue and Kinston highway are in Greenville No. 3 and must register at Pitt Drug Store.

Persons living east of Greene Street, Dickinson Avenue and Kinston highway and south of Fifth Street and Washington highway are in Greenville No. 4 and must register at Greenville Drug Company.

Persons living in the northern section of Chicod Township must register at Grimesland. Persons living in the central and western section of Chicod will register at Cox Mill and those in the lower section of the township will register at L. C. Venter's Store near Shelmerville.

VIRGINIA MAN HELD ON RAPE CHARGE HERE

C. A. Terrell Will be Given Preliminary Hearing Here Tomorrow

C. A. Terrell, alias T. C. Andrews, 34, of Roanoke, Va., will face hearing before Magistrate John Ivey Smith tomorrow on a charge of rape as a result of an attack upon Miss Annie Turner, 23, highly respected young woman of this city. While the attack took place on the evening of Thursday, October 11, the matter has been kept as quiet as possible until the hearing because of the feeling that might be aroused by a case of this type.

Terrell was arrested last Thursday night upon his return to this city and placed in city jail to await hearing. He was one of the two inmates of the jail who were almost successful in an attempted jail break Friday night.

Miss Turner is secretary in the office of D. M. Clark, solicitor for this district, and according to information Terrell visited the office during Mr. Clark's absence from the city, represented himself as a government investigation agent seeking to see the solicitor, and in this manner got into conversation with the secretary. He had stopped at the office door to talk on several occasions during the week while Mr. Clark was away, and on the afternoon of the attack visited the office about the time the young woman was preparing to leave for her home. He asked to be permitted to drive her home and when she got into his car to be carried home, he drove across the river despite her utmost resistance.

After the attack he was said to have offered her \$50 and when she refused he threatened her with violence if she "ever told." He also tried to persuade her to go to Washington with him where as a government agent he could procure her a good job. She refused the offer, but as a last resort, in order to get away from him, she told him she would go to Washington with him if he would drive her home to get her clothes. When the car stopped in front of her home she fled into the house and latched the door upon him.

When Solicitor Clark returned to the city the next afternoon she reported the matter to him and police officers were notified to be on the lookout for Terrell. Investigation revealed that he had been registered at one of the local hotels but had been asked to leave because of misconduct, and that he had left town. Upon his return to the city the following Thursday he registered at another hotel under the name of Andrews and was arrested by officers and placed in jail to await hearing.

Investigation of Terrell's car revealed that same contained two bullet holes.

Auto-Truck Wreck; No One Injured

Erwin Clayton was arrested on a charge of reckless driving growing out of an automobile-truck collision on the highway near Grimesland about eight o'clock last night.

Investigating officers reported that Clayton was driving his car in the direction of Greenville and was well over the center of the highway when his car collided with a bottling company truck from Washington driven by L. B. Nicholas. The truck was said to be traveling in the direction of Washington well over on its own side of the road and with two wheels off the cone at the time of the collision.

No one was hurt in the accident.

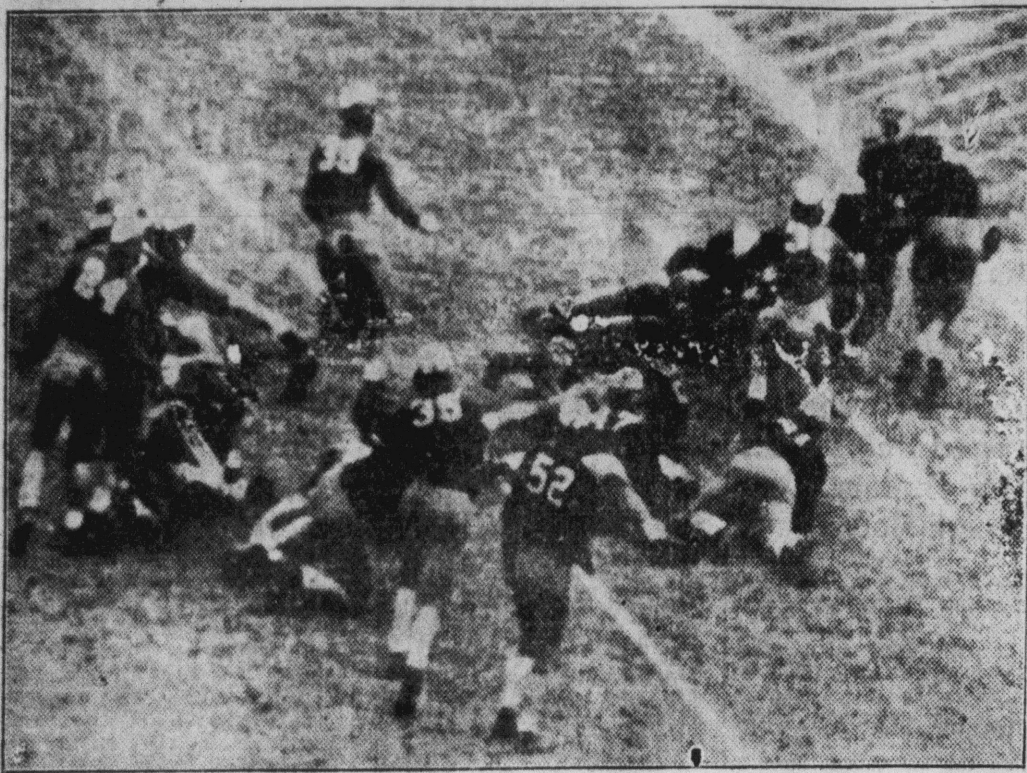

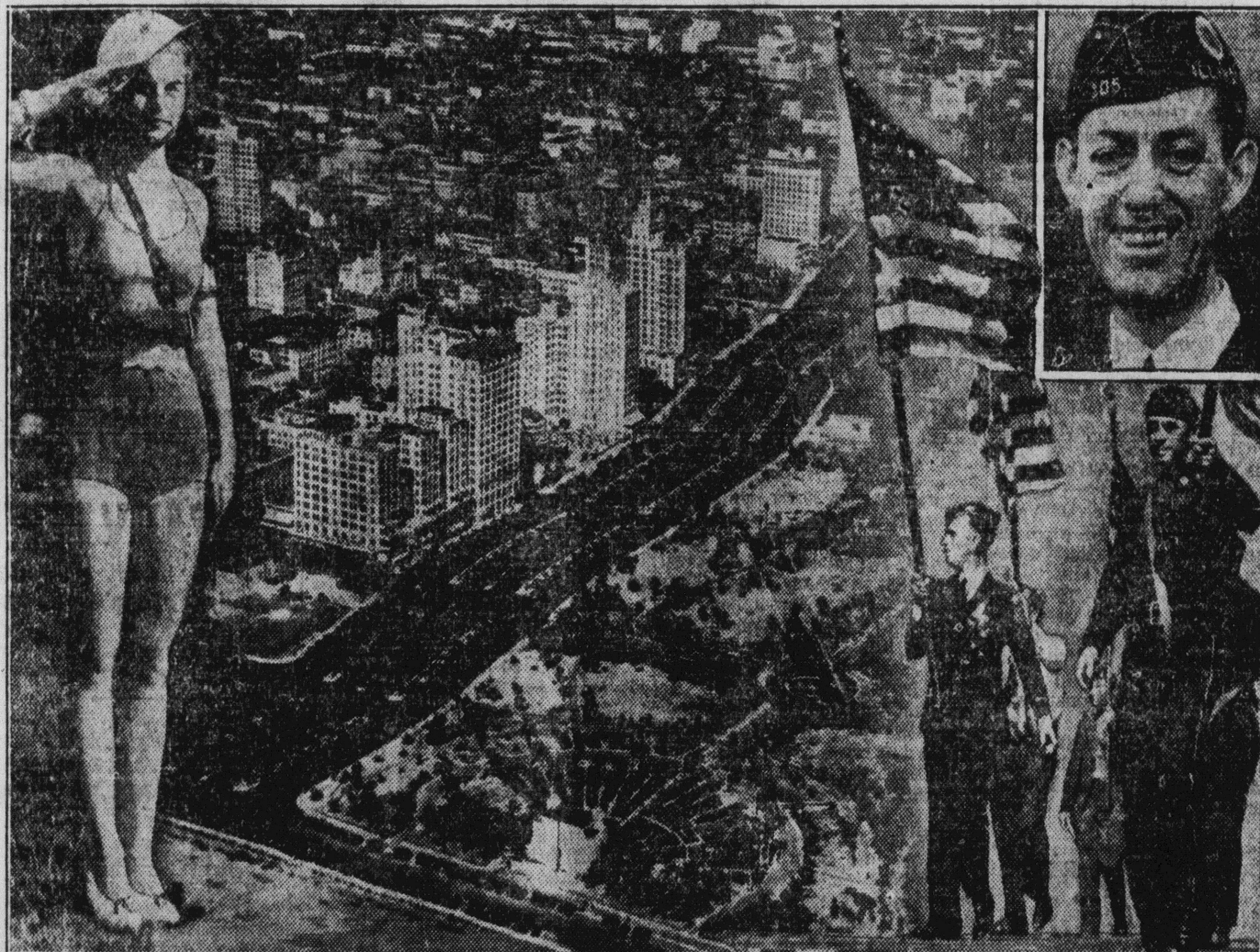

Music Festival Association Growing.
With four directors in the field, training eighty choruses of more than four thousand voices, and with fourteen towns on the waiting list for units, the North Carolina Music Festival Association prepares for its third month of operation.

The Association has as its objective the training of masses of people to sing. It combines the elements of the community sing idea and the choral club plan in its set-up. It affords trained leadership at a minimum cost to the various communities which have units, and through this leadership and the programs which it plans to sponsor during the year, it hopes to stimulate among the people of the state a desire to recapture the lost art of mass singing.

Places for the beginner, the now untrained voice, as well as for the trained singer will be found in the groups being organized in the districts now operating. Sight reading classes are an important part of the association's program. Song instruction courses will also be offered to the more advanced students, and through these classes, it is hoped that leaders will be developed who can extend the work of the association to the most remote rural districts.

In addition to individual chorus programs in communities fortunate enough to possess a unit, each district will have concerts in which all the groups, numbering from ten to fifteen choruses, will be combined in special programs. Then there will be the impressive climax planned for next spring when over 5,000 voices will be combined in a mammoth concert at Raleigh.

Trained directors with outstanding ability and experience have been secured to direct the various activities of the choruses. The four men now in charge of the twenty units that have been organized are all graduates of Westminster Choir School. Other directors will be secured from the same school as rapidly as districts are organized.

At present the association has twelve hundred adult members and 2,800 in its children's choruses. In most instances, the juvenile work is being done through the schools. Weekly meetings are held at which time the directors give fundamental training to the members.

A membership in the association entitled one to participate in all of the association's activities. He or she can sing in the chorus, attend the sight reading class or the course in song leadership, and will be admitted to all unit, district and state functions of the association. This membership costs so little that no one will be barred from joining. In many communities, people who cannot sing, or haven't the time for it, but who are interested in the movement, are taking memberships and sending others to sing in their places.

First Church of Christ, Scientist.

A. A. U. W. Hears Dr. Combs.

Dr. G. R. Combs spoke on "Ballads and Songs of the Kentucky Mountains" before an appreciative audience of the A. A. U. W. members and guests in Ragsdale Hall on Monday night, October 22, with the president, Miss Mamie E. Jenkins, as hostess.

Beginning with Bishop Berkeley's "Westward the Star of the Empire Takes Its Way," Dr. Combs pointed out that the tide of civilization has for centuries moved westward and that as it has swept over our land it has left in the southern mountains a group of people more isolated than any in the world. The folk literature, the folk songs, and the folk humor are the finest medium for understanding these isolated people.

Dr. Combs mentioned the difficulty of creating in a group, so far from the mountains the proper atmosphere for the ballads.

The largest group of ballads flourishing in the mountains, according to Dr. Combs, are those which were brought over from the old world. He quoted one English collector as saying: "There are more English ballads sung in the mountains of America than in England itself. Some of these have been handed down for 300 years or more."

Dr. Combs then sang parts of "Barbara Allen," "The Two Sisters," "Grandma's Carol" and "The Nighthawk." From this group also he sang the humorous ballad "The Spanish Merchant" in which a lover found out why his sweetheart always answered "No."

The lullabies said the speaker, are the most delightful groups of mountain ballads. As an example he sang a lullaby which brought in an accumulative refrain of animal sounds.

As an example of the native ballad Dr. Combs sang "The Moonshiner's Song." He brought out how some of these ballads became popularized and appeared in mutilated form, for example "The Prisoner's Song" heard so often over the radios a short time ago.

Merrily in passing, Dr. Combs spoke of the ditties—little tunes sung with folk games—and told how the leader of the Russian Symphony Orchestra took down one of these tunes for future use.

Dr. Combs, it is said, has one of the most complete collections of mountain ballads and songs in the world. Carl Sandburg visited in the home of Dr. Combs and secured from him several ballads for his "American Song Bag." In his book Sandburg gives Dr. Combs credit for his contributions.

Dr. Combs gave three reasons for his interest in presenting the ballads: 1. To give the inside world a better understanding of the mountain people. 2. To show how the literature in America has had its foundation in the folk literature of the primitive people. 3. To restore to simple homely things their former joys.

lar objective and objectives are what
keep movements moving.
Now that the die has been cast
for a new phase of the struggle be-
tween capital and labor the latter's
leaders at least find themselves
starting off with more support than
they had several decades ago on the
9-hour scrap. Many economists in
and out of the administration—
say nothing of a number of politi-

icians—are ready to testify that un-
employment will remain chronic in
this advanced machine age unless
work is spread by a material re-
duction in hours.

As recently reported here, Senator
Hugo Black of Alabama is prepared
to reintroduce his 30-hour week bill
next January. He will still find the
White House opposed to it.

President Roosevelt—according
to intimates—is in full sympathy
with the ultimate goal of labor but
believes a mandatory bill would kill
off so many business enterprises
that the net result would increase
unemployment. His idea is to work
toward it gradually through the
NRA. Naturally this would involve
prolonged dickering with the big in-
dustrialists.

Advocates of the Black bill are
fully aware of the White House atti-
tude. As a result you may look
for a compromise proposal from
their side for a 36-hour week. This
will be a tough one to block if all
the wild boys that look like winners
get elected to Congress next month.
They will add important votes to
existing support for a reduced work
week—but labor spokesmen are pret-
ty sure FDR will be able to head
off the issue.

Oil: The latest report of the Fed-
eral Surplus Relief Corporation—
which buys supplies for the Federal
Relief Administration—shows a con-
siderable purchase of cold liver oil.

Quite properly, this has been used
for under-nourished children but it
didn't prevent the wags from specu-
lating on increased appetites.

Notes: Labor leaders are suspicious
of the new draft bill for a revised
NRA now being drawn up by Henry
Harriman, president of the U. S.
Chamber of Commerce. An ex-
pected figure that more than \$200,
000,000 in U. S. currency is floating
around in Europe. . . . Ambassador
Lullitt will look into the Far East-
ern situation on his way home from
Moscow. . . . Nelson T. Johnson,
Minister to China, is returning to
Washington to report. . . . Lind-

mail controversies is having its ef-

Architects: Federal Reserve offi-
cials have begun to play a very ac-
tive part behind the scenes in shap-
ing the future of the banking struc-
ture.

They've been singularly on the
sidelines until recently. It is note-
worthy that when the Senate Com-
mittee was probing banking abuse
nobody thought it worth while to
call as witnesses them in who were
supposedly in charge of the banking
system. Up to March, 1933 the New
York Federal Reserve Bank—by all
odds the most influential followed
policies which reflected closely the
views of the big member banks in
its district. Since FDR took office
at Federal Reserve banks have
heeded Washington's wishes without
argument. In both situations the
Federal Reserve was more servant
than master.

As the central bank battle has de-
veloped it has appeared to be a
clash between advocates of full gov-
ernment control on one side and
privately owned commercial banks
on the other—with the Federal Re-
serve banks themselves simply in-
active pawns on the chess board.
This is no longer accurate. Federal
Reserve leaders are busy concoct-
ing a bank reform program of their
own which by no means coincides
with the ideas of member banks.
Their plan involves utilizing the
present banking machinery with the
government having a much larger
voice in its management than at
present—although it does not go far
as the central bank project in hand-
ing complete authority to the gov-
ernment. Insiders understand that
the Federal Reserve's recommen-
dations will carry weight where it
counts in administration circles.

Governor George Harrison of the
New York Reserve Bank is an im-
portant factor in current delibera-
tions. Harrison has several times
been reported on his way to the
nearest exit but has staged a strong
comeback. The informed predict he
will be a headliner in whatever re-
vised set-up is adopted. Ex-Chair-
man Eugene Black of the Federal
Reserve Board is also a key man
among the alteration architects. He
is thoroughly familiar with the
views of both government and bank-
ers and has done some skillful re-
conciling in his time.

Silver: Authorities say that the
Chinese tax on silver exports is tan-
tantamount to a complete embargo and
must inevitably result in enormous
price disparities between Shanghai
on the one hand and Hong-Kong,
Bombay and London—the three
greatest silver markets in the world
—on the other. They predict further
that this condition is sure to breed
wholesale bootlegging of the metal
which will eventually drain Shang-
hai of its silver as surely as if no
duty had been imposed.

Some of the loudest protests
against our silver policy come from
industries established in China with
British and Japanese capital at a
time when low silver assured them
low competitive costs. The inform-
ed remark that we have no special
reason to lose sleep over their woes
because their prosperity was gained
almost entirely at the expense of
the products of Western labor.
"We're feeding them a dose of their
own medicine and it doesn't taste so
good—but that's no reason we should
change the prescription."

You soon see the odd spectacle of
the U. S. government helping China
carry out her threat to adopt the
gold standard by swapping some of
our gold for her silver—despite Sec-
retary Hail's opposition.
We may have to do this as a
measure of self-defense. Otherwise
it's quite possible that China will be

forced into England's arms and be-

trade prospects if they get the
chance.

Election: New York Republicans
are dated by evidence of widening
rifts in the Democratic lute.

still carry a tidy collection of votes

Jim Farley. The city is their meat

Chapel Hill, N. C., Oct. 23.—Can "Hunk" Anderson break the jinx Carolina has held for N. C. State eleven of recent years, was the big question on the minds of "Big Five" football followers today? The two teams meet in their annual classic brotherly battle here Saturday at 2 o'clock with all indications pointing to another brilliant contest.

State has not been able to gain a victory over its brother team since 1927. The Wolfpack has been credited with having the superior material on several occasions, but the Tar Heels have always managed to nose them out.

The new factors, the new coaches, Anderson and Snively, enter into and add extra interest to the Carolina football equation this year.

With the Carolina-State rivalry as keen as it is, both coaches and teams can be counted on to point everything to a victory, and the answer may be one of the hardest fought games the State will see this year.

With Duke, Davidson and Wake Forest playing out of the State, the Carolina-State battle will hold the Big Five stage to itself, and is expected to draw the largest crowd here to date this season.

Carolina is being favored in some quarters as a result of its upset of Georgia. However, the Carolina offense looked none too good in the 6-0 win over Kentucky, and Coach Snively frankly views the State game with alarm.

He is particularly worried since Bill Moore, regular right end, and Jim Hutchins, regular fullback, are on the injured list.

Although nosed out by Wake Forest and Florida, State showed much power defeating Davidson and South Carolina, and may be all the tougher for its loss to the Gators last week.

The vets on the two clubs will be taking up where they left off in Raleigh last year, when Carolina won a dogged battle, 6 to 0.

All except one lineman who started the game for State that day are back, plus Ray Rex, 215-pound fullback, and several good reserves.

Carolina offers identically the same line from tackle to tackle and has six of the nine backs who worked the game, including Herman Snyder, who started at full; Charlie Saffer, who led the ground-gainers; Don Jackson, who had the 60-yard touchdown run called back, and George Moore, who scored the one touchdown.

With both clubs packing such an array of veterans and stars, Saturday's game is due to make and break All-State hopes. Among the outstanding candidates are Captain Barclay Shaufler, Emyder and Tatum of Carolina, and Rex, Farrar, Redding, Isaacs, and Stanko of State.
