START MOVE TO "SCRAP" LEAF PROCESSING TAX

Warn France She Is Playing With Fire In Saar Conquest

GERMANY TO TRY TO HALT OCCUPATION

Leading Newspaper Of German Government Declares Occupation of Territory Would Bring Serious Consequences; Move by France Declared Challenge to German Government

Berlin, Nov. 1.—(AP)—Semi-official German sources answering reports that France is preparing for possible occupation of the Saar territory warned today that France is "playing with fire."
The Deutsche Diplomatische Politische Korrespondenz, mouthpiece of the government, in an editorial headed "Playing With Fire," said: "Under no circumstances could peace and order be enforced in the Saar with military force by a power which is a party to the January 18 plebiscite."
The Reich Saar region votes then on whether to join Germany or France or to remain under the mandate of the League of Nations.
The editorial expression came in quick reaction to reports from Paris and London that France is making ready for a possible Saar occupation whenever the Saar governing commission deems it advisable.
"Occupation of the Saar under whatever pretext," the newspaper said, "will constitute a challenge to Germany and would amount to rate of territory under the league trusteeship. Even playing with such an idea should be sharply discountenanced by the whole world."

SENTENCE SUSPENDED FOR TWO BOOTLEGGERS

Durham, N. C., Nov. 1.—J. S. Coley, alleged Oxford highway bootlegger, was today fined \$75 and costs and given a suspended sentence of six months when found guilty of the illegal possession of sixty-five gallons of whiskey. Coley was arrested last Saturday when officers found three gallons of corn liquor in the field adjacent to his filling station.
Ike Triplett, who operates a filling station bend Coley's received a \$50 fine and a suspended sentence of four months for the possession of two gallons of whiskey, eight pints of which was alleged Virginia bonded liquor.

WOODS FIRES BURNING IN SOUTHEAST SECTION

Kinston, N. C., Nov. 1.—Woods fires have been reported from several counties east and south of here. State foresters expected them as a result of dry weather in recent weeks. In lower Beaufort County peaty soil in cleared fields is burning, giving off a dense smoke. Corn has been consumed in a field a few miles from Pantego. Residents of the section reported the stalks on which the ears were left, burning as the fire spread slowly over the ground. "Earth fires" have occurred in Hyde County where they are of frequent occurrence also.

BOUND OVER TO COURT IN DOUBLE FATALITY

Lumberton, N. C., Nov. 1.—In an inquest conducted at Chatham last night by F. B. Richardson, coroner of Columbus County, J. C. Adams, of Chatham, was ordered held for Superior Court under \$2,500 bond and G. A. Swum, driver of a truck in the fatal accident in Chatham Friday night in which Carson Mercer, of Chatham, and Busted Ivey, of Brunswick, were killed.
Evidence was that Adams, drinking was driving on the wrong side of the road at speeds variously estimated at from 60 to 100 miles per hour. He still is in Baker Sanatorium here with injuries sustained from the wreck. Coroner Richardson said he would be tried on a manslaughter charge. It was not explained why Swum, driver of a truck that was struck by an automobile occupied by Adams and Mercer, was held.

Violence Flares Anew At Mass. Carpet Plant

West Warren, Mass., Nov. 7.—(AP)—Violence broke out today near the entrance to the Ohio Carpet Company plant when some of the 250 massed pickets attempted to overturn two automobiles of workers who were trying to enter to go to work. Stones were thrown but no one was injured. Glass in an automobile was broken. The disturbance lasted but a short time and the pickets were dispersed by police.

WARNER HELD FOR THEFT OF HOOKER MONEY

John Warner, local sign painter and former moving picture show operator, was arrested here this morning charged with the theft of more than \$8,000 from the safe deposit box in State Bank and Trust Company here early last spring. A true bill in the case was returned late yesterday by the grand jury and the arrest was ordered immediately.
The theft was discovered during the month of April when S. T. Hooker went to his deposit box in the bank and found that some over \$8,000 had been removed from the box. The matter, handled very quietly, was turned over to police for investigation and a short time later Mr. Hooker's money, with the exception of a small part of it, was returned to him by Chief of Police George Clark.
At that time no further information other than that the money had been returned and no arrests had been made, could be ascertained from either Mr. Hooker or Chief Clark. Solicitor D. M. Clark was out of the city at the time the recovery was made public, and upon return to this city he announced that he would have the matter investigated by the grand jury at the first opportunity. When the grand jury met in August, the rush of other business caused Solicitor Clark to overlook the matter, and it was not presented to the grand jury until this week.
The grand jury returned the true bill in the case yesterday and the arrest was made this morning.

Credit: The Roosevelt administration is pointing itself for a vast public lending program in the coming twelve months that will be framed to take a sizeable percentage of the unemployed off the direct dole.
New Deal best minds are agreed that prolongation of straight-out cash relief for the jobless is impossible on the present scale. An already overtaxed Treasury just won't stand it.
There, they have decided to go in for underwriting of low-cost housing improvement of out-of-date industrial plants and general modernization of many facilities for production and distribution.
Administration are hoping against hope that private capital will suddenly loosen up in such a miraculous way as to make all this possible. They aren't overly optimistic.
As a rule, the Federal financial minds and engineers are busy mapping out the broadest program possible—that will be, theoretically at least, on a self-liquidating basis.
The idea will be to put out Government money in a big way for projects that should pay for themselves eventually. Men on relief rolls would be thus given jobs in large numbers. And the money thus put out could be carried as a credit on the national balance sheet.
Choices: Donald Richberg, executive director of the National Emergency Council, has been charged with arousing public enthusiasm for the plan. He is proceeding cau-

MURDERERS LOSE APPEAL IN HIGH COURT

Three Sampson County Men Must Die in Chair; New Trial for Pitt Negro

Raleigh, N. C., Nov. 1.—(AP)—Their appeals to the Supreme Court lost a trio of Sampson County men—Tom Johnson, Preston Howard and Johnny Hart—today were under sentence to die in the electric chair November 16 for the murder of Howard Jernigan, a filling station operator.
The death of the three men was automatically set late yesterday when the court announced it had found "no error" in their murder conviction. The court handed down opinions in thirty-six other cases.
Eugene Davis, arrested in the Jernigan case as an accessory before and after the fact pleaded guilty and is now serving sentence of life imprisonment. Jernigan was slain the night of December 21, 1933. The motive apparently was robbery.
The court also found "no error" in the case of Eddie Moxino as an accessory before the fact to the murder of Bennie Moxino by Fred Wade in Lenoir County on December 6, 1933. Eddie Moxino is under a sentence of life imprisonment for his part in the crime. Wade after pleading guilty to second degree murder is serving a thirty-year sentence.
The court, however, granted a new trial to Claude Clemmons, colored, convicted in Pitt County on charge of murdering Louise Robinson, an infant, burned to death in a fire. Clemmons had been acquitted on an arson charge in connection with the case and then convicted of murder by the same evidence.

MANCHUKUO SEEKING OIL 'MONOPOLY'

Government Already Takes Step in Spite Of Protest From Other Powers

Tokyo, Nov. 1.—(AP)—The Manchukuo, it was learned today, has already moved to effect an oil monopoly despite representations by the United States, Great Britain and the Netherlands.
Disregarding the foreign charge that the scheme is discriminatory and violates the principle of the open door, Hsinking has instituted steps to assume early possession of existing tentative marketing installation of the Standard Oil Company and the Standard Oil Company of New York and the British Asiatic Petroleum Company, reliable sources said.
They are to be eliminated for profitable distribution and retailing business built up in recent decades.
Cuts Debt Down
Smithfield, N. C., Nov. 1.—The town commissioners continue to reduce the local debt and the economies which they have effected are beginning to make a real show. Another payment of \$3,000 has just been made. The people are greatly pleased that the tax rate has been reduced this year and the bonded debt is likewise being reduced.

Federal Workers Seek More Money Next Year

Washington, D. C., Nov. 1.—Federal employees started a campaign today for more money than President Roosevelt has promised to pay them.
The President announced yesterday that plans are in the making to restore the remaining 5 per cent wage cut next January 1.
Forecasting a rise in prices he also said that would mean a rise in values. A drive to go beyond this restoration and increased salary rates for every grade of worker was announced immediately by Claude Babeck, president of the American Federation of Government Employees.

Late News Flashes

Posse Hunts Negro Rapist.
Thomasville, Nov. 1.—(AP)—A posse of several hundred men, many of them armed with pistols and shotguns and described as in a "very ugly" mood, this afternoon continued to scour a wide section south of here in search of the short, heavy-set negro who this morning allegedly under threat of death from a pistol he brandished, criminally attacked Miss Mary Dorsett, 26-year-old farm girl near her home three miles south on the Fisher Ferry road.
Meanwhile, in jail at Lexington is John Crosby, former Lexington negro, who was taken into custody after noon near the Cedar Lodge farm, about half a mile from the scene of the attack. Because of the temper of the crowd gathered about the community Crosby has not been taken back to the scene of the crime, to be identified by the girl, who told officers that although she did not know the negro before the crime, she would be able to identify him positively when she sees him again.
The girl who tended her sister's children while the sister worked in a cotton mill, was described as in a serious and highly nervous condition. She said she had been assaulted twice by the negro who overpowered her and she was unable to get away from him.
Deputy Sheriff G. L. Bryant, who is conducting the probe, said that there was unmistakable evidence the girl had been assaulted and brutally treated.
Shortly before noon bloodhounds were brought from Salisbury and took up at once a trail in the direction which the girl said her assailant took on leaving the spot of the alleged crime.

CLYDE HOEY SPEAKS HERE

Shelby Man Addresses Gathering of Democrats at the Court House Here

Praising the splendid achievements of the Democratic party, Clyde R. Hoey, of Shelby, prominently mentioned as a candidate for governor, addressed a gathering of Democratic voters at the court house here last night.

The address was heard by party leaders from many sections of the county in addition to numbers of others interested in what the national administration has done to lift the country out of the pits of economic depression and poverty.

W. E. Hooks, chairman of the Pitt County Democratic Executive committee, presided over the meeting and presented Colonel Albion Dunn, who in turn introduced the speaker of the evening as one of the outstanding political leaders of the state and nation.

Mr. Hoey, who has appeared in Pitt County in the interest of the party several times in recent years, told his hearers that the country had made the most remarkable progress in history under the Roosevelt administration, and pleaded for the cause of those leaders who are doing so much to facilitate the work of the president in completing his task of returning the nation to folds of prosperity.

Mr. Hoey referred to conditions under Republican rule of 12 years and compared it with the two years that it has been under Democratic rule. He was high in his praise of President Roosevelt and his policies. He commended the New Deal.

He urged his hearers to vote on next Tuesday declaring that those of this section who had been helped so greatly by the New Deal had a special reason for supporting the Democratic party. Prior to his speech at the court house Mr. Hoey was guest at a dinner at the East-Carolina Teachers' College and made a short talk to the student body.

TERRELL RAPE CASE NEARING JURY STAGE

Roanoke, Va., Man Takes the Stand in Criminal Court in His Own Defense

Evidence in the trial of C. A. Terrell, 34, married man of Roanoke, Va., charged with criminal assault upon Miss Annie Turner, 23 years old, secretary of Solicitor D. M. Clark, was completed shortly after 2 o'clock in Superior Court here today and indications were that argument of counsel would be completed late today and the judge's charge was not expected to be given until tomorrow morning.
Terrell's attack upon Miss Turner was alleged to have occurred on October 11 immediately following which he left this city. He was arrested a week later upon his return to Greenville and has been in jail without privilege of bond since that time.
Behind closed doors yesterday afternoon Miss Turner spent two hours on the stand, during which time she told her story and underwent cross-examination. She was followed by character witnesses and Dr. L. C. Skinner who examined the victim shortly after the attack. Dr. Skinner testified as to the young woman's condition following the attack.
Resting his case this morning, Terrell took the stand in his own defense and admitted an unsuccessful attempt to assault, but alleged that the young woman was a willing victim upon cross-examination. Terrell admitted a police record in Virginia covering a series of minor and major violations of the law. There were several other defense witnesses as to Terrell's character, but these were parties from Roanoke who had known the defendant up until he left Roanoke about ten years ago. The witnesses who testified included Terrell's wife.

NEGRO SENT TO STATE PEN

Doc Darby Draws From Ten to Twelve Years For Slaying Dennis Speight

Doc Darby, local negro charged with the slaying of Dennis Speight, also colored, here several weeks ago was sentenced to not less than ten nor more than twelve years at hard labor in state's prison by Judge R. Hum Parker in criminal court here yesterday afternoon.
The negro pleaded guilty to a charge of manslaughter during Tuesday's session of court.
Darby is alleged to have shot Speight to death at the latter's home here several weeks ago.
Darby said to have been drinking became angered when Speight asked him not to sit on the bed. Going to his home Darby allegedly later returned with his gun and shot Speight to death.

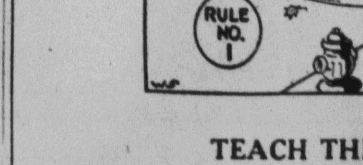
City Fathers Meet Tonight

Hogoblins and other scary-looking creatures were to be seen along the principal business and residential streets of the city as children in groups paraded from one house to another to remind the populace of Halloween.
The celebration in some sections of the city was decidedly noisy, but in others the night passed uneventful without anything being missed from front porches, and automobiles left parked in yards during the evening.
Numbers of Halloween parties were given by various organizations and in some of the schools and apple-bobbing contests along with other games popular at this season of the year were enjoyed.
Groups of children attired in keeping with the season attracted considerable attention, and some of the more boisterous visited various homes, turned porch and yard furniture topsy-turvy, leaving plenty of work for housewives to do this morning.
The black cats proved rather disconcerting to the superstitious, and many a person who believes it is an ill omen for a black cat to cross one's path, walked circuitous routes to off-set the spooky shadows crossing their paths.
Considering the occasion from all angles, it was one of the best enjoyed by the children of the city in many years, and costumes which helped give the night suitable colors were packed away today to await the coming again of the season hogoblins.

AAA HEADS TO CONFER WITH LEAF BUYERS

Washington, D. C., Nov. 1.—(AP)—The tobacco manufacturers are coming to confer for the first organized attack on the AAA processing tax.
Two meetings to consider revision of taxes on burly, flue-cured, fire-cured and cigar leaf tobacco have been scheduled for November 9, but the meetings a week ago will be held between AAA officials and large tobacco manufacturers. Some critics attacking the processing taxes in their entirety have demanded that they be scrapped.
Secretary Wallace said the processing taxes are the heart of the program of crop adjustment at the present, but he was willing to discontinue them if another way could be found to cut their production.
Just to indicate some possible alternative, he mentioned general sales taxes, increased income taxes on higher brackets, loans of \$500,000,000 for foreign countries to buy American goods or importing \$500,000,000 of foreign goods so other nations could get exchange to buy United States farm products.
That he would suggest these to any group leading for abolition of the processing taxes was the belief of his advisors.

TWO DECLARED GUILTY OF DEALING IN WHISKEY

Sanford, N. C., Nov. 1.—In Superior Court Tuesday C. J. Kelly, well-known Sanford man, former operator of Westview Filling Station, and Lemuel Barrett, a negro employee of Kelly, were found guilty of selling whiskey at the station located just north of Sanford on Highways Nos. 1 and 75. Judge Barnhill has not pronounced judgment in the case as yet.
The defendants were arrested following a raid by officers some weeks ago. When convicted in recorder's court and sentenced to the roads for twelve months, appeals were taken to Superior Court.

Fourteen Negroes Hurt Last Night In Truck Wreck

Fourteen negroes were injured, two of them seriously, when a truck in which thirty-five were riding, crashed into the rear end of a molasses mill being drawn behind a wagon on the Bethel highway about eight miles from the city.
Highway patrolmen who investigated the accident said the wagon was lighter, but the truck traveling in the direction of Bethel crashed into the rear of the outfit, turned completely around and spilled its human cargo all over the road. One negro woman whose name was not given, was brought to the hospital believed to have suffered internal injuries, and another also severely injured, was carried to Tarboro Hospital. The other twelve injured received first aid treatment were not injured severely enough to need hospital treatment.
The truck was said to belong to W. H. Dail of this city and the negroes were said to have been en route to Edgecombe County to pick cotton.

medically . . . Senator Pat Harrison is getting set to challenge Secretary Ickes and Governor Pearson on Virgin Islands conditions. By JAMES McMULLIN. New York, Nov. 1.—Re-aligned: Leading financial sources with close and friendly Washington connections fore see a striking change in the political picture when Congress meets. They predict that conservative Democrats and even Republicans will find themselves lined up in a coalition to support the President more often than they will oppose him. The American Legion's overwhelming vote for the bonus gives point to the realignment. The Legion's political prestige is back to normal and Congress will respond to its magic as warmly as ever. The only hope of blocking the bonus is for the President to get together with the right wing on Capitol Hill. Nor is the bonus the only issue on which the administration and conservatives will be linked in a common cause. The central bank and the Connery 30-hour bill will be equally painful thorns to both. Each of these will have powerful pressure groups behind it—the Committee for the Nation and Senator Owen's Sound Money League in one case and the Federation of Labor in the other. In addition there will be a lusty clamor for mandatory inflation of one sort or another and even more radical concoctions are known to be simmering on congressional stews. Bacon: Keen observers stress the point that united conservative sentiment in the nation is undoubtedly stronger than the forces of united radicalism. But the radicals are very likely to get the upper hand on any given piece of legislation unless the conservatives combine. Mr. Roosevelt and many adherents of his New Deal philosophy are counted on the conservative side of this classification on the promise that they aim to preserve the fundamental American economic system by eliminating its abuses not to destroy it. Insiders interpret the President's friendly overtures to conservative business and financial circles as a keen move to get the army organized before it's tested in the field. His continued insistence on concessions to liberalism at the same time is rated the proper strategy to win public approval—the only sure antidote to extremist experiments. Many conservatives agree they must cooperate to this end in order to save any part of their bacon. Matches: Reports are current in high quarters that devaluation to 50 cents is probable before Congress convenes. This would fix the realignment picture by depriving the inflationists of part of their ammunition. Ten fewer matches radical legislators have to play with the fewer fires they can start. Bonus: Now that the tumult of the convention is over New Yorkers familiar with American Legion machinery doubt that its skilled lobbyists will press so hard for the bonus as most people think. The Legion lobby will be directly responsible to Frank Belgrano—the new national commander. Mr. Belgrano is a banker and it's known that his business associates aren't exactly keen to see the veterans dip their lade into public funds. A national commander cannot openly flout the will of the Legion but he can exert a lot of sub rosa influence on the ardor with which its declared policies are pursued.

What Hitler does, the part he plays in world events is a matter of public concern and Miss Hyman presented the man and his life with accuracy and fairness, with thoroughness and with fidelity to facts, savoring the whole with wit and sparkling humor.

She gave us not only a glimpse of this man who is directing public affairs in Germany, but she gave us a long and careful look at the man's

character which makes him what he is. Almost we felt we had had actual contact with him—yes, had known Hitler all the tempestuous years of his life. We saw the grand sweep of his personality, took a look at his weakness and his strength, were made familiar with his habits and his private way of living, learned of his problems, his mistakes and his accomplishments. For us, on Tuesday afternoon, Hitler became something more than a mere name—something vastly more than a newspaper account, and photograph of this not-very-admirable man to us but, nevertheless, one of the outstanding men of the world today.

Like any Moses, Miss Hyman told us, Hitler takes himself with astigmatic seriousness (characteristic of men of his type) and a terrifying self-assurance that he alone knows the way to the light. From this derives an intolerance that will have nothing to do with any other program or viewpoint. Coupled with these characteristics, she possesses genuine oratorical gifts and the ability to see dimly and define vaguely the topography of the Promised Land. Moreover, he has the sagacity to seize upon and develop popular longings and possesses a very keen sense of the effectiveness of the theatrical.

In Germany millions of people from all walks of life have looked upon this man as the savior of his country and with unbounded enthusiasm have echoed the cry heard round the world—Hail Hitler!

GREENVILLE HIGH TO PLAY AT KINSTON

Greenville meets Kinston High School in Kinston Friday afternoon in a game that promises to be a real thriller. From comparative scores of games played by both teams this season it would seem that the teams will be evenly matched, with victory going to the one that takes advantage of the breaks.

The local team is going into this game with a determination to win. By playing an aggressive, heads-up game of football there is no question but that the end of the game will find them chalking up another victory.

Coach Woods has been sick for two weeks; during his absence Beatty has been directing the team. He found the team could execute a few plays fairly well, but knew practically nothing about blocking and tackling. He has spent a greater part of the time on fundamentals. In scrimmages the last two afternoons the boys have been charging lower, harder and tackling better. The ball-carrier has found his blockers opening holes in the line and clearing out the secondary for him. There is no question but the team well-trained in the fundamentals, blocking and tackling, is the team that can show the best record at the close of the season.

This fact was demonstrated last week when Greenville played Edenton. Coach House, coach at Edenton, presented a veteran team that was certainly well grounded in fundamentals. I don't recall having had the pleasure of ever seeing a high school team that looked any better than did this team. Their offensive smashes, end runs and passing game was superb. They may not win the Class B championship but the team that defeats them should be crowned champions. Their coach, Henry House, will be remembered as the star fullback of Chuck Collin's high-scoring Tar Heel team during 1929 and 1930.

Edenton defeated Greenville by a very large score, but Coach Beatty realized soon after the game started that his team could not win, so he gave every man on the squad a chance to play. This was a very good time to see how some of his substitutes would act when placed on the firing line.

Several of the men are still showing much progress. Hatem, on end, improves with each practice. He plays a large part of the game in his opponents' backfield. H. Forbes, William Harris and B. Eilers certainly are promising looking youngsters in the backfield. In the line, Forrest, Scoville, Joyner and Parrish are still showing improvement. At center, Summerell has improved some, but there is no doubt but that the team has been greatly weakened by several bad passes from center. Joyner has had more experience than Summerell, but is so light that he has seen very little service. This department will get plenty of attention, and there is no reason for Summerell failing to develop into a first-class center if he will show a little more interest and drive.

The team should enter Friday's game with practically every player in playing shape, with a possible exception of John Sizemore. He has been suffering with a side injury, and has been having trouble rounding into shape. Alton Cox has recovered and is playing end.

HOEY SPEAKS AT COLLEGE

Democratic Orator Discusses "Government" Before Student Body Here

"Government" was the theme Hon. Clyde Hoey used in his brilliant, clear, concise talk to the students of East Carolina Teachers College at 6:30 o'clock last night. He spoke to the young women as if they were intelligent citizens taking deep interest and active part in the affairs of the nation. He said he thought it a fine thing for all to think about government, talk about it, confer about it, and teach it.

Our government, he believes, made wonderful gains when it conferred the suffrage upon women. Our government, he further believes, as it now is, owes much to the teachings in the public schools. Although for teachers the outlook may now be temporarily darkened, he sees the teacher as an inspirational force and dynamic power in the government today, as always.

He showed that throughout our history, educated men have had the leading part in shaping and interpreting the Constitution, which has always been the bedrock of our democracy. As the keynote to his explanation of the basic principle upon which our government is founded, he used the inscription on the Yorktown Monument: "One country, one constitution, one destiny."

He drew a parallel between the policies of Wilson and of Roosevelt, showing that their underlying purposes were the same: To bring together those who had the highest ideals and theories and those who knew best how to work out the practical affairs of life. Wilson, the idealist, the educator, coming from college walls, bringing a rich fund of knowledge and idealism, gathered around him advisers from the practical affairs of life, while Roosevelt, the practical lawyer, called his advisers from their classrooms and research, from the educational ranks.

He closed by holding up Cecil Rhodes as a supreme example of one whose ideal was to do some great service for his country and whose achievement fulfilled, in a glorious way, his ambition.

Mr. Hoey and his daughter were dinner guests at the college. Other guests at the table of honor were President and Mrs. L. R. Meadows, W. E. Hooks, Mrs. C. S. Forbes, and Mrs. J. B. Spillman.
