

CONFLICT GIVES WAY IN LABOR CONTROVERSIES

Miners Vote To Return To Work At Wilkes Barre

EMPLOYEES OF A & P RETURN TO THEIR JOBS

Three Hundred Stores In Cleveland District Prepare to Reopen; Miners' Fight in Pennsylvania to be Carried to Court; Enamelware Workers in Milwaukee Return to Jobs

(By The Associated Press) Conflict gave way to co-operation today in the relations between employers and employees...

Employees of the Great Atlantic and Pacific Tea Company returned to work in 300 Cleveland stores today preparing to re-open them this week in accordance with the truce which the company and seven striking unions reached.

United anthracite miners, who attempt to close hard coal collieries near Wilkes-Barre resulted in three days of clashes with members of the United Mine Workers of America, voted to end their strike.

Seven hundred employees at the Geuder, Peckoe & Feay Company enamelware plant in Milwaukee also started back to work. Their three months of strike ended with increased pay and union recognition.

Rioting occurred in the strike of three hundred silk wagon drivers at Fargo N. D. Six men were arrested.

A New York union threatened to call out 2,000 employees in 150 buildings unless a \$30 minimum wage was established.

Thousands of persons climbed stairs to the skyscraper offices last week when a similar strike halted activity in the great district.

JUETT BUYS LUMBER PLANT

Greenville Tobacco Man to Move Ayden Vener Plant Materials to Greenville

It was announced today that H. O. Juett, local tobaccoist, has purchased the National Vener Lumber Plant in Ayden, including land upon which the plant is located.

The plant is comprised of nine buildings, 200 by 78 feet. Mr. Juett, it was said, expects to move materials to Greenville, although it was not stated when construction work would begin here.

Mr. Juett has been living in Greenville twelve years, and during the time has been connected with the tobacco warehouse and buying tobacco for some of the largest companies.

The Arden plant, it was said, cost \$385,000 to construct in 1918. The sum involved in the purchase by the Greenville man was not revealed.

The plant is one of the largest in this immediate territory, and deals in lumber and veneer products. It has played an important part in the industrial life of Ayden over a period of many years, and news of the purchase by the Greenville man was received with interest in business and employment circles.

NEGRO HELD FOR ROBBERY AT N-S DEPOT

Frank Redmond Nabbed After Stealing Case of Cigarettes From Freight Depot

Frank Redmond, colored, who police said escaped from a chain gang in the Pastolus community about five years ago, was taken into custody here Saturday night after allegedly robbing the Norfolk-Southern freight depot of a case of cigarettes during the day.

All but twelve cartons of the cigarettes were recovered when the negro was taken into custody, officers said.

Police said the negro obtained the cigarettes while a number of employees of the railway were at lunch. The robbery was later discovered and reported and police tracked Redmond, who apparently was short of funds, and sold a dozen cartons of the cigarettes to members of his race.

In addition to escaping from the chain gang in this county, Chief Clark said Redmond had recently completed serving a term in the Virginia State penitentiary on a charge of robbery. The negro was reported to have a long criminal record.

Redmond was said to have admitted the robbery here and talked freely of his activities in other parts of the country.

Auditor's Safe Robbed At County Courthouse

Robbers entered the auditor's safe at the court house last night, broke into the safe and made away with a small amount of money described by Auditor John Coward as the "stamp" fund.

Mr. Coward said he was unable to say definitely how much money was involved but declared the amount was small. No trace of the thieves had been obtained up to 3 o'clock this afternoon, although Sheriff Sam Whitehurst, began an investigation of the robbery immediately after it was reported.

The robbery was discovered by the janitor when he went to the court house this morning to begin cleaning up for the day. He immediately reported the affair but a complete check of the amount of loot obtained by the robbers was not available until the arrival of Auditor Coward at 9 o'clock.

The three lock boxes taken from the safe were carried to the police station for examination by finger print experts but no report of the findings had been made up to the noon hour.

Using a crowbar obtained in the basement, the robbers broke the glass in the door of the auditor's office, also known as the commissioners' rooms, tripped the lock and entered. They were able to work the combination or the safe, as not a scar was left on the doors to indicate forcible entrance. However, the crowbar was used in prizing the three lock boxes free. The boxes were taken to the basement broken open and rifled.

A quantity of stamps used by the office in the transaction of daily business were not molested, and officers expressed belief the yegmen were after money alone.

Three scratches were found on the inside of the safe door, indicating the robbers had struck a match either to light a cigarette, or to furnish light for their operations in examining the boxes.

HOLDUP MAN NABBED AFTER ROBBERY HERE

John Gorham Faces 2 Holdup Charges After Snatching Pocket Book Sat.

A negro, who admitted to police that he robbed two white women here the past five weeks, was in the toils of law today and probably will be bound over to the next sitting of criminal court in preliminary hearing sometime today.

John Gorham, 20, who said he was from Brunswick county, was captured Saturday night shortly after he snatched a pocketbook containing \$35 from Miss Doris Ross, employee of the local telephone exchange as she and her sister Mrs. Mamie Ross, were walking along the sidewalk in front of the Catholic convent on Fourth Street.

The young woman screamed as the negro suddenly appeared from behind snatched the pocketbook and fled. The screams attracted Bill Perkins and Luther Nobles, who were passing in automobiles. They jumped out of their cars and overhauled the negro after a spirited sprinting contest. The pocket book was recovered and the negro turned over to police. After a brief quiz by Chief of Police George Clark Gorham admitted he held up and robbed Mrs. L. H. Smith in the western section of the city five weeks ago. He obtained \$3 from Mrs. Smith, who said it was so dark at the point where she was crossing the street she was unable to obtain a good view of the robber. Although knocked to the ground as the negro grabbed her purse, Mrs. Smith escaped uninjured.

Chief Clark said Gorham, who also gave his name as Smith, stated he came to Greenville from Brunswick county shortly before the Smith holdup. A check was being made today of his criminal record.

PUSH SEARCH FOR ROBBER IN VIRGINIA AREA

Officers Seeking Man Believed to be Ralph Long Wanted at Rocky Mount

Hopewell, Va., Nov. 5.—(AP)—Police of a dozen Virginia communities tightened the meshes of a wide spread dragnet today as they pushed a search for a man known to them as "Ralph" and believed to be Ralph Long, who is wanted for the holdup of a filling station near Rocky Mount, N. C., "Raipa" snatched through the guard which last night was thrown over roads near Petersburg, Hopewell and nearby towns after a police officer had been attacked and beaten, his car stolen and wrecked, a man and his wife temporarily kidnapped and a filling station holdup. One man who said he was Junius Riddle, 29, a truck driver for the State Highway commission was being held today.

A third man, Garland Starks, a farmer of Newville, was also being sought.

The wild spree of automobile stealing, holdups and kidnaping began in Clinton, Va.'s near here yesterday when traffic officer T. W. Sapp attempted to arrest two men he suspected of driving a car while drunk. He said the men attacked and beat him, took his gun and car and fled.

Greatest Tobacco Year Seen Here This Season

Indications today pointed to the fact that more money will be paid out on the local tobacco market this season than any year in history—even the peak year of 1919-23.

A compilation of activities of the market for each year since the 1915-16 season also shows the average price to date this year is the highest for the period except in 1919 and 1920 when the figure was eclipsed.

The amount of money paid out in 1919-20 was given as \$15,867,518.83 for 30,031,161 pounds of tobacco at an average of \$52.84 per hundred pounds. That was the greatest season in the history of the market from the standpoint of prices, although the total amount of tobacco offered has been eclipsed on several occasions.

The figures for this season, with sales incomplete, are 47,294,252 pounds for which farmers received \$15,638,306.27 at an average of \$31.80 per hundred pounds.

During the 1918-19 season the market sold 25,977,231 pounds for which farmers were paid a total of \$10,234,670.38 at an average of \$37.92 per hundred pounds.

In 1917-18 the market averaged was slightly over 30 cents a pound, but with the exception of these three periods, the average did not go much above the 28 cent mark.

Although the money paid out here this season does not equal the 1919-20 figure, it was believed sales (Continued on page five)

TO SEEK NEW LEAF SIGNUP AT FARMVILLE

Plans were gradually assuming form today for the mass meeting to be held in Farmville next Thursday at 2:30 o'clock for the purpose of adopting resolutions calling on the government to take immediate steps to continued the tobacco production campaign.

The resolution, it was said, will ask for a new sign-up for a period of two, three, four or five years, to prevent over-production and enable the buying companies to pay favorable prices such as those prevailing this year.

Governor J. C. B. Ehringhaus has been invited to speak at the meeting along with Congressman Lindsay C. Warren, of Washington, of the First Congressional District.

Dr. M. T. Frizzelle of Ayden, has been selected as chairman and will preside over the gathering.

Leaders of the movement have declared that continued control of production of tobacco such as that prevailing the past year, is necessary to protect the market from large surpluses and hold prices to a favorable level.

Tobacco men, growers and the general public have been issued a cordial invitation to attend and use their influence in behalf of a new production campaign for the salvation of the tobacco crop—the most important in this part of the country.

DEPARTMENT AGRICULTURE SEES NEED

Department Predicts Reduced Stocks of Tobacco and Improvement in the Surplus Situation Next Year; Production of Contracting Growers This Year in Excess of Quantity Allotted

Washington, D. C., Nov. 5.—(AP)—Continued government control of acreage is necessary to progress in reducing surpluses and increased prices to tobacco growers, the Department of Agriculture declared today in its crop forecast for 1935. It predicted reduced stocks of tobacco and improvement in the surplus situation next year.

Particularly in the case of supplies of several types of tobacco remain large when compared with the rate of consumption, the Department said, despite increased domestic consumption of several tobacco products.

The report added that for some types, notably burley and fire-cured, the 1934 production of contracting growers is materially in excess of the quantity allotted to be sold under the contract.

U. S. SHIPS TO JAPAN DENIES MANDATE AREA

Geneva, Nov. 5.—(AP)—The entire question of Japan's right to hold islands under mandate in the Pacific ocean now that she has resigned from the League of Nations was thrown into discussion today as the League mandate commission heard a report that a United States warship had been denied the right to visit former German islands now under Japanese mandate.

According to league officials reports exist that Japan violation of mandate regulations is secretly constructing naval bases on these islands.

His concrete question, however, did not arise at today's meeting. What did happen was that a member of the commission told Nambu Ito, the Japanese minister to Poland, that he had read in a Stockholm newspaper that an American battleship transporting an American scientific expedition which intended to study conditions in the island had been denied admission to the island under the Japanese mandate.

It was answered that he had no knowledge of the report and added that the Japanese government had organized a scientific expedition to visit the island and has invited scientists of other countries.

He said, however, that he saw no reason why the United States or any other government should wish to send scientists on a ship when Japan herself had organized the scientific expedition.

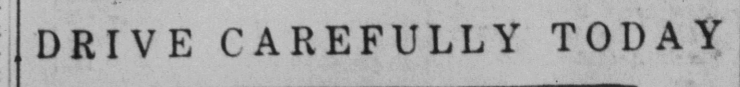

SCOUT DRIVE ON TOMORROW

The stage was all set today for the drive to be made here tomorrow to raise the funds necessary to assure organized Boy Scout work in this city for the coming year. A fellowship of around twenty workers will be held at Friendly Dining Room tomorrow morning at eight o'clock at which time the workers will receive the final instructions and pledge cards and begin their task of solicitation immediately.

In order to procure a Boy Scout program in this city it is necessary to raise a minimum of \$1,500, and those who are sponsoring the movement express confidence that the local citizens will respond generously to the appeal for the funds. At a meeting held the latter part of the week several voluntary pledges by individuals present, together with \$200 appropriated by the city, gave assurance that if the citizens were willing to do their part, the program would be put on here.

Following procuring of the funds, representatives of the Boy Scout organization will come to this city to take care of setting up the necessary committees to handle the work here during the coming year. The program includes the services of a trained Scout leader to be located here who will see to it that the program is carried out in a most beneficial way in this city. If the funds can be raised in tomorrow's drive, the organization work will be carried out immediately, and it is hoped by those interested that the trained workers may be employed and the actual program set under way here by the first of December.

The National Organization of the American Legion, co-operating with the National Education Association, is observing this American Education Week, the local Legion Post in Greenville is co-operating with the local schools in carrying out the program for the week.

The American Legion believes that the future safety of the American Republic is dependent upon an educated people, and on Armistice day, November 11, which falls on Sunday this year, the American Legion is requesting all churches to observe the day at the appropriate service in which there will not only be a remembrance of the end of the great conflict sixteen years ago, but also urging upon the people, the necessity of the support of the Public School System in America.

In North Carolina the state has practically taken over the operation of the school system. This has caused the local schools of the various communities to become state controlled and operated institutions and there has been an increasing tendency on the part of the local communities to forget their obligations to the local schools. The local post of the American Legion and the Local School Board are attempting to use the American Education week in Greenville to bring home to the people of Greenville the necessity for more interest in their local school situation.

The big item for this week is to get the parents to visit the schools while in operation and see for themselves just what is being done. In addition to urging the parents to visit the schools while they are in operation, this week, there will also be three meetings at night for parents at the schools. Tonight, Monday night, the Training School and the Third Street School will hold open house. On Friday night the West Greenville School will hold open house. There will be a meeting at the High School on Friday afternoon at 2:30 in the High School Auditorium.

Colored Baptists Close Successful Convention Here

Cheese Relish Salad 1 package lime gelatin, 1/2 cup chopped water, 2 cups boiling water, 1/2 teaspoon salt, 1/2 cup grated yellow cheese, 1/2 cup chopped gelatin, 1/2 cup sweet pickles mixture, 1/2 cup chopped pimientos, 1/2 teaspoon paprika, 1 tablespoon lemon juice

Pour water over gelatin mixture. Stir until dissolved. Add salt and cool until a little thick. Add rest of ingredients and pour to the thickness of 1 1/2 inches in shallow pan which has been rinsed out of cold water. Set in cold place to stiffen. Cut in squares, serve on lettuce and surround with mayonnaise.

Lightning Cake (Already Frosted) 1/2 cup butter, 1/2 cup sugar, 1/2 cup milk, 3 egg yolks, 1 teaspoon vanilla, 1/2 teaspoon lemon extract, 1/2 teaspoon salt, 1 1/2 cups flour, 2 teaspoons baking powder

Cream butter and sugar. Add rest of ingredients and beat 2 minutes. Pour into greased shallow pan. Spread with topping.

Topping 3 egg whites, 1/2 teaspoon cinnamon, 1/2 cup nuts, 1/2 cup sugar

Beat whites, add sugar and beat until creamy. Add rest of ingredients. Roughly spread over cake mixture. Bake 30 minutes in moderate oven.

Apples blend well with pineapple, oranges, peaches and bananas and are good used in appetizers, salads or fruit desserts. Do not forget to sprinkle lemon juice over the fruits just before serving.

"John, please keep out of that tree. It makes me nervous to see you climb so high. If you fell you'd break your neck."

The number of children who are hampered and held back by nervous mothers seems greater today than ever before. Time was when small boys and girls could get out of their elders and try stunts without fear of interference. But so small has the world grown that most children have to live in the public eye and behave with proper caution.

Half the fears will never be realized. Children walked unharmed in long grass and were never bitten by snakes even when there were more snakes to bite. Most snakes are harmless anyway. Dogs and horses are seldom vicious. The number of children killed or injured by falls out of trees is quite small.

And for such little, idle dreads, mothers will risk making their children's lives wretched. For a coward's life is wretched. He is pursued by dreads, hindered from enjoying many of the pleasures and often obligations of life, by improbable possibilities.

It is often hard for an anxious mother to control the expression of her fears. But if she is wise and has the child's best interests at heart, she will perhaps elicit her fits and grit her teeth to keep from interfering, or if necessary will go out of sight where she is not tempted to protest. Better to endure the agony one's self than to transfer the same dreads to the children.

Returns From Charlotte.

Miss Maria D. Graham of the mathematics department of the college has returned from Charlotte where she went to attend the funeral of her uncle, Alexander Graham, the noted nonagenarian educator, who died last week.

Alex Graham was the last of three brothers in a family that has greatly influenced education in

North Carolina for the past seventy-five years and seems destined to continue its leadership for many years to come.

Mr. Graham for sixty years was connected with the public schools in some capacity, and was a pioneer in this field. His son, Dr. Frank Graham, is president of the University, and all four of his daughters have been teachers in public schools, two of them still teaching in the Charlotte schools. One daughter, Mrs. Shipp Sanders, wife of a professor in the University, was a critic teacher in the Training School here one summer.

Miss Maria Graham's father, John Graham, for a half a century was one of the greatest leaders in the state in secondary education, especially noted for his splendid work with boys. Hundreds of boys were prepared for college or life in the schools which he headed. His work is carried on in this generation by one son and one daughter, W. A. Graham, superintendent of the schools in Kinston, is one of the leaders in the public schools in the state today. Miss Maria Graham, a charter member of the faculty of East Carolina Teachers College, has given her life to teaching.

While her third brother, Archibald Graham of Charlotte, did not teach, his influence on education through his only two children was great. He was the father of Edward Kidder Graham, under whose presidency the University of North Carolina made tremendous progress. His daughter, Miss Mary Owen Graham was for some time president of Peace Institute and has been in positions of leadership in the state and nation, in educational and political organizations and in the work of women's clubs. The grandson, Edward Kidder Graham, Jr., is now studying at Harvard, preparing himself to teach.

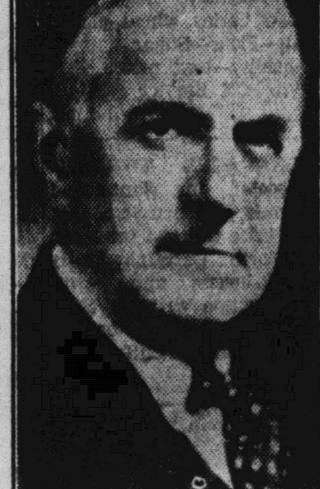

Insull Leaves The Stand

Chicago, Nov. 5.—(AP)—Samuel Insull finished his testimony as a defense witness against mail fraud charges today in a half hour appearance this morning in Federal Judge James Wilkerson's court.

Federal prosecutor, Leslie Salter asked Insull a half dozen questions and Insull's own attorney asked three and the deposed Chicago utilities executive left the stand.

Under cross examination the utilities executive maintained that his practices had always been honest and should be judged by the standards pointed out by the prosecution.

In his speech the senator bitterly assailed Ansell who had acted as counsel for a Senate committee investigating the election of Senator John Overton of Louisiana, supported by Long.

Contending he had been injured by the speech on Feb. 21, 1933, Ansell filed suit in the District of Columbia Supreme Court. Long challenged the validity of the summons served on him claiming immunity as a member of congress. The trial court and District of Columbia Court of Appeals both held the senator must stand trial.

Long was quoted as telling the Senate that Ansell had "practically forged his own appointment as judge advocate general, that Ansell had been condemned by the governor as a 'thief, scoundrel and crook' and that he 'had been practically run out of the army for fraud.'
