ADMINISTRATION PLANS RELIEF ALTERATIONS

World Turns To Celebrating Armistice Roosevelt Will Disclose Plans In Fireside Chat

WAR CLOUDS MAR OUTLOOK FOR EUROPE

Nations Look With Apprehension on Saar Plebiscite in January, Another World War Hang-over; Fresh Alarm Seen in France Over Saar Territory

(By Associated Press) Europe came to the eve of the Armistice's sixteenth anniversary today with fear for the future tempering its celebration to the return to peace.

In contrast with the delirious joy that greeted the end of the war on November 11, 1918, it looked apprehensively to the January Saar plebiscite, another grave war hang-over as the chief clouds on the horizon.

An indication of the prevailing mood perhaps was Ramsay MacDonald's statement last night that Great Britain's attempt to bring peace by disarmament had proved fruitless. After expressing hope of international accord, he warned: "In the meantime we have to take steps to secure that if we meet aggression and should at least be in position to defend ourselves."

"The Marseilles assassination," he said, "lit a flame at the side of material so inflammable one could almost hear it crackle in the heat it produced."

Paris, Nov. 10.—(AP)—Fresh alarm sounded in the ears of French veterans today as they prepared to march past the Unknown Soldier's tomb in the sixteenth Armistice Day parade.

The Saar vote, but two months away, was a dinner spot with the traditional Franco-German enigma approaching its old bitterness over the question of control of the territory.

The anniversary was also an occasion of tribute to France's post-war military alliance. Torchlight parades at the tomb of French and Belgian soldiers will be changed Sunday between Paris and Brussels.

Berlin, Nov. 10.—(AP)—To Nazi Germany, the Armistice is two days of national humiliation.

"Let the English celebrate the Armistice as a great peace day," one newspaper said. "Let the French wallow in reminiscences or orgy of victory—to us it is a reminder of the blackest national disgrace—a day of national mourning for all generations; a great empire in ruins," the paper continued, "unparalleled sacrifice was overwhelmed by a wave of red terror."

Funeral Services For Wife of Ayden Physician Conducted This Afternoon

Funeral services for Mrs. G. H. Sumrell, wife of a prominent Ayden physician, who committed suicide by taking poison Thursday night at her home in Ayden, were conducted from her late home this afternoon at 3 o'clock.

The final rites were in charge of Rev. W. H. Brunson, pastor of the Ayden Christian church, assisted by Rev. A. C. Noe, rector of the Episcopal church of Ayden.

Active pallbearers were Hal Edwards, Howard Sumrell, John Burgess, Ashley Harrington and Russell Britt.

Mayor's Proclamation

"I therefore call upon former members of the Red Cross to renew their membership during the ROLL CALL next week, and urge those who have never hitherto been members to enroll their names with those who are fighting disease and disaster and need under the banner of the AMERICAN RED CROSS, to the end that the Pitt County quota of 1500 members will be reached." LEAF SALES MOUNT HERE

Total Poundage on The Local Market Drawing Near Fifty Million Mark

Sales on the Greenville tobacco market today were pushing toward the fifty million mark, with indications that the figures would be passed probably during the next week.

The official report of K. W. Cobb, market supervisor, made public today, placed season's sales at 49,112,336 pounds for which growers were paid \$15,567,240.50, at an average of \$31.70 per hundred pounds.

The sale yesterday, the report of the supervisor disclosed, was one of the heaviest of the week, 419,604 pounds of leaf having been offered on the various warehouse floors. Farmers were paid \$123,919.93, at an average of \$29.53 per hundred pounds.

The heaviest sale of the week was recorded Monday, when over seven hundred thousand pounds of leaf was offered for sale.

In view of the fact that the bulk of the crop has already been marketed, sales from now on will be comparatively light, and the million pound days experienced during the early and middle part of the season are a thing of the past.

ARMISTICE DAY OBSERVANCE BEGINS SUNDAY

R. L. McMillan of Raleigh to Deliver Address at College Monday Morning

The two-day celebration of Armistice day will begin here tomorrow with brief services commemorating the end of the World War in the various city churches, and will end Monday afternoon with a football game at East Carolina Teachers college.

R. L. McMillan, of Raleigh, distinguished lawyer and former soldier, will deliver the principal address of the occasion at exercises in the Audin Auditorium at East Carolina Teachers college Monday morning at 11 o'clock.

J. H. Rose, commander of Pitt County Post of the American Legion, made public the complete program of the observance here today, and called on all employers to permit former service men to attend the exercises Monday.

Members of the Legion will appear at the various city churches tomorrow morning for a ten-minute service commemorating the end of the great conflict overseas and the sacrifices which American soldiers made in behalf of the cause. The services will begin at 10:45. The program will consist of a roll call of the dead, reading of appropriate poem and sounding of taps by buglers.

In addition to the address by Mr. McMillan at the college Monday, a special musical program will be provided under the direction of Miss Koykendall, head of the college music department. After the speaking a barbecue dinner will be served in the basement of the campus building at the college. Gold Star Mothers and members of the Legion Auxiliary will be special guests of the Legion as well as the local chapter of the Daughters of the Confederacy. R. C. Flanagan and members of the Board of Aldermen will also be honored guests.

East Carolina Teachers college and Louisburg will furnish entertainment in the afternoon with a football game on the college athletic field.

Graham Heads Council Washington, Nov. 10.—(AP)—President Roosevelt today appointed an advisory council headed by Dr. Frank Graham, president of the University of North Carolina, to assist the committee on economic security in formulating its recommendations for social insurance.

The council will advise in the development of a program for unemployed insurance, old age security, and adequate health care. The social insurance program of the president will be presented to the forthcoming session of the new congress. So far it is in a drastic form, subject to final shaping.

THREE HELD IN KIDNAPPING OF CHAS. URSCHEL

Mrs. Clara Seldman Son and Daughter Nabbed With Part of Ransom Money

Portland, Oregon, Nov. 10.—(AP)—Mrs. Clara Seldman, her son and daughter-in-law were brought here early today by federal agent C. C. Spears who said \$11,000 of the ransom money in the Charles Urschel kidnaping case was found at their home in Dunsmuir, California.

This made more than \$3,000 of the repaid Urschel ransom money recovered in Oregon and California during the past week. In that time five persons have been taken into custody in connection with the \$200,000 kidnaping of the Oklahoma City oil magnate for which 15 persons are serving prison sentences.

A few hours earlier a missile, believed to have been a bullet, cracked the windshield of an automobile in which Mrs. Margaret Hurtienne, sister of Mrs. Seldman, was being spirited from Eugene to Portland.

Mrs. Hurtienne was housekeeper for Alton Scott, of Medford, and both are charged with conspiracy in concealing the ransom paid for the release of Urschel who was kidnaped in July, 1933.

Mrs. Seldman was arraigned before a United States Commissioner at Eugene, Ore., late yesterday and bail was set at \$25,000.

Mrs. Seldman gave her name as Clara Davis or Mrs. George L. Davis, 39. Her son gave the name of Ed Seldman, 20. Spears indicated he would be taken before a United States commissioner here late today and young Seldman's wife probably will be released.

CONVENTION OF DISCIPLES CLOSES HERE

State Membership Well Represented at Three Day Session In This City

Disciples State Convention came to a close here last night with over 650 registered attendance, representing well their membership in the state from Asheville to Elizabeth City.

Jessie Trout, associate of the famous Japanese, Kagawa, told of the mission work of Disciples in Japan. Rev. L. B. Scarborough, rural pastor at Bath spoke on rural church grouping, showing the necessity of it for conserving and developing the rural Disciples. He has twelve hundred members in an area within a circle of eleven miles diameter. He spoke of other highly successful groups such as that of Rev. Roy O. Respass of the Creswell field.

Rev. C. M. Yocum of Indianapolis, Ind., head of the Foreign Department of the United Christians Missionary Society, spoke on problems of world missions. The Disciples have missions in many foreign countries. Rev. A. R. Liverett, Secretary of the Disciples Church Extension Board, spoke on the work of his Board which grants loans for church building for American Disciples. The loan fund of his board now exceeds three millions of dollars and is one of the largest of such funds in America.

The Youth Banquet held here last night overflowed the dining room of the local Christian church with hundreds in attendance. Miss Georgia Brewer, of New Bern, presided with a program of pep songs and booster speeches for the annual youth conference to be held next June.

Rev. John Barclay, of Wilson, at the concluding session of the convention made a special address to youth. Rev. Barclay condemned the profit motive which initiates and agitates war. He spoke of an "awful depression in religion and morals." Belief in God is being openly attacked by secularism, mechanism and humanism. Christians seem to be trying to follow both Wars and Christ. However, there is a rising tide of pacifism among Christians.

Rev. C. B. Mashburn, of Farmville, was elected President of the next State Convention, and Rev. John L. Goff, of New Bern, vice-president. For officers of the State Board, W. C. MANY IDEAS REPORTED AS CONSIDERED

Wholesale Shifting of Unemployed From Direct Dole to Work Relief Receiving Attention; Government May Back Business By Increasing Employment

Washington, Nov. 10.—(AP)—There were definite signs today that the Roosevelt administration planned fundamental alterations in its relief program. The president may disclose them in his next "fireside chat" with the nation early in December.

Several ideas are under discussion among his prominent assistants. So far as is known, none had yet received the approval of the man at the top.

One program already brought to public notice called for the wholesale shifting of unemployed from the direct dole to work relief. At present half of the 17,000,000 people being assisted are getting direct relief. Another suggestion which has just been disclosed is that the government might get millions off the relief roll by offering to guarantee private industry against loss if it speeds up production.

The authors of this plan which had not been worked out in detail, say that the purchasing power of those who get the new jobs would absorb the increased production.

The theory is that if the government stands the risk, business will be willing to go ahead and with purchasing power revived, the possibility of loss will be small.

Various methods of putting the plan into effect are under study. Under one of them, the government would determine the normal demand for staple commodities and offer to buy any commodity in that industry which could be absorbed by the market. If the thing were worked out properly the government would not have to buy much, some proponents believe.

Another proposal gaining favor in government councils is to lead to a large number of families at one shot to take them off relief and make themselves supporting.

News Behind The News.

Washington By GEORGE DURNO Credulity: The master minds are in a huddle figuring out how best to nip the movement for immediate full payment of the bonus before it gets too much momentum.

One group has a plan they believe to be a natural. They intend to urge it as against the first compromise idea of offering to cancel all interest on the 50 per cent bonus "loans" already acquired by the veterans, which interest would eat up most of the balance due by 1945.

Briefly, the plan involves immediate bonus payment—on a basis of its 1935 value—only to veterans, with dependants, who are proven to be in dire need. Federal Relief Administrator Hop-

kins would certify to the Veterans' Administrator Hines the names of such men. Political consideration would be removed by providing criminal penalties for relief officials making false certifications or veterans making false claims of need.

The average bonus remaining credited to the vets amount to about \$500. This could be paid in installments running over 5 or 6 months which would carry them into the summer. Federal relief rolls would benefit by not having to support them during that period and they would have an extended time in which to find jobs.

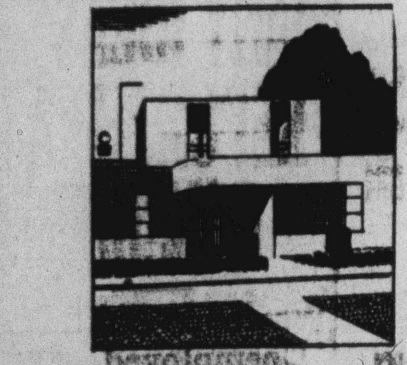

A TRIBUTE TO THOSE WHO NEVER CAME BACK

Written in the Meuse-Argonne in the Afternoon of November 11th, 1918

(On the morning of Nov. 11, 1918 our Division went over the top at 5:30 a. m. Between that hour and the time the signal came to cease firing at 11 a. m., we had lost several hundred men. The afternoon was spent in burying our fallen comrades, and it was while performing this duty that I came upon a grave on whose cross I found the identification tag of a pal that enlisted when I did on the evening of June 24th, 1916, in Company "K," Wilson, North Carolina. It was by his grave that I wrote the following verses, which later appeared in Colliers.)

Into the woods I went today—
Thinking of friends o'er the sea:
Of that Mother of mine, and
That girl of mine
Who are waiting, and praying,
For me.

And out in the woods I found
a cross:
Oh! how I gasped for breath,
For it told me that a pal of
mine
Had closed his eyes in death.

Oh! Pal of mine, that little
cross tells
That you hath done what you
could,
And now you are sleeping that
peaceful sleep
Out there in the lonesome world.

You fought the fight as a hero
fights—
You fell as a hero would fall:
You were always ready to do
or dare;
Always obeyed duty's call.

And the heart of that Mother,
back home, Pal of mine,
(Though it now seems broken
for good)
Will soon beat with pride for
her boy who has died
And rests 'neath that cross
in the wood.

For you gave your life for the
Stars and Stripes
That they forever might wave
O'er America, the land that you
loved,
"The home of the free and the
brave."

And your deeds, Pal of mine,
will always live on,
As all things do that are good:
Though your body doth rest
'neath that little gray cross
Out there in the lonesome wood.

The drought in the United States is benefitting ship owners of Japan whose vessels are carrying grain from Australia and South America to this country.

The Golden Gate Bridge, which is the only one ever authorized to be built across the outer month to a major ocean harbor, will cost \$35,000,000, according to estimate.

The First Armistice Day

AN INCIDENT IN THE TRENCHES

The precise, efficient lieutenant smiled. The war was over. The guns of his company had just spoken. He had done his bit well, perfectly to the last detail.

The echo of the volley died away. His soldiers, the weight of war lifted suddenly from their weary bodies and weary souls, leaped from the trenches and stood there in the open, waving their hands in delightful relief and joy, and shouting:

"The war's over! Armistice! The war's over!"

From across no-man's land poured suddenly the deadly lead of a dozen machine guns.

Seven soldiers of Lieutenant C's command fell dead.

The smile faded from the lieutenant's face. What was happening? Was it not Armistice? Was not the war ended? But the Germans were still firing! They had killed his men!

No Armistice Here

The officer ran down the trench to where another officer stood. Even as he ran, the entire line of New England soldiers rang with a simultaneous fire.

The records tell he was killed in action, but the records may be wrong.

He fell at Bras. A bullet, straight and true, found his head; but no enemy fired the shot. It came from . . .

Call him Lieutenant C. To name him might hurt those who cherish his memory in hearts that still grieve.

Many survivors of the gallant 26th Division, U. S. A., recall, perhaps, the bustling, efficient lieutenant. He was so precise, so exact; a stickler for detail.

Even before the dawn of November 11, 1918, soldiers along the line held by the 26th division northwest of Bras knew it was Armistice Day; that the war was to end at 11 o'clock that morning.

A Final Volley

Orders went down that a final volley should be fired at one minute before 11. It was to be a thundering adieu to War and a jubilant halloo to Peace.

Lieut. C noted the orders with care. Precise and exact, intent upon maintaining his reputation for detail to the very last shot, he made ready.

Palmstakingly he issued orders for the gunpowder regimen to horrible war. For hours before the time set he glanced frequently at his watch. When the moment came his order would be spoken, as always, on time to the very second.

Exactly on the dot, as shown by his watch, he gave the command to fire.

Farewell to Arms

The guns responded, roaring farewell to arms.

To the officer, Lieutenant C said:

"Lieutenant, tell me—in God's name tell me—what time is it?"

The officer glanced at his watch. It was exactly one minute to 11 o'clock.

Lieut. C—white and shaking, looked at his own time-piece, strapped to his wrist. It was five minutes past 11.

He walked slowly back to his company. The seven men who had shouted their joy short minutes ago lay there dead.

End of the War

Along the entire line—around the entire world—war-fatigued people screamed, danced, cheered, went mad with joy.

The Armistice!

The war is over! It is over, over, over! I tell you, the war is over!

Lieutenant C—stood beside the seven dead.

Slowly, precisely, expertly, he drew his pistol from its holster. Up ahead down the line there was such pandemonium as few generations know. Leaping, running men were shouting, crying, laughing:

"The war is over!"

The lieutenant put the gun to his head and pulled the trigger.
