DISORDERS MARK ARMISTICE DAY IN FRANCE

Several Clashes Occur Between Rival Factions

GUN FIGHTS TAKE PLACE OVER COUNTRY

Several Persons Injured by Disturbances in Paris and Other Cities of Nation; Demonstrations Against Herriot Cause Police to Guard His Hotel

Paris, Nov. 12.—(AP)—Armistice Day was the signal for renewed outbreaks between rival French political organizations, their hatred fanned by the fall of the Doumergue government.

Gunfights in Paris and street brawls in several other cities and towns punctured the nation's homage to her war dead. Several persons were injured.

There was a general fight at Lille when nationalists cheered a crude parade of socialists which formed on an anti-fascist front.

There was rioting in front of the memorial to war dead at Narbonne with communists and their opponents exchanging blows. Demonstrations against Edouard Herriot, former premier, held responsible by many for the downfall of the Doumergue government, occurred in Paris and Lyons.

Police repeatedly broke crowds in front of the hotel where Herriot lives when in Paris as they shouted for him to resign from the present cabinet. Herriot was hoisted in the city of Lyons at the conclusion of a speech. A police guard was thrown about his hotel at night.

The day was turned into something of a demonstration for the elderly Gaston Doumergue, former president, who resigned last week as premier. Nationalists' organizations paraded past his Paris home.

TWO INJURED IN AUTO MISHAP

Jesse Warren, who resides a few miles north of Greenville, was in the local hospital today suffering from a fractured skull and other injuries which may prove fatal, it was said.

Jim Hedgepath, who lives on the Southernland farm at Cottontale, suffered severe cuts about the head and face but was not believed seriously injured. When police carried him to the hospital about 2 o'clock this morning, he made an effort to escape but was later picked up about two blocks from the hospital and returned for medical aid. He was said, however, to have escaped early this morning.

With the car traveling at what police described as a "high rate of speed," Hedgepath was said to have lost control of the machine, which turned over four times on the pavement before coming to a stop.

The youths were pinned under the machine and were extracted by passersby who notified police. An ambulance was dispatched to the scene of the wreck and the young men rushed to the hospital for medical attention.

Police said the car, which belonged to Hedgepath's father, was almost completely wrecked.

Late News Flashes

Mooney To Get Hearing Washington, D. C., Nov. 12.—(AP)—The Supreme Court today ordered California to show within forty days why a review should not be granted Thomas Mooney in his eighteen-year campaign to escape serving the remainder of his life sentence for complicity in the 1916 San Francisco preparedness day bombing.

Through his attorneys the fifty-year-old San Quentin penitentiary convict asked that he be brought to Washington in an effort to convince the court he was convicted on perjured evidence following the death of ten persons and injury to 44 in the bombing.

He declared the State admitted the evidence was perjured but was powerless under its status to set aside the verdict if there had been no error of the law in the trial.

Mooney originally was sentenced to death, but it was commuted to life imprisonment following a plea from President Woodrow Wilson and others.

Once before, in 1918, the Supreme Court refused to interfere in the Mooney case. It declined to pass on the refusal of California court to grant him a new hearing.

Mooney had sought unsuccessfully to obtain a writ of habeas corpus from the lower Federal Court before he appealed to the higher court.

SEN. BAILEY IN LINE FOR A PROMOTION

North Carolina Senator May Become Chairman of Commerce Committee

Washington, D. C., Nov. 12.—(AP)—A process of elimination today put Senator Josiah W. Bailey of North Carolina in line for chairman of the Senate Committee on Commerce in the new Congress.

The position would be a promotion for the Tar Heel who is now chairman of the Claims Committee. Bailey's prospective promotion comes as a result of defeat in the primaries of Senator Hubert Stephens of Mississippi by Theodore Bilbro. Stephens who was chairman of the Commerce Committee, in the last Congress.

Although Bailey ranked first for the Commerce Committee, there are three Senators ahead of him holding important committee chairmanships, and it was held here that they would prefer their present posts.

The ranking member of the Commerce Committee is Senator Fletcher of Florida, who is chairman of the Banking and Currency Committee. Next in line is Senator Shepard of Texas, who hands down the chairmanship of the Military Affairs Committee. Senator Copeland, of New York, is chairman of the Rules Committee.

RALEIGH MAN ARMISTICE DAY SPEAKER HERE

R. L. McMillan Explains Effort of Legion to Take "Profit Out of War"

Pointing to efforts of the American Legion to take profit out of war, R. L. McMillan, of Raleigh, prominent member of the State Bar Association and a former soldier, delivered the principal address at Armistice Day exercises in the Austin Auditorium at East Carolina Teachers College this morning at 11 o'clock.

The address was the climax of a two-day celebration of the ending of the great World War, which began yesterday with brief services at all city churches and came to an end this afternoon with a football game at East Carolina Teachers College.

"One of the major portions of the American Legion National Legislative program," said Mr. McMillan "is the universal draft, the purpose of which is to take the 'profit out of war,' and one million Legionnaires in 10,000 posts scattered throughout this land and in ten foreign countries, together with the auxiliary members, call upon the citizens of the nation to see to it that Congress enacts an Universal Draft law. In the opinion of Legionnaires, peace advocates can accomplish more by supporting Universal Draft than by criticizing Armistice Day parades."

Referring to America's entrance into the World War, Mr. McMillan said:

"Determined that representative government would not perish from the face of the earth and listening to the cry of Belgium and the call of bleeding France, the soul of America was revealed to the allied cause.

The central powers considered themselves invincible, but the challenge of the invincible has been the chief moving power of youth, the spirit of abandon young America went to war. With a song on his lips, with a smile on his face, with courage in his soul and with steel in his eye, the American youth went forth to face the horrors of war, to follow the flag wherever it might lead, to the howling winds of the submarine-infested seas or to the muddy trenches in a foreign land.

"We make no assertion as to why we won the war because we know that the allied forces won the war, but we shudder to think of the fate of civilization had America not gone to war. Soldiers of France, descendants of those men who, with Napoleon, had swept across the face of Europe, were being pressed toward Paris. Italian locking down from the towering tops of their bordering mountains, wondered how long they could hold. Russia was stunned and demoralized. Australians and Canadians, great soldiers, were hurling themselves with abandon against an ever-advancing army. The Scots from the Highlands, with their plaid skirts known as the 'Ladies from Hell,' whose forefathers had sought out wars in which to fight, wondered why with brave Britishers, they could not stop the advancing hordes of Huns.

"It looked as though the fates were with the Hohenzollerns. People who had never prayed before prayed that the Americans would come. And America heard their cries and prayers and Americans came.

"Steel, though it was, the German line could not hold against the allied army after the entrance of the American soldiers, and on to Paris was changed to on to Berlin. Do I say that America won the war? I do not. I say only that the Germans were defeated."

CHECKS FOR COTTON HERE

Farm Department Paying Out \$24,071 To Contract Cotton Growers

Cotton growers who took advantage of the government acreage curtailment plan were moving toward the farm office here today to obtain their share of \$24,071.36 in cotton checks which the government forwarded here the latter part of last week.

E. F. Arnold, director of the Farm Department, said today notices of receipts of the checks had been mailed out to 1,078 growers who took part in the deduction campaign and he expected the greater part of the checks to be in the hands of the growers by the middle of the week.

This is the second consignment of cotton checks received by the office during the last few months, but it isn't the end by any means. Mr. Arnold said about 400 checks are yet to come, and as soon as they reach his office he will immediately notify growers of their receipt.

Mr. Arnold said growers would also receive checks for one cent a pound or 40 per cent of their crop under contract. Checks for this amount are looked for this afternoon.

Mr. Arnold said his office was also ready to deliver the second batch of tax exemption certificates to 1,300 cotton contract signers. This is a second allotment and is for small growers.

Claude Barnhill, 51 prominent farmer of the Oak Grove church area in the Stokes community, who died Friday night at 9:45 after an illness of two weeks, was laid to rest Sunday afternoon.

Perry, pastor of the Christian church at Robersonville and burial followed at the home place of his late father, J. R. Barnhill, Greenville Masonic Lodge No. 284, of which the deceased was a member, was in charge of the rites at the grave.

A large crowd of relatives and friends from all sections of the county attended the funeral and a wealth of flowers told of the high esteem in which Mr. Barnhill, one of the most prominent farmers of his community was held.

MILLIONS PAID FOR AIDING IN CROP CONTROL

State Tobacco, Cotton, Wheat and Hog-Corn Contract Signers Receive One Fifth of \$25,285,531 Paid Out by Government; Pitt County Farmers Receive Total of \$482,927

Washington, D. C., Nov. 12.—(AP)—North Carolina tobacco growers have received one-fifth of the \$25,285,531.47 the Agricultural Adjustment Administration has paid out in rental and benefit payments to the farmers who co-operated in the weed control plan. Tar Heel weed growers, the administration announced, have been paid \$5,562,064.77 of the total, or more than 20 per cent.

Rental and benefit payments totaling \$10,606,724.11, the department revealed, had been paid up to October 1 to North Carolina farmers who co-operated in the tobacco, cotton, wheat and hog-corn adjustment programs.

Cotton farmers who co-operated in the cotton plan have been paid \$4,894,484.01, while participants in North Carolina's hog-corn program received \$1,087,111.08. Wheat growers, small in number in the Heel State, have been paid \$41,484.94 for their co-operation.

Rental and benefit payments up to October 1 in the tobacco and cotton adjustment programs were as follows and cotton adjustment programs here as follows by North Carolina counties:

Beaufort—Total, \$136,010.90; cotton, \$26,328.40; tobacco, \$109,682.50.
Fibber—Total, \$482,927.43; cotton, \$92,487.00; cotton, \$390,439.99.
Wayne—Total, \$533,023.32; cotton, \$121,294.33; tobacco, \$196,628.99.
Wilson—Total, \$373,512.62; cotton, \$108,610.24; tobacco, \$263,907.

E. F. Arnold, director of the local Farm Department, today called on tobacco growers of the area to give strict attention to the marketing of their scrap tobacco and to be sure that all such sales are entered on their allotment cards.

Referring to scrap tobacco which some growers are reported to have sold to "tobacco bootleggers" without receiving a record of the sale, Mr. Arnold declared it would be absolutely necessary for all such growers to enter the sales on their allotment cards before they receive government benefit payments.

Growers who are unable to account for all of their sales, the Farm Director said, will lose their benefit payments and will be required to pay the 25 per cent government tax against all tobacco sold and not properly accounted for.

He said instances had been called to his attention where growers had sold scrap tobacco to bootleggers without receiving slips giving a permanent record of the sales. Paris Cemetary Now Has 20,000 Canine Graves

Paris.—(AP)—The twenty thousand dog has just been buried in the Paris cemetery which claims to be the biggest of its kind in the world.

The cemetery is located on Dog Island, in the Seine, once noted as the rendezvous of murderers and bandits. But since the beginning of the century it has been used as a canine graveyard where the pets of famous Frenchmen are interred.

Some of the epitaphs on the graves are affectionate, some tearful, and many of them grotesque and exaggerated.

"If thy soul, Sappho, dies not accompany mine," says the inscription on one stone, written by a former master. "I do not wish any immortality for myself."

"As for myself," says another, "I believe that in the Perhaps, in the Elsewhere, for which we hope, all good dogs will await their masters."

All reference to religion, however, is barred and quotations from the Scriptures are forbidden.

Around Three Hundred Thousand Lbs. Of Tobacco Sold on Local Market

With around three hundred thousand pounds of tobacco on the local warehouse floors, sales were completed around the noon hour today and tobacco men and farmers turned their attention to the annual observance of Armistice Day.

The market, like others of the state, did not close for the observance of the end of the World War, and in view of this fact, local banks also remained open to take care of the hundreds of patrons who sell tobacco here.

With season sales passing 49,000,000 pounds Friday, it was expected the fifty million pound mark would be reached during the week.

The bulk of the crop has already been sold and sales from now on will be comparatively light. Sales tomorrow are expected to be as large if not larger than today, although million pound days experienced during the height of the season are things of the past.

Melbourne Buys Wrong House As Australian Shrine

Great Ayton, Yorkshire, England.—(AP)—More than a year after the Victorian government bought a cottage here as the boyhood home of Captain James Cook, famous 18th century explorer, the local parish council says Cook never saw the house.

The Australian state paid \$4,000 for the house, tore it down stone by stone, and shipped it to Melbourne for re-erection as a part of the centenary celebrations.

The parish council's doubts about the cottage have just been voiced as an obelisk was to be unveiled here marking the site. It kept its silence before because it wasn't consulted when the sale took place.

Captain Cook joined the British Navy in 1775, the year when the parish council claims to house was built his parents.

"It is doubtful," the council has said in a statement, "whether Captain Cook ever visited the cottage during his parents' residence there."

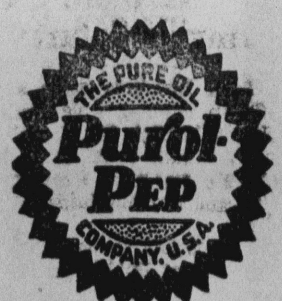

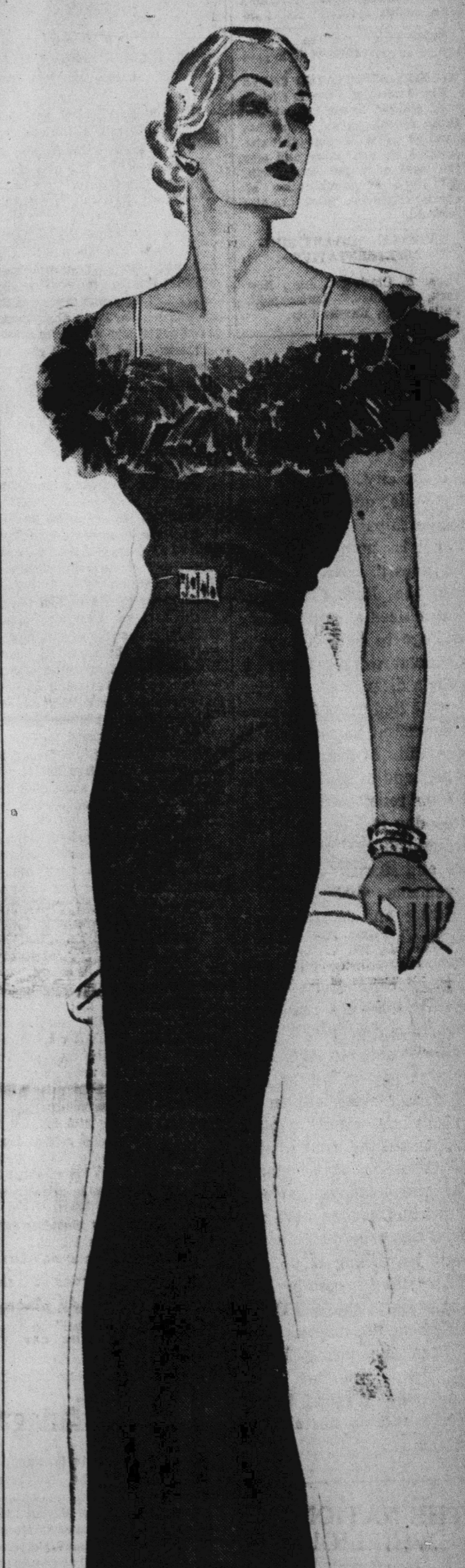

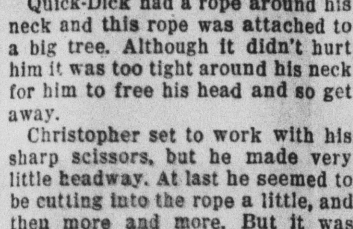

Quick-Dick had a rope around his neck and this rope was attached to a big tree. Although it didn't hurt him it was too tight around his neck for him to free his head and so get away.

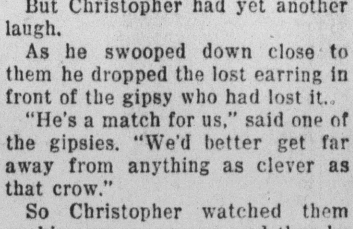

Big money has its own ideas about Government and they aren't yet New Dealers. In every campaign cash is poured into the attempted election of those with so-called conservative minds.

But the financiers and industrialists would be content in these times of readjustment to know that those in power were definitely regimented and controlled from a single push-button. Business men decidedly want a return to the old days when two parties fought each other every two years and subsided to an understandable routine in the interim.

Justice: The thinning ranks of tobacco chewers in the U. S. Senate—led by Senator William J. Bulow, of S. C., who claimed he was funnier than Will Rogers but hasn't got around to proving it—are heartened by "Honest Vic" Dahey's election in Ohio.

Notes: The new Congress will not be as wild as expected—FDR will hold a firm grip. The second chapter of the New Deal about to be unfolded reveals that relief must be permanent. New York BY JAMES McMILLIN Survival: The principal effect of the New Deal election sweep on New York was to strengthen the armistice between Washington and Wall Street. The tidal wave of votes melted such financial opposition as had resisted Moley's missionary work. White House chats with New York leaders and the banker's convention love feast. It isn't that the conservatives are any fonder of New Deal heresies. Rather it's a case of realizing at last that surrender is preferable to suicide.

The main worry now is whether the leftist strength in the new Congress will force the President away from his current conciliatory attitude toward business and finance. Most insiders believe he will do his best to keep the lions caged as long as big bankers and business men show willingness to pull their full weight for reemployment and recovery.

This doesn't mean that Wall Street has permanently abandoned hope of recapturing the reins of government. But the men who talked so confidently about a "return to sanity" in 1933 now concede that their dream cannot come true before 1940. Meanwhile they recognize that adaption to the popular mood is the key to their survival until then.

DUKE READY FOR BATTLE WITH U. N. C.

Durham, N. C., Nov. 12.—The memory of those eight straight heart-breaking defeats from 1922 through 1929 still rankling, Duke followers are hoping the Blue Devils will add another toward evening the score when they invade Chapel Hill Saturday for their 1914 classic of classics with the University of North Carolina Tar Heels.

There was little for the Duke alumni to stay from 1922, when relations on the gridiron were resumed by the institutions through 1929. Every year the Tar Heels would defeat the Blue Devils, regardless of how much Duke was favored to beat them.

In 1927, for instance, after Duke had lost the State championship to N. C. State by a 20-18 margin in one of the greatest games ever offered in North Carolina, the Tar Heels, in the midst of a bad season, came over to old Hanes field and administered an 18-0 thrashing to the Blue Devils.

During that long string of defeats, it was a common saying among the experts that any team could defeat Duke by wearing Carolina uniforms. The only satisfaction Duke followers could obtain was to say: "Wait until next year."

That long-awaited and long-expected "next year" did not come until 1932 when Duke defeated Carolina at Chapel Hill 7 to 0. However, in 1930, an victory string was ended, when the two teams battled to a 0-0 deadlock in a sea of mud and the following year again they fought to a scoreless tie in Durham.

Last year Duke's greatest team of modern history defeated a hard-fighting Carolina team, 21-0, for their most decisive victory in history over a Tar Heel eleven. Carolina has twice defeated Duke by a margin of 41 points, first in 1923, 41-0, and again in 1929, 48-7.

N. C. ROUTE TO PARK CHOSEN

Sec. Ickes Announces State Will Get Entrance to Great Smoky Park

Washington, D. C., Nov. 12.—(AP)—Secretary Ickes announced today he had chosen the so-called North Carolina route, for the southern section of the Shenandoah and Great Smoky Mountain National Park Phoenix Highway. The secretary overruled the findings of the board of three which recommended that the route suggested by Tennessee. The selected route runs from Blowing Rock south of Linville city along the Blue Ridge and the Mount Mitchell and Craggy range near Asheville, N. C., thence into the Mt. Pisgah range and northwest on the line along the range of Waynesville with an entrance into the park at a point where it will connect with the Newfound Gap highway near Cherokee, N. C.

Ickes, who made known his decision in a letter to Governor J. C. B. Ehringhaus, of North Carolina, and Governor Hill McAllister, of Tennessee, said his selection was influenced by the fact that there is now a well-established entrance to the Great Smoky Mountain National Park at Gettysburg, Tenn.

The secretary added there was little to choose between the North Carolina and Tennessee routes from the Phoenix standpoint, and other than being equal it seemed unfair that Tennessee should have the sole entrance to the park from both west and east.

Seeks to Contact Kidnappers
New York, Nov. 12.—(AP)—A. E. Distelhurst, of Nashville, Tenn., was to New York today hoping to establish contact with the kidnapers of his six-year-old daughter, Dorothy Ann, missing for nearly two months. Distelhurst said at his hotel he had come to New York City in accordance with ransom note instructions. He said he was awaiting further contacts with the supposed kidnapers and that he expected some contact would be made today.

State Seeks Siles Reynolds Fortune
Winston-Salem, N. C., Nov. 12.—(AP)—The State of North Carolina today stepped into the litigation over the \$250,000 estate of the late Siles Reynolds, seeking to cut a large slice of inheritance taxes from the fortune before it is divided among the heirs.

Attorney-General Dennis G. Brummett filed an intervention in Forsyth county on petition of A. J. Maxwell, commissioner of Revenue. Judge A. McElroy signed the order granting the State petition. That a compromise settlement of the State in the case was indicated by the appearance in court of an attorney representing several of the litigating parties. They jointly asking that the motion of the Brummett Banking and Trust Company be set for a hearing this week and that the court set Friday and Saturday at which time all parties are to be represented and arguments heard.

The amount of inheritance tax to be paid by the State will depend on the manner of the disposition of the estate. The court is asked to determine the right of the various parties and amount of taxes to which North Carolina is entitled.

It was learned that the inheritance tax would amount to about \$2,000,000 in a three-way division; that is between Ann Cannon Reynolds, Christopher Smith Reynolds and Laby Holman Reynolds.

Court Orders Sheriff Arrested.
Fort Payne, Nov. 12.—(AP)—Sheriff W. F. Pope of DeKalb county today was sighted for contempt of court by Judge A. E. Hawkins, presiding in circuit court, for alleged failure to obey orders of the court in an inquiry into last Tuesday's general election.

Sheriff Pope was ordered to appear for a hearing tomorrow at 10 o'clock. The citation also ordered that three officials, all Republicans, would be ordered arrested in connection with the election investigation for which national guards had been ordered out to preserve order.

The grand jury investigation grew out of alleged violations of election laws and refusal of the county elections board to count absentee ballots which Democrats claimed would give them a clean sweep of the county offices, dispossessing the ruling Republican party.

Sends Troops to Martial Law Zone.
Phoenix, Nov. 12.—(AP)—Arizona National Guardsmen were ordered to mobilize and to proceed tonight to the Arizona line at the Colorado River at the Parker Dam site to take control of a zone of which Governor B. B. McCreary declared martial law.

Major Leroy Mayrick under whose directions the troops will be moved said they would be in Parker by morning.

Parker is eighteen miles between the dam site, and from that point the guardsmen will move by boat up the river.

Failing to hear from Washington that work on the project had been held up pending settlement of Arizona's claim; the chief executive went to the national guard army where the troops prepared for a Armistice Day parade and ordered them to proceed to the martial law area.

Saloonist's Plaint Last Straw Load On League Pact

Wasaw.—(AP)—A Silesian German's complaint to the League of Nations' complaint to the League of Nations that the route of a new national highway diverted patronage from his saloon, was a "last straw" factor behind Poland's enactment of a new stand on the minorities treaty.

His contention was considered trivial, but it had so many counterparts that Polish officials felt they must stop these sources of almost continuous annoyance.

Third of Nation Allies
This foreign Minister Beck did when he told the League of Nations that Poland would no longer cooperate in international control of Poland's obligations toward national minorities.

About a third of Poland's 32,000,000 inhabitants fall in that category. There are 5,500,000 Ukrainians, 3,000,000 Jews, 1,000,000 Germans, 1,500,000 "White" Russians and scattering Lithuanians, Russians and Czechs.

Poland was one of the post-war nations which on June 28, 1919 signed a special treaty with the Great Powers giving minorities the right to appeal to the League on all

leged violations of their rights.
Even in 1919 the pact was considered here as humiliating. Since then antagonism has greatly increased, not only because of the saloon-keeper, but because Poles have increasingly entertained visions of a greatness equal to that of other nations.

Beck Scores Triumph
Beck's statement before the League found widespread support in Poland and his return from Geneva was akin to a triumph.

"The minorities," he said, "has reaped no real profit from this system of international protection. On the other hand it has been used often as instrument of malicious propaganda against countries to which it has been applied.

"What is still worse is that it also has been used as a medium of political pressure by countries of which, not being bound themselves by any obligations in this regard, have taken advantage of their rights under it to attempt to control affairs in countries where minorities did exist.

Cleaning Transforms Cathedral
Luebeck, Germany.—(AP)—Fall cleaning in the old Luebeck Cathedral uncovered thirteenth century Romanesque columns. Workmen had to scrape away salt deposits and in doing so removed modern veneer. The entire interior appearance was changed.
