MAN KILLED IN WRECK BURIED

Final Rites For Bennie James Held Near Stokes This Afternoon at 2:30

Funeral services for Bennie James, 25, of the Cottontale community, who was killed when the automobile in which he was riding turned over on the Washington highway Sunday night, were conducted at the family burying ground near Stokes this afternoon.

The body was carried to S. G. Wilkerson & Sons' Funeral Home shortly after death at the local hospital yesterday morning at 2:30 o'clock and the procession moved from there this afternoon at 1:30.

Young James died of a fractured skull sustained when the car went out of control on a downgrade curve about six miles from Greenville and turned over four times. James Hedgpath, the second occupant of the car, escaped with only minor injuries. Both were brought to the local hospital for medical attention and attached said at the time James had little chance to recover.

James, originally of the Stokes community, had been living in the Cottontale community for sometime. He was engaged in farming. He is survived by his wife, his mother, four brothers, a sister, and other relatives.

Police Court Postponed

Wednesday Session Deferred Until Saturday; Only Two Cases Docketed

With only two cases on docket, the regular Wednesday session of police court was postponed this morning until Saturday morning. It was made known by George Clark, chief police.

Mr. Clark said the postponement was ordered when witnesses in the two cases failed to appear. Each of the charges of a minor nature, the chief said, and only a short time is expected to be entailed in trial.

Mr. Clark said no arrests of any importance had been made by his men the last few days, and this accounted for the smallness of the docket. However, if everything runs true to form, the docket by Saturday morning ought to be sufficiently large to entertain the court for a couple of hours.

LEAF GROWERS DOUBLE MONEY THIS SEASON

Crop Reporting Service Gives Greenville Largest Producers Sales in October

Raleigh, N. C., Nov. 14.—(AP)—Tobacco farmers of North Carolina received more than twice as much per pound for tobacco they sold in October this year as they got for what they marketed in the same month in 1933, the Federal-State Crop Reporting Service announced today.

Sales last month by producers aggregated 116,328,169 pounds for which an average of \$33.70 per hundred pounds was paid. In October, 1933, the sales were 172,608,443, about 56,000,000 pounds more, but the average price paid was only \$14.99 per hundred.

The farmers of the State have thus far this season marketed 325,032,381 pounds of tobacco for which the Crop Reporting Service estimates they have been paid \$110,000,000. It is figured that 71.2 per cent of the season's crop has been sold.

The returns from tobacco this year already aggregate the second highest in the history of the State.

In October the State in average price with \$35.1 per hundred being paid for 71,897,863 pounds. Fairmont, the only market remaining open on the border belt, had the poorest average, with \$18.46 being paid for 615,492 pounds, but the average last month was \$6 higher than the \$12.64 paid in the same month in 1933.

Farmville led all markets of the State in average paid in October farmers getting \$35.90 per hundred pounds for 5,070,890 pounds sold there.

Closely behind came Rocky Mount with an average of \$35.84 for 11,181,586 pounds and Greenville averaged \$35.81 for 17,493,708 pounds.

Greenville showed the most producers' sales in the State in October, but Wilson led all markets of the State in total aggregate sales for the season, November 1.

Sales by markets follow: Greenville—Producers' sales, 19,491,384; average 1934, \$35.81; 1933, \$16.44.

Washington—Producers' sales, 935,320; average 1934, \$33.75; 1933, \$14.42.

Wilson—Producers' sales, \$14,336,622; average 1934, \$35.44; 1933, \$15.41.

LEE COUNTY OFFICERS SEIZE TWO WHISKEY STILLS

Sanford, N. C., Nov. 14.—During the week-end, Lee County officers were busy hunting for illicit whiskey stills. They succeeded in seizing two.

Friday afternoon Deputies M. J. Thomas, Owen Taylor and Henry Poe located a still near the Carabon road, about five miles from Sanford. They destroyed the plant and poured out about 800 gallons of beer which they found. The operators were not at the plant.

Saturday morning Deputies Thomas and Poe located another still in the same neighborhood, finding about 100 gallons of beer, made from cane molasses from which a strong rum can be made. The operators at the still also had business elsewhere when the officers called.

After destroying the still, the officers poured out the beer.

Many Missing

HEAVY DOCKET BEFORE COURT

County Court Continues Sitting Today After Hearing Number Cases Yesterday

With a number of unexpected cases docketed at the last minute yesterday, County Court had enough work to carry it through yesterday and a greater part of today. It was expected work would be completed on the dozen or more cases scheduled for today late this afternoon.

A peculiar feature about yesterday's session was the fact that all defendants appearing for trial were white with exception of one. Usually the docket is cluttered with charges against members of the colored race, but yesterday the blacks had a day off while the court attempted to deal out justice to the fifteen or more defendants appearing for trial.

As during the last session, a number of charges of driving drunk were given a hearing, and as before, Judge James fined each defendant \$50 and cost and ordered them not to drive again for a period of from six ten months. It used to be defendants appearing on such charges were released within a three months' revocation of license hanging over their heads, but violation of the traffic regulation has become so widespread that the court started extending the time in an effort to halt the threat to public life.

The following cases were given consideration: Josh Taylor, larceny of \$20 from Albert Mozingo, four months on the roads.

J. G. Matthews, driving drunk, \$50 and cost and license revoked for six months.

Henry Spence, driving drunk, \$50 and cost, license revoked for ten months.

Jim Henry Boyd, larceny, not guilty.

William J. Buckley, colored, driving reckless and assault with deadly weapon, \$25 and cost.

Fred Jenkins, driving drunk, \$50 and cost and license revoked six months.

Irving Clayton, driving careless and reckless, pay cost and \$25 for damage to a truck of the Beaufort Bottling Company.

Dixie Hardee, non-support; eight months on the road; sentence suspended on condition he pay to the Clerk of Court by the first of the each month \$20 for the use of his children and a further sum as \$50 between September and October of each year for the purchase of clothing and school supplies for the children.

Paul Griffin, driving drunk; not guilty.

Gus Scofield, drunk, sentence suspended on payment of cost.

J. H. Green, driving drunk, \$50 and cost and license revoked for six months.

C. H. McGowan, fishing out of season; judgement suspended on payment of cost.

MUCH COMMON LEAF OFFERED

Inferior Grades of Tobacco Predominate Sales on Local Market Yesterday

The sale of bright leaf tobacco continued light on the local tobacco market yesterday and the official report of K. W. Cobb, supervisor of sales, made public yesterday, showed the market handled a total of 118,024 pounds with receipts of \$32,549.65, and an average of \$27.58 per hundred.

The sales consisted almost entirely of common and damaged tobacco. Medium grades continued to bring good prices along with the remainder of the improved qualities offered.

With yesterday's sales poundage on the local market for the season was 49,570,098 with indications the 50,000,000 mark would be reached if not passed, the latter part of the week. The total amount of money paid out by the market was given as \$15,701,745.39 and the general average was \$31.68 a hundred.

Although the bulk of the crop has already been sold there is every indication the market will sell well over fifty million pounds with receipts passing the seventeen million dollar mark. A new high record for the amount of money paid out has been set here this season and the end of activities will see the sum boosted to such an extent that other markets will shoot a long time before passing the figure.

ONLY GAELIC COMMANDS RULE FREE STATE ARMY

Dublin.—(AP)—The order has gone down from President De Valera's office that henceforth all commands in the national army must be given in Gaelic.

For some time the administration has been campaigning for the revival of the ancient Irish language.

Previously Gaelic in the army has been used only in the first battalion, composed of men who understood the old tongue.

DISAPPOINTED IN LOVE YOUTH TRIES SUICIDE

Fayetteville, Nov. 14.—Arthur Hall, 19, of Autryville, is in a precarious condition in the Highsmith Hospital here from a gunshot wound which was self-inflicted Saturday night. The young man is said to have shot himself at his mother's home in a fit of despondency over disappointment in a love affair. The load of shot from the shotgun entered his left chest an inch and a half above the heart. Physicians entertained little hope of saving his life. His condition was reported unchanged today.

Murdered Distelhurst Child Found In Grave

Nashville, Tenn., Nov. 14.—(AP)—A body found in a shallow grave on the outskirts of Nashville was identified today as that of Dorothy Ann Distelhurst, six-year-old girl kidnaped as she was en route home from a kindergarten Sept. 18.

The announcement of the identification was made by Attorney General J. Carlton Loner who said that the child was murdered.

Dr. Herman Spitz, pathologist, and Dr. Leland Pouff, dentist and orthodontist, examined the body and joined the attorney general in the announcement that the identification was positive.

"The child was murdered," Loner said.

"Her skull at the left side was crushed by a hammer or other blunt instrument. A rag was

found in her mouth, possibly used a gag to prevent an outcry."

The girl's father, A. E. Distelhurst who had been in New York in an attempt to contact the kidnapers and pay over the \$5,000 demanded for the child's return, left New York this morning by train after being notified of the discovery of the body.

"The identification was established definitely by the filling in the upper right baby molar," Dr. Pouff said. He had filled Dorothy Ann's teeth before she disappeared and said the filling in the tooth was his work.

The body was found on the hospital grounds late yesterday but the announcement of the identification was delayed until the physicians made the examination which convinced them the body was that of the girl.

TAX MONEY IS PAID RAPIDLY

Over \$1,000 a Day Collected by City During First 13 Days Of This Month

Indications today were that tax collections in the City of Greenville would run ahead of last month when \$21,000 was collected, a new high mark for the corresponding period in previous years.

From the office of City Clerk J. O. Duval today came the statement that up to yesterday the city had collected taxes at the rate of over \$1,000 a day. Up to last night collections had reached \$15,000.

W. L. (Wash) Patrick, assistant city clerk and tax collector, said this morning that on the basis of the report last night collections for November would run well over the \$21,000 reported last month and set an all time record.

The clerk's office has been busy the last several days mailing out tax bills, and the populace is pouring into the office from day to day attempting to take advantage of the one per cent discount.

Mr. Duval said some of the collections were on years from 1928, but the bulk of the money involved this year's taxes.

City officials were highly elated over the fine way people are paying up their obligations to the government, and expressed the hope the bulk of collections would be made by February when penalties begin.

Late News Flashes

Recommend Building Airship
Washington, Nov. 14.—(AP)—The navy general board has recommended that an airship about half the size of the Macon be built for training purposes pending determination of the exact place the lighter than air crafts should hold in the naval program.

Secretary Swanson at his press conference today the policy making board favored the construction of a ship of 2,500,000 cubic feet capacity.

Approve Terminal Bonds
Washington, Nov. 14.—(AP)—The Public Works Administration today approved a new contract for the purchase of bonds for construction of a port terminal at Morehead City and opened the way for speeding up the development for which \$1,975,000 in PWA funds have been allotted.

M. R. Beaman, general manager of the Morehead City Port Commission, said the new contract did not require that the Atlantic and North Carolina Railroad, state owned line connecting Morehead City with the interior, be again leased within sixty day after the bonds have been bought.

Beaman also said the PWA legal division had concurred in an opinion of A. F. Sewell, North Carolina assistant attorney general, holding that the Atlantic and North Carolina court agree to guarantee terms.

MORGENTHAU NAMED HEAD OF THE BODY

Move by President Interpreted as Start on Consolidation of Federal Agencies to Absorb Emergency Units; Future Program of Relief Agencies to be Decided First of Year

Washington, D. C., Nov. 14.—(AP)—A committee to co-ordinate all the leading activities of the government was appointed by President Roosevelt today.

The move was interpreted as a start on consolidation of Federal agencies with a view to absorbing emergency units as the recovery campaign permits. Secretary Morgenthau heads the committee.

Mr. Roosevelt said at his regular conference that the future program of the emergency recovery unit probably would not be decided definitely until about the first of the year.

He said it would probably be determined also whether any more funds would be asked for the Home Owners' Loan Corporation.

Yesterday it announced new applications would not be received as more money already had been requested than it had.

It was understood this would be turned over as soon as possible to private institutions.

It apparently was the intention of the administration to close its books on the Home Owners' Loan Corporation with action upon existing applications for the \$3,000,000,000 fund.

NAMED ASSISTANT STATE MANAGER HOLC

Salisbury, Nov. 14.—(AP)—Appointment of Thomas C. Abernethy of Lincolnton, as one of the two assistant state managers of the Home Owners' Loan Corporation in North Carolina, was announced tonight by C. Scott Noble, state manager at headquarters here. At the same time Mr. Noble confirmed the appointment of Roy S. Smith of Charlotte, North Carolina as district manager of the Charlotte office.

Abernethy has already entered upon his duties at the state headquarters here. Noble visited Charlotte today and after a conference with the department heads of that office, administered the oath to Smith who will enter upon his new duties tomorrow.

As assistant state manager, Mr. Abernethy will rank equally with Eric W. Rogers, who has been serving as assistant state manager for the past year.

TYSON FINED IN COURT HERE

Man Held For Aiding In Attempted Jail Break Given Hearing In County Court

Elbert Tyson, charged with aiding and abetting Levy Tyson in an unsuccessful attempt to saw his way out of the city jail over a month ago, was ordered to pay \$50 for damage to the jail cell and cost in the regular weekly sitting of County Court here yesterday. In case of his failure to pay, he was ordered to serve a four months' sentence on the county roads.

Sufficient evidence was produced to prove that the defendant provided the prisoner with half a dozen hacksaws. The jail bars were sawed away, but the attempted break was discovered in time to prevent a delivery.

Levy Tyson was being held in jail on a charge of forgery. He was given trial in the last session of criminal court and sentenced to from two to three years in State's Prison.

One very astute Republican estimates that fully 70 per cent of the unfailing G. O. P. arguments have vanished in the last 18 months. This may help to explain to some of the Republican candidates why they had so much trouble writing their speeches during the recent campaign.

Baloney: Since this column disclosed that New Deal master-minds were cogitating over a new public works program that might call for 25 billion dollars over a 5-year period, many inquiries have been received as to why there should be so much feeling against paying two

and a half billions on the bonus. From an administration viewpoint there are a number of reasons.

First, an immediate cash payment would absorb half of the first year's allotment for public works, etc., and cripple many broad long-range plans now on the fire.

Second, New Deal economists figure that money paid to bonus-bites would go more toward paying old debts than buying new merchandise thereby putting the money into banks rather than circulation. Billions paid in wages is the goal of FDR and his aids.

And finally, of course, is the argument against special class treatment which Mr. Roosevelt voiced. Many veterans no doubt are in dire need but a far greater proportion can continue to eat and make—something—merry without the cash bonus.

In this connection a new and insistent school of thought is seeking the President's ear on the bonus issue. He is being urged to sit back and let the bonus-seekers play their cash-payment game for all it is worth and then sock the situa-

tion with a veto calculated to hang Old Man Bonus by the heels once and for all.

Calvin Coolidge strengthened his political position by vetoing a bonus bill back in the high days of prosperity when Uncle Sam was reducing his national debt and taxes simultaneously. It should be a natural for FDR to follow suit in a period when the federal treasury is being strained to the bursting point to feed about one-sixth of the total population.

Politicians and others urging the veto course are mindful of the post-war voting generation. Young men and women balloted for the first time last week who were four years old when we went in the World War. To them the American Legion represents a bunch of grey beards who parade every once in a while and reminisce about a war the new voters learned of in their history books at school. Unless papa is in the breadline the bonus is so much baloney to most of them.

Horns: Southern Democracy is going to be confronted with a delicate problem from its angle when

Congress meets in January. This column has no desire to raise the issue but merely to report the facts. They concern the impending arrival on the Washington scene of Arthur W. Mitchell, the Negro Democrat from Chicago who defeated Republican Rep. Oscar De Priest also a Negro.

Higher-ups in Democratic National headquarters have boasted privately for months that they could pick up House seats in both Chicago and Harlem—if they chose to nominate a member of the colored race as their candidate. They invariably explained this wouldn't be done because of the Southern Democrats.

Harry Baker, a white man, was nominated by the Democrats to run against De Priest this last time. Baker died before election. There are 60,000 votes in this particular district. Cook County bosses, seeing Democracy in the ascendancy decided these votes might come in handy in swinging Illinois elections. Mitchell was substituted for Baker.

A Texas Congressional wag, back in the 1932 campaign, suggested a Republican slogan of "Debuture, De Priest, and de tariff." Of De Priest is some Ar Mitchell, born in Alabama, comes to Washington to sit in Democratic Party caucuses and take his committee assignments as due.

De Priest raised a loud squawk last session because members of his race were barred from eating in the House of Representatives restaurant. Rep. Lindsay C. Warren, (D) of N. C., in charge of the restaurant as Chairman of the House Accounts Committee, paid this Republican complaint no mind. What Rep-elect Mitchell may think about the situation I put to him. At least he can go to bat as a Democrat.

Notes: Democrats have begun scrapping over Congress chairmanships. Private property may be commandeered by quick process for slum clearance and housing projects. Roosevelt is not offended by Borah's publicity-getting charge of waste in relief operations. Jim Farley doesn't admit that he will imitate Will Hays by jumping from the Cabinet into a big business job. Navy people are disgusted with Ramsay MacDonald's backing and filling tactics.

Questions: The stage is being set in the motor industry for the most important act in the capital-labor drama you have seen in a long time. The elements of conflict—some of them mentioned before in this column—are crystallizing in a form which must lead to a decisive showdown. Well-posed New Yorkers believe the final outcome is likely to set the tempo for relations between labor and management in all industry for many years to come.

To get the full picture it is necessary to realize there are five different questions at stake—each fundamental both to labor aspirations and to the defenses of business conservatism.

1. Will an annual wage system be stabilized on industry in an effort to forestall unemployment?

2. Can the principle of minimum wages and maximum hours—implying that industry's responsibility to workers ranks ahead of his duty to stockholders—be broadened and enforced permanently at the probable cost of widespread business casualties?

3. Does the future of organized labor rest with the American Fed-

eration or will it pass into the hands of more aggressive groups?

4. Can employer-fostered company unions survive?

5. How far will the government be right to intervene between employer and employee?

Add to these vital issues the fact that the auto business is in many respects the keystone of our whole industrial structure—because of its status as chief customer to so many other industries—and you'll see why New York is watching motor developments with an eagle eye. A serious upheaval in motors could come close to ditching the recovery train. This consideration strengthens the auto magnates' determination not to retreat. They figure the administration can't afford to force them into too tight a corner.

Wall: The industry's first move to checkmate the annual wage proposal is a voluntary plan to space production more evenly throughout the year. This will smooth out the seasonal employment curve and it's hoped will spike the demand to guarantee jobs by law.

But it will also make existence tougher than ever for the small independents. Under the old system—which virtually restricted current production to cars whose sales was assured the minute they came off the assembly line—only small working capital was required. The new arrangement calls for much larger amounts of liquid capital. You can level out production—but distribution will still be subject to season whims of purchasers. This means that manufacturers must be in a position to carry large inventories of finished cars during months of slack selling.

Ford and General Motors and Chrysler can manage it but some of the little fellows might be driven to the wall—which wouldn't help employment.

Explosion: The question of irreducible costs enforced by wage and hour limitations ties in with the above. Some auto men privately express a strong preference for quitting business rather than assume a cost burden which would make profit prospects as remote as Mars. Labor will press hard for shorter hours and a larger wage differential between skilled and unskilled workers. If it's demands are backed by the government you can look for an explosion that will dwarf Vesuvius.

BONDED WAREHOUSE NEEDED

There is one thing that Greenville needs and needs badly now, according to reports that we have received, and that is a bonded warehouse. For some time we have had a private warehouse, a portion of which has been used as a bonded warehouse, but at this time the entire space is being used for private purposes, with the result that farmers or others who wish to store something in a bonded warehouse are having to carry it to some other town. Just one day this week more than forty bales of cotton were hauled from this town to a nearby one for storage because there was no bonded warehouse here in which to place it. In the towns all around us there are bonded warehouses but none in Greenville, and certainly with the present demand here for safe and bonded storage space, we believe that a bonded warehouse would prove a good investment for someone. With the government urging farmers to store certain crops and get government loans on them rather than dumping them on the market, certainly no town as wide awake as Greenville along other lines, should be without a bonded warehouse in which the cotton, peanuts and other crops could be stored.

Carolina Playmakers Here Monday. The Carolina Playmakers will present an excellent bill of three one-act plays on next Monday night, November 19, in the Campus building of East Carolina Teachers College.

All three of the plays are true Carolina plays and they make an excellent program for an evening's entertainment. They have combined two of the most successful plays they have ever given in the past with a new play. The two well-known plays, both by Paul Green, are "Fixin's" a tragedy of the tenant farmer, and "Quare Medicine," a farce comedy of a country quack. Symphony Pleases Hearers. A splendid performance and a fine audience made the concert at East Carolina Teachers College last night, by the North Carolina Symphony Orchestra, conducted by Lamar Stringfield, a brilliant success.

The opening number on the program was Mozart's "Impressario Overture," played in true Mozart style, a light happy mood, and with no affectation, but in the simple, natural way it was intended to be played. The clearness of tone was marked.

The Brahms "Symphony No. 1 in C Minor" was the heart and soul of the program, and all four movements were beautifully played. The second movement, "Audente Sostenu" was perhaps the favorite of the musicians present, but the fourth, "Adagio, Allegro non troppo" was a close second. This was a most ambitious number for an orchestra that has been organized for so short a time. Brahms is one of the most intellectual composers. The musicians stood the test well.

The second half of the program had a miscellaneous group, ranging from classics to a North Carolina composition. Debussy's "En Bateau" had a lovely rhythm that attracted attention.
