LEAGUE ADOPTS PLAN TO END CHACO WARFARE

Hope Of Naval Compromise With Japan Fades

EFFORTS FOR DECISION ARE STILL PUSHED

Both America and Great Britain continue to stand pat on opposing larger Navy for Nippon; Jap Delegate at Washington Confab Hopeful of Some Kind of Settlement

Washington, D. C., Nov. 24.—(AP)—The threat of a limitless naval building program between three great rulers of the sea hangs today over the tri-power conversations as hope was virtually abandoned for a compromise on Japan's demand for naval parity.

Already deadlocked, the negotiations between the United States and Great Britain reached a crisis yesterday when the British sided with America in declining to recognize Nippon's demand for parity.

Officials, however, are continuing conversations until next week at least. Norman Davis, American delegate, and Sir John Simon, British Foreign Secretary, spent yesterday in discussing the troublesome situation.

NEW WEDDING RECORD SEEN

Register of Deeds Expects All-Time Mark in Pitt County This Year

With more attention being given to matrimony in Pitt County at this time than any other period in history, indications today pointed to the setting up of an all-time record when the December trek to the altar has been completed.

Register of Deeds J. C. Gaskins, who is never happier than when wedding bells are ringing, said today over six hundred licenses to wed had already been issued this year.

With December always one of the best months of the year for marriages, he said there was every indication Pitt County would outstrip all other counties of the State.

Last year seven hundred and sixty-eight persons applied for licenses to wed in this county, Mr. Gaskins said. It was not only the best mark in history, but exceeded records from all other parts of the State.

The marriage boom dropped off pronouncedly during the two years of depression, but with improvement of tobacco prices, always of monumental consideration to the people of this part of the State, the movement toward the altar picked up with the result that a new record was established.

Tobacco prices were even better this year than last, and no sooner was this evident, than the movement toward the altar developed into something of a race which will not let up until after the holidays, if the past is to be taken as an index to the future.

Improved Business Is Seen For End Of Year

Washington, D. C., Nov. 24.—(AP)—As the nation today headed into its period of holiday trade the Chamber of Commerce of the United States produced statistics to show "improving business sentiment."

This and other pronouncements lead business men to hope the Christmas trade might be the best since 1929 were keyed to a note of quiet optimism.

The Chamber said the improvement seen in October was continued in November. It sighted a 6 per cent rise in the volume of check payments, steady retail sales, stable wholesale prices, favorable car loadings and increasing steel production.

HOLD NEGRO FOR SLAYING

Perry German Denied Bond in Hearing in Police Court Here This Morning

Perry German, 26-year-old colored man, who was jailed here this week on a charge of slaying Jerome Slade, 27, also colored, in the western section of the city Wednesday night, was ordered held without bond following preliminary hearing in police court here this morning.

The prisoner was transferred to the county jail to await hearing at the next session of Superior court. Evidence tended to show, police said, that German went to Slade's home about 9 o'clock as Slade and his wife were talking in a bedroom, and fired a shotgun charge into the man's body from an open window.

With blood streaming from wounds in the chest, Slade was said to have rushed into the street where he dropped dead.

The shooting was said to have resulted from a beating which German told police Slade inflicted upon him at the Slade home last Sunday night.

"I told him I would be back and get even with him," Chief of Police George Clark said German told him, following his arrest at his home the night the shooting took place.

The officer said the negro confessed he shot German to "get even with him" for the beating.

Zack Parker and George Clark, colored, charged with robbery of a colored cafe in the western section of the city Thursday night, were bound over to the next sitting of Superior court under bond of \$300 each. They were unable to provide bail and were transferred from the city jail to the county jail.

ITALY SEEKS DISCUSSION OF YUGO CHARGES

Demands League of Nations to Consider Alleged Hungarian Complicity in Killing

Rome, Nov. 24.—(AP)—The foreign office announced today that Italy would demand immediate discussion by the League of Nations of Yugoslav charges of Hungarian complicity in the assassination of King Alexander at Marseilles.

The foreign office statement characterized the situation provoked by the Yugoslav charges as dictate, but not necessarily conducive to more serious complications.

"Responsible Italian circles, the official communiqué said, are following with great attention developments in the situation developed by the accusations on the entente against Hungary.

"These circles believe firmly in Hungary and still call for an immediate discussion of these accusations before the council of the League. The Magyar point of view in this respect will be supported by the representatives of Italy and the League.

The League in reply to the Hungarian demand that the assembly take up the matter of the Yugoslav charges against her had pointed out that the normal proceedings would be to present the matter at the regular meeting of the League in January.

Salvation Army to Conduct Series of Services Through December 9th

Trial Of Samuel Insull Draws Near Jury Stage

Chicago, Nov. 24.—(AP)—The trial of Samuel Insull, former head of a fallen utilities empire, drew to an end today.

Federal Judge James H. Wilkerson announced he would give the case to the jury this afternoon. Only the government's final argument with rebuttal and Judge Wilkerson's instructions to the jury remained as the court was resumed.

By tonight Insull may learn whether the United States government has convicted him of participation in a gigantic scheme to defraud investors who lost some \$100,000,000 in the collapse of his Corporation Securities Company or whether he has been vindicated, the captain of a ship that went down in the economic storm.

During the eight weeks the jurors who must decide if Insull and his 15 co-defendants were participants in the scheme to use the mails to defraud through the sale of corporate stocks have seen mountains of books hauled into the courtroom, listened to technical accounts of book methods, peered at charts and heard the defendants described as men of highest repute on the one hand and gross deceivers on the other.

PLAN PROBE OF MENACE ON SWIFT CREEK

FERA Administrator Assures Congressman of Improving Overflow on Stream

Harry L. Hopkins, director of the Federal Emergency Relief Administration, has given personal assurance to Congressman Lindsay C. Warren that he will immediately cause an investigation to be made of the incompleted CWA drainage project started at Swift Creek in Pitt county and that every possible step will be taken by him to remedy the situation after he has made his inquiry, a dispatch from Washington said today.

Several months ago a CWA drainage project was initiated at Swift Creek, a right of way twelve miles long being cut and trees felled. Then suddenly all such projects were terminated. By reason of this a very serious condition has arisen, caused by ponded water, and there has been a large increase in malaria. Congressman Warren stated that the late Dr. Jas. M. Parrott, state health officer, told him a few weeks before his death, that this incompleted project at Swift Creek constituted an absolute menace. For several months interested citizens have tried to get the situation remedied, but without results, many trips being taken to Raleigh about the matter.

Congressman Warren decided to take the matter up direct with Mr. Hopkins and arrangements were made to investigate conditions of the project at Swift Creek. Mr. Warren is urging all interested parties to meet the investigators when they arrive in Pitt county.

FOUND DEAD IN PARK, DECLARED SUICIDE Wilmington, Nov. 24.—Robert W. Montgomery, Sr., 46, 719 Princess Street, was found dead on a bench in Greenfield Park, shortly after 7 o'clock yesterday morning by a caretaker.

Coroner Asa W. Allen termed the death a suicide by poison. He said his investigation revealed the man had been in declining health and dependent for some time.

Mr. Montgomery was the son of Mrs. Dorothea Wagner Montgomery and the late Robert A. Montgomery. He was born in Brunswick county.

"They have earned our gratitude for their efforts to restore peace in South America," he said. He said he expected Paraguay would reply as soon as possible.

LOYD CASE IS CONTINUED

Charge of Resisting Officer and Drunkenness to be Aired Next Saturday

The case against Scott Lloyd, local young man charged with drunkenness and resisting an officer, scheduled for hearing in this morning's session of Police court, was continued until next Saturday morning.

Continuance was granted Lloyd when he told the court it would be impossible for one of his witnesses living in Robersonville to attend court before next Saturday.

The charge grew out of the attempt of Policeman Jess Whitchard to arrest Lloyd last Tuesday on a charge of drunkenness.

Police said that when the officer attempted to make the arrest Lloyd struck him. Whitchard then struck Lloyd with a blackjack but it required the services of Chief of Police George Clark before the prisoner was taken into custody and the double charge of resisting arrest and drunkenness was lodged against him.

TO CONTINUE EFFORTS FOR CONDEMNED MEN High Point, Nov. 24.—J. A. Myatt attorney for Bascom G. and Lester Green, whose appeals from death sentences imposed upon them in Alexander county in February for the killing of T. C. Pitt County's goal has been placed at \$1,500 and Mr. Garrett expressed confidence each community would cooperate whole-heartedly in the effort to go over the top.

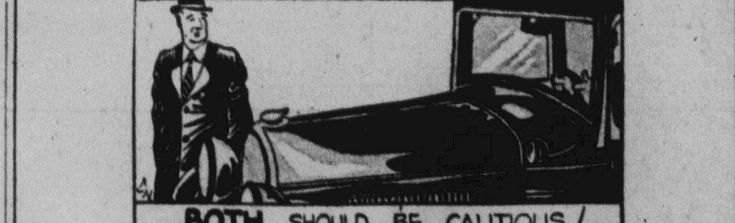

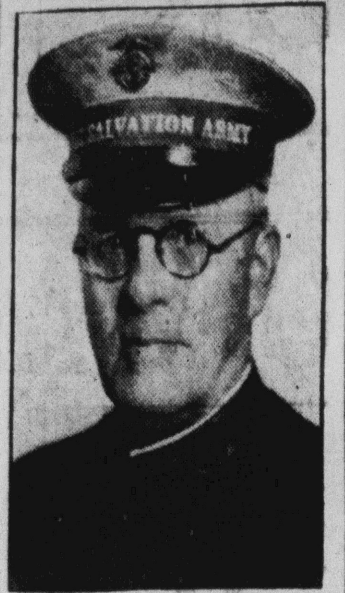

SCANNING BOOKS By JOHN SELBY Once in a while a textbook kicks over the traces, as it were and precepts an audience among general readers. It is so with a book entitled "Beacon Lights of Literature" (Troquois), or rather with the fourth volume of the series. And the reason that comment about it is cropping up in corners where textbooks seldom penetrate, even "Beacon Lights" seems to be that although Rudolph W. Chamberlain, the editor, provides experts from English literature as far back as Chaucer, he also gives much space to contemporary American writers, especially those whose work is appearing currently in the magazines and newspapers. This space is not devoted solely to what we call highbrow literature either, but includes examples of the work of columnists, journalists and playwrights as well.

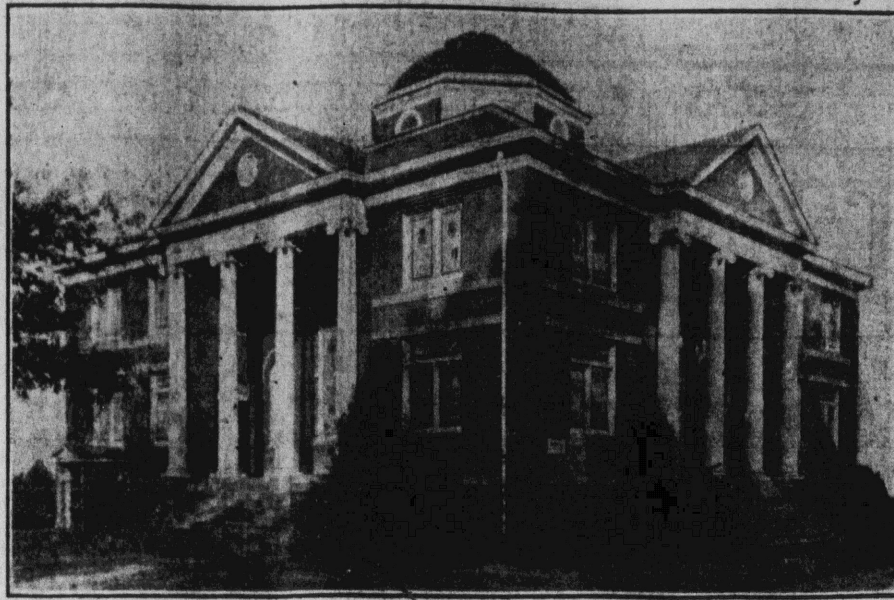

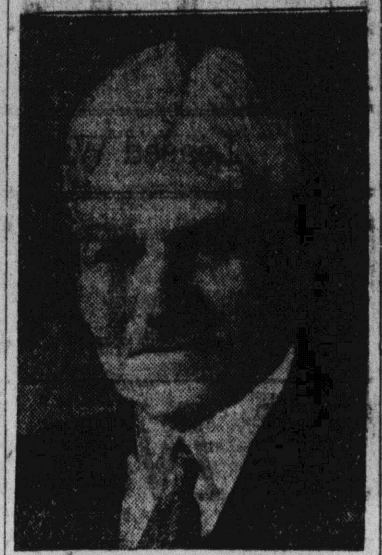

CLASS TO DISSECT ART IN OLD SURGERY CLINIC

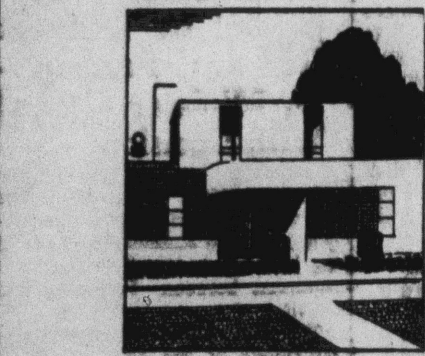

Judge Cowper declared it was a good idea for an organization to keep ever before it the building idea as epitomized in the Kiwanis program and to see that this building is extended not only to commerce and industry, but to those essential qualifications which play such a predominant part in public life.

## Washington Daybook

**By HERBERT PLUMMER**  
Washington, D. C.—One of the most successful methods employed by the Republican high command in the present campaign to get a "rise" out of the Democrats has been to charge that "new deal" relief expenditures have been speeded to the county just at election time.

Chairman Fletcher of the Republican National Committee sent Secretary Wallace of Agriculture into something akin to a rage by his charge that AAA checks to Western corn-hog producers were being held up for political purposes. A "contemptible" charge was the way Wallace characterized it.

AAA's explanation for the delay was that corn-hog contracts just recently have been cleared through regular machinery. Chester Davis, Farm Administrator, admits that an increase in farmers' income always is likely to affect elections "because the farm situation in my seventeen years of observation always has been closely identified with politics."

"What is happening now, however," he says, "is evidence that the administration is doing something positive about the problem."

**Accounting For Money**  
What irks "anti-new dealers" is that the 3,000,000 or more cotton, wheat, corn-hog, tobacco and sugar growers who signed contracts to cooperate with AAA crop control plans are to receive a total of \$900,000,000 in Federal money.

Where is it to come from? Does it loom as an obligation to threaten the nation's financial set-up?

AAA says "no," and cites its own estimates and Treasury figures as proof. These show that to date processing taxes have brought in more than \$500,000,000 or some \$100,000,000 more than has been paid out to the farmers in benefits.

The processing tax, paid by the consumer, during the months ahead will reach sufficient proportions, according to AAA estimates, to balance its budget.

**For And Against**  
The G. O. P. was quick to interpret the recent national referendum of corn and hog raisers as evidence of growing opposition to "regimentation." In Kansas the farmers voted against continuance of the program. The general percentage for the corn belt was about 65 percent in favor and 35 percent opposed.

Those who sponsored the referendum, however, have a different explanation. They say that possibly the drought, which will cause a shortage in corn next year, prompted many to vote nay because of a belief they could make a "killing" if crops are good, without co-operating with the government.

Then, too, they explain many farmers are buyers of corn and they are not in favor of any plan which increases the cost to them.

And finally, many farmers were irritated and unwilling to go on because of the manifest complications and difficulty in operation of the first years' program.

**China Remits Rent On Red Land**  
Nanking.—(AP)—Tenants of land recently seized from communists in central China are not required to pay rent for the first year under a ruling issued by the national government.

London.—(AP)—Justice is swift and exacting at the Old Bailey, England's famous criminal court here, and women help to make it so.

Two murder trials were completed recently in a single day, the same jury, on which two women sat, serving for both. In each instance a verdict of guilty was returned.

The women covered their eyes with handkerchiefs as the judge denounced his black cap and pronounced sentence of death on a 19-year-old youth who had confessed killing the manager of a movie theater.

Three hours later they averted their faces again when the dread black cap was placed on the judge's head a second time and a man was sentenced to hang for the murder of a boarding-house keeper.

## NEW TURKISH FACTORIES MARK FIVE-YEAR PROGRAM

Istanbul.—(AP)—Turkey's five-year industrial plan, says Prime Minister Ismet Pasha, is functioning normally and new factories are starting every few months.

When opening a new semi-coke factory at Zonguldak, on the Black Sea coast, he called iron and coal "the spinal cord of Turkish industrial life."

In 1923, he said, 600,000 tons of coal were produced in Turkey, but last year the production reached 2,000,000 tons.

"This figure," he said "must be still further increased."

Wilson, N. C., Nov. 24.—The first case filed in the Wilson Federal district which comes under the new amendment of the Federal bankruptcy act which provides for composition and extension of time to pay all debts, came to the attention of Federal Clerk G. L. Parker Thursday. Mr. Parker at once turned the case over to C. W. Beaman, of Wilson's newly-appointed Federal conciliation commissioner, as his initial case in his new position. The petition was of Willie Eatmon, Wilson County farmer.

Borah, of Idaho, must be put down in history as one of the greatest paradoxes of American politics.

He has, as William Jennings Bryan had, an almost incredible faculty of making himself heard in situations where his voice, by every orthodox calculation, would be least expected to be audible.

For thirty years the Democratic party listened when Bryan spoke, even at those periods when his personal fortunes were lowest, when the Now again Borah has the Republican party listening. He refuses to abide by party discipline, attend party caucuses, or campaign under party auspices.

Yet whose views on party re-organization and party leadership are attracting most attention and provoking most comment in the wake of the election? The views of Borah of Idaho.

Stir Up Discussion

This does not prove that his advice is likely to be followed by the party. It seldom has been, in all the years of this great prominence. His fame as a legislator rests most solidly on his power of resistance.

It is hard to recall a single major piece of legislation which bears his name. But the Congressional Record is strewn with reference to "Borah amendments," some of which were adopted.

His most sustained feat of resistance was performed when the League of Nations treaty was before the Senate. Time and again, when the contending factions appeared near a compromise which would have ratified the treaty, it was Borah who threw into the debate some coy word, some adroit question, which started the quarrel all over again.

The man's power to stir up discussion, to set people to thinking and debating, has appeared sometimes almost beyond human belief.

Now he has done it again. Just when so many politicians were sighing in relief, believing the election had settled everything, a voice scarcely heard at all during the campaign has re-opened the whole case.

Star of G. O. P. Show

Borah is credited with some who know him with a still-lingering aspiration to sit in the White House. Some speak of him as a possible rallying-point for the scattered Republican legions.

Such a suggestion manifests itself out of harmony with the whole background of the man. To sit in the driver's seat would be new experience for him. Some question whether he would like it.

Naturally, he has made many enemies in the course of his campaigning. To unite this party behind him he would have to overcome the resentment of those right-wingers whom he has harried for so long, and likewise the sentiment of those left-wingers whom he refused to join in their great Theodore Roosevelt bolt in 1912. Overcoming resentments never has been his forte.

But wherever happens later, Borah is, for the moment, the star of the Republican show. That is because he is Borah.

Improvement in Farm Prices Seen

Washington, D. C.—(AP)—A marked improvement during the last year is revealed by Bureau of Agricultural Economics indices.

Whereas prices of all farm products increased 28 per cent between October 15, 1933, and October 15, 1934, estimates on the cost of commodities farmers buy show an increase of but 9 per cent during the year ending September 15, 1934.

The farm increases represent higher market values only, and do not include rental and benefit payments from processing taxes. Minus the latter, full parity with industry does not yet obtain. While the index of all commodities bought by farmers stood at 126, the index of farm prices was an even 100.

Improvements is reflected in a more rapid rise in farm prices than in non-farm prices. Seed, raised to an index of 162 because of the exceedingly short crops resulting from drought, was the most expensive item the farmer bought in terms of percentage increase, and fertilizer at an index of 105 was the cheapest.

An over-abundance of potatoes made that crop a major one on which the farmer income decreased, prices dropping 35 per cent during the year. Corn prices advanced 98 per cent, tobacco 97 and oats 81 per cent to score widest farm gains.

LAMA HELD TOO HOLY FOR LIFE INSURANCE

Pelging.—(AP)—Because the Panchan Lama, Tibet's spiritual chief, is "too holy" to submit to a medical examination, an American insurance agent here lost the sale of a \$107,000 policy.

The Lama is theoretically immortal, but he deemed it wise, nevertheless, to arrange for insurance before his departure on the long journey across Mongolia to the land from which he was exiled several years ago.

Everything went swimmingly until he was asked to undergo the usual physical tests. Then he refused to doff his royal robes before an unbeliever.

Undaunted, the agent sold six policies of \$18,000 each among the Lama's followers.

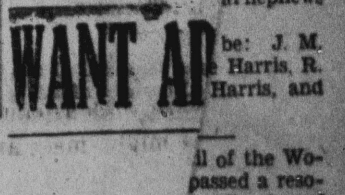

# LOCAL GRID TEAM TRIMS TARBORO 7-0

Greenville defeated Tarboro here yesterday in a close, hard-fought game to the tune of 7 to 0. The old passing combination of Captain Carroll to Hatem picked up where they left off at the Kingston game. Between them they managed to eke out the victory before the rain started and made the ball so slippery that it was dangerous to pass.

After making one first down, Tarboro decided to kick, but Leslie Smith thought that the ball should remain on the 40-yard line, so he blocked the kick and Greenville recovered. The locals did not capitalize just then on the brake, but waited until Cox stuck his toe into the ball and it traveled for 50 yards, finally stopping on the 10-yard line. Tarboro punted out to the 30-yard line. From this place Greenville started a march that ended at the pay-off mark. A pass, Carroll to Hatem, was good for 24 yards and touchdown. The extra point was made by the same route—a pass from Carroll to Hatem. This proved to be the only scoring done during the game.

The Greens wasted little time in starting another parade that looked like a second touchdown. Another nice punt by Cox put the visitors on their 10-yard stripe again. They tried to put out, but the ball traveled for only 15 yards. After a number of passes had failed, Tarboro recovered the ball and from his own 25-yard line Swinson put his team out of danger by punting 55 yards to the Greenville 20. On first down from this point, Carroll treated the fans to a pretty piece of running. After receiving a bad pass from center, he converted what looked like a 15-yard loss into five-yard gain.

Just before the half closed Tarboro reeled off a number of first downs that finally ended on the Greenville six-yard line. It looked like they were headed for a touchdown as the second quarter closed.

The entire last half was played in a steady rain. The ball was so slick that it was most impossible for the punters and passers to do much with it.

As the fourth quarter opened a Greenville punt traveled for only 10 yards. Tarboro took the ball here and gave the fans a real scare when they advanced to the home team's 17-yard line on some passing that looked at one time that it would carry them for a touchdown. The game closed with the ball deep in the visitors' territory. After receiving the ball on their own 17-yard line they had marched steadily down the field until they were trying to mash the old register for another marker.

Greenville presented a number of outstanding players. Cox did some splendid punting. On several occasions the line did not hold for him and he was forced to get off his punts with Tarboro players closing in on him. On the opposite end Hatem continued his good work. Smith, at tackle, played his best game. He was certainly a power-house in that line yesterday. Summerell was just above par; he was in there spilling the interference many times. Captain Carroll did some pretty running. He got away for several nice gains. Brewer ripped the middle of the Tarboro line wide open. When he learns to keep that head up he will go places with that ball. Harold Forbes did a very creditable job in his first starting assignment.

Greenville attempted ten passes; they completed two for a gain of 26 yards. They had one pass intercepted. Tarboro attempted eight and completed four for 33 yards and had one intercepted. Greenville made eight first down to five for Tarboro.

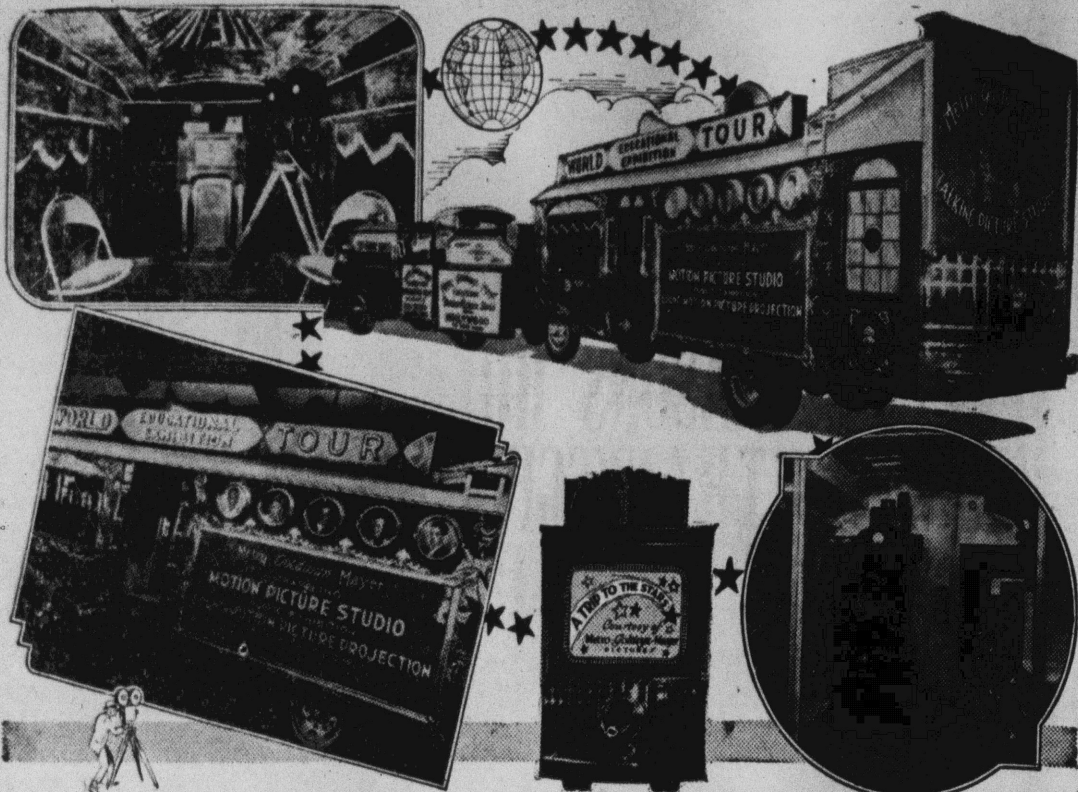

Carsile, Pa., Nov. 24.—(AP)—The bodies of three golden haired girls aged five, ten and fourteen were found huddled together beneath two blankets on a wild mountain side near Carsile today.

Coroner E. A. Hagele said he believed the children were dead when they were taken to the mountains. He expressed belief that they were brought from a distance as no children have been reported missing in this vicinity.

There was nothing on the bodies to aid in establishing their identity. Neither has the cause of death been determined.

Blood that had dried was smeared across the mouth of the ten year old girl and the oldest had a bruise on her face.
