Expect Germany To Go Back Into Arms Conference

DIPLOMATS OPTIMISTIC OVER FUTURE

Franco-German Agreement Reported in Rome; France Realizes Saar Will Vote to Return to Germany; Germany's Tone Declared Milder

Geneva, Dec. 4.—(AP)—The Geneva diplomats hold higher hopes today that Germany may return to the disarmament conference and to the League of Nations. A full Franco-German agreement reached in Rome under the League sponsorship of the Saar Basin territory created optimism. France is represented as realizing the Saar will probably vote for a return to Germany. With details of the truce arrangements in advance, the January 13 plebiscite stands less as a danger spot on the European horizon, the statement said. Germany cannot take the initiative in returning to the League, said an article in the Berlin newspaper Deutsche Diplomatische, quoting Foreign Minister Konstantine von Neurath. The tone of the article was milder toward League matters than any appearing in the paper of an official nature since Germany left the League.

TAR RIVER AT FLOOD STAGE

Farmers Warned to Get Cattle Out of Lowgrounds as River Continues Rising

Tar river was on a rampage today and farmers were urged to get all stock out of the lowgrounds as quickly as possible. B. T. Clark, head of the local weather bureau, was notified by the State Weather Bureau at Raleigh today that the river would rise to a 19-foot stage by the latter part of the week, four feet higher than the freshest which sent the stream out of its bounds about two months ago. Mr. Clark said the river stood at 12 feet today and was rising rapidly. He said it would probably be Friday before the stream reached its crest and then started falling. In view of the danger to animal life, Mr. Clark warned farmers to get all stock out of the low grounds declaring that the rise would be sufficient to do considerable damage.

Red Agitators Reported Busy In Finland Area

Berlin, Dec. 4.—(AP)—The newspaper Mittags Zeitung in a dispatch from Helsinki, Finland, today said a serious anti-Bolshevist agitation had started in Russian labor camps in the densely wooded territory between Leningrad and the White Sea. Intervention of Soviet troops, the dispatch asserted, has been frequently necessary recently. Fugitives covered their flight, the dispatch continued, by starting huge forest fires, but Russians are now so closely guarding the border that escape is almost impossible in Finland. Hundreds, it was said, are exposed in the woods hungry and cold.

FISHING BOAT RUNS AGROUND

Trawler Reported Complete Loss South Of Bogue Island Light Early Today

Manteo, N. C., Dec. 4.—(AP)—A fishing trawler, Mildred J. from Wilewood, N. J., aground a mile south of Bogue Island light, was rapidly breaking up today and coast guardsmen said she would be a total loss. Southeast winds during the night pushed her well up on the beach and made it impossible to salvage her. The five men aboard and their effects were brought ashore by coast guardsmen. The craft went aground yesterday while attempting to enter Oregon inlet for harbor.

NEGRO YOUTH JAILED HERE FOR SLAYING

Raymond Diggins, of Falkland Area, Held For Slaying of Sam Johnson

Raymond Diggins, 17-year-old colored youth of Falkland community, was held in the county jail here today charged with the slaying of Sam Johnson, 24, also colored, near Falkland, Sunday afternoon about one o'clock. Diggins was ordered held without bond following an investigation by a coroner's jury. Sheriff's officers said the negro confessed the crime shortly after being taken into custody. Diggins was shot through the neck with a single-barrelled shotgun and died almost instantly. The slaying, it was said, followed an argument over possession of automobile keys. Diggins, in his confession, it was stated, said Johnson had the keys to the automobile and when he asked for them, Johnson refused to surrender them. A fight ensued, and the prisoner said Johnson then made for a double-barrelled shotgun. He said he then obtained the single-barrelled gun and opened fire. The charge took effect in Johnson's neck, severing the jugular vein and almost cutting the head from the body. Diggins was taken into custody shortly afterward, and arresting officers said he signed confession that he committed the crime because Johnson declined to give him the automobile keys.

Wayne Refunding Bond Increased

COX ELECTED HEAD OF PITT COUNTY BOARD

Winterville Man Chosen Chairman of New Board of Commissioners Yesterday

Roy T. Cox, prominent manufacturer and business man of Winterville, was elected chairman of the Board of County Commissioners following induction of the new board into office at the courthouse here yesterday afternoon. He succeeds Herman McLawhorn, of Winterville, who served for two years, but who was not returned to office in the last election. In addition to the election of the chairman, the board also reappointed heads of other departments, but left several other matters for consideration at a special session set for tomorrow. J. H. Coward was reappointed county auditor and tax supervisor. Other members of his office were also reappointed. R. L. Barnhill was renamed assistant tax supervisor and H. L. Andrews was returned to his post as tax collector. R. Y. Twine was renamed caretaker of the courthouse and was also charged with responsibility of the upkeep of the County Home. His salary was increased from \$60 to \$75 a month. After discussing the superintendency of the County Home, the board deferred naming a new superintendent until tomorrow. J. C. Harris is the present superintendent, but it was said there were four or five other applicants for the post. Another question pending consideration of the board tomorrow is the project was started by the CWA sometime last year and was left incomplete when the government organization suspended activity. Since the time the stream has overflowed its banks causing considerable damage to the district. The government has sent a representative here to see about improving the condition and he will confer with the board tomorrow. Before the government begins work, the board of commissioners must agree to keep the drainage in good condition. The old board of commissioners met yesterday morning, finished incomplete business and adjourned at the noon hour after turning over responsibilities of the government to the incoming board. The board and other county officers named in the election were sworn in shortly after 2 o'clock. The new board worked until about 6 o'clock yesterday afternoon before deciding they would be unable to complete work and then decided to adjourn until tomorrow. R. T. Cox the new chairman, has been a member of the board for the last two years, having been re-elected in the last election. He is one of the best known business men of the county, being president of the A. G. Cox Manufacturing Company of Winterville. He is also prominently connected with other business enterprises of that community. His elevation to the head of the commission yesterday was received with interest by those connected with the county government as well as the public generally.

CHILD BADLY INJURED WHEN STRUCK BY CAR

Wilson, N. C., Dec. 4.—Ernest B. Glover, four-year-old son of Luther Glover, of Simms, this morning was struck and seriously injured by an automobile driven by County Commissioner R. T. Harrison. Mr. Harrison was hurrying to attend the Wilson County board meeting at the time of the mishap. He claimed the child ran in front of his car. The little fellow was hurried to a hospital here.

Hamilton Bank Robbed Of \$3,000 Early Today

Yeggs "cleaned up" all cash in the Bank of Hamilton, small Martin County town, last night, and today had apparently made good their escape.

A check up this morning revealed the loss as \$3,000, which was covered by insurance. First information of the robbery reached Greenville this morning Sheriff Roebuck, of Martin County, telephoned George Clark, chief of police of Greenville, asking the assistance of a fingerprint expert. The sheriff described the robbery as the "greatest" in the annals of the town, saying the bank had been completely "cleaned out." L. C. Page, fingerprint expert of the local police department, was dispatched to Hamilton as soon as the report was received. He returned to Greenville shortly after noon, giving details of the robbery not explained by the sheriff. Page said the bank and postoffice are located in the same building in the heart of Hamilton's business district. The robbers sawed their way through the wooden partition dividing the bank and postoffice, burned through the vault and safe with an acetylene torch to the money-box. Five doors had to be penetrated before the cash was reached. Had the robbery occurred night before last, Page said representatives of the bank stated, the yegmen would have found \$30,000 in cash in the safe instead of \$3,000. The major part of the sum was paid out in the regular transactions of the bank during yesterday.

SMITH NAMED TO EDUCATION BOARD IN PITT

Bethel Man Elected To Fill Unexpired Term of M. O. Blount Here Yesterday

W. J. Smith, of Bethel, prominent manufacturer and former member of the Board of County Commissioners, was elected a member of the Pitt County Board of Education here yesterday. He was named to fill the unexpired term of M. O. Blount, of Bethel, who resigned following his election to the House of the North Carolina Legislature. Mr. Smith is a graduate of Duke University and for many years has been prominently identified with the business life of Bethel and the county. After leaving he taught in the public school system of the State, later going to Bethel to engage in the lumber manufacturing business. He served on the Board of County Commissioners for two years and is well acquainted with affairs of the county. Mr. Blount served on the board for many years and announced sometime ago he would resign because of his election to the seat in the House of the General Assembly. He is one of the outstanding business men of the county, and always showed a great interest in education, especially general improvement of the situation in this county.

STILL SEIZED IN PACTOLUS

Distiller and Seven Gallons of Liquor Also Taken by Officer in Raid

A whiskey distilling plant, a distiller, seven gallons of liquor and about a thousand gallons of beer, were taken in a raid by sheriff's officers in the Pactolus community yesterday afternoon. Ernest Hardison, colored, who was captured at the still, was held in the county jail today on a charge of manufacturing whiskey for the purpose of sale. Officers said Hardison make a break for liberty, but was overhauled after a spirited sprinting contest in which virtually all members of the raiding party participated. The still was going at full blast when the officers suddenly walked in on Hardison and told him it was all over. Several gallons of whiskey had already been run and a thousand gallons of beer was about ready for the distilling process. The still was of a 75-gallon capacity. It was made of copper.

Cotton Act Draws New Support And Assault

(By The Associated Press) The Bankhead cotton control plan was the object of support and of criticism today while plans went forward for the vote on December 10 which will decide whether the plan shall be continued in 1935. Retention of the compulsory cotton control act was urged by a group of 26 farmers, farm magazine editors and directors of farm co-operatives from six States in conference with Secretary Wallace in Washington yesterday. The group submitted eight recommendations which they wished to be followed in applying the 1935 program. Saving conditions "did not warrant making a change pending the working out" for a long time policy for cotton. E. F. Creekmore, vice-president and general manager of the American Cotton Co-operative Association in New Orleans asked cotton producers to vote for continuing the act next year. In Atlanta Governor Eugene Talmaidge, of Georgia, criticized the act on the processing tax levied on cotton. In an article written for his newspaper, Talmaidge said: "No industry can live carrying a tax as high as we have on cotton today. If the Bankhead bill and processing tax are wiped off the government will see the necessity of letting the cotton farmers alone and those limitation contracts will be called off."

DECORATIONS FOR YULETIDE TO BEGIN SOON

Water and Light Commission to Erect Street Lights Beginning Next Week

The placing of electrical decorations on the main business streets of Greenville to brighten up things for the observance of the Christmas holidays will begin probably the first of next week, it was made known today. Decorations this year, as in previous years, will be under the direction of the Water and Light Commission. It was said today by members of the commission that the organization would use practically the same style of display as last year with probably a few changes being made in the heart of the business district. Strings of multi-colored lights will be placed across streets and at other vantage points, but merchants will be charged with the responsibility of providing their own decorations for store fronts. Commenting on the prospects of more extensive lighting of business houses and homes, the spokesman for the commission said indications pointed to more general use of lights this year than ever before because of the improvement of the financial situation hereabouts. The Merchants' Association at a meeting several days ago asked the commissioner to continue decorating streets as in previous years, declaring this service played an important part in providing proper atmosphere for celebration of the holidays. The association also has asked its members to decorate as elaborately as possible this year to keep step with other cities which are trying to outdo one another this year, providing an attractive setting for the coming of Santa Claus. Stores will begin opening at night December 17, and on that date Santa Claus will parade down principal streets of the city under auspices of the Merchants' Association. The cheery old gentleman will also distribute gifts along his journey, adding additional interest for the thousands of children expected to be on hand when the parade gets underway.

SON OF JUDGE CONFESSES IN MURDER CASE

Phil Kennemer of Tulsa Says He Killed John Gorrell Over Extortion Note

Tulsa, Okla., Dec. 4.—(AP)—Phil Kennemer, 19-year-old son of a Federal judge, was quoted today by Robert Thomas, 19, a companion, as saying he killed John F. Gorrell, Jr., because of an extortion note Kennemer said Gorrell wrote. Thomas, in a signed statement made before John F. Conway, assistant county prosecutor, said Kennemer confessed to him he shot and killed the 23-year-old dental student because of a note demanding \$20,000 from Homer F. Wilcox, Sr., Tulsa oil man, under threat of killing his daughter, Virginia Wilcox. Kennemer, son of Federal Judge Franklin Kennemer, pleaded not guilty when arraigned on a charge of murder in the first degree. An examination of the youth by mental experts was ordered by County Attorney Holly Anderson. Thomas in his statement to Conway said Kennemer told him about the shooting at a suburban cafe, about 15 minutes before Gorrell's body was found.

MECHANIC ARRESTED IN GASTONIA FATALITY

Gastonia, Dec. 4.—(AP)—J. F. Harmon, local automobile mechanic was arrested yesterday and charged with murder in the death of Boyd Stover, 14, who was killed Sunday by a hit-and-run driver. Harmon was released under \$5,000 bond for a hearing Friday. Tax collections in the city of Greenville during November ran approximately \$5,000 ahead of the previous months, it was revealed today by J. O. Duval, city clerk. PITT TEACHERS TO MEET HERE

Countywide Meeting To be Held at College Campus Building Saturday

A county-wide teachers' meeting will be held in the Campus building of the East Carolina Teachers College next Saturday morning at 10 o'clock, it was announced today by Donald Conley, director of the Pitt County Department of Education. The object of the session, the second held this term, is to study the new curriculum, receiving attention of the various schools of the State at this time. Speakers will be Prof. M. K. Fort, head of the placement bureau of East Carolina Teachers College, Miss Ruth Bonniwitz, instructor in the college art department, and Miss Juanita McDougall, of the State Department of Education. Mr. Conley will preside over the session and scores of teachers from all sections of the county are expected to attend.

SENATOR NYE SAYS BODY TO REPORT SOON

Munitions Committee At Washington Finds That Arms Makers Caused Downfall of Plan to Control Armaments; American Manufacturers Asked For Assistance and Gave it

Washington, D. C., Dec. 4.—(AP)—The chairman of the munitions inquiry today said it had uncovered evidence that European munition makers deliberately "scuttled" a Geneva plan to control world trade in implements of war. Senator Nye, Republican of North Dakota, who heads the investigation which has already produced repercussions abroad, said evidence would be revealed in a committee hearing beginning today. Arms manufacturers, he said, sat at the elbows of some of the official delegates to the international conference held at Geneva in 1925 and influenced them in writing an agreement so "innocuous" as to be hopeless. The European group of arms men, he asserted, also appealed to American manufacturers for assistance and got it. "Munitions officials knew who the American manufacturers were three weeks before the list was made public," he said. While the assertions were being made it became known that the State Department has taken a new step to expedite international action on America's recent proposal to control the manufacture and sale of munitions. Secretary of State Hull has called Hugh R. Wilson, Minister to Switzerland, to Washington, for a conference after discussing the proposal in the light of European reaction. Wilson will return to Geneva in time to push for its adoption at the January meeting of the Disarmament Conference's special arms control committee.

"The ages of Lenin" aptly describes the new group of commemorative stamps just arrived from Russia. Their issue is based on "ten years without Lenin," an idyllic mark the tenth anniversary of his death.

As previously forecast, the three lower values, 1, 3 and 5-kopek bear portraits of Lenin as he was when a child, when a schoolboy and when in his prime. These follow three other denominations illustrative of his political life and death.

The 10-kopek shows Lenin in a rostrum addressing an assemblage against an industrial background, the 20-kopek presents a view of Lenin's tomb in Moscow before which a great throng is marching.

It is the 30-kopek which is the most significant, in that it provides an indication of the characteristic differences between the present dictator, Stalin, and Lenin. The stamp bears a portrait of Stalin, with a bas-relief of Lenin in the background.

During his lifetime, Lenin, so the story goes, would never permit his portrait to be used on a stamp, meeting such a request at one time with "Do you think I am a czar?"

A First Airmail

Although it has been a decade or more since airmail postage stamps have come into general use throughout the world, there is one territorial division just now putting out its first adhesive in that classification.

It is the colony of French Oceania, the name applied to the island possessions of France in the South Pacific Ocean. The stamp is a 5-franc green following in general style the recently adopted design for the colony. It bears a modern plane soaring in from the ocean. So far only one of the new value has been announced.

Convict Collectors

Prison bars do not dampen the ardor of the stamp collector. He can be just as active between the cold gray stone walls as is the "free" collector in the cozy confines of his den.

Take the Philatelic Five of New Jersey, an organization of collectors lecturers established eight years ago that has since grown to a membership of 51. None of the members ever goes out nights, for their "home" is the State prison at Trenton.

The Philatelic Five even has a publication by the name, which has been issued occasionally since 1930. The editor of the latest is Leslie F. Onzy. By looking over some of the things he has to say, it is possible quickly to gain an inkling of this unique organization:

"Although our club membership is more or less transient, we are proud of our great increase in the past four years; an increase of over 100 per cent since 1930.

"If an outsider could watch some of our antics in collecting stamps no doubt he would enjoy himself hugely. Waste-paper baskets are closely watched each day—and the lucky collector is the one who is on the alert. In the wings we all have individual friends who go from room to room (?) asking the receivers of letters for the stamp thereon. Though the majority of the stamps are of the common type, it is surprising how often one can find good varieties."

Washington, D. C.—The advance guard of the Seventy-fourth Congress, in Washington for various reasons, most personal, will talk privately of what they have figured out on the question of the next session and payment of the bonus.

Not a few are of the opinion that Mr. Roosevelt can save the day if he pursues the proper strategy. If, they say, the administration will say less about the lack of funds in the treasury to pay the bonus and lay more stress on fundamental objections to payment at this time, it will stand a much better chance of heading off the pro-bonusers.

Many of them contend that money for the pay-off can be found if that be the principal objection raised. There are several alternatives.

Issuance of greenbacks is one. Patman, of Texas, one of the leading proponents for immediate payment of the House, already has advanced this idea.

That Gold Content  
If that course is too objectionable, it is held, there could be recourse to further reduction of the gold content of the dollar. The profit derived by the Treasury from the "move off this sort still is around somewhere. Members of Congress never have been quite able to understand how this profit has been or is being used as a stabilization fund. There have been suggestions that it be diverted to pay the bonus and the idea might become even more tempting in the future.

The President's sac card, therefore, in the opinion of many, is to enunciate with even greater emphasis the principle he laid down last winter when he vetoed the independent offices appropriation bill. The veto, said Mr. Roosevelt, "is not based solely on the consideration of dollars and cents."

sighted friends of the party. The screams of those who want to continue collecting their blood-money will fall on deaf ears so far as Ickes is concerned. He already has \$150,000,000 invested in slum clearance and plans to increase the ante plenty about that. Before he's through he hopes to have glorified tenements operating in about 15 cities.

Wherever Uncle Sam becomes a landlord only 30 per cent of the area acquired will be covered by buildings. The remaining 70 per cent will be turned into park and playground. Two, three and four story, completely modern apartment structures are contemplated with rental at about \$6 a room.

Progress to date has been slow because of the time required for condemnation proceedings. After a site has been selected it takes 100 days or better to acquire title.

Leaders: A politician who backs his judgment with cash and seldom loses is offering \$0 to 40 that Rep. Sam Rayburn of Texas will be next Speaker of the House. He is backing his choice against the field but getting surprisingly few takers.

The "field" actually narrows down to Rep. Joe Bryns of Tennessee. Although precedent dictates that last session's majority floor leader should inherit the Speakership, many of the railbirds are convinced his candidacy is fading as January approaches.

Vice President Garner will be in town any day now. He is a close friend of Rayburn's. Cactus Jack will deny taking any part in the House contest but there will be skeptics who will think he is yarning a little.

It is in the cards that Garner has been commissioned to sell Bryns the idea of leaving Congress altogether and becoming Director of the Budget. Such a job will tax the V. P.'s political skill if the situation is to be cleaned up with no dangerous hard feelings.

On the other hand, if Bryns could be shown in black and white he couldn't be elected Speaker that Budget job might suddenly become attractive. If he makes a run for it and gets beaten his status in the House will revert to that of a newly-elected Congressman. When he became Floor Leader he automatically gave up his committee assignments and seniority and he would have to start all over again at the bottom of the heap.

Rep. John McCormack of Massachusetts is gaining strength steadily as a candidate for the Majority Leadership. His election would answer the insistence of northern and western Congressmen that all of the leadership shall not go to the south.

During the off-season McCormack has been active as chairman of the Un-American Activities Committee which has been holding hearings in key cities all over the country.

Back on Nov. 20 this column tipped you the Rayburn-McCormack ticket was a good bet. It's a better one today—although, like horse racing, it's not a sure thing.

Noses: A demand is being revived that the U. S. Census Bureau make a nationwide unemployment count in 1935. It comes mainly from social workers who want the data and has support from politicians who could get some patronage there by. Both would like to know accurately what happened to city and rural populations during the depression.

Such a venture would be, in effect a modified decennial census and would give about 100,000 temporary employment. A bill ordering it is expected to be introduced early in the coming session of Congress.

Last session a bill was in for an unemployed census, to have been taken starting this past Nov. 15. Howls were raised against it on the ground that New Dealers were trying to get their hands on 100,000 new jobs for distribution at election time.

Just three more days of the tobacco season and the markets of this section will close. Those farmers who still have a little of their crop on hand must hurry if they want to sell it. We urge the growers to remember, however, that if they sell scrap tobacco it must be accounted for on their marketing cards if they want to avoid trouble, so if they have any to sell they should place it on the warehouse floors rather than sell it direct to dealers. Failure to account for scrap sales on the marketing cards is leading to a lot of trouble for many growers.

In putting up your Christmas decorations be sure that you take all precautions to avoid fires from same. In using paper or other flimsy materials for decorating same should not be closer than four inches to a regular electric light bulb as these bulbs generate heat and might cause the decorations to catch fire. In using decorative lighting circuits make sure that they are good circuits properly insulated and free from breaks or other defects that might cause short circuits. Don't take chances on marring your Christmas happiness by fire that might be caused from your carelessness in selecting or placing your Christmas decorations.

There is no abatement of the administration urge for government power ventures such as the Tennessee valley projects. Legislative indications point most strongly to regulation of holding companies.

A re-making of the railroad map still appears likely. Action at the next Congressional session promises to be limited, but a great deal is going on underneath with respect to the future.

The government is determined to bring the oil industry under more effective regulation, whatever it takes to do it.

However deep the peace which settles over Washington's relations with other business groups, these three salients hold the possibility of plenty of action.

**Bonus and Inflation**

Some of the "sound money" bloc is stirred up over the disclosure that President Roosevelt will meet the bonus agitation merely by asking where the money is coming from.

There are those in Congress who have a ready answer for that. They simply want to print the money. These two issues—bonus payment and inflation—seem headed for an intricate tangle before the session is over.

It may be purely a coincidence that Vice-President Garner, who knows House politics forward and backward, is coming back to Washington ahead of time; just as the Speakership contest approaches its decisive stage.

Of course Presidents and Vice-Presidents always take the attitude that they cannot interfere with House elections. It hardly is to be expected, however, that the overwhelming administration forces in the new House will fail to seek some

squarely up to FDR himself. It isn't far-fetched to say that the President's final decision on how much shall be spent next year for public works will be a vital and reliable tipoff on where the New Deal goes from here. New York still expects a conservative victory.

By examining the Securities Act with a microscope they've discovered that any officer or director who expresses an opinion about his company's financial status—unless it is based on facts contained in an audited and published report—is taking an awful chance. It appears that he can be sued for damages if (a) his statement later turns out to be inaccurate or (b) if he doesn't broadcast it to all his concern's security holders at the same time.

A number of companies have always believed that silence was golden when it came to answering stockholders' questions. This legal opinion is ice cream for them. They now have a perfect excuse for refusing to satisfy the curiosity of inquisitive shareholders—and nobody can accuse them of nefarious motives in keeping mum.

Recently he was named a member of the New York stock exchange "brain trust," an advisory committee to the exchange board of governors.

Professor George F. Warren left the chair of agricultural economics and farm management at Cornell University to flash across the national scene in connection with the Roosevelt "old purchasing and dollar depreciation" policies. He has returned to Cornell and now sees the President occasionally.

Professor James Harvey Rogers, the colleague of Warren, recently returned from an extensive silver investigation in the Orient under government auspices, is little heard of now. Presumably he will return to Yale as Sterling professor of political economy.

### The Old, Familiar Faces

Lewis Douglas, former director of the budget, and General Hugh Johnson, administrator of NRA until recently, while no specifically classed as the professor-type of "brain trusters," nevertheless generally were regarded as such. Certainly at one time they were among the most publicized members of the "new deal."

# Inauguration of U. S. China Airline Seen Next Year

Washington, D. C.—(AP)—Business men bound for the Orient and pleasure voyagers off to Far Eastern travel mecca soon may be boarding giant flying boats for swift transport over the world's largest ocean.

In view of the Postoffice Department's announcement that plans are being made for establishment "at an early date" of an American-controlled airline to China, the inauguration of the trans-Pacific flying service within a year is considered a likely prospect.

Pan-American Airways, which operates an international network of 30,000 miles serving principally South America and Central America, is reported ready to undertake the project. Government announcement of the enterprise is taken to indicate that the Postoffice Department will award mail contracts to help finance the service should it prove as feasible as now believed.

### Via American Possessions

The most likely route would be from some California airport via the American possessions in the Pacific such as Hawaii, Guam, the Philippines, and Canton, and connecting with airlines now operated in China by Pan-American in conjunction with the Chinese government. Pan-American officials have said a test flight will be made within a few weeks.

Preparing for trans-oceanic service, the company some time ago ordered six huge flying boats, one of which, the Brazilian Clipper, already has been in operation between Miami and South America.

It was great fun, and the casualties didn't run as high as one might think.

Now every corner is a "safety zone" with zig-zag white stripes running between each curb. Persons on foot are supposed to use them with impunity, yet if they get hit by an automobile each party is equally responsible and equally subject to a \$10 fine.

It has brought about a complete state of indecision. Automobiles creep carefully up to the intersections, watching a chance to dash across without winking a pedestrian.



Named To Highway Body

Raleigh, Dec. 4.—(AP)—Capus H. Waynick, High Point newspaper editor and former state senator, today was named assistant chairman of the State Highway and Public Works Commission.

The budget bureau has approved the temporary office of assistant chairman of the Highway and Public Works Commission and Waynick will assume his new duties at once at a salary of \$416 a month.

Chairman Jeffress has been seriously ill since the last of August and the highway commission of six members has been meeting to transact business of the department usually done by the chairman.

With the legislature only a month off and with much other work to be done it was decided to place the commission authority in one individual to serve instead of the whole commission and at the recommendation of Governor Ehringhaus the commission named Waynick.

Slayer of Nell Cropsy Kills Self

Elizabeth City, Dec. 4.—(AP)—James Wilcox, 58-year-old recluse, may have taken with him into death today the answer to the question of who killed beautiful Nell Cropsy.

Lying on his bed in the room which he occupied in the rear of a garage, Wilcox placed a shotgun under his left jaw and blew his head and face off.

Wilcox served 16 years in state's prison after being convicted of second degree murder of Miss Cropsy on the night of Nov. 29, 1901. First he was sentenced to hang but was granted a new trial in Perquimans county, and then was sentenced to 30 years on second degree murder. He was pardoned by Gov. Bickett Dec. 24, 1918.

Pier Lands In Sea

Honolulu, Dec. 4.—(AP)—"Will land in sea," said a brief message at 8:30 a. m., today (2 p. m. EST) from the Hawaiian-bound plane of Lieut. Chas. R. Ulm and his two companions as they asked the army and navy to stand by.

At 8:55 a. m. after battling nearly two hours to find their way successfully to Wheeler Field army airport near here, Ulm gave up and sent out an SOS. In the same message he said he was south of Honolulu but was heading back toward his plotted course.

TRANSIET TRAFFICS IN BLANKETS; FIVE MONTHS

Durham, N. C., Dec. 4.—Judge Walter Bass started off his reordership of Durham County Recorder's Court today by sentencing Quitman Lollar, 37-year-old World War veteran, to four months on the roads for the larceny of five blankets from the local transient bureau and trading them for two fruit jars of whiskey.

Lollar told the court the blankets were thrown out of the bureau window Saturday night. Police declared that transients were making a regular business of trading blankets for whiskey. He was given an additional thirty-day sentence for drunkenness.

POLITICS AT RANDOM

By BRYON PRICE

Some "new dealers" think the Ickes-Moffett incident may have results far beyond the field of housing policy. They hope to use it as an object lesson to help clear some of the confusion out of the Washington situation in general.

For a long time business in particular has been complaining of "uncertainties" and "contradictions" in administration policy.

These complaints were given prominent expression some weeks ago by the Chamber of Commerce of the United States. The gist of the protest was that business men could not confidently plan recovery unless they knew in what direction Washington planned to go.

Lately there have been signs that many business leaders were losing that hesitation, and were convinced the administration was heading along a pathway where business could safely follow.

Then, just at the psychological moment, two exactly opposite views about housing were voiced by two high administrative authorities.

Whither Administration?

The merits of the dispute between Secretary Ickes and Housing Administrator Moffett were significant enough for their own sake. Whether private industry or the public Treasury is to assume the load of national housing rehabilitation is a large subject in itself.

The larger question asked by many however, was whether the policies of the administration, as a whole, were to continue to be beset by confusions, inconsistencies, and cross-purposes within the inner circle of the President's chief advisers.

In this respect the Ickes-Moffett flarke-up served as a sort of climax to the long period of uncertainty in NRA, the series of reversals and new starts in relief, the controversy over banking policy, the constant amendment of official interpretation of Section 7-A and in short, the whole problem of right- and left-wing influence at the White House.

Hearing From Headquarters

The situation with relation to these matters generally is the more interesting when it is considered alongside the situation at the start of the Roosevelt administration.

No one disputes that the new regime in Washington, just after March 4, 1933, won the confidence of the country with unusual alacrity because of its swift, clear-cut action in the banking crisis, in shaping a new agricultural policy, in putting forth a bold recovery program through the (now much-amended) NRA.

There has been abundant evidence since that the President was fully aware of the rising conflicts within administration ranks. Twice he has appointed "co-ordinators" to bring the various lines of administration policy into harmony. More than one public official whose activities befogged the situation heard about it from headquarters.

There are those in Washington who believe Mr. Roosevelt will be disposed to apply very strong medicine to this general ailment. They believe the coming session of Congress may see another period of direct and clear-cut action. Time alone can tell whether this expectation is justified.

"I'm sure I'm right!" exclaimed Willy Nilly. "I couldn't mistake that voice! And I thought so as soon as I saw our first snow of the season!"

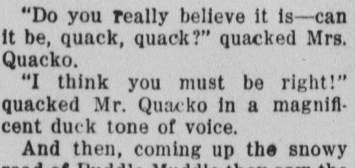

Minnesota to Beat 1930 Irish I asked a prominent coach who had seen both teams in action, at their best, to give his opinion on how the 1934 Minnesota aggregation would have fared against Knute Rockne's 1930 Notre Dame team, featuring a backfield of Carideo, Brill, Schwartz and Savoldi.

"It's hard to say but offhand I would pick Minnesota to win," he replied. "Maybe last impressions are stronger but I have a feeling that this year's Minnesota line would wear down that great Notre Dame outfit and finally pave the way for Lund, Aphonso, Kostka and company to run up a score. The Irish were faster and they had some great blockers. I wouldn't trade backfields, although I consider Kostka a more powerful line-backer than Savoldi, but I cannot escape the impression of overwhelming power given by the Goper forwards. It's the nearest thing to a top-notch professional line that I have seen—so far as weigh, power and drive are concerned."
