Dogolyub Yezitch Tells League Council Hungary Plotted Death of King Alexander; Says Act Was Direct Slap in The Face to Yugoslavia

Geneva, Dec. 7.—(AP)—Dogolyub Yezitch, foreign minister of Yugoslavia, denounced the Hungarian government today in the League of Nations' council as responsible in connection with the assassination of the late King Alexander of Yugoslavia.

Dr. Combs, the new president, became pastor of the Methodist Church over a year ago and during the time has taken an active interest in work of the association. As a member of the Kiwanis Club he directed the campaign to increase resources of the public library, and was also one of the leading figures in the movement resulting in the permanent Boy Scout organization for Greenville. He has also been prominently connected with other movements looking to improvement of community life.

PLAN SAFETY CAMPAIGN IN THIS SECTION

City Government to Inaugurate Movement to Reduce Toll On Public Highways

A concerted campaign to make the public "traffic conscious" will be inaugurated by the Board of Aldermen as soon as plans can be worked out.

The campaign in its incipient stage provides for bringing other cities and counties into the movement in the hope that sufficient competition in highway safety may be stimulated to reduce the awful toll of life and property taken by accidents on the various highways of the territory.

A committee composed of Mayor R. C. Flanagan and Chief of Police George Clark was named by the board to work out plans for the campaign and to get it into effect at the earliest possible moment. The committee was instructed to use banners across highways coming into the city and other phases of publicity to forever remind motorists that life is too precious to be thrown away for the sake of a "fool's chance."

The campaign was decided upon following a brief but impressive talk by Judge Frank Wooten, who proposed that the board do something to help reduce the daily toll of life taken by automobiles on the highways of the community.

Judge Wooten urged the board to inaugurate what he termed a "campaign of persuasion in view of the fact that the monthly toll of life taken by the highway is gradually increasing. He declared something must be done to make the streets and highways of the community safer for the citizenship, and that this could be accomplished only through forever keeping before the eyes of motorists the idea of driving safely under all conditions.

The speaker declared this responsibility of cutting down the loss of human life was up to the people, not especially operators of automobiles. He declared "we need more respect for the rights of others" and pleaded for a keener spirit of cooperation between law-enforcement officers and the citizenship.

The judge proposed that Greenville carry the program to other cities and communities, asking them to join in a competitive contest to reduce accidents in the quickest and most direct way possible. If necessary, he said, records should be kept of the automobile toll in the various communities and that these be compared at the end of each month to see which had made the greatest progress.

Alderman J. H. Boyd thought so much of Judge Wooten's proposal that he called upon the board to immediately name a committee to draft plans for the campaign, and if thought necessary, place signs across the highways on the town limits to notify the public that Greenville and Pitt County are for safety on highways, and calling on everybody to try to drive safely and sanely.

The board named the mayor and chief of police to direct the campaign and obtain the assistance of the county governments and city and county governments in other surrounding counties in an effort to make the movement as widespread as possible.

CITY CAR TAGS PUT ON SALE

New Greenville automobile license plates went on sale at the city clerk's office this morning, and citizens were urged to buy them immediately and have them on their cars by the end of the month.

The licenses were placed on sale following approval by the Board of Aldermen here, last night. The plates were to have gone on sale the first of the month when state tags were offered, but this has delayed pending okay by the board.

The tags are similar to those adopted by the state this year, silver figures on a black background and are very good to look upon. In fact the figures are believed to be visible from a greater distance than those previously used.

To give the tags a good sendoff, members of the board unanimously approved a suggestion that each provide himself with tags during the evenings. They paid over the cost of \$1 to the clerk and left the meeting happy in the fact they had obtained the first numbers. The numbers were from 1 to 9—very small as numbers go, but the aldermen felt mighty big over being the first purchasers.

THREE KILLERS PUT TO DEATH AT RALEIGH

Raleigh, Dec. 7.—(AP)—North Carolina, for the first time in its history, today exacted the lives of three white men of a family on a single day in the electric chair at state prison, for the crime of murder.

The triple electrocution, which was the second time three men had been put to death in three weeks at the prison, saw a father, Bascom Green, 44; his son, Lester Green, who would have been 23 on Monday, and R. E. Black, 25, son-in-law of the elder Green, walk their last mile.

The men all lived in High Point when they were arrested and all received death sentence for complicity in the attempted robbery of the Merchants and Farmers Bank of Taylorsville in which T. C. Barnes, the cashier, was fatally shot, and Solon Little, another employe, was wounded.

The state required 49 minutes to exact the death penalty of the trio. Mike Stefanoff, a Bulgarian emigrant, and fourth man convicted in the same case, went to his death in the chair early last summer.

The electrocution took place with no untoward incident and followed a veritable seige of pleas to Governor Ehringhaus to intervene, the weight of the requests being for Black, whom the evidence showed took no actual part in the shooting that occurred in the bank.

The two Greens both had lost appeals to the Supreme Court, the adverse decision having been rendered only last month.

Until November 6, when three young negro men paid the supreme penalty for the crime of murder, the state had never taken more than two lives in one day. Now within three weeks a second triple electrocution had been entered into the little brown record book at the state prison.

The execution of the two Greens marked the second father and son to die the same day in the chair, a similar event having been recorded in 1925.

BOARD LOWERS FIREWORK BAN

Children to be Permitted to Shoot Pop-crackers on Their Own Premises Here

With Christmas just around the corner, members of the Board of Aldermen decided last night to play Santa Claus to the children of Greenville by lifting the ban on the shooting of fireworks during the holidays.

Following an appeal from Sheriff Sam Whitehurst that the ruling prohibited the shooting of fireworks in the city limits be lifted during the holidays, the board not only decided to permit the use of fireworks in the celebration, but let down the bars so that dispensers of fireworks at the outside of the city limits come within the city limits to sell their products. Of course, they will be required to pay the usual tax asked by the city for the privilege.

In letting down the bars, the board specified, however, that the shooting of fireworks must take place on private premises. The ruling becomes effective today, and will expire the end of the Christmas season.

In commenting on the action of the board today, Chief of Police George Clark said that anybody apprehended shooting fireworks on the streets.

ARRANGE FOR COTTON-LEAF GROUP MEETS

General Meeting of Cotton and Tobacco Growers Here Tomorrow at 11 A. M.

Plans had been completed here today for the meeting of cotton and tobacco growers at the court house tomorrow morning at 11 o'clock for explanation of the referendum to be held on cotton and tobacco control acts December 14. It was announced today by E. F. Arnold, director of the local farm department.

In addition, Mr. Arnold also announced the dates and places of the series of group meetings to be held in various parts of the county next week to give farmers an opportunity to hear the referendum explained. Meetings will be held at the following places: Bethel, Community Building, 10 a. m., Monday December 10. Stokes, Christian church, 2 p. m., same date. Farmville, City Hall, 10 a. m., Tuesday, December 11. Black Jack, store, 2 p. m., same date. Winterville, school, 10 a. m., Wednesday, December 12. Ayden, school, 2 p. m., same date.

In view of the important part which the two pieces of federal legislation have played in the life of farmers, Mr. Arnold urged growers to attend the meeting in large numbers and fully familiarize themselves as to the Smith-Keer tobacco act and the Bankhead cotton control legislation.

The referendum is being conducted in all sections of the country where cotton and tobacco are grown for the purpose of determining sentiment of producers, and it is vitally important that growers vote and let their views be known.

Mr. Arnold particularly requested that the meeting here tomorrow morning be largely attended.

RIVER NEARS CREST HERE

Rampaging Tar Expected to Stop Rising at 19-Foot Stage Here Tonight

Tar River, which has overflowed its banks far into the lowlands, continued to rise slightly today, but was expected to reach its crest sometime tonight and begin falling tomorrow.

B. T. Clark, local weather observer, said this morning he received a message from the State Weather Department late yesterday afternoon saying the river was expected to reach a 19-foot stage sometime tonight.

Mr. Clark said the flood water stood at 18.8 feet this morning early, a rise of something like a foot above the report issued. The report yesterday morning revealed that the stream had risen over three feet during the past 24-hour period.

The flood was reported to have halted school buses in the Falkland community yesterday and today, making it impossible for children across the river to reach the school until the waters recede.

The highway at Tarboro was still covered by the muddy flood waters, it was reported today, but the inundation was not sufficient to halt traffic. Members of the high patrol were sent to the flood area yesterday morning to assist motorists in crossing the affected area.

Captain Stratford of the Salvation Army told the board his organization had just completed liquidating all debts owed by the Army here, and asked the board to raise this monthly contribution to the organization. The board agreed to increase the donation from \$20 to \$25 a month through February in view of the excellent work which the captain and his wife are doing here.

Late News Flashes SITUATION IS TENSE ALONG THE FRONTIER

Seek Jury In Grice Case. Goldsboro, Dec. 7.—(AP)—For the third time Mrs. Ruby Grice Sasser and her brother, Donald, came before the bar in Wayne Superior Court today for trial on charges of plotting her husband's death with Rufus Satterfield, her professed lover, who is under sentence to die a week hence for the killing.

A venire of 100 men from the adjoining county of Johnston reported at 9:30 a. m., for possible jury duty but the formalities of Judge E. Hunt Parker in explaining the rights of the defendants delayed the start of the actual quest for the jury until after 10 o'clock.

Only 11 jurors had been selected when the Johnston county venire was exhausted at 1:30 and Judge Parker ordered a second venire drawn and summoned to report at 9:30 tomorrow morning.

Charge Conspiracy In Yugoslavia. Geneva, Dec. 7.—(AP)—A general conspiracy against the territorial integrity of the new states born of the world war, was charged before the League of Nations council today by Edouard Benes, foreign minister of Czechoslovakia.

Benes' startling allegation came during a heated discussion of Yugoslavia's charges that the assassination of King Alexander at Marseille.

"There has been no mobilization of our troops on the Hungarian frontier," a spokesman asserted. "Our troops have not been reinforced by a single man since October 5 (the date when King Alexander was assassinated). At present our frontier forces are pretty small because the winter leave season has begun and large numbers of soldiers have been released for vacations.

"Reports that our soldiers have crowded the Hungarian frontier," the spokesman continued, "have been circulated by Hungary in order to divert world attention from Yugoslavia's protest to the League of Nations against Hungary's complicity in the murder of our king."

Szeged, Hungary, Dec. 7.—(AP)—After intermittent forays across the frontier into Hungary this morning, Serbian troops attached to the Yugoslav army retired temporarily, relieving the highly dangerous situation. As the forces remained only a short distance from the frontier, their presence is a source of great anxiety to Hungary.

The official Hungarian News Agency said the "chetniks" organization of armed men made a midnight raid in evacuated Hungarian homes in Yugoslavia carrying off valuables.

A pogrom, the agency said, was announced to be impending in Hungary. The News Agency declared the Yugoslavian authorities in their wholesale deportation did not spare anyone by reason of age, sex or illness.

"At a railroad terminal on the point," said the Agency, "mothers were looking for lost children and children were looking for mothers. Yugoslavian police showed a complete lack of mercy to those expelled. The refugees were forced at the point of bayonets to take anything with them, and were then marched under guard to the railroad station. They did not even spare a 70-year-old man with an insane wife.

"Among the refugees were elderly babies. A thousand Hungarians have been expelled from the Banya district, 1,500 from Novisad and 1,200 from Fubotica.

"The Serbian detachment entered this country about three miles from here early this morning and obliterated the Hungarian border forces to fight. Only strong disciplinary action by Hungarian officers may prevent a battle. The situation was tense and grave and fears were felt by authorities.

"Szeged officials said they did not believe an attack on the city was contemplated, but if it came, the city was prepared. Streets were crowded with Hungarian soldiers."

MEEKINS AT HIS DESK DESPITE HIS INJURIES Elizabeth City, N. C., Dec. 7.—Federal Judge I. M. Meekins was back at his desk here today despite minor injuries sustained yesterday afternoon when his automobile was in collision with another near Bailey.

"I am feeling as well as could be expected," said the jurist.
