TWO SCORE PERSONS DIE IN LANSING HOTEL FIRE

Yugoslavian Quarrel With Hungary Halted By League

SETTLEMENT IS HAILED AS BIG TRIUMPH

Both Nations Approve Resolutions Deploring Assassination of King Alexander; Not a Dissenting Vote is Cast; Hungary Asked For Punitive Punishment Of Authorities

Geneva, Dec. 11.—(AP)—A threatening Yugoslav-Hungarian quarrel was ended today and the agreement hailed by Geneva statesmen as a noble triumph for the League of Nations.

Especially gratifying to them was that it followed closely the removal under league auspices of another European "war threat." This was the Saar Basin territory plebiscite on which a Franco-German financial agreement was made last week and a solution reached on the difficult problem of policing the territory.

Both Hungary and Yugoslavia at a session of the League council last night approved a resolution deploring the assassination of King Alexander of Yugoslavia at Marseilles. Not a dissenting vote was cast.

Hungary was asked in a tactful way to take "punitive action against any authorities who special identities have been established and to communicate to the council the measures which it takes to this effect."

Both Yugoslavia which has charged Budapest with complicity in the assassination by harboring terrorists and Hungary appeared satisfied. Statesmen of major European powers were relieved when the government at Budapest, after signing a draft of the agreement, instructed its representatives to "vote for the resolution."

Diplomats here said the agreement provided that nations may make concessions to the League which they would find difficult to make direct to the government with which it was at odds.

They expressed belief the resolution provided the "certain Hungarian authorities may have assured at any rate through negligence certain responsibilities relative to the acts having connection with the perpetrations of crime at Marseilles."

YOUTH JAILED FOR LARCENY

Walter McKeel to be Sent to Reformatory After Stealing Articles from Cars

After being arrested on a charge of theft, Walter McKeel, 14-year-old Greenville youth, was being held in jail here today awaiting action of Juvenile court authorities looking to confining him in a reformatory.

The youth was taken into custody last night near State Theatre, after allegedly robbing several automobiles parked in the theatre district. Chief of Police George Clark said today the youth had stolen gun shells, cigarette lighters, gloves and a number of articles left in the cars by their owners.

The officer said McKeel was under a Juvenile court suspended sentence and that he would be sent to the reformatory to serve a term imposed by the court sometime ago.

The boy was reported to have given police considerable trouble recently. Several youths have been taken into custody lately on charges of minor thefts, and the majority have been sent to state reformatories. Among them were a number of colored youths, charged with perpetrating a number of robberies in this community.

Fortune Teller Leaves With Stolen Diamonds

Police today were seeking a phrenologist named Madame Tucker and two other members of her party for the alleged larceny of diamonds and other jewelry which Chief of Police George Clark said might eventually reach a value of \$25,000.

Associated with Madame Tucker were Mr. and Mrs. Butler. The three disappeared from the home of Mrs. Della McGee where Madame Tucker had rented a downstairs apartment for the practice of phrenology. The trio had been here about a month.

Mrs. McGee reported the loss of a diamond ring and silverware valued at over \$1,000 when the trio disappeared from her home this morning in a large Packard automobile which they brought to Greenville when they came here several weeks ago.

The phrenologist was also said to have taken a diamond ring valued at \$4,000 from Mrs. Jim Long, in addition to several pieces of jewelry from other folks. Chief Clark said it probably would be several days before the full extent of the loss would be determined.

The fortune teller, the officer said, won the confidence of ladies of the city after telling their fortunes, and asked them to let her wear pieces of jewelry. She first started out by taking trivial things, and then later the most expensive she could find.

The officer said the woman obtained possession of Mrs. McGee's ring and brooch by telling her she desired to buy them. The ring was said to have been obtained from Mrs. Long while telling her fortune.

Mr. Clark said he was convinced jewelry and probably a considerable amount of silverware had been taken from other unsuspecting women of the city and expected the loss to grow as soon as news of the disappearance of the woman is made known.

Butler, it was said, told people he was employed by an automobile concern out of the city and was here attempting to dispose of some cars they had on hand. He was reported to have remained out of the city most of the time but his wife usually was with Madame Tucker.

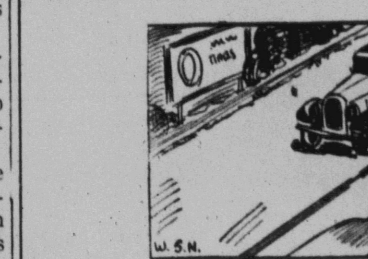

Trawlers Floated.

Manteo, Dec. 11.—(AP)—Three fishing trawlers which went ashore in Hatteras inlet bar today at 5:30 while one of the worst December snowstorms in the history of Dare county weather bureau swept the coastland, were floated later in the day by a crew from Hatteras inlet coast guard station under command of Capt. Bernice Mallance.

A 30-mile gale and blinding snow combined to contribute one of the worst threats to navigation the coast county has known this winter. Coast guard crews along Dare's 25 mile coast were on the lookout this afternoon.

The boats which were floated today after going ashore at Hatteras were the Betsy C and the Mary of New London, Conn., and the Ladao-grace of Philadelphia. The Betsy C was so badly damaged that the coast guard took her to shallow water for repair.

A. W. Drinkwater in charge of the weather bureau here which has been in operation for the past 30 days, said shortly after noon that the temperature was 28 degrees and that the wind was from the north.

New Slant On Reynolds Will.

Winston-Salem, Dec. 11.—(AP)—Only the relatively small personal estate of Smith Reynolds is subject to North Carolina intestate laws and the trust fund left him by R. J. Reynolds, Sr., is not subject to distribution under these laws.

The trust itself is entirely separate from an estate and its distribution will be governed by the terms of its creation—in this case the will of the late R. J. Reynolds, Sr. If the will of Smith Reynolds filed in New York in 1931 and already contested is declared invalid then the \$25,000,000 trust fund which is not

HOLD YOUTH FOR INQUIRY

James Robbins of Washington Surrenders For Hurling Brick Thru Window

James Robbins, 17, of Washington, N. C., believed by police to be mentally deranged, was being held for investigation here today after hurling a brick through the plate glass window of Key Brown's Drug Store at Five Points last night, and then going to the police station and surrendering.

Chief of Police George Clark said a physician would be called sometime today to examine the youth and in the meantime effort was being made to get in touch with his parents and inform them of the youth's predicament here.

Walking into the police station this morning about 1 o'clock, Robbins was said to have told the officer on duty that Greenville didn't have any police department because he had hurled a brick through the plate-glass window in the heart of the business district without being apprehended.

"Had I done such a thing in Washington," officers quoted the lad as saying, "I would have been caught in no time."

He said Washington had a crack police department, but didn't think much of the law-enforcement department here.

Asked about his parents, Robbins told his questioner he did not want them to pay him out, that he wanted to serve his time in jail.

His strange statements caused Chief Clark to believe the youth was mentally off and he immediately decided to call a physician for an examination.

The plate-glass window was badly damaged and will cost no small sum in being replaced.

Chief Clark said no direct charge had been brought against Robbins in view of the fact it is believed he is suffering from some mental disorder. His parents, however, will be asked to make reparations for the damage done to the drug store.

MRS. SMITH SEEKS HUGE LEAF FORTUNE

Former Wife of Smith Reynolds Wants \$25,000,000 For Self and Daughter

Winston-Salem, N. C., Dec. 11.—(AP)—If the contention of Ann Cannon Reynolds Smith are upheld by the courts she and her daughter, Ann Cannon Reynolds, II, will have their already huge patrimony—the Cannon towel fortune—enhanced by the \$25,000,000 tobacco fortune of Smith Reynolds. This was disclosed today by an examination of this State's intestate laws.

The opinion is predicted not only upon the court's findings that Libby Holman Reynolds was not the legal wife of Smith Reynolds, but also on the invalidity of a will made by Mrs. Smith Reynolds August 21, 1931, and filed in New York.

In her petition filed in Forsyth court, Mrs. Smith asked the court to divide the estate but made no suggestion as to the terms of the division.

If she is established as the legal widow, and it is ruled that her husband died intestate, Mrs. Smith would receive one-third of the estate and her child two-thirds. The wife is supported by the estate one year before debts are deducted. Real estate goes to the child subject to the widow's dower which allot her the income of one-third of the real estate for life.

The intestate law provides that if there is more than one child, the estate is divided equally among the children, and the widow getting a child's part.

The application of this law could not be made, of course, unless Libby Holman and her child are declared ineligible to share. This phase in itself would involve a lengthy court battle.

Error: Those concerned are rapidly discovering that political influence doesn't cut any ice around the Narcotics Bureau.

A few days back Dr. Edward Huntington Williams of Los Angeles, one of the founders of the American College of Surgeons, was convicted by a jury of issuing narcotic prescriptions to addicts not in accordance with professional practice.

Williams was a defense alienist in the famous Massie trial in Hawaii.

One of the character witnesses for the Doctor was Mayor Frank Shaw of Los Angeles. The prosecuting attorney, on cross-examination asked Shaw why he had made a trip to Washington to see Deputy Commissioner of Narcotics Louis Ruppel. The Mayor replied he had seen Ruppel and the latter had told him Williams was being prosecuted on a technical violation which probably would not hold.

Ruppel at this moment was in Honolulu on official business. Appraised of the Mayor's testimony, the Deputy Commissioner called back to Los Angeles a statement Shaw had attempted to use the power of his office to prevent Dr. Williams' (Continued on page four)

FRIGID WAVE HITS SECTION

Cold Wave Accompanied by Snow Sweeps Over This Part of the Country

Frigid temperatures, accompanied by snow, swept over this section today bringing to Greenville and vicinity the coldest weather of the year.

B. T. Clark, local weather observer, said the mercury dropped to 20 degrees here last night, one degree under the cold wave recorded here the 17th of last December.

The temperature, although low for this season of the year, lacked just 11 degrees reaching the seige of winter which visited this city last January 30, causing the mercury to hurdle to 9 degrees. That was not only the coldest weather of the winter, but of several years, and several weeks were required to repair the damage to water and heating systems done by the cold blasts.

The second snow of the year started falling late yesterday afternoon and slowed down last night around 9 o'clock. The tiny flakes melted as fast as they hit the pavement, but stuck on housetops, and this morning the city was covered with a thin coating of white that had turned to ice under the impetus of freezing which followed the snow.

The first snow of the season came last Friday night and continued Saturday morning, but the ground was so warm it failed to stick.

The sky continued dark today, indicating further snow might be expected during the day, but late this afternoon none had appeared.

FIVE KILLED BY JUMPING INTO STREETS

Early Morning Flames in Zero Weather, Turn Kerns Hotel at Lansing, Mich., Into Death Trap; Records Destroyed, May be Days Before Total Dead Revealed; Several Legislators Believed Dead

Lansing, Mich., Dec. 11.—(AP)—An early morning fire in zero weather turned the Kerns Hotel into a death trap today and with eleven known dead, police and firemen predicted the number of the fatalities might reach forty.

Their escape cut off by the flames, many guests jumped from the upper windows, some to the streets, others into the Grand River which flows at the rear of the hotel. A score of the guests were legislators here for a special session.

Five of the known dead drowned. Five others died of injuries suffered in leaping to the streets. Fleeing witnesses told of stumbling over the body of David Monroe, the assistant hotel manager, who apparently died of suffocation or injuries.

An incomplete list of injured in hospitals stood at twenty-seven. No complete list of the missing could be compiled because the hotel records, including the register, apparently were destroyed. Police and firemen said they believed the hotels ruins, which were still blazing fitfully and too hot to permit investigation, contained probably twenty bodies, and that possibly almost as many drowned in the river.

State Senator John Lerrdin, of Saginaw, was missing, as a fellow legislator who pounded on his door with the flames licking at his heels said he was unable to arouse him. Apparently he perished.

It was apparent that with the hotel records missing, it might be days before the full extent of the tragedy could be told.

Dr. Frank Brown, of Duke, Delivers Address at Chapter Meeting Last Night

Donald Conley, director of the Pitt County Department of Education was elected president of the Pitt County chapter of Duke University Alumni Association at the annual meeting of the organization held here last night in celebration of "Duke University Day." He succeeds Dr. J. M. Barrett, who served for the usual term of one year.

Other officers elected were: Dr. M. T. Frizzelle, of Ayden, vice-president, and Mrs. R. L. Coleman, of Greenville, secretary-treasurer. Mrs. Foster Young was elected as representative of the Alumnae Council.

The celebration was held at the Woman's Club at 7 o'clock. Similar celebrations were in progress in various communities throughout North Carolina and other States, and even in some foreign countries. Today, December 11, marks the tenth anniversary of the Duke Endowment, made possible by the signing of the Indenture of Trust by the late Jas. B. Duke, whereby Duke University was created.

The local meeting was presided over by Dr. J. M. Barrett, president of the association. After dinner the guest speaker of the evening, Dr. Frank C. Brown, head of the English Department at Duke University and for years Comptroller of the University, spoke authoritatively on "The Advancement of Duke University During Ten Years." The most interesting facts presented centered around the wide scope of usefulness which Duke University has enjoyed during its first decade of growth.

In the field of hospitalization alone over 472,000 patients have been treated in institutions throughout North and South Carolina. Over seven million dollars has been divided among 124 hospitals in these States, and free services have been rendered to an average of 400 patients daily. In the Duke Hospital alone more than 48,000 patients have been treated in the last four years. Orphanages, rural churches, retired ministers, and needy students have likewise shared generously in the benefaction of the Duke Endowment. Over fifty orphanages in North and South Carolina are yet receiving regular contributions from the Endowment. Last year at the University \$348,000 was paid out for self-help in scholarships, fellowships, loans and campus positions.

In discussing the specific aspects of growth and advancement at Duke University during the last ten years, Dr. Brown emphasized first of all the undergraduate school. Later the medical school, law school, school of religion, departments of engineering and forestry were briefly analyzed. A report of the co-operation which the universities at Chapel Hill and Durham are fostering apropos their libraries was hailed with enthusiasm by Dr. Brown. Encouraging remarks characterized the resume of religious and social activities at Duke among its 3,200 students. North Carolina, Pennsylvania, New York, and Virginia are respectively most frequently represented by students at Duke, stated Dr. Brown; and among this number, 750 are women. In his final remarks, Dr. Brown suggested ways whereby alumni may be a vital part of the University in its future development.

A. A. U. W. Meets. Miss Emma Hooper presented an interesting program for the A. A. U. W. meeting Monday night, December 10, a discussion of the play of the year.

Saying that she took the year to the Pulitzer Prize year, April 1, 1933, to April 1, 1934, Miss Hooper pointed out that one would find it hard to select the play of the year. Burns Mantle's "Best Plays of 1933-34" features "Mary of Scotland," the critics acclaim "Tobacco Road," a picture of all the worst of Southern life, and even the powers-that-be behind the Pulitzer award disputed over the relative merits of "Mary of Scotland" and "Men in White."

Most of the plays in the public eye have been strongly social and moral in their tone, thoroughly permeated by the social problem atmosphere. For "Mary of Scotland" which she said critics agree "achieves beauty and richness of speech and dignity of action," she gave the thread of the plot leading up to the great scene between Queen Mary and Queen Elizabeth in which Mary realizes that Elizabeth has caused her downfall. MR. FARMER! YOUR FATE IS IN YOUR HANDS

On Friday of this week the tobacco and cotton growers will have the opportunity by their ballot to decide the fate of the Kerr-Smith tobacco control act and the Bankhead cotton control act.

These laws that were passed for the protection of the growers who signed cotton and tobacco contracts were adopted for the duration of only one year and unless the growers go to the polls Friday and vote for the continuation of these laws they will cease to exist with the result that those growers who have signed contracts will be left with the bag to hold while the non-signer will have the opportunity to clean up at their expense.

The only thing that has made the tobacco and cotton contracts a success is that the non-signer has had to pay a heavy tax on his crop while the government has exempted the contracting grower from the tax through the medium of a tax payment warrant. If the Kerr-Smith and the Bankhead laws are permitted to cease their operation through the failure of the farmers to vote at Friday's election it will mean that next year, with no tax to pay, the non-signing grower will plant tobacco and cotton to the limit while the contracting grower will still have to hold his crop down to the government allotment thereby giving all the advantage to the non-signing grower.

Every farmer, landlord and tenant is entitled to vote in Friday's election and we urge especially the contract signers to avail themselves of this opportunity to protect their interests by voting to keep these laws in force that will tax the non-signing growers.

went the trans-Pacific wire, he apologized for interfering. This message was read to the jury and probably had much to do with their verdict.

Parole: Last year Deputy Commissioner Ruppel discovered by accident that a Democratic National Committeeman was pulling wires to have a New York dope peddler, found in possession of a ton of opium, paroled.

Ruppel turned the public eye toward his fellow party-man. If the peddler would reveal the names of his bosses in the racket there was no objection to his parole. Otherwise there was plenty. The man served out his sentence.

Narcotics Commissioner Harry J. Anslinger has been backing his somewhat youthful assistant, a former New York newspaper man, to the limit in this resistance to jolitical pressure.

Ironing: Organized labor, as represented by President William Green and the Washington headquarters of the American Federation of Labor, is making a lot of bold and aggressive gestures at the moment.

The unionists actually are emulating the Spartan who failed to make an outcry while a wolf beneath his cloak gnawed at his chest. Before Green's summarily called convention of his Building Trades Department two weeks ago, this column forecast that the labor movement was headed straight into a major internal crisis. Subsequent developments bore this prediction out.

The Carpenters, Bricklayers and Electrical Workers came back to take charge of the Building Trades take charge of the Building Trades unions waked out.

Latest dope from the labor front is that Green and his coordinators are working night and day to bring about a compromise—with fair promise of success.

A. F. of L. masterminds have until January 29 to accomplish their purpose. On that date the newly-enlarged Executive Council of the Federation meets for the first time. Before last October's convention it was composed of 11 members, who came from numerically small unions. Now there are 18 members and the big fellows are in the saddle.

Should they so decide the victorious Carpenters, Bricklayers and Electrical Workers undoubtedly could bring about a final ratification of their ousting of the little fellows.

History, however tells us that the miscellaneous trades can always beat the big unions in a family row. If the painters, elevator constructors, metal workers, etc., walk against their own brethren it is almost impossible to complete a building. Further, though smaller in numbers, some of the so-called miscellaneous trades are much more compactly organized.

So the oldtimers predict an acceptable branch will be extended to the minority dissenters. Two peace offers already have been made by the steam roller crew, but rejected. Odds are good that Green will have the whole squabble ironed out by January 29. The big shots of organized labor can't afford to lose the bet.

New York By JAMES McMULLIN Wages: The National Association of Manufacturers said little official-

system has worked beautifully for coal.

Ambitious: Railroad circles see a ray of hope for themselves in J. J. Pelley's new Association of American Railways. For the first time the industry has an organization which considers its problems from the viewpoint of the common welfare instead of the advantage or otherwise to some particular road.

Much yet but this hasn't dimmed its pep and ambition. Pelley's policy is to tackle the toughest problems first—on the theory that if these can be solved the rest will be easy.

The problems rated toughest may surprise you. In passenger traffic it's the Pennsylvania-Baltimore and Ohio competition between New York and Washington. It may sound simple to have each road run trains on alternate hours instead of every hour—but you can't take insiders' word for it that it isn't.

In freight it's lake cargo coal—coal shipped to a Great Lakes port by rail and then transported by water—usually east—to get cheaper rates. Simple: A Pennsylvania coal company is located on a railroad with a direct spur to the Buffalo Edison plant. But it ships its coal to a point across a narrow creek from the plant and has it hauled across by barge to get the lake cargo rate. The ICC forbids a lower price for all-rail delivery.

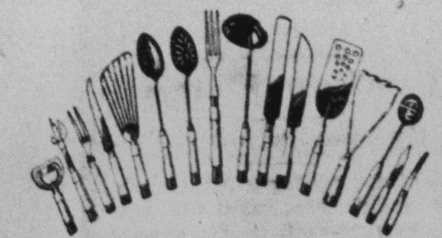
