BANKHEAD COTTON ACT GIVEN LANDSLIDE OKAY

Bandits Shut Ohio Village Off From World, Rob Bank

GUNMEN DARE RESIDENTS TO LEAVE HOMES

Seven Booming Charges Set Off in Bank, Blowing Parts of Vault Into Streets; Telephone and Electric Wires Cut Before Entering Bank; Village Stranded From Outside World

Willard, O., Dec. 15.—(AP)—A gang of eleven or more burglars shut the nearby village of North Fairfield off from the outside world early today, set off seven booming charges of high explosives in the village bank and escaped with loot estimated at \$2,000 by C. D. Harvey, president of the bank.

The gang came into town shortly after 2 a. m. and working leisurely, did not leave until 4:30 a. m.

During this time all the residents were kept in their houses by gunmen who dared them to come out and attempt to stop the burglary.

James Garzik, a carpenter, stepped out on his back porch and seven shots were fired in his direction. Garrett was not struck.

Members of the gang placed barn floors over the front windows of the bank, a frame structure, to screen their activities. With pieces of the vault and sections of the bank walls, the doors were blown out into the street. Pieces of the vault were found as far as 100 feet from the bank.

The gangsters, carefully and deliberately, cut all telephone and electric light wires in the village before entering the bank.

At 9 a. m. today telephone men were still trying to repair the damage and put a line through to the stranded village. North Fairfield has a population of approximately 800.

FIREWORKS CASE CLOSED

Louisburg Young Man Ordered to Pay Cost For Firing Popcrackers on Street

O. C. Hill, magazine agent, who gave his address as Louisburg, and who allegedly violated the police order not to shoot fireworks on the streets, was released on payment of cost when he appeared for hearing in mayor's court this morning.

Another young man, whose name was not disclosed, was summoned along with Hill on a similar charge, but was released when Hill assumed responsibility for shooting the fireworks.

Hill was ordered to appear before the court the first of the week when police said he was caught tossing fireworks out of a hotel window on Dickinson Avenue.

Chief of Police George Clark stressed the danger of tossing fireworks in streets when Hill was ordered to appear before the court, declaring the action jeopardized the lives of automobile drivers as well as persons walking along the streets.

The Board of Aldermen recently lifted the ban on the shooting of fireworks in the city by permitting their use in the backyards of homes. Chief Clark declared that anybody caught exploding fireworks on the streets would be summoned before mayor's court to explain why they did so.

CLOUDBURST DOES DAMAGE IN CALIFORNIA

Volcano Eruption, Floods, Snowstorms Beset Other Parts of The World

(By The Associated Press) Nature beset several sections of the world today with results of a series of violent manifestations.

There were cloudbursts in California, volcanic eruptions in Honduras, flood from the River Tiber in Rome, and heavy snowstorms throughout the Canadian province of Nova Scotia.

Seventeen persons perished as the British steamer Usworth was caught in a Middle Atlantic gale and was abandoned. Eleven others were saved.

Heavy rain in the Sierra Madre hills north of Los Angeles drove a five-foot current down foothill boulevards endangering the suburbs.

In Rome a week of rain sent the Tiber out of its banks. Roads were blocked by snowstorms in Nova Scotia which appeared to be moving to Newfoundland with increasing intensity.

The United States, for the most part, enjoyed fairly comfortable weather, but more snow is due for parts of the Middle West which was hard hit by snow during the last two weeks.

Foil Attempt To Rob Bank at Micro

Smithfield, Dec. 14.—The second attempt to rob the Bank of Micro within a year was frustrated in the early hours of Wednesday morning when would-be robbers fled after being discovered by a Micro citizen who happened to pass along the street at the time.

A Mr. Batten, who was on his way to the home of a druggist to get medicine for his wife who was taken ill during the night, heard a noise when he passed the bank and discovered that it came from the rear of the bank building. He roused a friend and the two of them went to investigate.

Cotton and Tobacco Acts Given Fine Support Here

Pitt County farmer are unequivocally in favor of continuing the Bankhead compulsory control act and the tax feature of the Kerr-Smith tobacco control measure.

Going to the polls in unprecedented numbers in the referendum held throughout the county yesterday virtually ten thousand growers cast their ballots overwhelmingly in favor of the two pieces of legislation passed by Congress to control production and boost prices of the two crops.

E. F. Arnold, director of the Pitt County Farm Department, who directed the referendum in this county, stated this morning members of his department were highly gratified with the splendid way which growers rallied behind the measures. He expressed his appreciation of the fine spirit exhibited by committee members in various parts of the county in arranging for the ballot.

The task of compiling the vote was a tremendous one, Mr. Arnold said, but it was handled in a highly efficient and satisfactory manner reflecting great credit upon the pollholders.

The total compilation of votes from all polling places gave 4,533 for the cotton act and ten against. With 177 votes outstanding in the

ETHIOPIA AND ITALY AT ODDS

Filing of Complaint With League by Ethiopia Causes Serious Situation

Rome, Dec. 15.—(AP)—Ethiopia's action in presenting its annual documentation to the League of Nations and filing it "Italian aggressions," was described by a government spokesman today as creating a serious situation.

As a consequence, the spokesman said the Italian government is contemplating taking definite steps in addition to filing a reply at Geneva. He would not indicate what this step would be, but intimated it might be concerned with sanction of the undefined Somali, Ethiopian frontier.

Italy would also insist, the official source said, that there be an immediate delineation of the frontier by the Joliet, Italian, Ethiopian commission.

The action of taking the controversy to Geneva signifies the Ethiopian government has assumed responsibility for the clash, the spokesman said. Prior to this, he said Italy had been led to believe the battle was precipitated only by local Ethiopian chieftains.

SCOUTS SEEK TOYS FOR POOR

Canvass Made of City Today for Broken Toys For Firemen to Mend

Boy Scouts of the city were in the midst of their canvass for broken toys for the poor this morning, but no report as to the success of the effort will be available before Monday.

All toys collected by the Scouts will be turned over to the local fire department for repairing. The firemen have put their toy shop into operation and expect to fix up scores of old toys for the poor between now and the holidays.

The toys will be distributed by the Salvation Army among children who will know little of the joys of Christmas time without activities of this kind.

The toy shop has been operated by the firemen for several years, and each year has seen numbers of toys abandoned by children of prosperous parents converted into practically new things to carry a thrill to the lots of the less fortunate of the community.

The Scout canvass today was under the direction of Leon Keaton, director of the Scout movement here. Keaton said several days ago every troop in the city would take part in the canvass in an effort to round-up as many toys as possible.

Officials of the Salvation Army said the need of toys this year was probably as pronounced as ever, and hope was expressed that persons who do not contribute today would send their offerings to the fire department where they will be properly taken care of.

CURB OF OTHER CROPS IS SEEN IN BALLOTING

Unofficial Returns Today Give 896,233 Votes For And 91,280 Against Compulsory Control Legislation; Only Four States Fail to Roll Up Necessary Two-Thirds Vote; N. C. Votes 12 to 1 in Favor of Measure

(By The Associated Press) A landslide for compulsory control of cotton led to speculation today as to whether the future might see such a curb extended to some other major crop.

Growers of the South voted yesterday on the question whether to continue the Bankhead Act next year, and incomplete returns today were:

Yes—896,233; nay, 91,280.

This was a proportion of more than 9 to 1. A two-thirds vote was necessary for continuance. About 2,600,000 producers were eligible to vote, and Secretary Wallace had estimated beforehand that about half that number actually would ballot.

Out of seventeen States voting, the returns showed four—Arizona, California, New Mexico and Oklahoma—failing to roll up two-thirds for the act, which imposes high taxes on cotton sold in excess of quotas. The national average is the deciding figure.

Raleigh, N. C., Dec. 15.—(AP)—By a margin of twelve to one, North Carolina farmers have spoken with ballots that they favor continuation through 1935 of the Bankhead Act to compel reduction of cotton acreage. Virtually complete official and unofficial returns showed North Carolina producers voted 117,087 to 9,540 for retention of the existing law.

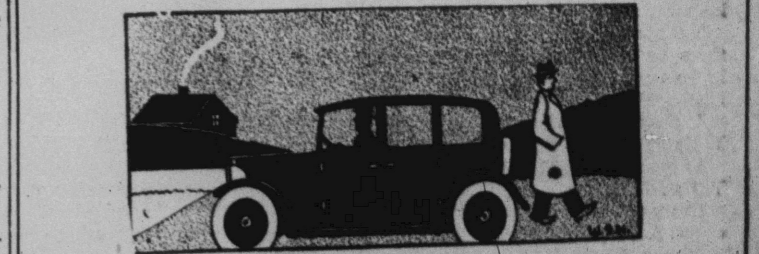
The figures included 77 of the State's 79 cotton-producing counties. Only 17 votes, eight in McDowell and nine in Person, were unreported. The eligibility records indicated through that some of the figures might be altered in the official canvass.

Stanly and Caswell were the only counties to vote against continuing the plan, it was indicated. In Caswell there were six votes for and twelve against. In Stanly the vote was 1,022 to 597 against the plan.

Lawson Little may be the king pin of the world's amateur golfers by virtue of his victories in the British and United States amateur championships last season, but out at Palo Alto he is just another sophomore trying for a place on Stanford University's golf team.

The Cardinal golf enthusiasts were delighted to welcome him back to his studies, for they visioned the strongest college golf team ever organized.

The long campaign, climaxed by his smashing victory in the National championship at Brookline, left him badly in need of a vacation from golf. Picking up his clubs after a few weeks' rest to try out for the Stanford team, Little found himself very much on the spot.

An international figure with a glittering record behind him, he was just another cocky sophomore when he got out on the first tee. To get a crack at beating the National champion all you had to have was a set of golf sticks, a certificate of eligibility, and a little confidence.

And it seems there were quite a few boys with the sticks, the eligibility and the confidence, for in the first match, Little was unceremoniously defeated by a lad named Tom Dwyer.

Even with the Stanford football team taking up most of the space in the West Coast sports sheets, this little sport managed to squeeze in on top of the pile. The boys wrote at great length about the uncertainty of the game. But wait till next time, they pointed out!

Next time, Little was beaten again by a fellow by the name of Hoerner. His first name to make matters worse was Jack, so a defeat of Lawson Little by Little Jack Hoerner gave the scribes a great chance to do bright little pieces about the plum Little Jack pulled out of the golfing pie.

Now, in all probability, the British and U. S. amateur champion will win his way back to a position on the team. But if he does get back, he'll probably have to win his way. Getting on your university golf team isn't like getting on the U. S. Walker Cup team. They make you prove your worth on the campus links.

who had been brought in to Cincinnati from Columbus to tell the bank that owned the club how the Reds could be conjured out of the National League cellar.

He's Back For More - But the test of Crosley's unselfish desire to give Cincinnati a winner came this winter, not last. After dropping the \$50,000 and having to take an undesired share of the adverse criticism which follows any loser, he sanctioned MacPhail's program to continue spending money to develop and buy as many young ball players as can be had. And the Cincinnati club today is the most progressive second division club in major league baseball.

There is a distinct possibility that Cincinnati would not have a major league baseball team today if it had not been for Crosley. And anyone who has ever been in Cincinnati knows what a tragedy this would be there. Though the citizens spend their time consoling the Red and all connected with them to a point far from the banks of the Ohio, still they would not give up the privilege of moaning about that team for all the beer in all the beer gardens in the city.

Let's Scrap the Old Machine - MacPhail's plan for the coming campaign will be the old New Year's cry of "out with the old and in with the new." Several moves have been made in this direction already, and by the time the December league meetings are over, he will be further along the road.

This plan is likely to take one or two paths. It may contemplate doing away entirely with all the old-timers and going along with youngsters who clearly are not quite ready for the majors, or he may string along for another year with the old-timers and add all the new material he can.

More than likely he will keep a few of these old stars in the hope of getting out of the cellar next year. MacPhail would like to be rid of them all probably, and introduce to the majors the youngest, noisiest, wildest, outfit the league has ever seen, but he can't be too radical in a precarious situation. He's too good a baseball man not to know that!

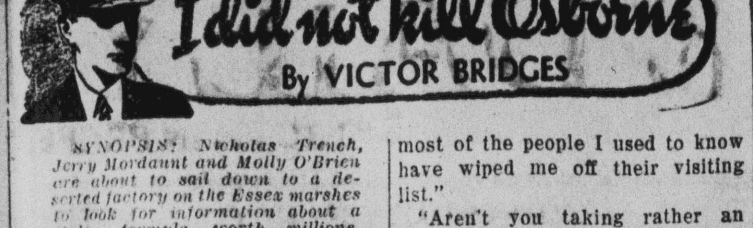

NEW BOOKS

By JOHN SELBY It is a matter of opinion, probably influenced liberally by political preferences, whether Theodore Joslin has bettered familiar picture of his former employer, Herbert Hoover, in "Hoover Off the Record" (Doubleday, Doran).

Mr. Joslin was Hoover's secretary. He kept a diary, evidently a most complete one. He waited some time after Hoover's retirement to publish Alto to speak his mind. Now he draws his own Hoover portrait, and it is like the never-to-be-forgotten Ravel "Bolero" which is a study in crescendo.

Mr. Joslin begins with a justification of Hoover methods, Hoover silence, and one or two other characteristics of the ex-President. Then he reaches the main theme of his book and that is the incredible Hoover capacity for hard work. This he develops in greater and greater volume until finally the reader has the feeling (quite without Joslin's desire and perhaps wrongly) that if play things might have gone easier for him.

The former Secretary writes sincerely. He is willing, as is his principal, to await the much-touted "verdict of history" on the actual accomplishments of the Hoover administration.

"Cradle of the Deep" by William Beebe (Harcourt, Brace). The deep sea explorer tells in rapid prose and by means of fascinating illustrations, what he found in the depths of Bermuda; also the history of deep sea diving.

Combined Carrier Cruiser Passes Swedis Navy Test

Stockholm. - (AP) - A new cruiser-airplane carrier, claimed to be the first fighting ship of its kind in the world, has been given its first tests and will become a part of the Swedish coast defense carry next year.

The Gotland, as the new ship is called, is hailed by military experts as one of the most modern, compact and efficient products of twentieth century naval shipbuilding genius.

The vessel has the distinction, among other things, of being the first cruiser to carry more than two air-planes, in addition to anti-aircraft guns, torped tubes and mine-laying equipment.

In full fighting trims the Gotland will carry eight airplanes on catapults, with provision for landing on a typical airplane-carrier deck.

Armament will include six 6-inch guns, four large anti-aircraft guns, and four special machine guns for defense against air attacks. There will be, in addition, six specially designed torpedo tubes.

The Gotland will be turbine-driven, oil burning, with a forced speed of 27.5 knots. It has an overall length of 442 feet, a displacement of close to 5,000 tons, and has been built at a cost of approximately \$4,000,000.

The WORLD OF STAMPS

By QUINCY JAMES Italy is celebrating in stamp again. The latest is a special set of stamps issued for the Rome to Mogadiscio fight.

All together, the set comprises stamps: one of which has been placed in a rarity classification. A recent photograph of King Emanuel is the principal idea for the design, with the ruler's head centered on the horizontal oblongs. Other than the lettering, the stamps consist of solid background, and each stamp is printed in a slight shade of 1 particular color.

To recapitulate, they are: One lire violet, 2-lire blue, 4-lire brown, 5-lire green, 3-lire carmine, and 10 lire sepi. The rare one is a 10 lire which has been surcharged a gold for official use, with the stamp itself different in color.

Also in connection with the fight special airmails were issued for the Italian colonies.

Just a Note Central Lithuania, now a part of Poland, issued stamps only for the years 1920-1921-1922. That was during the time that the territory was occupied by Polish troops after capturing it from Lithuania.

Saar and Stamps Postage stamps are playing a definite part in calling the attention of users of the mails to the coming plebiscite in the Saar Basin, set for next January 13. All denominations of the current issue of Saar stamps have been surcharged "Volksabstimmung 1935" meaning "plebiscite 1935."

In addition German postal authorities have joined in the campaign special postmark "Saar plebiscite 13 January 1935" is being used by all postoffices in Germany: Black white-red letter seals in the form of stickers also have been issued. Framed by a broken chain, the sticker shows on white background the slogan, "We want to return to the Reich," while "German is the Saar" is printed in fat black letters over the red inner design.

The German postoffices also are selling a button-hole badge consisting of a piece of Saar coal imbedded in a small brass plate to support the campaign. The badge reminds Germans that "the day of the reunion of one Europe's richest coal deposits with the Reich is not far away."

Votes: The Treasury Department put out an official figure the other day that tells a whole story when lined up alongside three other figures. In 1933 a grand total of 3,660,305 individuals paid all the income tax Uncle Sam received. Right now there are approximately 18,000,000 living on federal relief. Around 29,000,000 voters went to the polls last month. Current population usually is estimated at about 130,000,000.

More succinctly, five relief-benefitters for every taxpayer. Assuming they are adults, all six are entitled to vote.

Some of Washington's keenest analysts have decided this ratio points the national trend for the immediate future—not by the same differential, of course, because half the dole-dependents probably are minors. Here is their line of reasoning: The needy are content to let the national debt pile skyward so long as it means their food and shelter. The taxpayer may complain but he is in the minority. He can be voted down. This enables the New Deal to go ahead with its big pump-priming act. For the present there is no need to tinker with the dollar or inflating via the printing press. Much needed money to finance the forthcoming public works program can be borrowed. Payment, as usual, comes later.

In this connection economic authorities have been stressing a premise recently that Uncle Sam is far from foundering in debt. Comparisons with England and France—on a basis of debt vs. national wealth—would permit us to put many more billions on the cuff. Cash: Rep. Wright Patman of Texas, arch-advocate of the paid-up bonus, is preparing to steal a leaf from the diary of those astute nursemaids of Democracy, Jim Farley and Emil Hurja.

During the recent campaign Farley and Hurja, from National Democratic headquarters here saw to it that every district learned just how much Federal aid money had been pumped into it by the New Deal. Somehow word of this leaked out to the right sources. Manufacturers were tipped by their bankers to lay in an immediate surplus ahead of arbitrary price rises. Millions were spent in stocking up. Your history tells you the Hoover Administration undertook no price-fixing.

That is what might be called creating "a good panic" for the moment.

New York By JAMES McMULLIN Travelers: New York bankers are descending from their ivory towers and hobnobbing with their associates in other sections to an unprecedented extent. Not much publicity has attended their movements, but there is a notable change in the financial aces have heeded Horace Greif's advice to go West.

The important trends began in August when two Morgan partners made a quiet tour of the middle and far West. A little later James H. Perkins of the National City following their trail through roughly the same territory. But the most elaborate expedition to date is the one now being conducted by the Chase Bank. POLITICS at random

By BRYON PRICE (Chief of Bureau, The Associated Press, Washington)

A really ambitious effort is being made at Washington to knit tightly together the loose ends of the recovery program.

This has been tried before, the never under similar circumstances not with quite the same evidence of earnest determination. The current attempt is of such magnitude as to constitute a notable feature of all pre-congressional discussions.

Many have been the complaints that too much confusion and too many inconsistencies have attended recovery policies.

Mr. Roosevelt's friends have held that much of the confusion was unavoidable during the earlier stages of the administration, when emergency situations had to be faced one by one as they arose. It has been argued that NRA, for instance, scarcely could have been fully coordinated with anything, as no one knew at first what NRA would be like; and that such other agencies as the relief administration "just

grew," and had to be for the time being a law unto themselves.

That Budget Message

Whatever the truth may be about that, the President manifestly is convinced that more point and direction now can be given the whole group of recovery agencies.

Most of the experiments have progressed to a point where definite conclusions can be drawn. In addition, Washington has been assembling a great fund of detailed information on what may be expected from private industry in the way of recovery effort.

In spending, particularly, the lines are being more carefully drawn. The idea of a general recovery fund with disbursements sharply coordinated, is growing. Officials now believe they can tell with some degree of accuracy what relief and other expenditures will amount to during the coming year.

To fix these figures, of course, it first is necessary to decide what kind of relief is advisable, what experiments should be continued and what abandoned. So that it is the making of the budget, which must be submitted to Congress right after New Year's Day, which is hastening many vital decisions of policy.

That is the task to which Mr. Roosevelt now is addressing himself. It is possible that other budget message ever has been so

revealing as the forthcoming one must be, of necessity.

Not An Easy Task

There is much dispute how far the administration will be able to go in actually bringing the vast recovery machine into exact adjustment.

Mr. Roosevelt has learned in two or three previous attempts that laying down rules for co-ordination does not necessarily mean that co-ordination has been accomplished.

For the present, however, it is interesting and potentially important news that the situation is receiving serious attention; that the President has been impressed by opposing charges of confusion and inconsistency, and will try to do something about it.

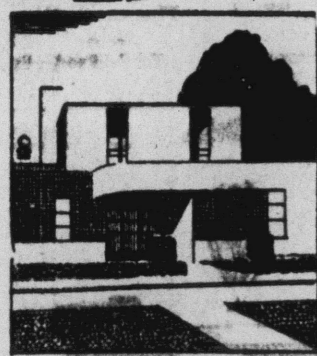
