JAPAN SEEKS TO RESUME NAVAL CONVERSATIONS

SANTA CLAUS GIVEN GREAT WELCOME HERE

Patron Saint Rides Into City on Wagon After Abandoning His Reindeers

Santa Claus rode triumphantly into Greenville last night and thrilled hundreds of children and grown-ups as he paraded down the main business streets of the city, distributing gifts of candy, apples and other things.

Abandoning his reindeers several miles from the city, St. Nicholas made his entrance into Greenville in a wagon pulled by two prancing mules. He had to abandon his reindeers because of the change in weather conditions, the temperatures prevailing here last night being declared too warm to permit the reindeers to continue their furious pace.

But regardless of the lack of sleigh and reindeers, Santa received a vociferous welcome from his admirers here and the adulation of the public, especially the children, probably will continue undiminished during the remaining several days of the cherry old gentleman is scheduled to spend in the city.

St. Nick was brought to Greenville under the auspices of the merchants' division of the Chamber of Commerce, and his arrival ushered in the opening of stores at night to take care of the holiday shoppers from now until Christmas.

With store windows gleaming with brilliant decorations and streets sparkling with vari-colored Christmas lights, Santa's entrance to the community last night was probably the most auspicious in the last several years.

Unmindful of the fact that he was riding behind two proud mules, St. Nicholas beamed benevolently upon the hundreds of children and grown-ups who thronged the sidewalks and streets in an effort to get a better view of him and to receive some of the gifts he threw into the crowd from time to time.

It was a great evening—the greatest since arrival of the Patron Saint last year—and the concourse followed the wagon until St. Nicholas dismounted at a vacant lot on Dickinson Avenue to take part in the brilliant fireworks display provided as a climax to the night's activities.

Visibly exhausted by his long trip from the Northland, Santa Claus left the business district shortly after the program had been carried out and prepared for taking his place in the various shopping centers during the intervening time between now and Christmas.

He will be on hand in stores and along the streets from day to day to help provide inspiration for shoppers and little children who never tire of looking at the white-whiskered old gentleman.

The annual visit of Santa and the opening of stores at night always stimulate interest in the myriad joys of the holidays and Greenville has been transformed by the Christmas spirit that will reach its climax Christmas Eve night when the Patron Saint or Millions of children in all parts of the land sneaks from houseposts to houseposts, cramming compass stockings with the things that carry joy to the hearts of tots and other members of the various households of the community.

SLAV CABINET EXPECTED TO RESIGN TODAY

Entire Government Probably to Give up Work During Late Afternoon

Belgrade, Dec. 18.—The Yugoslav cabinet reconsidered its decision to resign today after the withdrawal from the government of Bogolyub Yevitch, the Foreign Minister, and Dragutin Kovich, the Minister of Agriculture.

The resignation of the entire cabinet following a conference late today was accepted as a foregone conclusion.

The ministry at first intended to follow Yevitch and Kojick in placing their resignations in the hands of Prince Paul, head of the regency. Late it was decided to postpone action until after the remaining members of the cabinet had an opportunity to confer.

The sudden crisis was regarded as a test of strength between Yevitch and Premier Nikola Uvornich, aged head of a dozen successive governments.

THREE MEN KILLED IN MOTOR ACCIDENT

Warsaw, Ky., Dec. 18.—(AP)—Three men were killed and four others injured, one seriously, today when two automobiles collided head-on near the Warsaw airport.

The dead were identified as John Sech, of 44 Middlesex Road, Seehim, N. Y.; Joseph Netry, 20, Louisville, drivers of the cars, and John George, Louisville, who was riding with Netry.

Zech's wife, Dorothy, 23, was seriously injured. Three men in Netry's car, who gave their names as Abe Karen, George and Karen Malick, of Louisville, received lesser injuries.

BOMB BLASTS CARRY TERROR THRU HAVANA

Fear of Revolution Causes Soldiers to be Placed on Duty in The Streets

Havana, Dec. 18.—(AP)—Nearly one thousand soldiers patrolled the streets of Havana today after a night of bombing and fear of revolution.

Terror spread throughout the city before midnight when more than 40 bombs exploded. Three women and two men were injured by the blasts which were set off in every section of the capital.

Soldiers spent the early morning hours searching pedestrians, motor buses, and street-cars for bombs. Fourteen persons were arrested on charges of placing the explosives or for having them in their possession.

The city became excited over the possibility of a revolt or other outbreaks after police seized the supply of dynamite and arrested 90 passengers on buses where the explosive was found.

Extra precautions were taken by the army when an officer reported he had detained three members of the ABC political society opposed to the government of Carlos Mendieta and his strong man, Colonel Fulgencio Batista, commander-in-chief of the army. Sailors and police were also ordered to be in readiness.

The army officer said he had seen many other men, presumably ABC members, leaving the city in groups. Tension had been high since a band of armed men allegedly secret police last week raided the plant of the newspaper Accion, an ABC organ, and forced nine editorial workers to take castor oil.

HUGE STILL IS CAPTURED

Six Thousand Gallons Of Beer Also Taken By Officers In Falkland

The holiday supply of liquor in the Fountain community was cut short yesterday when sheriff's officers captured a distilling plant with 6,000 gallons of beer.

The still had just been fired up for operation when the officers suddenly swooped down and put an end to what would have eventually turned out to be a big load of whiskey to help take care of the holiday demand in this community.

Two men escaped when they were warned by outposts of the approach of the officers.

The still was of a 120 gallon capacity and was constructed of copper. It was one of the finest types used in distillation of contraband whiskey in this part of the country.

Distillers in all sections of the county are running at full speed ahead at this time in an attempt to take care of the public demand. Consumption at this season of the year is always larger than any other time and distillers and rum runners are making a titanic effort to take care of their customers.

Officers are keeping a keen lookout for the illicit traffic and scores of operators are expected to fall into the hands of the law between now and the first of the year.

Pitt Pays Defaulted Obligations In Cash

Pitt County today claimed the distinction of being the only county in the State to take care of its defaulted obligations in cash.

While a number of other counties have been calling attention to refunding operations, it was announced from the courthouse today by County Auditor Coward that Pitt had paid off \$120,000 worth of its obligations in cold cash, and is able to take care of its remaining obligations for the fiscal year in good style.

Mr. Coward said money for taking care of the obligations was on hand last June and had been paid gradually since that time as the county was able to get bonds in hand. Many of the securities, he said, were scattered in all sections of the county, and considerable time was required to get them in. All but around \$2,000 of the total sum has been paid, and the money is on hand at the treasury to take care of this obligation as soon as the bonds can be obtained.

The clerk also made known that enough money is on hand in the county coffers to take care of remaining obligations of the year.

With improvement in the county's financial situation caused by rapid collection of taxes, the county is in better financial shape at this time than it has been in years.

Like every other form of government, Pitt was hard run during the years of depression, but by slashing here and there and reducing expenses wherever possible, the commissioners were able to see their heads above the water when money became easier to obtain, and today were figuratively "sitting on the top of the world."

The commissioners and others connected with the operation of the county government, are proud of the fine record they have been able to establish, especially that of being the only county in the State that has been able to pay off its defaulted obligations in hard cash. It is a record others probably will sit up and take notice of in view of the unusual amount of publicity which has been given to refunding operations by other county governments.

BETTY GOW ON BIG FREIGHTER VESSEL BOUND IN DISTRESS IN FOR AMERICA MID-ATLANTIC

Former Lindbergh Nurse Expected to Testify in Hauptmann Murder Case

Glasgow, Dec. 18.—(AP)—An authoritative source said tonight that Betty Gow, former Lindbergh nurse, will sail from Cansa Saturday on board the steamship Duchess for New York.

New York, Dec. 18.—(AP)—The pruser of the S. S. Aquitana today reported not on board to a query was to whether Betty Gow, the former Lindbergh nurse, has sailed on the vessel for the United States.

London, Dec. 18.—(AP)—The possibility was seen today that Betty Gow, former Lindbergh nurse, who has cloaked all her movements in recent months in the deepest mystery, is aboard the Anchor Liner Galadonia nearing the American shores to testify at the murder trial of Bruno Richard Hauptmann.

The local office of the Anchor Line confirmed the report that a woman who booked passage under the name of "Vivien M. Taylor" sailed on the Galadonia from Glasgow December 13. The ship is due in New York December 20.

Miss Gow's mother is named Taylor. It was considered possible in Glasgow where all attempts to reach Miss Gow in recent months have been rebuffed, that the former nurse might be using that name. There was another rumor in Southampton that Miss Gow had boarded the Aquitana that sailed for New York this morning under the name of Taylor. This rumor was not confirmed.

MAN HELD IN HIT-RUN CASE

George Jackson of Greenville was to face trial here this afternoon on a charge of hit-and-run driving following an automobile wreck on the Greenville-Ayden highway, about a mile from Greenville last night.

He is charged with running into another automobile driven by Earl Stokes of Winterville, without stopping. He was chased about a mile and a half down the road and captured.

Sheriff Whitehurst said today Jackson appeared to have been taking up too much of the road when he ran into the other car. Both cars were damaged.

Bigger College Boys. Raleigh, N. C.—(AP)—It seems the college boys are getting bigger. Measurements compiled by the military department of North Carolina State College show the average freshman there this year is five feet 8.8 inches high and weighs 144 pounds. Last year's model was five feet 8 inches and weighed 142.

PERKINS IS CHOSEN NEW TREASURER

County Commissioners Also Adopt New Health Budget at Special Meeting

Vance Perkins, of Greenville, was named County Treasurer to succeed A. T. Moore at a special meeting of the Board of County Commissioners here yesterday.

The action followed the inability of Moore to provide bond of \$150,000 required for the post.

In a brief note to the commissioners, Moore, who had held the position of Treasurer for a number of years, explained he was unable to arrange bond and saw no immediate prospects of doing so, and tendered his resignation.

After accepting the resignation the board selected Perkins, who ran second to Moore in the primary in June, and then lost out in the second primary held a month later.

Perkins presumably will take over the post as soon as he can arrange bond, it was understood today.

Moore was not inducted into office the first Monday in December at other county offices because of failure to provide bond, and was given until yesterday by the commissioners to take care of the bond.

In addition to disposing of this matter, the board also concurred in action of the Board of Education in appropriating \$500 a year to the Sheppard Memorial Library of this city because of services which the institution has rendered to the various schools of the county.

Donald Conley, director of education, explained the action of the education department and told of the fire services which the local library had rendered to the school system by lending books not only to the children but valuable works of references to the faculty members.

The new health budget, carrying total appropriations for \$11,880, was also adopted. The department had been operating on a tentative budget pending settlement of provisions for the various fields of activities.

Of this amount of the county appropriates \$9,800, the remainder of the fund coming from State and Federal departments of health. In addition to the budget, the Federal Government also provides \$1,800 annually to defray the cost of employing an all-time sanitary inspector. The amount directly appropriated by the county is nearly twice as great as last year, and opens the way for certain improvements in public health activity throughout the county. The county last year allotted \$5,400 for this purpose.

The board also permitted the courthouse to close Monday at noon to give employees ample time for celebration of the Christmas holidays.

The courthouse will be re-opened Wednesday morning for resumption or regular business.

Prepare For Enrollment New CCC Contingent

An announcement was made at the FERA office today for boys to enroll in the fourth enlistment of the CCC. White boys between the ages of 18 to 25 inclusive, unmarried, who are eligible for relief under this plan may be enrolled. Pitt county's quota is 21. Application for enrollment may be made any time at the FERA office at the county house.

Final enrollment and entree in the CCC work will be made at Washington on January 10, where complete physical examination will be given.

Five alternates will also be selected to fill vacancies for rejections and physical disqualifications. Young men who have served a former enlistment will not be eligible for re-enrollment.

Early this morning Preslar was nabbed by officers in a Standard Oil Filling Station here. Officers were posted near the station because of a wave or filling station robberies that have occurred in that vicinity.

On the stand today one of the officers who made the arrest quoted Preslar as saying that he intended to get married Christmas and he needed some money.

ROBBERS VISIT OAK CITY FIRM

Over \$200 Worth of Clothing Taken by Thieves at Small Town Last Night

L. D. Page, finger-print expert of the local police department, returned this afternoon from Oak City where he investigated the robbery of a clothing firm last night in which goods valued at \$200 or more was taken by the thieves.

The name of the firm was not determined by the officer, who obtained a number of prints and expressed belief the robbery was the job of inexperienced thieves, probably of that community.

Page said overcoats, suits of clothing, dresses and a considerable amount of clothing were taken by the robbers, who gained entrance to the building by boring a hole in the back door and tripping the lock. Tracks at the back door indicated a truck or automobile was used in hauling the goods away.

## YOUTH ON PAROLE IN DIFFICULTY GAIN

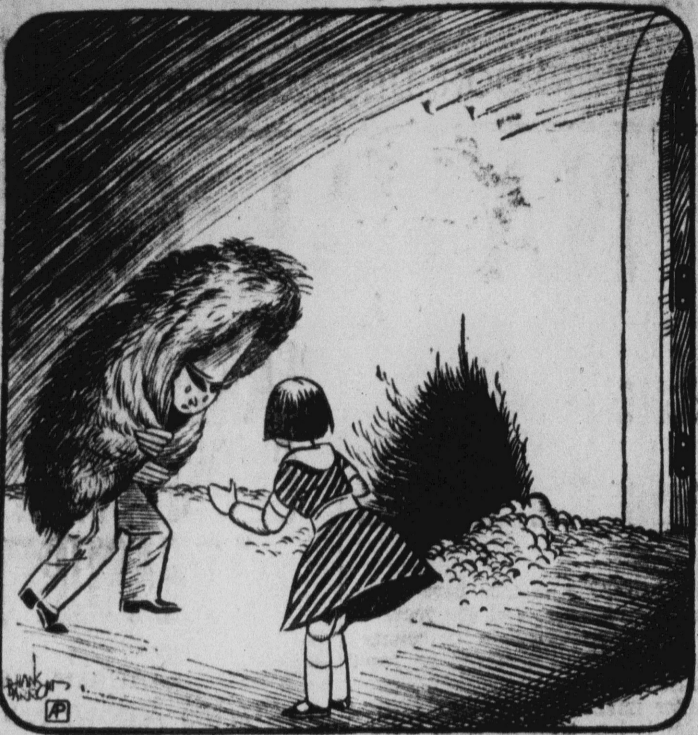

**Boy Scout Advancement.**  
In order to become a second class Scout, a Scout must:

1. Have at least one month's service as a Tenderfoot and know how and when to wear the Scout uniform.
2. Know the general directions for first aid; demonstrate treatment including dressing, where necessary, for hemorrhage, fainting, shock, bruises, burns, injuries in which the skin is broken, sprains, and demonstrate with the triangle the following bandages: head, arm (slung), hand, foot, and ankle bandage; eye and jaw bandages (roller bandages may be substituted on arm and ankle); artificial respiration. The Scout may elect to demonstrate any five requirements on animals.
3. Elementary signalling: know the alphabet of the Semaphore Code; or the General Service (International Morse) Code; or the elementary signs of the Indian Sign Language Code; or the letters of the Manual Alphabet for the Deaf; either with one or two hands.
4. Track half a mile in 25 minutes or if in town described satisfactorily the contents of one store window out of 4 observed for one minute each.
5. Go a mile in 12 minutes at Scout's pace—about 50 steps running and 50 walking alternately; or lay out, measure by the stride method and stake a four acre tract of land.
6. Use properly knife and hatchet.
7. Prove ability to build a fire in the open, using not more than two matches, care for and put it out.
8. Cook a quarter of a pound of meat and two potatoes in the open, without any cooking utensils.
9. Earn and deposit at least one dollar in a public bank or other savings institution (premiums paid on life insurance are accepted, if earned); or earn, raise and own some farm animal, or earn and contribute one dollar or its equivalent to the family budget or to welfare work in the community.
10. Know the 16 principal points of the compass.
11. Demonstrate his practice of at least five rules of safety at home, or work, or school, or on the street, or road, or farm.
12. Furnish satisfactory evidence that he has put into practice in his daily life the principles of eth Scout oath and law.

To make matters clearer, the Minerals Division is supposed to help American manufacturers of iron, steel, copper, etc., find profitable markets abroad. The Bureau of Mines is a scientific and research agency. Business men want their promotional and sales agency kept where it is.

Charges have been made that if one division of the Bureau of Foreign and Domestic Commerce is allowed to pass to another jurisdiction others will follow. It would be possible, under an arbitrary classification, to turn many of the Bureau's existing units over to the Department of Agriculture. If this chipping should be carried to an ultimate conclusion, say the protesters, there would be little left in the Bureau of value to American business either in the "Foreign" or "Domestic" line. Overly enthusiastic partisan Democrats are held to be the worst offenders in trying to cripple the Bureau—solely because of the prominent attachment Mr. Hoover's name had to it for so many years. Those now in the saddle at the Bureau point out that Woodrow Wilson actually conceived the idea of a foreign field service for industry. The claim Mr. Hoover overdeveloped it but that they are carrying on with all of the originally good features.

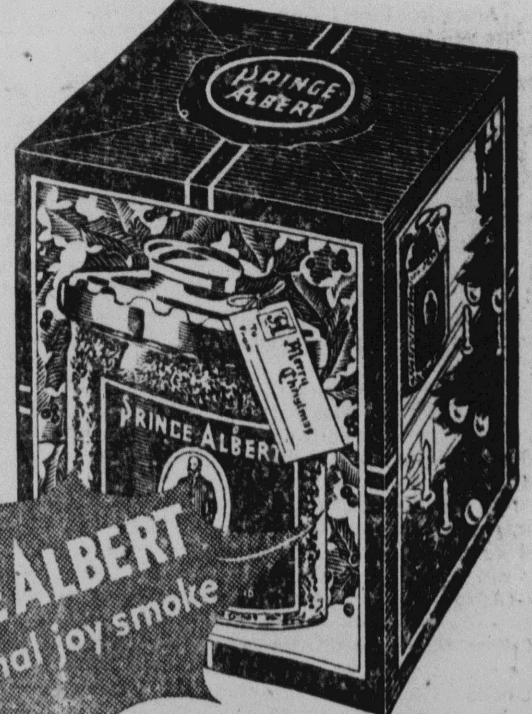
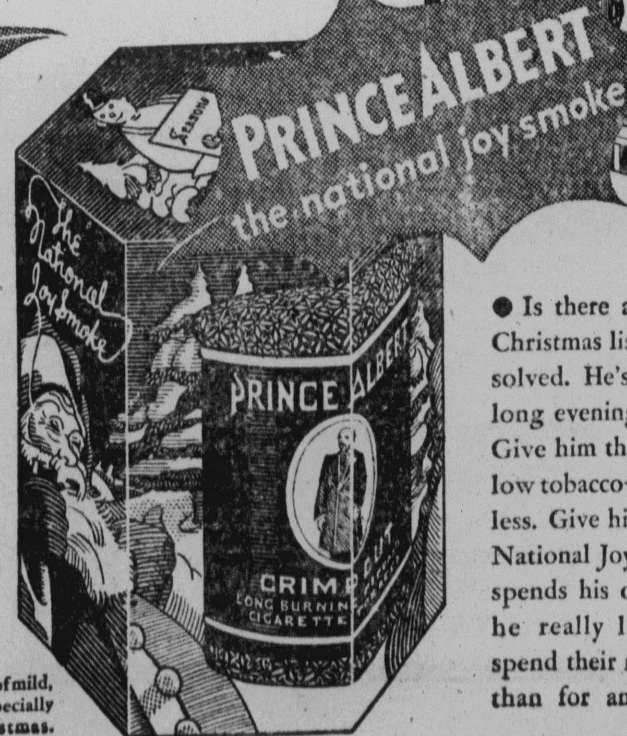

New York, Dec. 18.—(AP)—Cotton futures opened steady by trade and foreign buying. Prices held steady after the call with December settling at about yesterday's closing while later months showed net advances of two to three points at the end of the first half-hour with March at 12.55 and the new October at 12.33.
