SEE DOOM FOR SOLDIERS BONUS PAYMENT

Survey Indicates Senate To Uphold President's Veto

Immediate Payment Plan Will Fail to Get Necessary Two Thirds Vote

(Copyright By The Associated Press)

Washington, Jan. 10.—(AP)—A survey of the Senate indicated definitely today that if the present line-up of the soldiers' bonus issue continued unchanged through the ultimate roll call a presidential veto of full and immediate payment would be upheld.

This disclosure with recalled predictions by administration leaders that such a bill will be beaten in the Senate came as Frank Belgrano, National Commander of the American Legion, was hurrying to the capital from San Francisco to press the fight for the bonus.

Interviews with Senators showed 35 of them taking a stand indicating that barring future changes of mind—they would be virtually certain to vote to sustain the veto.

33 "nay" votes would block the bonus if it takes two thirds to override a veto. 21 others were non-committal including some who have voted against it in the past. 29 Senators recorded themselves as for the payment and others could not be reached because of their absence.

Congressional leaders have conceded that the House will probably override the presidential veto.

Late News Flashes

For Drivers License

Raleigh, Jan. 10.—(AP)—Anticipated legislation to regulate drivers license of motor vehicles and provide cheaper automobile license tags was introduced in the General Assembly today. Each division held a short meeting at midday and then recessed for the joint session at seven o'clock tonight to hear the bimill message of Governor Ehringhaus at 7:15.

The Senate got the first drivers license law legislation, Senator Cooper, of P.H., sending forward a measure that would require every driver to be licensed at a cost of \$1.25 each for private drivers and to provide for radio communication system between the sheriffs of the state as well as for revocation of the drivers license for cause.

In the House Representative Palmer, Cabarrus Democrat, introduced a measure to put all passenger cars (Continued on Page Four)

BILL TO RAISE TEACHERS' PAY IS INTRODUCED

Cooper Bill Would Increase Pay of All State Employees 30 Per Cent

Raleigh, N. C., Jan. 10.—School teachers can buy more silk stockings and State employees' wives can buy that new rug for the living-room if Representative Thomas E. Cooper, of New Hanover County, has his way about it. Today he introduced a bill calling for an increase of 30 per cent in State employees' salaries. Included in that group are, of course, school teachers, highway and prison workers and janitors.

Such an increase would put school teachers' salaries back at their former level and would restore three-fourths of the other State employees' 40 per cent pay reduction. It is estimated that the bill would cost more than \$5,000,000 before the end of the fiscal year on June 30. The measure is retroactive to January 1, 1935.

Mr. Cooper's bill carried no revenue clause designed to raise the necessary \$5,000,000. Because of that fact the bill will be referred to the committee on appropriations, which will probably be appointed next week.

It is necessary that all bills which call for expenditure, but which carry no revenue-raising features shall be referred to that committee.

The appropriations committee will consider the bill for a part in its regular program, revenue for which is drawn from the general fund, and as a result, the bill will not likely be reported on before the very last days of the present session.

Observers also pointed out that such a measure was without precedent, because it calls for an appropriation for the present fiscal year. They expressed the opinion that it is unconstitutional for the 1935 Legislature to make appropriations for any period save the next biennium.

SEE NO CHANGE IN ABSENTEE BALLOT LAW

Legislators Believe Absentee Voting Privilege Will Remain Law

Raleigh, N. C., Jan. 10.—The North Carolina General Assembly will not repeal the absentee ballot law nor will it make any radical changes in it, say observers here. Members of the Legislature interviewed by this bureau express little interest in changing the war-time act.

"If it comes to a vote," said Senator W. P. Horeon, of Plattsboro, "I shall vote to retain the act. It is perhaps true that in some instances there exist abuses of the law, but it must be remembered that with modern rapid means of transportation our population is no longer stable. Many people are unavoidably away from their home county on election days and I see no valid reason why they should be disfranchised or forced to travel great distances in order to vote."

Senator Horton's County, Chatham, uses the absentee ballot only in general elections.

Doubtless, say political observers, there will be some counties who will ask for exemptions and minor changes in the law. These, however, will be purely local measures affecting only the counties involved.

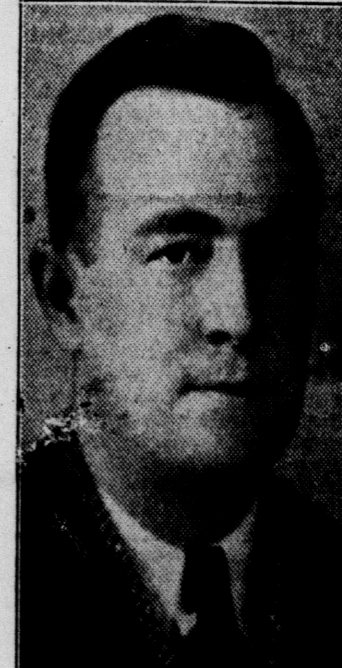
It was reported early this week that a petition calling upon the Legislature to repeal the absentee voting law was being circulated in Hoke County. However, Laurie McEachern, House member from Hoke, said he knew nothing whatever about the existence of such a petition.

Most of the sentiment for retention of the act comes from counties where the party in control of the local government has only a small majority. They fear that they would lose control should they lose their absentee voting strength. And some of the agitation for repeal of the measure comes also from those counties. This emanates from the minority party usually because they see a chance to win control if no absentee votes were permitted.

But, say those who oppose the law, the abuses of the act overbalance any good it may accomplish because, they say, those who control the government abuse the provisions of the act to retain their hold upon local offices.

Aged "Jafsie" Resumed Stand For Cross-Examination In Hauptmann Trial Today

(Copyright By The Associated Press) Flemington, N. J., Jan. 10.—(AP)—Hostile grilling and cross-examination of Dr. John F. "Jafsie" Condon which failed in an attempt to show the Yindbergh kidnaping was the work of a gang, ended unexpectedly today as court began its afternoon session.

The examination lasting from 2:33 o'clock yesterday afternoon until the noon recess today failed to shake in any essential detail the elderly Bronx educator's story that Hauptmann was the mysterious "John" who negotiated for and collected the futile Lindbergh \$50,000 ransom.

Counsel for Hauptmann attempted unsuccessfully at the morning session to show through Dr. Condon that the Lindbergh baby was stolen by a gang. Questions of this line hammered at the state's star accuser of Hauptmann by Edward J. Reilly produced only negative answers.

The aged educator didn't remember ever telling anybody that he believed a gang had kidnaped the baby and denied the attorney's assertion that he had told a newspaper man the baby's body had been brought back to the spot where it was found in the woods a few miles from the Hopewell Lindbergh home. He also ignored the attorney's use of the term "the chief" when asking if the box in which the ransom money was placed had been planned and ordered by "the chief." Jafsie said the box was ordered by Colonel Lindbergh and Attorney Henry Breckinridge and was built by a New York wood carver.

(Copyright By The Associated Press) Flemington, N. J., Jan. 10.—(AP)—Bruno Richard Hauptmann's defense at the trial for his life today sought to trip Dr. John F. "Jafsie" Condon on the details of the story in which he named Hauptmann as the mysterious "John" who negotiated for and collected the futile Lindbergh ransom of \$50,000.

Dr. Condon appeared on the stand today to be well prepared for the grilling of which he had had two hours foretaste at the hands of the defense chief, Edward J. Reilly, yesterday. The manners of the attorney and the witness started politely, each seeming to respect the other's prowess exhibited in the previous questioning.

"I will try not to bother you today," Jafsie told Reilly.

"That's all right, Doctor," replied Reilly. (Continued on Page Four)

BOMBINGS DO MUCH DAMAGE IN SOUTH BEND

Restaurant, Theatre and Other Buildings in Business District Shattered

South Bend, Ind., Jan. 10.—(AP)—Three bombs early today wrecked a restaurant and did widespread damage to a dozen stores and a theatre at the principal intersection in South Bend's business district, scattering the streets with debris and rousing citizens from their beds for blocks around.

The Palace Restaurant, a night club, at the corner of Colfax Avenue and Michigan Street, was wrecked, and the Palace Theatre badly damaged. Shops and drug store windows were shattered and debris was scattered over the streets. Early estimates of officials placed the damage at \$75,000. No one was injured.

Witnesses reported two small explosions at the rear of the restaurant and one terrific blast at the front. The interior of the cafe was leveled. Police said dry batteries were found at the scene, indicating that a time bomb had caused the blast.

Two huge safes in a neighboring jewelry store were overturned but not blown open.

Police officials said labor troubles were possibly the cause of the bombing.

Governor Not Expected To Demand Sales Tax

Raleigh, Jan. 10.—While Governor J. C. B. Ehringhaus is expected to recommend the re-enactment of the 3 per cent general sales tax in his message to the general assembly tonight, it is not expected that he will demand it. On the other hand, it is expected that he will express a willingness to do without the sales tax entirely if this general assembly can find a way to collect an equivalent amount of money from some other source or sources.

There is even a possibility that the Governor may not mention the sales tax at all and confine his remarks entirely to the need for bringing about a balanced budget, which means that the general assembly must not appropriate more money than it can provide revenue to produce and that it must also provide enough revenue to balance with appropriations.

But most observers here believe the Governor will mention the sales tax and recommend its enactment for another two years at least on the grounds that the emergency that existed in 1933 is still present, even though to a lesser degree and that the sales tax should hence be continued for two more years. It is not expected that he will recommend any increase in the tax rate.

SEEK NEW TAX LISTING DATE

Legislature May Change Listing Date From April 1 to January 1

Raleigh, N. C., Jan. 10.—A change in North Carolina's tax-listing date from April 1 to January 1 is considered highly probable, according to local observers. Because neighboring Virginia, use the first day of the year for that purpose, it is said that North Carolina counties lose a huge sum annually because of transferring of personal property from one State to another in order to avoid listing and subsequent payment of taxes.

"There is no doubt whatever," said W. E. Easterling, assistant director of the local government commission, "but that the difference in listing dates is seized upon as a means of tax evasion. The local government commission has always contended that the date should be changed to January 1, the date used by Virginia."

Most significant of all to observers here was the recommendation made by the Senate Association of County Commissioners to that effect at their convention last August. Watchers of the political scene in North Carolina have long been aware that the county commissioners, because of their close touch with local conditions, have been the power behind much legislation affecting local governments.

In its report issued this week the local government commission stressed the need for the change in date because of tax evasion, and added that such a move would also allow more time for the preparation of tax books and tend to cause the tax year in local units to more closely coincide with the State's fiscal year which ends June 30.

It has long been the contention of students of the tax problem that much shifting of bank deposits as well as merchandise "in transit," has taken place just prior to the tax-listing date. They point out that this shifting would be of no avail if North Carolina had the same listing date as neighboring States.

ASSEMBLY IS FAVORABLE TO THE GOVERNOR

Majority of The Members Are Strongly Behind The Administration

By J. C. BASKERVILLE. Raleigh, Jan. 10.—The 1935 general assembly is an administration assembly. This was evident when the vote for speaker was counted Tuesday night when Representative Robert Grady Johnson of Pender was elected on the first ballot with 67 votes, with Representative W. L. Lumpkin of Franklin, the candidate of the anti-sales tax forces, and anti-administrators, getting only 17 votes. Representative Laurie McEachern of Hoke, the other candidate for the speakership, regarded as being just as strong a supporter of Governor Ehringhaus and his administration as Johnson and as much in sympathy with it, received 19 votes. The combined Johnson and McEachern vote totals 76. As a result, most observers here conceded that the Governor is already assured of a strong working majority in the house.

It has been conceded for some time that a majority of the members of the senate are pro-administration and that the Governor would probably have a stronger majority there than in the senate. But if he can command from 65 to 75

Opposes Diversion Of Highway Funds

Raleigh, N. C., Jan. 10.—Vigorous opposition to further diversion of highway funds was voiced today by Senator Carl L. Bailey, of Washington County. He explained that he vetoed for the million dollar diversion two years ago simply because an emergency existed.

He also approved, he said, "in principle," the request of Capus Wayne, chairman of the Highway Commission, for \$3,000,000 to be used for immediate maintenance and repair of roads and bridges. "I haven't had time," said Bailey, "to examine in detail Mr. Wayne's plans outlined in his request, but I know by first-hand knowledge that our highways need immediate repairs. This is true in my own county, where secondary roads are deteriorating because of lack of funds."

Senator Bailey said he expected, if it is necessary, to actively fight any move to further divert funds from the highway department, and expressed the hope that it will not be necessary to maintain the present pace of diversion.

He is being prominently mentioned for the chairmanship of the Senate Roads Committee. Others say he is in line to head one of the two Senate Judiciary Committees. In either case it is expected that he will be a leader in formulating any plans for the highway department.

Mr. Wayne's report states that there are 5,000 bridges in the State unsafe for present traffic loads. He asks one billion dollars for their immediate repair. The remaining two million would be spent in rebuilding and repairing secondary roads, many of which he declared, were breaking down rapidly because of insufficient repairs. The \$3,000,000, if appropriated, would be spent before the expiration of the present fiscal year, or before July 1.

SATURDAY IS 'BUNDLE DAY'

Boy Scouts Will Collect Clothing to be Given to Needy Families

Next Saturday has been designated as Boy Scout Bundle Day here and at that time the Scouts of this city will make a house-to-house canvass for clothing to be turned over to the Welfare Department for use among the needy families of this community.

The drive is being put on under the direction of Leon Keaton, head of the Boy Scout movement in this city, and the public is urged to help make the drive a success by getting together all articles of wearing apparel that they wish to give to the Welfare Department. Mr. Keaton stated that at this time there was a great need for shoes as well as clothing, and he urged that those who have discarded shoes be sure to include them in the bundles made up for delivery to the Scouts when they call Saturday.

All gifts should be bundle up before the time of the Scouts' call and placed on the front porches of the homes. The Scouts will then collect the bundles without inconvenience to the housewives, and this plan also will greatly speed up completion of the work.

MEDICINE, LAW, TEACHING FRESHMAN CLASS CHOICE

Chicago, Ill.—(AP)—If the hundreds of studies comprising this year's freshman class at the University of Chicago realize their present ambitions fully half of them will be doctors, lawyers or educators.

Robert C. Woellner, head of the vocational guidance and placement service at the university, says the three vocations were the most popular in a recent survey of the class.

CONCENTRATE TROOPS ALONG AUSTRIA FRONT

Italians Said to be Taking Precautions Against Any Nazi Trouble

Vienna, Jan. 10.—(AP)—Italian troops were being concentrated along the Austrian frontier ready to act immediately should German Nazis pounce in this country following the Saar plebiscite it was reported reliably today. Both the Austrian and Italian governments are taking extreme precautions fearful what might follow the expected German victory in the plebiscite.

Hundreds of known Nazis and sympathizers have been arrested in Tyrol Province adjacent to the German frontier. Police and auxiliary forces of the province where Nazism is still strong ordered the provinces under a state of alarm from Saturday until next Tuesday week in anticipation of demonstrations.

Italy duplicated her act of last summer when she sent troops to the frontier following the Dolfuss assassination during a Nazi push.

Rome, Jan. 10.—(AP)—A government spokesman said today the latest information from Vienna and Berlin leads to the belief of only the very lightest possibility of a Nazi push immediately after the Saar plebiscite. Consequently no extra precautions have been taken by Italian troops along the Austrian border.

It is quite logical that troops be engaged in winter maneuvers near the frontier for this is the time every year that the Alpine troops are called out for exercise and probably the young Fascists' organization is also engaging in winter training, the spokesman said.

Pitt County Man Is Charged With Bigamy

New Bern N. C., Jan. 10.—Moses Teel, 23, of Pitt County, was arrested and jailed late Monday by county authorities, at the request of Pitt County officials, on a charge of bigamy. The charge was preferred by his first mother-in-law. The young man was located at his recent home, with a second wife, three miles from North Harlowe. He asserted that he had been informed that a divorce had been granted him from his first wife several years ago in Pitt County.

Urges Farmers To Organize Co-operatives

Raleigh, Jan. 10.—(AP)—Dr. Frank Porter Graham, president of the University of North Carolina today urged formation of strong self-organized farm co-operative groups as he addressed a joint meeting of the North Carolina Institute of Farm Organizations and the conference of Farm and Home Agents here.

President Graham described the farmers as a whole as the only major unorganized group in the United States so far as the formation of self-governed co-operatives is concerned.

Husband Stands As Wife Sits in House

Raleigh, N. C., Jan. 10.—The shoe is on the other foot in the Hutchins family now. Usually the wives of members of the General Assembly stand in the lobbies while their husbands sit in the House and Senate, since only members and newsmen are allowed on the floor.

But today Mrs. Charles Hutchins, of Burnsville, Representative from Yancey County, sat in her seat in the House, while her husband, for several other sessions the Representative from Yancey, stood in the lobby of the House. He was soon recognized by an old House member and extended the courtesies of the floor. But since there were no more seats, his wife continued to sit and he continued to stand.

Mill Employees Returned To Work

Rossville, Ga., Jan. 10.—(AP)—Approximately 450 employees reported for work at Richmond hosiery mills today following the ultimatum of mill officials that today was the last day striking employees would be taken back.

National guardsmen took two alleged night riders into custody during the night. Another man described by officers as an agitator, was also arrested and two pickets who resumed duty in front of the mill gates today were taken into custody by the guardsmen for questioning.

The hosiery plant officials said the mill would resume full operation tomorrow with new employees if the strikers did not apply for reinstatement today.

weights insist the most constructive steps the President could possibly take would be to make it clear that collective bargaining doesn't imply majority rule or even the recognition of unions belonging to the Federation of Labor. They also would like him to emphasize that his true interest is not for the purpose of allowing the Federation time and opportunity to organize for a showdown on the closed shop. They impress this idea on their Washington contacts as hard as they can, but they're not really sanguine about getting results.

A British visitor to New York asks what the shooting is all about. He points out that England had no new company unions for twenty-six years—and nobody seems to mind. He adds that the British trade unions were inclined to overestimate their power until the general strike of 1926. Since then they're been more willing to talk things over and their relations with employers are remarkably harmonious.

UTILITIES: No wonder the copper people are keen about government plans for expanding electrification of homes and the use of electric appliances. The demand for more and heavier wires will give them a chance to get back on an even keel by increasing consumption instead of limiting production.

An engineer whose opinion is entitled to respect says one of the utilities' chief worries is that wider use of gadgets means the reconstruction of transmission lines. He contends that they found it easier to make money on moderate consumption with higher rates—but here comes the government and compels them to change their slant.

He adds that many operating men privately favor this course and would have been glad to work it out before now—but the banking element in utility management generally said no.

One thing to Samuel Insull's lasting credit is that he did develop the method of moving electricity in huge volume to the homes of the people. That will be remembered when his financial errors are forgotten.

RAILS: There's lots of talk in the air about Joseph Eastman's plans for moving railroads. Rail experts believe these would help a great deal if they were wisely arranged—chiefly in eliminating duplicated main lines. These are more of a problem than unprofitable branch lines because they cost so much more to maintain. For instance, there is no economic reason for five competing main lines from Chicago to Omaha.

INITIATIVE: New York likes the story of the cable company official who found he was losing business to radio competition on the theory that it was faster. He built a receiving set to intercept commercial messages to South Africa. When one of these came through he would shoot a cable to the addressee conveying the message and telling him he would get it officially from the

Pan American is unique among all commercial air carriers. It operates at present exclusively between Florida and South and Central American countries and the West Indies. It has been heavily subsidized by the government with the particular blessing of the War and Navy Departments.

When all domestic air mail contracts were cancelled peremptorily Pan American remained aloof so far as official action was concerned. Being cornered in the transportation of foreign mail only, they waited to take their place with 42 steam, snip lines and one other air line at a later hearing. The other, 43 appeared.

INVESTIGATORS: Col. Charles A. Lindbergh, as an official of a domestic line, appeared before a Senate committee and forcefully condemned the cancellation of those domestic contracts. He based his objection primarily on the fact none of the lines had been given a hearing.

Deaf Mute Artist Enriched For Bust of Duce

Vienna.—(AP)—In appreciation of a bronze bust which he made of Premier Benito Mussolini of Italy, Gustavus Ambrosi, deaf-and-dumb Austrian sculptor, says he has been given a pension for life and a fee of \$10,000 by the Duce.

Mussolini wrote Ambrosi recently that of all the scores of busts and paintings made of him since he came into office a decade ago, the bronze bust of the Vienna genius is by far the finest. The Italian leader ordered eight duplicates of the bust for presentation purposes.

Pope Rewards Artist. Similarly, the Pope gave Ambrosi, once a poor stone-cutter, a sizeable honorarium and a letter of appreciation for a bronze likeness of the holy father. This portrays the pontiff with a wonderful smile and an expression of radiant serenity.

Ambrosi's latest work is an unusually faithful bronze portrait of Admiral Horthy, who has just celebrated his fiftieth year as regent of Hungary.

Earns Literary Honors. Beginning life as a stone-cutter at \$6.00 a week, Ambrosi's first sculptural work, made when he was 15, was a striking figure called "Man With Broken Neck." It was made after he saw a fellow workman fall from a high scaffold.

His own country has honored Ambrosi by giving him a house and two studios, rent free, and bestowing upon him the title of "national artist."

Ambrosi also is noted for literary talent. He has written a number of poems and some prose works.

'Don't Worry' Berlin's Word As Vote Nears

Berlin.—(AP)—Two ideas dominated the official German attitude on the Saar's January 13 plebiscite: "The Saar is German!" and "Nothing can be gained by a vote for the status quo."

One typifies hope and the other a fear that the Saar population, predominantly German, may decide it is better to remain under League of Nations' jurisdiction than to cast its lots with Hitlerism. The conviction is general that the Saar will not go to France.

But there also appears to be a growing belief that Saar voters, dubious of Nazi policies on economics, religion, and race, may decide to remain as they are with the expectation some day of returning to Nazi-less Germany.

New Problems Presented. Should the territory revert to Germany it will face, like other German states, the current problems of finances, unemployment, and foreign trade with which Hitler's "third reich" is struggling.

It also will get some of its own. These include: The relations of the devout Saar Catholics with a Nazi regime that promises freedom of worship for Protestants and Catholic, but indicates favoritism for a "paganist" movement.

Competition of Saar coal with that produced in German regions and adapting coal exports to German exchange restrictions.

Nazification of a population and its institutions which may not be amenable to this discipline.

Germany, it is indicated, will lower Saar unemployment in probably the same way as in the Fatherland—taking young men out of jobs and sending them to labor camps so their elders can have work.

Berlin Figures Answers. Official Germany is confident of solving the coal trade problems and related issues. It is emphasized that change from League jurisdiction to German control will handicap only a fraction of the Saar's set-up because Germany takes about 50 per cent more coal from the district than does France.

Furthermore, it is argued that 50,000 Saar men are engaged in industries dependent mostly on export trade with Germany, which has increased 90 per cent since 1932.

Additional promises are made that agriculture and the building industries in the Saar will be encouraged by the opening of subsistence projects by increasing soil fertility and by made work programs.

IRRIGATE BEAN ROWS

Wooden troughs were constructed and iron pipes laid from the creek bank to the bean patch. Water entering the pipes or troughs was carried by gravity to the patch, where it flowed down the rows of beans. Sections not reached by the water in this manner were irrigated by water from buckets.

RELIEF CATTLE BEING MOVED OUT OF MARTIN

Williamston, N. C. Jan. 10.—All relief cattle shipped into Martin County from the West last summer are scheduled to be moved out by Friday night of this week, according to orders, received here from relief headquarters in Raleigh. Most of the cattle are being driven to Jamesville, twelve miles from here, whence they are being shipped by rail to Goldsboro.

Originally there were 1,076 head of cattle shipped into this county. Of this number, 73 were lost in the pastures, an equal number dying from one cause or another. Bears are understood to have killed and eaten at least two of the smaller ones. Reaching here in early autumn half-starved by a food shortage in the West, the cattle were in bad condition when they arrived.

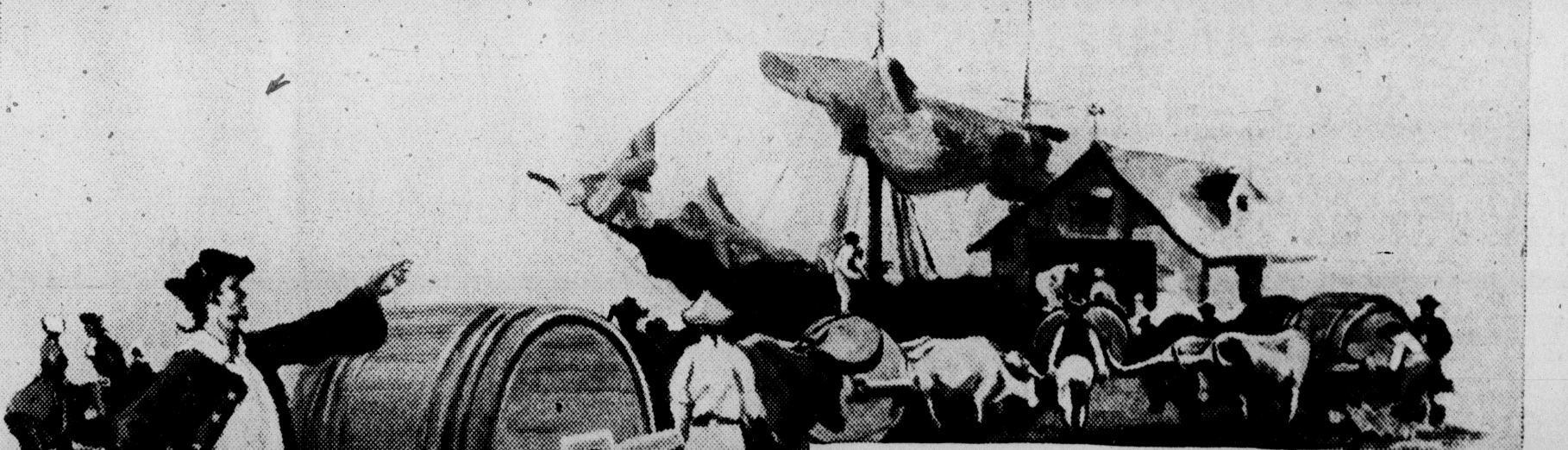
