

MEMBERS OF NOTED GANG ARRESTED

Two Gangsters Who Shot Their Way to Freedom at Richmond Again Taken

New York, Jan. 18.—(AP)—Robert Mais and Walter Legenza, who shot their way out of the Richmond, Va., prison and three other members of the "tri-State" gang were arrested, the New York Department of Justice announced today. The other three under arrest, Frank Fay, of the Department of Justice said, are Mary McKeever, Martin Farrell, and Edwin Gale.

Mais was surprised in an apartment at Eight Manhattan Avenue at 3:30 this morning, and was captured in bed. Federal operators and Philadelphia and New York police had surrounded the apartment house and entered the apartment door so unexpectedly that Mais had no time to reach for the .38 calibre automatic pistol that was at his side.

The first taken into custody were Farrell and Gale at a midtown hotel yesterday. Legenza was next located in a Manhattan hospital where he was receiving treatment for a broken leg. The arrest took place last night as did that of Mary McKeever who was visiting the patient.

Fay, who is head of the intelligence division of the Department of Justice here, said the arrest of these five "eradicates so far as we know" the tri-State gang.

Mais and Legenza shot their way out of the Richmond prison September 29, 1934, killing one person and seriously wounding two others. They were under sentence of death for slaying the custodian of a U. S. mail truck. Fay said, after their escape, they robbed government armories at Baltimore and Morristown, Pa., to obtain weapons. The two also have been sought for questioning in connection with the kidnaping of William Weiss, of Philadelphia, last November. A ransom of \$8,000 was paid for his return, but Weiss is still missing.

Washington, D. C., Jan. 18.—(AP)—The Department of Justice plans to turn Robert Mais and Walter Legenza, tri-State gang leaders captured today, over to the State of Virginia for execution. The two broke jail in that State while awaiting fulfillment of the death sentence for murder.

The tri-State gang has been accused of various murders and robberies throughout Pennsylvania, Virginia and Maryland and are believed to have carried on their operations in North Carolina.

WOULD AID TEACHERS

More Bills to Help School Teachers Are Introduced in The House

Raleigh, N. C., Jan. 18.—Several more bills relating to school teachers were introduced in the House Thursday. One, by Representative Carr, of Duplin, would increase teachers' salaries 25 per cent. Of the other two introduced by Representative O'Berry, of Wayne, one would carry out the recommendation made by Governor Ehringhaus in his message and put all school teachers under the Workmen's Compensation Act. The second of the bills introduced by Representative O'Berry would allow all school teachers seven days a year of sick leave with pay and place them on the same basis as all other State employees.

The Carr bill to increase teachers' salaries were referred to the House appropriations committee and is not expected to get back to the House, since whatever increase is made in teachers' salaries will be made in the regular appropriations bill, rather than in a separate bill. In fact, the various bills that have been offered so far to increase teachers' salaries are regarded as nothing more than gestures of good will and a bid for the support of the teacher vote from those who have introduced them so far.

At the present time the school teachers are not included under the Workmen's Compensation Law, nor are they permitted any sick leave. The bills introduced by Representative O'Berry will merely extend the same benefits now enjoyed by other State employees with regard to compensation and sick leave to school teachers as well.

Mrs. Anna Roosevelt Dall Married at New York This Morning

Washington, D. C., Jan. 18.—(AP)—President and Mrs. Roosevelt today announced the marriage of their daughter, Anna Roosevelt, Dall, to John Bottiger, former Chicago newspaper man. The ceremony took place this morning at 9 o'clock at the President's home in New York City on East 65th Street. It was performed by Judge J. Frederick Knochman, of New York, intimate friend of the family.

Mrs. Roosevelt and other members of the family attended. Others present included Mrs. James Roosevelt, Sr., mother of the President; Mrs. James Roosevelt, Jr., Elliot Roosevelt, brother of the bride, and his wife, Ruth; another brother, and Harry Hoeker, close friend of the family.

The couple immediately left for an unannounced destination. Boettiger has been residing in New York City, and they will make their home there. Recently he left the Chicago Tribune and is now employed by Motion Picture Producers of America.

For months before the marriage the capital had buzzed with rumors of the romance. They became friends during the "Roosevelt" campaign transcontinental tour when Mrs. Dall was with her father and Boettiger covered the trip for the Tribune. Later he was assigned to the Washington staff of the newspaper.

ONLY A FEW LOBBYISTS REGISTERED

Usual Number of Lobbyists Expected in Raleigh as Assembly Progresses

Raleigh, N. C., Jan. 18.—Only ten lobbyists have registered so far in the "lobbyists' book" in the office of Secretary of State Stacy W. Wade, as they are required to do by the 1933 anti-lobbying law, despite the fact that there are at least fifty well known lobbyists already here and actively at work and have been since the session opened last week. In fact, many of these lobbyists arrived here and set up their headquarters before any of the members of the General Assembly arrived.

None of the members of the large and admittedly influential text-book lobby has as yet registered. Regarded as among the ace lobbyists for the text-book publishers are B. O. Sisk of Greensboro, North Carolina representative for the Rand-McNally Publishing Company, publishers of text-books, maps, charts, globes and school supplies; Ted Ray, of Hendersonville, North Carolina representative of the World Book Company, and a member of the 1933 General Assembly; Fred Terrell, of Burlington, State representative of D. C. Heath & Co.; R. G. Fitzgerald of Raleigh, representative of the Silver-Buddette Publishing Company and several others who have not yet put in their appearance but who will be here as soon as any legislation comes up affecting text-books or the schools.

Nor have any of the lobbyists for the North Carolina Education Association registered yet, although they are already here and at work. Superintendent M. E. Yount, of Alamance county, chairman of the legislative committee of the North Carolina Education Association, which always directs its lobbying activities, is staying at the Sir Walter Hotel here and is expected to be here for the duration of the session, although he is apparently still drawing his salary as Superintendent of Schools in Alamance county. Several other county superintendents have also been seen here since the Legislature opened and more will be here later on.

Other lobbyists who have not yet registered, as the law requires, are Roy R. Lawrence, president of the North Carolina State Federation of Labor; former Lieutenant Governor J. Elmer Long, of Durham, counsel for the North Carolina Bitters Association; Mrs. J. Henry Higsmith, secretary of the North Carolina Federation of Women's Clubs, and several others.

Would Remove Exemptions And Cut Sales Tax

Raleigh, N. C., Jan. 18.—Removal of the present exemptions from the sales tax law and the reduction in the tax rate from 3 per cent to 2 per cent, is proposed in a bill introduced by Representative Carr of Duplin.

Since all bills of this nature are automatically referred to the finance committee, it is expected that the bill will not be reported out and that whatever change the committee makes in the sales tax will be made in the regular revenue bill. Consequently this bill is not regarded as of having much significance.

PERMANENT: On February 1 the President's Federal Aviation Commission, headed by Clark Howell, will make recommendations to Congress through the White House. Already, it has made a preliminary report but the public will not be taken into confidence until the first of the month. The Commission is running on a per diem basis and it is easier for the bookkeepers to wind up on that date.

One major proposal will suggest establishment of a permanent government commission to control all commercial air activities, including air mail. It is understood the report will recommend a commission of five members.

There are five members on the Federal Aviation Commission but their closest friends deny indelicately there was any idea of perpetuating the five investigators as government officers for the duration of the Roosevelt administration.

SENATE TAKES STEAM OUT OF BONUS DEMAND

Upper Branch Amends House Resolution for Full and Immediate Payment

Raleigh, N. C., Jan. 18.—(AP)—Amended so as to ask Congress to pay the soldiers' bonus "as soon as it is practicable for the United States Government to make the payment," the Senate today suspended its rules and passed the joint resolution which yesterday was approved in the House. The resolution must be returned to the House for concurrence in the Senate changes.

The six Senators on the Military Affairs Committee, headed by Corey, of Pitt, gave the House draft of the resolution unanimous favorable report this morning, and it was considered under suspension of rules. As amended it passed 42 to 2, the only Senators voting against it being Smith, of Stanly, and Shute, of Union.

Shute explained that he would vote against any measure memorializing Congress to take any action one way or the other, on proposals before it. Smith said he was against the proposal until everything which should be done for them had been done for the disabled veterans. "I may vote for general distribution for the benefit of the others when every disabled veteran has been taken care of," he said.

WOMAN KILLED NEAR HERE BY DRUNK DRIVER

Mrs. Horace Branch Run Down on Cox Mill Highway Early Last Night

Mrs. Horace Branch, 23, was killed about 6 o'clock last night when she was struck by an automobile as she walked beside the Cox Mill highway in company with her husband and another companion. Herman Evans, driver of the death car, was ordered by the coroner's jury to be held without bond on a charge of killing Mrs. Branch while he was driving an automobile in a drunken condition.

According to testimony of Mrs. Branch's husband and her girl companion, the three were walking on the dirt shoulder on the left side of the highway when the Evans' car approached from the rear apparently driving on his right side of the road, struck Mrs. Branch, carried her a short distance and then plunged into a ditch and overturned. Other witnesses who appeared upon the scene immediately after the accident testified to Evans' drunken condition.

Funeral services for Mrs. Branch were conducted at Red Oak Church at 3 o'clock this afternoon by Rev. W. H. Brunson, of Ayden. Burial followed in the Josh Smith Cemetery.

In addition to her husband, Mrs. Branch is survived by her parents, Mr. and Mrs. Richard A. Worthington, of Winterville; two brothers, Robert G. and Richard E. Worthington, and three sisters, Mrs. C. L. Evans, Misses Nora Lee and Doris Dean Worthington.

ENTER PLEA OF MURDER

Charleston Youth Enters Plea of Second Degree in Wilmington Killing

Wilmington, N. C., Jan. 18.—(AP)—Francis Young Lagare, Jr., of an old North Charleston, S. C., family, on trial here for his life for the murder of C. W. Watson, negro druggist in an attempted hold-up on October 24, 1934, entered a plea of guilty in the second degree this morning and the plea was accepted by the State.

Lagare yesterday heard a battery of State witnesses take the stand and quote him as having admitted to them he killed the negro.

These included persons reaching the scene soon after Mason's body was pumped full of bullets, and police officers who questioned the defendant after the shooting.

Lagare told officials he went to the drug store with the intent of robbing it, but that he lost his nerve when Mason leaped on him and started shooting. He ascribed hunger as the reason for his action.

Sentence of Lagare was delayed this morning while State and defense attorneys conferred on the case, taking into consideration the character of the youth and other details of the case.

Slot Machines Got Their Money

Raleigh, N. C., Jan. 18.—When Senator Rivers D. Johnson, of Duplin County, gives his children money for movie tickets he means for them to go to the movies. He does not intend for them to drop the said movie fares in slot machines.

A short time before the 1935 General Assembly convened he gave his children money for movie tickets. On their way to the picture show the children stopped in a store, reputedly owned by the mayor of Warsaw, John's home town, and tried their luck at playing a slot machine. It was awful. After dropping all their money in the machine they returned home for more money. They explained to the Senator that they still wanted to see the show.

So Senator Johnson has taken steps to insure that his children will see a movie when he starts them on their way. One of the first things he did, upon the convening of the present session, was to introduce a bill to abolish slot machines. It is a stringent measure and would also prohibit their sale or manufacture. The bill went to the committee on appropriations and grievances. Senator Rivers Johnson thinks slot machines fall in both categories.

HAUPTMANN IS BREAKING UNDER STRAIN

Was Visibly Annoyed As Today's Session Of Trial Got Under Way

(Copyright By The Associated Press) Flemington, N. J., Jan. 18.—(AP)—Anna Hauptmann's nerve broke today at the trial of her husband for his life.

"It's a lie," she shouted at a witness, Ella Auchenback, a Hauptmann neighbor in the Bronx, was the witness. She had testified Mrs. Hauptmann came to her two days after the kidnaping of the Lindbergh baby and said she and her husband had just returned from a trip.

"You lie, Mrs. Auchenback, you lie," Mrs. Hauptmann flared. Counsel for both sides leaped to their feet and so did the spectators. Mrs. Hauptmann's face usually pale and placid, was livid.

"Madam," Justice Trenchard said to Mrs. Hauptmann, "don't you see the impropriety of this outburst? I am asking you, don't you see?" Mrs. Hauptmann stood silent.

"Will you promise you won't do it again?"

"I'd like to try, but sometimes I can't help it," she apologized. Her voice broke. "I'll not offend these gentlemen of the jury."

Justice Trenchard suggested that Hauptmann, too, promise.

Reilly interposed to apologize for his conduct yesterday when he shouted, "Mister, mister, you stop lying; you are telling a story," at the witness on the stand.

As the questioning of Mrs. Auchenback was resumed, Mrs. Hauptmann settled back in her seat, her face still flushed.

Flemington, N. J., Jan. 18.—(AP)—As the trial of Bruno Richard Hauptmann went into its thirteenth day today the prosecution felt it had built up a sufficient case to send him to the electric chair for the kidnaping and murder of the baby, Charles A. Lindbergh, Jr.

"The State's case is definitely in now," Attorney-General David T. Wilentz said. "Any time I may turn to the judge and say, 'Your Honor, the State rests its case.'"

At the same time, he said he had sixty or more witnesses ready to testify should he find them necessary.

Hauptmann was visibly annoyed as he began the thirteenth day of his ordeal hearing. Henry Eichlin, Bronx engineer, completed his testimony of the terrain of the Bronx where the ransom for the Lindbergh baby was paid, and Sergeant John Wallace, of the State police, related again to the jury the story of his arrest on September 19. The German carpenter appeared to find it hard to maintain a grip on his emotions which yesterday flared up, causing him to accuse a witness of lying.

Eichlin's direct testimony was completed just before the close of court yesterday. Reilly cross-examined him with the aid of a Bronx map. The attorney elicited detailed information from the witness about the Condon residence, City Island, Van Courtland Park, Woodlawn Cemetery, the New York Central Railroad Station in the Bronx, and other places shown on the map which have figured in the testimony.

LEGISLATORS GETTING DOWN TO BUSINESS

Quick Action by Committees Expected to Hold Session to 60 Days Duration

Raleigh, N. C., Jan. 18.—This General Assembly is in a hurry and does not intend to stay here a day longer than sixty days unless it is absolutely necessary. The manner in which the Assembly has gotten down to work, especially on the finance and appropriations bills, and the comparatively small number of local and State-wide bills that have been introduced so far, is regarded as an indication of this. It is agreed that both the finance and appropriations committees are already at least a month ahead of previous sessions.

Both the finance and appropriations committees, of course, must grant hearings to any who want to appear before them. But Chairman Harris Newman of the Senate finance committee and Chairman Gregg Cherry of the House finance committee have already announced that they will close all public hearings by January 27. Since the appropriations committee must hear all the State departments, institutions and divisions with regard to requests for increased appropriations, slightly more time has been granted by the chairman of the appropriations committees for these hearings. But Chairman Lee Gravelly of the Senate appropriations committee and Chairman Victor Bryant of the House appropriations committee, have set February as the last date on which they will grant any hearings.

As a result the hope is now general that the appropriations bill will be reported to the House by about February 15, ready for consideration there. It is expected that the finance committees will complete their work on the finance act before this date. But because no revenue bill can be reported until an appropriations bill has been enacted, will make it necessary to hold the revenue bill in the committees until after an appropriations bill has been adopted. For the finance committees have no way of knowing how much revenue they must raise by means of the revenue bill until after the appropriations bill has been adopted.

The Assembly could throw a monkey wrench into the machinery and blast all houses for an early adjournment, of course, if it should adopt an appropriations bill providing for the expenditure of a much larger amount of money than the finance committees are able to provide revenue for. But in spite of the pressure from some angles for enlarged appropriations, especially for schools, indications are that a majority of members in both Houses are inclined to see pretty much eye to eye with the Governor and the Advisory Budget Commission. This is taken to mean that the appropriations committees are going to hold appropriations pretty close to the figures proposed in the budget appropriations bill and that the finance committees will not have much trouble in finding the revenue with which to meet these appropriations.

Some members of the finance committees are already hopeful that they will be able to find between \$5,000,000 and \$6,000,000 a year in new revenue without levying any new taxes, but merely plugging some loop-holes in present taxes. If this is the case, it is likely that the appropriations committees will increase their allotments accordingly. But it is too early yet to tell anything about this phase of the matter.

Representative Tam C. Bowie, of Ashe County, is expected to oppose any and all increases that are proposed in appropriations and is said to have already remarked that he would not vote for any appropriation that is above the 17533 level. But he seems to have if any followers in this session. Most of the members are convinced that the appropriations for schools and almost all other agencies need to be increased as much as they can be without throwing the budget out of balance.

Most of the members of both Houses seem to be in agreement with the Governor that the budget must be kept in balance and that the Legislature must not appropriate any more money that it can find revenue to supply.

The enactment of an appropriations and revenue act very similar to those recommended by the Governor and Budget Commission is already being freely predicted in many quarters.

Production Credit Corporation Holds Annual Stockholders Meeting

Members of the Greenville Production Credit Association which serves the counties of Pitt and Greene, held their first annual stockholders' meeting at Greenville on January 17, 1935, heard complete reports on the first year's operations of the association and elected directors for the coming year.

The meeting was very largely attended, not only by the members, but also by a great many farmers who are not members but who desire to acquaint themselves with the credit facilities which the association is offering. An invitation had been extended by the association to all farmers to attend.

After the annual report of the year's operations had been made to J. C. Galloway, secretary-treasurer of the association, the meeting was addressed by John B. Mann, of the Production Credit Corporation of Columbia. In his address Mr. Mann explained this corporate set-up of the Farm Credit Administration of Columbia, which serves the States of North Carolina, South Carolina, Georgia and Florida, and made a thorough explanation of the local association's financial statement.

Mr. Mann said that the procedure for obtaining loans for the coming year had been greatly simplified and that the loans could be handled a great deal more quickly than in the past. He urged farmers, however, to make their applications early and get their commitments approved as they do not begin paying interest until they get their money.

Other speakers at the meeting included N. F. Palmer, a director from Greene County; E. V. Vestal, county agent, and Lowell G. Taylor, Greene County representative of the association.

The meeting was presided over by Dr. Paul Fitzgerald, president of the association. The directors elected for the coming year are: Dr. Paul Fitzgerald, J. P. Davenport, John R. Carroll, N. F. Palmer, and G. L. Mewborn.

The Greenville Production Credit Association makes loans for agricultural purposes. Several applications for 1935 loans have already been received by the association.

Immediately after adjournment of the stockholders' meeting, the board of directors met and organized. The following officers were elected, namely: D. Paul Fitzgerald, president; G. L. Mewborn, vice-president, and J. C. Galloway, secretary-treasurer.

The first "Roosevelt Congress," it will be remembered, gave the President authority to negotiate trade agreements with foreign countries. Only one with Cuba—but the State Department has a total of thirteen in process of negotiation.

Mr. Fish apparently thinks one negotiated treaty is enough. At least he said so on the floor of the House.

Free Trade Charges

"I do not question the sincerity of the State Department," said Fish. "We have (as Secretary of State) a very distinguished and able man, a former member of this House. . . . But, he shouted, the New Yorker,

he is "an out-and-out free trader." And he added that Secretary Hull has under him a number of visionaries who believe in breaking down economic barriers throughout the world."

What irks Fish is that \$426,000 has been set aside for necessities of carrying on the work of negotiating reciprocal trade agreements for the coming year.

The appropriation item gave him the opportunity he has awaited. He made no excuses.

"I confess," he said, "I am a protective Republican and that I believe in tariff protection. . . ."

Others Hold Same View

Just what he can do about it remains to be seen. There are 322 Democrats in the

House and 102 Republicans. The relative line-up in the Senate is much the same.

There are, however, both Senators and Representatives on the Democratic side of the dividing political aisles who share in varying degrees the view of Fish.

His appeal that "I am against every proposed treaty with European nations as being against the interests of American labor and destruction of American industry" may find a response not wholly confined to the sparsely inhabited sector of the two Houses on Congress now occupied by Republicans.

sons in a year or so. The idea is to use the momentum of the bonus drive—which probably can't be stopped anyhow—to insure the Treasury against future inroads from ex-soldiers.

For instance every veteran who cashes his bonus now might be asked to pledge himself in writing never to ask for any further benefits either as an individual or as a member of an organization—with a proviso that he will resign from any organization which contravenes his pledge. Then payment of the bonus might be made contingent on acceptance of this condition by 80 or 90 percent of the beneficiaries involved.

It's not a certainty that this plan will be tried but it is being seriously considered. American Legion leaders know about it and are naturally not at all keen. Some astute observers believe it would mean curtains for veterans' organizations—which subsist traditionally on the government gravy they can get for their members.

But the informed are confident FDR could sell it to the country—and therefore to Congress—if he chooses. Conservatives agree the bonus would be cheap at twice the price if it will ransom the public purse from future drains—which are

otherwise rated as certain as sunrise. OFFSIDE: One of American Telephone's chief worries—as its inquisition approaches—is the Congressional and public reaction to revaluation of its interest in the movie industry. It controls about 90 per cent of sound reproduction in the pictures through subsidiaries.

Several embarrassing questions are likely to be asked. Having been allowed to monopolize its own field, how many more monopolies does it want? How come it uses money collected from ratepayers for costly experiments outside its own line? Television research will be criticized on the same grounds.

POLITICS AT RANDOM

By BRYON PRICE
(Chief of Bureau, The Associated Press, Washington)

The quiet pace set by the new Congress during its first weeks has caused much surprise in Washington and some grumbling among the members.

Perhaps this is partly due to a state of mind. For upward of two years the capital has been living in an endless whirl of activity. The last previous Congress probably established a record by the breathless speed of its legislative actions.

Many of the advance prophecies pictured the present Congress as going its predecessor one better. It was to be a pell-mell performance, from the start. The psychological build-up was so tremendous that what actually has happened thus far appears tame and uninteresting by comparison.

What with plain and fancy oratory about everything except the current issues, three-day recesses, and other delays and postponements, it took both the Senate and House a couple of weeks to get down to actual debate on concrete legislative proposals. And even then, the debate avoided most of the things Washington really is thinking about.

The House took up one of the drier appropriation bills. The Senate passed by the whole list of domestic problems and resurrected the old dispute about the World Court.

Too Much News
Various explanations have been offered. One story, about which members of Congress are being twitted over the dinner table, is that Congress found it couldn't compete on page one with the Hauptmann trial in New Jersey, and decided to hold its fire for a more favorable moment.

This jocular imputation is repudiated unanimously by the Senators and Representatives, albeit they are no strangers as a class to the art and artifices of publicity.

A more seriously-urged suggestion is that, with so great an infiltration of new members, the Democratic leaders wanted to size up the situation with extreme care before launching on the real business of the session.

The threat of stubborn opposition to the "hump sum" method of appropriating for relief surprised some of Mr. Roosevelt's friends, and led to several conferences and nose-countings.

It may have been coincidence, but the unusual period of quiet and caution also coincided with the Supreme Court's hints that some of the legislation passed by the last Congress was too sketchily drawn.

Amendment Blamed
A combination of various elements may easily have caused the delay, but it unquestionably was accumulated by the fact that under the new Norris amendment this Congress was a month behind the previous schedule before it even started.

Under the old arrangement the sessions began in early December. Committees at work during the recess had enough legislation ready to insure a prompt starting of the machinery. Major action began before the Christmas holidays, and by mid-January, the legislative program usually was well under way.

With the new meeting-date after New Year's Day, and a none-too-

speedy getaway following mid-January this year sees almost nothing done.

So there are grumblings and expressions of impatience, and a lot of members getting out of sorts even before the fun begins. That may easily make things livelier once the show actually starts.

New Bill Would Cut Cost Auto License Third

The Reflector, Sir Walter Hotel, Raleigh, N. C., Jan. 18.—A bill to reduce the cost of automobile licenses about one-third by changing the licensing basis from 55 cents per 100 pounds to 35 cents per 100 pounds, has been introduced in the House of Representatives by Sen. Sells, of Brunswick County. It was referred to the committee on roads. Although some four or five bills have already been introduced to reduce the automobile license fee on passenger cars to \$5, it is not expected that any of those bills will pass, since they would cause a loss in highway revenue of about \$3,500,000 a year and most opinion here is that the highway fund cannot stand that large a loss in revenue.
