SURPRISE WITNESS SUPPORTS HAUPTMANN ALIBI

MANY DANCE AT ROOSEVELT CELEBRATION

Hundreds From All Parts of County Represented At Ball Here Last Night

Pitt county people joined with those in 7,000 other communities of the nation last night in celebrating the fifty-third birthday of President Franklin D. Roosevelt.

The celebration here was in the nature of a ball given in the campus building of East Carolina Teachers college, and is proved to be one of the most enjoyable and brilliant ever given in the community.

There were more dancers on the floor last night than at the ball last year but the number of spectators was cut sharply. However, it was expected the proceeds would be larger than the previous year when between \$700 and \$800 was raised for the Warm Springs Foundation.

Mayor Flanagan general ball chairman and member of the steering committee, stated today they considered the ball a big success, socially as well as financially. They said they wished to express their thanks and appreciation to all who had any part in the success of the ball.

F. C. Harding welcomed the hundreds of people to the spacious college auditorium prior to the beginning of the President's radio address, and assured them the local committees had done everything in their power to make the occasion significant of the great cause it represented—the raising of funds for sufferers from infantile paralysis.

W. W. Lee, acting in the capacity of master of ceremonies, and finding his specialty dance program shot to pieces because of the illness of J. H. Rose, who was in charge of this phase of the celebration, called on a number of youngsters who were to have taken part and some who were not expected to be called upon. He eventually succeeded in presenting a program of acrobats and specialty dancing probably surpassing anything seen here in years.

Leading the fancy dancing parade were Joe Perry and Miss Margaret Bostie, who gave a faithful interpretation of the latest dance numbers including the Carrioca.

An acrobatic number was presented by Miss Carolyn Hamric. Later Miss Hamric and Miss Owen Bell appeared in a tap dance number. The special program was concluded with fancy dancing by Ray Mumford and Miss Elizabeth Gates.

Music for the ball was furnished by Hod Williams and orchestra of Charlotte, radio broadcasting artists who have been on the air at Charlotte daily for quite a while.

The building had been appropriately decorated for the dance. The dance committee was assisted by Billy Nesbit, expert decorator of Blount-Harvey Company, who was loaned by the firm to help make the occasion as enjoyable as possible.

Call Out Soldiers To Break Big Theft Ring

Manchester, Ky. Jan. 31.—(AP)—National Guardsmen and State police rolled into this foothill town in a surprise move to break what Adjutant-General Henry Dehart called an automobile theft ring headed by prominent officials.

The troops, commanded by Brigadier General Elmer Carer, halted on the outskirts of Manchester a few minutes while the long string of thirteen National Guard trucks and a half-dozen State police cars moved close up as hundreds of people poured out of nearby houses.

Some on foot and others on horseback they proceeded the soldiers and police into town. The guardsmen and police numbered about 160 and had been issued rounds of ammunition in an adjoining county.

When they reached here machine guns, hand grenades and handcuffing gas guns, as well as rifles, were in evidence. The soldiers and some 40 police sat shivering in the cold while awaiting orders and other details.

DRIVER'S BILL TO BE Aired AT NIGHT SESSION

Reflector Bureau Sir Walter Hotel Raleigh, Jan. 31.—Debate on the state-wide drivers license bill will open in the senate Monday night and the galleries will be assured of the first interesting night session since the general assembly opened.

This is the first state-wide bill of major importance to be reported out of committee and placed on the calendar in either house.

The drivers license bill was placed on the senate calendar Wednesday with a unanimous favorable report by the joint roads committee and Senator U. L. Spence, chairman of the senate roads committee, suggested that the bill be taken up immediately so that it might pass its second reading today and its third reading Friday.

Senator Spence replied that neither he nor the committee members had any desire to rush the bill through but that they did believe it should be acted on as soon as possible since the people of the state were demanding that something be done at once to reduce the steadily growing number of automobile accidents and deaths.

HOWARD AGAIN HEADS LOCAL TOBACCO BODY

C. W. Howard, head of the Greenville Tobacco Company, was re-elected president of the Greenville Tobacco Board of Trade at the annual meeting of the organization held in Mr. Howard's office at the Greenville Tobacco Company this morning at 10 o'clock.

Other officers chosen were: R. C. Stokes, Jr., vice-president; M. V. Jones, secretary; and K. W. Cobb, treasurer and supervisor.

In addition to the election of officers, the tobaccoists heard interesting reports on the progress of the market submitted by K. W. Cobb, supervisor; C. W. Shuff of the student loan fund committee, and R. M. Garrett, of the advertising committee.

Making his annual report to the board, Mr. Cobb stated that official figures for the 1934 season were 51,183,384 pounds handled by the market at an average of \$31.41 per hundred pounds and for which the market paid out a total of \$16,077,882.78.

He stated that the past year was one of the best the market has ever had. He said the market had many friends who had not sold here before, and expressed appreciation of the loyalty of old customers who continued to dispose of their offerings here at high prices.

Mr. Cobb declared the market had established an all-time record for the standpoint of money paid out and that although the season for all markets was not yet over, he was confident final reports would show Greenville as the "world's largest tobacco money market."

C. W. Shuff reported on the student loan fund donated by members of the board, and explained his committee was interested in raising a like amount of money this year to add to the fund.

R. M. Garrett, chairman of the advertising committee, declared the advertising campaign the past year had been a great success, and had resulted in the bringing of hundreds of people here.

LEGISLATIVE RAMBLINGS

If you return home some day to find your front porch and your front yard littered with circulars and bills you can attribute the said littering to a bill introduced in the Legislature by Senator Burrus of Guilford.

The Burrus measure would prohibit cities, towns and local governments putting the ban on hand-bill distribution, thus leaving it up to the distributors themselves as to just how far they want to go.

In the space reserved for the legislator's remarks on the bill is the legend "Burrus, by request." It isn't known whether or no, the Assembly will be circularized with pleas for passage of the bill.

Every resolution passed by this Legislature costs the State of North Carolina seven dollars, said Senator Rivers D. Johnson, of Duplin, "and you can send a letter for three cents." BILLS SEEK TO TAKE OFF BRIDGE TOLLS

Measures Receive Favorable Report By Joint General Assembly Committee

Raleigh, N. C. Jan. 31.—(AP)—Bills to remove tolls from the bridges over the Chowan River at Edenboro Point and on the Cape Fear River near Wilmington, were reported favorably today by the joint General Assembly committee on roads.

The group announcing it intended to carry the measure to the floor of the division where quickest action can be started. No action was taken on other proposals to lift tolls.

The Senate Judiciary Committee No. 1 voted this morning to invite all sheriffs of the State to a conference on the proposal to extend their jurisdiction beyond their home counties and to create a State Radio Commission set for public hearing next Tuesday.

The group also requested all county attorneys interested in the drafting of a new tax law for the State to meet with the committee next Thursday morning as an entirely new bill is to be drawn due to Superior Court ruling invalidating part of the present law.

FRANK SPAIN SUCCEUMS TO WRECK INJURY

Funeral Services For Grimesland Young Man to be Held Tomorrow at 2 P. M.

Frank Ringold Spain, of Grimesland, died in the local hospital this morning at 5:30 o'clock as result of injuries which he sustained in an automobile collision near Greenwood Cemetery today a week ago. He suffered a fractured skull and internal injuries and never regained consciousness.

Funeral services will be conducted from the home of his parents, Mr. and Mrs. J. S. Spain, at Grimesland, tomorrow afternoon at 2 o'clock. The final rites will be in charge of Rev. Warren Davis, pastor of the Washington Christian Church, assisted by Rev. W. A. Ryan, pastor of the Eighth Street Christian Church, of Greenville. Burial will follow in the Mount Pleasant Cemetery.

He is survived by his parents; two brothers, Jack and Jodie Spain, of Greenville; three sisters, Mrs. Herbert Jernigan, Raleigh; Mrs. Jesse Shearin of Halifax and Miss Margaret Spain, of Grimesland.

Young Spain was a member of an old and socially prominent Pitt County family. He was a native of the county. He completed his high school at Grimesland. He was a first year student at East Carolina Teachers College, and committed between the college and his home each day.

He had caught a ride with Roy Elks when their car was struck by another machine driven by Charlie Haddock. Haddock was at liberty under \$5,000 bond today after having been released from the hospital the past Tuesday. He was slightly injured.

A negro man by the name of Smith also received a fractured skull and broken leg, and while his injuries were serious, physicians held out for his recovery. Haddock was said to have been drinking but the negro who was riding with him was reported to have been sober. Investigating officers said they found a bottle of whiskey in the Haddock car.

Both cars caught fire, one of them being destroyed while the other was extinguished after the tires had been burned off.

The accident occurred just one week after a woman was run down and killed by a drunken driver on the Cox Mill road, near Cox Mill.

STOKES MAN PASSES AWAY

Henry David Gurganus Succumbs to Two Weeks' Illness In Hospital Here

Henry David Gurganus, 33, prominent grower of Stokes, died at the local hospital last night at 8 o'clock following four weeks' illness.

Funeral services will be conducted from his late home tomorrow afternoon at 2 o'clock, and burial will be made in the Stokes cemetery.

Mr. Gurganus, native of Martin county, moved to Stokes about 25 years ago and had made his home there ever since. He was engaged in farming and took an active part in development of the industry in that particular locality.

A member of the Stokes Christian Church, he always used his influence for advancement of the work of the congregation as well as the entire denomination.

He is survived by his wife and three children, Miss Velma Gurganus and Hassell and Frances Gurganus, all of Stokes.

R. W. CHILD DEAD IN N. Y.

Former Ambassador To Italy Succumbs To Attack of Pneumonia in Hospital

New York, Jan. 31.—(AP)—Richard Washburn Child, attorney, writer and former ambassador, died at a hospital here today from pneumonia. Child, who was 54, caught cold several days ago and the cold eventually turned into pneumonia. He was named ambassador to Italy by President Harding.

The funeral, it was learned, will be held Saturday. Interment will be made in Newport, R. I.

Meanwhile in New York, a woman who offered to testify for the state against Hauptmann in connection with his spending one of the Lindbergh ransom bills, Fannette Rivkin, was found bound and gagged on the floor of a beauty parlor in which she worked.

A building superintendent rescued her and she was taken to a hospital, but was unable immediately to say what had happened or who her assailants were.

BACKS STORY RELATED BY CARLSTROM

Louis Kiss Tells Murder Jury he Saw Accused Man in Bakery Night Lindbergh Baby Was Stolen 60 Miles Away; Carlstrom, First Surprise Witness Resorts to Constitutional Right In Answering Incriminating Question

Flemington, N. J., Jan. 31.—(AP)—Two men with a ladder in an automobile appeared at Princeton, N. J., in the afternoon of the day baby Charles Lindbergh, Jr. was kidnapped and slain, and neither was Bruno Hauptmann, a defense witness testified for Hauptmann today.

Lou Harding, a laborer of Trenton, said to the men asked him the way to the Lindbergh estate.

Harding said: "It was two people came along in a car. They were men and asked me to direct them to the Lindbergh estate and I told them."

"Was either one of these two men this defendant?" Edward Reilly, defense chief asked.

"No, Sir, it was not," he said. Just before this on the witness stand August van Schenke testified he saw Hauptmann in the Bronx the night of March 1. He was the fourth person to support Hauptmann's testimony. He admitted on cross examination that he was a speakeasy and used the name of Wuenstor. The defense called Louis Kiss, who also admitted speakeasying and who said he saw Hauptmann in the bakery restaurant of Christian Fredricksen the night of March 1, 1932.

Van Henke said he saw Hauptmann at about 8 p. m. near a filling station in the Bronx on the night of the crime and had conversation with him about a police dog which Hauptmann had with him.

He identified the defendant in the courtroom and said he had never seen him before the meeting in the Bronx. On that occasion he said Hauptmann gave him his name.

Kiss said he saw Hauptmann in the bakery restaurant shortly after 8:15. His words supported the testimony given before him by Elvert Carlstrom, 27-year-old carpet helper, and Mrs. Hauptmann, wife of the defendant.

When Attorney General David Wilentz, who sought to smash his credibility, asked him about this, Edward Reilly, defense chief, broke the silence that followed with the declaration that the answer might be incriminating. "I am willing to be the witness," Wilentz said, "if there is no objection from the court, if it is his feeling to contend (Continued on Page Four)

bill for the relief of agriculture.

Senator Johnson avers he holds no malice for the farmer. "I simply do not believe in passing a resolution every time we turn around. Particularly do I refer to memorials to Congress. They never read them."

Despite Johnson's opposition, the rules were suspended upon the motion of Senator Gravelly and the resolution passed.

Another bill to require the State to assume the greater part of the bonded road and bridge debt of the counties, also to increase the State tax on gasoline to seven cents a gallon with the provision that the revenue from the added cent be turned back to the counties to apply on their road debts, is now before the Senate Committee on Roads. The bill was introduced Wednesday by Senator V. A. Browning of Bryon City, Cherokee County.

The bill is slightly different from the others that have been introduced along the same line in that it would require the State to take over the unpaid balance of county road bonds only on those roads which have been included in the primary State highway system which now consists of almost 10,000 miles of highways. There is no way of knowing how this would compare with the total county road bonded debt of about \$95,000,000. But Highway Commission officials pointed out that virtually all of the roads built by the counties were included in the primary State Highway system and that scarcely any counties sold road bonds to improve their secondary roads.

As a result, it is estimated that the enactment of the bill would transfer at least \$90,000,000 of county road and bridge bonded debt to the State, to be paid from the highway fund. Since these bonds bear a much higher rate of interest than the State Highway bonds, it is estimated that the debt service on them would be at least \$10,000,000 a year and that the total outlay for highway debt service would thus be increased from the present figure of \$8,500,000 a year to at least \$18,000,000 a year. This would leave only about \$4,000,000 a year for maintenance, reconstruction and improvement of the more than 60,000 miles of roads in the entire State system. It is now agreed that at least \$10,000,000 a year is needed for maintenance alone.

The bill is not expected to get a favorable report from the committee.

**NEW MOVE TO AID FARMERS**

**War Against Erosion To Be Launched at Banquet in Raleigh Tonight**

Raleigh, N. C., Jan. 31—A new war will begin here tonight—a war against erosion which now costs North Carolina farmers millions of dollars a year and a war for utilization of the now worthless pine crop.

More than 175 farmers, bankers, publishers and business leaders will meet here at a banquet under the joint auspices of the Agricultural Committee of the N. C. Bankers' Association and the Agricultural Research Bureau of the Barrett Company and will hear addresses by two men—one of whom will warn against the dangers of erosion, the other will prescribe a remedy for the loss. Dr. Charles H. Herty, former University of North Carolina professor and eminent scientist who has recently been experimenting with the manufacture of new-spring from the southern pine, probably will tell of his work and predict a gigantic new industry for the South, which would take into its scope not only industrialists, but farmers.

For, if Dr. Herty's plan is developed, farmers will be able to sell their slash pine for far better prices than ever before, and the lowly pine will be classified as one of the State's major "crops."

Dr. Herty will speak from Atlanta on a "Vital Message to the South."

It has long been known the superintendents and principals want their pay to be again based as formerly, on pupil enrollment rather than the number of teachers employed in a county or in a school. Not so easy is it to accurately check pupil enrollment. Significance also, as several legislators and observers pointed out, is that supervision of salary schedules would be placed in the hands of a single individual, the State Superintendent, instead of control of a group, the State School Commission.

Under the terms of the Lee bill no teacher could draw the maximum teacher salary who has taught for less than fifteen years. The bill would set up, under the supervision of the School Commission and the State Superintendent, a program of teacher-training, the rate of pay to be determined by the individual teacher's progress through the training and length of service. The effect of such a set-up would be, of course, to extend to teachers now employed pay-advantages by seniority. In short, it would, in some phases, have the aspect of trade unionism in basing pay upon tenure of service.

The bill is similar to some introduced in previous legislative sessions in that it attempts to extend the period of pay increment to 15 years. The Lee bill is exceedingly ambitious in that respect, because previous measures have attempted to set up such a period for only four years. Opposition to the bill will doubtless develop because of that.

It is, however, quite apparent that the chief opposition will come from these sections of the measure designed to establish pupil enrollment as a basis for principal and superintendent pay schedules. There are those also who will oppose the bill because of the one-man aspect of pay-scale regulation.

# THINK VANN BILL TO GET BAD REPORT

## Measure to Consolidate County Offices Expected to be Killed in Legislature

Raleigh, Ja. 31.—Unfavorable report on the Vann bill to permit boards of county commissioners to consolidate county offices that are not elective, fix salaries, appoint tax collectors and otherwise exercise more stringent control of county finance than they do at present, is expected as a result of the hearing held here Wednesday afternoon at which several hundred county officials registered their vigorous protest against the bill.

The bill is one of several sponsored by the North Carolina Association of County Commissioners which they maintain will reduce the cost of operating county governments, thus reduce county taxes and remove the agitation for county consolidation. The bill also had the approval of Governor J. C. B. Ehringhaus and the Local Government Commission. It is generally conceded that the bill, if enacted, would make it possible for the boards of county commissioners to greatly reduce county budgets and eliminate a large number of unnecessary county offices and office holders.

It was this phase of the bill which is expected to defeat it before the joint committees on counties, cities and towns and which brought several hundred county officials here to the hearing that did not want their salaries reduced or their jobs abolished or consolidated. It is generally agreed. None of the speakers touched upon this phase of the bill, however. Most of them maintained it was dangerous because it would concentrate too much power in the hands of the county commissioners. They also maintained it would result in poorer service from the county officials. But the real reason they opposed it was because it would reduce the salaries of the present officeholders and might reduce the number of jobs for those now holding them. It struck too closely at the bread and butter of the leading politicians in every county—the county officials—most of whom are conceded to have much more political influence than most county commissioners.

One of the principal opponents of the bill was A. W. Graham, Jr., Clerk of the Superior court in Granville county, who maintained that the bill gave too much concentration of power to the hands of the county commissioners. W. E. Church, clerk of the Superior court of Forsyth county, Winston-Salem, also spoke against the bill and maintained it was undemocratic since it gave the county commissioners too much authority over the other county officials. He insisted the people of the various counties were not in favor

of the bill and did not want it and that before being put into effect it should be submitted to a vote of the people in each county.

John R. Morris, secretary of the North Carolina Sheriffs Association, and from Wilmington, New Hanover county, opposed the bill on about the same grounds and maintained that if it were passed, concentrating so much power in the hands of the county commissioners, it would tend to breed a desire for even more power and that "if they are given an inch they will take a mile."

Walter Bass, clerk of the Superior court in Durham county, also opposed the bill and said that he was not willing to entrust any board of county commissioners to fix his salary, no matter how good and fair they might be.

The only speaker advocating the bill was John L. Skinner of Warren county, secretary of the North Carolina Association of County Commissioners. He maintained that the passage of the bill would make it possible to materially reduce county expenses and hence, county tax rates and to a very large extent restore local government back to the counties. He also maintained it would eliminate much of the present dissatisfaction on the part of many people with regard to their county governments and eliminate the agitation for county consolidation.

Indications were that most of the members of the committees were in sympathy with the county officials whose salaries might be reduced or jobs abolished if the bill should be passed. At the present time the salaries of most county officials are fixed by the general assembly by means of public local bills and they see to it that the members elected to the general assembly are friendly towards them as possible. It is generally agreed that many members of the general assembly owe their election to the support and influence of county officials.

## Spring Graduates Add To Worries Of Nazi Officials

Berlin (AP)—What to do with 600,000 young Germans who will complete secondary school courses next spring presents a problem that Nazi labor and youth leaders already are worrying about.

So many thousands of recent graduates have been sent to farms for the "land year" or to labor camps that these possibilities for paring unemployment lists virtually are exhausted.

In an appeal signed by Leaders Hecker, Ley, von Schrach, and Syrup, chiefs respectively of the Reich's economics chamber, labor front, youth movement and labor insurance office, a campaign is forecast whereby employers will be forced to take apprentices into their service.

The manifesto gives the assurance that the boys and girls will be faithful learners and workers, and says: "Make room in your business on April 1, 1935, for as many apprentices as you can. The preparation of the young generation is not a burden but an opportunity for serving the whole German people and economic structure."

Besides the secondary school graduates, 100,000 will emerge from scientific and higher institutions. Some of them will be sent to highway and canal gangs, but the prospect is that not a few of them trained for legal, scientific or other professional careers, will have as their jobs sweeping out offices.
