Tri-State Gang Leaders Die In Electric Chair

LEGENZA AND MAIS EXECUTED AT RICHMOND

Men Charged With Series of Robberies, Murders and Kidnapings Pay Supreme Penalty; Mais Admits He Helped Plan Holdup at Richmond; Legenza Goes To Death Stoiically

State Penitentiary, Richmond, Va. Feb. 2.—(AP)—Gangland careers of murderer, kidnaping and robbery ended today in the electric chair for Robert Mais and Walter Legenza.

Mais still suffering from six machine gun bullet wounds, went first at 7:50 a. m. and the poker-faced Legenza followed fifteen minutes later at 8:06 a. m.

They were electrocuted for the murder of Ewell M. Hubbard during a mail truck robbery here last March 9. The trial which they had led had recorded two known murders and several suspected kidnapings and numerous robberies.

Shivering in the chill air of the winter daybreak, Mais told Rice M. Youell, prison superintendent, that he was not present at the slaying of Hubbard, but that he was present when the robbery was planned.

Mais walked to the chair accompanied by guard. Legenza, taken in a wheel chair, was unable to walk because of two broken legs suffered in leaping over an embankment to escape Philadelphia police.

A plaster cast was removed from Legenza's right leg to permit fitting of the electrode. A cast on his left leg was not removed. Last hour spiritual ministrations and prayers were read by prison Chaplain R. V. Lancaster and Colonel Fred Seiler, of the Salvation Army. Both men refused breakfast before electrocution.

The electrocutions were carried out before a jury of witnesses as provided by law. Newspaper men received announcement of their deaths from Prison Warden William G. McGraw, secretary of the board. Asked how the men stood the ordeal, he said: "I did not see it."

Mayor Youell said it was exactly two minutes in each instance from the time the switch was thrown until the physicians pronounced the men dead.

Both gangsters were pale. Legenza was naturally so because of blood transfusions in New York. Heeds were placed over their heads just before the deadly current was turned on.

A witness said neither showed a lack of nerve at the last. He said Mais appeared to say something but it was inaudible.

A list of crimes attributed to the gangsters included a truck robbery at Norfolk, N. C., when \$35,000 worth of cigarettes were taken.

Mrs. Hardee Dies In Chicod Section

Mrs. Ritje Hardee, aged 82, died at the home of her son, in the Chicod Township, this morning at 6:30 o'clock. She had spent her entire life in the community in which she died.

Mrs. Hardee was the daughter of the late Spencer and Lovie Smith Haddock of the Stokes community of Chicod Township. She was a life-long member of Pleasant Hill Free Will Baptist Church and manifested much interest in the work of the denomination as long as her health permitted.

Funeral services will be conducted from the home of her son, J. H. Hardee, tomorrow afternoon at 3:30 o'clock by Rev. W. H. Laughlin, pastor. Burial will be in the Hardee graveyard near the home.

Mrs. Hardee leaves to survive one son, J. H. Hardee, with whom she made her home with; one brother, Joe Haddock of the Chicod community; also seven grandchildren.

Active pallbearers will be: E. C. Hardee, Fred Foster, D. N. Bradshaw, Herman Stokes, W. B. Mayo and Herman Stokes.

CHANCE FOR AUTO LICENSE CUT BRIGHTER

One Bill Before The Legislature Stands Out as Having Chance of Passage

Reflector Bureau, Sir Walter Hotel, Raleigh, N. C., Feb. 2.—Of the numerous bills introduced in the Legislature to reduce the cost of automobile license plates only one is considered any chance at passage. That is the bill introduced by Senator White of Robeson, which would reduce the 55-cents per hundredweight levy to 40-cents and fix the minimum license charge at nine dollars.

Despite the number of bills offered to levy either a flat \$5 charge for all private or fix \$5 as the minimum no observers will concede that such measures have even an even chance to be enacted into law. Most of the 55 bills have been introduced by legislators who made promises during their campaign for election that they would offer such bills. Many of them probably feel that by the introduction of their bill they have fulfilled their obligation. Perhaps only a very few believe a \$5 bill has so much as a chance.

The White bill, however, by setting up a \$9 minimum and reducing the hundredweight charge by fifteen cents offers a more reasonable reduction in the face of increased highway expenditures. It would result in a reduced hundredweight charge of about 27 percent. Earlier in the session it was believed that the ultimate reduction would amount to 10 or 15 percent. Perhaps, say observers, the White measure may be adopted as a compromise between the \$5 group and those who are staunch supporters of the highway department and who are of course, against and diversion of highway funds.

The roads committees will doubtless wait a while before considering the license reduction measures. There will be more such bills. The roads committees will not report to the Legislature on any of these bills until the highway appropriation is definitely settled. The final reduction will depend almost entirely upon the size of the highway fund. That will be the yardstick by which license reductions will be made. The bill finally presented to the Legislature is almost certain to be a committee bill, a synopsis of combined opinions.

Long Week-Ends Will Delay Revenue Measure

Reflector Bureau, Sir Walter Hotel, Raleigh, Feb. 2.—(AP)—The revenue bill probably will not be reported to the House until February 13 or 14 as a result of the refusal of members of the joint finance committees to stay here over the week-end and work on the bill, according to Representative R. Gregg Cherry, chairman of the House finance committee.

"If the members of the committees had been willing to stay here over the week-end and work on the revenue bill, there would have been a good chance to finish it and report it to the House by the latter part of next week," Cherry said. "But with no meeting of the committee from Thursday afternoon until next Tuesday afternoon, it will of course be impossible to do the work that needs to be done on the bill. If we could have held meetings of the committees on Friday, Saturday and Monday we could have accomplished the same amount of work it will now take us until Thursday to do.—As a result, I see

no chance of reporting the bill to the House until week after next." While the finance committees have completed their scheduled public hearings, considerable opposition has developed to a number of changes already made in the license tax of Schedule B section of the bill. As a result of these changes, additional hearings have been requested on the section licensing peddlers, outdoor advertising concerns and resort hotels. Several more days may be required to dispose of these hearings and reach an agreement on these sections.

Another knotty section that promises to give the committee a good deal of trouble is the section taxing chain stores, especially if the move to extend it to filling stations goes through. Still other troublesome problems may develop from day to day. As a result it is expected to take a good deal more time for the committee to finish with the bill than at first seemed likely.

LOCAL POWER COMMISSION GIVES ROAST

City Officials From Other Towns and Other Guests Enjoy Oyster Feed

The annual oyster roast given by the Water and Light Commission was held at the power plant on Tar River last night, and as usual proved very delightful.

Mayors, aldermen and other public officials from several towns in this part of the State were present and enjoyed the inspection tour of Greenville's \$2,000,000 municipally-owned water and light plant as well as the oysters.

A bounteous supply of oysters of a very large type, were served the large number of guests, and the way the food disappeared carried joy to the heart of the large force of workmen charged with the important task of providing the oysters, red hot.

Although few improvements have been made at the local plant this year, it is still one of the finest in this part of the State, furnishing electric current to a score of more towns in this immediate section. The plant yard and roads leading to and from it have been improved to such extent that the place may be reached much more easily than in past years.

The guests were escorted through the buildings by Martin Swartz, superintendent of the plant, and members of the commission, who are proud of what they have been able to achieve in past years. They have been able to improve the plant from a very small affair to one of the best to be found in this part of the State and capable of taking care of demands of the community for years to come.

The visitors expressed appreciation of what had been accomplished here and congratulated Mr. Swartz and members of the commission on their good work.

Late News Flashes

Seek Negro For Attack. Greensboro, Feb. 2.—(AP)—Pesses of armed citizens and officers sped over a wide area in Rockingham and adjoining counties today in the hunt for a black negro who early last night robbed, criminally assaulted and left to the Miss Annie Grogan, an elderly spinster who lived alone on a small farm in the Shiloh Church section of this county.

Stripped of all her clothing and tied hand and foot, the 60-year-old woman lay for two hours or more in a gulley a quarter-mile from her home before she managed to walk and crawl a mile to the home of W. B. Gray, a brother.

She named as her assailant Jake Johnson, about 40, sharecropper on a nearby farm. The robbery and attack took place between 6 and 7 o'clock, but it was around 9:30 before she made her way to her brother's home in a desperate condition.

Officers were notified last night and conducted the hunt quickly, fearing mob violence should the negro be apprehended. However, news of the crime, one of the most shocking in the history of the county, spread rapidly this morning and (Continued on Page Four)

CITY READY TO START RELIEF WORK MONDAY

School Children Without Clothing and Unemployables to be Taken Care of

The annual campaign to carry relief to children of the poor and to provide work for "unemployables" which the government has turned back to the counties and towns, will be launched in Greenville next Monday, it was announced today by Mayor R. C. Flanagan, head of the relief committee.

At a meeting the middle of the week final plans looking to taking care of the situation here were decided upon and the mayor was authorized to go ahead with the program with the assistance of Chief of Police George Clark.

Speaking of the situation today, Mayor Flanagan said 201 colored and 30 white school children were in immediate need of clothing and that they would get it. Fuel is also being provided for families, declared to be absolutely destitute with no visible means of support.

Employment is being provided for "unemployables" who are found to be deserving of consideration, but the ruling is being drawn tightly in this respect. The mayor made it plain that persons not deserving of aid would not get it.

Mayor Flanagan said investigation had disclosed that both white and colored school children had found in dire need of shoes, shirts, sweaters and underclothing, and relief would be rushed to them by the first of the week at the latest.

Relief will be carried on this winter largely through a fund which the Mayor saved from an old community garden project authorized by the government. Another sum described as "small" is also in the hands of the committee to take care of the situation as far as possible.

THEFT CASES BEFORE COURT

L. H. Burlingame Bound Over on Charge of Receiving Stolen Goods Here

L. H. Burlingame, local filling station operator, charged in four cases with receiving and concealing stolen goods, was bound over to County Court under \$500 bond in a preliminary hearing in police court this morning.

Burlingame was taken into custody following the arrest by police Thursday night of nine negro youths charged with the wholesale theft of automobile accessories and other things from filling stations throughout the city. They were also alleged to have stolen 700 brick from the store of Smith Electric Company and to have sold them to Burlingame along with a grease gun and automobile batteries. Police charged Burlingame with purchasing the goods knowing them to have been stolen.

The youths were to face hearing before Judge J. F. Harrington in juvenile court this afternoon and probably will be ordered confined in schools of connection in other sections of the State.

The defendants are: James Whitefield, Joe Tom Graham, David Lee Clark, Dave Henry Grice, Joe Curtis Grice, Charlie Pierce, Petrow Grice, Willie Ray Tucker and Boston Bradley.

Chief of Police George Clark who directed the investigation, said all of the boys confessed and told of having sold part of their loot to Burlingame.

The sterling went on for a month or more before officers finally were able to trace it to the gang, one of the largest and youngest captured here in months. The boys range in age from 12 to 15 years of age.

Other cases heard in police court this morning were: P. L. Bullock, abandonment, bound over to County Court, unable to give bond and remanded to jail. W. S. Corbett, 30 days in three charges of disorderly conduct; sentence suspended providing the defendant pays to his wife \$17 and one-half of his weekly earnings.

WORK ON CITY CLUBMEN ASK PARK WILL BE FOR EXTENDED STARTED SOON SCHOOL TERM

Beautification of Ground Around Swimming Pool to Begin in Few Days

When the "good, old summertime" comes again Greenville people are going to have a public park they will be proud of, it was stated today by Mayor R. C. Flanagan.

The mayor said that the work is scheduled to begin in a few days in connection with beautifying the grounds around the swimming pool which are to be converted into a public park.

The park, the mayor said, has been made the major project of the year by the Garden Club of the Women's Club and they are going to do everything in their power to make it as beautiful as flowers, shrubs and park furnishings can make it.

Lights and seats will be placed on the walkway of the culvert running by the swimming pool and through the municipal playground, the mayor said. The same arrangements will be made on the side of the hill of the Training School property which was loaned by the college to the city last year for use as a public park.

One of the main objects of the Garden Club the mayor pointed out is to make the unsightly grounds around the swimming pool and playground beautiful. With this end in view, landscape gardeners have looked over the situation and advised the ladies what plan to follow in carrying out the beautification project.

Even when the pop-eyed Kingfish is cranking on the Senate floor, you can look up into the special gallery reserved for Senatorial families and special guests and see one or more stocky gun-chewing gentlemen from the Long boyhood.

Before he leaves the floor, by some prearranged signal these men are notified and slip quietly out to pick up their charge at the cloakroom entrance.

FISCH'S NAME AGAIN ENTERED KIDNAP TRIAL

Not Revealed What Part Names of Two Dead Persons Will Take When Trial Is Resumed Monday; New York Times Said Miss Sharpe Remained Reticent Because of Visit to Speakeasy

Flemington, N. J., Feb. 2.—(AP)—The State of New Jersey will let the name of Violet Sharpe injected into the Lindbergh case by the defense. Assistant District Attorney Robert Peacock said today.

Miss Sharpe, a maid in the home of Mrs. Dwight W. Morrow, mother of Mrs. Charles A. Lindbergh, committed suicide when she was questioned for the fourth time by officers investigating the kidnaping.

New York, Feb. 2.—(AP)—Violet Sharpe visited a prohibited speakeasy the night the Lindbergh baby was kidnapped, the New York Times reported today, in explaining why the 20-year-old house maid left the Englewood home of Mrs. Dwight W. Morrow committed suicide.

Without making known its informant, the newspaper said Miss Sharpe, contrary to orders of the house, visited the banned speakeasy in Orange.

When Mrs. Morrow asked where Miss Sharpe had been, the Times said, the maid refused to answer. She persisted in answering, according to the paper, even after police had called her for questioning intervals. While police were waiting for her to resume questioning she committed suicide.

Flemington, N. J., Feb. 1.—(AP)—The shadowy figures of Violet Sharpe and Isador Fisch, long since dead, were projected once more in the uncertain outlines against the background of Bruno Richard Hauptmann's defense today in a trial for the murder of the Lindbergh baby.

Into what part of the kidnaping puzzle the defense planned to place them, was not revealed as the weekend recess cut short the trial until Monday.

Previously the State had exonerated Violet Sharpe, the maid in the Morrow home who committed suicide when the investigation was at its height.

Chief of the Defense Counsel, Edward J. Reilly earlier declared he would not attempt to link Hauptmann's former business partner with the actual kidnaping.

But through a surprise witness the defense yesterday adduced testimony vaguely linking the crime with the Morrow maid and the German fur dealer who is accused of Hauptmann's leaving behind him the \$14,000 ransom money when he went to Germany to hide.

They witness, Peter H. Sommer, related how he saw a woman resembling Violet Sharpe and man who looked like Fisch board a 42nd Street cross-town in New York City at a Jersey terminal bearing the body of a baby in a one-piece sleeping suit. A second man assisted them, he said.

This was on the night of the kidnaping, March 1, 1932, he said. Sommer's story was due for a shake-up by Attorney General David L. Wilentz when the trial is resumed.

Admit Plot To Kill Long. Baton Rouge, La., Feb. 2.—(AP)—In an atmosphere intensified by a bustling national guards armament, Senator Huey Long today heard testimony that two former deputies plotted to kill him for \$14,000, and then postponed inquiry into his murder plot hearing.

With Long laying the role of cross-questioner, George Red Davis, former deputy sheriff of the Baton Rouge parish, testified that he and Fred Parker, another deputy, were responsible for the conspiracy to kidnap the dictator.

Winding up testimony at the morning session in the hearing before Judge Wolmack in the skyscraper Louisiana capital, Long announced the inquiry would be postponed definitely.

Davis testified he had plotted with Parker on several occasions to kidnap Long, first for \$14,000 and later for \$20,000.

usual perspicacity enabled him to slide it in the nick of time—albeit at the expense of a swell shiner.

DELIVERY: Make no mistake about it, Huey Long is in deadly earnest when he says he's going to run for President next year. He is reaching out steadily to corral the support of the unrescued millions to whom recovery has not yet penetrated. This through his share-the-wealth talk.

The Kingfish has borrowed Adolph Hitler's technique—minus, naturally, attacks on the Jewish race. (There are reports he assured Chicago Negroes he drew no racial line which is something for a Southern politician.)

And if eventually he can round up the dynamic left-wingers and the static discontented he believes he will have something to deliver to the big corporations, precisely as Hitler did to the German financial barons.

ADVISING: Long probably isn't kidding himself he can beat President Roosevelt next year—although votes he would draw as a third party candidate would come largely out of FDR's column. The 1936 run would be designed rather to give him a good warm-up so he could go hell-bent for the White House in 1940 if old man depression was still with us.

In the meantime Huey has taken over part of the United States just as Hitler took over part of Germany in the early days. Hitler was beaten several times in national elections, but look at him now.

His big '36 gesture quite likely will be made in the Democratic National Convention where he can get himself placed in nomination and staged a Long demonstration such as only he knows how to put on. Any delegates he can pick up to add to his own state's in the interim will make just that many more votes and that much more noise. Who knows but what he might even dominate himself?

DIFFICULT: The enforced absence of Rep. William B. Bankhead of Alabama, as Democratic Floor Leader of the House is worrying the administration high command more than you ever suspect.

Dominant, corner-cutting leadership is much desired to put many impending New Deal measures through without dotting of i's or crossing of t's.

When a very mild revolt was threatened over steam-roller passage of the \$4,880,000,000 works relief bill, Speaker Byrns had to double in brass and go back to his old job of cracking the whip. He worked under difficulties from the Speaker's chair.

HOPING: Rep. Edward T. Taylor of Colorado, who has been acting leader in reversed and respected by his colleagues. His 70-odd years demand that the recalcitrants, nevertheless, weren't so willing to jettison his leadership in a tight spot.

Bankhead went to the hospital on a stretcher the day he was nominated for Leader by the Democratic caucus. He had to have the oath administered to him there so he could draw his pay—a function which required a special House resolution. Friends of Bankhead had urged him not to run for the majority leadership, bearing in mind heart attacks he had suffered earlier, but to no avail.

The Albatross is regarded as one of the ablest men to debate in either house. Last session he frequently stepped into the breach and pulled the Democrats out of embarrassing situations. New Dealers are hoping fervently he will soon be so far recovered he can do business at the old stand.

Building: The new Progressive Party, fathered by the LaFollettes of Wisconsin, very carefully is making a third party record for itself in the Congressional Record under the guidance of Rep. Gerald J. Doleau, who is acting as minority

leader for the progressive bloc in the House.

Boileau is constantly in his seat on the floor, suffering a sustained debate that would make strong men weak. But he forces himself to listen attentively and he is on his feet at the psychological moment with questions directed at the orator of the moment designed to build up a case for the Progressive Party's existence.

NEW YORK

SNAG: Floyd Carlisle continues to draw nothing but raspberries for his rate-cutting gestures on behalf of the Consolidated Gas electric subsidiaries. It didn't take long to figure out that the net saving to New York domestic consumers on his latest proposition would be about 1 per cent—and they would have to carry the city's special utility taxes. His demand for a guaranteed 7 per cent return on a rate base "dewatered" by less than eight per cent had as happy an effect as waving a red flag at Hamilton Fish.

Carlisle gets support from the opposition on only one point. There's general agreement that consumers would save a lot of money if sub-metering were eliminated. But that's no simple trick either. Large landlords get nice pickings from this privilege and will fight to the limit any move to abolish it.

There's one factor operating in Con Gas's favor. The informed say the administration feels enough utility yardsticks have been set up for the present—so Mayor LaGuardia may find it tougher than pulling teeth to get funds for his proposed municipal plant if it comes to as howdown. The hope is that Carlisle is privately courting someone such snag to have his bacon.

OFFER: Con Gas is still far from out of the woods. Well posted sources say that Carlisle will have to go farther in at least three directions if he wants assurance of a continued monopoly.

1. Offer an immediate and substantial rate reduction NOT contingent upon a transfer of the tax burden.

2. Accept a rate base reduction of 20 per cent or more instead of the 71-2 per cent now proposed.

3. Ask for no more than 6 per cent original return on the revised rate base.

Unless these concessions are made it isn't safe to count the federal government out of the picture—although it will probably be some time before it swings into definite action.

OIL: There has been remarkably little excitement in the oil industry since federal control was scratched by the Supreme Court. This is partly due to the Texas Commission's strenuous efforts to keep the hot oil situation in hand—but even more to the unexpected discretion of the small producers.

A New Yorker with close Texas contacts says the hot oilers realize that now is no time to get racy. Lavish over-production would merely be inviting stiffer federal legislation. But he predicts there'll be a lot of fun after Congress goes home and there's no further chance of new laws for awhile.

Profits on crude oil production are running higher than they have since 1929. Humble Oil's report is characteristic.

This company showed \$13,000,000 profit on crude for the first nine months of 1934—more than that department accounted for in the whole of 1933. At the same time its refinery business showed a loss against a profit the year before and the sales department ran in the red.

This points the trend in the industry toward concentration on production and gradual curtailment of refining and selling activities.

RAILS: Insiders say that the RFC's new authority to buy depreciated rail bonds in the open market should help sick roads a lot. Plenty of industrial corporations have cut down fixed charges in the past few years by buying in their own bonds and preferred stocks below par. The railroads couldn't do this—even at bankruptcy prices—because they didn't have the cash. Now the RFC is preparing to do it for them.

This isn't pure altruism on RFC's part. The more of a given road's bonds it owns the more voice it will have in that road's reorganization.

This doesn't imply a drive for government ownership. It does mean the RFC will be in a position to force needed readjustments where security holders are stubborn. The informed prophesy 15 to 20 reorganizations inspired by the government before the end of the year.

TALENT: New York's reaction to the threatened walkout of foreign opera stars because of curtailed salaries is "so what?" Large sums of money hitherto pumped abroad can now be kept here to develop home talent. Comment runs that there must be a few decent sopranos and tenors among 120,000,000 people—even if scouts have to listen in a bathtub to find them.

word the Senator from Duplin hushed outcries in this county by his manners. Now in the county of P. Mr. Eagles' county and mine, we announce it that way. "Too, we aren't advanced educationally in Pitt like the folks of Duplin. So I think the reading clerk has little education, despite the handicap he may suffer as a result of his Pitt

County residence. The first time I ever saw the reading clerk he was on my front porch, and he discoursed for an hour or more on the works of Voltaire and the Greek philosophers. His erudition is a thing beyond dispute. But the way to pronounce 'tates' is a 'tals'. In spite of that I tender my apology to the clerk, but I do recommend that when he comes to a difficult word that he just skip it."

Developments resulting from a local bill, introduced by Representative Bailey, of Haywood, may result in increased pay schedules for school bus drivers. The bill, passed by the lower House under suspension of the rules, would permit the commissioners of Haywood County to supplement the \$750 monthly salaries of school bus drivers by \$20, the supplement to be paid out of the county's general fund, and would grant to the commissioner's the power to levy taxes for the purpose. The bill further authorizes the employment of adult drivers.

When the bill reached the Senate, Senator Ramsey, of Transylvania, moved for suspension of the rules, saying that he had no intimate knowledge of the bill, but that he had resolutions from school boards and the county commissioners of Haywood asking for immediate adoption. Several Senators wanted to learn definitely if the supplement was to be paid out of school moneys

or the general fund. Senators Spence Hill and Newman joined in asking questions and asked that the bill go to committee for customary consideration. "There are perhaps 30 counties," said Senator Newman, "where school bus drivers are sadly underpaid. Therefore, since the bill will doubtless have some bearing on the State's bus policy, I ask that the bill be referred to a committee." Others indicated that the problem was of importance in their districts.

Senator Ramsey withdrew his motion for immediate consideration. At that point Lieut. Governor Graham who had been reading the bill, said that inasmuch as the bill provided for the raising of revenue that it would necessitate a roll call, and gave it as his opinion that the lower House had passed it illegally under suspension of the rules. He asked Senator Ramsey to ask the Representative who introduced the bill to request its return to the lower House for proper action.

That school bus drivers' pay will be increased was strongly indicated in the debate. There appears, however, little likelihood that adult drivers will be a supplanter of the revised law. Most legislators believe such a requirement would prove too expensive.

It is apparent, too, that any pay increase for bus drivers will in all probability be a State-wide measure.

May Ask Legal Liquor Without Referendum

Raleigh, Feb. 2—Legal whiskey in North Carolina without a referendum is the prospect held out today by some members of the legislature. Their opinions were given as a result of the Hill bill, copies of which were distributed to legislators by Senator John Sprunt Hill so that they might read and study the measure over the week-end.

Surprising is the sentiment favoring enactment of the control features of the bill without a referendum and without the taxation section. Many legislators voiced their opposition to the "double-taxation" idea, saying that they are opposed to whiskey for revenue and that a tax on liquor in addition to a reasonable profit would still leave a margin upon which bootleggers might capitalize. The Hill bill proposes a ten per cent tax, to go to the general state fund, in addition to a profit, and provides that the profits shall be allocated by counties and municipalities for "relief, unemployment and old age insurance." Several

legislators are of the opinion that all the profit should go to the state fund for similar purposes. They regard the suggested division as dissipation of revenue held out as "a bait" for supporting votes.

Those advocating the liquor control feature of the bill point out that a serious situation confronts the state in liquor control and that no referendum should be held. They counter opposing views with the assertion that the sales tax, though it has many enemies, was passed without a referendum and add that the sales tax is at least as much a bone of contention as liquor. Observers claim to sense a perceptible shift of sentiment in support of their claims.

plan without submitting it to a popular vote.

Those who advocate passage of the bill without submitting it to popular vote say that the bill would in reality be subjected to a referendum because any county or town desiring to prohibit the sale of legal liquor could still do so. They stress the fact that no community would have legal liquor forced upon it by the bill, but would, as a part of the state, derive benefits from the revenue obtained despite their "dryness."

Introduction of the bill is scheduled for next week. Already a legislative committee of the United Dry Forces is at work to prevent its passage despite the stout claim by Senator Hill and his associates that they too are, and always have been dry.
