TWO DEAD IN HOLLYWOOD'S MURDER MAZE

Third Probably Fatally Wounded In Murder and Suicide In Movie Center

Hollywood, Cal., April 26.—(AP)—Death stalked through Hollywood today leaving in its wake two men dead and a third probably fatally wounded.

Confronted with an apparent case of murder, near murder and suicide, police sought to unravel a maze of facts in the shooting of Paul Wharton, 25-year old Hollywood dress designer, William Howard, about 34, an ex-navy ensign and chauffeur of the style creator; Henry E. Bolte, 38, law instructor at the University of California at Los Angeles.

Howard, sought by police immediately after the shooting, was found dead, apparently a suicide, several hours later in an apartment building entrance several blocks away.

Preliminary investigation by police lead them to believe that Howard shot Wharton, drove hurriedly to Bolte's apartment to await his arrival, shot him and then killed himself.

STOKES MAN LAID TO REST

Luther Whitehurst, Who Committed Suicide by Firing a Shotgun Charge into his Forehead at his Home in the Stokes Community Wednesday Night, Was Buried Thursday

Funeral services for Luther Whitehurst, 31, who committed suicide by firing a shotgun charge into his forehead at his home in the Stokes community Wednesday night, were conducted from his late home yesterday afternoon at 3:30 o'clock and burial was made in the family burial ground near the home.

Whitehurst, well-known farmer, was said to have been in ill health for some time and took his life while in a fit of despondency over his physical condition.

Erroneous reports reaching here yesterday were to the effect that Walter Whitehurst had committed suicide, and discovery of the error was not made until late in the afternoon.

Whitehurst was a brother-in-law to Mrs. C. L. Whitehurst who committed suicide by jumping into a well at her home about three weeks ago.

An investigation was deemed unnecessary by Coroner A. A. Ellwanger, who declared it was a plain case of suicide.

BODY READY FOR STUDY OF COTTON ISSUE

President's Committee to Hold Conference Next Week on Textile Situation

Washington, D. C., April 26.—(AP)—While brickbats flew at the Farm Adjustment Administration from several quarters, the President's Cabinet committee created to study the cotton textile situation prepared today for private conferences all next week with governors, members of Congress and industrialists.

As the Cabinet sub-committee announced its schedule which opens Monday with appearance of Governor Brann, Senator Hale and industrial representatives from Maine Minority Leader Snell assailed yesterday on the House floor the entire administration farm program while in Augusta, Ga., W. E. Anderson, as president, opened the convention of the American Association of Manufacturers with a demand that Secretary Wallace resign.

An interested listener to Anderson's denunciation of the cotton processing tax and his criticism of Secretary Wallace was Marvin I. McIntyre, the president's secretary, and an unofficial observer attending the meeting of the Southern mill men.

During the day reports from Augusta, said McIntyre received a delegation of Georgia and South Carolina farm representatives who paid tribute to Wallace.

GRAND JURY FILES REPORT

Recommends That Magistrates Continue Filing Dockets With Grand Jury

Recommendation that all magistrates of the county turn their dockets over to every grand jury for inspection was made by the six months grand jury in its report filed with Judge M. V. Barnhill in criminal court here yesterday afternoon.

The jury expressed surprise at the improper and poorly-kept condition of the magistrates' dockets although it was found that a few were in good condition and self-explanatory.

It was also recommended that all files be turned over to the county monthly along with other suggestions looking to the improvement of the court records.

In its January meeting the jury had asked the Clerk of Court to have the magistrates submit their dockets for inspection at this term of court, and the recommendations followed examination by members of the jury earlier in the week.

The jurors also visited the various county offices and found them in satisfactory condition, but recommended that the Clerk of Court not later than May 15 present a report on the condition of various clerkships handled through that office.

The report, bearing the signature of J. M. Whitehurst, the foreman follows in detail:

We, the Grand Jury of this term of court, respectfully submit our report, investigation and recommendation in the following report:

We have noted upon all bills of indictment presented to us and have passed on same in accordance to the evidence.

We visited and inspected the county offices, namely, Clerk of Court, Register of Deeds, Sheriff, Board of Health, Treasurer, Tax Collector, Board of Health, Welfare Department and the Auditor. We found all records kept in an orderly, neat and business-like manner, and we wish to commend the officers in charge.

Late News Flashes

Awaits Report on Revenue Bill Raleigh, April 26.—(AP)—A varied assortment of statewide legislation occupied attention of the legislature today as a new report was awaited from the revenue bill conference.

The assembly wrote into a bill to submit to voters in 1936 a series of proposed amendments to raise the income tax limit from 6 to 10 per cent, permit classification or property for taxes and put new limits on public debts.

The senate sent to the house a measure backed by the governor which would permit organization of a non-profit membership corporation for the encouragement of rural electrification.

HADDOCK IS FOUND GUILTY

Jury Returns Decision In Manslaughter Case After Hour of Deliberation

Charlie Haddock, of the Haddock's Cross Roads community, charged with manslaughter in connection with the death of Frank Spain, of Grimesland, was found guilty by a jury in criminal superior court here late yesterday afternoon, but Judge Barnhill reserved judgment. The case started shortly after noon Wednesday, went to the jury yesterday afternoon shortly before 4 o'clock and a verdict was returned about an hour later.

Spain, a student at East Carolina Teachers college, was fatally hurt when the car in which he was riding with two or three friends was struck by Haddock's machine. Spain was going toward Grimesland and Haddock was headed for Greenville.

Spain sustained a fractured skull and died several days later. Haddock sustained a deep cut on the forehead and remained in the hospital several days under police surveillance.

He was held on a charge of driving drunk and reckless and careless driving, but the charge was changed to murder when Spain died. The grand jury returned a bill of indictment early last week.

Judge Barnhill directed a verdict of acquittal in the case of J. C. Wynne, Jr., of Bethel, charged with secret assault on Jesse Bullock, also of Bethel. Action of the court was based on the ground of what was described as insufficient evidence.

Wynne was all-ged to have shot Bullock about a year ago, but contended that the prosecuting witness shot himself.

The verdict was handed down after the state had completed the presentation of evidence.

SPRINGFIELD ALARMED OVER MINER INFLUX

Police Take Precautions to Guard Against Disorders as Miners Throng City

Springfield, Ill., April 26.—(AP)—Alarmed by the influx of thousands of Illinois miners, authorities of the State capital were tense today, fearing renewed violence in the long standing miners' war that has torn spracially through the Illinois coal fields.

Throughout the early morning hours trucks rumbled through the city adding scores to the massed miners, estimated by authorities at more than 2,000. They were established in encampment in two city parks. Further contingents were reported to be moving along highways on Springfield.

All special police and special deputies were called into emergency service last night by authorities fearing an attack on the city jail where three men, members of the United Mine Workers of America, are held on charges of slaying a member of the rival mine union, the Progressive Miners of America, in an affray that brought wounds to seven others Easter Sunday.

The prison bristled with machine guns and other weapons as officials prepared to repulse any attack on the jail. State Attorney Alfred Greening was reported to have requested Governor Horner to call out National Guardsmen to cope with the situation, but the governor in Chicago said he had not received any official notification of the request.

An ominous quiet prevailed over the miners' encampment and no one would comment on the purpose of the concentration of the miners' forces.

SEEK BERRY PICKERS HERE

Fifty Workers Wanted For Strawberry Fields of Eastern Carolina

Mrs. Ruby Allen, head of the local federal re-employment office, issued a call today for fifty workers to go to the strawberry fields of eastern Carolina immediately.

Similar calls are being sent out by re-employment offices in various parts of the state in an effort to meet the demands of growers.

With the berries ripening rapidly, hundreds of pickers are needed at once to prevent the crop from going to the bad. It was said in reports reaching here yesterday from the strawberry section.

It has been years since the labor shortage has been so pronounced in the berry section, and relief organizations in all sections of the state have been called on to aid the growers in saving their crop, described as one of the best in years.

Mrs. Allen urged persons desiring to do this kind of work to get in touch with her office immediately. Growers, it was said, are providing means of transportation for pickers as well as housing and meals.

LEGISLATIVE RAMBLINGS

Raleigh, April 26.—Pursuing its course of the last month the senate failed again to agree on a question of revenue for the next biennium when it deferred until today action on the bill by Senator Newman, finance chairman of New Hanover, to extend to counties a discount of ten per cent in order to induce them to pay into the state coffers about \$500,000 due from uncollected taxes under the now-abolished 15 cent ad valorem levy for the support of schools.

The bill would offer a discount of two per cent to cover overcharges and errors, three per cent for collection charges, and additional discounts from prompt settlements. The additional discounts would be allowed on the following basis: five per cent if paid before next Nov. 1, two per cent if paid before Dec. 1, and one per cent if paid before Jan. 1. Practically every county in the state owes the state uncollected taxes under the 15 cent levy on the \$100 assessed property valuation. The tax is no longer levied, having been replaced with the re-

LABOR HEAD HERE TONIGHT

Miss Frances Perkins, Of Roosevelt Cabinet, to Speak at College at 8 P. M.

Frances Perkins, Labor Secretary in the New Deal Cabinet, author and lecturer, who will speak in the College Campus building tonight at 8 o'clock, is known as almost entertaining speaker as well as one who is an authority in her field. Her subject is "Economic Problems Today."

Before the lecture, Miss Perkins who is motoring through the country, will be the guest of the college for dinner.

Opposed because of her sex for most of the long list of State and National offices she has held, Miss Perkins has always succeeded in administering the office so well that such criticism has been silenced.

Miss Perkins first became actively interested in labor conditions after the Triangle Shirtwaist Company fire in 1911, which resulted in the loss of over a hundred lives. Ever since that time she has taken a leading place in the struggle for social betterment.

The five-day week, the minimum wage, the abolition of child labor are all causes for which Secretary Perkins has fought and is fighting.

In private life Miss Perkins is Mrs. Paul Wilson, a wife and the mother of one daughter.

A good audience is anticipated for this unusual number in the College entertainment series.

On January 9, 1929, Miss Perkins was appointed Industrial Commissioner by Governor Franklin D. Roosevelt.

On March 4, 1933, she took office as Secretary of Labor in President Roosevelt's Cabinet.

As Industrial Commissioner of the State of New York, she was department head of the New York State Department of Labor and also engaged in writing, public speaking and legislative work. During the three years (1929-1933) she has given much attention to the problem of unemployment, issuing a monthly statement on employment trends in the New York State factories, which is accepted as an authoritative index to business in the State.

As ex-officio member of Governor Roosevelt's Commission on Unemployment Problems for the State of New York she has assisted in devising and promulgating plans for industrial stability and social insurance. In public addresses she has stressed the importance of maintaining the economic welfare of maintaining the wage-earner's purchasing power. She has appeared as speaker before many organizations including the National League of Women Voters, National Democratic Club, American Academy of Political and Social Science, National Consumers' League, National Safety Congress.

Article of her writings, discussing various phases of social and industrial problems have been published in *Harper's Magazine*, *The New Republic*, *The Annals of the American Academy of Political and Social Science*, and *The Survey*, and others.

During her administration as Industrial Commissioner Miss Perkins was largely instrumental in obtaining the passage of the 48-hour law which limits the hours of labor of women and minors in mercantile establishments to eight hours a day or 48 a week. This law became effective July 1, 1931.

COUGHLIN IS DENOUNCED BY SEN. BAILEY

Minister's Ambitions Described as "Damnable" by N. C. Statesman

Washington, D. C., April 26.—(AP)—Absorbed in the preliminary forming of political lines for 1936, the capital sought today to assay the effects of Senator Bailey's denunciation of Father Coughlin as a man of "damnable ambitions who seeks to stir up the mountain of hate in a distressed land amongst a suffering people."

With a third party talk very much in the air, observers also watched to see whether an answer would be forthcoming soon to the question of whether Father Coughlin and Senator Huey Long, of Louisiana, may unite their forces in 1936.

Senator Long has already departed for Des Moines, Ia., where he will speak Saturday before Farmers' Holiday National Convention. The head of the farm holiday group, Milo Reno, has already advocated a merging of the Coughlin-Long forces.

Before a silently listening Senate, Senator Bailey, of North Carolina, voiced his denunciation of Coughlin's activity.

Prefacing his remarks with an explanation of why he referred to the clergyman as "Coughlin" rather than as "Father" Coughlin, Senator Bailey said:

"I left off his title and I did it deliberately. In his church—and I shall always speak respectfully of all churches—he can be called Father but he cannot be called Father in American politics.

"In his church he may have his priestly robes and his power of absolution, but when he undertakes to promise a harp and halo to the American people by political action I shall challenge his priestly power."

Bailey said he had profound respect for the ministry, but that when a minister goes out with his radio incendiaryism to stir up hate, "I will snatch the halo from his brow and throw it into a spittoon."

GWALTNEY ON TRIAL TODAY

Alleged Slayer of Casey Cade Goes on Trial For Second Degree Murder

Ben Frank Gwaltney went on trial in criminal court here this morning on a charge of second degree murder or manslaughter in connection with the death of Casey Cade, a few miles north of Greenville, slightly over a year ago.

The prosecution completed presentation of evidence shortly before court recessed this afternoon.

The case is expected to go to the jury late this afternoon.

Gwaltney is charged with shooting Cade to death with a shotgun in an altercation occurring on a farm several miles from Greenville. The two engaged in an argument and Gwaltney went to a nearby house, returned shortly afterward with a gun, which he allegedly fired at Cade.

Gwaltney declared he shot in self-defense as Cade was advancing upon him with a knife.

Gwaltney was arrested and held under bond for this term of court.

The grand jury returned a true bill at a previous term. The State announced that it would not seek a verdict of first degree murder, but would be satisfied with second degree manslaughter.

Often, said the newspapers, Ivestiya, new and superior articles are introduced on the market, but fail to find a demand because the public is unaware of their existence.

German Highways Expand Berlin.—(AP)—Germany now has 34,800 miles of "rich streets," the new name for wide, improved highways, linking 128 of the most important communities.

HOUSE SURVEY BEGINS TODAY

Federal Housing Administration Sponsors Survey of Greenville Buildings

A number of workers started a house-to-house canvass in Greenville today in the interest of making a thorough survey for the Federal Housing Administration. Some of the questions that the canvassers will ask is, Does the house need carpentry work, painting, plumbing, roofing or electrical work. They will also ask how many persons occupy the home and where they are employed.

R. L. Powell, Federal Housing Administrator, asked the citizens to cooperate with these Federal workers by answering the questions and at the same time to treat the workers courteous and polite.

After the complete survey has been made, those employed in the building trade will have access to the records which will be on the second floor of the U. S. Postoffice in Greenville.

1935 MODEL BOSS THIEF OPERATES WITH TRUCKS

Great Bend, Kas.—(AP)—Sheriff Bill Murdy has warned farmers to be on their guard against horse thieves and cattle rustlers—an echo of frontier days.

One alleged horse thief awaits trial and numerous cattle thefts have been reported. The sheriff said the modern "boss" thief and rustler, instead of being adept with the rope and branding iron, operate with trucks. The stolen animals usually are taken to auction sales miles away.

Victoria, Australia.—(AP)—Boss "Fred and thunder" stories are simply the poor relations of literature, says officials of the Victoria state schools.

Accordingly school children here will in future be able to read stories, between lurid colored covers without interference from teachers.

In fact, "blood and thunder" stories are to be published in the school paper, which has a circulation of 240,000.

"There is nothing wrong with the 'Deadwood Dick' story," said J. R. Lyall, the schoolmaster who edits the paper. "Stevenson's 'Treasure Island' is its big brother."

GERMAN SINGING CORPS TOP LISTS OS 'VEREINS'

Berlin.—(AP)—Germany is still the classic country for "vereins" despite repeated trimmings by the Nazis.

That the sometimes drastic curbs did not affect song-loving Germans became apparent from statistics which reveal that there are 23,384 singing societies in Germany with 65,991 active members.

Passive members, content to support music by paying their dues and listening to others sing, numbered 769,438.

SUBSTITUTE COTTON TAX NOW SOUGHT

Mill Heads Favor Continuation of Processing Tax Until Substitute is Found

Augusta, April 26.—(AP)—The resolutions committee of the American Cotton Manufacturers Association was reported today as favoring continuation of the processing tax until a substitute is found.

It was indicated the resolutions committee would insist on specific substitutes to provide relief for the cotton farmer before suggesting that the cotton processing tax be scrapped.

The committee, which will report at Saturday's closing session had before it Secretary Wallace's 1934 report to President Roosevelt in which the secretary recommended consideration of possible alternatives for the processing tax.

He said it might be necessary to obtain revenue for the benefit of the farmer either by increase of federal taxes or probably by some new form of tax.

A two possible sources of revenue Wallace suggested of an increased income tax and sales tax.

THE NATIONAL WHIRLIGIG News Behind The News

DILEMMA: New Deal economists and politicians are a restless, bold and colorful group through their motor-boats and derbies trying to figure out a solution to this cotton problem.

Between the growers who want higher prices, the manufacturers who want lower prices and the exporters who see their world markets slipping away the Roosevelt administration is being damned if it does and damned if it doesn't.

The New Dealers prayerfully have taken a hitch in their belt and struck out toward a middle road. They anticipate criticism from both sides of the central lane but they hope to arrive at a fairly permanent adjustment of prices and production.

CURTAIL: This is a large order, as Secretary of Agriculture Wallace will concede. The latter's advisers are convinced the world is at another of those periodic agricultural crossroads where nations lose their overwhelming dominance in given crops.

Sentiment among government experts favors a continuation of the curtailment program until our annual surplus carry-over gets down to 5,000,000 bales. Thereafter prices may be more or less stabilized in the neighborhood of 12 to 14 cents a pound with the grower educated

President Roosevelt has undertaken some sizeable tasks, but it is questionable whether anything he has tackled thus far is even in the same class as the \$4,880,000,000 spending job he now is beginning.

The total of the new work relief appropriation is so great that most ordinary people simply can't grasp its magnitude.

To most American citizens, \$1,000,000,000 is hard to visualize. Imagine 4,880 stacks of money, with \$1,000,000 in each.

And in spite of the qualifying amendments which Congress put into the act, the President's latitude as to the manner and allocation of the spending remains extremely broad.

The responsibility which rests on Mr. Roosevelt in this matter would be positively staggering, even if it involved only the obvious difficulties of making wise selections, in a wholly detached way, from among the thousands of spending projects which will be placed before him for approval.

Under Pressure
But it involves a great deal more. Mr. Roosevelt is very far from being in the position of a man making a will disposing of \$4,880,000,444. Undue pressure from possible beneficiaries invalidates a will; and moreover, the maker of the will never has to worry much about the consequences.

From now on until the last penny is allocated, Mr. Roosevelt is certain to be under the strongest kind of pressure. The States, cities and communities are mobilizing their most persuasive agents on the doorstep. It is a disputed question how far politics actually will enter into the decisions made, but it is perfectly assured that scores of politicians will do their only best to get in on the ground floor.

So far as the consequences are concerned, Mr. Roosevelt himself has more to gain or lose than has any claimant. Not only the success of his recovery program, but his own political future may easily become involved.

Either a first-class failure or a first-class scandal would be used against him in 1936, even though the real cause lay in the blundering crookedness of subordinates.

At a Critical Time
Many in Washington believe the test of Mr. Roosevelt's acumen hardly come to a more critical time.

Berlin.—(AP)—Nazi eugenics experts are viewing with alarm the failure of 300,000 couples to marry.

They consider the World War as partly responsible for a hitch in the 'be fruitful and multiply' program because a great decline in marriages is expected after 1936.

One of them, Dr. H. Burgdoefer, says the low birth rate during the war is an 'unconquerable obstacle' in maintaining the present 'record trend to marriage registry offices.'

Many Thousand 'Missing'
This trend led to 366,174 marriages between May, 1933, and the end of '34, with the aid of Adolf Hitler as a main pillar of his re-population scheme.

Dr. Burgdoefer finds that another 300,000 couples are 'missing'—they 'should have married, but didn't.'

Adverse economic conditions are blamed: 'These marriages were due in 1933 but had to be postponed because of the depression,' he maintains.

He expects the run on the registry offices to continue until the second

The American cotton processor hesitates to buy foreign cotton for fear it may not make up into cloth that will equal the home-grown product. Nevertheless it is a fact that cotton now flourishing in southern Brazil came from selected American seed.

HARRIERS: While the utilities interests have been applying pressure to defeat the pending administration bill which would write holding companies off the boards within five years the home team hasn't been overlooking its turn at bat.

The other day utility representatives appearing before the Senate Finance Committee in opposition to the proposal kept finding themselves confounded with embarrassing questions.

The answer: At least half a dozen of the more interested New Dealers were in the committee room. Every time a witness was in the midst of getting over a good point one of the administrationites would slip a penciled question to one of the presiding Senators. Most of them were rather embarrassing.

YOUTH: Republicans are of divided opinion regarding the regional meeting that is intended to develop a party program. Some of the best strategists think these meetings will develop discord instead of harmony. Different regions favor different methods and different candidates. They don't agree upon issues. These strategists contend that rivalries over candidacies will confuse party councils.

With the Democrats fighting among themselves, why should Republicans start a row in their own family? is the way one of the "old boys" puts it. "Let the opposing army tear itself to pieces. We can't sit down and invent issues—they make themselves."

Young Republicans generally favor the regional meetings. They insist that the party is rapidly re-emerging and that its former element wants action. Out of these meetings they believe a party program will evolve, and perhaps a leader may appear.

HOG: Direct-action boys are hopping on to Senator Pat Harrison's compromise bill. Veteran propagandists are having an effect on Senators. What's the use of putting a compromise that doesn't compromise?

Mixed in this situation is politics as usual. A bloc of Senators would be glad to make trouble between FDR and the veterans. They don't see why they should support a bill calculated to get FDR out of a tight hole.

The House majority can't be expected to turn down the veterans by accepting the Harrison bill after having voted the whole bill on the bonus. The veto lobby is keeping the fire stirred in the House. No compromise.

National banks with their own banknotes outstanding will have to deposit cash with the Treasury to cover their currency still in circulation when the bonds on which the note issue privilege is based are retired. Experience indicates that the notes themselves will be slow to come in for cancellation—and some of them probably won't show up for years. It's estimated that this will give the government about a billion dollars of the bank's money to play with at no charge for a period from a year to a year and a half.

The big banks are in a better position to stand the gaff than the little fellows—but many of them feel they're faced with the prospect of paying a premium to remain in business for the next year or so. They can't effect economies through mergers — as brokerage

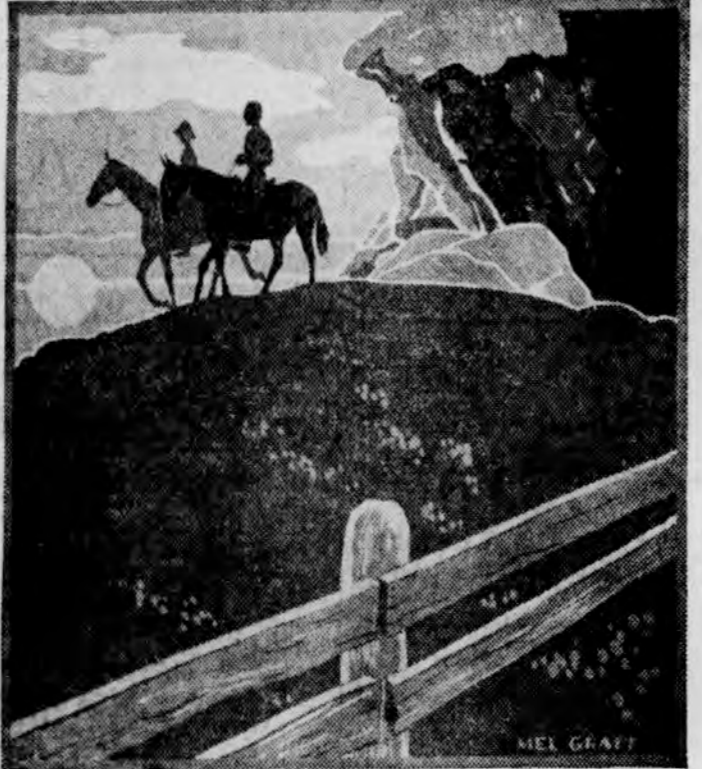

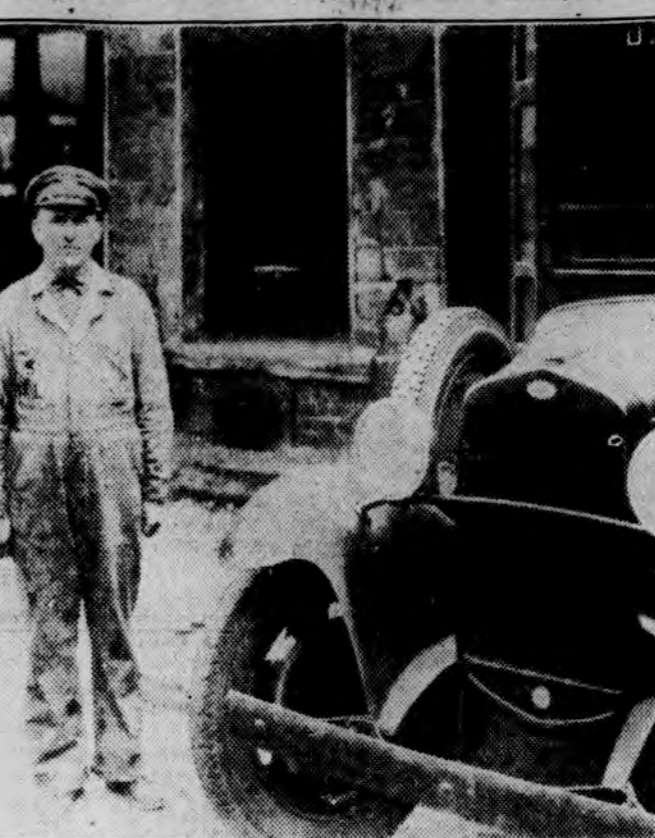

the buying public clearly refuses to shudder in its shell.

Recent stock market gains trace to investment purchases—not speculation. Dividend payers have led the parade. Bond yields are getting so low that shrewd financial men are turning to stocks of companies with good earnings records as plenty safe by row and much more attractive from an income standpoint. Judging by current prices of 4 per cent yield on such stocks is considered hard- some. It's tough on the die-hards—but most informed sources agree that recovery is moving up.

STRATEGIC: Aviation authorities rate the Pan-American hop to Hawaii the forerunner of a practical trans-Pacific service. Overseas jumps will always be more costly than over land trips of the same distance because of the much heavier fuel load which must be carried. But airplane engineers have made the pleasing discovery that payload efficiency increases with the size of the plane up to a point that hasn't yet been reached—so the giant four-motored clippers will be able to operate profitably if they can get the traffic to carry.

A trans-Atlantic plane route isn't so far away either. Pan-American officials privately expect this to develop before the Pacific schedule. They changed their minds for an excellent reason. The government wasn't interested in subsidizing an Atlantic run but was to the tune of two million dollars—in a Pacific line. The Navy department helped enthusiastically to sell the idea as strategically valuable.

Short Frontier Involved

The actual boundary, designated by plebiscite after the World War which placed approximately 166,000 residents of North Slesvig under Danish rule, is no more than sixty miles in a direct line.

Germany's interest in the district which Danes call North Slesvig dates back to 1848, in which year an interior revolution was suppressed by the Danish crown. In 1864 a new conflict broke out, admittedly, according to historical verdict, backed by Bismarck, and as a result the

entire Schleswig-Holstein area went to the German Confederation of that day.

In the geographical divisions at the conclusion of the World War Denmark, it is admitted, could well have asked for, and received, nearly the entire Schleswig area, with old historical boundaries as a guide.

Both Denmark and Germany insisted on a plebiscite, however, the former from a fear that certain districts had been so Germanized that peaceful supervision and parliamentary representation would be impossible.

Nazis Claim New Situation

The socialist-liberal government which prevailed in Denmark insisted that only a free test of public opinion should determine the new boundaries. The plebiscite was, therefore, carried out in 1920 both by large sectional voting and by parish voting, with part of the district remaining with Germany.

From the German viewpoint many of those who voted for Denmark at the time did so for purely economic reasons, out of distrust of Germany's financial future. A new situation now has arisen, it is argued, in which the tests of public sentiment of the past are no longer to be regarded as final.

For the Danes there is the steadily developing conviction that Nazi Germany looks upon Slesvig as only another injustice of the World War with no allowance for the historical boundaries that prevailed in the time of Bismarck.

Two Penalized For Assault on Officer

Edenton, N. C., April 25.—Atty. Gen. Lloyd E. Griffin, their counsel, had made an earnest and lengthy jury plea, referring to them as "a couple of country boys known for a good time," the listening jury returned a verdict of guilty here on Monday against William T. and John T. Bembridge, local tobacco farmers.

The young men were on trial the entire day charged with assaulting Chief of Police, after he had tried to arrest them for intoxication, reckless driving. Recorder Pruden gave William three months in a road gang and fined John \$25 and costs. Both posted bond for an appeal.

SENATE FACES BIG CALENDAR

Several Important Matters on Tap, Including Biennial Appropriations

Raleigh, N. C., April 26.—A heavy calendar faces the State Senate as it deliberates the biennial appropriations bill which contemplates the spending of more than \$65,000,000 during the next two years.

Regarded as of prime importance are two bills which would pave the way for the electrification of thousands of rural homes in remote sections of the State. One of the measures would set up a State rural electrification commission to represent rural areas and the other bill for the purpose of electrifying rural non-profit corporations in such areas for the purpose of electrifying rural homes through the extension of power lines. Both are Senate bills and have not been in the Loker House.

The House bill, offered by Representative Bryan, of Durham, and which has been approved by the House, which would limit the right to obtain a divorce on the grounds of two-years separation to the injured party, thus requiring that applicants for divorce prove that they are the injured party, is on the Senate calendar. It is believed that the Senate bill will pass it unless a coalition of Senate layfers block it.

The Tompkins-Ervin bill which would grant to cities and towns the power to regulate taxicabs and to require operators of taxi lines to furnish liability insurance or surety bonds is a measure which passed the House early. In several towns in the State this question has been a highly-controversial topic. As a result, the argument may be injected into the Senate debate.

The Morpheus-House-Horton bill which would make registers of deeds elective for four-year terms instead of two, is before the Senate again after having been passed by the House within 39 counties exempted recalled, revived, passed again with 37 counties exempted. It is believed that the Senate will pass the bill because old-line politicians realize that registers would, if the bill becomes law, contribute to county political war-chests only once in four years if they were candidates only that often. Too, by running two years registers aid in "getting out the vote," an item dear to the hearts of politicians.

The bill which would permit the manufacture of 5 per cent beer also faces the Senate after being passed two weeks ago by the House. Manufacture of beer is still banned under North Carolina law despite the fact that the sale, transportation and possession are legalized. No trouble is seen for the bill. It would impose an annual license tax of \$500 on brewers.

The Alspaugh bill, already approved by the House, would modify the stringent Ervin anti-slot machine law passed this session by legalizing pin games, or pin tables. Regular slot machines which pay out tokens (sometimes) would still be banned.

Sure-fire bolts of contention is the Williams of Hyde resolution which would rescind the Cherry resolution. The Cherry resolution, previously passed by both the House and Senate requested the North Carolina Congressional delegation to work for repeal of the cotton processing tax backbone of AAA's crop control program. The Williams resolution passed by the House, would nullify the Cherry resolution. Its sponsors, oddly enough, are legislators hailing from non-cotton growing counties who are anxious that the Federal Government control the potato crop. If the cotton tax is repealed they see the breakdown of all crop control.

The measure was offered by Senator Newman in an effort to get the counties to pay up. Senator Newman has already included in his revenue bill estimates collections under this item.

When the bill appeared on the calendar for action Senator Johnson of Duplin sent up an amendment which would allow the state treasurer to settle with counties on whatever discount basis he should deem advisable. Opposing the amendment was Senator Allsbrook of Halifax who said that it would allow too much latitude for politicians. He declared that he did not believe that the state treasurer himself (Charles Johnson) would like the amendment. At once Senator Johnson was on his feet. "The only reason Senator Allsbrook is opposing this amendment is because he dislikes me personally," shouted the Duplin Senator. Senator Allsbrook denied the allegation and a compromise was reached under which the maximum discount permitted any county would be ten per cent. It was then that the bill was deferred until today upon the motion of Senator Johnson.

Despite reports from Washington to the effect that Congressman Robert L. Doughton will definitely announce whether or not he will become a candidate for Governor in 1936 on Monday afternoon and the belief in Washington that he will become a candidate, there are many political observers here both inside and outside the general as-

sembly who still feel sure that Doughton will not become a candidate for Governor. All political factions and alignments here, however, are anxiously awaiting his announcement this coming Monday, since it is agreed that if Doughton does enter the race for the Democratic nomination for Governor in June, 1936, he will undoubtedly have to be reckoned with by the other candidates.

It was learned here today that Congressman Doughton was in Winston Salem Wednesday morning of this week conferring with some of his friends there and that he did not receive anything like the encouragement he had hoped for. It is also generally conceded here that there is by no means as much sentiment for Doughton here now as there was several months ago and that many observers here do not think he can be nominated if he becomes a candidate.

In fact, the prevailing opinion in most political circles here now is that Lieutenant Governor A. H. Graham occupies the top position among all of the actual and potential candidates for Governor. Doughton second place, Clyde R. Hoey of Shelby third place and John McRae of Charlotte fourth place. A great many also believe that Graham's position would be strengthened rather than weakened if Doughton and Hoey should both get into the race, since most observers believe that Doughton and Hoey would cut into each other's strength more than they would into Graham's and that he would easily be the winner in the three, four or five cornered race for the nomination. As a result, Graham's friends are hoping that Doughton will get into the contest as well as Hoey, though there is still some doubt as to whether Hoey will run. A great many observers are convinced that Hoey will become a candidate, however, especially if Doughton does not get into the race.

Continued from Page One) their docket in us at this term of court. This request was compiled with and we have examined all dockets of each magistrate.

We were very much surprised to find that most dockets were improper and poorly kept; however there was a few whose dockets were very good, neat and self-explanatory.

For the benefit of some of the magistrates, we would like to make the following suggestion:

That in all cases the complaint should be properly stated and the judgment specific and self-explanatory. All cases committing bonds should be filled out with names of bondsmen. All cost itemized, names of all witnesses, and if witness fees allowed, record same and make the witness receipt for it.

We also recommend that all magistrates turn their fines over to this county monthly and their dockets over to every Grand Jury for inspection.

We have not been able to investigate the various guardianships, but we recognize the importance of making such investigation. It is therefore recommended that the Clerk of Court make a report to the foreman of this body not later than May 15, 1935 in which is shown a complete list of all guardians and listing those guardians who have satisfactorily complied with the law, and those who have not done so, stating in what particular they have failed to comply with the law. It is intended that this report shall show clearly whether guardians are properly bonded and whether funds of their wards are securely held.

We wish to extend our appreciation to the Presiding Judge, M. V. Barnhill, the Solicitor and other officers of the court for the courtesies and co-operation at this term of the court.

PENSION BILL BEFORE HOUSE

\$1,000,000 Asked For Monthly Payments Of Aged of North Carolina

Raleigh, April 25.—A specific old-age pension bill was offered the lower house as Representative Doughtin, of Warren, introduced a measure which would, if passed, provide maximum payments of \$15 monthly to North Carolinians who are 65 years of age or older and who are without means of support. The measure would set aside \$1,000,000 from the state's general fund to be expended during the next two years.

Those eligible for the proposed pensions would be persons 65 or older who have been residents of the United States at least 20 years and of North Carolina for at least 10 years and who have no children who can and will support them and who do not deprive themselves of property for the purpose of becoming eligible to receive a pension.

Maximum payments under the Doughtin bill would not exceed \$15 monthly, payable on the first Monday in each month. If a person eligible for a pension should, for example, have an income of \$5 a month he would be eligible to receive from the state not more than \$10 monthly.

In addition to the monthly payments the measure provides that at death the state shall contribute a sum not to exceed \$50 for burial expenses for any person receiver.

An Old Age Commissioner would be appointed by the Governor for the purpose of administering the fund. The Commissioner would serve a four-year term and receive a salary not to exceed \$3,000 annually. In turn the Commissioner would approve appointments made by boards of county commissioners to membership on county old-age pension committees. County commissioners would name three persons to serve on such committees, and committeemen would receive salaries not to exceed \$50 a month. Salaries of the committee members would be fixed with the \$50 limit by the county commissioner. The State Commissioner's salary would be fixed within the \$3,000 limit by the Governor.

County committees would receive applications for pensions and make recommendations to the State Commissioner and would meet at county seats on the first Monday in each month and at such other times as might be necessary.

All pension payments would be exempted from assignments, sales

of other claims and in cases of bankruptcy would not be paid to creditors of the pension receiver or any of their agents or attorneys. Making a false statement in an application for a pension would constitute a misdemeanor punishable by a minimum fine of not less than \$200 or not more than two years at hard labor.

The bill makes no mention of anticipated federal legislation along the same lines, but the maximum payment of \$15 is expected to be incorporated in the federal law, thus providing a pension of \$30 monthly. The measure, if passed, would go in effect next July 1. The bill was sent to the appropriations committee.

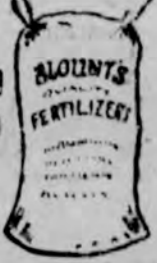
